**Engagement of Heavy Vehicle Drivers for Haryana Roadways.**

In view of the emergent situation arising out of the illegal strike of some of the employees of Haryana Roadways, the department requires 504 HTV drivers purely on contract/daily wage basis for a period of three months. The period of the engagement could be extended subject to the situation/vacancies.

The details of the requirement are as under:-

**Note:-** The age of the applicant should be from 21 years to 42 years, which shall be taken as on closing date.

**Only applicant having experience of driving of heavy transport vehicle for 10 years or above will be eligible to apply for the post of HTV driver. The person who had served in Army/Air Force/Navy on the post in which heavy transport vehicle licence is required, he will be given preference and if the number of such persons fall below the required number of drivers for the depot then other person having 10 years experience and above will be considered. The short listed candidates will be put for the driving proficiency test which includes DUG test, ZIG ZAG /8-shape test (both forward & reverse) Road Test etc.**

1. That the engagement will be purely on contractual basis for 3 months.
2. The contract/engagement can be terminated at any time without assigning any reason or prior notice and the person so engaged shall have no right to claim regularization or any other benefits of such engagement for any purpose.
3. The engagement shall be through written agreement signed by General Manager on behalf of department and the person engaged.
4. The engagement shall not be extended beyond three months, however, the period of the engagement could be extended subject to the situation/vacancies, as decided by the Govt.
5. Applicants are required to attach the self attested photocopies of the necessary documents as per the details provided with the application form.
6. The original certificates should not be enclosed to the application form. All documents should be self attested.

7. Candidates should submit only one application for one post in the office of General Manager, Haryana Roadways. Applicant applying in two or more depots will not be considered and his application will be cancelled.
8. The Heavy Vehicle Drivers engaged against this advertisement shall not have any legal right for claim regularization of his services in the department.
9. Eligible candidates will be engaged through a selection process, which comprises of short listing based on merit and experience, driving proficiency test (Dug test, Zigzag test, Road Test etc.).
10. The applicant shall clearly write the name of the post on the envelope and shall send it through registered post to following address i.e. General Manager, Haryana Roadways or can submit the application directly in the office of concerned General Manager.
