As talks with Dems collapse, Trump warns of emergency

Prez Storms Out Of Meeting On Shutdown, Mexico Wall

Washington: The United States is heading towards declaration of a national emergency that will draw its military into a domestic political wrangle after talks between the ruling executive and the opposition Democratic leadership broke down over funding a southern border wall, taking an already difficult impasse into gridlock territory.

President Trump walked out of a White House meeting with Democratic leaders Chuck Schumer and Nancy Pelosi on Wednesday after they refused to meet his demands for \$5.7 billion to build a section of a border wall, saying they will not negotiate on the matter until he agrees to end the partial shutdown of the government by accepting their funding on everything except the wall. "Just left a meeting with Chuck and Nancy, a total waste of time. I asked what is going to happen in 30 days if Iquickly open things up, are you going to approve Border Security which includes a Wall or Steel Barrier? Nancy said, NO. I said bye-bye, nothing else works!" he tweeted soon after talks on resolving the twin issue of the wall and the shutdown collapsed in acrimony.

The deadlock, with or without the table slamming, makes it almost certain that the President will use provisions of a national emergency declaration to press ahead with

building the southern wall or steel barrier as he calls it now. Trump is scheduled to visit the city of McAllen in Texas, in a district which abuts the Mexican border. Trump has painted a terrifying picture of illegal immigrants pouring into the US and indulging in wanton crime, including rapes and murders, even though official figures and studies show that such traffic is at an all time low and immigrants commit less crime than native-both Americans.

Both Trump and his Republican cohorts and the opposition Democrats believe they have painted the other side into a corner amid signs the government shutdown, which will enter a record 21stday on Friday, could extend into next week. Some 800,000 workers, including in such crucial departments as Transportation Security Administration and Internal Revenue Service, will go without a paycheck on Friday, the bi-weekly payday.

Prospects of the president declaring a national emergency, which will allow him to draft the military and its budget to build the wall, is increasing by the hour as Democrats refuse to budge on the matter. Trump told reporters he "may gothatroute" if he was unable to work out a deal with Democrat, saying, "I have the absolute right to do national emergency if I want. My threshold will be if I can't make a deal with people that are unreasonable." The National Emergency will not involve suspension of civil liberties as it happened in India, but many critics say it is a slippery slope, and once the military is drawn into a political spat, the conse-

Pak forex stash won't support even 2 mths of imports: Report

Islamabad: Pakistan's foreign exchange reserves are worth less than two months of goods and services imports, a report by Moody's said, indicating the failure of the Imran Khan government to resolve the ongoing economic crisis by borrowing from allies.

The country does not have enough foreign exchange reserves to pay its public and private external debt due over this year, the Moody's report revealed. "Foreign exchange reserves are low, and gross borrowing requirements are large in Pakistan and Sri Lanka, threatening the ability of these governments to refinance debt and fund deficits affordably," Moody's Investors Service said.

The forex crunch will make Pakistan vulnerable on the external front and push it again to a default-like-situation that it had averted in recent months with Saudi Arabia's help. Pakistan's foreign reserves have declined due to persistent current account deficit.

Taliban kill 30 Af troopers amid peace efforts

Kabul: The Taliban launched a series of attacks on security checkpoints in four Afghan provinces early on Thursday, killing 32 members of the security forces and pro-government militias, provincial officials said.

The latest Taliban attacks came in the northern provinces of Kunduz, Baghlan, Takhar, and Badghis in the west. Ahmad Fahim Qarluq, the chief of the Qala-e-Zal district in Kunduz, said a large number of Taliban attacked security checkpoints in the early hours, killing 10 soldiers and police and wounding 11. Qarluq said 25 Taliban fighters were killed.

In neighbouring Baghlan and Takhar provinces, the Taliban killed 16 members of progovernment militias in attacks on outposts, officials said. They also said the Taliban suffered heavy casualties. To the west, in Badghis province, a spokesman for the governor said six members of the security forces were killed. A Taliban spokesman claimed responsibility for the attacks. REUTERS

China takes India envoy on trip to **Uighur** camps

New Delhi: Indian envoy in Beijing was among a select group of diplomats to be taken, in a first, by China to the Xinjiang province where many ethnic Uighurs and other Muslim minorities have been interned in re-education camps apparently meant to de-radicalise them. Chinese officials here said the visit was meant to familiarise senior diplomats, including the Pakistan envoy, with social and economic progress in the province.

In all, 12 envoys, mostly from Muslim majority nations, travelled to Xinjiang's capital Urumqi and the cities of Kashgar and Hotan late last month. Xinjiang's regional government invited diplomatic envoys as well as representatives of envoys from Russia, Kazakhstan, Kyrgyzstan, Uzbekistan, Tajikistan, India, Pakistan, Indonesia, Malaysia, Afghanistan, Thailand, and Kuwait, state-run Xinhua news agency reported. The envoys visited markets, mosques, factories, as well as vocational education and training centres. TNN

LA judge dismisses Judd's claim against Weinstein

LIFE WOULD BE TRAGIC IF IT WEREN'T FUNNY —

Los Angeles: A federal judge in Los Angeles on Wednesday dismissed actress Ashley Judd's sexual harassment claim against movie producer Harvey Weinstein but said she could proceed with a defamation claim against him.

Judd had accused Weinstein of defaming her in 1998 after she refused what she said were his sexual advances a year earlier. In her lawsuit, filed in April 2018, the actress accused Weinstein of smearing her reputation by discouraging director Peter Jackson from casting her in his blockbuster movie franchise 'The Lord of the Rings'.

Judd, one of the first women in October 2017 to accuse Weinstein of sexual misconduct, had accused the Hollywood movie mogul of sexual harassment in violation of a California law barring such conduct by a person in a "business, service or professional relationship" with another.

In a footnote to his ruling, US district Judge Philip Gutierrez said he was not determining whether Judd was sexually harassed by Weinstein "in the colloquial sense of the term". But Gutierrez said Judd's relationship as an actress with the film producer was not covered under

the California statute she had sued under, nor under a 2019 amendment.

"We have said from the beginning that this claim was unjustified, and we are pleased that the court saw it as we did. We believe that we will ultimately prevail on her remaining claims," Weinstein's lawyer, Phyllis Kupferstein, said.

Judd's attorney, Theodore J Boutrous Jr, said this ruling does not upend her complaint. "Nothing about today's ruling changes that Ms Judd's case is moving forward on multiple claims," Boutrous said. "We look forward to pursuing the three claims for relief that the court has already ruled can moveforward," he said, Weinstein is to stand trial in May in New York on five charges, including rape, involving two other women. REUTERS

Gaga to shun R Kelly over 'misconduct'

Los Angeles: Lady Gaga has vowed to remove a duet she recorded with R&B singer R.Kelly from streaming services and never collaborate with him again.

Her comments, in a lengthy Instagram post, followed a new TV documentary in which multiple women accuse Kelly of sexual misconduct, sometimes with minors. Kelly, 52, singer and record producer best known for hit song 'I Believe I Can Fly', has repeatedly denied accusations in recent years of abuse, including those made in the new documentary.

Gaga said she believed the women and found the documentary "absolutely horrifying". "I stand behind these women 1000 percent, believe them, and know they are suffering and in pain, and feel strongly that their voices should be heard and taken seriously," she said in her post. Gaga in 2013 released a duet with Kelly called 'Do What U Want(With My Body)'. REUTERS

Nepal woman, 2 kids die in 'menstrual hut'

Kathmandu: A woman and her two sons suffocated to death in Nepal after she was forced to sleep in a windowless shed during her period, police said on Thursday, the latest victims of an age-old Hindu practice that was banned more than a decade ago.

Amba Bohara, 35, and her sons, aged 12 and nine, had lit a fire on Tuesday night to keep warm in the freezing mud and stone hut, but were discovered dead the next morning by her father-in-law in western Nepal's Bajura district, police said.

The practice of "chhaupadi" banishes menstruating girls and women to animal sheds or huts for the duration of their period, when they are thought to be impure. "They died of suffocation because there was no ventilation and they had made the chamber airtight to beat the cold," police official Uddhay Singh Bhat said.

Greece probes 'terror' envelopes sent from India

Athens: Envelopes mailed from India to a dozen Greek universities prompted an anti-terrorism investigation on Thursday after tests found an industrial irritant that triggered an allergic reaction in members of the staff.

The envelopes were addressed to 12 university rectors across Greece, from its islands to the mainland and capital Athens, and some had a printed note of "Islamist content" inside, written in English, a police official said, without elaborating.

The General Secretariat for Civil Protection said an irritant, used in the production of adhesives and printing ink, was likely deliberately added to the envelopes. Police sources said the anti-terrorism unit of police was conducting an inquiry.

Seven people reported a respiratory reaction after coming into contact with an envelope addressed to the rector of the University of the Aegean on the island of Lesbosd. Some letters were intercepted before reaching the recipients. REUTERS
