pected to draw the rules in about a week, the government has also asked the states to prepare their own criteria for exclusion. This will be applicable to jobs and education that fall under the purview of the states. "We will, over time, see how the states frame the rules. These can also be taken into consideration," Gehlot said.

The minister said the reference to the Rs 8 lakh annual household income and size of land holding was drawn from existing parameters for the creamy layer among OBCs when the constitutional amendment to include economic deprivation as a ground for reservation was being considered.

BJP appoints

DJP president Amit Shah Don Thursday appointed former chief ministers Shivraj Chouhan, Vasundhara Raje and Raman Singh as national vice-presidents of the party, an important responsibility ahead of the Lok Sabha polls. The decision is seen to create space for a new crop of leadership at the national level.

The party lost the recent assembly polls in MP, Rajasthan and Chhattisgarh where the three were the incumbent CMs. However, Shah's decision to appoint them to key posts shows that their role remains valued for the party. P16

Anand has requested an urgent hearing - before the 2019 Lok Sabha polls — as it is the "constitutional duty of the respondents, including the Union of India, PM and Election Commission, to ensure every eligible voter of this country can vote".

"TOI has raised a very important issue since due to jobs or other reasons, voters, who have temporarily moved to another city or state, often cannot vote as their name is not registered at the new place. Although they are eligible

to vote, they cannot," said the 89-year-old lawyer, asking: "Isn't denial of the right to vote to one-third (of India's) voters a fraud on democracy and the Constitution itself?"

He pointed to TOI's January 6 report, which mentioned how the US, UK, Germany, Australia, Estonia and New Zealand had enabled their voters to vote from outside their hometowns. "The same modifications should be made in our Constitution
