FIRAgainstAsthana Stays, CBI Told to Probe Allegations in 10 Weeks

New Delhi: Refusing to quash the FIR registered against him and others on charges of corruption, the Delhi High Court on Friday dismissed a petition filed by CBI special director Rakesh Asthana.

The court directed the agency to conclude its probe against Asthana and coaccused within 10 weeks.

The court ruled that the grounds of mala fide against ousted CBI director Alok Verma in registering the FIR against Asthana "are not made out". The court also ruled that "nor can the allegations against the petitioner be conclusively ruled out at this stage"

Asthana had claimed that the FIR against him was ante-dated and documents were fabricated to falsely implicate him. Rejecting the claim the court has ruled that the facts are not borne out from the records.

Referring to allegations levelled by complainant Satish Babu Sana in the case, the court has held "although Sana's complaint lists a certain sequence of events and details some facts, it does not mention any direct interaction with Asthana apropos ₹5 crores or any promise of leniency towards him".

Significantly, the court has further ruled that "Sana's conversations were all along with Somesh and Manoj. It is not known whether Somesh or Manoj spoke to Asthana or any other office of the CBI in the presence of such officers. tomanagea bail-out. As per available information, the SIT constituted by interim CBI chief M Nageswara Rao has already recorded the statement of Sana and found contradictions in his statements. The agency has collected evidence in the case and is soon likely to submit a report to the con-

cerned court. The court ruled that involvement in the offence will only be determined during the course of trial. It also did not find any merit in the challenge to Section 17-A of the Prevention of Corruption Act, which according to Asthana, prohibited the investigating agency from registering an FIR without

seeking sanction from the government. The court ruled that no sanction under Section 17-A to prosecute a public servant was required in cases where the public servant was not discharging a public duty or was indulging in corruption. The Court has ordered that all allegations should be probed swiftly to restore the credibility of the agency.

'Accused Criminal' Asthana Inspired CVC Report: Cong

New Delhi: A day after the sacking of Central Bureau of Investigation (CBI) director Alok Verma on charges of corruption, the Congress maintained that he was removed without any verified and proven charges while CBI's special director Rakesh Asthana, who is believed to have a strong backing of the government, stood as an "accused criminal".

Congress spokesman Abhishek Singhvi questioned the credibility of the Central Vigilance Commission (CVC) report, which was made the basis for Verma's removal, saying the content of the report was inspired by the same "accused criminal" Asthana, who suffered a setback on Friday when the Delhi High Court cleared the way for his arrest and probe into corruption charges levelled against him.

Singhvi quoted from the CVC report to dismiss the four main charges levelled against Verma, just as Congress leader Mallikarjun Kharge had done in his note of dissent in the meeting of the high-powered committee that voted to sack Verma by a majority of 2:1. He said CVC had itself admitted its charges were not substantiated.



Jagan an Ally if he Stays Away From Cong & BJP: TRS





The PIL sought directions to the ECI to prohibit all persons, whether politicians or private individuals, from posting advertisements related to politics or elections, or paid political content on social media platforms 48 hours before election day.-PTI

New Delhi: BJP chief Amit Shah has likened the forthcoming Lok Sabha election to the Third Battle of Panipat, cautioning party cadre not to be complacent like the Marathas who lost the 1761 battle that "led to 200 years of slavery" in India.

Delivering the inaugural address at the BJP national convention here on Friday, Shahsaid, "Battles are of various types...there are some battles that have an impact for decades, 2019 battle is one which will have an impact for decades... The Marathas won several battles. Then came the Third Battle of Panipat... Unfortunately, the Marathas lost the battle... The Maratha army that had won 131 battles but lost one battle that led to 200 years of slavery for the country. The English ruled over us for 200 years... Today it is a similar battle."

The BJP president emphasised that the party is fighting an "ideological battle" in 2019 with cultural nationalism, antyodaya and welfare of the poor as its goal, while the opposition is a group of parties which has no leader or policy.



Shah underlined the recent achievements of the Narendra Modi government and played up the 10% quota for the economically backward, the relief in goods and services tax to traders having turnover of up to ₹40 lakh, and the Ram Mandir issue in his speech.

His mention of the temple issue drew a long applause from the crowd at the Ramleela ground. "BJP wants that a grand Ram temple is built at Ayodhya as soon as possible," he said. The party's official stand, as stated by the prime minister, is that it will wait for the Supreme Court verdict on the issue. In the presence of Modi and the top leadership, Shah said it was at the same venue that a pledge to get 272+ seats was taken by the party in 2014 and this time the pledge to make Modi

The party has come a long way since 2014 when it was in power only in six states, as it rules in 16 states today, Shah said.

PM again is being taken by them.

However, he made no mention of the recent defeats in assembly elections in Madhya Pradesh, Rajasthan and Chhattisgarh in his 45-minute speech. Shah claimed that the party will repeat its 2014 performance in Uttar Pradesh and get 73-74 seats in 2019 polls from the state. His remarks came on the eve of the proposed announcement of an alliance in UP by Samajwadi Party president Akhilesh Yadav and BSP chief Mayawati on Saturday.

In it Together, BJP & Cong Oppose Candidates Footing Bill for Ads on Criminal Record

New Delhi: Ahead of the Lok Sabha polls, Congress and BJP have both questioned the Election Commission's diktat that a candidate should foot the bill to publicise his criminal record, especially since it eats into his poll expenditure limit. Candidates from both the national political parties are learnt to have written to the EC red-flagging their

concerns over the decision initiated September last year. People familiar with the development said the EC would look into the

creasing criminalisation of politics, ordered that it be made mandatory for every candidate in the fray in an election to inform the public at large about his criminal record in "bold letters" and at least three times after filing of nomination papers through newspapers at large

and electronic media. EC implemented the order for the first time in the recently held state elections, bringing out standard by a Supreme Court order in formats for each candidate to make a public declaration of his criminal record.

While the SC order did not clarify on who would foot the bill for these ad-



vertisements and under which precise electoral account it would fall, it was added to the candidate's election account in the elections in Madhya Pradesh, Rajasthan, Chhattisgarh, Telangana and Mizoram.
