ome elements of the new project may be implemented under the current system as well.

Once the new mechanism is in place, taxpayers will get a pre-filed form in their income tax account which will have their name. PAN and other details, a tax officer said.

In addition, the columns related to salary, interest income and tax deducted at source captured in the 26AS forms will also be there. Taxpayers can add to the form by adding other income that may have accrued but not reported to the tax department earlier, said an officer.

Goyal also said there will a system for quicker rectification of mistakes.

"This is a laudable initiative and will go a long way to ease tax compliance, collection of taxes and enhanced experience for taxpayers. India will become more competitive and aligned with global best practices. However, the real success of this will be measured when the technologies and tools become easy to use for a common man or woman and technology changes are accompanied by changes in the mindset and culture of the tax authorities at the operational levels," said Neeru Ahuja, partner at consulting firm Deloitte India. In recent years, processing of returns has picked up and the tax department is also issuing refunds faster.

Home min to mull online FIRs for railways

New Delhi: Sharing his concern over passengers' ordeal to file an FIR in case of a crime or theft on trains, Union home minister Rajnath Singh pitched creation of a framework for people to file it online during their journey. Junior railway minister Manoj Sinha also favoured giving more power to Railway Protection Force (RPF) highlighting how it's

"toothless". Speaking at an event on railway security, Singh said the home ministry will see whether online filing of FIRs can be integrated into the CCTNS system, which allows citizens to lodge FIRs electronically. "If somebody is travelling by train and something happens, he needs to visit the Government Railway Police station to get an FIR registered. It will then go to the state, to district and eventually to the police station concerned. There is no guarantee that he would get the desired

justice," he said. Singh suggested to railway ministry to discuss and decide on online FIR. "We will provide all possible support from the home ministry," he said. Both Sinha and RPF director general Arun Kumar pushed for handing over registration, inquiry and detection of passenger-related crimes on board trains to the RPF. The minister said a draft bill for amendment in the Railways Act to empower RPF to register, inquire and prosecute cases of luggage theft and crime against women has been approved to be sent to the Cabinet for approval.

Expansionist China's inroads into Indo-Pacific alarms US

'Beijing Looking For Strategic Bases In Pak, Cambodia And Vanuatu'

New Delhi: After establishing its first overseas naval base at Djibouti in the Horn of Africa in August 2017, which now also hosts marines, infantry combat vehicles and helicopters, China is now looking at Pakistan, Cambodia, Vanuatu and other countries for additional military bases to enhance its strategic footprint and emerge as the pre-eminent power in the crucial Indo-Pacific region.

Sounding this warning in its latest report on "China's global expansion by military and non-military means", the Pentagon says Beijing also "completed" over \$20 billion



of military sales and transfers as a component of its foreign policy just between 2012 and 2016 to become the world's

fifth largest arms supplier. arms to Indo-Pacific countries, primarily Pakistan, Ban-

gladesh and Myanmar. China's second-largest arms sales were to the Middle East and North Africa.

The Djibouti base, where China is now constructing a 450-metre pier capable of berthing at four warships by mid-2019, and "probable follow-on bases at other locations" signal "a turning point" in the expansion of operations of the People's Liberation Army in the Indian Ocean Region (IOR) and beyond, warns the Pentagon report.

"These bases, and other improvements to the PLA's ability to project power during the next decade, will increase China's ability to deter the use of conventional military force, sustain operations abroad, and hold strategic economic corridorsatrisk," it says.
