

#### **Solar Alliance Forum** Meet

D usiness Leaders and Diplomats Prom the National and International community today participated in a collective dialogue on world's solar energy needs as part of the International Solar Alliance forum at the ninth Vibrant Gujarat Global Summit 2019.

On this occasion, H E Armida Alisjahbana, the executive secretary of the United Nations Economic and Social commission for Asia and the Pacific (UN-ESCAP) presented special remarks. Conceptualized in 2003, by the Prime Minister of India Narendra Modi, the summit has evolved into a platform for brainstorming on agendas of global socio-economic development, knowledge sharing and forging effective partnerships.

A seminar on 'Port Led Development and Strategies' noted that India is on the cusp of as the 'Transhipment Hub of Asia' leading a maritime revolution globally

The seminar deliberated on two sessions. While the first session emphasized on the challenges faced in port-led development, promotion of coastal shipping in the form of fiscal and non-fiscal incentives, and newer models for encouraging PPP in the maritime industry; the second session focused on Multimodal Logistics, challenges in hinterland integration and adoption of green initiatives, developing port nad industrial connectivity, and the unlimited opportunities of Gujarat ports. Professor Shuo Ma, the

International Vice President of the World Maritime University, stated, "It is usually believed that the capital investment or lack of it is the key factor for further boosting the development of coastal shipping in many countries including India, but it may not be true. The utilization ratio in ports is merely 60 per cent which gives a room to increase productivity without making further investments."

He further pointed out the fact that the coastal shipping is in direct competition with other modes of transport. Customers look for the best value for money option. So competitive pricing should be considered as much as balancing the traffic and efficient utilization of the potential of ports.

The event was attended by Nitin Patel, the Deputy Chief Minister of Gujarat, and had special addresses by R C Faldu, Minister of Agriculture, Rural Development, Fisheries, Transport, Government of Gujarat; Dr J N Singh, IAS, Chief Secretary, Government of Gujarat; and Sunaina Tomar, IAS, Principal Secretary, Ports and Transport Department, Government of Gujarat.
