Death sentence sought for 5 in Khashoggi murder case

Saudi has not released names of the defendants; no date set for the next hearing

Saudi Arabia's Attorney-General sought the death penalty for five of 11 defendants charged with the murder of journalist Jamal Khashoggi as their high-profile trial opened in Riyadh on Thurs-

All 11 accused were present with their lawyers at the first session of the trial, the Attorney-General said in a statement carried by the country's official Saudi Press Agency (SPA).

Saudi Arabia had twice submitted formal requests for evidence from Turkey where Khashoggi was murdered inside the kingdom's Istanbul consulate on October 2 – but had received no response, the statement added. The names of the defendants have not been officially released. Five top officials in Saudi Arabia – including royal court insider Saud al-Qahtani – were sacked over the Khashoggi murder, but there is no proof they are among those charged.

'Rogue operation' Khashoggi was murdered in what Riyadh called a "rogue" operation, tipping the kingdom into one of its worst diplomatic crises. The 59-year-old Saudi insider-

The Khashoggi murder shocked the world at a time when Saudi Arabia and its de facto leader, Crown Prince Mohammed bin Salman, were pushing an aggressive have been seriously tarnished by the murder.

The UN and human rights groups have called for an independent investigation into the killing.

"Given the possible involvement of Saudi authorities in Khashoggi's murder and the lack of independence of Saudi Arabia's criminal justice system, the impartiality of any investigation and trial would be in question," Samah Hadid, a West Asia director at Amnesty International, said on Thursday. "This is why a UN-led and independent investigation is needed into the murder."

It was unclear whether Mr. Qahtani and Ahmad al-Assiri, two senior aides to Prince Mohammed initially implicated in Khashoggi's murder, were among those on trial. Saudi officials said in November that Mr. Qahtani - who has not spoken publicly since then – had been banned from travel pending the investigation but authorities have refused to disclose his whereabouts.

Ankara, which pledged repeatedly to allow nobody to escape justice in the case, has sought the extradition of the suspects to stand trial in Turkey. But its requests have been repeatedly rebuffed by Riyadh.

'N. Korean envoy has gone into hiding, sought asylum'

Seoul says he escaped Italy's diplomatic compound in Nov.

North Korea's top diplomat in Italy has sought asylum and gone into hiding, Seoul lawmakers told reporters after a closed-door meeting with South Korean intelligence officials on Thursday.

It would mark the latest high-profile defection by a senior North Korean envoy since the Deputy Ambassador in London abandoned his post in 2016.

"Acting Ambassador Jo Song-gil's term was ending in late November last year and he escaped the diplomatic compound in early November" with his wife, South Korean lawmaker Kim Min-ki told reporters.

Mr. Jo. 48, has been acting Ambassador in Rome since October 2017 after Italy expelled the then Ambassador Mun Jong-nam in protest at a North Korean nuclear test a month earlier in violation of UN resolutions.

Italy is an important diplomatic mission for Pvongyang, as it handles relations with the Rome-headquartered UN Food and Agriculture Organisation and North Korea suffers from chronic food shortages

'Italy has no knowledge' A source close to the Italian Foreign Ministry said on Thursday that the country had "no knowledge" of any asylum request from Mr. Jo. The source said the Ministry had simply received a request for the "replacement"

of the diplomat, but did not know Mr. Jo's whereabouts, adding that the replacement had arrived in Rome.

The NIS briefing to lawmakers came after South Korea's JoongAng Ilbo daily reported that Mr. Jo had sought asylum in an unidentified Western country with

"He sought asylum early last month," JoongAng quoted a diplomatic source in Seoul as saying.

Italian authorities were "agonising" over what to do, the official was cited as saying, but added that they were "protecting him in a safe place". Mr. Jo is "known to be a son or son-in-law of one of the highest-level officials in the North's regime", JoongAng cited an unnamed North Korea expert as saying.

Most North Korean diplomats serving overseas are normally required to leave several family members typically children – behind in Pyongyang to prevent their defection while working abroad.

Mr. Jo however came to Rome in May 2015 with his wife and children, suggesting that he may be from a privileged family, JoongAng said, adding the reason for his defection bid was still

One of the leaders of the "yellow vest" anti-government demonstrations was detained by police in Paris late on Wednesday for organising an unauthorised protest, signalling a harder line by the authorities against the movement. Eric Drouet – who already

faces a trial for carrying a weapon at a previous protest was held while heading for the Champs-Élysées, which has been the scene of violent clashes over the last month.

"It's called respecting the rule of law," Economy Minister Bruno Le Maire said on Thursday, as he defended the arrest which drew criticism from some leftist opponents of the government.

would aim to buttress sectors such as beef, dairy and fishing - those most exposed to customs and regulatory changes likely to arise if Britain severs all ties. Nearly 80% of Irish exporters deliver products to Britain, according to 2016 government figures.

Authorities in Beijing had previously said the two men, Michael Kovrig, a former diplomat, and businessman Michael Spavor, were suspected of endangering state security.

"Without a doubt, these two Canadian citizens in China violated our country's laws and regulations, and are currently undergoing investigation according to procedure," Zhang Jun, China's prosecutor general, said. He said the investigation process had been handled according to law.

Lion Air ends search for black box

Lion Air has ended its search for the cockpit voice recorder (CVR) from its Boeing 737 MAX jet that crashed into the Java Sea in October, killing all 189 people on board. However, Indonesian investigators said that they plan to launch their own probe.

The main wreckage and the CVR, one of two socalled black boxes, were not recovered in an initial search. Lion Air said in December it was funding a 38 billion rupiah (\$2.64 million) search using the offshore supply ship MPV Everest. The search using the ship ended on Saturday, Danang Mandala, the spokesman for Lion Air Group, said.

Bangladesh Opposition renews call for fresh vote

BNP members boycott swearing-in ceremony of MPs

Opposition members of Bangladesh's Parliament boycotted a swearing-in ceremony on Thursday, after rejecting results of an election that they said was rigged to give Prime Minister Sheikh Hasina her third straight term.

While newly elected Members of Parliament from the ruling bloc, including Ms. Hasina, were sworn in, the seven Opposition members stayed away. "Why should we take the oath when we've rejected this election?" Mirza Fakhrul Islam, secretary general of the main Opposition Bangladesh Nationalist Party, told reporters. Mr. Islam is one of the seven Opposition mem-



bers who won a seat. The Election Commission

has rejected an Opposition call for a new vote, but despite that, the alliance on Thursday submitted a new demand for a re-run of the polls. On Thursday, New York-based Human Rights vote was characterised by "violence and intimidation against the Opposition ... and the misuse of laws to limit free speech". It called for an independent and impartial investigation of the accusations of electoral abuses.
