#### Cong MP balancing act: NSA cases stay, Home to clear in future

**MILIND GHATWAI BHOPAL, FEBRUARY 9** 

WITH THE invocation of the National Security Act (NSA) against persons arrested for slaughter and illegal transport of cows in Madhya Pradesh in two recent cases coming under criticism, including from a state Congress MLA, the Congress government in the state has decided to exercise caution from now on while invoking the stringent legislation.

Every three months, the government issues a notification authorising district magistrates to exercise powers conferred under Section 3 (3) of the NSA to detain persons if they threaten communal harmony or commit acts prejudicial to the maintenance of public order and the security of the state. A top bureaucrat told *The Sunday Express* that now the state Home Ministry will review such decisions and decide if there has been an error of judgment by district authorities in issuing such detention orders. Every collector has to also send a report to the Home Ministry about such

Despite repeated attempts, Law Minister P C Sharma and DGP V K Singh did not return calls.

Currently, collectors invoke the NSA based on recommendations of superintendents of police. But while the provision is regularly invoked against habitual criminals, its use for offences under the state's prohibition of cow slaughter act is not that

# Need Bill, won't let any harm come to you: PM to Northeast

'Only after requisite checks and requests from states can citizenship be granted'

SPEAKING AT a huge public rally here on Saturday, Prime Minister Narendra Modi reiterated his government's commitment to passing the Citizenship (Amendment) Bill, 2016, while reassuring the people of Assam and the Northeast that they would not face any difficulty due to it. Saying his government was committed to protecting the culture and interests of the people of the Northeast and Assam, he said that "only after requisite checks and requests from the state government can the decision to grant citizenship be taken".

Addressing the rally that was attended by over three lakh people, of various communities and tribes, Modi said those "who believed in Maa Bharati (Mother India)" but were persecuted in their native countries of Pakistan, Bangladesh and Afghanistan had nowhere to go to but India. At the same time, Modi said, there was no place for "ghuspetiyon (illegal immi-

## To 'pool anti-BJP, TMC votes', Cong, CPM clear way for West Bengal tie-up

THE CONGRESS and CPM-led Left Front on Saturday appeared to be heading for a tactical understanding in West Bengal for the Lok Sabha elections. The Left may not contest in all the 42 seats, saving it wanted to maximise the pooling of "anti-BJP, anti-Trinamool Congress votes".

The state leadership of both the Congress and CPM has been pushing for a tactical tie-up, but the central leaders were ambivalent. The Congress high command was hoping for an understanding with the TMC, while the CPM's Kerala unit had been opposing any truck with the Congress.

The TMC, however, was not willing to enter into an alliance with the Congress.

The CPM Politburo which met here on Friday and Saturday discussed the issue. Congress president Rahul Gandhi too had a meeting with PCC presidents and Congress Legislature Party **CONTINUED ON PAGE 2**

THEY THOUGHT he would do it after the Pongal festival in January. Then, after his five-day yagya in January end.
