New Delhi: If the CBI produced evidence of Kolkata police commissioner Rajeev Kumar or any authority in West Bengal destroying evidence or thwarting investigation into chit fund scam cases, it would "come down on them so heavily that they will regret it", the Supreme Court told the agency on Monday.

Former IPS officer Bharti Ghosh, an ex-aide of Mamata, on Monday joined BJP. After joining the party, she slammed Didi, calling her dharna a "political move" and an "asatyagraha to block fair investigation". P13

The court, which will hear the CBI's contempt plea against the West Bengal government on Tuesday, made its observations after solicitor general Tushar Mehta referred to the "siege" of the agency's office in Kolkata. Mehta was responding to the court's remarks that the CBI petition did not cite material on destruction of evidence.

Appearing for West Bengal, senior advocate A M Singhvi, also a Rajva Sabha MP from the state, said, "CBI is engaged in a political witch-hunt and is hounding the police commissioner, forgetting that he is only a witness and not an accused in the chit fund scam cases." However, the court suggested that he keep his arguments ready for Tuesday's hearing.

The CBI rushed to the SC claiming to possess "substantial material to exercise power of arrest without warrant" against a non-cooperative Kumar

in the chit fund cases and narrated the action against its officerson Sunday by Kolkata police. It pointed to the siege of its office and residence of a joint director stationed in the city.

The CBI made two pleas -SC direct Kumar to "surrender/make himself available" for questioning and initiation of contempt of court proceedings against chief secretary Malay Kumar De, DGP Virendra Kumar and Rajeev Kumar for disobeying SC orders directing every state authority to cooperate in the probe.

London: British home secretary Sajid Javid has signed the order for fugitive Indian tycoon Vijay Mallya's extradition back to India. Javid, who took up his position in April 2018, signed the order for the extradition of the indebted liquor baron on Sunday, eight weeks after

Bhopal: The Kamal Nathled Madhya Pradesh government on Monday made it mandatory for all industries in the state to provide 70% employment to local youth.

"To fulfil the manifesto promise, we have made 70% jobs mandatory for local youth of MP across industries facilitated by state government," Nath tweeted.

"The new industrial policy has been made effective and all industries who seek incentive from the state must provide 70% jobs to local youth. We have not received any proposal turning down incentives provided by government, hence all industries covered under this policy will have to mandatorily follow the rule," said principal secretary of department of industry Mohammed Suleman.

Sources said firms given land and other facilities by the former BJP government have also been asked to follow the new policy.

Passenger couple kill Ola cabbie, chop body into 3 pieces

New Delhi: Many Delhiites may feel it's unsafe to take a cab late at night. The danger, however, can be equally real for cabbies ferrying passengers in the late hours. Ola cab driver Ram Govind became the latest victim of crime by passengers, when a couple allegedly murdered him, dismembered the body into three pieces and dumped it in a drain in Greater Noida.

The motive for the crime: Govind's Hyundai Xcent cab, which the couple wanted to sell off in western UP, police officials said. Almost a week after the cab

driver went missing while on duty, the couple from Loni, Ghaziabad, was arrested for murdering him and taking the cab away to Moradabad. Police said Govind had

completed a trip from Madangir to Kapashera and was waiting idle in his car when he got a booking at lam (on January 29) from the accused -Farhat Ali and Seema Sharma alias Aseeman - from MG Road in Gurgaon. The duo wanted to go to their home in Ghaziabad.

New Delhi: Delhi has seen a sharp surge in swine flu, with 1,011 cases reported since January 1 this year, making the capital second to only Rajasthan in the number of cases reported, data from National Centre for Disease Control reveals.

At least 895 of these ca ses are figure in Delhi government data that only includes patients with local addresses, officials said. Just 205 swine flu cases were reported in the capital last year. Rajasthan, which had 2,375 cases and swine flu 221 deaths last year, has seen 2,263 cases and 85 deaths since January 1.

Officially, Delhi has had no swine flu death but hospitals have reported several deaths so far in 2019.



IIT Roorkee claims 1623 edition of Bard's First Folio in its library

SHAKESPEARES

Roorkee: A priceless 1623 edition of William Shakespeare's "First Folio" has been found among thousands of historic manuscripts and unseen photographs at IIT Roorkee's Mahatma Gandhi Central Library. The collected edition of the Bard's dramatic works, published seven years after his death, includes all but two of his plays.

IIT Roorkee's dilapidated copy of "Mr William Shakespeares Comedies, Histories, & Tragedies" is stacked inside a cardboard box in the librarian's office, its pages individually separated with tracing paper. A handwritten "1623" on

were printed. In 2001, a copy was sold at Christie's in New York for \$6.16 million. The librarian at MGCL, Dr

C Jayakumar, says they have many other rare works. One of them is a document bearing Nehru's signature in Hindi, English and Urdu, along with the date "November 25, 1949".

However, the treasures may soon be lost as Jayakumar's proposal to IIT to build a small museum within the library to protect the works is still pending. PTI
