# Why not increase the VVPAT count, asks SC

Random checking working fine, says EC official

The Supreme Court said on Monday that it was in favour of increasing the random physical verification of Voter Verified Paper Audit Trail (VVPAT) in the Lok Sabha and Assembly elections, though the idea was met with stiff resistance from the Election Commission.

Deputy Election Commissioner Sudeep Jain said the current practice of physically checking the VVPAT paper slips of one randomly selected polling station in an Assembly constituency and each Assembly segment in the case of the Lok Sabha election was "all that is needed." There was no need whatsoever to extend the physical count of VVPATs.

#### 'Based on data'

Mr. Jain told a Bench of Chief Justice of India Ranjan Gogoi and Justice Deepak Gupta that VVPATs were "working absolutely right" and everything that the ECI did was based on expert statistical data. He said the Election Commission, on its own, constantly bettered its parameters.

A visibly annoyed Justice Gogoi responded to Mr. Jain's comments, asking him why the EC had not introduced VVPATs on its own af-

## Goyals step down from Jet board

Banks assume control of cash-strapped airline, to look for new investors

Ending a nearly two monthlong struggle to remain in control, Jet Airways' power couple Naresh Goyal and his spouse Anita on Monday resigned as directors from the board of the company.

Their exit paves the way for recapitalisation of the financially challenged airline through a resolution plan.

The resignations of Mr. and Mrs. Goyal were accepted at a hurriedly convened board meeting here. Mr. Goyal, a former travel agent who founded Jet Airways in 1993, also ceased to be the chairman of the company, ending his 25-year tenure at the helm. Another director Kevin Knight, who represented Etihad Airways on Jet's board, has also resigned.

Describing it as a 'groundbreaking' promise and a final assault on poverty, Congress president Rahul Gandhi on Monday announced that 20% of the poorest families in the country would be annually given ₹72,000 each under the Nyuntam Aay Yo*jana* (NYAY) or minimum income guarantee scheme, if

his party returned to power.

Mr. Gandhi asserted that five crore families and 25 crore people would be lifted out of poverty under NYAY – the acronym suggested by Congress general secretary Priyanka Gandhi-Vadra to convey a sense of 'justice' for

## Kalyan Singh faces flak over remarks backing Modi

Congress accuses Rajasthan Governor of violating dignity of Constitutional office

Rajasthan Governor Kalyan Singh on Monday found himself in the middle of a controversy after his remarks supporting Prime Minister Narendra Modi's return to power in the Lok Sabha election came to light through a video footage.

The video purportedly showed Mr. Singh telling reporters that the nation and society needed Mr. Modi to become the PM again.

"All of us are BJP workers. We genuinely want the BJP to win. We want that Modiji should become the Prime Minister... It is necessary for the nation and so-



ciety that Modiji becomes the PM again," Mr. Singh said in the video shot in his hometown Aligarh last

Mr. Singh, a former twotime Chief Minister of Uttar

Pradesh, apparently made the remarks in the midst of a protest staged by some BIP workers outside his house against the party ticket for the Lok Sabha polls being given to sitting MP

#### Non-partisan position

Mr. Singh's remarks drew criticism from various quarters, with leaders reminding him that a Governor should be non-partisan and should maintain distance from party politics.

Chief Minister Ashok Gehlot said Mr. Singh's statements did not suit the dignity of the post he was holding. "We have utmost respect for Kalyan Singhji... He is holding a [high] Constitutional post. It is expected of the Governors to be non-partisan," he said.

Rajasthan Pradesh Congress president and Deputy CM Sachin Pilot described Mr. Singh's remarks as violating the dignity of his Constitutional office. He said it was unfortunate that Mr. Singh had described himself as a BJP worker.

Mr. Singh quit the BJP in 1999 and rejoined the party in 2004. The 87-year-old BJP leader was appointed Rajasthan Governor in 2014 after Prime Minister Narendra Modi came to power at the Centre.

### AI withdraws boarding pass with photos of PM, Rupani

Air India on Monday was forced to withdraw its boarding passes carrying an advertisement featuring Prime Minister Narendra Modi and Gujarat Chief Minister Vijay Řupani following criticism on social

Earlier in the day, a passenger shared photos of his boarding pass for travel on March 25 on Twitter and wrote, "my Air India boarding pass prominently flashes Narendra Modi, Vibrant Gujarat & Vijay Rupani-...Wonder why we are wasting public money on this Election Commission (sic)."

Following an uproar over the violation of the model code of conduct, the airline said it was "rolling back" the boarding passes.

It didn't divulge the name of the advertiser, but said it found the ad was flouting the code. Airlines carry advertisements given by third parties to augment their non-fare revenue.

The Vibrant Gujarat Summit of the State government was held in Gandhinagar from January 18 to 20, but the boarding passes carrying the ad continued to be in use across Air India's network.

Following the controversy, National Conference leader Omar Abdullah tweeted about a similar experience with GoAir. "I was on a GoAir flight yesterday & also had a similar boarding pass with the PM's photo on it," he wrote.

## SC to consider AAP govt.'s plea on services
