After SC rap, EC 'wakes up to its powers' Campaigning ends

Poll body acted against communal speeches after top court pulled it up and gave it 24 hours to act

The Supreme Court on Tuesday took note of the Election Commission of India quickly changing tack on April 15 to pass a flurry of restraining orders against leading politicians for their communally provocative and divisive speeches.

The EC orders came shortly after the poll body invited the court's wrath for describing itself as "toothless" in the face of hate.

"Seems you have got your powers now," Chief Justice of India Ranjan Gogoi said, addressing the commission on Tuesday.

"We found we have several powers..." senior advocate C.A. Sundaram, who represented the EC, acknowledged in court.

"So, EC has woken up to

its powers," Chief Justice Gogoi pointedly said again.

On Monday, the EC had claimed it was mostly helpless if candidates engaged in communal diatribe during their campaign speeches. This riled Chief Justice Gogoi, who initially threatened to have Chief Election Commissioner Sunil Arora in court in the next half-hour.

The court then decided to delve deep into the poll panel's claims that its powers were "circumscribed". It gave the Commission exactly 24 hours to be ready with a

Sensex, Nifty touch a new high

Positive trends in global markets and strong foreign fund inflows combined to drive investor sentiment in the Indian market on Tues-The BSE Sensex gained

369.80 points to close at a new high of 39,275.64 points. This is only the second time that the benchmark has closed above the psychological 39,000mark - the first instance was on April 2, when it closed at 39.056.65. The broader Nifty too ended at a new high of 11,787.15 while gaining 96.80 points.

EC restrictions

The Election Commission restrictions on campaigning by Uttar Pradesh Chief Minister Yogi Adityanath, BSP leader Mayawati, SP leader Azam Khan and Union Minister Maneka Gandhi came into effect from Tuesday. All are charged with violating the model code of conduct.

Several cases of violations of the code continue to emerge even as campaigning gains momentum for the third phase in 115 constituencies across 12 States and two Union Territories on April 23.

Mr. Modi's speeches continue to focus on national security and nationalism while the Congress has tried to build momentum around its manifesto promise of minimum income guarantee.

Jet Airways seeks ₹400 crore infusion to avert shutdown

The Jet Airways board, at an emergency meeting held on Tuesday, authorised its management, headed by chief executive officer Vinay Dube, to engage with lenders to secure at least a few hundred crore rupees of interim funding to continue operations till a new owner

The board also authorised the CEO to take the final call on the airline's operations, people familiar with the development said.

Armed with this, the CEO approached the lenders to

release ₹400 crore for the sake of the employees and to prevent a shutdown. Jet requires at least ₹1,000 crore to meet its immediate needs.

In a filing with the stock exchange, the airline said, "In view of the critical liquidity position of the company, its operations have been severely impacted. It is awaiting emergency liquidity support from the consortium of domestic lenders led by the State Bank of India." "The company's leader-

ship, in consultation with its Board of Directors, is engaged with lenders in connection with the funding request to arrest a further deterioration of its services, and minimise inconvenience to its guests," it said.

Kerala Minister makes a heart-to-heart offer to save 15-day-old infant


SPECIAL CORRESPONDENT THIRUVANANTHAPURAM It was a medical drama that had entire Kerala on edge on Tuesday. A 15-day-old infant boy,

with a congenital heart disease and multiple cardiac problems, was being rushed from a hospital in Mangaluru to Thiruvananthapuram by road – a distance of about 600 km – through a green channel. His parents had apparently been persuaded to seek treatment in the State capital despite the risk of transporting the seriously ill baby.

It took the personal intervention of Kerala's Health Minister K.K. Shylaja to convince the parents to accept the offer of free treatment by the State government.

Senior officials told The *Hindu* that the District Early Intervention Centre of the Health Department at Kasaragod had contacted the person coordinating the green channel arrangements at 10 a.m. to say that the government's Hridyam programme could treat the infant for free in Kozhikode or Kochi, considerably reducing the travel time.

However, the family did not respond to the offer. "Around 2 p.m., after the child had been on the road for almost five hours in a

ventilated condition, following a call from Ms. Shylaja, we again contacted the family... But till the Health Minister herself got in touch with the parents, they were not willing to change their plans," an official said.

Following the Minister's call, the baby was rushed to the paediatric cardiology division at Amrita Institute of Medical Sciences (AIMS) in Kochi.

The Health Department is coordinating all arrangements at the hospital under Kerala's unique and comprehensive programme Hridyam, which takes care of all congenital paediatric cardiac surgeries, including emergencies, through a public-private partnership network of hospitals. Dr. R. Krishna Kumar,

head of the paediatric cardiology department at AIMS, said the baby's condition was critical and he would be in observation in the NICU for 24-48 hours to stabilise his condition.
