If such candidates are not available in particular specialty, those without PG qualification but having at least three years experience after MBBS, out of which one year Junior Residency from a

Government Hospital in the concerned specialty, can be considered.

## Age Limit for appointment as Senior Residents:

- ☐ 33 years for those having Post Graduate qualification
- ☐ 35 years for Post Doctoral Degree holders
- ☐ Relaxation for SC/ST/OBC and Physically handicapped as per government of Indian notification will apply.

Note: Railway may allow to relax age limit from 33 years to 40 years, as done by institution like AIIMS in a particular specialty where they normally find difficulty to have senior residents subject to approval of Competent Authority on the issue.

## Tenure of Senior Residency:

- 1. The contract of appointment for Senior Resident will be one year but the total period of Senior Residency can not exceed the maximum period of three years, subject to renewal/extension every year.
- 2. The termination of contract can be done on one month notice or pay from either side.

#### **Emoluments:**

For Senior Residents having Post Graduate degree

For Senior Residents with only PG Diploma

The Senior Resident Doctors will be required to be on call duty not exceeding 12 hours/day.
