Congress Punjab in-charge seeks report into face-off between Amarinder, Sidhu

THE CONGRESS in-charge for Puniab, Asha Kumari, Tuesdav sought a report from the party's state unit over the war of words between Capt Amarinder Singh and his cabinet colleague Navjot Singh Sidhu, even as more party leaders backed the chief minister and several sought the cricketerturned-politician's resignation.

Sidhu is under fire from his own party leaders after he guestioned during electioneering in Bathinda why no FIR was lodged against the Badals, who headed the previous state government. for the desecration of religious texts in 2015.

"We seek a report on every event and in this issue too a report has been sought from the PCC (state Congress committee)," Kumari said.

Sunil Jakhar, who is seeking reelection from Gurdaspur, will give the report once he is free from the election process after the declaration of the results.

Amarinder on Sunday had accused Sidhu of "damaging" the Congress in the state and suggested that maybe he harboured ambition of becoming the chief minister.

Meanwhile, more Congress leaders came out in support of the Punjab CM.

"Amarinder Singh is an undisputed leader of Puniab. There are many facets to his personality," said former Union Minister and Congress leader Manish Tewari. He praised Amarinder as a "protector of Punjab's waters", a writer, an able administrator who has a mass appeal.

"People need to learn and grow," he added, in a veiled attack at Sidhu. He said nothing could be more laughable if anyone compared himself to "Captain Sahib".

Chairman of the Punjab Congress Election Managing Committee, Laal Singh said Sidhu's statements were ill timed and ill advised and have the potential of sabotaging the party's 'Mission 13'. He said, if the party misses the mark, it will be entirely for the statements made by Sidhu.

In a statement, Laal Singh said, Sidhu was in the Congress for just 27 months and had been accorded "all the privileges, honour and respect". Laal Singh pointed out that the former BJP

signed the task of campaigning for the party across the country. "All these things come with a sense of responsibility, which Sidhu should have honoured and acknowledged," he said, adding, if he had any such issues, he could have raised these at different party forums or he could have taken these up with the party high command.

Laal Singh also said that Navjot Sidhu was wrong in joining his wife, Dr Navjot Kaur Sidhu, in blaming the Punjab CM for denial of Lok Sabha ticket.

Jails Minister Sukhjinder Singh Randhawa too hit out at his cabinet colleague saying, "Making such a statement dur-She said state party chief ing elections meant directly helping the Badals."

Randhawa said that the Local Bodies Minister should know that "in the 2017 assembly polls, the Congress came to power in Punjab with an overwhelming majority as people voted in Amarinder Singh's name".

"The party high command is with the chief minister. Our party has never tolerated indiscipline," Randhawa said, adding that Sidhu should know that the state government had set up a special investigation team (SIT) over the desecration issue. "Does Sidhu not know that action is being taken and some people have already been arrested. Is he ignorant of these facts," he said.

Randhawa alleged that when Sidhu's wife was a BJP MLA, she never spoke a word on the issue.

Food Minister Bharat Bhushan Ashu and Industries Minister Sham Sunder Arora, in separate statements, said Sidhu should resign as his outburst may affect party's prospects.

Union Minister of State for Housing and Urban Affairs Hardeep Singh Puri, who is BJP's Lok Sabha candidate from Amritsar, also took a jibe at the Congress, saying, "All along the campaign, one could sense unease in their ranks."

"Now the cat is out of the bag," he tweeted, adding that Sidhu was under attack from his own cabinet colleagues.

Punjab minister Sadhu Singh Dharamsot had Monday asked Sidhu to resign from the state cabinet if he could not work with Amarinder Singh.

No EVMs replaced, tampered with: Fatehabad admin

DISTRICT AUTHORITIES in Fatehabad have dismissed allegations of alleged tampering/replacing EVMs that had cropped up in the district of Haryana on May 14.

A truck full of steel boxes that had entered the Bhoria Khera college in Fatehabad district where a strongroom is located was intercepted by Congress workers. While Congress alleged the boxes carried EVMs that had to be replaced with those in the strongroom, district administration

said the truck was carrying empty boxes in which EVMs had to be stored after counting. Fatehabad falls in Sirsa constituency.

Fatehabad's Deputy Commissioner, Dhirender Khadgata told *The Indian Express*, "We found that the truck was being escorted by Tehsildar on the directions of Assistant Returning Officer and brought from Tohana. After counting on May 23, the EVMs have to be stored in these empty boxes and kept in safe custody. There was an apprehension raised by members of a political party, but after we clarified the actual situation to them, they were satisfied with our reply. Since we did not want any misunderstanding, thus we sent the empty boxes back and deferred bringing them again till the counting concludes."

He added: "The EVMs were kept in safe custody in the strongroom set up in Chaudhary Maniram Godara Women College in Bhoria Khera. The strongroom is guarded round-the-clock in a three-tier security cordon. Representatives of political parties are also guarding the strongroom...On May 14, around 4.30 pm, we had received information that a truck loaded with empty steel boxes reached the college."

Reserve machines, not used at all, clarifies EC

COMMENTING ON a purported video clip claiming EVM machines were being transported in Phagwara outside polling centre on May 19, Chief Electoral Officer Punjab S Karuna Raju has clarified that these were reserve machines and that "nothing wrong or out of rules" had happened.

Raju said it was being reported that a man on voting day was moving near Senior Secondary School Bhanoke carrving EVMs.

"It was ascertained after investigations that this man was one Balwinder Kumar of BDPO office Phagwara who had been appointed incharge of Sector 4 by Returning Officer Hoshiarpur and he had 9 Polling stations under him," he said.

He further said that Balwinder Kumar had been given provided two complete sets of EVMs in a GPS fitted car to exchange the machines in case of any discrepancy during voting at any of these nine booths. A videographer Manish Kumar was also present in the car carrying EVMs, he added. Raju said that to allay all ap-

prehensions, those present at site were taken to dispatch centre at Guru Nanak College and they were shown that on those machines it was clearly mentioned that those were reserve machines and had not been used at all.

BSP workers keep 24-hr watch on strongrooms Outer security cover to the count-

WITH SAFETY of the electronic voting machines kept inside strongrooms in focus, BSP workers in Punjab's Jalandhar (Reserved) seat have been camping round the clock outside the premises of the district's land record office to guard the EVMs. This while workers from other political parties have only been making rounds to the spot.

In Jalandhar, EVM and VVTA machines have been deposited at the office of the Director Land Records, Government Sports School and the State Patwar School, both located at the premises of land record office. The administration has de-

ployed 900 security personnel, including Paramilitary, Punjab Armed Police (PAP) and Punjab Police to guard these machines.

Of the total 2.07 crore electors, 1.37 crore have sealed the fate of 278 candidates in Punjab.

669 cases of voter impersonation recorded across Punjab

THIS LOK Sabha election, 669 cases of voter impersonation were recorded across Punjab. while 153 others opted to exercise their right to refuse to vote under Rule 49 O of the Conduct of Elections Rules 1961.

Under Rule 49P of the Conduct of Election Rules, 1961, if an individual come to vote at a polling station after another person has already voted in his/her name, the presiding officer shall first ascertain the identity of the elector and once satisfied, shall allow the elecA total 153 people also opted to exercise their right to refuse to vote under Rule 49 O of the **Conduct of Elections Rules 1961**

tor to vote by means of a tendered ballot paper, and not a voting machine.

Data sourced from the Punjab Chief Electoral Officer (CEO) showed that out of 669 voter impersonators, the maximum were reported from Anandpur Sahib LS con-

stituency, where 549 tender votes were reported in Kharar assembly constituency and 20 in SAS Nagar assembly segment.

They were followed by Amritsar LS with 61 tender votes including 20 each from Attari, Amritsar East and Majitha assembly segments and 1 from Amritsar South. Twenty such cases reported from Fatehgarh Sahib LS, 5 from Bathinda and 3 from Sangrur, 2 each from Jalandhar and Faridkot, 1 each from Khadoor Sahib, Hoshiarpur,

Firozpur and Patiala. The Election Commission website states that if a registered elector, after signing or putting their thumb impression on the Register of Voters, "decides not to record his/her vote, he/she shall not be forced to...A remark to the effect...shall be made in the remarks column against the entry relating to him/her in the Register of Voters by the presiding officer...under Rule 49 O of the Conduct of Elections Rules, 1961..."

Electors who do not wish to vote also have the option of pressing the None Of The Above (NOTA) on the EVM. Data sourced from the CEO

office shows that Gurdaspur

Lok Sabha Constituency has

topped the chart in this category where 81 voters had refused to vote under Rule 49 O, which included 75 voters from Gurdaspur assembly segment and 5 from Dina Nagar Assembly segment. In Amritsar LS constituency,

20 electors refused to vote in Majitha assembly constituency while 17, 12 and 11 voters refused to vote in Patiala, Firozpur and Anandpur Sahib LS constituencies respectively. There were three each in Fatehgarh Sahib and Faridkot LS, two in Muktsar.

Apart from this, Sangrur, Khadur Sahib, Jalandhar and Hoshiarpur LS had one such voter each.

NOTA results will come after counting of votes.

The Punjab CEO also released an age-wise voter list on Tuesday, according to which 50.25 per cent of the state's voters are below the age group of 40 years.

According to this list, there are 20781211 voters in Punjab, out of which 10442665 are aged between 18 and 39 years, 71,59001 are between 40 and 60 years (34.44 per cent). A total of .02 per cent are aged 100 and above, while 13 per cent are between 61 to 80 years, and 1.5 per cent are between 81 and 90 years.
