# 'Trump must turn over financial records' Theresa May offers 'new deal'

Judge asks President's accountants to comply with Congressional subpoena; he will appeal decision

A federal judge has ordered U.S. President Donald Trump's accountants, Mazars USA, to comply with a subpoena from the House of Representatives Oversight Committee and submit financial records related to Mr. Trump to the Committee. The Committee had subpoenaed financial records and communications from the accountants pertaining to Mr. Trump, his businesses and charity, from 2011 to

"It is simply not fathomable that a Constitution that grants Congress the power to remove a President for reasons including criminal behaviour would deny Conthe power to investigate him for unlawful conduct...," DC District Court judge Amit Mehta wrote, citing precedents from the 1800s to Watergate (a Richard Nixon scandal) and Whitewater ( from the Clinton era).

tee's subpoena was motivated by the testimony of Micahel Cohen, Mr. Trump's former fixer and personal attorney. Prior to becoming President, Mr. Trump frequently inflated and deflated his financials to suit specific financial goals and plans, Mr. Cohen had testified, providing at least two financials from Mazars to support his testimony, as per court docu-

The judge ruled that Congress had the power to investigate potentially illegal conduct by an individual before and after they become President.

**Sweeping authority** "Congress plainly views itself

as having sweeping authority to investigate illegal conduct of a President, before and after taking office. This court is not prepared to roll

back the tide of history," Mr. Mehta wrote in his opinion. The White House has se-

ven days to appeal the verdict. The accounting firm had said it will comply with the law - which means, pending any stay granted through an appeal, Mr. Trump's financial records will be handed over to the House in a week as Mr. Mehta refused to order a stay.

Mr. Trump and team have resisted Congressional inquiries, which they claim are politically motivated.

Democrats have, through various House committees, been looking into the finances of the President, his campaign, and the activities that may have constituted an obstruction of justice with regard to the Mueller probe into Russian meddling in the 2016 presidential election.

Monday's ruling is likely to bolster the House Financial Services Committee's case for acquiring Mr. Trump's records from Deutsche Bank and Capital One via a subpoena. The subpoena is be-

ing fought in a New York court by Mr. Trump, his family and the Trump Organization in federal court in New York. The case will be heard on Wednesday.

'Crazy decision'

Mr. Trump called Judge Mehdecision ta's "crazy", "wrong" and alluded to Mr. Mehta being an "Obama-appointed judge". He also said he would appeal the decision.

The White House directed former White House Counsel Don McGahn to not comply with a House Judiciary Committee subpoena on Monday, in another instance of the administration resisting the Democrat-controlled House's attempts to investigate the President and associates.

Mr. McGahn was due to appear before the House panel on Tuesday. The Chairman of the panel, Jerrold Nadler, warned that Mr. McGahn would be held in contempt of the House if he did not appear before the

# to break Brexit deadlock

A second referendum & closer trade ties with EU on cards

Prime Minister Theresa May set out on Tuesday a "new deal" for Britain's departure from the EU, offering sweeteners to Opposition parties in her fourth attempt to break an impasse in Parliament over Brexit.

Three years since Britain voted to leave the EU and almost two months after the planned departure date, Ms. May is mounting a last bid to try to get the deeply divided Parliament's backing for a divorce deal, to leave office with some kind of legacy.

The odds do not look good. Despite offering what she described as "significant further changes", many lawmakers, hardened in their positions, have already decided not to vote next month for the Withdrawal Agreement Bill, legislation which implements the terms of Britain's departure.

Speaking at the headquarters of Pricewaterhouse-Coopers, Ms. May appealed to lawmakers to get behind her deal, offering the prospect of a possible second referendum on the agreement and closer trading arrangements with the EU as

"I say with conviction to every MP or every party: I have compromised, now I ask you to compromise," she

"We have been given a clear instruction by the people we are supposed to represent, so help me find a way to honour that instruction, move our country and our politics and build the better future that all of us want to see."

By offering the possibility of holding a second vote on her deal and a compromise on customs arrangements, Ms. May hopes to win over Opposition Labour lawmakers, whose votes she needs to overcome resistance to the deal in her own Conservative Party.

But she will infuriate lawmakers supporting Brexit.

Her movement towards what many describe as the "Remain" lawmakers, who want to stay in the EU, is a shift for a Prime Minister who has long said she is against a second referendum and staying in a customs union with the bloc.

# Chinese-built drones may steal data, warns U.S.

Tech sector faces increased scrutiny amid trade war

Washington has warned that Chinese-made drones could be giving spy agencies in Beijing "unfettered access" to stolen data, according to a report in American media.

The Department of Homeland Security sent out an alert on Monday flagging drones built in China as a "potential risk to an organisation's information", CNN reported.

The U.S. government has "strong concerns about any technology product that takes American data into the

territory of an authoritarian State that permits its intelligence services to have unfettered access to that data or otherwise abuses that access," wrote CNN, quoting the DHS alert.

Huawei's 90-day reprieve The warning comes as China's tech sector attracts unprecedented scrutiny amid China-US trade war.

Washington has cranked up the heat on China's Huawei by banning American companies from selling or transferring U.S. technology to the telecoms giant, though the U.S. Commerce Department has granted the firm a 90-day reprieve.

U.S. intelligence believes Huawei is backed by the Chinese military and that its equipment could provide Beijing's spy agencies with a backdoor into the communications networks of other countries.

U.S. has also pushed its closest allies to reject Huawei technology. The DHS report did not name any specific Chinese manufacturers, but China-based DJI produces about 70% of the world's

### Nepal bans Chinese digital wallets

Nepal on Tuesday banned popular Chinese digital wallets Alipay and WeChat to prevent the loss of foreign currency earnings from tens of thousands of Chinese tourists.

Over 1,50,000 Chinese holidaymakers visited Nepal last year, many using digital wallets to pay in hotels, restaurants and shops in tourist areas – especially in Chinese-run businesses.

Laxmi Prapanna Niroula, a spokesman for the central bank, said that Nepal was losing out since the actual transactions took place in China.

# Austria's Kurz to face no-confidence vote

Governing coalition collapsed over a corruption scandal involving his deputy

Austrian Chancellor Sebastian Kurz is set to face a noconfidence vote in Parliament next week after his governing coalition collapsed over a corruption scandal. Speaker Wolfgang Sobot-

ka, a member of Mr. Kurz's conservative People's Party, set a special session of the legislature for Monday. Opposition parties wanted it held this week, but Mr. Sobotka said he wants to "give space to the EU election campaign," the Austria Press Agency reported on Tuesdav. Austria elects European Parliament lawmakers on

The Opposition Now party has drawn up a no-confidence motion seeking to oust Mr. Kurz before an early national election expected in September.

Mr. Kurz called for that election after far-right Freedom Party leader Heinz-Christian Strache, who was his Vice-Chancellor, resigned on Saturday. Mr. Strache was shown on video appearing to offer favours to a purported Russian investor during a meeting two years ago on the Spanish island of

Mr. Kurz's party holds only 61 of the 183 seats in parliament. It isn't yet clear whether the second and

### Joko Widodo re-elected as Indonesia's President

Troops on high alert after protests

Heavily armed Indonesian troops were on high alert on Tuesday amid fears of civil unrest in the capital Jakarta, as the surprise early announcement of official election results handed Joko Widodo another term as leader of the world's third-biggest democracy.

The Election Commission had been due to give the divisive poll's final tally on Wednesday, but results were announced early on Tuesday instead.

Presidential challenger Prabowo Subianto, a 67year-old retired Army general, has vowed to take his claims of widespread cheating to court as several thousand supporters rallied in

the sprawling capital.

Tensions have also spiked since police said last week that they arrested dozens of Islamic State-linked terror suspects who planned to cause chaos by bombing post-election protests.

On Friday, the U.S. embassy in Jakarta issued a heightened security alert for Indonesia. Other embassies issued similar warnings.

# The highs and lows at Cannes

It is to do with the rule of averages. That every great day spent on movies at the Cannes Film Festival will necessarily follow with a runof-the-mill one. Sunday was a cinephile's delight stacked with Terrence Malick's A Hidden Life and Celine Sciamma's Portrait of a Lady on Fire.

Mr. Malick's majestic ode to resistance posits a bucolic idyll in a larger war-torn Austria where an ordinary farmer displays a rare strength and steadfastness of will to take on the fascist forces. It has the emotional sweep as well as the philosophical heft that Cannes winners should ideally be made of.

Ms. Sciamma's is poetic story of same sex love set in the 18th century, captured with delicate, graceful gaze

that stays passionate without compromising on the gender and sexual politics of the relationship. A day later, Monday

brought in a dose of disappointment. Dardenne Brothers' Young Ahmed deals with a serious issue – that of the growing religious radicalism in the young, but chooses to skim the surface instead of taking a necessary deep dive into it. We see all the familiar ideas and manifestations of Islamic orthodoxy portrayed with broad brushstrokes but little attempt to go behind

the reality of indoctrination. As a result, it does little more than propagate and reinforce sterotypes at a time when the narrative is begging for all round nuance. A highly dissatisfying departure from a bunch of passionate political con-

tenders for the Palme D'Or

this year - be it Mr. Malick, Ken Loach or Ladi Ly.

Ira Sachs' Frankie is the kind of charmless, light weight film. Despite the presence of a diva like Isabelle Huppert, as an seasoned actor getting her dysfunctional family together on a vacation in Portugal, Frankie just refuses to fly.

**India's entries** 

One may wonder about the entries from India, a leading filmmaking nation. At the India pavilion, filmmaker Shaji N. Karun, tells me that the nuances of Indian filmmaking is getting lost on Cannes selectors and a Western sensibility is taking over. It is "worrying, alarming and annoying" for him as Cannes is where he always found himself returning with a sense of diversity and "cerebral insights".
