Decide on Modi, Amit Shah 'hate speeches' by May 6, SC tells EC


Congress has alleged that the poll body was not applying rules uniformly



The Supreme Court on Thursday gave the Election Commission of India (EC) time till May 6 to take a final call on the complaints filed by the Congress against the alleged hate speeches and misuse of the armed forces as political propaganda by Prime Minister Narendra Modi and BJP president Amit

The Commission repeatedly protested, saying it would need time to call for the entire transcript of the speeches and decide the context of the allegedly offending words in them. This would take time, it said.

"So, you have today, then Friday and even Sunday... You can do it," Chief Justice of India Ranjan Gogoi told the commission, represented by senior advocate Rakesh Dwivedi.





Mr. Dwivedi submitted that there were a total of 11 complaints against the two leaders. "Of this, four have been effectively decided. We need time till at least next Wednesday to decide on the rest," he said.

But the court put its foot down. "You come on Monday," CJI Gogoi responded.

Senior advocate A.M. Singhvi began the hearing by submitting that the EC had

not decided on the complaints for the past three weeks. "What was spoken by them [Modi and Shah] cannot be taken back... the damage caused is irreversible. But the EC has to take a decision by tomorrow [Friday]," he submitted.

Direct attack In one of the most direct attacks on the EC, a 146-page petition filed by Congress presented by advocate Sunil Fernandes, alleged that there was one set of rules for Mr. Modi and Mr. Shah and another for the rest of the candidates.

The Congress said several representations of "violation" of the model code of conduct were made to the EC, but no action had been forthcoming from the poll body, which should be devoted to the concept of free and fair elections in a democracy

Since March 10, when the general election was notified, Mr. Modi and Mr. Shah had "specifically in sensitive areas and States, ex facie violated the provisions of the Representation of the People Act and the election rules and the process," the petition said.

Odisha evacuates over 11 lakh

Extremely severe Fani to hit coast with 180 km wind speeds

With the extremely severe cyclonic storm Fani expected to cross the Odisha coast between Gopalpur and Chandbali, south of Puri town, on Friday morning, the State government on Thursday evacuated over 11 lakh people from low-lying areas in 15 districts.

Heavy rainfall had started at many places in the coastal districts by Thursday evening under the influence of the storm. Fani is expected to make landfall between 8 a.m. and 10 a.m. and continue to rage up to noon, officials said. The cyclone will hit the coast with a maximum sustained wind speed of 170-180 kmph, gusting to 200 kmph. Storm surge of about 1.5 metre height may flood low-lying areas.

SC to hear petition to debar Rahul from polls

The Supreme Court on Thursday agreed to hear a plea to direct the Election Commission of India (EC) to debar Congress president Rahul Gandhi from contesting the Lok Sabha election and "becoming a Member of Parliament" after he had "voluntarily acquired British

nationality' A Bench, led by Chief Justice of India Ranjan Gogoi, was responding to the plea by Delhi residents Jai Bhag-

wan Goyal and Chander Prakash Tyagi. The petition said the court should "command" the government to decide the question of acquisition of British citizenship by Mr. Gandhi and consequently determine his Indian citizenship.

It wanted the court to decide whether a person who has voluntarily acquired British citizenship should be allowed to contest from Amethi and Wayanad, and then "fill a seat" in Parliament.

It was evident that Mr. Gandhi had acquired British nationality. This was clear from the incorporation certificate of U.K. company BACKOPS Limited and the returns filed by the company, it said.

The petition wanted a declaration that Mr. Gandhi "is not an Indian citizen and he is incompetent to contest as per the provisions of the Constitution read with the Representation of the People

The plea follows a notice

issued by the Ministry of Home Affairs to Mr. Gandhi on the question of his "dual citizenship".

On November 30, 2015, the Supreme Court dismissed a public interest litigation petition filed by a lawyer seeking a CBI investigation against Mr. Gandhi for allegedly declaring himself a British national before company law authorities in the U.K. The court found it too "frivolous" and called it an attempt by the lawyer to start a

"roving inquiry."

Chargesheet filed against Zakir Naik

Plea for recusal of CJI in Assam case rejected guishing in the detention

Chief Iustice of India (CII) Ranjan Gogoi on Thursday refused activist Harsh Mander's request that he recuse himself from hearing a PIL petition highlighting the sub-human" living conditions of detenues in Assam's detention centres.

Mr. Mander said his petition, which was solely intended to release those lan-

centres for years, transformed itself, through oral observations made by the CJI during hearings, into a premise for "more people being detained and deported" in Assam.

The CJI said it was the judge who decided whether to recuse himself from a case and not the litigant.

'Cover lotus references in city schools that are polling stations'

An election observer on Thursday asked for 'Rashtriva Phool - Kamal (national flower - lotus)' embossed on a school building wall in West Delhi to be covered as it is a violation of the model code of conduct. Lotus is the BJP's election symbol.

A police officer said that the observer has asked them to identify such walls in schools that are listed as polling stations in Delhi.

During a visit to polling stations, the election observer found that in several

schools information such as national bird, national animal among other things were mentioned on the walls. "We have been instructed to cover the word 'Kamal' painted/ embossed on the walls in schools where polling will be held on May 12. We are in the process of identifying such walls and they will be covered with the help of the district administration," said

the police officer. The election observer has also asked for photos of Pandit Jawaharlal Nehru and B.R. Ambedkar to be covered in schools listed as polling

this time

Reacting to the observer's objection, a schoolteacher said: "There are so many parties and each of them has an election symbol that represents something that we use in schools. It doesn't mean they everything."

In 2012, the Election Commission had ordered to cover up the statues of then U.P. Chief Minister Mayawati and elephant, the symbol of her Bahujan Samaj Party, ahead of the Assembly polls. The same have not been covered

Girls outshine boys in CBSE Class 12

Girls outperformed boys in this year's Central Board of Education's Secondary Class 12 examinations with a nine percentage point advantage in pass percentages. Overall, 83.4% of the 12.87 lakh students who attempted the examination held in February and March 2019 have passed, the CBSE said on Thursday.

While 88.7% of girls cleared the examination, only 79.4% of boys did so. Among transgender students, the pass percentage was 83.3%.

Joint toppers

The joint toppers – who scored 499 out of a possible 500 - were also girls, both from Uttar Pradesh.
