

Arrest warrant against Tharoor over remark

A city court issued an arrest warrant against Congress MP Shashi Tharoor on Tuesday over his alleged remark that the BJP, if voted to power again, would rewrite the Constitution and pave the way for creation of a "Hindu Pakistan". His alleged statement sparked off a controversy, with the ruling BJP demanding an apology from the Congress leader.

'Rules have not been followed: we will fight

Congress general secretary Priyanka Gandhi Vadra on Tuesday broke her silence on the scrapping of the special status to Jammu and Kashmir by saying "the manner in which this has been is done completely unconstitutional."

Ms. Vadra, who was talking to reporters in Sonbhadra district of Uttar Pradesh, said the NDA government's moves in Jammu and Kashmir were "against all principles of democracy".

"There are rules to be followed when such things are done. They have not been followed," she alleged. "The Congress party has always fought for the Constitution and democracy. We will continue to fight. This is a very clear view of the party," she

Referring to fellow Congress leader and former MP Jyotiraditya Scindia welcoming the scrapping of the special status to J&K, Ms. Vadra said Mr. Scindia "is also in the CWC [Congress Working Committee] and signed the statement". She added, "All are in agreement."

She said the party had a "clear opinion" on the issue and that there were no differing views. Unlike the BJP, in her party it was not that just one voice was heard while others were sup-

Enact security regime for NRC data, says SC

Authorities had raised concerns about a data leak

The Supreme Court on Tuesday directed Assam National Register of Citizens (NRC) authorities to enact a security regime akin to the Aadhaar data protection before making the information on exclusions and inclusions in the NRC list available to the Centre, Government of Assam and the Registrar General of India.

The order came after State NRC coordinator Prateek Hajela raised concerns in court about the security of the sensitive data.

"We direct that an appropriate regime be enacted on lines similar to the security regime provided for AAD-HAR data. Only thereafter, the list of inclusions and exclusions shall be made available to the State Government, Central Government and Registrar General of India," a Special Bench of Chief Justice Ranjan Gogoi and Justice Rohinton Nariman ordered.

The Bench had, in the previous hearing, clarified that it would not delve into Mr. Hajela's references to the leakage of NRC information in the Assam Assembly and certain statements made by Debabrata Saikia, Leader of the Opposition in the State Assembly, and Santanu Bharali, legal advisor to Chief Minister Sarbananda Sonowal.

The court agreed with the suggestion made by Mr. Hajela in his July report that people born before December 3, 2004 may be included in the NRC if the parent through whom legacy is drawn is not a declared foreigner (DF) or D Voter (DV) or whose case of nationality is pending before a foreigner tribunal (PFT).

Such persons can be included in the NRC even if the other parent is a DF or PFT. However, on the other hand, persons born on or after December 3, 2004 would not be included in NRC even if any of the parent is DV or DF or PFT. That is, those born on or after December 3, 2004 would not find a place in the NRC even if the parent from whom legacy is drawn is clear from all angles. The court said this is in tune with a Supreme Court order of Ju-

'It should be given statutory status'

Chief Justice of India Ranjan Gogoi on Tuesday recommended a comprehensive legislation to make the Central Bureau of Investigation functional as an efficient and impartial investigative

Delivering the 18th D.P. Kohli Memorial Lecture, Chief Justice Gogoi listed legal ambiguity, weak human resource, lack of adequate investment, accountability, and political and administrative interference as key

"The CBI should be given statutory status through legislation equivalent to that provided to the Comptroller & Auditor General. The legal mandate of the CBI must be strengthened by having a comprehensive legislation addressing deficiencies relating to organisational structure, charter of functions, limits of power, supe rintendence and oversight,"

"Further, to address an increasing incidence of inter-State crimes, an argument could be made for including 'public order' in concurrent list, for the limited purposes of investigating such crimes," he said, advocating administrative and financial autonomy for the

Sushma always took up challenges: PM

Prime Minister Narendra Modi led leaders across party lines and members of his own Council of Ministers on Tuesday in paying homage to former Union Minister Sushma Swaraj who passed away last week.

Terming Swaraj a Minister who transformed the External Affairs Ministry from one bound by protocol to one which heeded the "people's call," Mr. Modi was fulsome in his praise for his late colleague. He recalled instances when he and Vice-President M. Venkaiah Naidu helped persuade her to fight from Bellary in Karnataka against Congress president Sonia Gandhi in 1999. "I remember Venkaiah Naiduji and me going to Sushmaji, and asking her to go to Karnataka to fight elections. The outcome was certain but she was someone who was always ready to take up challenges," he He also recalled how she

persuaded him, in 2014, just before his first address to the UN General Assembly as Prime Minister to stick to a written text, her point being that she felt every forum had a particular form attached to it. "Wherever she went, she transformed the work culture there," he said. BJP leaders, including

Home Minister Amit Shah, Defence Minister Rajnath Singh and party's working president J.P. Nadda, and others were present at the meeting.
