Steep fines to save lives, not for revenue: Gadkari

Asked about some BIP-ruled States also not being in favour of steep fines, the Union Minister said that in the Act, the government has provided for a lower and upper limit for a fine, and States are free to take a deci-

Post-study work visa back in the U.K.

Students entering the UK in quirements. the 2020-21 academic year intake are expected to be eligible, said a spokesperson from the UK High Commission in Delhi, adding that students who have entered the UK earlier but still hold a valid student visa at the beginning of the next academic year are also likely to be eligible for the new route.

The visa will require a new application including payment of a new visa fee. the amount of which is yet to be determined. The visa is not extendable beyond a two-year period, and time spent in the UK on this visa will not count towards settlement. Visa-holders will be allowed to work at any skill level. Once they find a suitable job, they will be able to switch to a skilled work visa if they meet re-

Almost 22,000 Indian students got a UK visa in the year ending June 2019, a 42% increase from the 15.000 students who did so last year.

However, this still lags far behind the highs of 2010-11. when 39,090 Indians were granted student visas to the

In 2012, then Home Se-Theresa May scrapped the post-study work visa, claiming it was being abused by bogus colleges exploiting international students, including those from India. "Unlike the route which closed in 2012, this new route will also include safeguards to ensure only genuine, credible students are eligible," said a statement from the High Commission.

Mamata assuages fear on Deocha coal block

'Work only after rehabilitation'

Cow important to the rural economy, says PM

Modi says it is unfortunate that some people are critical of the government's policies to protect the animal

Prime Minister Narendra Modi on Wednesday said that livestock had always been vital for the rural economy in India, and stressed that his seriousness towards protection of cows could be gauged from the vaccination scheme introduced by the government.

Citing a scheme run by the Rwandan government to tackle malnutrition and poverty through the distribution of cows to elaborate on the role of cows in the rural economy, Mr. Modi said the African nation's scheme donated a cow to each household. The first calf produced by the cow is then given to the government, which then donates it to other villagers who do not have a cow.

Rural economy

"This works like a chain," Mr. Modi said, praising the Rwandan model for creating a network of employment. This also helped ensure that the cow, livestock and milk production became part of the rural economy, he said at the launch of the National Animal Disease Control Programme (NACDP) at Mathura in Uttar Pradesh. The programme aims to control and

eradicate foot and mouth disease and brucellosis among livestock in the country.

He said "some people created a storm" after he had visited Rwanda last year and donated "250 cows" to its villagers. It was unfortunate that there were some in the

country who were critical of the Centre's cow conservation policies.

"Some people, the moment the words Om and cow fall on their ears, their hair stands on end. They think the country has gone [back] to the 16th and 17th centuries," Mr. Modi said.

Describing the Motor Vehicle (Amendment) Act, 2019 that proposes higher fines for several traffic violations as "very harsh", West Bengal Chief Minister Mamata Banerjee on Wednesday said that her government will not implement it in Ben-

"We are not implementing the Motor Vehicles Act, which was passed recently in the Parliament, at present in West Bengal because it is very harsh. Of course we are going for a 'Safe Drive Save Life' campaign," the Chief Minister told journalists at the State Secretariat.

Speaking about the new law, Ms. Banerjee said that when it was discussed in the Parliament, her party members had raised objections saying that this matter was an interference into the federal structure.

"They didn't listen to us. Unilaterally you cannot take a decision which will harm people. Now, if anything is wrong, instead of ₹500 they will charge ₹10,000. There

are so many poor people also, where will they get all this money from?" she said. According to the Trinamool Congress chairperson, solutions to problems

Two anti-lynching Bills being examined by Centre

The anti-lynching Bills passed by the Rajasthan and West Bengal Assemblies last month will have to be cleared by the Union Home Ministry before they become

On August 5, the Rajasthan Assembly passed the Raiasthan Protection from Lynching Bill, 2019 providing for life imprisonment and a fine from ₹1 lakh up to ₹5 lakh to those convicted in cases of mob lynching leading to the victim's death.

A senior official in the Rajasthan government told The *Hindu* that the Ministry was examining the Bill and it would respond to clarifications sent by them, if any.

On August 30, the West Bengal Assembly passed a Bill to prevent and punish mob assaults and lynching. The West Bengal (Preven-

tion of Lynching) Bill, 2019 proposes a jail term from three years to life for those involved in assaulting and injuring a person and also defines terms such as "lynching" and "mob". The State also proposed the West Bengal Lynching Compensation

Under norms of the Union

Home Ministry, the State laws are examined from three angles - repugnancy with Central laws, deviation from national or central policy and legal and constitutional validity. An official said since such

consultations required inte-

ractions with various Ministries or departments, no time frame could be fixed when the Bills would be cleared. Based on the comments by the Ministry, the President rejects or gives assent to a Bill.

'Horrendous acts'

In 2018, the Supreme Court condemned the increasing number of incidents of mob lynchings across the country calling them "horrendous acts of mobocracy" and had then asked Parliament to make lynching a separate

offence. Meanwhile, last month, the Y.S. Jagan Mohan Reddy government in Andhra Pradesh withdrew two laws passed by the Assembly under previous Chief Minister N. Chandrababu Naidu.

The Andhra Pradesh Protection of Depositors of Fi-Establishments nancial (Amendment) Bill passed in 2015 and the Andhra Pradesh Money Lenders Bill, 2017 were being examined by the Ministry before they received assent from the President.

The Andhra Pradesh government withdrew the two Bills on August 27 and 31, respectively.
