'IAS officer who quit was under notice'

Before he quit over curbs imposed in Kashmir, IAS officer Kannan Gopinathan was issued a show-cause notice in July by the Union Home Ministry for alleged acts of "omission and commission" which constitute "misconduct" and "dereliction of duty".

The Ministry cited "dereliction of duty" in the administrative work of the 33year-old officer in the notice served on him on July 8. Among the various

"omissions and commissions" cited, it said the officer posted in Puducherry had failed to submit a report on the 2018 Kerala floods. Sources said as the officer was to be sacked for his conduct and was given 10 days time to revert with his clarification to the Ministry, he guit the coveted government job on August 21, stating that he was 'disturbed' over the curbs imposed in J&K since August 5. After Mr. Gopinathan's resignation, it was reported in the media that he was issued notice after his comments on Kashmir

Mufti's ancestral house for sale

His family members feel unsafe living there after security was withdrawn



The ancestral house of the late Mufti Muhammad Sayeed, Peoples Democratic Party (PDP) patron and former Chief Minister, in Bijbehara town of the volatile south Kashmir is up for sale, four weeks after the government decided to withdraw its police guards.

A family member of the Muftis, who did not want to be identified, told *The Hindu* that the family of the younger brother of the former Chief Minister, Mufti Muhammad Amin, "is finding it hard to stay in the house because of the volatile situation".

The relative said the decision to withdraw the security personnel "has made the members family vulnerable".

"Multiple security pickets were erected in the twin houses long before militancy started in the 1990s. In the run-up to the revocation of J&K's special status, security guards were withdrawn from the house and the close relatives of PDP president Mehbooba Mufti too lost their security. There is no

other option now but to look for a buyer. Many members of the family have already shifted to Jammu," the family member said.

Two wooden multi-storey ancestral houses of the Muftis are located inside the congested locality of Baba Mohalla in Bijbehara. They have come under attack from protesters as well as militants in the past.

Family sources said Ms. Mufti, detained at Chasmashahi in Srinagar since August 5, has already sold her share of the property but another PDP leader and cousin, Sajad Mufti, still owns property there.

The family said "very few buyers are coming forward." Mr. Sajad Mufti, living in a colony adjacent to the ancestral houses, is planning to sell his house. "His security has also been withdrawn," the family sources said.

According to the family,

Mufti Muhammad Sayeed, who was the Union Home Minister in the V.P. Singh government in 1989 and served as J&K's Chief Minister twice, started his political career from the house in the 1950s when he joined the Democratic National Conference, a splinter group of the National Conference led by Ghulam Muhammad Sadiq. He joined the Congress in 1965 and became the party presi-

dent in 1972.

Produce Farooq Abdullah in court, Vaiko files plea in SC

He is scheduled to attend a Chennai meet on September 15

Vaiko, Rajya Sabha member and Tamil Nadu politician, on Wednesday moved a habeas corpus petition in the Supreme Court seeking the Jammu and Kashmir government to produce former Chief Minister Farooq Abdullah, believed to be under detention following the dilution of Article 370, in court and set him free.

In his petition, Mr. Vaiko said Mr. Abdullah was scheduled to attend a conference organised by him in Chennai on September 15.

'Peaceful, democratic'

Mr. Vaiko, general secretary of the Marumalarchi Dravida Munnetra (MDMK), said the event was organised annually "on the occasion of the birthday of Thiru. C.N. Annadurai, former Chief Minister of Tamil Nadu, in the spirit of peaceful democratic debate and discussion so as to strengthen the unity and integrity of India".

The petition said Mr. Abdullah had attended the previous year's event. Mr. Vaiko said he could not contact Mr. Abdullah despite his best ef-

"On or around August 5, Farooq Abdullah was placed under detention in Srinagar," it said.

An MDMK release in Chennai said, "Farooq Abdullah had accepted the invitation to attend the event. Due to the situation prevailing in Kashmir, it is learnt that leaders, including Mr. Abdullah, are kept in house arrest. They could not be reached."

The petition said Mr. Vai-

ko had written to the authorities on August 29, seeking permission to allow Mr. Abdullah to attend the conference in the "spirit of encoudemocratic raging participation."

No response

However, neither the Union Home Ministry nor the State government chose to respond to his letter.

"The actions of the respondents [Union and State] are illegal and arbitrary and violative of the right to protection of life and personal liberty, right to protection from arrest and detention and also against right to free speech and expression, which is the cornerstone of a democratic nation," the petition said.

Any limitation on the fundamental freedoms of free speech and expression imposed in the guise of a "reasonable restriction" should be narrowly interpreted by the Supreme Court in order to maintain the spirit of democracy.

Chidambaram moves Delhi High Court for bail

He has been under detention for 21 days in INX Media case

Former Finance Minister P. Chidambaram, who has been under detention for 21 days in connection with the INX Media case, approached the Delhi High Court on Wednesday seeking regular

Mr. Chidambaram, in his petitions that also challenged a trial court order remanding him in judicial custody till September 19, has said that he is being prosecuted for his being a political opponent of the party in

The 74-year-old said he is a senior spokesperson of the Congress and has been vocal, both in his speeches and writings, in his opposition to BJP-led government.

"...the instant criminal proceeding is mala fide and is born out of political vendetta, and that the investigating agency is acting at the behest of the Central government, which wants to malign the untainted and unimpeachable reputation of the petitioner," the plea said. It

Mr. Chidambaram was first arrested on August 21 from his residence in Delhi by the CBI.

The case relates to a first information report (FIR) registered by the CBI on May 15, 2017 against alleged irregularities in the Foreign Investment Promotion Board clearance provided to INX Media for receiving overseas funds of ₹305 crore in 2007, when Mr. Chidambaram was Finance Minister. The Enforcement Directorate (ED) is also investigating the alleged

offence of money laundering arising out of the FIR.

"As far as FIPB cases were concerned, the petitioner (Chidambaram) approved only those cases that were recommended by the FIPB and put up to the petitioner by the Secretary, Economic Affairs," the petition said. Mr. Chidambaram said

that during the period when he was in CBI custody, he was confronted with five officers of the Finance Ministry, who were involved in the processing of the FIPB file pertaining to INX Media.

"All of the aforesaid persons have affirmed the correctness of the approval granted to INX Media. Neither of them has alleged any illegality in the approval," his petition said.

He said the CBI and ED had not found "even an iota of evidence of any payment by INX Media or INX News to the Petitioner or to his son Karti P. Chidambaram, coaccused in the subject FIR."

Mr. Chidambaram said there was no likelihood of him absconding and not being available for trial.

India-Poland direct flight from today

Economic ties between India and Poland will receive a boost with the beginning of direct flights from Sept. 12. According to Polish sources, the flight will be operated by LOT Polish Airlines and the first flight will fly Polish Deputy Foreign Minister Marcin Przydacz to India.

The direct flight will connect New Delhi with Warsaw and will operate five times a week. His visit comes weeks after the External Affairs Minister Dr. S. Jaishankar's trip to Warsaw. He is expected to meet Minister of Civil Aviation Hardeep Singh Puri and T.S. Tirumurti, Secretary of Economic Affairs in the Ministry of External Affairs. Business and connectivity will be priority during the visit. He will preside over the Sept. 13 meeting between the Polish Agency of Trade and Investments and FICCI. MoUs between the University of Poland and the Jawaharlal Nehru University will also be signed.

His visit will also emphasise the common Indian and Polish experience of World War II.

sources said. The IBGs, each tailor made based on threat, terrain and task, are part of the overall force transformation initiated by Army Chief Gen. Bipin Rawat. They are brigade-sized agile self-sufficient combat formations which can swiftly launch strikes against an adversary.
