### MGNREGA wages to be pegged to inflation

"They have now agreed to update the indices annually. MGNREGA wages will be linked to whichever index is higher in a particular State," said the official, estimating that the increased wages based on updated inflation indices may result in 10% higher government expenditure on the scheme.

Wage rate revisions are usually notified at the beginning of a financial year, but the Ministry is trying implement the hike during the current year itself, as part of a stimulus package to counter the ongoing slowdown.

"If transferring expenditure [via MGNREGA] is done, rural wages could increase and that could percolate down into more purchasing power in the hands of the consumer," said Soumya Kanti Ghosh, chief economic advisor for the State Bank of India.

According to the latest Periodic Labour Force Survey, market wages for men were higher than MGNREGA wages by 74% in 2017-18, while for women, it was a 21% gap. "They must first increase the wages and subsequently ensure better inflation indexation. Otherwise, the impact will be minimal," said Dr. Sinha.

Even with existing wages, the scheme is running out of funds due to increased demand for work. MGNREGA received a budgetary allocation of ₹60,000 crore, of which more than 75% has already been released by the Centre even before the halfway point of the year. Last week, the RD Ministry asked the Finance Ministry for an additional supplementary grant of ₹15,000-₹20,000

### Modi has ended policy paralysis: Shah

Union Home Minister Amit Shah on Tuesday attacked the Congress for its "culture of policy paralysis", alleged corruption and unguarded borders prior to 2014, saying people then wondered whether India's democratic multi-party system had failed.

"After nearly 70 years of Independence, there was a question in the minds of the people whether the vision of the founding fathers had really been real-Whether multi-party democratic system had failed to fulfil the aspirations of the citizens of the country," he said at an event of the All India Management Association.

In this scenario, the nation in 2014 gave a resounding majority to the Narendra Modi-led government, an absolute majority government for the first time in 30 years, Mr. Shah said. He said previous governments could take only five decisions in the past 30 vears, whereas, the Modi government took over 50 decisions in the past five

#### **Congress reacts**

The Congress said Mr. Shah's statement was "belittling India's multi-party democracy and shocking".

Senior Congress leader Anand Sharma said, "Given India's rich diversity, only a multi-party system can be inclusive and representative of the Union of India. The NDA itself is a multi-party alliance and its member parties have formed governments in States. I hope that Nitish Kumar, Parkash Singh Badal, Uddhav Thackeray and others are listening."

Mr. Modi, who turned 69 on Tuesday and celebrated his birthday in Gujarat, his home State, made the remarks at a rally near the Sardar Sarovar Dam, where he offered prayers. The dam achieved the full reservoir level for the first time, State-wide prompting celebrations. Lauding Sardar Patel for

his role in the annexation of Hyderabad princely State with the Indian Union in 1948, the Prime Minister said September 17 was celebrated as the Hyderabad Liberation Day because of the vision of the late leader.

"Just imagine that had the foresight of Sardar Patel not been there and he would not

have been given the task of integration, what kind of a map India would have now. Today, India is trying to fulfil his resolution of "One India, excellent India" and comhis uncompleted plete tasks," he said.

Mr. Modi said he was happy to see the rising number of visitors to the Statue of Unity of Sardar Patel, built by the Gujarat government at a cost of ₹3,000 crore overlooking the Sardar Sarovar dam on the Narmada Mr. Modi arrived at Keva-

diya in the morning to take part in the "Namami Narmada" festival being celebrated by the State government to mark the filling up of the dam to its full reservoir level of 138.68 metres due to heavy inflow of waters from the Narmada's catchment areas in Madhya Pradesh. After attending the rally in Kevadia, the Prime Minister flew back to Gandhingar where he visited his mother.

## All 4 accused in Bettiah gang-rape case held

Police deny that victim was recently released from the Muzaffarpur shelter home

All four persons named as accused in the Bettiah gangrape case have been arrested and the complainant, who claimed she was 18 years old, turned out to be a minor, a police officer said on Tuesday.

'Confessed involvement' Additional Director General of Police (Headquarters) Jitendra Kumar said that the four accused, including two brothers, have confessed to their involvement with the girl last

Bettiah SP Jayantkant said all four accused named in the FIR - Akash Kumar, Sajan Kumar, Kundan Kumar and Anshu Kumar – have been ar-

"All of them, including si-

blings Akash and Sajan, are said to be known to the girl. The victim and the accused reportedly used to visit each other," he said.

Earlier, the SP had said that the complainant, in her FIR, stated she was raped by the four on Friday in a moving car in Bettiah, the district headquarters of West Champaran. Mr. Jayantkant had also said that the medical examination reports of the girl showed "no internal or external injury" which was unusual in case of a sexual assault. He, however, maintained that the police had "not ruled out anything" as of now.

### 'Girl a minor'

In Patna, the ADG said, "The girl's medical examinations suggest that her age is between 15 and 17 years. During interrogation, the accused have confessed that they had intercourse with the girl. Even if it was with mutual consent, it becomes immaterial and falls in the category of an offence as the girl is a mi-

Search for another man He also said that police were looking for another unnamed person in connection with the

The ADG clarified that the girl was not among the eight former inmates of the Muzaffarpur shelter home who were recently released and reunited with their families upon a Supreme Court

"The girl had gone missing from her home in May last year and found at a railway station in Muzaffarpur. She

was kept at the shelter home for a week and shifted to Mokama thereafter. She was released from the Mokama care unit," the ADG said.

He, however, declined to divulge more details about the girl, saying "the identity of a sexual offence victim, especially a minor, has to be kept secret. Sharing more information will give it away".

Expressing outrage over the Bettiah incident, the National Human Rights Commission and the National Commission for Women had shot off missives to top officials in Bihar.

The NCW, which took suo motu cognisance of the incident, asked the Director General of Police to treat the case on priority, while the NHRC sought a detailed report in four weeks.

## Assam police take action in stripping case

# Ayodhya: SC delves into motifs

Advocate says arguments on the Hindu side are based on theology not legality

Lotus carvings on Kasauti pillars, figurines, Garuda flanked by two lions and a Dwarapal are not typical features of a mosque, the Supreme Court confronted the Muslim side in the Ayodhya

Constitution Bench led by Chief Justice of India (CJI) Ranjan Gogoi was based on architectural features and photographs of materials believed to be unearthed from the Babri Masjid- Ramjanmabhumi site.

But senior advocate Rajeev Dhavan countered the court's questions, saying the "decorative pieces could have come from anywhere". These objects and photographs of carvings did not provide a conclusive proof that there was once a temple dedicated to a particular deity - Lord Ram. "There is no of a God in Ramjanmabhumi," he argued.

Mr. Dhavan said the Hindu side's argument of a temple of Lord Ram drew strength from the impression that mosques should be simple, unadorned. Mr. Dhavan said the Hindu side arguments were based on theology rather than legality and concrete proof.

"The theological argument raised here is just because they see some flowers, a lotus, this place is unIslamic and the mosque is not a mosque. It is too much to say that Islam is out, mosque is out just because you see a few figurines, flowers, etc. It is a little too rich to say a mosque is not mosque and prayer offered was not prayer," he argued.

Justice D.Y. Chandrachud suggested the presence of these material objects, which were either found at the site of the mosque or formed part of the Babri



Masjid's architecture, may have been due to cultural assimilation. "Cultural assimilations occur after invasions. We see how certain religions are practised differently in different countries," Justice Chandrachud pointed out.

Latching on to that, Mr. Dhavan said, "Mosques were not built by Muslims alone... Taj Mahal was not built by Muslims alone. Both Hindu and Muslim labourers joined hands."

"Just because there is

places of worship of different religions coexist in physical proximity. He said pillars would have

either been found lying around at the time of the construction of the mosque or were found broken and fixed to be used for the mosque, or they were brought to the site from other places. The presence of these objects did not make Babri

mosque "unIslamic or un-Quranic". "You cannot use them to claim Muslims were not praying to Allah there but to some other god," Mr. Dhavan said.

Justice S.A. Bobde asked whether there was any witness to back their claim that these materials and carvings were a result of cultural assimilation.

Mr. Dhavan replied, "Assimilation is there for My Lord to see. There is a chhabutra outside and a mosque inside. The British had allowed both for the sake of peace."
