

Latest push: Camps in 400 districts for easy loans

STATE-OWNED banks and Non **Banking Financial Companies** (NBFCs) will jointly organise loan distribution programmes in 400 districts across the country in the next one month for retail, agriculture and MSME customers, Finance Minister Nirmala Sitharaman said Thursday after a review meeting with heads of public sector banks.

To provide relief to Micro, Small and Medium Enterprises (MSMEs), the government has advised banks not to treat stressed MSMEs loans as Non Performing Assets (NPAs) till March 31, 2020, and instead work towards timely resolution of these, she said. The relief will be provided under existing guidelines of the Reserve Bank of India.

"We have decided that in 200 districts of the country between now and September 29, there shall be a gathering which the banks will have of the NBFCs with whom they have tied up and given liquidity, and retail customers of the bank or new retail customers, all coming **CONTINUED ON PAGE 2**

Tiger count up but official photos show one in seven could just be a paper tiger

ON JULY 29 this year, the government announced its quadrennial tiger survey: 2,967 tigers nationwide and as many as 2,462, almost 83%, of them photographed. This is a jump from the previous survey in 2015 that counted 2,226 tigers and ostensibly photographed 1,635 almost 73%. The latest photos haven't been made public but officials pointed to photos taken for the previous survey to say that such a high share of tigers being photographed leaves little room for extrapolation or inaccuracy.

India's tiger population is undoubtedly on the rebound thanks to better protection and monitoring over the last 15 years. But an investigation of each of the 1,635 and 61 additional photos in the 2015 report by The Indian Express puts a question mark on the counting process.

For, by well-established norms of wildlife population estimation, 221 of these "tiger photos" should not have been counted. This works out to 16% over-reporting — in other words, there is one paper tiger for every seven tigers in the data. The survey is done by the Wildlife Institute of India and the National Tiger Conservation Authority.

FOREIGN SECRETARY Vijay Keshav Gokhale Thursday said Prime Minister Narendra Modi, who is leaving for the US Friday, will not discuss the issue of Article 370 at the United Nations and will focus on development and other issues when he addresses the United Nations General Assembly in New York on September 27 morning.

Gokhale said Article 370 is an "internal issue", and the Prime Minister will focus on issues related to development and India's role in shaping the global agenda. "Terrorism is one of the issues, but will not be our focus," he said.

While Pakistan has been trying to internationalise the ending of J&K's special status under Article 370, and plans to raise it at the UNGA, India has maintained

At Jadavpur, Left students manhandle MoS Supriyo, Governor rushes to rescue

AMID HIGH drama, Union Minister of State (MoS) for Environment, Forest & Climate Change Babul Supriyo was heckled and manhandled by a section of students at Jadavpur University (JU) on Thursday. The students gheraoed Supriyo for over five hours, stopping him from leaving the campus. When Governor Jagdeep Dhankhar

rushed to IU in the evening, his vehicle was also blocked for about an hour, before a huge police contingent reached the campus and escorted them out.

Supriyo later alleged that he was assaulted. "I was severely thrashed, my hair was pulled, and I was punched and kicked," he said. "This is not expected from students of JU. If they have a problem with me coming here, they should have debated the matter. They should not have CONTINUED ON PAGE 2



25 letters to PM, \$2.4 million, oil surveyor, judge — Howdy!

WHAT BEGAN as 25 letters sent to Prime Minister Narendra Modi in June, inviting him to Houston during his US visit, has now become a mega event, with \$2.4 million collected by prominent Indian-American business leaders from 40 major donors and hundreds of smaller donors to host him at "Howdy, Modi!"

on Sunday. In June, some of the city's Indian-American professionals heard that Modi would be coming to New York in September for the UN General Assembly meet-

ing. Later that month, they learnt that along with their home, two other cities were in the running Chicago and Boston — to host him. The India-US negotiations

over Iranian oil sanctions had just peaked, and Houston, with 150,000 Indian-Americans, found its main selling point. "Houston has a very vibrant

Indian diaspora and it's a big energy capital. Energy security is a top priority of India," BIP's foreign affairs head Vijay Chauthaiwale said from Houston.

"India needs energy, and Houston has lots of energy. There could be a strategic partnership," said Jugal Malani, chair of the Texas India Forum. Malani said the Forum was created in July specifically for organising the Modi rally, because they "didn't want to be associated with any other existing organisation". "None of us have experience of putting together an event like this," he said.

Along with a main committee of six members, there are 20 working committees, adding up to roughly 200 people. And then there is an army of volunteers.

From the owner of a company that surveys oil fields, to the founder of Chinmaya Mission in Houston, a Congress lobbyist, a county judge — the drivers of the two-month long preparation are

focussed on boosting India-US trade relations. Several of the prominent donors and organisers are wealthy business owners of oil, gas and energy companies, as well as corporate donors like

Walmart and OYO USA. After moving to the US in 1981 to work for his brother-in-law's small business, Malani began his own industrial products company 17 years later. For the last two decades, he has been the CEO of the Unique Industrial Product Company, supplying metal products domestically and globally.

"Houston is the energy capital of the world, and India consumes 10% of the world's energy," Forum spokesperson

Gitesh Desai said. "It has an interest to go to Houston and talk to the energy leaders."

In 2008, Desai was the president of the Indo-American Political Action Committee, a lobbying group that has contributed almost equally to Democrats and Republicans according to online records. It lobbied for the India-US nuclear deal as well as auditing of US aid to Pakistan, said Desai, who received the Pravasi Bharatiya Samman Award in 2019.

Besides Malani, funding came from Swatantra Jain, who serves as senior vice president and director of petrochemical **CONTINUED ON PAGE 2**
