Karnataka bypolls will be deferred, EC tells SC

He said it was "not defection if you give up membership of a political party for reasons of conscience, then you resign and go back to face the public mandate. This is recognition of the MLAs right to resign". He submitted that for an MLA, his constituency was sovereign. A party whip cannot stop him from doing good for his electorate. In such cases, the legislator may opt to resign rather than continue his participation in an ineffectual government.

Senior advocate C.A. Sundaram, for former Congress MLA D. Sudhakar, had submitted that the authority of the Speaker when faced with the resignation of an MLA was limited. The Speaker was to only see if the resignation was voluntary or genuine.

"A Speaker is not the party boss. He is the master of the house and not the president of the party," he said.

Senior advocate Mukul Rohatgi, for some other disqualified legislators, had highlighted the procedural flaws in the events leading to the disqualification, including the lack of notice

In contrast, Bangladesh Prime Minister Sheikh Hasina refused to make any comment on Kashmir, indicating her support for the government's actions.

When confronted with a direct question from an audience member at the Council on Foreign Relations on why the Islamic world had not raised the issues of Kashmir and the Rohingya refugees more forcefully as a collective, Ms. Hasina said it was because the OIC is 'not united" and there are differences between countries that have "more resources" and those who have less.

Turkish President Recep Tayyip Erdogan, the only leader to raise Kashmir at the UN thus far and said Kashmir remains "besieged and eight million people are stuck in Kashmir despite resolutions adopted by the UN Security Council", stressed that the only solution for the "Kashmiri people" through dialogue.

Modi meets Rouhani, discusses Chabahar

Despite a sanction carve out for India's participation in the construction and development of Iran's Chabahar port – a strategic project that would connect India, Afghanistan and Iran to Central Asia, while circumventing Pakistan – work on the project was "very slow", Ali Chegeni, Iran's envoy to India, had told *The Hindu* earlier this month.

Mr. Chegeni had also said that India should not have cooperated with the U.S.

sanctions. The meeting comes a day before Mr. Modi's UNGA address and a day after Mr. Rouhani's, in which the Iranian leader had said Iran would not talk to the U.S. unless sanctions were lifted.

European countries, such as France and Germany had hoped to arrange a meeting between Mr. Rouhani and U.S. President Donald Trump.

Pakistan Prime Minister Imran Khan said on Tuesday that Mr. Trump had enlisted his help in mediation and that he had spoken with Mr. Rouhani.

However, Mr. Trump left New York shortly after noon on Friday without having met Mr. Rouhani.

NSA discusses steps to ease J&K curbs

Decision on the phased restoration of mobile telephony in the Valley to be announced soon

National Security Adviser (NSA) Ajit Doval camped in Srinagar ahead of Prime Minister Narendra Modi's address at the United Nations General Assembly in New York on Friday.

For the past week, security officials have been making arrangements to ensure no violence is reported in Kashmir in the wake of the highprofile event as it might affect India's image globally. Mr. Doval did not accompany Mr. Modi unlike on other visits when he was a regular part of his entourage.

Series of meetings

Mr. Doval held a series of meetings in Srinagar to review the security arrangements and discussed measures to ease restrictions in Kashmir further. He appreciated that no complaints regarding human rights violations were reported from any part of Kashmir Valley

J&K students reject invite of Adityanath

Kashmiri students of Aligarh Muslim University have rejected the invitation of Uttar Pradesh Chief Minister Yogi Adityanath to discuss the advantages of the removal of Article 370 in J&K. Mr. Adityanath on Wednesday invited 40 Kashmiri students from different districts of the State through magistrates to share their concerns.

Bilal Majid, a Ph.D. scholar in the Department of History, told The Hindu that the Kashmiri students had unanimously decided not to accept the invite as it could be used "to perpetuate the propaganda that everything is normal in Kashmir". He said the district administration pursued them but they politely declined. "Our conscience doesn't allow us. However, if there are one or two students who want to go, they could attend the meeting," said Mr. Majid.

No clarity on Maharashtra for BJP

Party's poll panel likely to clear names for Haryana on September 29

The BJP will most likely hold a meeting of its central election committee on or after September 29 for clearing the candidates for the Haryana Assembly election, and await the declaration of its seat-sharing arrangement with the Shiv Sena for the Maharashtra polls around the same time.

Party president Amit Shah was engaged in day-long meetings on Wednesday and Thursday with core groups of both States at the BJP headquarters in New Delhi. International wrestler Yogeshwar Dutt, former India hockey captain Sandeep Singh and Shiromani Akali Dal MLA Balkaur Singh joined the party while the meetings were under way.

Mr. Singh has sought ticket for his wife and has offered to resign his Rajya Sabha seat to facilitate the nomination.

The new entrants into the party and wrestler Babita Phogat are tipped to get ticket, with sources saying several new faces will be fielded and around 15% of sitting MLAs will be dropped.

The situation in Maharashtra is a tad more complicated with the BJP and the Shiv Sena yet to make an announcement over seat-sharing arrangements and the BJP holding out for a more dominant position in the alliance looking at the altered political situation on the ground.

Region-wise review

At Thursday's meeting, where Chief Minister Devendra Fadnavis was also present, sources said Mr. Shah held a region-wise review of the State.

"Most likely, the seat-sharing arrangement will be cleared by the high command here, but declared in Mumbai with Shiv Sena president Uddhav Thackeray in tow," added the source. While some numbers are making the rounds, the only thing that is clear is that the BJP is determined to take the largest share.

Justice S.A. Bobde of the Supreme Court said on Thursday that the court could not be expected to reconstruct the history of the Babri Masjid site from ruins, and Archaeological Survey of India (ASI) findings may not be

"authoritative". The oral remarks of the judge, who is part of the Constitution Bench led by Chief Justice of India Ranjan Gogoi, came when the Muslim side argued that if the Hindu side could infer a grand temple from materials unco-

vered in the ASI excavations at the Babri Masjid site in 2003, nothing prevented the Muslim parties from deducing the pre-existence of an Idgah mosque on the very same spot.

'Conjecturing so much' Senior advocate Meenakshi

Arora, for the Sunni Wakf Board, pointed to how the ASI report even inferred there was a circular shrine, believed to be of the sixth century and dedicated to Shiva at the site. "We are inferring so much... conjecturing so much," she rued about the

nature of the court hearings which reached their 32nd consecutive day. "We cannot reconstruct what happened from the ruins, that is why we want expert opinions," Justice Bobde reacted.

"This [about the shrine] is there in the ASI report... It is

the ASI which is saying there was a shrine. The experts [ASI] themselves are inferring. That is why archaeology is an inexact science. We dig and we imagine our past," Ms. Arora said.

the pre-existence of a massive, multi-pillared structure believed to be a Hindu temple dedicated to Lord Ram and thus proof of his birth at the spot. Ms. Arora, however, went on to reveal that the ASI report also has references to finding "Islamic material" during the excavation.

"Lime surkhi is used in some of the materials dug up by the ASI. Lime surkhi is synonymous with Mughal construction. It is not possible to find the use of lime surkhi in the construction of structures believed to be built centuries before the entry of the Mughal sultanate," Ms. Arora explained.
