

DAYS BEFORE they demit office, the long-standing dispute within the Supreme Court-appointed Committee of Administrators (CoA) is out in the open.

Former India captain Diana Edulji, one of the members of the CoA, has broken her silence to lash out at the two other members, saying she is "not at all happy" with the processes adopted by the committee. "We are not very open, we are seen favouring certain states. That is not the idea of CoA, even today Justice RM Lodha said dilution is too much," she told *The Indian* Express.

This was a reference to a remark by Justice (retd) Lodha Friday — whose roadmap set up the CoA — that the reform process has been diluted.

On Thursday, BCCI electoral officer N Gopalswami disqualified nominations from five state associations and three government bodies in the electoral roll for the elections, set to be held in Mumbai on October 23, which CONTINUED ON PAGE 4


Both leaders will meet again today; delegation-level talks to follow; investment areas to be focus

PICKING UP from Wuhan where they met in April last year, Prime Minister Narendra Modi and Chinese President Xi Jinping, on Day 1 of their second informal summit, Friday said that "radicalisation was a matter of concern" to both countries and they would work together to see that radicalisation and terror do not affect the fabric of the multicultural, multi-ethnic and multi-religious societies in their countries. Disclosing what transpired at

the 150-minute one-on-one discussion between the two leaders in the seaside town of Mahabalipuram near Chennai, Foreign Secretary Vijay Gokhale said both leaders felt that radicalisation and terror was a "common challenge" for both countries which are "diverse" and "complex".

While sources did not rule out the possibility of J&K having been discussed, the indications that the Chinese **CONTINUED ON PAGE 4**

Bengal on boil over killings, family says no link to any Parivar, only ours

JIYAGUNJ. SAHAPUR. OCT 11

AS THE murders of Bandhu Prakash Pal, his wife and fivevear-old son in Murshidabad snowballed into a political row with the BJP targeting the ruling TMC government in West Bengal claiming Pal was an RSS functionary, his family Friday said he was not associated with any political party or organisation and lashed out at both parties for politicising the issue.

Pal (40), a teacher, his wife Beauty (30) and their son Angan (5) were found murdered at

their home in Lebu Bagan area of liagani Tuesday.

"He was like a white paper. Who told you he is a BJP member? He was never associated with BJP or Trinamool Congress. He was never with RSS. These are lies being spread," said Maya Pal (68), Pal's mother at their house in Barala village, Sahapur under Sagardighi police station.

The bodies of Pal and his son were found in one room and Beauty's in another. Police said husband and wife were hacked to death and Angan strangled first and then assaulted with a heavy object to ensure that he died. Police said four men were **CONTINUED ON PAGE 4**

Corporate tax cut: 'Suit boot ki sarkar jibe stalled it, welfarism helped it'

THE CORPORATE tax structure reforms announced by the NDA government last month were initially proposed four to five years ago but the "suit, boot ki sarkar" jibe made it difficult for the government to undertake the corporate tax reform, Arvind Subramanian, senior fellow at Washington-based Peterson Institute for International Economics and former Chief Economic Adviser, said.

Speaking at the O P Jindal Distinguished Lectures at the Institute Watson International and Public Affairs, Brown University, Subramanian said that in the wake of the current downturn, the government

acquired the political capital to undertake more difficult reforms such as the recent corporate tax reform. Subramanian was CEA when former Congress president Rahul Gandhi directed the "suit boot ki sarkar" jibe at the NDA government in October 2014.

IN AN unusual interpretation of the model code of conduct, six students of the Mahatma Gandhi Antarrashtriya Hindi Vishwavidyalaya (MGAHV) in Maharashtra's Wardha have been expelled for organising a dharna and writing a letter to Prime Minister Narendra Modi

protesting, among other things,

rising incidents of mob lynching

and "shielding" of leaders

accused of rape.

In an order issued October 9, Acting Registrar Rajeshwar Singh said the students were being expelled for "violating the 2019 assembly election code of conduct and interfering in the judicial process" by organising a group dharna.

Chandan Saroj, one of the six students thrown out, said though some 100 students were present at the dharna on October 9, university authorities took action "selectively against three Dalit and three OBC students". He said "there were many upper caste students too in solidarity

The expulsion order identified the students as Chandan Saroj (M Phil, Social Work); Neeraj Kumar (PhD, Gandhi and Peace Studies); Rajesh Sarthi; Rajneesh Ambedkar (Women's Studies Department); Pankaj Vela (M Phil, Gandhi and Peace Studies); and, Vaibhav Pimpalkar (Diploma, Women's Studies Department).

reform and partly driven by the fact that the backs are against the wall and it was kind of that we have to do something. I think this was an idea which was actually actively considered four to five years ago and rejected. I don't want to go into all the personal angles here. But looking back I realise that the taunt of suit, boot ki sarkar, that the government was vulnerable to, also made it difficult to undertake the corporate tax reform. It's this new welfarism that burnishes the pro-poor credentials that then you acquire political capital to do the more difficult reforms like corporate tax reform. There is a deeper thing going on which we can't dismiss so easily and the corporate tax reform is an example of that," Subramanian said.

He also said that if UPA-2 was paralysis, Modi-I was hyperactivity. "It was hyperactivity, but with vision. That can't be a criticism," he said in his role as commentator at the lecture series titled 'India's Economy: How Did We Get Here and What Can be Done?' "New Modi welfarism is pub-

lic provision of essential goods and services: cooking gas, toilets, banks accounts, power, housing and medical insurance and now water. It is vision...political strategising plus energetic implementation and follow-up, must be acknowledged", he Commenting on other reform measures of GST, Subramanian said there might have been implementation challenges but those can't be termed as lack of vision. For Insolvency and Bankruptcy Code, he said, it's proving to be insufficient, but the original conception cannot be faulted. "Even demonetisation cannot be accused of lack of vision," he said.

Professor of finance at Chicago Booth School and former RBI Governor Raghuram Rajan, who was key speaker at the lecture series, however, said he disagreed with Subramanian about the measure having a vision.

"I find it strange to call demonetisation as something with vision. Of course, everything has a vision behind it but the question is: is it a coherent vision? Is it a vision that takes us forward? Unfortunately, I disagree with you on it," he said.

Subramanian said India's financial system has been kept alive basically through recapitalisation and now there is "twin plus twin

balance sheet" challenge, wherein there are rising NPAs once again and intensification of corporate stress. "You saw the NBFCs lending, which was basically a weakening of regulatory standards. Now, as a consequence of limited action and limited reform, the fact that growth has been slow, we have gone from twin balance sheet, which had banks and infrastructure companies, to what I will call a twin plus twin balance sheet challenge, where on the financial side the non-bank financial companies have been added to the stress and the borrowing side, it's not just big infrastructure companies but certainly real estate companies have also come into the problematic category," he said, adding that investment and growth cannot durably revive without addressing this twin plus twin challenge.

Rajan, however, was more despairing. "Basically signs of deep malice, significantly lower growth and narrowing fiscal space (indicate that) India is losing its economic way. I will argue that perhaps the reason is, we are centralising power without a persuasive economic vision and if we do this we risk wasting the demographic dividend," he said.

Brushing aside suggestions that slow global growth, trade and oil prices are behind the slowdown in India's GDP growth and economic activity, Rajan blamed it on sins of both "omission and commission".

"There is an attempt to say that this (slowdown) is because of outside. To blame the outside is probably wrong. What probably is a better explanation is that it is a consequence of not having invested since the global financial crisis and lack of significant reform over the same period. These acts of omission, in some sense, combined with acts of commission. The sequence of demonetisation and goods and services tax, essentially was the straw, that seems to have broken Indian economy's back because it came at a time when the economy was relatively weak," said Rajan.

Arguing that India must open up its economy, Rajan said that India grew stronger and saw higher investment, consumption and export growth "when India became a much more open economy" and today in some sense "closing down relative to the past. On the one hand growth has been relatively slow, but the fiscal is also a source for concern".

"What one would want for is slashing in some of the old regulations that hold back firms and focusing on improving the ease of doing businness...There has been some attention but largely focussed on world bank indicators of ease of doing business rather than the actual conditions in india on what prevents businesses from working easily," said Rajan.







Five senior leaders hold press conference demanding Chacko's removal, allege he leaked letter

WITH LESS than three months to go for the Assembly elections, the Delhi Congress has plunged into a full-blown crisis with factional feud that had so far remained behind closed doors going public.

With various factions eyeing the Delhi Pradesh Congress Committee president's post, the war escalated to an extent that AICC in-charge P C Chacko was blamed for leaking a letter written to him by former Chief Minister Sheila Dikshit's son and former Lok Sabha MP Sandeep Dikshit.

In the letter, Sandeep is learnt to have written that Chacko caused mental agony to Sheila in her last days, which led to her sudden demise. On Friday, a section of the Delhi Congress leaders demanded Chacko's removal, accusing him of "leaking" the personal letter.

Meanwhile, senior Delhi Congress leaders Kiran Walia, Ramakant Goswami, Jitender Singh Kochhar, Mangat Ram Singhal and Rohit Manchanda held a press conference in the evening demanding Chacko's resignation over the alleged leak of the letter.

"This is a betrayal of faith. We were surprised to see the letter being widely discussed. He has been taking decisions on his own for the state unit. We had met Chacko ji earlier as well and requested him not to pass comments on Sheila ji," Walia said.

"We want Chacko ji to be immediately removed from the post of AICC Delhi in-charge and request Sonia ji to order an inquiry in the matter. The party against those found guilty," said Goswami.

Exemptions to 2-wheelers will undermine odd-even: Transport dept opinion

THE POTENTIAL benefits from the odd-even scheme will be "lessened significantly" if twowheelers are exempted, the Delhi Transport Department has observed, arguing against blanket waivers to scooters and motorbikes during the enforcement of the vehicle rationing drive from November 4-15.

Responding to Chief Minister Arvind Kejriwal, who had sought to know if women, CNG cars and two-wheelers should be exempted from the scheme, the department suggested that twowheelers be allowed to ply till 11 am on odd-even days and the Delhi government's office opening hours also be shifted to 11 am.

However, the exemptions to women and CNG vehicles should continue, the department has said. The Delhi Traffic Police, however, has not sent its suggestions on the exemptions so far, saying they are yet to get them vetted by the Commissioner of Police.

carte blanche exemptions are given to all categories of twowheelers from the restrictions to be imposed during odd-even drive," the Transport Department note, which is now being examined by Kejriwal, states.

Transport Minister Kailash Gahlot, however, told The Indian Express that two-wheelers will have to be given certain exemptions as the existing transport infrastructure will not be able absorb the load. "Staggered office hours can be implemented in case of Delhi government offices. In case of private sectors, we can just issue advisories. A considered decision will be taken soon," he

said. The note, prepared after extensive deliberations within the

department, states that around 88% of Delhi's registered vehicles which comes to around 66.5 lakh, are two-wheelers, fuelled completely by petrol and diesel.

Two-wheelers compliant with BS-IV emissions norms which kicked in on April 1, 2017, are 12 lakh out of the total registered bikes. "It has been reported that the regulation for BS-IV compliance not only tightened the HC+NOx values (sum of Hydro Carbons and Oxides of Nitrogen by 23-60% compared to existing BS-III standards but also specified independent NOX standards for two-wheelers," the note adds.

However, since the RC (registration certificates) of bikes do not have any mention of whether they are BS-IV compliant or not it will not be possible to exempt them despite being less polluting, a senior official said.

Since not giving any exemption would cause inconvenience to a massive number of people dependent on two-wheelers, the department has suggested that they be exempted from the scheme till 11 am on the days the policy will be enforced. Like the previous two phases, odd-even is likely to be in place between 8 am to 8 pm every day.

Suspects in snatching that left journalist injured held after shootout near Nizamuddin rly station

AT LEAST 12 rounds of gunfire were exchanged between Special Cell officers and two men near Hazrat Nizamuddin railway station early Friday morning. After the arrest of the two men, Anil Ram (26) and Arun Kumar (24), police said they were also involved in robbing an ANI journalist in CR Park last month. On September 22, the woman, Joymala Bagchi, had suffered a jawline fracture after she was pulled out of a moving auto by the accused who attempted to snatch her phone.

PASSENGER WAITING rooms at the New Delhi and Hazrat Nizamuddin railway stations have been given a makeover, with the addition of new amenities and fresh interiors.

Upgraded under a public-private partnership (PPP) model, the revamp is an initiative of the Commercial Department of Northern Railways' Delhi division, and has cost over Rs 4 crore for the New Delhi and nearly Rs 2 crore for the Nizamuddin stations.

Railway officials said the waiting rooms earlier had several problems, including overcrowding and lack of facilities.

"AC waiting rooms encountered rampant unauthorised entry and elongated usage by passengers. Overcrowding led to inadequate cooling, and available assets were always stretched to the limit," A Northern Railway official said.

"Non-AC waiting rooms, being largely unmanned, were never preferred. Due to the poor ventilation, lighting and ambience inside, passengers preferred waiting on platforms," the official added.

The new waiting rooms, both air-conditioned and sleeper, have improved security, in addition to food and beverage counters and staff for guiding passen-

People using AC waiting rooms would have to pay a charge of Rs 10 per hour per person and Rs 5 for children between the ages of five and 12. Sleeper waiting rooms can be used for free.

These charges have been set for a period of five years under the PPP contract. They would be increased to Rs 20 per hour for adults and Rs 10 per hour for children for AC waiting room if

an extension of five years is granted to the contract. Sleeper waiting areas would still be free, officials said.

At the Nizamuddin railway station, Jagruti Kansara, who was travelling with five passengers from Haridwar to Pune and had an eight-hour stopover in Delhi, suggested that the AC waiting room should be free to use for two hours.

"If a private company has made these waiting rooms and wants to charge the public, they can be shifted outside. On the platform, as is our right, the government should allow passengers to use the waiting facility for

free for two hours, after which it can be charged," she said.

Railway officials said the AC rooms have a charge so that the PPP firm is able to recover the money spent on the project. "It was thought that people travelling in AC train compartments can pay Rs 10 per hour extra to use the waiting rooms. We have kept sleeper waiting rooms free of cost after considering that not all passengers may not be comfortable with paying an extra charge," an official said.

Contract for the upgradation of two waiting rooms at the Old Delhi station has also been awarded, the official said.

On video conference, CM says will set up task force to meet C40 targets

DELHI SIGNED the 'C40 Clean Air Cities Declaration' Friday, pledging to implement a slew of clean air policies under the watch of a Special Task Force (STF) chaired by Chief Minister Arvind Kejriwal. The Chief Minister made the announcement during a joint press conference at Copenhagen C40. which he addressed via video conferencing.

In his opening remarks, Kejriwal said that he "could not be here due to unavoidable circumstances". The Chief Minister was denied political clearance to lead an eight-member delegation to the summit in Denmark by the

Ministry of External Affairs, following which the organisers of the summit offered to let him address the meeting through video conferencing.

"We are going to form an STF in the coming days, which will be chaired by me. It will have ministers, experts and senior officers. We will monitor the implementation of measures under the C40 declaration," Kejriwal said.

Meanwhile, in an official statement, the organisers said: "The pledge unveiled today at the C40 World Mayors Summit in Copenhagen commits cities to set ambitious pollution reduction targets and implement substantive clean air policies by 2025."

If the 35 signatories to the declaration reduce annual average

PM2.5 levels to WHO guidelines (10 ug/m3), the statement said, "it could avoid 40,000 deaths each vear". The Central Pollution Control Board's safe standards of PM2.5 are 60 ug/m3 (microgram per cubic metre). Apart from Delhi, there are 34 other signato-

ries to the declaration, including Bengaluru, Barcelona, Los Angeles, Paris, Sydney and Washington DC.

In his speech, Kejriwal listed the measures taken in the capital since the AAP government took office in 2015, including two phases of odd-even scheme, closure of thermal power plants operating from within the city's limits and discouraging use of diesel generators.

on air quality later, Kejriwal said his government decided to implement the Odd-Even scheme despite being warned that the move may upset people and have political consequences.

Addressing a closed session

"We received positive feedback from the citizens, and they accepted it wholeheartedly... This lifted our spirits and pushed us to take several other steps," he said.

The CM also praised environment activist Greta Thunberg for uniting people across the world on the issue of climate change.

Later, in a tweet, Kejriwal explained why he spoke in Hindi: "Language is an intrinsic part of any country's culture and identity. If we love India, it is only natural that we love its languages. Indians should also take pride in speaking in any Indian language like people of China, Japan, France do while speaking in their respective mother tongue. This doesn't mean I am against English... But when presenting India's case in global forums, we will do so in our own language with pride."

Task force's target: Bring down particulate matter 30% by 2024

THE SPECIAL Task Force on air pollution, which will be chaired by Chief Minister Arvind Kejriwal, will come under the Dialogue and Development Commission (DDC) of Delhi, which will double up as the nodal agency to monitor the government's clean air initiatives. The task force will tackle longterm challenges in cleaning the capital's air by coordinating with various government departments and agencies, DDC vicechairman Jasmine Shah said.

It has set an ambitious goal of exceeding the targets set under

the National Clean Air Programme (NCAP). The NCAP sets the target of bringing down PM2.5 and PM10 levels by 20-30% by 2024 as compared to 2017.

Shah said the C40 declaration, though not legally binding, will help the government tap into a network of knowledge.

"The vast pool of resources and innovations found across the globe will have to be tapped into and taken into consideration while framing plans to clean Delhi's air. And for that we also need coordination among multiple departments," he said.

The task force will also create a climate transformation plan and budget. So far, members of the panel, which will also have external experts, have not been chosen.

Apart from monitoring big ticket initiatives, such as procurement of buses and rollout of the e-vehicle policy, the STF will also take the lead in executing measures such as greenscaping of 500 km of total 1,260 km roads coming under PWD.

The government also plans to provide a subsidy of Rs 5,000 per tandoor to restaurants to replace coal-based ovens with electric-or gas-powered ones.

"The government will also launch the Delhi Tree Challenge encouraging people to plant saplings in and around their houses," Shah said.

Punjab, Haryana claim farm fires not affecting Delhi's air, Gahlot says their actions not visible



AUTHORITIES IN Punjab and Haryana have denied that stubble burning in the two states is impacting Delhi's air quality, a claim rejected by Delhi environment minister Kailash Gahlot Friday. Weather experts, however, noted a spike in instances of farm fires in the last 24 hours.

Punjab agriculture secretary KS Pannu said a number of measures have been taken to control stubble burning in the state, including distribution of happy seeder and other machines that are alternative to stubble burning. He said 28,000 such machines

ready reached farmers. Additionally, Punjab has recently deputed one additional

chief secretary or principal secretary to each of its 22 districts to monitor residue burning of paddy crops. "We don't think pollution from Punjab reaches Delhi, but it is a problem anyway and therefore these steps are required," he said.

Farmers have already started setting fire to crop residue in the state with Amritsar recording 223 active fires events till October 9, the highest in the state so far.

In Haryana, the state pollution control board's member secretary S Narayanan said the number of active fire cases between September 25 and October 10 have dropped by 116 this year as compared to last year, when 459 cases were recorded.

"This is not the cause of Delhi's air pollution," Narayanan added. The claims were rejected by

Gahlot. "Haryana and Punjab haven't taken mitigating steps. The apathy also stems from the fact that Haryana is going to polls.

None of their actions are visible on the ground," Gahlot said when asked specifically about stubble burning Friday. The average air quality index (AQI) of Delhi remained 'poor' for a second day Friday. The AQI on Friday was 216, five points higher than on Thursday.

Air quality and weather forecasting system SAFAR Friday predicted that Delhi's AQI is expected to remain in the 'poor' category Saturday, and would deteriorate to 'very poor' on Sunday and Monday. "The biomass fire counts in Punjab and Haryana have significantly increased during the past 24 hours. Such magnitude will influence Delhi's AQI," it said.

Kuldeep Srivastava, scientist at IMD, said a light northwest wind has been carrying "stubble matter" with it since Friday, which is impacting Delhi's air quality.

3 women arrested for robbing war veteran in Hauz Khas ATM

EIGHT DAYS after a 76-year-old war veteran was robbed by two women inside an ATM kiosk in South Delhi's Hauz Khas, police arrested the two accused along with a third woman, who were together involved in over four cases of theft in Delhi. Police said the women — Komal (35) and Seema (25), and their accomplice Sangeeta (30), hailing from Madhya Pradesh — would often target elderly people and women.

On October 3, N K Mahajan was inside the ATM kiosk when the two women stole money from his pocket.

DCP (South) Atul Kumar Thakur said, "We received CCTV footage from the kiosk, which showed the two women. We

started to look for similar cases and came across one from Kotla Mubarakpur. CCTV footage of the incident showed it was the same accused."

Through their informers and their own officers, police received information about the women. "The narcotics squad found that the women were in a park in Pushp Vihar, following which a team rushed to the park and arrested them. We found that while Komal and Seema would go commit the thefts and the robberies, Sangeeta would stand guard,' said Thakur.

During questioning, the accused women told police that they would come to Delhi and stay with their relatives. During the day, they would go to busy markets, ATM kiosks, banks and crowded places to target women and elderly people.

Arya reportedly started a Facebook Live before setting himself on fire. Mishra said, "We have heard this but we haven't come

across the video or the link so far.' Arya's family claimed he felt disturbed that the two continued to trouble the family and were not arrested by police, and that the IO was not helpful. Mishra said, "IO Sandeep was on leave since October 8 as he had met with an accident and fractured a hand... he didn't meet the family."

In sugar belt of Ahmednagar, party loyalty loses out to local cooperative politics

SANDEEP ASHAR SHIRDI, OCTOBER 11

IF PARTY hopping has been the flavour of this election season in Maharashtra, the sugar belt of Ahmednagar, also the largest district in the state, is at the centre of it.

Just ahead of Lok Sabha polls earlier this year, Sujay, son of then Leader of Opposition in the Assembly, Radhakrishna Vikhe-Patil, rocked the Opposition's boat by joining the BJP and subsequently winning the Ahmednagar South seat as its candidate.

In June, Vikhe-Patil followed in his son's footsteps. The BJP gave him a Cabinet Minister rank in the Devendra Fadnavis government, notwithstanding the allegations of corruption he had levelled against it months ago.

While the defections rattled the Opposition camp, it was in line with the 'Aaya Ram Gaya Ram' culture Ahmednagar is famous for.

A land of powerful and interconnected political families and cooperative barons, Ahmednagar has often witnessed strange political alliances and defections. "Political parties and ideologies don't matter much here. It is the regional cooperative politics that counts," said political analyst Tarachand Mhaske.

Consider this. Bhausaheb Kamble, who was the Congress's candidate from Shirdi Lok Sabha seat against Shiv Sena just five months ago, is now Sena's candidate from Shrirampur Assembly seat in the region. Similarly, Vikhe-Patil's brother-in-law Rajesh Parjane, another local heavyweight, is in the fray against BJP's sitting MLA Snehlata Kolhe in Kopargaon, which borders Vikhe-Patil's constituency Shirdi.

Shah slams Rahul for Congress UK chapter discussing J&K with Corbyn

UNION HOME Minister and BJP president Amit Shah on Friday slammed Congress leader Rahul Gandhi for his party "taking up India's internal matters with foreign leaders" a day after a delegation of the Indian Overseas Congress's UK unit met Britain's Labour Party leader Jeremy Corbyn and discussed the situation in Kashmir.

Addressing election rallies in Chikli (Buldhana) and Karanja (Washim) areas of Maharashtra, Shah said, "Overseas Congress chief Kamal Dhaliwal, who is close to Rahul Gandhi, met Jeremy Corbyn and raised human rights issue and complained that the situation is not normal in Kashmir."

He said, "I would like to ask Rahul Gandhi, 'What does your party want to do by raising internal matter of Kashmir with foreign leaders?' In the past, former Prime Minister Jawaharlal Nehru placed the Kashmir issue before the United Nations, (and) now we have Rahul Gandhi taking up the Kashmir issue with the UK."

Shah said Prime Minister Narendra Modi has "sternly conveyed" that "no one has the right to interfere in matters of Kashmir; and

that every issue related to Kashmir will be decided by Indian Parliament".

On Thursday, after the meeting in London, the Congress had, in New Delhi, distanced itself from the event and condemned the Overseas Congress. Senior Congress leader Anand Sharma had said, "We are shocked by this misrepresentation and unauthorised statement.... The delegation which met, or for that matter any committee or chapter of the Indian Overseas Congress, has neither the mandate nor authorisation to speak on any

matter which pertains to policies or India's domestic issues...any issue pertaining to Jammu and Kashmir are purely India's internal affairs.... We disown any such claim. I am conveying this to the leader of Labour Party."

At Friday's rallies, Shah spoke about the Union government's decision to withdraw special status accorded to J&K under the Constitution and urged the people to ask Congress and NCP leaders why they opposed scrapping of Article 370. "Whose interests were they serving by retaining special status in the Valley," he asked.

He asserted that the decision has helped remove the biggest hurdle and made Kashmir an integral part of India. Shah also assured the people that the

National Register of Citizens (NRC) will be strictly enforced across the country to get rid of infiltrators. "2024 tak ek ek ko, chun chun kar nikaalne ka kaam karenge (by 2024, we will identity each infiltrator and drive them out)," Shah said, referring to the next elections.

The choice before the people in the Assembly polls is the Congress-NCP alliance and the BJP-Shiv Sena alliance, he said and added that while the former is in politics to serve their own families, the BJP-led alliance is working for the country.

Cong manifesto in Haryana focuses on women, students

THE CONGRESS Friday released its manifesto for Haryana elections, promising 75 per cent reservation for youth in private companies, 33 per cent reservation for women in government jobs and private institutions, and 50 per cent reservation for women in Panchavati Raj institutions.

Among others, the manifesto promises free rides for women in state buses, an allowance of Rs 5,100 per month for widows, disabled or unmarried women and Rs 3,100 monthly stipend to pregnant women from the third month of their pregnancy and Rs 5,000 per month till the child turns five. It also promised Rs 2,000 every month to women below the poverty line as "chulha kharch", an allowance meant to offset the "high price" of cooking gas.

"This time, there is a special focus on women in the state," party general secretary in charge of the state, Ghulam Nabi Azad, said while releasing the manifesto. State Congress chief Kumari Selja, manifesto committee in-charge Kiran Choudhry, Congress legislature party leader Bhupinder Singh Hooda and former Union minister Pawan Bansal were also present. The 22-page "sankalp patra" said loans to

farmers will be waived "within 24 hours" if the party comes to power after the October 21 Assembly polls. It also promised free power for small farmers (with up to 2 acres of landholding), rice and wheat at Rs 2 per kg for the poor, residential plots for Dalits and an unemployment allowance for graduates.

The Congress promised that if voted to power, it will bring in a "strong legislation on the subject of mob lynching and declare those who have been proved guilty in such crimes ineligible for government jobs".

"There is difference in our party and other parties. We are hero in delivering but zero in publicity. But other parties, especially the one running the government at the Centre and in several other states at present, are zero in delivering but hero in publicity," Azad said.

Besides women and farmers, the manifesto focuses on youth. It promises unemployed postgraduates an allowance of Rs 10,000 per month and jobless graduates Rs 7,000 per month till they get a job. It also promises annual scholarships of Rs 12,000 to students from Classes I to X and Rs 15,000 to those in Classes XI and XII if they are from a scheduled caste or extremely backward classes.

The manifesto also promises a scheduled caste commission and a minorities commission and says the "creamy layer" for OBC in quotas will be raised to an annual income of above Rs 8 lakh. At present, this is Rs 6 lakh.

Wooing state government employees. the Congress promised that if it comes to power, its government will raise retirement age from 58 to 60 years. "Employees will get pay scale on the Punjab pattern and full implementation of Seventh Pay Commission with effect from January 1, 2016," Selja said.

She said that after coming to power, Congress will set up a special probe commission to inquire into the alleged scams that took place during last five years of BJP government in the state. She added that to tackle the drug menace, on the lines of Puniab government Haryana will also have a Special Task Force.

In Muslim-dominated Mewat, BJP picks 2 turncoats, 1 first-timer

EYEING ITS maiden victory in three constituencies in Haryana's Muslim-dominated Mewat district, the BJP has fielded two MLAs who were elected on INLD tickets in 2014 and a 28-yearold who is the district's only woman candidate.

According to the 2011 census, 79.2 of Mewat's population is Muslim, as are two of the three BJP candidates.

Nuh, Punhana and Ferozepur Jhirka constituencies have eluded the BJP since the first election in Haryana in 1967, despite the party occasionally giving tickets to candidates from the dominant community.

In the 2014 Assembly elections, despite the popularity of PM Narendra Modi in the preceding Lok Sabha polls, the BJP could not even secure the position of runner-up in the three constituencies. Its Ferozepur Jhirka candidate, Chaudhary Alam Mundal, finished fourth, losing to INLD's Naseem Ahmed. Ahmed has since joined the BIP. and the party has pinned its hopes on the two-time MLA — he was also elected on an INLD ticket in 2009. Son of former Congress minister Shakrullah Khan, Ahmed had joined the Congress in May this year and BIP in August.

Speaking to The Indian Express, Ahmed said, "BJP was not a major force in Haryana. But after 2014, under the leadership of Manohar Lal Khattar, the party has got the tag of honest government, which has made it a strong force."

He added, "The BJP did not have an MLA in Mewat, but it worked in the district, especially on water and electricity. I want to see Mewat develop and become an industrial hub."

The BJP's candidate from Nuh, Zakir Hussain, also won the 2014 elections on an INLD ticket, and joined the BJP in June. The grandson of Mohammad Yasin Khan, who

was a Punjab MLA, and the son of former MLA and MP Tayyab Hussain, this is Hussain's third stint as MLA.

In the 2014 elections, Hussain had defeated BJP candidate Sanjay, who came third.

While campaigning, Hussain has, like Ahmed, spoken of development. "Despite Mewat not having any BJPMLA, the CM did so much for the district. That is why I decided to join the BJP. We will work for Mewat's develop-

ment and take everyone forward while maintaining brotherhood," Hussain said at a jansabha on Friday. The BIP's Punhana candidate, Nauksham Chaudhary (28), is the daughter of a retired judge and an HCS officer. She did her BA and MA from Delhi University's Miranda House, and Masters in Luxury Brand Management

Just like the first informal summit in Wuhan took place in the backdrop of the Doklam crisis, the two leaders will meet for the second such summit in the backdrop of the Kashmir

Xi, who landed at around 2 pm in Chennai, decided to drive to Mahabalipuram, while Modi flew in a chopper to reach the seaside temple town, overlooking the Bay of Bengal.

When the two leaders met for the first time in Mahabalipuram at around 5 pm, Modi took it upon himself to give a guided tour of the monuments built by the Pallava Dynasty in the seventh century – a UNESCO heritage site.

Govt plans new ration cards only after duplicates are weeded out

AFTER LINKING ration cards with Aadhaar numbers to check bogus entries, the Narendra Modi government is working on a system to ensure that new ration cards are issued only after a national-level "de-duplication" check.

This initiative, taken by the Ministry of Consumer Affairs, Food & Public Distribution, is aimed at reducing corruption in the public distribution system.

"Once the proposed system becomes operational, new ration cards will be issued only after the national level de-duplication check is done. At present, the deduplication check is being done in some states within their jurisdiction. We are planning to implement this at the national level by next year", said Ravikant, Secretary, Department of Food and Public Distribution.

ration card data. Some of them have already shared desired details. We will aggregate this data into a national level database. It is expected to be done within a year. Once this is done, each new application of ration card will have to pass through the de-duplication process. New ration cards will be Aadhaar-verified and the proposed process will ensure that there is no existing ration card in the name and address of new applicant", he told *The Indian Express*.

This move is important because earlier the government's focus was on weeding out bogus rations by linking them with Aadhar of the beneficiaries. There are around 23.30 crore ration cards in the country of which 85 per cent have been seeded with Aadhaar numbers of the beneficiaries.

ED seeks Chidambaram's custodial interrogation

THE ENFORCEMENT Directorate (ED) on Friday moved a Delhi Special Court, seeking the custodial interrogation of former Union minister P Chidambaram in the INX Media money laundering case. The agency's move comes before his judicial remand in the corruption case runs out on October 17.

On the ED's application, special judge Ajay Kumar Kuhar issued a production warrant against Chidambaram (74) and directed the Tihar jail authorities to produce him before it on October 14 at 3 pm.

Probing corruption charges in the INX Media case, the CBI arrested Chidambaram on August 21. The next day, he was remanded in CBI custody. Later, on September 5, he was sent to judicial custody in Tihar jail, which was extended from time to time and is set to expire on October 17. The ED has sought

Chidambaram's custody on the ground that he is required to seek information about some overseas shell companies and 17 bank accounts. Meanwhile, the Delhi High

Court on Friday issued a notice to Chidambaram and his son Karti on the ED's plea challenging the anticipatory bail granted to them in the Aircel-Maxis case.

Justice Suresh Kumar Kait also sought a response from Chidambaram and Karti on the agency's plea seeking cancellation of their anticipatory bail, granted by the special judge on September 5.

The judge said that he will hear the ED's petition against the anticipatory bail Chidambaram and his son, along with their appeal against discharge of DMK leader Dayanidhi Maran, Kalanithi Maran and others in the cases filed by the CBI and the ED in the Aircel-Maxis case, on November 29.

Ahead of Bijepur bypoll, BJP, Cong face factional feuds

WITH THE bypolls to the Bijepur Assembly seat in Odisha around the corner, the BIP and Congress are staring at open factional fights among party leaders.

The bypoll was necessitated as Odisha Chief Minister Naveen Patnaik, who won from two constituencies in the April Assembly polls, decided to vacate Bijepur and retain his Hinjili seat.

A Congress bastion till 2018, BJD won the seat after the death of then MLA Subal Sahu. The BJD fielded Subal's wife Rita Sahu as its candidate, and she defeated BJP's Ashok Panigrahi.

BIP has said that the voters of Bijepur will punish BJD for Naveen's vacating the seat. Union minister Dharmendra Pradhan campaigned in Bijepur on Friday, with top western Odisha leaders like MPs Basanta Panda, Suresh Pujari, and KV Singh Deo accompanying him.

"Who was elected from here?" asked Pradhan referring to the CM. "You could have left Hinjili and represented Bijepur. Was it wrong for people here to trust

However, a factional fight is threatening the party's strategy BJP's Panigrahi openly expressed his dissatisfaction after the party nominated Sanath Gadtia as its candidate. "The party is ignoring me and is not giving me any responsibility. The same happened in (the Assembly polls in April). I don't think the party trusts me. I am confused."

He also pointed at Damodar Rout, a veteran BJD leader who joined BJP and later claimed he was not given much attention after the Assembly elections.

The Congress is caught in the same trap - its leader Ripunath Seth, who was reportedly lobbying for himself or his son to be the party's Bijepur candidate, lashed out at eventual nominee Dilip Panda. "I will campaign for Congress. Who is Dilip Panda? We will speak for the party," he said.



Pak trying to push in infiltrators to keep J&K in turmoil: Army

NORTHERN ARMY Commander Lt General Ranbir Singh said on Friday that although the situation in Kashmir has considerably improved after the scrapping of special status, it remains fragile due to continued attempts by Pakistan to push in militants.

"Ever since the abrogation of Article 370 and Article 35A, there has been a significant improvement in all the violence parameters in Jammu and Kashmir... there has been reduction in terrorist-initiated incidents, stonepelting incidents and there has also been a reduction in protests that were carried out by large number of crowds coming out," he told mediapersons at the opening of a youth festival in Doda district's Bhaderwah town.

"... but the situation remains fragile because Pakistan continues attempts to push in infiltrators so they can keep Jammu and Kashmir in a state of turmoil," he said, adding, "we are dutybound, prepared and fully equipped to ensure their designs are not allowed to succeed".

Terrorist training camps are still active across the border and Pakistan is trying to provide them all kinds of support, including weapons, he said, adding that the recent air-dropping of weapons in Punjab with the help of drones was a step in that di-

SOLDIER KILLED IN CEASEFIRE VIOLATION

Jammu: An Army man was killed in Rajouri district on Friday as Pakistani troops resorted to unprovoked firing along the LoC in Nowshera sector. Sources said that the ceasefire violation from across the border came around 5.50 am. During the exchange of fire, Naik Subhash Thapa sustained injuries. He was evacuated to a hospital where he succumbed to injuries.

In response to a question, he said that there were 200-300 militants active in the state. About their number across the LoC, he said that nearly 500 are at training camps and launch pads at any given time, waiting to infiltrate. Sharp spike in ceasefire violations by Pak this year

THE NUMBER of ceasefire violations by Pakistan in July, August and September this year is more than combined violations in these three months for the last two years, Army sources said Friday. In 2019, there have been 296

ceasefire violations in July, 307 in August and 292 in September. There were 68 violations in July in 2017 and 13 in 2018, 108 violations in August in 2017 and 44 in 2018, and for September 2017 and 2018, the figures stood at 101 and 102, respectively.

There have been a total of 2,216 ceasefire violations from January till September 30 this year and the region south of Pir Panjal has been heavily targeted, sources said, with Nowshera and Poonch witnessing the maximum violations with 820 and 744 instances, respectively.

Sources mentioned that between August and September, the total number of agitations across the Valley have come down by more than half. Terrorist activity has also slowed down compared to 2018, Army sources added.

Order comes ahead of 'durbar move'

SRINAGAR, OCTOBER 11

THE JAMMU and Kashmir administration has asked all administrative secretaries to remain in Srinagar on the "appointed day" — October 31 when the state's bifurcation into two Union Territories comes into effect. Government officials have said the move is aimed at ensuring a smooth transition.

At least six departments — Home, General Administration, Planning, Finance, IT and Ladakh Affairs — will remain operational from Srinagar until further orders.

Sources said the swearing-in ceremonies for the Lt Governor, Chief Justice of J&K High Court and Advocate General will take place in Srinagar for the Union Territory of Jammu and Kashmir, followed by the ceremonies in Leh for the Union Territory of Ladakh.

The order, issued by the state's General Administration Department on Friday, comes ahead of the 'darbar move' scheduled to take place in two weeks. Darbar move is the traditional move of the J&K government from Kashmir to Jammu for the winter and from Jammu

to Kashmir in the spring.

"It is impressed upon all administrative secretaries that they shall not move outside the state during the transit days of annual darbar move in October-

November 2019," the order said.

The state has also asked all state service employees to give preferences for their allocation to the newly-created Union territories. Quoting section 89(2) of J&K Re-organisation Act, another government order states that "the state government hereby seeks options from employees who are serving substantive basis in connection with the affairs of the existing state of Jammu and Kashmir for their further allocation to the successor UTs of I&K and Ladakh".

All departments functioning under the state have been asked to ensure that every employee provides the required information to the head of the depart ment concerned after due verification.

However, the order states that while preference indicated by the employee will be taken into account while deciding on allocation, "it shall not be obligatory on the government to allocate the employee to the UT of his/her choice".

Press Council team puts off Valley visit by 3 weeks

BANDIPUR TIGER RESERVE

Forest officers use drones, elephants, camera traps to catch 'man-eater'

EXPRESS NEWS SERVICE BENGALURU, OCTOBER 11

THE KARNATAKA forest department has deployed drone cameras, six elephants and nearly 140 camera traps to find a tiger that is suspected to have killed two farmers — in early September and on October 8 — on the fringes of Bandipur Tiger Reserve on Karnataka-Tamil Nadu border. The search was launched after a

farmer, Shivalingappa, was killed on October 8 near his property in Chowdahalli area on the forest's fringe. Last month's suspected fatal tiger at-

tack was reported near Hundipura village in the area where multiple tiger sightings have been reported by local residents in the last six months.

After the incident in September, Forest Department officials said they had combed the region but the animal remained elusive.

An official said, "They (local residents) want us to catch or kill the tiger — they want results. They say the fresh incident occurred, given our failure to catch it last month." The Forest Department had earlier enlisted services of three elephants to comb the region. They added three more elephants in their renewed effort. The department has also formed five combing

groups comprising staff from the tiger reserve. Each group will be headed by a range forest officer. Based on the animal's recent sightings, officials said they have identified five possible hiding spots. Narayan Setti, a farmer in Hundipura,

said, "There is a danger of tiger attack if we go to our field to graze the cattle. We are accustomed to seeing elephants in this region but over the last six months, there have been many tiger sightings. We have been here for 30 years; we have to bring our cattle out of the farms to graze."

Bandipur Tiger Reserve field director T Balachandra said the stripe profile of the tiger was obtained from camera traps and a DNA profiling was being carried out to ascertain the animal involved.

Sharpshooter father-son duo Shafat Ali Khan and Asghar Ali, who were involved in shooting the tigress Avni in Maharashtra's Yavatmal last year and who own a property close to Bandipur reserve, have offered to track the tiger but forest officials and wildlife enthusiasts have turned down the offer, local wildlife activists said.

1 killed, two injured in Jehanabad after tension over idol immersion

EXPRESS NEWS SERVICE PATNA, OCTOBER 11

ONE PERSON was killed and another injured on Friday during communal violence in Jehanabad, where tension had been building since Thursday evening over immersion of Durga idols.

Police have arrested 12 people from both sides.

On Friday morning, Vishnu Yadav and Bittu Yadav, both residents of Gorakshni which is adjoining the Muslim-dominated Jafarganj area, were reportedly standing in front of their house when around a dozen people arrived and one of them shot at the duo. Vishnu was hit on the head and Bittu on his leg. Both were admitted to hospital, but Vishnu (22) died a few hours later.

Jehanabad District Magistrate Naveen Kumar confirmed one death. "We have arrested 12 people. There has been adequate police deployment. The situation is under control now," he said.

Tension prevailed since

Thursday evening over the routes of Durga idol procession. As the idols passed through Muslimdominated belts, there was tension between two communities, followed by stone-pelting and torching of vehicles. The tension allegedly started after a stone hit a Durga idol.

The district administration, however, ensured that all the idols were immersed by Thursday late evening with extra police deployment.

Police sources said Vishnu that had nothing to do with Thursday's violence and that he became a "random target" during a bid by some people to provoke communal violence.

DGP Gupteshwar Pandey said the incident was a "skirmish between antisocial elements which followed opening of fire from one side". The situation is under control after the early morning incident, he added.

Prohibitory orders were issued under Section 144 of CrPC, heavy deployment of forces was put in place, and the DM and SP Manish camped in the area.

MP considers cess to fund projects for cows

THE MADHYA Pradesh government is considering a 'cow cess' to raise funds for its cow welfare activities, like Project Gaushala, which is running way behind schedule.

Chief Minister Kamal Nath gave an indication to this effect on Friday while reviewing Project Gaushala at a meeting where a presentation was made on different kinds of cess either being imposed or considered by governments of Punjab, Rajasthan, UP and Haryana.

These state governments are either collecting or proposing to collect cess from purchase of foreign liquor, new vehicles, nonjudicial stamps, entertainment tax, profit-making public sector undertakings and electricity bills. Sources told *The Indian* Express that the CM asked the additional chief secretary (finance) to examine the proposal.

Nath expressed displeasure at the slow pace of work on building 1,000 gaushalas (cow

shelters). In keeping with the party manifesto for the Assembly election, the Congress government had announced early this year that it would build 1,000 gaushalas and accused the

BJP of not building any govern-

ment gaushalas during its long

rule in the state. He emphasised better coordination between the rural development department, which is building the gaushalas, and the animal husbandry department. Announcing that 3,000 gaushalas would be built in 2020, he said that by December, spots should be finalised and relevant permissions secured.

Before the meeting began, veteran Congress leader Digvijaya Singh tweeted, "The MP government should immediately remove the stray cows and send them to gaushalas or cow sanctuary. Kamal Nathji if could do so immediately you will be counted among true gau bhaktas and 'so-called BJP leaders' will get guidance."

UTTAR PRADESH'S Anti-Terrorist Squad (ATS), in a joint operation with Lakhimpur Kheri police, on Thursday arrested four people for their alleged involvement in a terror funding network across India.

The ode to Vatapi Ganapati, an avatar of Ganesh worshipped in Uthrapathiswaraswamy Temple of Nagapattinam in Tamil Nadu, is based on Raga Hamsadhwani and is traditionally played at the beginning of a classical concert. In the 1980s, Kadri Gopalnath, dressed in a veshti and a kurta, would walk up on the stage in various auditoriums in Tamil Nadu with his saxophone, and play this

2.2 billion people worldwide living with eye conditions, preventable in 1 billion: WHO

THE WORLD Health Organization (WHO) released its first World Vision Report this week, proposing ways to address challenges such as integrating eye care into healthcare systems. The report found that globally, over 2.2 billion people have a vision impairment. In a telling finding, the report said that out of these 2.2 billion, 1 billion people are suffering from conditions that are preventable, or unaddressed. A majority of the cases among these 1 billion cases are of unaddressed presbyopia, at 826 million. This is followed by unaddressed refractive error, at over 120 million.

Rural communities, low-income countries and older people bear the brunt of these impairments, the report said. For instance, the age-specific prevalence of presenting distance vision impairment in an urban population of Delhi (20% prevalence among 60-69-year-olds) was one-third lower than that of a rural population in Northern India (28%).

The report estimated that over 11.9 million globally have conditions such as glaucoma, trachoma and diabetic retinopathy, which could have been prevented. The estimated cost of preventing conditions among these 11.9 million people is over \$5.8 billion.

Surgeries for cataract, which is the leading cause of blindness globally, have shown improvements over time, in low middle-income countries. In

Delhi diplomacy to fight disaster

At climate summit in New York, PM Modi pushed the global Coalition for Disaster Resilient Infrastructure. As world observes International Day for Disaster Reduction, a look at the initiative India has taken

WHILE SPEAKING at the UN Secretary General's Climate Action Summit in New York on September 23, Prime Minister Narendra Modi had announced the launch of the Coalition for Disaster Resilient Infrastructure (CDRI) and invited all countries to join it. Ahead of International Day for Disaster Reduction on Sunday, a look at what CDRI is.

What it proposes to do

Envisaged as an international knowledge platform where countries can collaborate to make their existing and new infrastructure strong enough to withstand natural disasters, CDRI is the fruition of at least three years of discussions that India has had with more than 40 countries on this subject.

In simple terms, CDRI is an attempt to bring countries together to share and learn from the experiences of one another to protect their key infrastructure — highways, railways, power stations, communication lines, water channels, even housing — against disasters.

Need to protect infrastructure

Many countries, including India, have over the years developed robust disaster management practices that have helped in sharply reducing human casualties in a disaster. However, the economic costs of a disaster remain huge, mainly due to the damage caused to big infrastructure.

According to a recent estimate by the World Bank, Cyclone Fani, which hit Odisha in May this year, caused damage to the tune of \$4 billion. The losses in the Kerala floods last year could be in excess of \$4.4 billion, according to a post-disaster needs assessment report by the state government. In the US, there were 10 climate change disasters this year in which losses exceeded S1 billion.

Much of the developing world is still building its basic infrastructure. Many developed countries are also in the process of replacing old infrastructure that have completed their lifetimes. Future infrastructure needs to take into account the heightened risks arising out

of the increased frequency and intensity of extreme weather events and other adverse impacts of climate change. Even existing infrastructure would need to be retrofitted to make them more resilient. Disaster-proofing a project would involve changes in design, and use of newer technologies. These involve additional costs which, however, are only a fraction of the losses that a disaster can bring.

"We have pretty good evidence to show that wherever we have made investments in making infrastructure more resilient, over a period of time that investment has basically paid for itself," said Kamal Kishore, member of National Disaster Management Authority. The NDMA is operating as the interim secretariat of CDRI as of now.

An international forum

Disaster preparedness and infrastructure creation are largely national endeavours. However, modern infrastructure is also a web of networked systems, not always confined to national boundaries. There are increasing numbers of trans-national and trans-continental highways and railways; transmission lines carry electricity across countries; assets on a river are shared. Damage to any one node can have cascading impacts on the entire network, resulting in loss of livelihoods and disruption in economic activity in places far away from the site of a disaster.

To make entire networks resilient is the main thought behind the Indian initiative of CDRI. The platform is not meant to plan or execute infrastructure projects. Nor is it an agency that will finance infrastructure projects in member countries. Instead, CDRI will seek to identify and promote best practices, provide access to capacity building, and work towards standardisation of designs, processes and regulations relating to infrastructure creation and management. It would also attempt to identify and estimate the risks to, and from, large infrastructure in the event of different kinds of disasters in member countries.

CDRI hopes to have as its members not just countries, but organisations like UN bodies, financial institutions, and other groups working on disaster management. It seeks to help member countries integrate disaster management policies in all their activities, set up institutions and regulatory provisions to ensure creation of resilient infrastructure, and identify and use affordable finance and technology.

CDRI and Belt Road Initiative

CDRI has sometimes been seen as India's response to the Belt Road Initiative, China's ongoing multi-billion-dollar programme to recreate the ancient Silk Route trading links. China is building massive new land and maritime infrastructure in several countries. India and some other nations view this as an attempt by China to use its economic and military heft to usurp strategic assets in other countries.

Though the comparisons are not surprising given the competing strategic interests of the two neighbours, the magnitude and purpose of the two initiatives are starkly different. Unlike BRI, CDRI is not an attempt by India to create or fund infrastructure proj ects in other countries. Having said that, international initiatives like these are not without any strategic or diplomatic objective.

CDRI and Solar Alliance

A more relevant comparison of CDRI can, however, be made with the International Solar Alliance (ISA) that India launched at the climate meeting in Paris in 2015. ISA, which has evolved into a treaty-based organisation with more than 50 countries already signed up, aims at a collective effort to promote the deployment of solar energy across the world. Its objective is to mobilise more than \$1 trillion into solar power by 2030, and to deploy over 1,000 GW of solar generation capacity in member countries by that time. India hosts ISA, with its headquarters in Gurgaon.

The CDRI secretariat too would be based in New Delhi. While it is not envisioned to take the shape of a treaty-based organisation CDRI can be seen as complementing ISA's efforts. ISA is about climate change mitigation deployment of more solar energy would bring down the reliance on fossil fuels. thereby reducing greenhouse gas emissions. CDRI, on the other hand, is about adapting to climate change, a need that is inevitable.

With these two initiatives, India is seeking to obtain a leadership role, globally, in matters related to climate change.

Kishore of NDMA stressed, however, that CDRI is more than just a climate change initiative. "It does not matter whether the infrastructure is risk from climate-induced disasters or those taking place due to geophysical reasons, like earthquakes, volcanoes, landslides or tsunamis. The infrastructure needs to be strengthened to cope with all these," he said.

ELASTOCALORIC EFFECT

Cooling effect produced by twisting and untwisting of rubber bands. Can it be used in a fridge?

untwisted, it produces a cooling effect. This is called the "elastocaloric" effect, and researchers have suggested that it can be used in a very relevant context today. Researchers from multiple universities, including Nankai University in China, have found that the elastocaloric effect, if harnessed, may be able to do away with the need of fluid refrigerants used in fridges and air-conditioners. These fluids are susceptible to leakages, and can contribute to global warming. The results of the research were published in the journal *Science* on Friday.

WHEN RUBBERS bands are twisted and

In the elastocaloric effect, the transfer of heat works much the same way as when fluid refrigerants are compressed and expanded. When a rubber band is stretched, it absorbs heat from its environment, and when it is released, it gradually cools down. In order to figure out how the twisting mechanism might be able to enable a fridge, the researchers compared the cooling power of rubber fibres, nylon and polyethylene fishing lines and nickel-titanium wires. They observed high cooling from twist changes in twisted, coiled and supercoiled fibres.

They reported that the level of efficiency of the heat exchange in rubber bands "is comparable to that of standard refrigerants and twice as high as stretching the same materials without twisting". To demonstrate this setup, the researchers developed a fridge the size of a ballpoint pen cartridge that was able to bring down the temperature of a small volume of water by 8°C in a few seconds. They suggested that their findings may lead to the development of greener, higher-efficiency and low-cost cooling technology.

Cyanide is used in the extraction and polishing of gold, and for gold-plating. The ornament industry uses the chemical to give gold its reddish yellow colour, believed to be the "original" colour of the metal, and for ridding it of impurities.

Kerala is among the country's biggest consumers of gold jewellery. How is cyanide stocked in the state, and how is its distribution regulated?

The law and monitoring

The stocking and sale of cyanide is regu-

lated by The Kerala Poisons Rules, 1996, which were notified under The Poisons Act, 1919, which empowers state governments "to regulate possession for sale and sale of any poison".

The Drugs Control Department under the Government of Kerala's Health Department issues permits for stocking cyanide for professional use, and licences to stock and sell the chemical. Any individual or institution can apply for both under relevant sections of The Kerala Poisons Rules, 1996. The applicant must have a valid and legal reason to seek the permit or licence, as well as a technically qualified person to oversee the storage and handling of the lethal toxin.

Number of permits, licences

The Drugs Control Department says only 35 agencies — research institutions, universities, academic bodies, or labs in the government or private sector — have permits to stock cvanide.

An agency can at a time stock only 250 grams; the average annual cyanide intake of an institute in Kerala is 250 g to 500 g.

The chemical has an expiry date of three years from manufacture. Permits have to be renewed every year. There are no valid cyanide licences —

Cyanide crystals come in packets of 250 g.

meant for sale of the chemical — in Kerala at present.

Legal source of the chemical

Cyanide is legally sourced from a Mumbai-based agency, which sells the chemical under strict restrictions to institutions or individuals who are able to furnish the relevant certificate issued by the Drugs Control Department. The permit-holder has to appear in person before the agency to procure the allotted quantity of chemical.

Smuggling and illegal imports

The industrial use of cyanide is allegedly dependent on smuggling or illegal imports. The small quantities involved make it difficult to detect and seize illegal consignments, officials said. A police officer of the rank of Sub-Inspector can suo motu register a case of

illegal trade in cyanide. The last seizure of cyanide that officials

could recall took place in 2002, when sales tax officials at an inter-state border checkpost in Palakkad seized 250 kg of the chemical from a truck. The consignment, imported from Australia, was meant for an individual in Kozhikode. Investigations revealed the chemical was meant for the gold industry The accused individual was convicted and fined a paltry Rs 250 as per the law.

What Kerala proposes to do State Drugs Controller Ravi S Menon said

it is proposed to amend The Kerala Poisons Rules in the wake of recurring incidents of acid attacks, as the use and stocking of acid also come under the purview of the Rules. "We are planning to bring the use and

stock of cyanide under the ambit of the proposed amendment in ways such that the accessibility of the public to cyanide is reduced We also plan to incorporate sections to reduce the toxicity of the cyanide that is made available," Menon said.

Abiy Ahmed Ali, Laureate, for Peace in Horn of Africa: what was his role?

ETHIOPIAN PRIME Minister Abiy Ahmed Ali was awarded the 2019 Nobel Peace Prize on Friday for "his important work to promote reconciliation, solidarity and social justice". In its citation, the Norwegian

Nobel Committee said: "Abiy Ahmed Ali has initiated important reforms that give many citizens hope for a better life and a brighter future."

What Abiy did

When Abiy became Prime Minister in 2018, Ethiopia had been locked in conflict with Eritrea for 20

years. In July that year, the former Army officer-turned-PM, then 41, stepped across the border, held Eritrean President Isaias Afwerki in a warm embrace and signalled the beginning of a peace effort, announcing to the

world that war was no longer an option. The Nobel Committee noted how Abiy. in cooperation with Afwerki, worked out the

principles of a peace agreement, set out in declarations the two leaders signed in Asmara during that July visit and in Jeddah in September. It also listed domestic achievements by Abiy in his first 100 days as Prime Minister — lifting Emergency, granting amnesty to thousands of political prisoners, discontinuing media censorship, legalising

outlawed opposition groups, dismissing military and civilian leaders suspected of corruption, and increasing the influence of women in political and community life.

The conflict, its roots

The stalemate Abiv helped break is about a border dispute that began in 1998. Conflict between the two

countries, however, has a longer history. Eritrea, once an Italian colony, was merged with Ethiopia in 1936 during Benito Mussolini's regime, then taken over by the British during the Second World War. After the War, a United Nations declaration in 1950 made Eritrea part of a federation with Ethiopia. When Eritrean groups launched

Abiy's visit, the two countries have announced the resumption of trade, diplomatic, and travel ties and "a new era of peace and friendship" in the Horn of Africa.

"... Telecommunications have been restored, allowing families that were split up in the war to contact each other. In the days that followed this breakthrough, some Ethiopians

called Eritrean numbers randomly, and vice versa, just to speak to someone on the other side, simply because they could. Others tracked down parents, siblings and friends," The New York Times reported.

Ethiopia is Africa's second largest country by population, but landlocked, while tiny Eritrea is connecting by sea to the Middle East. Through the years of conflict, Ethiopia had depended heavily on Djibouti for access to the Gulf of Aden and onward to the Arabian Sea. The peace deal opened up Eritrean ports for Ethiopian use.

Challenges ahead

While the peace effort is a step forward, ethnic rivalries in Ethiopia have flared in recent years and the country has millions of internally displaced refugees. "No doubt some people will think this year's prize is being awarded too early. The Norwegian Nobel Committee believes it is now that Abiy Ahmed's efforts deserve recognition and need encouragement," the Committee said.

It acknowledged Afwerki too: "Peace does not arise from the actions of one party alone. When Prime Minister Abiy reached out his hand, President Afwerki grasped it..."
