

JHANSI 'ENCOUNTER'

Pushpendra grandmother dies, kin say she couldn't bear shock of his death

EXPRESS NEWS SERVICE LUCKNOW, OCTOBER 13

A WEEK after 28-year-old Pushpendra Yadav was killed in an alleged police encounter in Jhansi, his 85-year-old grandmother died on Sunday. Her family alleged that she died as she could not bear the news of her grandson's death and had stopped eating from the past few days.

Pushpendra's father, Harish Chandra Yadav, said that though his mother was not keeping well for some time after she broke her leg a few months ago, it was the shock of her grandson's death that killed her.

"Initially, we did not tell her about Pushpendra's death as we knew she would not be able to cope with the loss. But she kept on asking where is Pushpendra. Around four days ago, she came to know about his death. After that, she had stopped eating

food and also stopped taking medicines. She would have lived longer but her condition started deteriorating after that," Harish Chandra said, adding that "one fake encounter destroyed the life of my whole family".

Meanwhile, Pushpendra's elder brother, Ravindra, said that his whole family would choose to die if they did not get justice. "If the government cannot give us justice, then kill us all in police encounters. Today, my grandmother died and soon every member of my family will embrace death," he said. On October 6, Pushpendra

was killed in an alleged police encounter, hours after he allegedly fired at the station house officer (SHO) of Moth police station, Dharmendra Singh Chauhan, who had seized Pushpendra's truck last month. His family had refused to cremate the body demanding a murder FIR registered against

Chauhan.

Man killed, 10 injured in clash over accident

AMIT SHARMA MEERUT. OCTOBER 13

A 22-YEAR-OLD was killed and 10 injured after two communities clashed at Kashi village in Meerut on Sunday due to a motorcycle accident. During the 40minute clash, both sides pelted stones at each other, used lathis and fired bullets.

The deceased has been identified as Shoaib. The police have sent the body for post-mortem.

"After talking to locals, we have learnt that Shoaib and his three friends were speeding on their bikes towards Kashi village around 4 pm. Shoaib lost control of his bike after hitting a speed braker and injured Jatin who was standing by the road..." Deputy SP Chakrapani Tripathi said.

The bikers were overpowered and beaten up, said Anand prakash Mishra, in-charge of Partapur Police Station.

"Shoaib called his men, leading to violence. He was attacked with lathis. We took him to hospital where he was declared brought dead," said Mishra.

WITH EFFORTS by the management of the defence public sector unit Hindustan Aeronautics Limited to resolve wage issues raised by unions at the company failing on Sunday, workers are set to begin an indefinite strike at HAL units across the country from Monday.

"Despite the management's concerted efforts towards bringing an amicable/early wage settlement, unions unfortunately have adopted a recalcitrant approach and did not accept the offer and decided to resort to indefinite strike; in spite of management's appeal to resolve the issue in a spirit of accommodation," HAL said in an official statement on Sunday.

"All the workmen in all the HAL divisions will be commencing their indefinite strike with effect from October 14, 2019 as decided earlier," said Suryadevara Chandrashekhar, general secretary and chief convenor of the All India HAL Trade Unions' Co-or-

dination Committee, on Sunday. The umbrella body of trade unions at the defence public sector had served a notice on September 30 to the management of the strike from October 14 at HAL's nine units around the country following breakdown of talks for revision of wages of nearly 20,000 workers.

The HAL management has called the strike illegal and warned of national security implications in the event of the All India HALTrade Unions Co-ordination Committee proceeding with the proposed indefinite strike.

strike/agitation jeopardizing the interest of the employees/organization and the nation at large,' HAL said in its statement.

"The proposed indefinite strike will have adverse repercussions on the performance of the organisation in general and workmen in particular. Further, in the interest of national security and the need to maintain the fleet serviceability of Armed Force, it is imperative that the workmen do not resort to such illegal strike and should settle for a fair and reasonable wage revision offered by the management," the management had said earlier.

The trade unions are questioning discrimination between workers and executives in proposed pay hikes for workers and the hikes implemented for executives in the firm.

The workers' unions at HAL which are not affiliated to any political party, have been demanding wage revision, which was due in January 2017, on the lines of revision done for executives at HAL in November 2017.

While the HAL management has offered an eight per cent increase in gross salary to workers. the unions are seeking parity with a "35 per cent increase given to officers in one stroke".

According to HAL union officials, the management is also insisting that workers agree to a wage revision for workmen with "meagre 10 per cent fitment benefit and 19 per cent of perks" compared to the 15 per cent fitment benefit and 35 per cent perks sought by the unions.

Pope elevates Indian nun Mariam Thresia, four others to sainthood

INDIAN NUN Mariam Thresia and four others were declared Saints by Pope Francis at a canonisation ceremony at the St Peter's Square here on Sunday.

Mariam Thresia, who founded the Congregation of the Sisters of the Holy Family in Thrissur in May 1914, was raised to the highest position within the centuries-old institution during the open-air mass attended by thousands from across the world, including India.

The nun from Kerala was canonised along with English Cardinal John Henry Newman, Swiss laywoman Marguerite Bays, Brazilian Sister Dulce Lopes and Italian Sister Giuseppina Vannini.

Huge portraits of the five new Saints were hung from St Peter's Basilica during the ceremony that lasted nearly two hours. The ceremony included a Latin hymn and a recommendation by a representative of the Congregation for the Saints.

"Today we give thanks to the Lord for our new Saints. They walked by faith and now we in-

'Mentally unstable'

A 65-YEAR-OLD man lodged in a detention camp for illegal migrants in Assam — whose family claims he was mentally unstable — died at the Guwahati Medical College and Hospital (GMCH) on Sunday where he had been admitted for treatment due to "deteriorating health", police and family members said.

A senior police officer said the deceased, Dulal Paul, a resident of Alisinga village of Sonitpur district, was admitted to the GMCH on September 28. The officer said Paul had been in the detention centre in Tezpur

Dulal, said, "He was mentally unstable... His siblings and their families are in the NRC. Our family has land documents dating back to the 1960s. A mentallyunstable person was put into detention."
