CBI files chargesheet against Chidambaram

Karti's firm 'received ₹9.96 lakh without doing any service'

The Central Bureau of Investigation (CBI) on Friday filed a chargesheet against 14 accused, including former Union Finance Minister P. Chidambaram and his son Karti, in the INX Media case.

Mr. Chidambaram "misused his official position" in granting approval to an FDI proposal of INX Media and INX News Pvt. Ltd. in lieu of "illegal gratification" in India and through offshore payments, the CBI said.

The agency alleged that a payment of ₹9.96 lakh had been made to Advantage Strategic Consulting Private Limited (ASCPL), which was floated by Mr. Karti, "without delivery of any service".

Among those arraigned in the chargesheet are INX Media, its subsidiary INX News and then director Peter Mukerjea, Chess Management Services Private Limited, ASCPL and Mr. Karti's characcountant Bhaskararaman.

Indrani Mukerjea, a former INX Media director, turned approver (pardoned) in July with the court's permission. She claimed to have paid \$5 million through the offshore route in lieu of the favours, and having met Mr. Chidambaram, along with Mr. Mukerjea and Vir Sangh-

vi, on the FIPB issue in March/April 2007.

The then Additional Secretary Sindhushree Khullar, Joint Secretary (Foreign Trade) Anup K. Pujari, the then Officer-on-Special Duty in the Department of Economic Affairs Pradeep Kumar Bagga, the then FIPB unit Director Prabodh Saxena, Under Secretary Rabindra Prasad, and Section Officer Ajit Kumar Dungdung have also been named as

Against those accused, the CBI has invoked Sections 120-B (criminal conspiracy), 420 (cheating), 468 (forgery for cheating) and 471 (using forged document as genuine) of the Indian Penal Code, along with the relevant provisions of the Prevention of Corruption Act. The case was registered on May 15, 2017.

Questioning the timing, Mr. Karti tweeted: "It's been done only to beat the 60-day deadline of my father's [judicial] custody. We will deal with it as per legal procedure and will be vindicated."

The agency is probing the charge that INX Media received ₹403.07 crore in foreign investments against the FIPB approved amount of ₹4.62 crore in 2007. It also made an illegal downstreaming of ₹40.91 crore into its sister concern, INX News.

Terror-funding: FATF retains Pak. on grey list

It cites lack of progress on action plan

The Financial Action Task Force (FATF) retained Pakistan on the "grey list" and gave a stern warning that it will be blacklisted if it does not fulfil the global standards criteria for combating terrorist financing by February 2020.

The terror financing watchdog discussed Pakistan's actions for countering terror financing and antimoney laundering at the International Co-operation Review Group (ICRG) plen-

ary in Paris that concluded on Friday. Pakistan has been under the enhanced monitoring process or grey list since June 2018 and has not made sufficient progress, said FATF president Xiangmin Liu.

"Despite the high-level commitment to fix these weaknesses, Pakistan has not made enough progress but has made tangible progress under this new government, which the FATF welcomes," Mr. Liu said.

Rajasthan govt. files appeal in Pehlu Khan lynching case

Sessions court had acquitted all 6 accused in August

The Rajasthan government has filed an appeal in the High Court challenging the Alwar sessions court verdict that acquitted all six accused in the Pehlu Khan lynching case. Khan, 55, a dairy farmer from Haryana, was waylaid by a mob of cow vigilantes who accused him of smuggling cows and thrashed him on the Jaipur-Delhi national highway on April 1, 2017, resulting in his death.

The sessions court acquitted all the accused on August 14 of the offences of murder, rioting and unlawful assembly, giving them the benefit of the doubt on the basis of the police probe which had created uncer-



tainty about their involvement in the alleged crime.

Additional Advocate General R.P. Singh said here on Friday that the appeal under Section 378 of the Criminal Procedure Code had been filed earlier this week.

It is yet to be listed for hearing in the Jaipur Bench of the Rajasthan High Court.

Khan's family has also filed a separate appeal in the High Court against the sessions court judgment.

'Multiple lapses'

The State government had appointed a Special Investigation Team on August 17 to look into the reasons behind the acquittal of the six accused. The SIT pointed out multiple lapses in the police probe and found "shoddy investigation" by some officers

Justice Bobde as successor

Chief Justice of India Ranan Gogoi has recommend ed Justice Sharad Arvind Bobde as his successor and the 47th Chief Justice of India in keeping with convention and the seniority norm, sources said. The Chief Justice, due to retire on November 17, has sent his recommendation to the government.

The written communication from the incumbent, ideally a month before his retirement, is the first step in the process of the appointment of the next CJI.

For over 700 Hindus from Pak., India is their only 'refuge'

Eviction threat looms over settlers on Yamuna floodplains following National Green Tribunal's order



Five years ago, when 11year-old Rajkumari arrived in the national capital from Pakistan's Sindh province, roaming in the neighbourhood and going to a school were things she had not experienced.

Living in a jhuggi near Majnu Ka Tila, she is one of the many people who came to Delhi on a pilgrimage visa and did not go back.

Rajkumari, now 16, says, "Back in Sindh, girls were not allowed to go to schools or leave their homes much. I went to school for the first time after arriving here. I want to study further and continue staying in India as I have more freedom here."

2011, have over 700 residents now (over 120 families). Living amid constant fear of being uprooted from

the place they call home, the residents hope the Indian government will grant them citizenship.

"The pilgrimage visa was just an excuse for us to move out of Pakistan. We reached Delhi with our families in 2011, leaving our farmlands and property behind, to escape the torture we faced there. All we hoped for was better income prospects and a secure life," says Sona Das, the 'pradhan" of the area.

With the National Green Tribunal on Thursday directing the Delhi Development Authority to evacuate the residents from the floodplains on account of encroachment, the settlers say that "India is the only place they can expect to take shelter in".

'Rehabilitate us'

"If they want us to vacate we will, but they must rehabilitate us properly. Right now we are leading a life of starvation, but after all we are Hindus. Why do we have to live like this in this country? If the government does not stand with us, where would we go?" says Das, a daily wage labourer.

Gomti, 45, a homemaker living in the jhuggi since 2014, says managing a family of 10 is becoming "increasingly difficult" because of lack of a steady income. Some of the residents are daily wage labourers, while others have small shops or are street vendors. Though most residents

have obtained Aadhaar cards, they say that after getting citizenship, they can lead a "respectable life". "Our only demand is that the government grant us citizenship and rehabilitate us so that we can lead a respectable life in the country we want to," says 42-year-old Sukhnand pradhan, another labourer.

FIR against four policemen in U.P. custodial torture case

DSP, inspector among those booked for murder, assault

The Uttar Pradesh police have registered an FIR against four policemen, including a Deputy Superintendent of Police and an inspector, in connection with the alleged custodial torture leading to the death of a 35year-old man in Pilkhuwa area of Hapur district.

Pradeep Tomar, a security guard, died at a Meerut hospital on October 13. His 10-year-old son claimed that his father was brutally tortured by policemen in his presence at a police station. Police said Tomar had been summoned to Chijarsi outpost for interrogation in connection with a murder case.

The FIR was filed on

Human Rights Commission took note of the case and issued notices to the State Chief Secretary and the Director General of Police. The commission has sought action-taken reports within four weeks.

In the FIR, the victim's brother, Kuldeep alias Tejpal, accused DSP Santosh Mishra, SHO Yogesh Baliyan, inspector Ajab Singh and an unidentified policeman of torturing Tomar. The offic-

ture. "The cause of the death has not been confirmed. The viscera sample has been preserved. There was blackening of the posterior and signs of contusion on arms and other body parts [of Tomar]," said Superintendent of Police Yesh Veer Singh. He said a departmental probe and a magiste-

rial inquiry have already been ordered into the incident. While Mr. Baliyan and Mr. Singh have been placed under suspension, Mr. Mishra has been transferred to Garhmukteshwar.
