

Sex, lies and video 'trap'

Six have been arrested in a Madhya Pradesh case based so far on rumours regarding 'big names' rather than facts or complainants. Parents of the youngest accused plead innocence, saying only fault of their 19-year-old was 'ambition'

FEW YEARS ago, when she was still a minor, Monika Yadav's parents told her they had found a boy for her and it was time she agreed to marriage — like other girls her age in Rajgarh, a district in Madhya Pradesh known for child marriages. Monika, a good student who had represented Government Girls' Higher Secondary School, Biaora, in the 62nd National School Games in cricket in Class 11, stood her ground because she wanted to study further and work.

By then, Yadav had already been away from home for five years for studies, moving first to Narsinghgarh and then Biaora, both in Raigarh district. Her village Sanwasi, with 2,000-odd people, only has one primary school.

Just after her arrest, it was neigbours who told Yadav's illiterate parents, Hiralal and Kaushalya, that their 19-year-old, the younger of their two children, had been arrested by the Indore police in the 'honey trap case' that has been making news in Madhya Pradesh since last month — with rumours, more than facts, claiming a large web involving crores of rupees as well as politicians,

bureaucrats and senior police officers. The Congress even claimed a plot against its MLAs, to pull down its precariously

poised government in the state.

be many "victims", except for one person, no one has filed a complaint against the six accused, of whom Yadav is the youngest.

Four days after Yadav's arrest, Hiralal filed a human trafficking complaint against three of the accused.

Yadav's family of four lives in a brick house down a kuchcha lane in Sanwasi. The dimly lit structure has a tin roof, a few plastic chairs lie around, and some clothes hang on its decaying walls. In a corner, produce from the fields is kept in a neat pile.

The parents say Yadav told them in June that she was moving to Bhopal, about 90 km away, to pursue graduation. She came home twice after that, including for Raksha Bandhan, the parents say. While they noticed she had on new clothes and cash, they say they took her word that "Didi ka hai... didi ne diya hai (Didi has given)."

By 'Didi' she meant Aarti Dayal, allegedly one of the main conspirators in the case. Yadav's parents say Dayal had come to their house once, promising to fund their daughter's education as well as employ her in her

Bhopal NGO. The case broke on September 17 when an Indore Municipal Corporation (IMC) Superintending Engineer filed a complaint at the Palasia Police Station alleging that Dayal had demanded Rs 3 crore from him, later reducing it to Rs 2 crore, threatening to circulate a video clip of him in a compromising position. The 60-year-old claimed Dayal was always accompanied by a young assisinitially asked him to find a job for the girl. He named the girl as Seema Soni (police believe this was Yadav), and admitted having a fling with her.

Police arrested Dayal and Yadav soon after, along with Dayal's driver. Originally from Chhatarpur, Dayal, 29, shifted to Bhopal's Sagar Landmark Colony a year ago, and had told neighbours she ran an NGO.

The Indore police next roped in the antiterror squad and their Bhopal counterparts, and went on to arrest Shweta Vijay Jain, 39, from a colony near Dayal's, Shweta Swapnil Jain, 48, and Barkha Soni, 34, all from Bhopal. Barkha's husband Amit used to be an office-bearer of the Congress's IT cell, while Shweta Vijay was once associated with the BJP and had unsuccessfully sought a party ticket from her native Sagar. Police claimed to have seized Rs 14.17 lakh from Shweta Vijay's house. Shweta Swapnil originally hails from Jaipur.

Of the six, only Yadav and the driver have humble origins. Both the Shwetas and Dayal live in upscale colonies in Bhopal.

Police claimed to have seized laptops and mobile phones from the accused, and recovered hundreds of clips of men in compromising positions, including known names. Police also claimed that the racket flourished under the former BJP government, explain-

ing some of their zealousness. However, with no more complainants, police don't have much to go on. While speculation has been rife, and photos as well as

best lead is that NGOs run by two of the accused seem to have benefited from their "connections" in the bureaucracy. Rumours further swirled when the government changed two chiefs within eight days of a Special Investigation Team set up to probe the case, after the BJP sought a CBI investigation. The SIT's brief incidentally is only to look

into the Superintending Engineer's case. Senior Superintendent of Police, Indore, Ruchivardhan Mishra, the only police official who has remained unchanged, did not respond to calls. The new SIT chief, Rajendra Kumar, has avoided media from day one. Not just police even government prosecutors are not ready to speak on the case.

A Congress leader says police had been told to "go slow" to not divert attention from the Kamal Nath government's first investor summit — the three-day Magnificent MP that ended on Friday.

Advocates Dharmendra Gurjar and Vivek Chaudhary, who represent Shweta Vijay and Shweta Swapnil respectively, say police have accused their clients falsely, despite the fact that they were not named in the FIR and nothing had been found from them. Chaudhary says Shweta Swapnil was only arrested because "her name is similar to Shweta Vijay". "You can't arrest someone on the basis of mere doubt. If police have recovered videos and extortion details, they should name the victims and file

Former Congress IT cell office-bearer and government contractor Amit Soni, who remained missing for several days after his wife Barkha's arrest, claims police have not even told him why they had taken her to Indore. Denying earning government contracts through extortion, Soni says his total turnover was hardly Rs 1 crore and he has been getting work for years.

Yadav's father Hiralal now wishes he had married her off as he had wanted to. "She had told me, 'Mera jeevan mat kharab karo (Don't ruin my life)'... I don't how she got trapped," he says, breaking down.

Many in the village agree that Yadav could be an unsuspecting victim. Sarpanch Indar Singh, who met her in custody, says she told them she had been sent to the IMC Superintending Engineer with the promise of a job. He says she had no idea when the video of her with the engineer was made and that she herself was blackmailed into continuing liaisons with the engineer and others on the basis of it.

Ironically, adds the sarpanch, one of the reasons Yadav stepped out of her home and village was to help Hiralal out with a land dispute; he turned to his daughter as she was educated, unlike him.

Singh claims as she took her family's case all the way to Bhopal, the cloistered girls of Sanwasi came to see Yadav as a role model. Till she intervened, warning a few who

'There is comfort in saris... no need for shoes either, I just wear flats'

Earlier this year, khadi silk saris were introduced as uniforms for women staff working on the desk at police stations. But last month, following an increase in the demand, the Delhi Police issued a circular which stated that each police station will be allotted only four saris — two each for the two Public Facilitation Officers — for two years



'I wear my sari for 15-20 days, then get it dry-cleaned.' Gajendra Yadav

Do you like your new uniform? ▲ Initially, I was sceptical. It takes a lot of time to wear a sari, and maintenance isn't easy either. But after wearing it regularly for the past four months, I now feel comfortable. I also like the sari's orange colour. I don't have to wear shoes now, I pair my sari with black ballerina flats. The sari unifrom is also good during summer.

Have you heard about the new ∠ guidelines?

Yes. I think the saris are durable and can be easily worn for two years. I have four saris now. After two years, when the department allots me only two saris, and one of them gets worn out, I can write an application and get a new one. They only ask for the reason and give a new sari within weeks.

Is it compulsory for you to wear \supset the sari every day?

Yes. I have to be in unifrom for my shift from 9 am to 5 pm. My work involves meeting people, overseeing the tenant verification process, directing beat officers to meet senior citizens etc. We have been instructed to wear the sari while performing all these duties.

/ How do you maintain the saris? I prefer getting them dry-cleaned every 15-20 days. I could wash them, but they don't dry in time. Whenever I take casual leave, I give one of the saris for cleaning and ironing. I can then wear it for another two weeks. I have kept my saris in a different section of my wardrobe.

A 'marriage' to be made in court

Taking the lead, a 16-year-old has gone to the Supreme Court for her right to tie the knot despite her age, citing the Muslim law

ABOUT 200 km from Lucknow, in a remote village in the Terai region of Uttar Pradesh, villagers talk about "a bhayanak (scary) love story that has left behind even Heer-Ranjha". What has them stunned is that the one taking the lead in this tale is a 16-year-old girl — fighting to uphold her "marriage" to a 20-year-old against their families, village, and the govern-

ment, all the way up to the Supreme Court. Three months after the girl and the 20year-old got married in the verandah of his house, the youth says he has left everything up to her. "She is adamant and I trust and believe that she will not change her statement. We have married as per Islam and in front of elders. The rest is on Allah."

The village dominated by upper-caste Muslims, mostly Sheikhs and Pathans, agrees that under the Shariah law that allows marriage on attaining puberty, their wedding is valid, but adds that it is the first such case in

their memory.

On June 22, around 11 pm, the couple are said to have summoned a maulvi from a neighbouring village to conduct the nikah. The maulvi was known to them as he held classes in the village. The next day, the girl's father lodged an FIR against the 20-year-old, his father and their neighbours, under IPC sections covering kidnapping and inducement of a woman to compel marriage.

Sub-Inspector Shailendra Yadav, the Investigating Officer in the case, says, "We produced the girl before a magistrate. She refused to go back to her family and, since she was a minor, she was sent to the Nari Niketan on July 3 on the orders of the magistrate."

The youth went to the high court, alleging that the girl was being detained against her will. "After the court rejected their plea saying the girl is a minor, they approached the Supreme Court," the S-I says. As per general law, a girl has to be at least 18 and the groom

Personal Law Board secretary Zafaryab Jilani says, "If a girl and boy are minors, then the consent of parents is required. But if they are major, then they can decide to continue or end their marriage. However, the definition of 'major' or being 'baalig' is dif-

Eyes glued to his mehndi-coloured hands, with English letters of her name hidden in the design, as a groom would do at a wedding, he says he put the henna on for "good luck".

The girl's father is also a farmer, while her elder brothers work as labourers in Mumbai and Delhi. The family denies her claim that they were trying to marry her off, adding that she made that up under duress and asking why the nikah was held at 11 in the night withpradhan says, "We had informed the family members of the girl. Pathans and Sheikhs marry into each other's families and most of us are related. But none from the girl's side came.'

AS WE continue to garble various readings of India's Independence, looking through convex prisms, we devour into pigeonholing various experiences of multitudes of actors and their investment in the so-called freedom struggle, or not?

The post-Independence era is one of the most sophisticated times in our efforts to carve our story. As a result, many movements took shape holding the State accountable for failing to fulfill its chestthumping promises, including IP, Naxalite, environment right, Dalit Panthers, BAM-CEF, land, anti-corruption, and Hindutva movements.

Of these, the most successful in terms of reaching the disenfranchised, poor, outcastes, landless, women, and labourers was designed by Kanshiram and DK Khaparde. Rooted in Ambedkarite radical consciousness. Kanshiram led the all-India BAMCEF movement to unite victims of Brahminical Social Order alongside DS4 (Dalit Shoshit Samaj Sagharsh Samiti) — a militant organisation formed on December 6, 1981, to fight atrocities against Dalits.

Additionally, it went on to launch a first national-level Dalit political base, the BSP (Bahujan Samaj Party), as a "Mass-based, Broad-based & Caste-based" organisation with remarkable victories — something Babasaheb Ambedkar and Gandhi's patronising Congress couldn't do in terms of electoral gains for the 'untouchables'.

Kanshiram was successful in weaving culture with society and politics. His movements were firmly rooted in social move-

ments that had roots in national politics en route cultural prop. Thus, Kanshiram's politics took shape as cultural activism angled its fate. Therefore, along with the social movements on streets and in offices, Kanshiram invested in starting newspapers, magazines and journals to help succour the movements on the ground and theorise its implications by himself, and not outsource the job of theoretical interpretations to the press or 'theoretical Brahmins' comfortably lazing within the four walls of university campuses or cushy quarters.

Untouchable India

Kanshiram's success could be attributed to his reliance on arts, activism and journalism. Kanshiram started the first English language pan-Indian Dalit-centered journal Untouchable India (June 1, 1972). Untouchable India's first edition drafted vision and determination of the anti-caste movement. The cover photo had a meditating Buddha in a calm state. This indicated Kanshiram's zeal to fulfill Ambedkar's unfinished work on spiritual and political revolutions — *Prabuddha Bharat*.

Untouchable India refused to fit into the Brahminical story-writing samples of magazines. It challenged the nationalist narratives and asked the Dalits to self-examine their subordinate slave status in society.

Kanshiram-led journalism and literalism was a landmark moment in the history of Indian print media. The journal's stylistic arrangements, neat editing, sophisticated analysis, and hard-hitting, uncom-

promising editorials and articles put the onus on the oppressor. Its clear political stand and investment in cultural strength gave a platform to scholars, artistes and poets, both known and not so well-known.

The special issue of *Untouchable India* published on August 15, 1972, celebrated 'Silver Jubilee of Dependence'. This piece was published at the same time as Raja Dhale's monumental and controversial piece, 'Black Independence Day', was published in Sadhana. Both leaders denounced the Indian State for its apathy in giving justice to the rape victims in Brahmangaon, Maharashtra.

Journalism

As the BAMCEF's informal activities were going on since December 6, 1973, Kanshiram launched BAMCEF bulletin in 1975 to educate the mass about their lowly condition. Once BAMCEF was formally established in 1978, The Oppressed Indian, a monthly journal, was launched in 1979 with critical commentary on caste. Besides, it took on the government and casteist forces who were involved in committing atrocities. It also "exposed" the stooges "with the possibility of improving them" and also "encourage the courageous ones by giving them due publicity".(The Oppressed Indian, April 1979).

The necessity of an independent 'news service' for oppressed Indians was due to intentional "blackout" and blackmailing of their activities by the press dominated by Brahmin-Banias, argued Kanshiram.

Besides this, Kanshiram continued to produce opinions and news informing his nation-wide cadres. Shortly after, in 1980, The Oppressed Indian announced the launch of four news weeklies and four literary monthly magazines.

Bahujan Nayak, a Marathi weekly, was started from Nagpur. Bahujan Sanghatak, a widely circulated Hindi language weekly, was started from Delhi. The Bahujan Ekta made strides in the Gujarati cultural orthodoxy. And, in Punjabi, Bahujan Sandesh reached the toiling masses.

Literary ventures such as Shramik Sahitya were started in Marathi, Dalit Sahitya in Gujarati, Bahujan Sahitya in Hindi and Soshit Sahitya in Punjabi. To offer economic analysis of the country's problems and examine its impact on Dalits, Aarthik Uthhan was started in November 1980. An Englishlanguage version of the same issue, Economic Upsurge, was launched in November-December 1981. Along with this an 'economic monthly' and 'daily newspaper' were to take off from November 1980 in English and Hindi language (The Oppressed Indian, October 1980, cover).

The issues dealt with nationalisation of banks, cooperative stores for the rural population, industrialisation, land, the impact of bank credits on weaker sections, and topics such as unions and Ambedkar's views.

Following this, Bahujan Times made a much-desired entry into the English- and Hindi-language sphere to cover the BSP's activities. The Buddhist Research Center's (established by Kanshiram) BRC Bulletin covered Buddhism and religion with the objective of keeping cadres informed about the BRC's activities on Buddhism.

These journals were not just news, reportage and analysis for the masses, they helped establish an impartial relationship with cadres in the BAMCEF movement. By documenting its views and opinions, it ensured that it stays forever accountable for its actions and morals.

This effort seems to be submerged in the current leadership of the BSP and BAMCEF, that did not invest in producing next generation thought leaders and intellectual powerhouses that could keep up with the country's changing political landscape.

If Kanshiram was a fighter, he was also rooted in unsparing analyses that drew from Buddha, Jyotirao Phule, Shahu, B R Ambedkar and Periyar. People associated with the movements were well aware of Kanshiram's "unsympathetic words while enumerating faults" of the movement. Kanshiram's long-time associates involved in his journalistic and art ventures remain one of the important cornerstones of the BAMCEF-BSP movement. They archived the movement for the future generations. We are yet to find such organised energy.

Down with looters

THERE ARE only two kinds of really rich Indians. Wealth creators and looters. The Prime Minister declared his respect for wealth creators in his Independence Day speech this year, acknowledging their vital contribution to his dream of making India a 5 trillion dollar economy by 2024. Sadly, he seems not to have noticed how important it is to control the looters if the wealth creators are to create wealth. In the looters category, as the more perceptive of you may have already gathered, I include politicians and officials. Looters by nature are incapable of creating wealth and get rich by looting those who can. On Modi's watch, tax inspectors have been given the power to arrest those they accuse of hiding loot and they have become more vicious in this pursuit than ever before because the Prime Minister's crusade on black money has emboldened them.

Last week, a friend who is as honest a wealth creator as I know called to tell me sadly that he is on the verge of closing down his very successful business because he can no longer face the daily menace of predatory tax inspectors. "They are threatening to charge me a penalty that will amount to a 100 per cent of my profits," he said, "because my books show that I have sometimes made a sale of more than Rs 2 lakh in cash in a day. When people pay cash, and there are many who prefer to, I put the money in my bank account and pay taxes and GST, but this is not enough. These tax guys tell me that if I had spread the amount over four days it would have been alright, but since I have been honest enough not to, they want to charge me this penalty. This is insane."

Yes it is. And, it is a direct consequence of the Prime Minister's relentless quest for 'black money'. It is true that tax evasion is widespread in our dear Bharat Mata, but there are reasons for this. The vast majority of Indians who evade paying taxes do it because the process of paying is so complicated. I do not pay GST in my line of work but those who do tell me that it is a Kafkaesque nightmare of rules and paperwork. Millions of small businesses have closed down because GST has driven them out of business. There has long been talk of 'rationalization' of this many-layered

tax but this has not happened yet.

Very rich Indians, of the honest kind, evade taxes because they often have to keep money aside to pay politicians at election time. Mr Modi knows well that despite his determination to end corrupt practices, the money that fuels the BJP's formidable election machine is as black as it comes. To get hold of this at election time, political parties deploy their most efficient looters. When the economy is booming and 'animal spirits' abound collecting for the party is usually easy. When times are hard as they are now the looters charged with finding this money do not hesitate to intimidate and threaten those who cannot pay. The irony is that if wealth creators were to use the same methods to collect their dues from government, they would land up in jail.

Minister noticed that many dishonest wealth creators give up their businesses to enter politics because they know it is much easier to make money out of 'public service'? Once they enter Parliament or some state legislature, they live like billionaires. They travel first class, go on wondrous holidays in foreign lands, send their children to fine foreign universities, buy their wives designer clothes and jewels and nobody asks any questions. If they spend Rs 2 lakh a day, no tax inspector asks them any questions because looters are cocooned by the mighty shield of political power. This is especially true if they attain high office and live in splendour behind the high walls of a bungalow in hated

Speaking of jail, has the Prime

Lutvens Delhi. Last week, while campaigning in Maharashtra, Mr Modi announced proudly that he had lived up to his promise of putting many looters in Tihar Jail. Decades of socialism created many, many looters who should be in jail, as should be wealth creators who loot banks on the pretense of doing business. The directors of the Punjab and Maharashtra Co-operative (PMC) Bank deserve to spend the rest of their lives rotting in a prison cell, as does Nirav Modi. But, if an honest man is forced into bankruptcy because he accepted cash from a customer that exceeded the ludicrous limits imposed by a bad regulation, then there is something very wrong with what is happening. Wealth creators must never be forced to live at the mercy of looters. This is something that happens only in bad countries.

Gandhi, the eternal poet

GANDHI HAS called himself "an artist of non-violence". That makes it easy for artists, including poets who are artists of the word, to connect with the great man and his lasting legacy. Gandhi has said very little about poetry, though he had deep spiritual links with the Bhakti and Sufi poets and had carefully and critically read Gita, if we consider that an example of India's poetry which is, at times, nothing but philosophy in verse. But his very life was like that of poetry, everseeking, ever-evolving, profoundly conscious of the power of words to establish connections among apparently distant and even contradictory things, employing suggestive symbols picked up from the kitchen and the work place, creating new meanings out of paradoxes and retreating into suggestive silence when words seemed to fail

THE YEAR was 1931, a very crucial year for Indian politics, with Mahatma Gandhi and others at the helm of the freedom struggle. Caroline Miller, a teacher at Allahabad's Crosswaithe College, and Ramchandar Lakshman Rau, a journalist with The Hindu newspaper in Allahabad (now Prayagraj), decided to tie the knot and take part in India's struggle for freedom.

Since she was a Christian and he a Hindu Brahmin, it had to be a court marriage. Two weeks before the wedding, the couple had to give a notice to the court registrar. The wedding took place in Allahabad on February 2, 1931. This was the first inter-religious and first inter-caste marriage of the year. The registrar, a Mr Mumford, after whom Mumfordganj in Allahabad is named, issued a certificate. The wedding had two witnesses — the then principal of Crosswaithe College, C R Powiah, and a trustee of the college's board. However, the main witness was not present as he was observing 'maun vrat (fast of silence)'.

It was Mahatma Gandhi.

After the ceremony, the newly married couple went to Anand Bhavan to request Gandhiji to sign the certificate. Gandhiji had known the couple since the early days of the freedom struggle. After signing the document, he turned it over and wrote, "May

you both live long to serve the nation". The certificate now lies at the Nehru Memorial Museum and Library, among R L Rau's

other documents. For those wondering about this preamble, I

happen to be the daughter of this illustrious couple.

My first encounter with Gandhiji, which was also perhaps my last, was spurred by the colossal

turn of events that took place before his assassination on January 30, 1948. It all began when I joined the 1942 Quit India movement spearheaded by him. I was nine years old. The movement had taken shape after the failure of talks between the British and our national leaders. We saw our parents, relatives and friends join the revolt. Leaders such as Sucheta Kriplani, Acharya J B Kripalani, Maulana Azad, Lakshmi Sahgal, Dr Krishnabai Nimbkar, and Aruna Asaf Ali plunged headlong into the movement.

The spirit of 'Quit India', that came soon after Gandhiji's Satyagraha movement, en-

thused many children to fight for the country's freedom. About a hundred of us left school, much to the chagrin of our teachers, and took to the streets of New Delhi shouting "Inquilab Zindabad" and "Bharat Chhodo" slogans. On August 14, 1947, around 11 pm, my parents and I went to the Central Hall of Parliament. With bated breath we awaited the stroke of midnight. When the moment came, the air rent with cries of 'Jai Bharat' and 'Jai Hind'. Like Nehru said, "... When the world sleeps, India will awake to life and

The next day, August 15, 1947, was a day of reckoning and joy for every Indian. We reached the Red Fort before sun break. At 7 am, Nehru arrived, dressed in a simple kurta-pyjama and the famous 'Nehru jacket', and unfurled the Tricolour to the rendition of 'Jana Gana Mana' at exactly 7 am. It was a proud moment. We breathed free in a free nation.

As mentioned earlier, my most memorable encounter with Gandhiji was on the penultimate day of his assassination. On January 28, 1948, my friend and classmate at New Delhi's Modern High School, Tara Bhattacharya (née Gandhi), Gandhiji's grand-daughter, asked me to accompany her to Birla House, where Gandhiji held his prayer meetings. She told me we would be his 'dandis (sticks)' — he would place his hands on our shoulders and be escorted to the prayer platform. It was a great honour for me to have the Father of the Nation bless me with his hands on my shoulders. We escorted him to the Prarthana Manch, from where he sat and addressed a large gathering of people.

During the course of the prayer meeting, an explosion occurred on the grounds of Birla House. It was not clear if it was linked to Nathuram Godse, but perhaps it was a sign of the events to come.

After the address, I touched Gandhiji's feet, and asked him to bless me. He said, "Ab toh hum chale, tumhare kandhon aur hathon mein iss desh ko saunp kar. Tum phoolo aur phalo. Is desh ki tarakki ke bhavishya bano. Bhagwan tumhe bhala aur surakshit rakhe (We are leaving now. handing over this country to you. May you flower and grow. Become the future of the nation's success. May God keep you healthy and safe)."

Out of **MY MIND MEGHNAD DESAI**



THE MOST intriguing question of modern Indian history of the last 75 years is why did Indira Gandhi call an election in March 1977? She did not have to. The Opposition was in jail. While some underground activity was going on, Indira Gandhi was in complete control of the government, the Army and the judiciary. Her son and chosen successor Sanjay was telling her to not bother about an election. The president was in her pocket. She was constitutionally within her power to rule for as long as she liked.

But she called an election. Her secret services told her she would win. They

her decision was one which said she could not stand the international criticism which was appearing in New Statesman. Foreign leaders such as Labour Party leader Michael Foot sentimentally backed her, but there was unease abroad. Indira Gandhi wanted to ensure that she could prove to the British that she was democratically popular. That the people should not care about the politicians in jail as they were just troublemakers. She was Mother India.

What moved her is a fundamental fact about Indian politics, whichever party is in power. The fact is that India and its politicians exist in a goldfish bowl where they are acutely aware of the Western gaze. The countries does not matter. In a way nor does German or Italian press. It is foreign English-language press and, to some extent, BBC Radio and TV. Politicians are sensitive souls. Whatever nonchalance they pretend to, a disapproval from a foreign Western source hurts. Historically, Indians have never looked

Eastwards. They do not think they are Asians. Sir William Jones discovered in the late Eighteenth century (while he was the judge for East India Company's Law Courts) that Sanskrit had affinity with Greek and Latin and called them an Indo-European family of languages. It worked like magic and ever since Indians have thought of themselves as European.

- Mahatma Gandhi, Jawaharlal Nehru, Subhas Chandra Bose, Sardar Patel, B R Ambedkar, or even to preach as Vivekananda did. Rabindranath Tagore is the sole leader who went as readily to Japan and China as to the West.

A recent example of this sensitivity to Western opinion came when the British Labour Party passed a resolution on Kashmir. It was critical of the Modi government. It could hardly be surprising, but the reaction in India was furious. How dare the Labour Party criticise the Indian government? But then the Kashmir issue has been discussed in most years at the party's annual conference. The Labour Party has many members of the South

Asian diaspora as its members. When I was active at the conference, I recall there were always resolutions sent by local parties to the conference. They were sent by parties with members who had migrated from Mirpur (Pakistan Occupied Kashmir), Pakistan, India taking diametrically opposite stands. These resolutions would be composited into one common resolution which would be debated by the conference. Nothing much happened to these resolutions, whether passed or not.

All these years no one has paid any attention to Labour Party resolutions. The reaction reflects much more Indian sensitivity than any practical consequence of the resolution. Why are people so sensitive?

FOR THE first time since its inception in 1969, the Booker Prize has gone to a black writer. This went unnoticed because it has gone to many people of colour, especially Indians, and Salman Rushdie is top of the heap with the Booker of Bookers. But black writing is a different thing, especially in America, and it is worth looking beyond current and popular voices like Maya Angelou, Alice Walker and Toni Morrison, to names that no longer grace bookstores the world over, but spelt literary power in their time:



JAMES BALDWIN (1924-1987) produced reverberating work urging the acceptance of colour and queer sexuality. Prominent

works include Tell Me How Long the Train's Been Gone (1968), Giovanni's Room (1956) and the loosely autobiographical Go Tell It on the Mountain (1953). Unusually, he did not wish to be seen as a black writer.



LANGSTON HUGHES (**1902-1967**), a leading figure of the Harlem Renaissance, was an early adopter of jazz poetry, which

appropriated the syncopated rhythms, downbeats and repeats of jazz and blues music. His collected works are available from Knopf, and his best-known book was also his first: The Weary Blues (1926).



ANGELA DAVIS (BORN 1944), radical feminist, former communist and Black Panther affiliate, is professor emerita at the

University of California's History of Consciousness Department. Known as much for her activism as her writing, the Rolling Stones' Sweet Black Angel is dedicated to her. Her most widely-read works are probably Women, Race and Class (1983) and If They Come in the Morning: Voices of Resistance (1971).



ELLISON (1914-1994) wrote only two novels, apart from the posthumously assembled Juneteenth -Invisible Man


(1952) and Three Days Before the Shooting... (unfinished, published 2010), but left an indelible imprint on American letters. *Invisible Man* was a huge bestseller and beat Hemingway's *The Old Man and the* Sea to the National Book Award.



OUR LAST recommendation is not literary, but an unusual historical document: The Negro **Motorist Green** Book was an annual published from New York

City for three decades, 1936-1966. While the Jim Crow laws were in force in the US, it was essential reading for black people who, despite being poor, had bought cars to avoid segregation and humiliation while using public transport. Published by New York postman Victor Hugo Green, it listed hotels, restaurants, petrol pumps and shops which would not refuse to serve black travellers. It was a guidemap to a whole alternate nation thriving within racist America.

Birth of the Iron Fist

Margaret Atwood's latest reveals the insidious armature of Gilead — an oppressive political order we are uncomfortably familiar with

HO ARE you, my reader? And when are you? Perhaps, tomorrow, perhaps 50 years from now, perhaps never." In Margaret Atwood's new novel, its most vital character is aware of the possibility that the testimony she is writing, at the pain of death, could mean nothing without the presence of a reader. That it would be as a tree falling in a silent forest, unacknowledged, unheard. But since 1985, when The Handmaid's Tale was first published, readers have hearkened to the book's most striking warning — that every society carries within itself, like an unfertilised egg journeying to the womb, the possibility of dystopia.

"Nations never build apparently radical forms of government on foundations that aren't there already," wrote Atwood about the Gilead she had imagined in *The Handmaid's Tale.* "The deep foundation of the United States — so went my thinking was not the comparatively recent 18th-century Enlightenment structures of the Republic, with their talk of equality and their separation of church and state, but the heavy-handed theocracy of 17th-century Puritan New England — with its marked bias against women — which would need only the opportunity of a period of social chaos to reassert itself."

In Gilead (formed by the violent overthrow of American liberal democracy), women are brutally segregated and stripped of all right to money, property and movement; a pariah class of women lose their names and social standing, and are forced to undergo ritualised rape to reproduce for the rest of the community. The backsliding of history and democracy across the world, and the strengthening of religious nationalism, has meant that reading Atwood's dystopia today is a way of making sense of events that might midwife such worlds. Sometimes, it helps us spot them in the headlines. For instance, Alabama's near-total ban on abortion became law earlier this year.

The Testaments, which has just won the 2019 ManBooker Prize with Bernadine Evaristo's Girl, Woman, Other, was written, says Atwood, to answer a more hopeful question: how does Gilead fall? The answers come through three testimonies — of a young woman growing up in Gilead; another young girl who lives across the international border in Canada; and of Aunt Lydia, one of the founders of Gilead, who created the ideological apparatus (and the corny hymns) that keeps women in their place.

This diversity of voices gives it a different texture from the breath-pinching claustrophobia of the first novel. Like its protagonist Offred, whose vision is compulsively constrained by the wings framing her face, the reader of The Handmaid's Tale experiences an ominous world through silence and suggestion, but does not see its whole design. In the tantalising end of her account, Offred doesn't know what lies in store for her — she steps

"into the darkness within; or else, the light". In The Testaments, Atwood reveals the machinery of Gilead, the nuts and bolts of its systematised oppression, and the ugliness where it is coming apart. It also answers the question that many of us are asking of his-

tory: how do totalitarian regimes seize power? "In the vanished country of mine, things had been on a downward spiral for years. The floods, the fires, the tornadoes, the droughts... People became frightened. Then they became angry," writes Lydia of the series of events which made Gilead possible. Why do people not rise up in revolt? "Ignoring isn't the same as ignorance; you have to work at it." How does the unthinkable become the usual? "The reality is that many children were loved and cherished, in Gilead and elsewhere, and many adults were kind though fallible, in Gilead as elsewhere," writes one of the girls.

In The Handmaid's Tale, Aunt Lydia was a cartoon figure of pure ruthlessness, terrifying and one-note. The Testaments opens with her writing a holograph in a secret chamber, in the Forbidden World Literature section of a library, away from the prying eyes of security cameras (she knows where they are, because she has placed them there). The Aunts, bureaucrats of the regime, are the only women allowed to read and write; and the only women with a modicum of power. Hers is a message to an unknown world, but also a

reckoning of not just the sins of Gilead, but of what brought her here. Before she became Gilead's ace apparatchik, Aunt Lydia was a judge, a believer in "life, liberty and democracy", someone who had made it the hardscrabble way. When Gilead shuts her life down, she chooses betrayal and survival. "What good is it to throw yourself in front of a steamroller out of moral principles and then be crushed flat like a sock emptied of its foot? Better to fade into the crowd, the piously praising, unctuous, hate-mongering crowd. Better to hurl rocks than to have them hurled at you."

Aunt Lydia's testimony slyly asks the question of the reader: what would you have done? But more importantly, for all purposes, this ironic, scheming, twisted survivor, who gobbles down an egg sandwich after witnessing a murder, remains the hero of this tale. This is Atwood's steely-eyed pragmatism at work. It asks us to contemplate the moral murkiness of all human decisions; it tells us that spotless idealism might not survive to fight another day.

The Handmaid's Tale is, undoubtedly, the superior work of the two — The Testaments, by its very structure, exchanges an expansive,

plot-driven narrative to the former's brooding, punch-in-the-gut brilliance. But you can only read these books as prophecy up to a point. For one, as Atwood has pointed out before, no cruelty in this dystopia rivals civilisation's capacity for injustice. The reproductive slavery of women, their devaluation by patriarchy, continues in many parts of the world, complicated by race, class and ethnicity.

As dystopias go, moreover, Gilead could be outpaced by reality. It appears to be a throwback to an autarkic time, its waters unroiled by social media's algorithms of hate; its totalitarianism a plain, doughty one, without extra trimmings of democracy, nationalism and mob violence.

Do not come to Atwood then for a map out of the mess you are in. Come, instead, to realise how human courage breaks and then resurrects; how resistance follows oppression; how a regime of fear infects love and friendship; and how hope might survive if humans act. Somewhere, in a cupboard in dystopia, is a message scribbled for all of us. We have the choice to read and bring it to life: "Nolite te bastardes carborundorum. Don't let the bastards grind you down."

A short but extremely detailed anecdotal perspective on the Western Ghats rainforest

WALKING INTO the rainforests of the Western Ghats is a magical experience that is not easy to recreate in a book. In Pillars of Life, Drs Divya Mudappa and TR Shankar Raman have pulled off the impossible. This slender book describes 28 characteristic rainforest trees from the Western Ghats, bringing the forest to life through text and illustration. The rainforests of the Western Ghats

rank amongst the most biodiverse forests in

the world. They are packed with trees of all shapes and sizes. Well-known ecologists, Mudappa and Raman stepped away from a more traditional academic path several years ago to live in the rainforests in the Anamalai and Valparai region. Their research on the rainforest directly informs the innovative approaches to rainforest restoration that they adopt. Pillars of Life describes some of the most charismatic, landmark trees in these threatened forests. Mudappa and Raman's rich intuitive understanding of these species comes from countless hours spent there, staring down at the floor, and up at the canopy, binoculars in hand. Through these narratives, their love for

trees and passion for the rainforest is both

visible and infectious. There is rich science here. Nageia wallichiana is a conifer that looks very different from the pine and fir trees we more commonly associate with the term. The tree comes from the family *Podocarpaceae*, an ancient family of gymnosperms that has been around since the dinosaurs. The differences in trunk, leaf, flower, fruit and seed structure are related to pollination and dispersal strategies. Trees can be pollinated and their seeds dispersed by wind, water, insects, and animals. Wind-dispersed trees

> stand tall above the forest canopy, enabling the wind to distribute their seeds to far-flung corners of the landscape without obstruction from other trees. Sunlight is a precious resource in the rainforest, and many species of Ficus use an ingenious strategy to grab the sunlight. A seed, dropped onto a higher branch of a host tree, germinates to give rise to the aptly named strangler fig — a tree which grows over and surrounds its host tree, and which eventually dies, starved of

access to sunlight. Mudappa and Raman are equally knowledgeable about bugs, bees, birds, bats, civets, squirrels, sloth bears, monkeys, elephants



Finally, the book would not be the same without Nirupa Rao's gorgeous sketches. Her illustrations, coupled with the evocative pen sketches of the Anamalai landscape by Sartaj Ghuman, help the book to come alive. In a particularly striking two-page spread on the wild *rudraksh* (trees of the

and other ungulates during the day, and by

flying squirrels at night.

Elaeocarpaceae family), Roy uses a series of six sketches to show us how the leaves turn from bottle green to flaming red before they finally drop onto the forest floor, forming a vivid carpet of scarlet colour. Visuals like this help us paint a picture of the forest, floor and canopy, in our minds in a way that photographs simply cannot, prompting our imagination to fill in the rest of the picture.

Trees are keepers of history. A giant banyan tree at the south-eastern edge of Bengaluru, not far from where I live, has witnessed a number of rulers come and go from Kempegowda's descendants to the Marathas, Mughals, Wodeyars, Hyder Ali, Tipu Sultan, and the British Raj. The tree witnessed the Independence movement, saw the transformation of the agricultural landscape around it during the Green Revolution, and now stands next to a four-

lane highway connecting Karnataka with

Tamil Nadu, one of the last remnants of a once green and fertile landscape.

Standing tall over the rainforest canopy for centuries, as the authors say, the trees they write about have acted as "historians and record keepers of the local environment." Some of the trees in the forests they describe are hundreds, even thousands of years old. Yet we chop them without thinking, decimating the last few remaining rainforest fragments thoughtlessly. Once lost, we can never recover them. Their hope is that books like these can inspire more of us to understand the ecology and be inspired by the magical experience of living with trees. We need a forest of books such as these.

SIBERIA 15 die in dam collapse at gold mine

Moscow: Fifteen people were killed and another 13 missing after an illegally built dam collapsed at a gold mine in a remote Siberian settlement on Saturday, in the latest deadly accident to hit Russia. The dam on the Seiba River in the Siberian region of Krasnoyarsk burst and flooded several cabins where the victims lived, Russian authorities said. About 300 people, six helicopters and six boats were involved in a search and rescue mission, the emergencies ministry said.

EGYPT

Over 100 held in crackdown freed: Lawyers

Cairo: Egyptian rights lawyers say authorities have released over 100 people who were among hundreds more arrested in a sweeping crackdown following small but rare antigovernment protests last month. Lawyers Mustafa el-Demiry and Khaled Ali say the detainees were released late Friday, pending an investigation into claims they took part in the activities of a banned group and disseminating false news on social media platforms. The Egyptian Center for Economic and Social Rights says around 3,700 people including journalists, activists and foreign nationals, were arrested in the past month.

SRI LANKA Lanka removed from FATF's **Grey List**

Colombo: Sri Lanka has been removed from the "Grey List" of terror financing watchdog FATF, according to a report. The nation will no longer be subject to the force's monitoring under its on-going global anti-money laundering and countering the financing of terrorism (AML/CFT) compliance process, the Colombo Gazette reported on Saturday. The FATF, whose five-day plenary concluded in Paris on Friday, said Sri Lanka made significant progress in addressing the strategic AML/CFT deficiencies identified earlier, the daily said.

UK PM defiant after lawmakers vote to force delay in Brexit plan

In new twist, amendment proposed by expelled Conservative Party member passes 322-306

LONDON, OCTOBER 19

PRIME MINISTER Boris Johnson suffered a humiliating defeat on Saturday as Parliament rebuffed his campaign to take Britain out of the European Union by the end of the month and forced him to seek an extension that he had vowed never to pursue.

The events left Johnson's agreement in limbo and threw British politics again into chaos, with any number of outcomes possible: a no-deal exit from the European Union, a second referendum on whether to leave at all, or a general election that could shift the balance in Parliament. The only sure result was continuing frustration and confusion among the British public. Johnson argued that it was

the best deal Britain could hope to strike — one that, in his telling, would position the country for a thriving future as an agile, free agent in the global economy – and that any further delay would be "pointless, expensive and deeply corrosive of public trust."

Instead, by a vote of 322 to 306, lawmakers passed a lastminute amendment, brought by Oliver Letwin, an expelled member of Johnson's Conservative Party. According to the amendment passed by the House, the vote means Johnson is obliged to write to the EU seeking a delay beyond Britain's scheduled departure date of October 31.

But Johnson has repeatedly

said he will not do this and on Saturday he stuck to that line.

"I will tell our friends and colleagues in the EU exactly what I have told everyone else in the last 88 days that I have served as prime minister: that further delay would be bad for this country, bad for the European Union and bad for democracy." The European Commission

urged Johnson's government to quickly explain how it wants to proceed with Brexit preparations after losing another parliamentary vote. Spokeswoman Mina Andreeva said Brussels "takes note of the vote in the House of Commons today on the so-called Letwin Amendment meaning that the Withdrawal Agreement itself was not put to vote today.

"It will be for the UK government to inform us about the next steps as soon as possible," she

'NEW REFERENDUM'

THE BATTLE over Brexit spilled onto London streets Saturday when tens of thousands gathered to demand a new referendum. "I am incensed that we are not being listened to. Nearly all polls show people want to remain in the EU. We feel we are voiceless," said Hannah Barton, 56, a cider maker from central England, draped in an EU flag.



What is the Letwin amendment?

THE LETWIN amendment, proposed by Conservative rebel Oliver Letwin, delays a vote on the Brexit deal until the House passes the required legislation to implement it properly. It is intended to be a safety net to prevent hardline Brexiteers from engineering a no-deal situation.

The legislation requires Johnson to write to the EU, requesting a delay till January 31, 2020. The PM has, however, ruled out "negotiating" for an extension. Saturday's vote does not mean the PM's deal is dead, as he has vowed to introduce the required legislation next week. Whether it will pass within the original deadline remains to be seen.

Erdogan vows to 'crush the heads' of Kurdish forces if no pullout

PRESS TRUST OF INDIA ISTANBUL, OCTOBER 19

PRESIDENT RECEP Tayyip Erdogan on Saturday warned that Turkey would "crush the heads" of Kurdish forces if they did not withdraw from a proposed safe zone along the border under a US-brokered deal.

If the pullout does not happen by Tuesday evening, "we will start where we left off and continue to crush the terrorists' heads," Erdogan said in a televised speech in central Anatolian city of Kayseri.

Turkey has agreed to suspend its Syria offensive for five days and to end the assault if Kurdish-led forces withdraw from the proposed safe zone away from the border.

Erdogan also provided some details from his talks with the Americans, adding that Ankara agreed to the 120 hour time deadline after its initial demand of "one night" for the withdrawal.

"If the promises given to our country are not kept, as we did in the past we will not wait and restart the operation as soon as the time we have given ends," he said.

The Turkish leader said he also informed US President Donald Trump of Ankara's position during a phone call late Friday.



'TURKS PREVENTING WITHDRAWAL OF FORCES, CIVILIANS'

Beirut: The commander of Kurdish forces in Syria accused Turkey of sabotaging a US-brokered truce Saturday by blocking the withdrawal of his forces from a flashpoint border town in northeastern Syria. "The Turks are preventing the withdrawal from the Ras al-Ain area, preventing the exit of our forces, the wounded and civilians," Mazloum Abdi, head of Syrian Democratic Forces (SDF) said in a phone interview from Syria. **PTI**

PAKISTAN'S OPPOSITION leader Bilawal Bhutto-Zardari has announced that his party would hold nationwide anti-government protests to press Prime Minister Imran Khan to resign and restore "real democracy" in the country.

Bilawal, the chairman of the Pakistan Peoples Party, said the government had lost its credibility in the masses as it did not fulfil any of its promises. "Our demand is to restore democracy [in the country]," he said in his address at a party rally here.

"We don't accept this artificial democracy. the democratic and socio-economic rights of the masses shall be restored, and for that Imran Khan has to resign."

Bilawal, 31, said all opposition parties had decided that the government must step down.

"Our anti-government movement has started from Karachi," he said, as he announced his plan for further protests across the country.

He said the PPP will protest in Thar on October 23, demonstrate in Kashmore in Sindh province on October 26 whereas rallies in Punjab will begin from November 1.

Syria withdrawal strategic nightmare, says McConnell

US SENATE majority leader Mitch McConnell Friday attacked President Donald Trump's decision to pull troops from Syria as "a strategic nightmare" that will help Washington's foes and hurt its allies.

"Withdrawing US forces from Syria is a grave strategic mistake," McConnell, the top Republican in Congress, wrote in an op-ed published in *The* Washington Post.

"It will leave the American people and homeland less safe, embolden our enemies, and weaken important alliances." His comments come after Trump Wednesday defended his decision to pull US troops out of Syria as "strategically brilliant."

McConnell, usually a staunch supporter of the president, had


While the CVC Act says a retired Central Vigilance Commissioner cannot take up a diplomatic assignment or forprofit government office, it doesn't bar them from taking up a private sector job.

The Act also doesn't stipulate a cooling-off period or whether any permission has to be sought before taking up a private sector job.

"Pursuant to Regulation 30 of the Securities and Exchange Board of India Regulations, 2015, please note that the Board of Directors at its meeting held today, i.e. October 18, 2019, has appointed Shri K V Chowdary as an Additional Director-Non-Executive," it said.

It added that Chowdary was not related to any director of the company. "In accordance with the circular dated June 20. 2018, issued by the stock exchanges, we hereby confirm that Shri K V Chowdary, is not debarred from holding the office of director by virtue of any SEBI order or any other such authority," it said.

During Chowdary's tenure as CVC, the CBI saw one of its biggest crises following infighting between its top two officers the then CBI Director Alok Verma and then Deputy Special Director Rakesh Asthana –

who levelled charges and counter-charges against each other. The Supreme Court directed Chowdary to conduct a probe into the allegations against Verma.

In a formal submission to Justice A K Patnaik, the retired Supreme Court judge supervising the inquiry, Verma said Chowdary visited his residence as an "arbitrator" for Asthana.

While Verma was sacked in Ianuary this year, Asthana was moved out. The decision to remove Verma hinged ostensibly on the CVC's inquiry report. Chowdary, in his report, is The Mukesh Ambani- learnt to have said that the witowned RIL communicated the ness, Satish Sana Babu, who implicated Asthana in a corruption case, was unreliable.

A 1978-batch Indian Revenue Service (IRS) officer, Chowdary was appointed Chairman of the Central Board of Direct Taxes (CBDT), the top policy making body of the Income Tax department, in August 2014. On his retirement, he was

appointed as an Advisor to the Department of Revenue on issues relating to black money, before being made the Central Vigilance Commissioner (CVC) on June 10, 2015. His selection as CVC was

challenged in the Supreme Court, but the petition was eventually dismissed as the court said the complaints could not be taken at face value.

On October 17 last year, RIL had announced the appointment of former SBI chairperson Arundhati Bhattacharya as an independent additional director on its board for a period of five years.

G20 agrees to tighten norms for 'stablecoins'

Group of 20 (G20) finance leaders on Friday agreed to set strict regulations on cryptocurrencies such as Facebook's Libra, warning that issuance of such "stablecoins" should not be allowed until various global risks they pose have been addressed.

The agreement came after a G7 working group warned that when launched on a wide scale, stablecoins – digital currencies usually backed by traditional money and other assets - could threaten the world's monetary system and financial stability.

Finance chiefs of the G20 major economies agreed that while stablecoins could have potential benefits of financial innovation, they give rise to a set of "serious" public policy and regulatory risks. "Such risks, including in par-

ticular those related to money laundering, illicit finance, and consumer and investor protection, need to be evaluated and appropriately addressed before these projects can commence operation," the G20 finance leaders said in a statement issued after their meeting. Bank of Japan Governor

Haruhiko Kuroda said the G20 will kick off debate on how to regulate stablecoins based on proposals it receives from standardsetting bodies like the Financial Stability Board (FSB) and the Financial Action Task Force (FATF) The FSB and the FATF are ex-

pected to report their findings on stablecoins to the G20 next year That reduces the chance Facebook will meet its goal of rolling out Libra in 2020.

"Policymakers have expressed concerns over various risks stablecoins pose. Until they are addressed, stablecoins should not be issued. That was something agreed by the G20 members," Kuroda told a news conference hosted by Japan, which chaired this year's G20 gather-

THE INTERNATIONAL Monetary Fund (IMF) said on Friday its 189 members agreed to maintain the IMF's \$1 trillion in total lending resources, while delaying changes to its shareholding structure to as late as December 2023.

The move ends a deadlock with the United States, which had opposed shareholding changes that would give a bigger voice to China and other large, fast-growing emerging markets in a review process that was due for completion this year.

IMF Managing Director Kristalina Georgieva announced the decision at the Fund's and World Bank's annual meetings, saying that the initiative will provide confidence that the IMF can adequately support member countries as they deal with slowing global growth.

US Treasury Secretary Steven Mnuchin, who holds an effective veto over major Fund decisions,

endorsed the move, which calls for a doubling of the IMF's crisis lending fund to about \$500 billion, restoring it to levels during the 2008-09 financial crisis. It would be accompanied by a reduction in bilateral lending arrangement to keep overall IMF resources unchanged.

But it would require the United States to double its commitment by contributing about \$38 billion to the fund, known as the New Arrangements to Borrow (NAB), a move that would need approval from the US Congress.

The ministers and governors also took updates from the G20 deputies on quality infrastructure investment, debt sustainability, financing for universal health care and building effective country platforms, and from the Africa Advisory Group on the Compact with Africa initiative.

On the discussions at the session regarding the work underway on developing a consensus solution on tax challenges arising from digitisation, the FM stated that a unified approach to the nexus and profit allocation challenges was a promising one that merits serious attention.

'Boeing pilots saw MAX system problems in 2016'

A BOEING pilot behind the 737 MAX certification in 2016 told a colleague a key flight handling system was "running rampant" during simulator tests, as per doc-

uments reviewed Friday by AFP. The Boeing staff guipped about problems during simulations of the Maneuvering Characteristics Augmentation System (MCAS), a flight-handling mechanism that is believed to be at the center of two MAX crashes that killed 346 people. Boeing's chief technical pilot of the 737, Mark Forkner, said the MCAS system's performance during the simulator tests was "egre-

gious" and that "I basically lied to the regulators (unknowingly)," according to the instant messages.

Forkner's lawyer, David Gerger, told AFP Saturday, "If you read the whole chat, it is obvious that there was no 'lie.' The simulator was not reading right and had to be fixed to fly like the real plane. Based on everything Mark knew, he thought the real plane was safe." The messages — which Boeing knew about for months before sharing with the Federal Aviation Administration — raised fresh questions about the company's knowledge of problems with the MAX long before the crashes and about whether it has been transparent with regulators

'Should be able to follow your dreams. It doesn't make you a bad mother'

Sania Mirza's comeback bid has been all about striking a balance between being a selfless parent and a selfish athlete. Messages from inspired mothers resuming jobs spur her on, but the need to compete and quest for an Olympic medal are the true motivators. MIHIR VASAVDA speaks with the tennis star.

The other night, was the first time ever that I went out overnight. I usually speak to him on FaceTime. When I spoke to him that night, it was the first time he looked at the screen and cried because he wasn't able to hold me or whatever. So I think now the realisation is coming more. The awareness that I'm not there. But it is what it is.

SANIA MIRZA is talking about 'selfless love'. For an athlete, it's a tricky territory. Being a world-class professional demands a certain level of selfishness: block out everything and everyone, focus on your training, your matches, your travel and your recovery.

Being a parent, she realised after the birth of her son Izhaan last October, is quite the opposite. "Suddenly, it's not about you anymore," she gasps. Sania sneaks out for training when her son is asleep and gets back before he wakes up. When she is away for work, her mind drifts to a thought that distracts millions of working parents: "What's my child doing?"

On a comeback trail, the 32-year-old has spent the last one year juggling between being a selfless mom and a selfish athlete. It's tough, exhausting even. But she hustles on, determined to show women who 'kill their dreams' after motherhood, that it needn't

What've your days been like since you've returned to full practice?

I start my day around 6.30 or so because after having the baby, I have to manage my time. That is the biggest challenge you face because you have to manage your time according to his timing. So I try to go for practice very early, I try to finish by 9.30-10 so by the time he wakes up, which is around 9-9.30, I can be back. After a 2.5-3 hour practice session, I spend some time with him. Then, there are some days when I do Pilates and some days I do a two-hour gym session. It's a tough day. I am exhausted. It's not like before where my only job was to play tennis and train.

Often, as athletes, you've got to put yourself first. As a parent, is it tough to balance your needs and your child's?

The biggest change I've had since having Izhaan is that it's a very selfless kind of love you have with your child while as a tennis player, everything revolves around you. Your training, your warm-up, your cool-down, your recovery. It's all about what you want to do. And then all of a sudden, it's not about you anymore. It is challenging, but it's a very natural process. It just happens by itself which is why it is quite hard not just to play tennis but to work, if you have an office job, right after you have a child. It's very difficult because there's so much in the beginning years, when the mother is a lot more involved with the child as opposed to the father. Which is why it is very challenging to find that extra energy, motivation and inspiration.

Mine is not a routine office job. It requires a lot of self-determination and physical hard work. There are many times when he wakes up two-three times in a night. So you're not actually getting that kind of sleep and rest that you probably need. Most of the times he sleeps with me, so when I start to play matches, one of the things I will have to do – especially on match nights — is he will have to sleep separately because it's not possible for my body to recover the same way if I'm not getting proper sleep. Those are the things that are quite challenging. Again, it's a natural sort of process so I'm just dealing with it. It's a new experience and been a lot of fun and different. But it's not taking a toll on me yet.

When you are away once you start playing and travelling, you think it might be different?

When I go for my work or endorsements,

I do leave him overnight with my mom – he's very good with her. Thankfully, I have a great team. We call it Team Izhaan, I always joke about it. So for me, it's been relatively good and he's easy. The first time I actually went to work, I was in Delhi for a day when he was six weeks old, it was the hardest day I had in years. I couldn't imagine it would be that difficult. He probably didn't even notice that I had gone but it took a toll on me.

Now, he's almost one and he kind of understands when I'm not there. The other night was the first time ever that I went out overnight, to Mumbai I think. I usually speak to him on FaceTime. When I spoke to him that night, it was the first time he looked at the screen and cried because he wasn't able to hold me or whatever. So I think now the realisation is coming more. The awareness that I'm not there. But it is what it is. At the end of the day, I advocate that as a mother of a child, your life doesn't end. It doesn't mean you kill other dreams or whatever you want to do, no matter what you do. It doesn't make you a bad mother. It's always the mother's guilt that people always put you through by saying things like 'oh my god, how do you leave him' or whatever... there are so many people saying all kinds of things. With a good support system, you should be able to follow your dreams too. It doesn't make you a bad

Before she was forced off the court in 2017, Sania was on a scarcely-believable run. a dozen other finals that made her the undisputed best in women's doubles. Her march, though, was abruptly ended by a freak knee injury — jumper's knee, caused by repetitive stress on the quadriceps tendon — in October

Year-ending 2017, she was ranked 12th in doubles. And even though she isn't ranked right now by the Women's Tennis Association (WTA), Sania has the cushion of starting where she left after the WTA introduced a rule last year that allows a player returning from pregnancy to use her Special Ranking (the ranking at the time when her break began).

During training, the shots are flowing like they did before. But Sania is waiting to see if it all comes together on the court. She is in awe of Serena Williams, who has shown that she hasn't lost any of her powers after having a baby. And with former world number 1 Kim Clijsters, a mother of three, announcing a second comeback from retirement, there's enough inspiration around.

Till a couple of years ago, it seemed tennis was better designed towards fathers making a return than mothers given there were close to two dozen men returning to Tour compared to barely a few women. But next year, you will join a growing brigade of moms who will compete on the professional tour. How do you feel about that?

It's extremely inspiring. Of course, Serena has done it now but I think Kim was the first

back and won a Grand Slam. She is making a comeback again. It's pretty amazing and inspiring to see other women being able to pursue their dreams and keep them going. I have seen most women, especially athletes, most people used to retire and have kids. That was kind of a norm. And it's obviously changed in the last few years.

Now that you're back on court practising daily, how do you feel about your game?

Istill have two-and-a-half months before I have to compete. It's (the game) pretty close. But no matter how much you train, there's nothing like match practice. If I feel at any point that it's too hard to manage, I'm going to have to take decisions then and there. Right now, I do think I have tennis left in me.

Is that why you are making a comeback, because you feel there's something more left to offer?

The simple fact is that I really miss competing. I feel that I still have a few years left in me at the top level. It would be incredibly amazing for me if my son can watch me play at a big tournament and watch me win. I could've easily said it's over and I would've been very proud and happy about the career I've had. I have been number 1, I have won Grand Slams. What more can I do? But I just felt that I still had competition left in me. That's one of the main reasons.

And then, I feel if I'm able to inspire even one woman, how incredible would that be! I get so many messages everyday from and are now joining gym or returning to work because they saw my video. And I'm not even competing yet. Those are the best moments of my day, when I read those messages from all these women. So it's a bunch of reasons why I would like to come back and I think that even if I'm not able to come back, hypothetically speaking, at least I tried. And that's what is important. It's about trying.

Has your measure of success changed?

The whole outlook to life changes after you have a kid. But when I walk on the court, I would still want to win. That's the player inside me. If I don't feel that way, then I shouldn't be playing. But I do think that for me, whatever I do from now on in my life, especially in tennis, is only a bonus. Because my career could've well been over two years ago when I had a knee injury and I was pregnant. So whatever I'm able to do now on will be a bonus. It's almost like a second life for my career.

Her 'second life' will begin in the first week of the New Year. Sania hopes to return to the Tour two weeks before the Australian Open, which gets underway on January 20. Her schedule, she says, will depend on whom

2020 is also the year when the Olympic Games will take place. The last two Olympics have been nothing short of a soap opera, a cringey one at that, as far as Indian tennis goes. The ego battles between Leander Paes,

she eventually partners.

In Rio, Sania and Bopanna came closer than ever to pocket a doubles bronze. The pair was a set and a break up against USA's Venus Williams and Rajeev Ram in the semifinals before the wheels came off and they lost in three. In the medal match, they lost to Czech pair Lucie Hradecka and Radek Stepanek in straight sets. Moments later, Sania admitted she might have played her last Olympic Games.

For some of us on the outside, the buildup to an Olympics, as far as tennis goes, has been traumatic. Are you looking forward to a peaceful way to play an Olympics one last time?

(Laughs) When we lost in the semifinal at the last Olympics, it was the most painful experience of my career. When you lose in the first round, it probably hurts less than when you're playing for the medals. At that point, I had no intention of playing tennis at the next Olympics. Now that I'm making a comeback hopefully, that is definitely something that is in the back of my head. I would be very proud of myself if I'm able to make it to Tokyo.

I have been very clear — whether it was Olympics, Asian Games or Commonwealth Games — that I always play for my country. I don't play for anybody else. Olympics is very close to my heart. And Tokyo would be special as well because it will be my fourth Olympics. It'll be amazing to be in a position to compete because probably the only thing missing from my career if I ever look back later is an Olympic medal. So it would be an amazing opportunity for me to put myself in that position again. I remember Olympics very fondly (laughs).

Do you, though, truthfully? You say Olympics are special and yearn for a medal. Could the story have been different at London or Rio if...

...To be very honest, I'm not a person who'll say I didn't win that because of that That's not fair and I'll be a sore loser. Do I want to have the same experience again at the next Olympics? Definitely not (laughs)! I think whenever you go with baggage into anything, especially to compete, it is very tough because you already have enough going on. So vou don't need extra baggage — everybody knows what was going on, all kinds of things being said, media was involved on different occasions, different people involved... So I don't think it helps the cause in anyway. Maybe, that wouldn't have happened and we wouldn't come with a medal regardless. That's why I won't say it's because of that we didn't win a medal. But I am going to say that I really don't think that any of that stuff helped when you are trying to go and win a medal for the country.

The entry, it seems right now, won't be so straightforward because of the rankings issue.

We have to wait and watch. It is very different this time. We are in a different position as a tennis-playing country. We are not in that commanding position that we used to be when Mahesh, Leander and Rohan were all in top 15 of the world and I was in the top 10. I have some relief, I am technically in the top 10. We just have to wait and see how it turns out.

At the end of the day, Rohit was unbeaten on 117 – his third century of the series, sixth overall in 30 Tests – when bad light followed by rain ended the day's play six overs after tea. Rahane was batting on 83 and India, thanks to an unbroken 185run fourth wicket partnership, had raced to 224 for three. Rohit, in the process, achieved the record of hitting most number of sixes in a Test series, 17.

Fans of a certain vintage have grown up watching Mumbai batsmen dominating Indian cricket. Mumbai batting pairs putting on century partnerships used to be normal in the 1980s and '90s; be it Sunil Gavaskar and Dilip Vengsarkar, or Sachin Tendulkar and Sanjay Manjrekar, or Tendulkar and Vinod Kambli (for a brief period). Things changed over the past two decades because the Indian team gradually became an assortment of players from almost every part of the country. Smaller cities started to rise and produce players, more so since the emergence of a Ranchi boy, answering to the name of MS Dhoni. Indian cricket thrived due to the game's expansion into every nook and cranny.

From that perspective, two players from the Mumbai maidans, displaying the 'Mumbai school of batting' and helping India come out of the woods happened after a long time. But as India's batting coach Vikram Rathour pointed out after the day's play: "Khadoos cricket that Mumbaikars used to play has changed now. You see Mumbaikars play a lot many more shots now. And you see some very, very solid players from other parts of India now. So, we weren't even looking at it as Mumbaikars' partnership. It was two good players who batted well for the Indian team today."

Rohit vs Rabada

The contest between Rohit and Rabada in the morning session was fascinating. Even after lunch, the South Africa quick bowled another top spell, and Rohit had to tough it out. Rahane took charge during that period, taking three fours off a Rabada over. The Indian Test vice-captain showed a lot of intent and his positivity kept the scoreboard moving at a brisk pace. Later, when Rohit was in his element, he became the aggressor.

Test cricket was resplendent in its ebb and flow, punches and counter-punches; but what a shame that barely 5,000-odd spectators turned up on the first day, on a

Coming back to Rohit's knock, fluidity started to arrive towards the end of the first session, when he dispatched Ngidi to the mid-wicket boundary with a short-arm pull. Another pull off Nortje a couple of overs later cleared the long leg fence. In between, Zubayr Hamza at short leg put down a tough chance off debutant left-arm spinner George Linde. It was, in fact Linde's first over in Test cricket and he was unlucky. while Rohit, dropped on 28, capitalised on the reprieve.

A glorious off-drive off Nortje took Rohit to his half-century. Then, he started to accelerate. He milked Linde, played a contemptuous inside-out extra-cover drive against Ngidi before decimating Dane

Piedt. The opener reached his hundred hitting a six off Piedt over long-off. The decision to promote him to the top of the order has proved to be a masterstroke.

"I always believed he (Rohit) is too good a player not to be playing in any format. It was a good call to make him open. With the amount of runs he has scored, he has settled the issue for the time being. Somebody of his experience and the kind of cricket he plays, if he starts coming good at the top of the order, it changes everything for the Indian team, even when you are touring," Rathour said.

South Africa sent Temba Bayuma for the coin toss but he didn't do any better than his skipper. The visitors lost the toss for the third time on the spin. They made five changes to their playing XI, including two debutants in Heinrich Klaasen and Linde. But yet again, they surrendered the initiative after making early inroads. Batting would be difficult in the fourth innings on this pitch, and the Saffers are already playing catch-up.

Nortje rues missed chances after India recover from 39/3

PRESSTRUST OF INDIA RANCHLOCTOBER 19

SOUTH AFRICAN pacer Anrich Nortje on Saturday rued letting India off the hook after reducing them to 39 for three on the opening day of the third and final Test here.

Hoping to avoid a 3-0 whitewash, South African bowlers gave a good account of themselves by taking three wickets quickly, but Rohit Sharma and Ajinkya Rahane shared an unbeaten 185-run partnership to take India to 224/3 in 58 overs when bad weather forced an early stumps.

Rohit slammed his third century of the series during a knock in which he grew in confidence. There were chances too: he successfully reviewed an LBW decision before getting a reprieve on 28 when Zubayr Hamza dropped a difficult chance.

"We were definitely better as in the previous Test. We just tried to control the game little bit better. Unfortunately, we couldn't get another wicket... It would have been nice to have them four-five down," Nortje said after the first day's play.

"We had one or two overs where we went on top, later on we just pulled it back again. So, maybe, here and there we lost but, in general, a good effort by everyone.

"Overall, it was a good effort by the bowlers. There was little bit in it this morning, tried to utilise as much but one or two overs didn't go our way."

Kagiso Rabada was the pick of the attack with 2/54 in 14 overs, while Nortje (1/50 from 16 overs) picked up the wicket of India skipper Virat Kohli. "I was hoping for a wicket somewhere and to get him was unbelievable, but just try and come with a plan. I try and put as much pressure as possible and finally got the wicket."

Hailing Rabada's effort, he said: "He bowled really well. He was asking the right questions everytime. I thought Lungi backed him up as well. The (bowling) partnership up front was quite decent, so all credit to them."

He said there's still hope in the side as they look to bounce back.

"I think there were quite a lot of opportunities right through the series. Lots of nicks going through the gaps or falling short. Something happened today here there, that's normal to cricket. We have to take it forward going from here. Just keep on asking those questions and control the controllables, I guess."

Nortje disagreed that their bowlers were finding it difficult to cope with the SG ball. "We have practised with it so I won't blame that. We have used that in South Africa

before we got here." The wicket had some uneven bounce, especially in the first session, and Nortie said: "Definitely it was keeping a bit low at stages, ball hitting the bottom of the bat. Bit of move-

ment but we will have to wait and see.

"I don't know about the next few days... Maybe we will get even or low consistently but ball staying low will have effect for the seamers I don't know about spinners."

Another Delhi-based bookie being probed in **KPL** fixing scandal

THE CENTRAL Crime Branch (CCB) unit of the Bengaluru police has identified a second bookie from New Delhi allegedly involved in luring players to indulge in game manipulation in the Karnataka Premier League (KPL).

The second bookie, Jatin Sethi, who was identified in the CCB investigation into illegal betting and match-fixing in the KPL approached a court in Bengaluru for anticipatory bail this week.

The CCB believe he is the missing link and have launched a search for him.

Sethi and another Delhi-based bookie Sanyam Gulati, who's at large, allegedly asked cricketers to underperform in the KPL this August. The identities of Sethi and Gulati emerged in the CCB probe following the arrest of Ali Asfak Thara, 40, owner of the KPL team Belagavi Panthers, and a celebrity drummer Bhavesh Bafna, 26 who has been part of tournaments like the KPL, Tamil Nadu Premier League and the Indian Premier League.

The Belagavi Panthers team owner Ali Asfak Thara was arrested last month for placing bets on KPL matches with a bookie allegedly based in Dubai. Thara is alleged to have influenced many players in the KPL with regard to the illegal betting racket.

The CCB police arrested the celebrity drummer Bafna last month on the basis of a complaint given by Bhavesh Gulecha, 26, a fast bowler for the Bellary Tuskers team in the 2019 KPL season. Gulecha has given a statement to the police saying he was approached by his childhood friend Bafna to give away more that 10 runs in an over in a match.

According to the version provided by Gulecha to the police he was offered a spot in an IPL team and Rs 2 lakh as advance if he agreed to meet bookie Sanyam Gulati and agree to spot-fixing in KPL games.

The celebrity drummer who was arrested on October 2 has also sought bail in the betting case. In the course of bail hearings Bafna's lawyers refuted allegations that the drummer used to send signals to cricketers who had allegedly agreed to indulge in corruption by playing the drums in a certain pattern.

According to police sources Bafna has claimed during questioning that the bookies approached him first during TNPL matches by claiming to be big fans of his drumming skills. "Based in Bengaluru, he (Bafna) used to work on behalf of bookies in Delhi and Mumbai," a senior crime branch police official said.

The investigations into betting and match fixing in the KPL were opened up by the CCB police on the basis of inputs provided by the anti-corruption unit of the BCCI on the heels of allegations of illegal betting and match fixing in the TNPL.

Delhi face Gujarat in Vijay Hazare quarters

Bengaluru: After an longish league phase of the Vijay Hazare Trophy, eight teams have qualified for the knockout phase beginning here on Sunday with Delhi playing its quarterfinal against Gujarat.

Defending champion Mumbai will take on Chhattisgarh while Tamil Nadu will square off against Punjab. Both matches will be played on October 21. Chhattisgarh defeated

the Shreyas Iyer-led team in the league stage. Elsewhere, Manish Pandey-led Karnataka won seven of their eight matches in Group A and face newcomers Pondicherry in the quarters. Nadeem's India cap comes after 15 years of First-Class cricket, 424 wickets

"JUNG JAARI hai (the fight is on). One day, they will come and pick you for the Indian team," Shahbaz Nadeem's father Javed Mahmood told his younger son. Nadeem's response was, "I won't give up. I'm playing for India A,

and will play for India one day." Javed recounted the conversation the day Nadeem eventually made his Test debut, that too on his home patch. The left-arm spinner was drafted in as cover for the injured Kuldeep Yadav, who had a sore shoulder. As India batting coach Vikram Rathour said, the team management wanted to go with three spinners on this JSCA Stadium pitch. So Nadeem replaced Ishant Sharma in the playing XI.

Nadeem personifies perseverance. He

made his first-class debut in 2004 and over the next 15 seasons, through 110 first-class matches, has picked 424 wickets. Last year, the Jharkhand spinner rewrote record books in List A cricket, when he picked eight wickets for 10 runs against Rajasthan in the Vijay Hazare Trophy. He had three five-fors in four innings during India A's tour of the West Indies earlier this year. But the 30-year-old was striving to reach the next level. Nadeem's family already had to deal with

a budding cricketer giving up the game in frustration. Nadeem's elder brother Asad Igbal decided to pursue a career in engineering, when he wasn't picked for the India colts. "Asad was the first cricketer in our family. He even became the East Zone U-19 captain. He was an all-rounder. But when uncertainty loomed, with regard to his cricket career, we decided that it would be too risky if both my sons took up cricket as a career. Do beta hain,

dono barbad ho jayenge to hum logon ko budhapa mein kaun dekhega (we have two sons

and if both their careers are destroyed, who would look after us when we got old)," Javed told The Sunday Express. A retired police officer, he was transferred from Muzaffarpur to Dhanbad when his sons were in school.

Asad sacrificed his cricketing ambition to ensure his younger brother could play the game without any pressure.

Nadeem was one of the fittest boys in his school, even when he was just 10 years old. His father attributed it to genetics. "I was a champion athlete at the university level. Shahbaz used to win all sprint events -100m, 200m, 400m - when he was in Class IV or V. This is something which he got from me," Javed said. Fitness has kept the Jharkhand spinner in the game for a long time.

Nadeem initially wanted to be a pace bowler but his childhood coach Imtiaz Hussain made him a spinner. "When he

came to our coaching camp for the trial, I told him to bowl spin instead. I told him that with his physique and height, he couldn't become a fast bowler. But I assured him that he could go far if he took up spin bowling," Hussain told this paper.

At Tata Digwadih Stadium in Dhanbad Nadeem had his first lessons in organised cricket, on a matting wicket. He progressed to play Ranji Trophy for Jharkhand but with his career still at a nascent stage, he decided to move to Kolkata and joined Town Club, with an eye to play for Bengal. Things didn't work out as planned and Nadeem decided to return home.

According to Hussain, former Jharkhand State Cricket Association (ISCA) president and current BCCI acting secretary Amitabh Choudhary helped Nadeem revive his career. "Amitabh Choudhary ensured that his talent didn't go waste. Nadeem was given a chance through the ranks." Hussain described his ward as "obedi-

to play for Jharkhand and he steadily rose

ent". Only once did Nadeem receive a serious dressing-down from his coach. He was entering into adulthood, when for a while he lost focus. Hussain was initially reluctant to recall the incident, but eventually narrated

it briefly. "It was a different type of incident, Young ladke mein ladkiyon ka chakkar hota hai na, aisa hi kuch hua tha (young guys get attracted to girls). It wasn't a big deal but I felt it would hamper his cricket. But that relationship didn't work out. Later, he got married to a lady

from Jharia." On Saturday, Nadeem received his Test cap from his skipper. "He was in Kolkata a couple of days back. Now he is playing a Test. Delighted for him," Virat Kohli said at the toss.

Indian football's roadmap: Minutes of the meeting

A POSSIBLE Asian Champions League group stage spot in 2021 for the Indian Super League (ISL) champions, doubts over the sustainability of the model and I-League clubs being told to find their broadcaster.

The Asian Football Confederation (AFC) and All India Football Federation (AIFF) painted a rosy future for Indian football following a meeting in Kuala Lumpur last Monday, which can potentially change how domestic leagues are structured in the country. However, *The Indian* Express spoke to officials from the AIFF, I-League and ISL clubs present at the meeting, who provided an account of how it transpired.

Since they were not authorized to speak to the media about the meeting, the officials requested anonymity.

According to a representative of an ISL club, AFC secretary general Windsor John and competitions director Shin Mangil said the decision to make ISL the country's top tier was based on 'sporting merit, according to information provided to them by the AIFF. "The decision was based on the logic that the investment made by ISL clubs has improved infrastructure in India, their contribution has improved national team ranking apart from the fact that all national team players play in the ISL and technical aspects like superior broadcast quality, social networking, etc.," the official said.

A few I-League clubs protested these

Mangil and John presented a roadmap for Indian football, according to which the ISL will be the country's premier division with a few I-League clubs assured a place 'on merit' in it in the coming years. On Sunday, the newlyanointed top tier will get underway but the ISL clubs should know that this status comes with its own poisoned chalice.

The average lifespan of a domestic league in India has been 10 to 11 years. The National Football League was launched in 1996 with grand plans. They fizzled out and the NFL had to make way in 2007 for the I-League. A decade later, wheels were set in motion for the ISL to take over as the country's top division, which finally happened last Monday. By the time a rebranded league with promotion and relegation is launched in 2024-25, the ISL will have completed a decade and the league's promoter Reliance Sport's 15-year agreement with the AIFF will expire.

An I-League official said this point was raised by a few clubs, including Minerva Punjab and Mohun Bagan. "There have been so many instances where a corporate entity has entered Indian football but packed up because they were not prepared to suffer losses year after year. The AIFF and AFC were asked what if the promoters and ISL club owners lose interest by 2024-25, when the league is to be rebranded. For now, they have told all of us to be patient,' the official said.

Sustainability, it is learnt, became the buzzword of the two-hour meeting. And not for nothing. More than a dozen I-League clubs have shut shop in the last decade. ISL franchises, too, have been in the red - reportedly suffered annual losses of around Rs 30 crore.

The losses played a huge role in two ISL franchises being forced to relocate - Delhi Dynamos have moved to Bhubaneswar and will be called Odisha FC while Pune City got new owners, who moved the club to Hyderabad. Reigning champions Bengaluru FC very nearly had to vacate their ground due to legal tussles. They, in fact, named Pune as their home venue before a court granted them some reprieve for this season.

According to an ISL club official, the clubs make Rs 13 crore on an average from the central revenue. But they pay Rs 15 crore as franchise fee each year. Globally, bulk of a club's revenue comes from the league selling its TV rights. However, since the broadcasters - Star Sports - themselves are the league co-owners,

the ISL teams do not make a paisa from TV

At least the ISL has a broadcaster, which makes it possible for teams to get some sponsors. A club official, it is learnt, asked AIFF general secretary Kushal Das why the I-League fixtures have not yet been released even though it is less than a month for the season to start. The I-League is scheduled to get underway on November. Das, the official said, replied the delay has been because of broadcasting issues.

Football Sport Development Limited (FSDL), a joint venture between ISL co-owners Reliance Sports and Star India that was established to run the ISL, takes a call on fixtures for the I-League as well. "The FSDL prepares ISL fixtures and sends it to the AIFF. With regards to the I-League, the AIFF prepares the fixtures' list and sends it to FSDL, who consult the production team of the broadcasters and give their consent," a source said.

Das is believed to have told the clubs that a broadcast deal has not been finalized yet. "He told us that generating advertisement revenue is a significant problem for broadcasters who telecast Indian football, which is why they haven't cracked a deal yet," a club official said.

With less than a month to go, the I-League clubs have been asked to chip in when it comes to searching for a broadcaster. Mohun Bagan director Debashish Dutta responded by demanding more professionalism from the AIFF and seeking an assurance from AFC secretary general Windsor John the promised roadmap will be implemented. "The AFC secretary has said a team will be formed that will monitor Indian football and ensure this is implemented," an AIFF official said.

An ISL club official also said that John hinted at a direct spot for India in the group stage of the Asian Champions League from 2021, when AFC's new commercial deal comes into effect. No Indian club has played in the elite club competition, failing repeated in the qualifying

Ireland beaten black and blue by All Blacks

New Zealand, in the semifinals, haven't lost a World Cup game since a quarterfinal upset to France in 2007. Ireland are yet to win a World Cup knockout game after eight attempts.

IRELAND WERE ranked No.1 till the start of the World Cup. They were a rare team to beat the All Blacks in the Cup intervening years. But it all amounted to nought as they were steamrolled 46-14 by the All Blacks who are looking insurmountable.

Here is the NZ Herald's breathless gush of the tries during their 46-14 win over Ireland that sent them into the semis.

13th minute: Aaron Smith nips through a gap from 10 metres for the crucial first try. It came after relentless pressure from the All Blacks, with Kieran Read and Sam Cane committing defenders in strong drives near the line.

21st minute: Aaron Smith dives over for the All Blacks second try, after a wonderful backline move. It was an old fashioned double round, but executed at blinding pace, as Sevu Reece wrapped around Jack Goodhue and set George Bridge off for the corner. Bridge was brought down metres from the line, but Smith profited from the next play.

32nd minute: Beauden Barrett scores the All Blacks' third try. It brought back some memories of the climax to the 2015 World Cup final, as Barrett chased down a kick at pace before regathering to score. It came from an Irish knock on near halfway, with Mo'unga reacting quickly to kick the loose ball.

48th minute: Some instinctive Kieran Read magic, as the captain pops a pass off the ground for Codie Taylor, who dives over under the posts. It's the try that kills any faint hopes for Ireland and their supporters, with the score at 29-0, and continues their bizarre record of having never won a World Cup knockout match.

61st minute: The All Blacks' fifth try, and a special moment for Matt Todd, after he missed out on the 2015 World Cup. The flanker ran off a precise TJ Perenara pass close to the ruck, after Sevu Reece had been grounded inches short of the line.

73rd minute: The All Blacks' sixth try, which exhibited everything that makes this current All Blacks side some lethal. Savea made strong inroads after a turnover, before passing as he was falling to Dane Coles. The replacement hooker bustled through, before slipping the ball one handed to George Bridge, who was perfectly positioned.

79th minute: It's close to a cricket score, as man of the match Beauden Barrett finds his brother with a long, spiralling left hand pass. Jordie's try is the All Blacks seventh of the night, surely raising compar-

England beat Australia 40-16 England start tom-tomming

Wallabies missing tail

England's 24-point margin of victory was their joint biggest in a Cup knockout game and Australia's heaviest defeat in the knockouts. Australia have lost just three of their nine Rugby World Cup quarters, each defeat coming against England (also 1995, 2007). According to The Australian, the Wallabies enjoyed 63 per cent possession in the 4 tries to-1 count win. They gained twice as many metres as England (568 to 273), twice as many carries (151 to 71), they beat more defenders (21 to 12) and made more clean breaks (8 to 7).

"But they lost it in the fine detail, as Eddie Jones always suspected they would, conceding 18 turnovers to England's eight and making 12 handling errors to England's five. Australia play the highest ball-in-hand game in world rugby while England kick the most. It's not how much ball you get, it's what you do with it," it wrote.

Messi, Suarez, Griezmann take Barca top

BARCELONA'S 'MSG' strike force is finally clicked into gear as Lionel Messi, Luis Suarez and Antoine Griezmann all scored in a ruthless 3-0 victory over Eibar on Saturday.

Griezmann's place in the newly-formed attacking trident has not been secure but the Frenchman opened the scoring at Ipurua before teeing up Messi and then playing the crucial pass for Suarez to make it three.

"There will be good and bad days but we are getting to know each other and bit by bit we will do even better," said Griezmann.

An authoritative Barca display thrust them to the top of La Liga, for a few hours at least before Real Madrid play Real Mallorca. They moved three points clear of Atletico, who drew 1-1 at home to Valencia.

The victory also dismissed suggestions their players might be affected by Friday's postponement of next Saturday's Clasico due to protests in Catalonia.

Violence in Barcelona and disruptions at El Prat airport meant Ernesto Valverde's side altered their pre-match routine and embarked on a 589-kilometre bus trip to the Basque County on Friday.

All the while, discussions continued over the Clasico against Real Madrid, which is now expected to go ahead in December.

"It is fashionable not to agree on political issues but at least let's agree on the date of the Clasico," Valverde said afterwards. "It doesn't seem to me that difficult."

Perhaps chaos off the pitch inspired Barca to unite on it. This was their fifth consecutive victory in all competitions, a sequence which is swiftly erasing memories of a stumbling start to the season. The resurgence has coincided with Messi's return from injury yet it was the fluidity and cohesion of the front three, rather than the Argentinian's familiar solo brilliance, that will have been most pleasing for Valverde. "Great players always understand each other," Valverde said. "With time and matches they will understand each other even more."

Griezmann has four goals since joining Barca from Atletico Madrid last summer but a series of underwhelming showings led to Ousmane Dembele starting against Sevilla before the international break.

There was good news too for Barcelona in defence, where Samuel Umtiti came through 90 minutes in what was his first appearance of the season. Umtiti, who has been out with a

foot injury, replaced the banned Gerard Pique

The only blot on the result was an injury to Sergi Roberto, who hurt his left knee and was replaced at half-time. He will be a doubt for the Champions League game away at Slavia Prague on Wednesday. Atletico lost ground as they were undone by a late Dani Parejo free-kick against Valencia at the Wanda Metropolitano, where both sides finished the game with 10 men. Diego Costa scored a firsthalf penalty. In a mad final 10 minutes, Joao Felix limped off with all three of his team's substitutes already used, Parejo struck in the 82nd.

Govt can't dictate terms to federations on selection: Rijiju

New Delhi: SPORTS MINISTER Kiren Rijiju on Saturday made it clear that the government would not interfere in selection matters but advised the Boxing Federation of India (BFI) to be transparent and resolve the Nikhat Zareen-Mary Kom in the best possible manner.

Former junior world champion Nikhat Zareen had written a letter to Rijiju on Thursday, demanding that she be given a trial bout against Mary Kom before the Indian squad for next year's Olympic qualifiers in China is decided. The BFI wants Mary Kom (51kg) to compete in Qualifying event in China after she won her eighth World Championships medal in Russia. "We have to understand one thing, govt

can't dictate the federations or get involved in the process of selection," Rijiju said on the sidelines of the felicitation program of the Indian women's boxing team. "If there are anomalies and certain things

which are not in the interest of sports we make advisory suggestions. Olympic charter is clear that govt shouldn't interfere in the functioning and administration of a federation." PTI

Alli grabs Spurs equaliser, Burnley denied one as VAR dominates proceedings

DELE ALLI scored a second-half equaliser for Tottenham Hotspur to secure a 1-1 home draw with Watford on an afternoon when VAR again emerged as the main talking point across several Premier League games.

Complete confusion followed Alli's strike at the Tottenham Hotspur stadium when the big screen indicated that the goal had been disallowed for handball after a VAR check but the referee pointed to the halfway line for the restart.

Burnley were also controversially denied an equaliser in a 2-1 defeat at Leicester City while technology ruled out two Wolverhampton Wanderers goals in their 1-1 draw with Southampton as well as an Aston Villa effort in their 2-1 win over Brighton & Hove Albion.

Less controversially, Chelsea beat Newcastle United 1-0 and Everton overturned West Ham United 2-0 while the game between Bournemouth and Norwich City ended goalless.

Spurs, who had conceded 10 goals in their previous two games, looked to be heading for a fifth defeat in six matches after Abdoulaye Doucoure put the visitors

But Alli took advantage of a flap by Watford keeper Ben Foster and, after appearing to control the ball with his shoulder, put the ball in the net. Although the VAR check ruled the strike legitimate, the big screen flashed up "no goal", sparking bemusement in the stadium.

"I was sure it didn't hit my hand but then you start thinking did it?," said Alli. "I tried to make sure it didn't touch it so I could get the strike away.

At the King Power Stadium, Leicester moved second — ahead of Manchester City's late kickoff — although technology proved decisive once again.

Dyche furious

Burnley's Chris Wood was denied a second goal when he was adjudged to have fouled Jonny Evans in the build-up, a decision that left Burnley manager Sean Dyche furious.

Asked about VAR, Wolves manager Nuno Espirito Santo said: "It is what it is. I hope it gets better."

Matt Targett's late winner helped Aston Villa come from behind to beat 10-man Brighton 2-1 as Dean Smith celebrated his one-year anniversary in charge. Technology was involved once again, with But Conor Hourihane having an early strike ruled out for Villa. Pressure eased on Everton manager

Marco Silva after overseeing a much-improved performance against West Ham. Excellent goals from Bernard and Gylfi Sigurdsson ended Everton's run of four consecutive defeats and moved them out of the relegation zone.

"Pressure is normal in football," Silva said.

West Ham disappointed throughout in going down as they suffered their first away league defeat of the season.

At Stamford Bridge Marcos Alonso's second-half strike gave Chelsea the narrowest of wins over Newcastle -- their fifth in succession in all competitions -- to move them third.

Crystal Palace host Manchester City in the late kick-off.
