

Sena's Uddhav insists on 50:50 formula

The ruling BJP-Shiv Sena alliance on Thursday managed to retain control of the Maharashtra Assembly, but with a reduced mandate. The alliance suffered losses in Vidarbha and western Maharashtra, with nine Ministers losing in the election.

With reduced numbers, the BJP will now be dependent on the Sena to form the government. Upping the ante, Sena chief Uddhav Thackeray, speaking at a press conference after the results, said it was time to implement the 50-50 formula for power-sharing, as decided earlier.

Mr. Thackeray said, "It is time to remind the BJP about the formula arrived at when BJP chief Amit Shah visited my home..." Prior to elections, the Sena had pitched Yuva Sena chief Aaditya Thackeray as the next deputy Chief Ministe, a demand which the BJP neither accepted nor denied publicly.

The BJP's parliamentary board, which met in Delhi in the evening, authorised party president Amit Shah to hold discussions with Sena chief Uddhav Thackeray on government formation.

The BJP also lost the Lok Sabha bypoll in Satara, where it had fielded the incumbent Nationalist Congress Party (NCP) MP Udayanraje Bhosale after he switched sides.

Exit polls belied

Proving all exit polls wrong, the Congress-NCP combine crossed the 100-seat mark, riding an anti-incumbency

wave in the rural belt. In absolute numbers, the

BJP-Sena tally fell by 29 seats, while the Congress-NCP alliance notched up an additional 21 seats, compared to the 2014 numbers. The BJP won 103 seats out of the 150 it contested, while the Sena secured a clear mandate on 56 seats out of 124. The saffron alliance's final tally stood at 159. The BJP's 14 allies also contested on the lotus symbol.

BJP will stake claim to form govt.: Amit Shah

Contrary to nearly all exit poll projections, the ruling BJP picked up just 40 seats in the Haryana Assembly elections and looked to seven Independents and 10 MLAs of the debutant Jannayak Janta Party (JJP) to hang on to power in the 90member House.

The Congress put up a surprisingly robust performance, winning 31 seats, while the JJP displaced the Indian National Lok Dal as Haryana's regional force and heir to the politics of Haryana strongman Devi

The Congress and the JJP busted the BJP's claims of winning 75-plus seats, resulting in a hung Assembly.

At one time, the BJP and the Congress were level at 35 leads, but the BJP pulled ahead by the evening, making it the single largest party within the striking distance of power.

In a tweet, party president Amit Shah made it clear that the BJP would stake claim to power when he thanked the people for giving the party another chance to serve them.

The IIP, which contested its maiden election, sprang

a surprise by winning 10 seats. The party could play a key role in the formation of the next government, and is scheduled to hold a meeting of its national executive and party MLAs in Delhi on Fri-

day. JJP leader Dushyant Chautala, who won from Uchana Kalan, said, "Party MLAs will take a collective decision. It is too early to say anything. The MLAs will select our party leader in the House... then we will take a step further."

Return of rebels?

The BJP, however, may not need the JJP as five of the seven Independents are said to be BJP rebels.

Eight Ministers of the outgoing Manohar Lal Khattar government were rejected by the voters as was BJP State chief Subhash Barala. However, the Chief Minister himself romped home by over 45,000 votes.

Soon after the results were declared, veteran Congress leader Bhupinder Singh Hooda appealed to all Opposition parties to join hands against the ruling BJP.

LJP retains Samastipur NDA allies stay ahead in Assembly bypolls

NEW DELHI BIP ally Lok Ianshakti Party (LJP) retained the Samastipur Lok Sabha seat, while the Nationalist Congress Party (NCP) retained the Satara Lok Sabha seat in the byelection results declared on Thursday.

The LJP's Prince Raj, son of party MP Ram Chandra Paswan, whose death in July necessitated the bypoll, defeated Ashok Kumar of the Congress by a margin of 1,02,090 votes.

In Satara, the NCP's Shriniwas Dadasaheb Patil had a lead of over 85,000 votes over the BJP's Udayanraje Bhonsale. Mr. Bhonsale's resignation and defection to the BJP in September had necessitated the bypoll.

Of the 51 Assembly byelections held across the country, the Opposition Congress and the ruling BJP won three seats each in the six bypolls in Gujarat. OBC

leader Alpesh Thakor, who defected to the BJP from the Congress during the Lok Sabha polls, was defeated in Radhanpur by Raghu Desai of the Congress.

In a setback for Bihar Chief Minister Nitish Kumar. the NDA won just one of the five Assembly seats, while the Opposition Rashtriya Janata Dal took two – Simri Bakhtiarpur and Belhar.

HC seeks response from ED on Chidambaram's bail plea

NEW DELHI The Delhi High Court on Thursday sought the response of the Enforcement Directorate (ED) on a bail plea of senior Congress leader and former Union Finance Minister P. Chidambaram in the INX Memoney-laundering case.

Justice Suresh Kait asked the agency to file its reply within a week. The 74-year-old was arrested by the CBI on August

21 from his residence in In the bail plea, Mr. Chidambaram has contended that the ED registered the Enforcement Case Information Report under Section 3 of the Prevention of Money

Laundering Act, solely

named as an accused nor as a suspect therein. There is no allegation against the petitioner in the body of the captioned ECIR," the plea said.

It further contended that all the evidence is documentary and in the custody of investigating agencies, hence it cannot be tampered with by Chidambaram.

India, Pakistan sign Kartarpur pact

It will facilitate Indian pilgrims to visit Gurdwara Kartarpur Sahib

India and Pakistan on Thursdav signed an agree ment to operationalise the Kartarpur corridor that will facilitate pilgrims from India to visit the Gurdwara Kartarpur Sahib in Pakistan.

The agreement is valid initially for five years. India will hand over the list of pilgrims to Pakistan 10 days in advance and those granted permission to go may be informed only four days before the proposed date of

SC tells telcos to pay govt. ₹92,000 crore

Sector benefited from AGR scheme but did not fulfil obligations to govt.: Bench

In a blow to telecom service providers, the Supreme Court on Thursday upheld the Department of Telecom's move to recover adjusted gross revenue (AGR) of about

₹92.000 crore from them. A Bench, led by Justice Arun Mishra, said the sector had long reaped the fruits of the Centre's liberalised mode of payment by the revenue sharing regime. "It has benefited immensely under the scheme as apparent from the gross revenue trend from 2004 to 2015," he said.

However, the service providers failed to fulfil their obligations to the government and raised frivolous objections.

A judge cannot be suspected of bias: Mishra

A judge need not recuse himself from a larger Bench scrutinising the correctness of his own past judgment, a Constitution Bench held in a verdict published on Thursday.

"No litigant can choose who should be on the Bench. He cannot say that a judge who might have decided a case on a particular issue, which may go against his interest, should not hear his case as part of a larger Bench," Justice Arun Mishra wrote in the leading judgment for the
