THE RULING BJP-Shiv Sena alliance returned to power in Maharashtra Thursday, winning 161 of the 288 seats in the state Assembly, But the poll results did not go according to script with the BJP suffering reverses in Vidarbha and Marathwada and, in the process, managing 105 seats way below the halfway mark of 144 which it hoped to attain on its own, and less than its strength

of 122 in the previous House. With the results in, Chief Minister Devendra Fadnavis, only the second Chief Minister in Maharashtra in 47 years after Vasantrao Naik to complete the full five-year term, conceded his





# How 303 plus 370 didn't quite add up this time

However, in the party headquarters, there was no mistaking the low-key nature of the celebrations. For, the BJP, riding on the

high of its 303 Lok Sabha seats, the high-octane pitch on Article 370 and a call to expel all illegal migrants and implement the National Register of Citizens across the nation, had lost seats in both states.

Speaking to *The Indian* Express, BIP general secretary Kailash Vijayvargiya, who was in charge of Haryana when the BJP won the 2014 polls, said: "The PM's popularity and Shah's leadership brought the BJP back to power in both the states. The party could have done better micromanagement on the ground. Our workers could have been deployed more effectively to mobilise support and consolidate votes."

The BJP, which had led in 79 of Haryana's 90 Assembly segments in the Lok Sabha elections barely five months ago fell to 40. In a state that, ironically, provides a healthy recruiting ground to the armed forces and when apart from state leadership, both Modi and Shah repeatedly highlighted Kashmir and Article 370 in their rallies.

Modi addressed 16 rallies ahead of the October 21 polling in these two states, Shah held

In Maharashtra, the party

fell well short of NDA's target of 220+ despite a wave of defections — most engineered by the BJP — from the Opposition Congress and NCP which had faced their worst electoral results in the Lok Sabha elections. The BJP won 105 seats of 164 as against the 122 it won from 260 seats it contested last time. In the Lok Sabha elections, BJP was leading in 125 Assembly seats and Shiv Sena led in 105 seats totalling 230 of 288. Apart from the slip in Shiv Sena, the BJP slipped in Vidarbha, the home turf of chief minister Devendra Fadnavis, and Western Maharashtra where it had lured many from the Opposition

"We were expecting to win a majority on our own in Maharashtra. Now that we need to rely on Sena to form the

government, it could be more demanding," said a senior party leader underlining that the BJP will face changed equations in a state with a more confident Opposition led by Sharad Pawar's NCP and, of course, a more aggressive Sena.

The verdict in these two states is being seen as a message to the BJP-led government as well as its leadership that voters differentiate between a national election and state polls. And that national issues may not always outweigh local issues. The results may nudge its attention towards the economic slowdown which, incidentally, has been publicly contested and downplayed. Indeed, at least three leaders in the party indicated that the setback in the two states could have been influenced by aspects of economic distress. The results also highlight

the limitations of vilifying the politically dominant communities in these states. The BIP tried to rally numerically smaller and the politically less dominant communities against Marathas (Maharashtra) and Jats (Harvana). The fact that it lost significant ground right in the backyard of its CMs, Vidarbha (Fadnavis) and North Haryana (Khattar), puts a question mark on the effectiveness of its regional satraps to hold the party's fort against dominant caste politics. Party sources said the BJP leadership "relied" on these satraps without "paying heed" to other leaders including ministers which led to a number of rebel candidates fighting against official candi-

Some BJP leaders admitted that the results will also be factored in as the party plans for upcoming elections in Jharkhand and Delhi. The results are also a signal to BJP's unconventional choices as CMs – Raghubar Das (Jharkhand), Yogi Adityanath (UP), Trivendra Rawat (Uttarakhand), Jairam Thakur (Himachal Pradesh), Rupani (Gujarat), Sarbananda Sonowal (Assam), Biplab Thakur (Tripura) among others – that "some of them may have mistaken Modi's popularity as endorsement of their leadership," said an in-

The struggling Opposition can seek some comfort in the fact that the results fit a pattern

that indicates the BIP finds it hard to improve its performance in states where it's already in power and is seeking re-elec-

Modi's dramatic and sweeping victory in 2014 upset many a calculation and the BJP won Maharashtra (2014), Haryana (2014), Jharkhand (2014), Assam (2016), Uttar Pradesh (2017), Uttarakhand (2017) and Karnataka (2018) but in all these states, it was in opposition. However, it has struggled to improve its position in states where it was seeking re-election: Gujarat (2017), Madhya Pradesh (2018), Rajasthan (2018) and Chhattisgarh (2018). Indeed, it took Modi's concerted personal push to stave off a setback in his native Gujarat in 2017.

This trend is also reinforced by the results of Assembly bypolls where the party is in power — Uttar Pradesh, Gujarat and Bihar. The BJP has won seven of 11 seats that went to polls in UP Assembly. The party won three of six seats in Gujarat and in Bihar, the ruling alliance won only one of the five seats. This when Assembly bypolls are generally considered an easy win for the ruling establishment.

The late-night developments were prompted by the setback received by the BJP when the Assembly poll results came in earlier in the day: A resurgent Congress led by Bhupinder Singh Hooda claimed 31 seats and the newly formed Jannayak Janata Party (JJP) of Dushyant Chautala won

Both the Jat leaders severely dented the BJP's poll call of "Abki baar 75 paar (Over 75 seats this time)" — the ruling party had gone to polls with 48 MLAs after winning the Jind bypoll in January.

More embarrassing for the party was that barring Khattar and Health Minister Anil Vij, all their five Cabinet colleagues, their party's state unit chief and a minister of state, lost badly to either Congress or JIP candi-

The Congress claimed more than double its tally of 15 in 2014, and the JJP opened its account by reaching double digits. The results came just five months after Haryana voted for the BJP in all the 10 Lok Sabha seats with huge margins.

As the results became clear, it was initially expected that Dushyant Chautala, the son of Ajay Chautala and grandson of Om Prakash Chautala, would play the kingmaker in deciding the next government. But the BJP decided to go with the

"rebels" — at least 30 rebels of the BJP and Sena upset their calculations. He said the people have given the alliance a decisive mandate to form the government for a second consecutive term.

But Shiv Sena chief Uddhav Thackeray lost no time to "remind" the BIP about the "equal" or "50-50 power-sharing" formula for all berths in the new government. This was also interpreted as Senaspeak for rotating the post of the Chief Minister.

"We all know that when the alliance was forged before the Lok Sabha polls, the 50:50 formula was decided. There is no need to hide it now. It was also decided that seat sharing would be 144-144. BJP state president Chandrakant Patil had then said I should understand the BJP's problems in seat sharing. I understood their problems and accepted a smaller share of the seats. But if their problems are going to increase, then I can't understand all their problems," Thackeray told reporters at the Sena headquarters in Dadar.

were coming in, Fadnavis spoke to Thackeray. He defended the BJP's performance: "In 2014, the party contested 260 seats and won 122. Whereas now, it contested 164 and won 102 (that figure changed to 105 later)." In the past, the "strike rate" was 47% and vote share 28%. This time, the "strike rate" jumped to 70% while the vote share was 25.75%.

For the Sena though, the score of 56 was a disappointment. Its "strike rate" was just 45% as against BJP's 70%. Describing the elections as an "eye opener", Thackeray said, "I feel proud that people of the state have kept democracy alive. When some people started walking with some assumptions, it appears people brought them to ground reality. It is a lesson for all political parties.'

What came in the way of BJP plans was the pushback by Maratha strongman Sharad Pawar in the face of action by him and his colleague Praful Patel in the last days of the election campaign. His NCP won 54 seats, a gain of 13, compared to the 2014 assembly polls. Its ally Congress, which almost seemed to have given up, also bagged 44 seats, two more than in 2014. Together, they neared the three-digit figure, lending the Opposition more voice in the House.

During the campaign, Pawar took on the central and state leadership of the BJP. This helped NCP retain sway over western Maharashtra. In fact, he salvaged the situation for the Congress which appeared leaderless throughout the campaign. "The mandate is for us to sit in Opposition," Pawar admitted. But he took a swipe at the BJP-Sena for inducting rebels of the rival camp. "The elections have shown people are not ready to accept turncoats who desert the party."

Fadnavis too acknowledged that rising aspirations of party workers had many rebels entering the fray. "We could not contain this... But almost 15 rebels who have been elected had expressed their support to the alliance post polls. We are considering their support as they are our party workers," he said.

Although the BJP has kept its analysis on hold for now, the results show that the party didn't fare too well in Vidarbha, which is Fadnavis's backyard, and Marathwada, besides western Maharashtra.



THE CONGRESS government in Madhya Pradesh is considering a proposal to include eggs in the anganwadi menu in 89 tribal blocks as supplementary nutrition under the Integrated Child Development Services (ICDS) scheme.

A presentation made before Chief Minister Kamal Nath informed him that the inclusion of protein-rich eggs in the anganwadi menu could go a long way to tackle the challenge of malnutrition and under-nutrition, especially in tribal dominated areas of the state.

Right to Food campaigner Sachin Jain wrote a letter to the CM last month requesting that eggs be included in the menu at the earliest and how it was important step towards management of under-nutrition. "The problem of high levels of

child malnutrition in the state is well acknowledged. Despite some improvements over last decade, the level of under-nutrition is still very high, with 42 per cent of children under 5 being stunted. The immediate determinants of under nutrition are poor diet and ill health (infections).

proposal is at an early stage. "The idea is to provide protein-

rich food by serving one egg three times a week. It will not be compulsory, and those who don't eat eggs will be provided milk and banana," he said.

The annual cost of serving three eggs per child in 89 tribal blocks will be between Rs 40 and Rs 50 crore. Rajan said many states have already included eggs in their menu and the proposal, as and when it gets the final nod, will be implemented from the next financial year. "Eggs are readily available and tribal children like

to eat them," Rajan said.

The Bakshi Group has indeed diversified into various verticals, but what I have learnt over the years is that it is the quality of growth that outweighs everything else and provides satisfaction and stability. The size of a business does not matter if there is no quality attached to it. Quality provides a name to the business. If your customers are not happy and they lack satisfaction, they might rebuke you—and we have always followed Customer Centricity at every step. Therefore, one should not focus on size but on quality—to be the best at what you do and not necessarily the biggest.

#### You have been a leading light of the industry. What would your message be to all the new generation entrepreneurs and leaders?

Like I said earlier, the size of the business does not matter, what you do and what you leave for the next generation matters. When one comes out to work, one should not forget that the customer is the only stakeholder that will put in money for the product one is selling and the others will only ask for money and be an expense. The message I would therefore reiterate is that there should always be a deep-rooted faith and respect for the consumer, and it is this that will help new generation entrepreneurs and leaders to be successful in their endeavours.

If given a chance, leaders should not waste time waiting to find a team of sincere workers and start working—the starting point comes from within. The Government has reduced the corporate tax rate. It is a welcome move by the government. How has that benefitted you as a diversified group? What are your views on its impact on businesses in general?

The recent reduction in the corporate tax is more of a move to attract foreign investors than aid the industry at large. There are various aspects to this—any policy that is brought in shows its impact after a few years. In this case, the move may positively impact the income tax.

The real estate and hospitality sectors are not doing very well. Problems like stressed assets, slump and liquidity are some of the challenges. The forecast for the two sectors is also not very good. What is your sense of the future for the two? In the hospitality sector, I do not

think that there is a slump. But in real estate, ves, there is. The real estate sector has now seen a correction of sorts in the way the business has been done until now, but I still feel that if you care for your customers they will never leave your side, and that is what has helped Central Park.

And how long do you think will the phase last?

For this segment we are coming up with a project where we have focused on activities that a millennial would want to participate in. Trends have revealed that in comparison to the space meant for activities, these customers do not mind compromising on the area for resting and sleeping. This goes more into the segment of co-habitation, where there will be common living areas accessible to 20 plus private rooms with amenities. These will be operated on the model of pay-as-you-use. Kitchens will be private but will be amply supplied by a convenience store right outside the hall. If the couple living together has a child, there is a place for children, too. If they do not want to own a car, an area will be created for taxi services such as Uber & Ola – hence, we have not kept any parking. The entire premises will have party halls, hang-out areas, etc.

This concept is futuristic and has the potential to serve the millennials. In the next 30 years, people will probably not work for as many hours a week as they do now. People may not even buy homes. Energy will come cheap. People will be more worried about their health, mind and body. These are all ideas that we should keep in mind beforehand, seeing the overall trends pertaining to millennials and their needs.

#### Talking about housing in the country, where do you see the real demand?

Housing is one of the basic needs of the people. But cities around the world have been witnessing migration, which is a worldwide trend. Indian mega cities and state capitals are no different to their counterparts around the globe. The migration rate in the country however, is high compared to other countries. Therefore, housing-needs and its supply are directly proportional to the rate of migration.

But there is a challenge to the growth of housing in the country. Our cities lack the infrastructure to build houses at the required speed. The problem is escalating because migration to cities is not stopping and continues to grow. Problems like limited parking space, availability of resources and urban poverty continue to create further issues for urban dwellers. People migrating to cities continue to earn a living in the city and send money to their homes, which spirals a vicious cycle of poverty around them. In addition to these challenges, peo-

ple have other expenses such as rent, needs of a growing family, etc. With family growth, there is need for a house; as the family grows further, they need a bigger house/flat—this reflects the market demand. Thanks to the private sector, demand continues to be high. The sector per se has been witnessing challenges. Witnessing the demand potential, several unscrupulous builders have adopted wrong means for growth. In the process of building something they have ruined themselves and have also given a bad name to the sector.

On a more practical level, as you said, housing supply remains a challenge and the preparedness of the city also is a problem. How do you see the situation improving?

Correction in the sector has already commenced. The government is more responsible than the builders. Lending banks have been bailed out. But the prime question is – where has the money gone? The Government has not been able to plug the loopholes. There have been a few learnings though: first, there is need for a more proactive stand on all the problems highlighted. Second, people must learn from past mistakes – credit is not free; it is a cost. Third, when one borrows, one must return. These areas must be corrected in the system.

In terms of projects undertaken, the people and the system put in money to build something. If one is striving hard to complete the project, the trust of the people remains in the system. That is what is required in the current scenario.

#### Talking about the India growth story and real estate, what is required to boost growth?

The first step has already been taken in the form of RERA (Real Estate Regulatory Authority). The government and the sector participants have realised that it is their responsibility to protect the interests of customers and corporates are working towards delivery now. Everything has to be done methodically and systematically and the onus to deliver on the consumers' money lies in the hands of these corporates. They should deliver what they have promised. RERA will help in mitigating the challenges to some extent.


Pick up RERA rules from any state and you will find there is equal provisioning of penalty for delivery and payment default on part of a developer and a consumer, respectively. That said, there are some among consumers, too, who want to exploit the situation. But overall consumers should be protected.

#### What are some of the initiatives that you think will be healthy for the sector?

We are following some of the best initiatives at Central Park that directly relate to corporate governance. For instance, we book apartments with a grace period of 30 days. This means we give our buyers a chance to book the apartment and cancel this booking within 30 days in case they change their minds. We consider the flat booked when we receive the cheque but do not encash this cheque for the first 30 days. This is also because sometimes buyers makes an impulsive decision. Should a booking be cancelled, the cheque is refunded with no deductions. This is a first-of-itskind initiative in India. This really helps Central Park gain consumer trust.

#### What is your one message to those who are planning to begin their entrepreneurial journey?

Every day, one's conduct should be a reflection of one's character – keeping this in mind, one should bear in mind one's responsibility towards consumers and work towards fulfilling it. Success will follow these values.

# At markets in capital, traders rue dip in festive sales

NEW DELHI. OCTOBER 24

ON THURSDAY, the Sarojini Nagar market wore a festive look as people went about making last-minute Diwali purchases. However, the festive spirit was considerably subdued inside shops. Pointing to his empty store, a shop manager said, "We don't understand what is going on. We usually see so many customers during Diwali."

The remark found an echo at many markets, including Khan Market, Karol Bagh, Sadar Bazar and Chandni Chowk, with some

traders attributing the dip in sales to the "economic slowdown", and "failing to recover post the implementation of GST and demonetisation".

Typically decorated with lights during Diwali, Khan Market wore a deserted look.

Calling it a multi-faceted problem that has been building up for years, Brij Gopal Khosla, vice-president of the Khan Market Traders' Association, said: "Business is down 40-50% since last year. There are various reasons — sentiments are low, the economy is down. The online business is different, we do not consider it competition... Since

GST, sales are going down and prices going up."

The Confederation of All India Traders (CAIT), which has writ-

ten to the government against ecommerce websites, also said sales were sluggish this year.

Praveen Khandelwal, CAIT national general secretary, said, "Past experience shows that between Navratri and Diwali, business goes up by 30%. This year, it has declined by 30% for all businesses including mobiles, FMCG, shoes and fashion wear."

"Diwali has no meaning for traders anymore. The major culprits are e-commerce websites, which offer discounts of up to 90%," he added.

CAIT, in a statement, claimed retail trade in India generates a yearly business of Rs 45 lakh

crore, of which business of Rs 6 lakh crore alone is during the Diwali period.

S K Mittal, who runs a silver works at Chandni Chowk and is a member of the Delhi Hindustani Mercantile Association, said, "Every year, our business has been going down by 20% since demonetisation."

In Chandni Chowk, other factors such as redevelopment work have also affected business.

Rachit Gupta, who sells artificial jewellery in the area, said, "In the past 12 years, this has been the worst. Business has dropped by 40% from last year due to the slowdown."

# Ex-DU teacher **SAR Geelani** suffers cardiac arrest, dies

FORMER DELHI University teacher SAR Geelani, who was arrested in the 2001 Parliament attack case before being acquitted by the Supreme Court, died Thursday following a cardiac arrest.

His son Atif confirmed to The Indian Express that Geelani (50), who stayed in Zakir Nagar, passed away in the evening. "He had gone to the gym when it happened," he said. Geelani is survived by his wife, his son Atif and daughter Nusrat.

Former DUTA president Nandita Narain said, "We've seen him through many difficulties... His health was affected by the whole ordeal. I think he was a patient of asthma as well, and was unwell for the past few days."

Geelani, a Kashmiri who earlier taught Arabic at Zakir Hussain College, was arrested and sentenced to death by a Delhi court in 2002 in connection with the 2001 Parliament attack. However, the Delhi HC acquitted him of all charges for "need of evidence" in October 2003. The SC upheld the HC's decision in August 2005. Through it all, Geelani maintained his innocence.

Months before his SC acquittal in February 2005. Geelani was seriously injured when he was shot at five times outside his lawyer Nandita Haksar's home in Vasant Kunj.

Geelani was vocal about his views on Kashmir's self-deter-

mination and was critical of the hanging of Afzal Guru, who was convicted and hanged in connection with the Parliament attack case in 2001. Geelani's support of Guru

landed him in trouble again when in 2016, shortly after then JNU students' union president Kanhaiya Kumar was arrested for sedition for allegedly shouting anti-India slogans on campus, when he too was arrested for the same in February and kept in 14-day judicial custody. He had organised an event at the Press Club of India to mark the anniversary of the

hanging of Guru. He had been out on bail since March 2016, and was provided police security. Delhi Police is yet to file a chargesheet in the matter.

Family members wanted to take his body to Kashmir for the funeral and informed police that they did not want a post mortem to be conducted as they didn't suspect any foul play.

Police, however, have decided to conduct a post-mortem Friday. The body was shifted to AIIMS Thursday night.

- Silver coated sweets may be checked for the presence of harmful aluminium by rubbing the silver foil by hands. Original silver foil will vanish by rubbing, whereas aluminium foil will remain there.
- Visible insects, fungus contamination and any offodour should be checked prior to purchase. Taste or smell the sweets before buying.
- Before purchasing sweets, it must be ensured that the food handlers are wearing gloves while packing sweets and the food is being prepared under hygienic conditions.
- Before purchase of any packed food item, read food Labels declaration carefully, to know the date of manufacturing, best before, expiry date, use by date
- Khoya, Paneer and Milk preparations are generally adulterated with starch, which may be checked by lodine Test, by taking a small sample mixed with water and bring to boil. Allow this to cool and add few drops of iodine in the solution if turns blue, then it is adulterated with Starch.
- Dry fruits & Nuts should be checked for contamination and colour before purchase. Pista pieces can be checked for presence of added synthetic colour by putting and pressing on moist filter paper. The synthetic colour used on pista will reach out on moist filter paper.



# Delhi govt to offer 1,000 free surgeries at private hospitals

NEW DELHI, OCTOBER 24

THE DELHI government is set to widen the ambit of its health scheme, whereby people who are given a waiting time of over 30 days for a surgery or procedure at a Delhi government hospital are eligible for free treatment at empanelled private hospitals.

Under the expansion, 1,016 surgical, 123 oncology and 10 neonatal procedures, as well as six medical packages, have been made part of the 86 surgeries already covered under the Delhi Arogya Kosh (DAK) — a corpus that funds various health schemes for residents of Delhi. This includes implants as well as treatment for vector-borne diseases, sources said.



4,654 patients got cashless treatment till Iune 2019

With the additions, all treatment covered under the Centrerun Ayushman Bharat scheme will fall under the DAK. The Delhi government has not implemented the Centre's scheme in the city yet, calling their scheme better. Only Delhi voters will be eligible for the scheme. Children below 19 years of age will be eligible on the basis of the voter

identity card of their parents, along with Aadhaar card or birth certificate from Delhi.

The free surgery scheme was launched in March 2017 and 56 private healthcare providers have been empanelled by the government. Till June 2019, a total of 4,654 patients received cashless treatment under the scheme. Under Ayushman Bharat, free

worth Rs 7,901 crore has been

availed in 32 states and UTs.

Procedures like cardiology, or-

thopaedics, radiation, oncology, cardio-thoracic and vascular surgery, and urology have emerged as the top tertiary specialties. In Delhi, the packages will include cost incurred during pre-anaesthetic check-up; inves-

tigations; medicines and con-

sumables; bed charges; diet

charges; consultation; and nursing care, among others, and will specify the duration of admission.

"We held a meeting on October 21 to discuss package rates... We are expecting that around 100 NABH-accredited hospitals will be able to offer the facilities," said the official, adding that private hospitals can't deny treatment to any patient if they have the service. "This scheme is a win-win sit-

uation for private and government hospitals. We are paying more than the rate decided under the Ayushman Bharat scheme. A private hospital will be paid 10% to 40% over what the Ayushman Bharat scheme offers," said president of Delhi Medical Council Dr Arun Gupta, who has been elected to the newly formed governing body of DAK.



## 1,728 UNAUTHORISED COLONIES GET LEGAL TAG

# Regularisation push: DDA to use images from ISRO

**ABHINAV RAJPUT** 

NEW DELHI, OCTOBER 24

TO MAP the boundaries of 1.728 unauthorised colonies in the capital, which received the Centre's approval to be regularised, the Delhi Development Authority (DDA) has sourced satellite images from the Indian Space Research Organisation (ISRO). It will also seek help from Survey of India, Department of Science and Technology, said DDA vicechairperson Tarun Kapoor.

The key responsibility of implementing the Centre's decision lies with the DDA, the city's land-owning agency, which has set itself an ambitious deadline of three months to execute the project.

Kapoor said the DDA held a meeting with senior officials of the revenue department, and it has been decided that a portal will be developed to facilitate the process of registration of properties.

Since 2015, the Delhi government has tried to demarcate boundaries using four different methods, including drones.

According to a senior government official, the main problem with demarcating areas was that maps provided by different agencies had different outlines: "Maps provided by RWAs were from 2007-09. Since then, the

area has expanded. *Shajra* maps from the 19th and 20th centuries did not have measurements in metric terms... when converted, they turned out to be confusing. The fixed points used in these maps, such as ponds, walls or pillars, have now disappeared. We got a survey done but it had several inaccuracies."

Sources said the earlier plan to demarcate boundaries using Google Earth images had not given desired results, and the DDA was forced to reach out to ISRO and Survey of India.

The agency will also build a local area plan — a layout for the 1,728 colonies, which will have details of the number of parks, schools and other amenities that have to be provided.

# At RK Puram unauthorised colony tagged affluent, residents say houses just 100 sq yards

NEW DELHI, OCTOBER 24

A MOTOR-MECHANIC spreading out car parts in front of his apartment, an elderly man resting on a charpoy — the narrow lanes of Anant Ram Dairy resemble those in other neighbourhoods of Delhi. Located in the heart of R K Puram, this neighbourhood though is one of the 69 unauthorised colonies categorised as "affluent" colonies.

On Wednesday, the central government cleared a proposal to regularise 1,728 unauthorised colonies in the city. These do not include the 69 "affluent" colonies — with Sainik Farms in South Delhi, Mahendru Enclave in North West Delhi and Anant Ram Dairy being the three that Union Minister Hardeep Puri spoke about.

Residents of Anant Ram Dairy, meanwhile, insist that their neighbourhood is nothing like the other two.

"There is no property in the

neighbourhood which is larger than 200 square yards. Most are around 30 square yards... others are 50 and 100 square yards. How is this a wealthy or affluent

colony? We are trying to get a date to meet the Housing Minister to present our case, and to ask that a team be sent to conduct an enquiry into why this colony has been included in the list," said Ashok Phalwan, president of the residents' association.

The neighbourhood, in existence since 1952, occupies 16 acres nestled in the midst of government housing complexes in RK Puram. Unlike many unauthorised colonies, all basic amenities are in place here permanent water and electricity connections, pucca roads, functioning sewage and drainage system and streetlights. But residents claim that the "unauthorised" tag continues to pose a problem for them.

"We're paying house tax to the New Delhi Municipal Council (NDMC) and development charge for the facilities.

But because we're not recognised as legitimate, we cannot develop the area or even carry out repairs properly," said Anil Lal, a resident who works in household interiors.

While residents claimed they do not know why the neighbourhood has been counted amongst the affluent colonies, they weighed in on the possible reasons. The neighbourhood has housed former ministers PR Kumaramangalam and Dinesh Singh.

"Why should the 250 other families living here suffer because two prominent people lived here? Another reason might be that it is the only unauthorised colony in the posh NDMC area. But it has grown over time from the hutments which housed dairy farmers,' said advocate and resident Ashok Singh.

# Ahead of polls, BJP to hold outreach drive on regularisation

FOLLOWING THE Centre's decision to grant ownership rights to over 1,700 unauthorised colonies in the capital, the BJP central leadership has asked the state unit to talk about the move at the grassroot level, by holding outreach programmes in each district ahead of the Assembly polls. To this end, Delhi BJP presi-

dent Manoj Tiwari Thursday stayed the night at Shashi Garden in Patparganj. Talking to people about the decision, he appealed to them to vote for the party. BJP leader Neelkant Bakshi

said the party has also prepared posters, with photos of Prime Minister Narendra Modi and Tiwari, calling the move a "Diwali gift". Around 2 lakh posters will be put up across the capital, he said. Earlier in the day, Minister of State for Home

Affairs Nityanand Rai visited Raja Vihar, an unauthorised colony, along with Leader of Opposition Vijender Gupta and North West Delhi MP Hans Rai Hans.

Rai, who is one of the in charges for the Delhi Assembly polls, said that the Centre will leave no stone unturned to ensure the process of regularisation and giving ownership rights starts at the earliest. Hans said he will invest his MP fund to providing civic facilities in unauthorised

colonies.

Party leaders have also been asked to send reports of the feedback they get from the colonies to senior leaders, said BJP women's wing president Poonam Parashar Iha.

Post Diwali, the BIP will launch Phase II of the outreach programme in the colonies in which senior leaders and morcha presidents will be given responsibility of a district each, said a senior leader.

# AAP rallies thank Kejriwal for move **EXPRESS NEWS SERVICE**

NEW DELHI, OCTOBER 24

A DAY after the Union Cabinet cleared the proposal to transfer property rights to residents of unauthorised colonies, the AAP Thursday took out "dhanyawad *yatras*" across the city, crediting Chief Minister Arvind Kejriwal for "forcing the Centre to bend". Through the local-level gath-

erings, the AAP essentially sought to push the message that the Centre could not have made its move had the Delhi government not sent its proposal in 2015, a narrative set by Kejriwal himself Wednesday. The vatras were mostly led by AAP MLAs.

"After five years of struggle by Kejriwal, finally, the Centre had to bend. Now, people living in unauthorised colonies of Delhi will also get a respectful life," AAP said in a statement.

On November 2, 2015, the Delhi Cabinet had cleared a proposal to regularise 1,797 colonies and 10 days later, on November 12, the proposal was sent to the Centre. "The Centre sat on our proposal, citing pending work of mapping the colonies. How have they done it now? After all, the DDA itself is admitting that the mapping exercise will take at least three months," a senior AAP leader said.

"The Delhi government wrote several letters to the BIP government at the Centre and requested them to take a decision on this proposal as soon as possible, but the Central government did not take any step. Not waiting for the Centre's decision, the Kejriwal government sanctioned development works worth Rs 6,000 crore for these colonies. And now the Centre has approved the decision of the Delhi government," the AAP statement added.

# DU students claim beaten up at bar, police file FIR

*New Delhi:* Four DU law students sustained injuries after they were allegedly beaten up by bouncers at a bar in North West Delhi's Mukherjee Nagar Wednesday.

DCP (North West) Vijayanta Arya said, "We have lodged an FIR against the bouncers; efforts are on to nab them," adding that a few weeks ago, an FIR had been lodged against the same bar for serving hookah.

Police said the complaint was filed by a second-year student at DU's Faculty of Law. "The student invited his friends to the bar to celebrate his birthday. As they were dancing, one of his friends requested the DJ to change the song. When the DJ refused, a heated argument ensued. A bouncer intervened and

started beating the students, said a senior police officer. The student alleged he and his friends were taken down and attacked by other bouncers. "The bouncers claimed they were misbehaving in the bar. The group received

grievous injuries," said the officer After the incident, around 200 students turned up at Kingsway Camp to protest, causing traffic

snarls. They dispersed after police assured action would be taken. Former DUSU president Shakti Singh alleged, "Police did not cooperate in the matter and were shielding the accused instead." Police, however, said a case

has also been filed against the bar's owner for not carrying out verification of his employees, including the bouncers. **ENS**

# GOVT & POLITICS





## **New Insights**

IF, AFTER his 2014 win, there were a series of books on the political life and achievements of Prime Minister Narendra Modi, authors are now coming out with not-so-well-known facts about his tryst with foreign policy before he was elected to the top post. In his new book Modiplomacy -Through a Shakespearean Prism, former diplomat TPSreenivasan (who was then deputy chief of mission at the Indian embassy, Washington DC) narrates an incident which show that Modi had played a key role in strengthening the draft US Congress resolution to push the Bill Clinton administration in demanding that Pakistan withdraw from Kargil. "As requested by Clinton Pakistan Prime Minister went to Washington on 4 July, America's Independence Day, and agreed to withdraw and end the Kargil war," the book says. According to the author, Modi, the organisation general secretary then, who was visiting the US, had sought reopening of the text of the draft private resolution to make it stronger.

# Pressing Matters

HOME MINISTER Amit Shah on Thursday cancelled his visits to events of central agencies as the Haryana and Maharashtra election results began filtering in. Shah, who is also the BJP president, was the chief guest at the ITBP Raising Day parade. He was also supposed to address a conference of Anti-Terrorism Squads from across the country organised by the NIA. But the minister did not attend either of them. In his absence, MoS Home G Kishan Reddy presided over the ITBP event. There was no official word on why he cancelled his visits.

## BOOST BEFORE POLL

THE RELEASE of Karnataka Congress leader D K Shivakumar from jail has given a boost to the party in a state gearing up for a big electoral battle in December. Bypolls to 15 of the 17 vacant Assembly seats will be held on December 5, and the outcome is critical for the stability of the BS Yediyurappa government. There is speculation that Shivakumar, who has been virtually the goto man for Central leaders in the state, could be given a big responsibility. Congress leaders did not rule out the possibility of him being appointed state Congress chief, but added that much will depend on his plans, too.

## FIRST IMPRESSION

STANDING COMMITTEES have usually acted as critics of departments they are supposed to scrutinise. Railways is no different. However, officers attending the meeting of the new Standing Committee on Railways earlier this week got a different vibe. Headed by BJP MP Radha Mohan Singh, the meeting mostly talked about how well the transporter was functioning. While nothing can be made of the first meeting, officials are of the view that this committee may not be as "tough" as previous ones.

# In refusing Justice Mishra's recusal, SC relied on two verdicts by CJI-led benches

THE FIVE-JUDGE Constitution bench hearing a case on the interpretation of a provision of the Land Acquisition Act refused recusal of Justice Arun Mishra from the bench by relying on two judgments delivered by benches headed by former Chief Justice of India (CJI) Dipak Mishra.

The verdicts, delivered in 2018, had held that the CJI has the last word in assigning cases to other benches.

The petitioners — land associations — had sought Justice Mishra's recusal on the ground that he had delivered the 2018 verdict, which has to be reconsidered, in which the court deviated from the settled law and subsequently sought a larger bench hearing on the issue.

Among the judgments cited, Justice Mishra relied upon a three-judge bench's ruling in Asok Pande v. Supreme Court of India, and another ruling by a five-judge bench in Campaign for Judicial Accountability and Reforms v. Union of India.

Both benches, headed by then CJI Dipak Misra, reiterated that there cannot be any "mistrust in functioning of the office of the CII" (then Misra).

While Asok Pande's plea had challenged the CII's powers to assign cases to other benches. following allegations that CJI Misra was "selecting assigning cases" to Justice Arun Mishra, the

AMID STRAINED ties between India and Pakistan over Jammu and Kashmir, New Delhi and Islamabad Thursday finally signed the 'Kartarpur Sahib Corridor Agreement' on the zero line at Dera Baba Nanak in Gurdaspur to facilitate the visit of Indian pilgrims to Gurdwara Darbar Sahib Kartarpur.

The signing comes after hectic negotiations over the last year, with Delhi and Islamabad agreeing on most major issues except a \$20 fee to be levied by Pakistan per pilgrim on which India has sought a relook.

The agreement is significant since it's essentially a confidencebuilding measure that comes at a time when the two countries haven't held bilateral talks amid a series of incidents: terrorist attacks in Pathankot, Uri and Pulwama, Balakot air strikes, downgrading of diplomatic ties, withdrawal of Most Favoured Nation status, snapping of trade ties, and cancelling of bus, train and even postal services.

The corridor will be opened on November 9 with Prime Minister Narendra Modi and Pakistan Prime Minister Imran Khan inaugurating the facility in their respective countries. It said that India has consistently urged Pakistan to not levy any fee. However, it said, India agreed to sign the agreement in the interests of the pilgrims and timely operationalisation of the

corridor before the 550th Prakash Purb.

India also said that it continues to pursue all-weather connectivity through the corridor. In this context, the government has built a bridge on the Indian side and a temporary service road as an interim arrangement.

"It is expected that Pakistan will fulfil the assurance that it would build the bridge on their side at the earliest," the statement said. It also said that provisions are made for facilitation of pilgrims. "All the required infrastructure, including the highway and the passenger terminal building, are nearing completion... A robust security architecture has been put in place while facilitating smooth and easy passage of pilgrims," it said.

Referring to mandatory registration on the website, the statement said pilgrims will be informed by SMS and email of the confirmation of registration 3-4 days in advance of travel. An electronic travel authori-

sation will also be generated, which will have to be produced along with passports at the passenger terminal building, it said.

# How long? Come with clear answers: SC to J&K on curbs

THE SUPREME Court Thursday told the I&K administration to "come with clear answers" on how long it intends to keep in place the restrictions imposed ahead of the August 5 announcement ending the special status of the state under Article 370.

While the administration maintained it was reviewing the situation daily, Justice N V Ramana, heading a three-judge bench, questioned Solicitor General Tushar Mehta who appeared for J&K: "It's already two months. How long will the restrictions be in place?". Posting the matter for further hearing on November 5, Justice Ramana told Mehta "you have to come with clear answers".

The bench, also comprising Justices R Subhash Reddy and B R Gavai, is hearing *Kashmir Times* Executive Editor Anuradha Bhasin's petition challenging the communication blackout imposed in the state.

Justice Reddy too said: "You may impose restrictions from time to time, but you have to review it daily." "We are," replied Mehta,

adding that 99 per cent of I&K was now without movement restric-Appearing for the petitioner,

# Two non-local truckers killed in Shopian, trucks set on fire

# Pak troops shell civilian killed

ONE WOMAN was killed and four others were injured after Pakistani troops resorted to unprovoked mortar shelling along the Line of Control (LoC) in North Kashmir's Tangdhar town on Thursday. Another four civilians were injured in shelling in Kupwara district on Thursday evening.

THE DELHI High Court on Thursday sought to know the CBI and Enforcement Directorate's (ED's) stand on the bail pleas of Christian Michel, the alleged middleman in the AgustaWestland VVIP chopper case.

Iustice Anu Malhotra asked both agencies to file their replies to the separate bail pleas within two weeks, and listed the matter for further hearing on November 13.

Michel, extradited from Dubai, was arrested by the ED on December 22, 2018. He was later arrested by the CBI in the case related to Rs 3.600 crore AgustaWestland deal. He is in judicial custody at Tihar jail.

Michel has approached the High Court against a trial court's September 29 order denying him bail in the case. Earlier, the trial court had rejected his bail plea on two occasions — in February and in December 2018.

Challenging the trial court's order, Michel through his counsel submitted that "his pre-trial incarceration is violative of his personal liberty under Article 21 of the Constitution of India".

Article 21 states that no person shall be deprived of his life or personal liberty except according to procedure established

While urging the court that he be given regular bail in both cases, the application stated that Article 21 was available to noncitizens as well, and thus he is entitled to the presumption of innocence like any other accused for securing his liberty.

Highlighting that there is no allegation that any attempt was made by him to tamper with evidence or influence any witness, Michel, in his bail plea, stated that though he does not have "deep roots" in India, he has never evaded the process of law and his intention to cooperate with the probe agency is clear from his past conduct.

# Deleted my Twitter account, it can be restored: Ramani

JOURNALIST PRIYA Ramani Thursday told a Delhi court that she has deactivated her Twitter account, which was not deliberate "in order to destroy evidence" and that it can be reactivated.

"This case has been very hard for me the past one year. I have been in Delhi almost every month and I need to focus on my personal and family life. It is not deleted and it can be reactivated," she told the court of Additional Chief Metropolitan Magistrate Samar Vishal during her cross-examination by M J Akbar's counsel Geeta Luthra.

Ramani had last year levelled allegations of sexual misconduct and harassment against MJAkbar, who subsequently resigned as Union MoS for External Affairs and filed the defamation case.

Luthra showed Ramani comments from the Twitter handles @rajivazad and @indiawassup, where the users reacted to Ramani's tweet. Ramani told the court that she had not read the comments earlier.

Asked whether she can open her Twitter account and confirm these comments, Ramani replied, "I deleted my Twitter account around a month ago, so it cannot be verified now. I do not remember the specific date."

Luthra asked Ramani, "Are you aware that your Twitter account is evidence in this case or not?" Ramani's counsel Rebecca Iohn objected to the question and said, "The Twitter account of the accused is not evidence in this case and the tweets which are a subject matter of this case are already admitted by her and exhibited in her evidence."

ACMM Vishal said that will be decided during time of judgment.

Ramani then told the court, "It is wrong to suggest that these comments and replies...to my tweet show that Mr Akbar's repu-

Luthra then said, "I put it to you that the comments, replies on your Twitter handle, which account you have now deleted during the trial, have become inaccessible." Ramani replied, "I don't think it is true."

The ACMM then asked Ramani whether all these messages be seen again and recovered if she reactivates her Twitter handle with the same account Ramani replied, "I think so."

Luthra also asked whether Ramani deactivated her Facebook account, to which Ramani replied "No. I have 700 friends on Facebook". Luthra asked Ramani whether

she has retweeted any tweet by

Ramani replied that she does not remember. Luthra then showed her a copy of her retweet of Akbar's post on how not to use metaphors. Ramani told the court, "I may have on 04.12.2010 retweeted a tweet of Mr Akbar's on how not to use metaphors. I do not remember that on 14.12.2010. Itweeted about Mr Akbar's Times of India column as compared to India Today writing".

Luthra suggested that Ramani has also, on other occasions, commented positively and tweeted about Akbar's work, to which Ramani replied, "It is incorrect. I don't think so." Her cross-examination will continue on Friday.

# DENTED AT THE TOP

BJP returns in Maharashtra, may be back in Haryana, but will have to address new questions

OR A PARTY for which no election is too small, and which aggressively courts an aura of invincibility, there are unmistakable messages writ on the Haryana and Maharashtra walls. The outcomes of the assembly elections in these two states are a warning that the BJP cannot take its winning streak for granted, that there is something tenuous and nothing inevitable about it — it managed to retain power in one, but not as convincingly as it had projected, and lost its majority in the other, only months after sweeping the state in the Lok Sabha elections. The Maharashtra and Haryana results are a reminder that political dominance in a democracy, beyond the whirring of the marvellous election machine, is made of the several pacts between the voter and the party at local levels that need to be constantly worked upon, and renewed.

In days to come, the BJP must ask itself if the leadership of Prime Minister Narendra Modi, his popularity, is enough. It may have helped the party win the Lok Sabha election decisively across states — as in Haryana, where it won all 10 seats — but it has now evidently failed to carry it past the halfway mark in the Haryana assembly or hold on to its numbers in Maharashtra. It can even be argued that the BJP's underwhelming performance in Haryana and Maharashtra is not despite PM Modi, but because of him — that's a question that can no longer be un-askable in the party. If these elections signal the possible limits of the personality cult that the BJP has constructed around PM Modi, and the dangers of banking on it excessively or exclusively, they also point to the diminishing returns of the emotive nationalism card, played in these two elections by the insistent and emphatic invocation of the Centre's abrogation of Article 370 in Kashmir. There is no evidence to suggest that the electorates in Maharashtra and Haryana opposed the removal of J&K's special status, but there is reason to conclude that at a time when the aam voter is cramped and cornered by agricultural distress and raging joblessness closer home, it was not their primary concern. For some time now, it had seemed that the BJP had been able to accomplish two feats — to separate the economic from the political, and to subsume the political into a test of nationalism. These election results indicate that that separation, that distraction, may no longer be working as well to the BJP's advantage as it did in the past.

In both states that went to polls, the BJP had become, not without its own complicity, the most favoured destination for defectors. If it opened its doors wide to leaders from the NCP and Congress in Maharashtra, it took in large numbers from the INLD and Congress in Haryana. The final tallies in both states have also put a question mark against the anything-goes, moveable politics that it seems to be turning to, to win.

# A CRACK, AN OPENING

BJP's dimming numbers may not signal an endorsement of Congress politics. But they provide it an opportunity

HE MAHARASHTRA AND Haryana assembly election results offer the Opposition, especially the Congress, some reason to cheer. After the drubbing in the general election a few months ago, it has crawled back to relevance in both states. In Haryana, the Congress stood in the way of the BJP winning a simple majority whereas in Maharashtra, the BJP's final tally is likely to be significantly less than its strength in 2014. Yet, while the results are a wake-up call for the BJP, the Congress would be mistaken if it reads them as a sign of its own resurgence.

By all accounts, the Congress has been the indirect beneficiary of anti-incumbency in these states. In Haryana, the party has made considerable gains from 2014, but it may have more to do with it being the default option for voters angry with the Manohar Lal Khattar government. A divided house, the Congress was rocked by resignations and desertions till days before polling. The party organisation is in disarray, its district units remain headless. If it has been thinning organisationally, it has been missing in action politically, staying away from street mobilisations in the past five years despite the growing stress in the agriculture sector and disquiet among youth over joblessness. In Maharashtra, the NCP has won more seats than its parent body and is poised to be the main Opposition party. Here, the Congress hitched its wagon to NCP chief Sharad Pawar, who, at 80, was the Opposition's star campaigner. In fact, the party could learn from Pawar how to turn adversity into advantage and hold the fort against odds. Maharashtra was rocked by protests over farm distress, unemployment, social discrimination and so on in the past five years. Yet here too, the Congress was missing in action even as a large section of the population turned restive. The party's failure to do its job as the Opposition and engage with the public is now reflected in its failure to make bigger gains from the clear anti-incumbency in the two states.

The Congress leadership may well conclude that electoral success is cyclical and that its turn will come when the BJP exhausts itself. Such smug optimism would be misplaced. The Congress is no more seen to be the natural party of governance, that mantle seem to have shifted to the BJP. The party will need to sort out leadership issues, revitalise its cadre, and voice public concerns by mobilising on the streets if it wishes to be in the reckoning more than it is at the moment.

Bikaner police is monitoring waist sizes of policemen. But there was something comforting about corpulent cops

AYBE IT'S BOLLYWOOD'S fault. Too often, the beat constable or the junior sub-inspector is given short shrift during a chase scene. The villain easily outruns the cops in a foot chase, if the police do manage to arrive in time to stop anything at all. The Rajasthan police has, in Bikaner, decided to address this problem. And like all bureaucracies, it has reduced a social problem to one of numbers — in this case, weights and measures. The officers in Bikaner have been instructed by the Superintendent of Police (SP) of the district to provide details of the men under their charge who have an "above average weight/waist size" and "chest size".

A fighting-fit police force is, of course, something that all civic governments now assume society requires. But there is something comforting about the archetypal image of the beat constable, whose belly would always enter a room before him. Ganpat Havaldar from Nukkad, for example, gave joy to an entire generation, much more so, perhaps, than the muscle-bound John Abraham or Ajay Devgn have on the big screen. And, given how intimidating and frustrating most interactions with the police can be for

ordinary citizens, it might be better if cops looked like friendly neighbourhood uncles. Of course, the Bikaner SP's initiative is in keeping with the way India views its police forces. The criterion, even at the time of entry, is largely physical. And despite laudable initiatives at trying to introduce community policing, investigative skills that go beyond intimidation and sensitivity to issues of caste, gender, community, etc, the police continue to retain aspects of their colonial origins. And, given their abysmal working conditions and hours, is it any wonder many don't have time to eat salads and hit the gym?

# Cracks in the edifice

Assembly elections give a small but important reprieve from BJP's arrogance, its consolidation of power

IN HINDSIGHT, all election results seem over determined, paradoxically even more so when they go against projected trends. The close result in Haryana, and the BJP's inability to put in a command performance in Maharashtra has, to borrow Leonard Cohen's phrase, "opened up a crack" through which some light can come in. Far from the hangover effect of the Lok Sabha election, the BJP's drop in vote-share in Haryana is more than 20 per cent, quite spectacular by any means. It will be too quick to draw large conclusions, but these elections have brought back some home truths about politics. There is nothing inevitable about the BJP

juggernaut, even with all its resources, leadership, organisational acumen, and the use (and abuse) of state power behind it. There is an undercurrent of dissatisfaction that is sidelined by high-decibel nationalism issues. The intriguing question is that the scale of the upset might have been even greater had this undercurrent been tapped into with greater resources and organisational acumen by the Opposition. The dent in Harvana has occurred despite a lack of deep presence and intensity in the opposition. Even with Narendra Modi's popularity, there is a sense of unease about India's economy; rural India seems to be a little riper for revolt. By playing the nationalism and the Article 370 card in local elections, the BJP may itself have expressed contempt for local voters. Both Haryana and Maharashtra, like many Indian states, have a strong sense of their identity. The support for nationalism and abrogation of 370 is very high. But voters can also see the sense in which this achievement can be used as a shield to mask other important issues. It is an interesting question whether in this instance, the BJP's attempt to nationalise the election actually hurt it, and it might be a case of the central leadership needing to be blamed more than local strategists. As Haryana demonstrates, messaging requires responsiveness to context, not just the wielding of a mantra, which is what nationalism might have become.

Voter preferences are not too deeply congealed into ideological formations just yet. One of the interesting things in this election is that the turnover of seats is fairly high. There is a thesis that has been propounded of

social cleavages. We sometimes veer between placing too much emphasis on social cleavages, or we write them off prematurely. In most elections, social identities split votes across all parties, though the distribution varies. The real question is when do they matter and how. It will be simplistic to see this election as a Maratha revolt against a non-Maratha CM in Maharashtra or a non-Jat CM in Haryana. The seemingly greater salience of social identity can be as much as an effect, not a cause of politics. In contexts where there is a credible ideological identity, social cleavages can be overcome. If caste seems to reassert itself a little more in some elections, it is probably because there is no other narrative or organisational formation around which to congeal. Contrary to popular perception, there is nothing inevitable about the hankering for

stability and strong leadership at the state level. The voters have expressed their protest, or in some cases reasserted their identity, in the best available form they could. Both states have returned a fractured verdict, with voters, rightly not unduly worried about the implications for stability. We might want the system cleaned up, but we do not want leaders who represented it persecuted in political terms. Leaders, even sometimes corrupt ones, are our own alienated selves, and there are limits to persecution. Sharad Pawar's biggest achievement was to respond to the government's attempts to tighten the noose around him by mounting a political response, responding with new energy. This is a cautionary tale for the BJP using state power to only appear to target opponents and protect its own, and a lesson for the Opposition in how to fight such a targeting — mobilise.

The most significant consequence of this election might be this. One of the mechanisms by which dominant party systems reinforce themselves is by their power to distribute patronage. For anyone wanting a share in power, aligning with the ruling dispensation becomes a winning strategy. At one level, this is manifest in defectors who join the ruling dispensation. Many of those defectors have been punished. The opposition also is demoralised since the possibility of gaining access to power remote. The biggest significance of this election is that it breaks that self-fulfilling cycle of single-party dominance. The fragmentation of protest through state patronage may have its limits; and it still makes sense for some political groups to hedge their bets rather than join the winning bandwagon. This election demonstrates the rationality of doing so. It is a break on the logic of state patronage creating its own power.

Where does India head after this? The election gives a small, but important reprieve against the BJP's arrogance and their consolidation of power. What the BJP will do next is an open question. Will its economics turn more leftward and politics more right? The opposition can take some heart from the fact that there is political space for them to exploit. But this political space can only grow and have a multiplier if there is more smart and credible coordination amongst all opposition groups that converts a protest vote into an alternative economic and ideological narrative. It will be a pity if this moment is squandered on the shoals of personal ambition, or short-term thinking. There is also going to be another interesting question: Does the Congress do better in the relative absence of its central leadership? Nothing is a foregone conclusion in Indian politics, provided we can give up on complacency or resignation.

# Whose Mahatma

After Patel, Bose and Bhagat Singh, RSS is trying to appropriate Gandhi

MOHAN BHAGWAT has rediscovered Mahatma Gandhi. In an article on October 2, he called him the brightest leader that India's freedom struggle had produced. But, he did not rebuke the BJP and the RSS leaders who unleashed their diatribes against Gandhi. The "saint" who declared Godse to be a true patriot, is a member of Parliament from the BJP. It may surprise some that Bhagwat chose to wax lyrical about Gandhi on his 150th birthday, but did not defend him on any of those occasions.

This is a textbook example of how the RSS works; they can't bury Gandhi's ideas, hence they must appropriate them to their end. One can say anything that serves its purpose as long as it is loaded with force and vigour. We have seen them paint the legacies of Sardar Patel, Subhash Chandra Bose and Bhagat Singh in saffron. Now they brandish that brush at the Mahatma, marking the political-ideological contradictions of our times all too clearly.

Bhagwat claims that K B Hedgewar was one of those who spoke at a rally in Nagpur organised in protest of Gandhi's arrest in 1922. However, he wouldn't reveal why Hedgewar left the Congress soon after. He wouldn't allude to the ideological transformation that led the speaker at a Congress rally in 1922 to become the founder of RSS in 1925. This shift reflects the chasm between the ideals of Indian national movement and Hindu fundamentalism.

Let us not take our eyes off from the bunch of thoughts that fuel atrocities in the name of citizenship and Article 370, that allow cow vigilantes to lynch citizens or violent men to kill Dalit children for defecating in the open, that systemically degrade Dalits and Muslims.

The roots of Godse's hatred against Gandhiji cannot be traced elsewhere. Gandhiji stood for harmony and unity between Muslims and Hindus. It was the entrenched hatred for Muslims that led Hedgewar to embrace fascism in the way it was propounded by Benito Mussolini. How can anyone draw parallels between this and Gandhian vision? Can Bhagwat or anyone else prove that Gandhiji harboured any sympathy towards the Sangh's hatred for Muslims?

MS Golwalkar codified the thoughts that underpinned the Sangh's ideology. His perspectives are espoused in his books We or Our Nationhood Defined and Bunch of Thoughts. He deals with India's enemies: Muslims, Christians and Communists, in that order. The similarity of this list with Hitler's list of enemies, as noted in *Mein Kampf*, is strking: Jews, Christians and Communists in that order. Bhagwat might not like to mention these now.

Instead, he writes of Gandhiji's visit to Sangh Shala in Delhi during partition and the reports that appeared in this respect in Harijan on Septemer 27, 1947. To portray it as Gandhiji's patronage of communalism as opposed to his desperate cry to put an end to the bloodshed in those moments of despair is appalling.

Gandhi's murder was not an outcome of a madman's sudden provocation. Godse undertook preparations that spanned several months. During the trial, he narrated the groundwork that preceded the killing. Whether Godse was a member of RSS at the time of firing his pistol is nothing but a technical detail. He had always maintained that he had nothing personal against Gandhiji. Yet, he was convinced that every day Gandhiji remained alive was an affront to Hindu dignity. The murder was as much political as it was heinous.

At the time of his crime, Godse was still the editor of the mouthpiece of Hindu Mahasabha. Gopal Godse, Nathuram's brother had emphasised the Sangh's influence over their lives. They spent longer hours at the RSS office. Hatred for Muslims was inculcated in them in those formative years. Gandhiji led a war against such hatred. That is why in Godse's eyes Gandhi became unfit to live.

Let us not take our eyes off from the bunch of thoughts that fuel atrocities in the name of citizenship and Article 370, that allow cow vigilantes to lynch citizens or violent men to kill Dalit children for defecating in the open, that systemically degrade Dalits and Muslims. Let us not forget how it propelled the bullets that took Gandhiji's life then, and the lives of Govind Pansare, Narendra Dhabolkar, M M Kalburgi and Gauri Lankesh now.



# Restoring a balance

BJP's weakened showing in Maharashtra polls is a lesson for the party that ridiculed the Opposition and displayed over-confidence



"AAG KE liye pani ka hona zaruri hai, satta ke liye santulan zaruri hai," says Om Puri in his inimitable style in Vishal Bhardwaj's Magbool, based on Shakespeare's Macbeth. Voters in Maharashtra have displayed what that santulan, or equanimity, is all about. The hubris with which the BJP-Shiv Sena conducted its business in the past few months has led to the saffron combine's wings being clipped to a large extent — and rightfully so.

Before the electioneering began, the BJP seemed way ahead of the other parties. Maharashtra Chief Minister Devendra Fadnavis had an unblemished record and his performance was nothing short of spectacular. However, just before the elections, he started showing signs of over-confidence, and times, this bordered on recklessness. The first indication of this attitude was the Maharashtra BJP's "free-import" policy. The party inducted all and sundry from other parties, forgetting that not so long ago, its leaders had dubbed some of the new recruits as corrupt. The height of the BJP's brazenness was inducting the NCP MP from Satara, Udayan Raje Bhonsale, a descendent of the great Maratha warrior Chhatrapati Shivaji, and a controversial leader. The BJP made him resign just before the polls, forcing the Election Commission to hold by-polls in Satara along with the state assembly elections. The BJP had hoped that Shivaji's descendent will bring in the much-needed Maratha votes. But the Satara by-poll is a case study in BJP's adventurism. Satara not only handed a resounding defeat to the BJP but hurt the party in adjoining constituencies as well. Barring a few exceptions, many of the newly-imported leaders bit the dust.

The BJP's second mistake was dismissing — in some cases, even ridiculing — all those trying to raise economic and agrarian issues. The BJP's response to such matters was "all is well" and "only the media is creating a fuss out of nothing". This indifference to economic issues has cost the BJP a significant number of seats in rural and semi-urban areas. Vidarbha, a stronghold of the BJP — thanks to the RSS headquarters being located at Nagpur and chief minister Devendra Fadnavis and party stalwart and Union Minister Nitin Gadkari hailing from the region — has turned away from the BJP. CM Fadnavis' victory margin is significantly lower than in 2014. The Marathwada region too has deserted the BJP and Sena. These regions have reported the maximum farmer suicides.

The third and the most important lesson for the BJP from this election is: Never humiliate the Opposition. There may not be an opposition leader who can match the BJP's leaders in stature, but it is the voter in whose minds the seeds of opposition are sowed. And, when the voters realise that the time has come to rein in the party in office, they stand with anyone who is willing to take on the ruling dispensation. This is exactly what has happened in Maharashtra. While the BJP's leaders — including Fadnavis, party chief Amit Shah and even Prime Minister Narendra Modi – kept harping on the fact that there is no challenger on the other side of the fence, voters in Maharashtra backed even rookies against the party's stalwarts. It's not surprising that several



cabinet ministers in the Fadnavis government were sent packing by voters.

The performance of the BJP's alliance partner, Shiv Sena, has been underwhelming. Political observers have time and again pointed out the Sena's helplessness in tagging along with the BJP. The Sena did the most laughable thing in politics — have their cake and eat it too. Though sharing power with the BJP, the Sena tried to occupy the Opposition's space. It was neither here, nor there. Voters have sent out a clear message to the Sena that it can not have the best of both worlds. The Sena has been hopped from one agenda to other; in the process, it seems to be losing its identity. To begin with, the Sena talked about the Marathi Manoos, it then jumped onto the Hindutva bandwagon and in the current election, it tried to offer a mix of both. The election outcome suggests that both issues have slipped out of the party's hands.

Not surprisingly, the only leader who can savour the election result is the old war horse, Sharad Pawar. When every other opposition leader was either giving in or joining the BJP, the Maratha strongman demonstrated how to tame the raging bull. The octogenarian leader criss-crossed the state and single handedly took on the BJP. Fadnavis will rue the humiliation he handed out to the NCP chief at various platforms. Putting behind a life-threatening ailment and his advancing years, Pawar demonstrated how to convert challenge into an opportunity. For instance,

Pawar converted the ill-timed ED notice to him into a media spectacle. Under the glare of cameras, he walked into the ED office in Mumbai with hundreds of supporters to "surrender" before authorities. Caught completely off guard, the ED had to publicly give a "clean chit" to Pawar.

This was the turning point of this election campaign. By beating the ruling party with its own stick, Pawar also gave a lesson or two to the NCP's alliance partner, the Congress. Virtually rudderless, the Congress was the most invisible political force in the current elections. It was Pawar who galvanised the Congress and towards the end of the electioneering, it at least resembled a political party. The point to be noted here is that neither Sonia Gandhi nor Priyanka Gandhi had a single rally or meeting in Maharashtra. One can understand Sonia's absence because of her ill-health, but the Congress could have deployed Priyanka in the Maharashtra election campaign.

This, in fact, makes the election outcome even more interesting. The message is very clear: No political party can — and should take the electorate for granted. A ruling party's slide begins the moment it gives a call for getting rid of the Opposition. Such hubris creates an opposition for the ruling dispensation in the voter's mind. And, it is the voter who knows, Satta ke liye santulan ka hona zaruri hai.

# Medical devices are not drugs

Why government should bring a new law to regulate medical devices, not apply the 80-yearold Drugs and Cosmetic Act

ASTONISHING THINGS are happening in the Ministry of Health and Family Welfare these days. In less than 30 days, the ministry is going to put in place a regulatory framework for medical devices that will likely give lobbyists for the medical device industry a wonderful Christmas present. Amazingly enough, the ministry aims to implement this new framework without the Parliament casting a single vote to determine the future of an industry which has already proven itself to be brazenly irresponsible towards patients in India as we are seeing in the ongoing hip-implant scandal. Rather than moving a new law in Parliament to regulate the medical device industry, the ministry is creating an entire regulatory framework out of notifications and rules, using powers delegated to it under the Drugs and Cosmetics Act, 1940 – a pre-independence legislation that was enacted almost 80 years ago.

The first move towards the new framework was made in 2017 when the ministry, using powers under the Drugs and Cosmetics Act, notified the Medical Device Rules, 2017. At that time, only a few medical devices were notified as "drugs". In a notification a few days ago, the government announced its intention to treat all medical devices, be it an implant or a MRI machine as "drugs" under the Drugs and Cosmetics Act. This means that all medical devices would be placed within the framework of the Medical Device Rules, 2017. This attempt to deliberately retrofit medical devices into the Drugs and Cosmetics Act will lead to a toothless regulatory framework for devices, similar to what exists for drugs today. I say this for two reasons after having spoken to legal experts.

First, the ministry cannot create new offences or penalties through its rule-making authority. Only Parliament can enact a law that creates new offences and penalties for wrongdoing. As a result, the Medical Device Rules 2017 contain no penal provisions. Although the Drugs and Cosmetics Act does contain a penal provision for the manufacture of sub-standard drugs, it cannot be used to penalise manufacturers of sub-standard medical devices (although medical devices will now be legally defined as drugs) because legally binding standards recognised in the Second Schedule to the Drugs and Cosmetics Act covers only pharmacopeias for drugs. If no standards for medical devices are recognised in the Second Schedule, it follows that there can never be a prosecution of a manufacturer of sub-standard medical devices.

What will unfold, if the current proposal is adopted, will be similar to what we see with substandard drugs: Companies that make defective products will recall them from foreign markets while continuing to sell the same product in India, and comply with the law. There is one subtle

distinction here. Even though sale of substandard drugs can be prosecuted under the current law; because there is no political will, most manufacturers who make poor quality drugs go scot-free. Under the present proposal, even if there is public pressure, similar to what we have seen in the faulty hip-implant case, no prosecutions will take place because there will be no basis to prosecute intentional wrongdoing in the law.

More importantly, medical devices, because of their nature, will be far more difficult (if not impossible) to standardise when compared to drugs. So, what are the tools available to Indian regulators under the proposed framework to hold makers of sub-standard medical device manufacturers to account? The answer is none whatsoever. At most, the ministry can prohibit the manufacture and sale of certain medical devices under Section 26A or cancel a license to prevent future harm. But what of penalties or prosecution to punish for the harm already inflicted on patients due to negligence or worse, intentional wrongdoing by the manufacturer?

The second reason is that it is quite clear that the ministry has not learnt any lesson from the recent hip-implant debacle. One of the main challenges faced by the government in securing justice for faulty hipimplants was to secure a list of patients who had received the implant through surgery. Since the manufacturer sold these devices to doctors and hospitals and not patients directly, it did not have a list of patients who had these devices implanted. It could therefore conveniently skirt the government's query for a list of all the patients with faulty implants. Neither the doctors nor the hospitals have an incentive to share the list of patients or even inform the patients because it would mean opening themselves up to legal liability for surgically implanting faulty devices in the patient's body. One of the solutions to solve this information deficit is to create a confidential patient register that should be maintained by the government to record all details of implants. This register could be used to notify patients in the case of malfunctioning devices. The proposed regulatory framework does not offer any such provision. As a result, the next time there is such a case, the government will once again not be able to contact the patients to

inform of their rights. While medical devices have tremendous potential to revolutionise healthcare, the hip-implant scandals in India and abroad have shown us the dark underbelly of this industry. The proposed regulatory framework lacks teeth and will do little to hold the powerful medical devices industry accountable in cases of intentional wrongdoing. The government must rethink this toothless framework and instead enact a new law through Parliament. Medical devices are not drugs, and it would be a grave mistake to apply the same regulatory framework to regulate these complex devices. The need of the hour is for new ideas to regulate this industry in the Indian context where the courts lack the capacity to tackle such

## WAITING FOR VERDICT

THE HEARINGS before a Constitution bench for title rights to the land where the Babri Masjid stood ended a week ago. Urdu dailies have extensive reports on it and *Etemad*, the Hyderabad-based AIMIM's daily, published an editorial on the subject on October 17.

Etemad reflects on what the Supreme Court had said before the trial began. The editorial says: "It (SC) had said it would hear only those sides that had appealed the Allahabad High Court order and no new side. It rejected Subramaniam Swamy's plea to be heard. It also said that only the title suit would be heard and no other claims." In this, news has emerged that one party and person, the chairman of the Sunni Waqf Board, against whom an FIR had been registered, has retreated from the case and this has created immense restlessness amongst Muslims." The editorial asserts: "Muslim ulema, intellectuals and politicians have all said that the Supreme Court ruling must be respected. But no Hindu side has said this."

*Munsif*, on the same day, has an extensive report on its front page. It raises question marks (literally) over the talk of a "deal" between some Hindu and Muslim parties. It quotes the Shahi Imam of Delhi's Jama Masjid, Ahmed Bukhari, asking why there is saudebaazi (deal-making) at the lamhe-

aakhir (last moment). Mumbai-based *Urdu Times* on October 16 published an editorial, 'Masjid ka Maamla' (The Masjid matter). It gives its view, wherein it holds that the Hindu side has failed to establish that there was a mandir on the ground that was destroyed to build the Babri Masjid, or that it stood where the Babri Masjid was. The editorial outlines the arguments laid down in Court by both sides. "These arguments in Court will determine which side gets the land," it says. The editorial ends on an interesting note: "If the Court decides on the logic of arguments presented before them, then it should be clear that the top Court is still not overwhelmed by Hindutva and is still unaffected or pure — untouched by Hindutva sentiments."

## RESTIVE OVER NRC

INQUILAB ON October 14 ran an editorial on the NRC (National Register of Citizens), calling it a "new fancy" (naya shosha). It mentions a "central minister" (unnamed) who dropped a *naya shosha* in a rally in Mumbai's Bhendi Bazaar, stating that NRC is not for Indian Muslims but for foreigners. The minister did not reveal where or how he discovered that Muslims are scared, or did he think it necessary to advise Indian Muslims about

not being scared, before they are scared?" The paper argues: "Then, another question arises. Why did he deem it necessary to say this? Actually, by framing the NRC as a Hindu-Muslim question, it makes it clear that not only daal mein kucch na kucch kaala hai, balki poori daal kaali hai. Now, is it that blackness has crept in because of the compulsion to bring in black money?" The editorial mixes metaphors and goes on: "Or, is it that people are trying to keep their hands clean of their attempt to clean corruption?" It concludes that through several contradictory statements, ministers and leaders of the ruling party are deliberately trying to keep the people in the dark about the whole thing (NRC exercise).

Siasat has an editorial on October 9, on "(Bangladesh Prime Minister) Sheikh Hasina's silence over the NRC". On October 12, it poses a more direct question, asking, "Who is the intended target of the NRC?" It claims: "The government is trying to divert the focus from burning issues that need peoples' attention. And this policy of diversion is being concretely implemented as the new NRC is being spoken of for all India." It has harsh things to say about India's social atmosphere. "After Assam, West Bengal was made a centre and all issues that spread disagreement, hate and division in society are being spread there". The newspaper argues that "(Home Minister) Amit Shah is so obsessed with NRC that he can see no other issues pertaining to the common man. It ap-

pears that this is not a matter of home affairs alone but the entire central government is taking this on, on a war footing." It elaborates that all ministers holding different portfolios are also talking of NRC, which "makes it clear that before all ministers, peoples' issues have no significance".

## NOBEL PURSUITS

EDITORIALS HAVE lauded the Nobel to Indian-origin and educated economist, Abhijit Banerjee. Banerjee and Esther Duflo's work on combating poverty has also been discussed at length.

The October 17 editorial in *Inquilab* says: "(Abhijit Banerjee) has used many opportunities to point out the problems with the Indian economy, but his viewpoint has been ignored and there has been no attempt to use his talent, skills or expertise. The government tried during demonetisation to paint all these experts as communist and as those with Leftist views." It asks if labelling people like this is not an "insult to their knowledge and status in the world?"

Siasat on October 16 has an editorial devoted to Banerjee. It talks about the need for strong and concrete policies to battle poverty. It says: "They offer lessons which need to be learned by those in developing countries, where the problem of poverty exists."

# Resurgence of Pawar with Cong riding piggyback, and fissures within BJP-Sena

### Opposition is not dead, yet

Weeks before the Maharashtra Assembly election, Sharad Pawar, 79, was staring at the remains of his NCP after the BJP had systematically poached key members in areas that remained Pawar strongholds despite the Modi wave. The BJP scaled up its ambitions to winning145 seats on its own so that it would not be at the mercy of its alliance partner, Shiv Sena. It proved a bridge too far, although the BIP-Sena did hold on to power.

There were two turning points for Pawar in the run-up to the polls. The first came when he was named by the Enforcement Directorate in a money-laundering case against the Maharashtra Cooperative Bank. He announced he would voluntarily present himself at the ED office in Mumbai. On the given day, NCP supporters swarmed Mumbai, turning it into a Maratha pride moment, while the ED frantically put out a statement that it had not summoned Pawar. He called off his visit to the ED office at the request of the Mumbai police commissioner, but had sent out a strong political message.

It was on the very last day of the campaign that the second turning point arrived. He addressed a widely televised rally for the Satara Lok Sabha bypoll, standing under pelting rain, to thundering applause. The footage went viral overnight. It was NCP's magic moment, and possibly set a template for the opposition in the state and country.

## Nationalism vs local issues


In rallies, the emphasis by Chief Minister Devendra Fadnavis was mainly on work by his government, but he also ended every meeting with the Centre's decision to revoke J&K's special status. In an interview to The Indian Express, Fadnavis said the Kashmir issue had resonance in Maharashtra. In speeches by Prime Minister Narendra Modi and Union Home Minister Amit Shah, too, the Centre's action to abate Article 370 was a main pitch. The results indicate it may not have had as much resonance among Maharashtra voters as local issues such as farm distress, and rural indebtedness. In Nashik, the BJP-Sena paid heavily for the government's onion price control measures. Throughout its campaign, a confident BJP did not address the consequences of the economic slowdown in the country's most industrialised state.

**SOPS DON'T ALWAYS FETCH VOTES:** In the BJP's calculus, the Maratha quota, granted in 2018, was the silver bullet to winning over Maharashtra's politically most dominant community. The Marathas had been a mainstay of the Congress and NCP's voter base but the BJP's dominance in the Lok Sabha polls appeared to suggest the community had shifted loyalties. The Assembly polls made it clear that the BJP could not take this for granted. Out of 70 seats in Western Maharashtra, a Maratha stronghold, the BJP won only 16 seats, against its 25 of 2014. The promise of the Bharat Ratna to V D Savarkar did not help the BJP quest for dominance either.

## Gandhis weren't missed

After the rout in the Lok Sabha elections and the leadership crisis within, the Congress appeared not to be in the fight for the Assembly elections, and was a feeble partner of the NCP. Rahul Gandhi addressed only five meetings, and Sonia Gandhi stayed away from the campaign for health reasons.

It was left to the Maharashtra Congress to make the best out of a bad situation. What may have helped it in constituencies it won was its choice of candidates who were locally well known though they may not have had a state-wide profile. A rudderless Congress,

coat-tailing on the NCP, won four more seats than in 2014. In many seats, it also benefited from bad vibes within the BJP-Sena alliance. One of the curiosities of the Congress-NCP alliance was that the two parties did not address a single rally from the same platform but still managed to project a united front. However, despite its improved seat tally, the Congress finished fourth, and its vote share fell from 17.8 per cent to 15.2 per cent.

# Divided saffron alliance

From the start, the BJP-Shiv Sena alliance was beset by tensions, born out of BJP's ambition of finishing the Sena, and the latter's insistent demand for "equal" power sharing, by which it meant a shared chief ministership, or the deputy chief minister's post. While Fadnavis and Uddhav Thackeray managed to paper over these issues, the Sena's acceptance of a lower seat share was a shock to cadres. It was a battlefield between Sena and BIP in many seats.

Tensions within the BJP too played a part, especially in Vidarbha, marked by the sidelining of Nitin Gadkari, and ticket aspirants seen as close to him. On the ground, unhappy RSS cadres are said to have worked for rejected candidates who contested as independents. Also, only 16 of 31 defectors from Congress-NCP to BJP-Sena won, an indicator that not all voters are receptive to party hoppers.

## Fadnavis suffers a setback

Fadnavis had outsmarted rivals in 2014 to become the Chief Minister, and defied critics who saw his Brahmin identity as unworkable in a Maratha-dominated political ecosystem. He proved them wrong, along the way deftly dealing with the Marathas by granting them a quota, then breaking their stranglehold by going after cooperatives. This time, his mission was to return the BJP with a near majority of its own, so that it could shake off the Shiv Sena. Instead, the BJP has become more dependent on the Sena than it was. The loss of seats in Vidarbha, his home turf. is another setback to Fadnavis.

### For youth, absence of jobs

The election results in Haryana went against the idea that the BJP has successfully managed to disconnect economics from politics by focusing on its nationalist agenda. Haryana, which has a population over 40 lakh in the 20-29 age bracket, has witnessed a steep rise in unemployment over the last five years. A report by the Centre for Monitoring Indian Economy for May-August 2019 pegged unemployment in the state at 28.7 per cent, the highest in the country. A few years ago, it had been only 8 per cent. It is estimated that there are 2.02 million unemployed young people in the state and over half of them are matriculates and above.

While the BJP sought to highlight transparency in recruitment to Class IV posts, its rivals drummed home the rising joblessness. The loss of jobs in the Manesar-Gurugram belt also appear to have hurt the BJP, which fell short of the halfway mark.

The Congress and the Jannayak Janata Party (JJP) harped on disappearing jobs during their campaign, with the latter promising to implement the right to work and a 75 per cent job quota for locals. Many Haryanvis, who had voted for the nationalist agenda in the Lok Sabha polls, seem to have decided that local issues mattered more in the Assembly polls.


#### Gandhis out of limelight This was one election where the Gandhi

family of the Congress did not play a lead role in campaigning. Most of the canvassing was done by the candidates themselves, with some help from state Congress Legislature Party chief Bhupinder Singh Hooda and the new state Congress chief Kumari Selja. While Prime Minister Narendra Modi addressed seven rallies in the state, Rahul Gandhi addressed only two.

The upswing in the fortunes of Congress, from 15 seats in 2014 to 31 now, indicates that the Gandhi star appeal did not matter. Two-time former Chief Minister Hooda, who is facing investigations in the Manesar land scam, emerged the clear leader of the Congress with his focus on local issues. The fear that former state Congress chief Ashok Tanwar's resignation from the party, and his support to both the JJP and the INLD, would affect the party's performance, too, was proved wrong. Hooda got the lion's share in the distribution of tickets, and the Congress swept his strongholds of Rohtak, Sonipat and Jhajjar. The Congress won 11 of the 15 seats in the Jat belt with the BJP taking three and one going to an independent.

## **Emergence of Dushyant**

The JIP, formed out of a split in the INLD, has emerged as a third front by bagging 10 seats in its maiden elections. A new leader in has emerged in Dushyant Chautala, 31, greatgrandson of Chaudhary Devi Lal. Known for his oratorical and organisational skills, he has demonstrated that the state is ready for a youthful leadership. Many of the cadre votes

that used to go to the INLD have shifted to Dushyant, showing discontent with a moribund leadership. That he also has the Chaudhary Devi Lal lineage also helps.

Interestingly, candidates from political families did reasonably well in elections regardless of their party affiliation. Kiran Chaudhry (Congress) was able to retain her seat, as was Kuldeep Bishnoi. Abhay Chautala was the only INLD winner, in results that spelt doom for the party. Founded in October 1996 as Harvana Lok Dal by Chaudhary Devi Lal, who served as Deputy Prime Minister and as Chief Minister twice, the INLD used to give the national parties a tough fight in Haryana. Even in 2014, it had won 19 seats, four more than Congress, to emerge as the principal opposition.

## Hurt by over-confidence

The slogan 'Mano again' for Manohar Lal Khattar did not resonate with Haryanvis on the ground. CM Khattar's statements such

as "Main anaadi nahin siyasat ka khiladi hoon", backfired with the Opposition accusing him of being arrogant. There was an uproar on social media when, during his Jan Ashirwaad Yatra preceding the polls, Khattar threatened to behead a man who had crowned him (he later clarified it was because he believed in equality).


The fall of heavyweights in his ministry those defeated included eight ministers and the BJP state chief — showed that the top echelons of the government had failed to connect with people despite the multitude of people-friendly initiatives. Bakshish Singh Virk, the BJP candidate from Assandh, who had bragged that no matter which button you press, the vote will go to BJP, also lost the seat he had won in 2014.

Some of the results showed substance can trump star appeal. Sports stars Babita Phogat and Yogeshwar lost, while Sonali Phogat, the Tik Tok star, was defeated from Adampur. Sandeep Singh, the former hockey captain who overcame a debilitating injury, managed to swing Pehowa because his story of grit resonated in a constituency populated by Partition refugees.

## **Jats remain a factor**

Although the BIP sought to move beyond the dominance of Jats, the community did make a difference in 36 seats across four parliamentary constituencies. In the Lok Sabha polls, the BJP had secured more than 70 percent of both non-Jat upper caste votes and OBC votes besides 50 per cent of Jat votes as per data from Lokniti-CSDS. But many Jats who had voted for the BJP's nationalist agenda in the Lok Sabha polls, cast their vote on local issues in the Assembly polls.



# Hooda admits: change came late

IN AUGUST, former Chief Minister BHUPINDER SINGH HOODA publicly rebelled against the Congress and declared himself the chief ministerial candidate, "with or without Congress". Giving in to pressure, the party high command, in September, made him CLP leader and replaced Ashok Tanwar with Kumari Selja as PCC chief. Hooda tells **VARINDER BHATIA** that if the change was made earlier, the results would have been different.

#### After winning 31 seats, what is your next step?

The mandate of the people of Harvana is against the state government. I have already appealed to the entire Opposition that the people's mandate should be respected and we should all join hands — whether it is the JJP, INLD, independents or Kanda's HLP. Let us see how they respond. I have not yet spoken with Dushyant Chautala, but a few independent candidates who have won are in touch.

If the change in the party's state leadership was made earlier, would the results have been different?

Of course, the results would have been different.

#### Do you think the BJP's nationalist campaign failed? Talking about Balakot, Article 370 etc is a

separate issue. At the Assembly polls, they should have listed the achievements of their state government in the last five years. They should have shown what they have done for the people of this state — be it traders, youth, farmers. Every section of society is upset with this BJP government. People of the state have shown their anger today and proved what I have been saying — that it is a non-performing government.

THE EXPRESS INTERVIEW BHUPINDER HOODA CONG LEADER, HARYANA

#### Almost all the BJP's outgoing ministers have lost.

This reflects the non-performance of the government. Its ministers were full of arrogance. It shows that the government did not

take any people-friendly decision. The state government did not have any achievement to showcase. Whenever they went to the people, they could not say if they have got any additional metro line, thermal power station, university, college, job avenues, industries.

They absolutely failed in governance. The state which used to be No. 1 in per capita investment and per capita income in 2014, has now been reduced to being No. 1 in unemployment and crime.

#### The BJP is staking claim to form the government.

It can do so, as it is the single largest party. But, morally, it has lost all right to do so. When your entire cabinet has been rejected, when the people have given their mandate against you, when the people have rejected you, you do not have any moral ground to stake claim.

It is a moral defeat for the BJP.

The Muslim-dominated seats of Nuh. Ferozepur Jhirka and Punhana are in southern Haryana. The Jat-dominated seats, which fall in Rohtak, Jhajjar and Sonipat districts, are Beri, Jhajjar, Meham, Badli, Baroda and Garhi Sampla-Kiloi. In the Muslim-dominated constituen-

cies, the BJP relied on INLD turncoats Zakir Husain in Nuh and Naseem Ahmed in Ferozepur Jhirka — both were seeking reelection from their respective constituencies. In Punhana, the BJP fielded debutant Nouksham Chaudhary. However, these constituencies maintained their voting pattern, which was evident in Thursday's results.

In Nuh, Congress candidate Aftab Ahmed defeated BJP's Zakir Hussain by 4,038 votes, while in Ferozepur Ihirka, Congress's Mamman Khan defeated BJP's Naseem Ahmed by 37,004 votes. In Punhana, Congress's Mohd. Ilvas defeated Independent candidate Rahish Khan, while BJP candidate Nouksham Chaudhary was nowhere in the fight.

Among the Jat seats, Beri saw Congress candidate Dr Raghuvir Singh Kadian defeat BJP's Vikram Kadian by 12,952 votes, while in Jhajjar, Congress candidate Geeta Bhukkal defeated BJP candidate Rakesh Kumar by 13,751 votes.

In Baroda, Congress candidate Sri Krishan Hooda defeated BJP's Yogeshwar Dutt by 4,840 votes and in Meham, independent

candidate Balraj Kundu defeated Congress's Anand Singh Dangi by 12,233 votes. Here, BJP's Shamsher Singh finished third.

Badli saw Congress's Kuldeep Vats defeating BJP's Cabinet minister Om Prakash Dhankar by 11,245 votes, while in Garhi Sampla-Kiloi, Congress's Bhupinder Singh Hooda defeated BJP's Satish Nandal by 58,312 votes — the biggest victory margin in these Assembly polls.

Beri, Meham, Badli, Garhi Sampla-Kiloi and Jhajjar Assembly segments fall in Rohtak parliamentary constituency, from where BJP's Arvind Kumar Sharma defeated Congress's Deepender Singh Hooda in the Lok Sabha polls just five months ago. Baroda constituency falls in Sonipat parliamentary constituency, from where BJP's Ramesh Chander Kaushik defeated former CM Bhupinder Singh Hooda in the same parliamentary elections.

The caste factor appears to have played a vital role in deciding the BJP candidates' fate in the Jat-dominated seats. Despite the BJP fielding Jat candidates here, the party's image as a non-Jat party and failure of Jat leaders within the BJP to secure reservation for their own community seem to have gone against them. Forty lives were lost in Haryana during the Jat quota stir. Later, a large number of Jats were arrested on charges on charges of vandalism.

In the 2019 Lok Sabha polls, too, the BIP candidates who won by huge margins failed to make inroads in these Assembly

In Nuh, the BJP had got 34,258 votes while the Congress had polled 82,116 votes. Similarly, in Ferozepur Jhirka, BJP had got 26,466 votes while the Congress had led the segment with 1,08,324 votes. In Punhana the BJP had polled 22,267 votes against Congress's 81,876.

Similarly, in all Jat-dominated Assembly segments, the BJP had trailed the Congress during the 2019 Lok Sabha polls.

# Dushyant emerges as new Chautala

THE FLEDGLING Jannayak Janata Party (JJP), born just 10 months ago out of a family feud in the Indian National Lok Dal (INLD), emerged Thursday as a third political force in Haryana by winning 10 out of the 90 seats in the Assembly polls — a significant number in a verdict that did not throw up any clear winners with BJP and Congress failing

As the results came in, however, JJP chief Dushyant Chautala struck a measured note and dismissed talk about him being a kingmaker. "I am neither a king nor a kingmaker... I have called a meeting of senior leaders, including the winning candidates, tomorrow. We will discuss our future course of action, and will abide by whatever decision is taken by the party," he said.

Dushyant, 31, is the son of Ajay Chautala and grandson of Om Prakash Chautala, both of whom were sentenced in 2013 to 10 years in jail for their role in a teachers' recruitment

On its poll debut this time, JJP's candidates defeated heavyweights such as finance minister Capt Abhimanyu from Narnaund, BJP state chief Subhash Barala from Tohana, and minister of state Krishan Kumar Bedi from Shahbad. Dushyant's mother Naina Singh upstaged Congress candidate and late CM Bansi Lal's son Ranbir Singh Mahendra from Badhra.

Dushyant, a business graduate from California State University and a lawyer from NLU, trounced Prem Lata Singh, wife of BIP leader Chaudhry Birender Singh, who had defeated him in the previous state polls in 2014. Just four months ago, Prem Lata's son

Brijender Singh, a former Haryana-cadre IAS officer, had defeated Dushyant from the Hisar Lok Sabha constituency.

But many of JJP's winning candidates this time are ambitious turncoats. Ram Karan, the winner from Shahbad (SC), was an INLD member who had lost to BJP's Krishan Kumar Bedi by a mere 562 votes in 2014. He joined JJP after Congress refused to give him a ticket.

Two of the winners are disgruntled BJP leaders who switched sides for tickets. Jogi Ram Sihag, the winner from Barwala, is former chairman of the Haryana Housing Cooperative Federation, who joined Dushyant's party on October 3.

Ram Kumar Gautam, the giant-slayer from Narnaund, is known for his role in scrap-

ping the Jat quota. He had once left BJP when it allied with INLD, saying it was a "party of demons". This time, he quit the saffron party after being denied the ticket from Narnaund. Devinder Singh Babli, who defeated the

after being denied ticket by Congress. The JJP also fielded the highest number of Jat candidates at 34 followed by Congress's

BJP state chief at Tohana, joined JJP in October

27 and BJP's 20, and found support in Jatdominated seats. Anoop Dhanak, one of the four INLD legislators to join JJP when the party split last December, won from Uklana, while Amarjeet Dhanda stopped Paramjeet Singh Dhull (INLD) from scoring a hattrick at Julana.

Both the candidates fought on the slogan, "Croron chahne waalon ka mela hai, kaun ke-

hta hai Dushyant Chautala akela hai? (It's a festival of those who seek crores, and who says Dushyant Chautala is alone?)". One of the last to come up with their

manifesto, the party targeted the youth by promising right to work and 75 per cent quota for local youths in jobs and an unemployment allowance of Rs 11,000.

When Dushyant founded JIP on December 3, 2018, after his expulsion from INLD by party supremo and grandfather Om Prakash Chautala, many had thought it would be a flash in the pan. But he positioned himself as the heir to the legacy of Choudhry Devi Lal, arguably the tallest Jat leader of Haryana, by using his name Jannayak, and started enrolling members.

His detractors first took note of the young party when Dushyant's younger brother Digvijay came second in the Jind bypolls, relegating Congress heavyweight Randeep Singh Surjewala to third and INLD, once considered formidable in the seat, to fifth. It also raked in more votes than INLD in the Lok Sabha polls in May.

The JJP draws its cadre not just from a fractured INLD Jat vote, but also from Indian National Students Organisation (INSO), a well organised outfit set up by Ajay Chautala.

Ever since he became the youngest Lok Sabha MP at 26 after defeating former CM Bhajan Lal's son Kuldeep Bishnoi from Hisar in 2014, Dushyant has been nurturing the youth constituency.

The student cadre translated into enthusiastic supporters during the Assembly elections. With a smattering of green and yellow flags, catchy slogans, and peppy numbers, JJP was very much the third most visible party in the campaign, with long cavalcades of supporters belying the party's age.

## AAP candidates set to lose deposits in Haryana, Faridabad

Gurgaon: The AAP candidates in Haryana's Gurgaon and Faridabad districts are set to lose their deposits, with all of them missing the 16.67 per cent vote share mark by large margins. Chandigarh: The Yogendra Yadav-led Swaraj India, which had contested 40 seats in Haryana, failed to open its account. The party had surprised everyone on July 23 by releasing its list of candidates.

Party founder Yadav had made it clear that he did not expect to win any seat. "I am just laying the foundation of a new electoral discourse," said Yadav. The party's candidates were selected for their affinity to public service. The party called its manifesto Imaan Patra and promised to create 20 lakh job opportunities at an outlay of Rs 20,000 crore in the state. **ENS**



"IT MAY not be a clean sweep but Sharad Pawar, the warrior, has fought back. And how," NCP MP from Baramati, Supriya Sule, said on Thursday.

Addressing the media in Mumbai, the NCP chief showed just how his leadership helped the party improve its tally from 41 seats in 2014 to 54, just two behind the Shiv Sena: an unrelenting drive, even at just days shy of 79. While he was being hailed as the comeback king, Pawar said he would embark on a state-wide tour to develop a new batch of young, second-rung leaders in Maharashtra.

Not long ago, the state and his old associates seemed to have turned their back on Pawar, with many quitting the party to join either the BJP or the Sena. But rather than getting bogged down, Pawar decided to launch the comeback of his life, holding 66 rallies in the campaign phase. In the run-up to the elections, the

Enforcement Directorate had registered a case against Pawar in a money laundering case, but his strategy to run a campaign on how he was being "targeted" as part of vendetta politics by the ruling regime seems to have found a connect with the voters.

"In this election we have seen that people do not take to kindly to people who get intoxicated with power. Power comes and goes, and people have this expectation that you should be grounded. If you take a position contrary to that, the same people do not take to it kindly," he said, reacting to the election verdict.

## MNS wins one seat, vote share drops

Mumbai: The Raj Thackeray-led MNS has been able to win only one seat — Kalyan Rural won by Pramod Ratan. The MNS's vote share in Maharashtra has been in a free fall from the heady days of 2009 when it won 13 seats polling 5.71 per cent of votes. This dropped to 3.1 per cent in 2014 when it won one seat. It has now further come down to 2.3 per cent. After its initial plan not to contest, the MNS fielded 101 candidates. Raj Thackeray's aggressive style of campaigning was hardly on show with many perceiving this change to the ED notice slapped on him in a money laundering case.

## AIMIM gets two, loses old seats

Mumbai: The AIMIM made inroads in North Maharashtra winning two seats in Malegaon Central and Dhule City, but failed to save its own turf of Aurangabad Central and Byculla, where the party had won in 2014.

After breaking ranks with Prakash Ambedkar-led Vanchit Bahujan Aghadi, the Hyderabad-based party under the leadership of state president Imtiaz Jaleel had fielded 44 candidates in Maharashtra — the highest so far since Asaduddin Owaisi-led party started contesting elections in Maharashtra. Mufti Ismail won from Malegaon Central seat and Shah Faruk Anwar from Dhule City.

## VBA draws a blank, vote share dips

Mumbai: Six months after its impressive debut with over 7 per cent of votes in Maharashtra at the Lok Sabha elections, the Vanchit Bahujan Aghadi (VBA) failed to impress in the Assembly elections, failing to win a single seat. While its candidates fared reasonably well in a few select seats, overall, its vote share fell significantly from its Lok Sabha performance.

# As BJP's tally dips, Uddhav reminds it of '50-50' formula

AS THE BJP's seat tally in the Maharashtra Assembly polls tumbled to about 20 less than what it was in 2014, Shiv Sena chief Uddhav Thackeray lost no time on Thursday to "remind" his saffron alliance partner about the "equal" or "50-50 power sharing" formula for all posts in the government.

This is Sena speak for rotating the chief minister's post between itself and the BJP for two-and-a-half years each. Thackeray appeared to be speaking with the newfound confidence that the BJP's lower than expected performance in the elections seemed to have given his party.

"We all know that when the alliance was forged before the Lok Sabha polls, 50:50 formula was decided. There is no need to hide it now. It was also decided that the seatsharing ratio would be 144:144. BIP state president Chandrakant Patil then said that I should understand BJP's problems in seat sharing. I understood their problems and ac-

cepted a smaller share of the seats. But if their problems are going to increase, then I can't understand all their problems," Thackeray told mediapersons at the Sena headquarters in Mumbai.

Maintaining that he needs to expand his party, he added: "So, all senior leaders from both parties will sit together and we will take a decision on the formula. Then, we will stake a claim on government formation."

It was not a "warning" to the BJP, he said, but "just a reminder" of what had been discussed earlier.

The Sena chief's remarks came after the Assembly polls results showed that the BJP is set to win 105 seats, and the Sena 56. Both parties have won less number seats as compared to the last time. In the 2014 elections, the BJP had won 122 seats, while Sena won 63 after contesting the polls separately.

Thackeray indicated that he would not explore the possibility of forming a government without the BIP by seeking support from the Congress-NCP combine. "I am not in a hurry. I am not greedy for power and won't do anything out of turn for power," he said on Congress-NCP offering support for a Sena CM.

Sena leaders are confident that the party's bargaining power has increased due to the fall in the BJP numbers, though its own tally of seats has fallen by seven seats from what it had won in 2014.

"The drop in the number of Sena seats happened either due to the rebellion by party workers or non-cooperation of BJP workers at many places. The results clearly showed that there was no alliance at the ground level despite attempts made by the top leaders of both parties," said a senior

Sena leader. Another Sena leader said that the party faced anti-incumbency at a few places and also faced strong fight from the NCP in some

"Some of our candidates faced the antiincumbency. Also, change of candidates seems not to have worked in our favour." said the leader, pointing out that people did not vote for defectors from Congress and NCP who had joined Sena ahead of the polls and were given tickets by the party.

# In Latur (Rural) seat, NOTA is first runner-up with 27,500 votes

THE CONSTITUENCY of Latur (Rural) saw 27,500 voters choosing the 'None of the Above' (NOTA) option, the highest in the Maharashtra Assembly election. NOTA polled the second highest number of votes — accounting for 13.78 per cent of the total votes counted in the seat.

In the constituency, Congress candidate Dhiraj Deshmukh, son of former chief minister Vilasrao Deshmukh, got 1,35,006 votes (67%). After Deshmukh and NOTA, Shiv Sena's Sachin Deshmukh and VBA's Baliram Done polled 13,524 and 12,966 votes, respectively.

District election authorities, however, said they were not surprised by the high number of NOTA votes. An official said that a BJP candidate was expected to be given a ticket for the Latur seat, but eventually a Sena candidate was chosen due to the seat-sharing arrangement between the two alliance partners. Following this, there were protests by BIP workers in the district. Pamphlets were also found urging voters to choose NOTA.

> As per rules, even if NOTA is chosen more than any other candidate, the candidate who gets the maximum votes after NOTA — even if it is a single vote — will be declared a winner, the district authorities had clarified.

> Done, the candidate who stood fourth, alleged that the rumours about NOTA were politically motivated to discourage voters from electing him. So far, neither the Sena candidate nor the VBA or any other candidates have filed complaints on the alleged rumour.

Apart from Latur, Palus Kadegaon, which is part of Sangli Lok Sabha constituency, also saw a high number of NOTA votes — 20,631 or 9.9 per cent of the electorate. The winning NOTA was chosen more than any candidate apart from Kadam.

In Mumbai's Jogeshwari East constituency, 12,031 voters or over 8% chose the NOTA option, the highest in the city. The constituency comprises areas including Aarey Colony, where 2,185 trees were hacked for a Mumbai Metro car shed earlier this month. While many residents protested the tree-cutting, none of the groups, including the 7,000 adivasis living in the 27 tribal padas part of the constituency had, however, declared that they would be choosing NOTA as a protest vote. Shiv Sena's Ravindra Waikar, the incumbent MLA, won with a margin of 58,787

votes.

In 2014, when NOTA was used in the state for the first time in Assembly polls, the maximum NOTA votes recorded in the city were in Chandivali-4653, with Jogeshwari East

recording 2,038 NOTA votes. In 2013, the Supreme Court had directed the Election Commission to provide a button called None of the Above in EVMs, for those who come to the polling booth and decide not to vote for any of the candidates in the fray. The court had observed that the mechanism of 'negative voting' serves a fundamental and essential part of a 'vibrant democracy', and held that such an option gives the voter the right to express his disapproval with the kind of candidates being put up.


