### BJP, JJP join hands to form govt. in Haryana

Deputy CM post, RS seat for Dushyant Chautala's party

Union Home Minister and BJP president Amit Shah, along with Jannayak Janta Party (JJP) leader Dushyant Chautala, on Friday evening announced that the two parties would form a government in Haryana.

The Chief Minister will be from the BJP and the Deputy Chief Minister from the IIP.

The JJP's support to the BJP allows the saffron party to cobble together more than adequate numbers to stake claim to form a government.

#### **Comfortable numbers**

The Assembly election results, declared on Thursday, left the BIP six short of a majority. While eight victorious Independents have pledged support to the BJP, the 10 MLAs of the JJP have made the situation most comfortable for the party.

It would also help the BJP to avoid accepting the support of Gopal Kanda, the controversial MLA of the Haryana Lokhit Party, out on bail in a case related to the suicide of air stewardess Gitika Sharma.

"We respect the mandate given by the people of Haryana and have decided to come together to form the government," said Mr. Shah,

As many as 12 MLAs in the newly elected 90-member State Assembly have criminal cases against them, according to a Haryana Election Watch and Association for Democratic Reforms (ADR) report. Only nine MLAs had criminal cases against them in the previous House. Besides, only nine women have been elected this time, four less than in

Congress tops list

The Congress tops the list with four MLAs having a criminal record, followed by BJP with two. Both Indian National Lok Dal and Haryana Lokhit Party's lone winning MLAs face criminal cas-

Three of the seven Independents who are set to play a pivotal role in government formation also have criminal cases registered against them, serious one in the case of two.

Analysis of educational qualifications has revealed

that 62 MLAs - 69% of the total strength - are graduate or above, and 27 have declared their qualification as between primary and senior secondary level. As many as 57 MLAs are aged between 51 and 70 and only 10 are below 40 years of age. Seventeen MLAs are between 41 and 50 years of age; the remaining six are in the 71-80 age group.

### Gujarat firm wins consultancy bid to redevelop Central Vista

HCP Design, Planning and Management to be paid ₹229.75 crore for masterplan: Hardeep Puri

An Ahmedabad-based architecture firm that carried out the development of the Sabarmati riverfont in Gujarat in 2002 has been chosen to lead the Central government's ambitious revamp of Parliament and the Central Vista.

The Central government on Friday announced that it had chosen HCP Design, Planning and Management for its redevelopment of Parliament and Central Vista and the development of a new common central secretariat.

#### **Detailed planning**

The firm would now prepare a masterplan for the entire area, from the gates of Rashtrapati Bhavan till In-

For these services, it would be paid a consultancy fee of ₹229.75 crore, Union Housing and Urban Affairs Minister Hardeep Singh Puri said, adding that it was about 40% less than the initial estimate of ₹448

Mr. Puri said usually the consultancy fees are about 3% to 5% of the total project cost. However, he said the final cost of the project would be determined by the tendering process for the projects, which he said would be on the ground by May

Central Public Works Department officials said the usual formula may not be applicable to this project, with two officials saying a rough estimate was ₹12,450 crore.

#### **Public consultations** Before the masterplan and

designs are locked in, Mr. Puri said the firm would have public consultations. The government has set the deadlines of November 2021 for the revamp of the 3-kmlong Central Vista, March 2022 for the redevelopment of Parliament and March 2024 for the construction of the common central secretariat for ministries Speaking about the need

for the revamp, Mr. Puri said the buildings, like Parliament House and North and South Blocks, were constructed around 100 years ago and did not have the space and amenities needed today. The redevelopment of

Parliament would add offices for all MPs and could include a new building connected to the existing heritage structure with a walkway, he said.

He reiterated that the Parliament, North and South Blocks would not be demolished, unlike some of the government offices constructed post-Independence, but their usage could change.

activist Anjali Bharadwaj of the Satark Nagrik Sangathan said the government had amended the RTI Act in July and had not issued the prescribed rules for nearly three months after the amendment received the President's assent on August 1. She said the rules had been drafted and promulgated in a "completely surreptitious manner in flagrant violation" of the procedures laid down in the Pre-Legislative Consultation Policy of

"The policy requires all draft rules to be placed in the public domain for comments/suggestions of people. The draft was not available in the public domain and no consultations were held with members of the public," the citizens' group said in a statement.

Among new rules, the government has been given the "power to relax" their provisions, which raised "serious concerns that the government could potentially invoke these powers to determine different tenures for different Commissioners at the time of appointment",

### Diwali fails to bring cheer to traders: CAIT

'Less turnout even on Dhanteras'

Confederation of All India Traders (CAIT) on Friday complained that the festive season had failed to bring cheers to retail markets due to continued "customer slowdown". "The slowdown in com-

mercial markets of the country continues even today and also hit the sales on Dhanteras, the day which is considered as the most auspicious day to buy gold or silver jewellery, utensils and kitchenware. There is gloomy atmosphere in almost all the outlets as people didn't turn up as expected," the union said in a statement, adding that market observers said that it is perhaps the most disappointing festival day in the last 10 years.

Pankaj Arora, head of the iewellery committee of CAIT said that gold and silver trade touched a record low

on Friday with an unprecedented 35%-40% decline in sales. He added that the bare minimum sale of these goods were "namesake purchases" on account of Dhanteras.

CAIT president B.C. Bhartia attacked e-retailers for "unethical business practices", which he said had wrecked retail trade. Coupled with a liquidity crunch. Diwali held no meaning for traders this year, he said.

# Kejriwal flags off 104 new standard-floor CNG buses

Vehicles feature CCTV cameras, panic buttons, among others

Chief Minister Arvind Kejriwal on Friday flagged off 104 new standard-floor CNG buses, which the government said feature modern technology, including CCTV cameras, panic buttons and hydraulic lifts for differently

abled passengers.
"I want to congratulate the people of Delhi on the arrival of 104 new buses on the roads of the city. It is a huge step towards providing convenience to the people and will strengthen Delhi's public transport," Mr. Kejriwal said.

This is the second lot of buses from the total of 1,000 standard-floor CNG buses that started being delivered last month from the Delhi Transport Corporation depot in Dwarka. Earlier, he had flagged off 25 such buses in

"On one hand, new buses

will be running on the roads read of Delhi and on the other hand, women will be able to access free bus rides starting from October 29.The government will also deploy bus marshalls within the next week to ensure the safety of women," he added. According to the government, six of the new buses will be deployed on the Nangloi to Mehrauli route, six will ply between Najafgarh and Safdarjung Terminal, 20 between Nangloi and Badarpur Extension and 19 between Qutubgarh Border and Old Delhi. Similarly, 15 buses will ply between Uttam Nagar and Kapashera Border, 12 from Qutubgarh to Fatehpuri, 12 from Najafgarh to Azadpur, 8 between Kanjhawala and Azadpur in addition to 4 from Najagfarh to Narela. In addition to these, 1,000 low-floor AC buses are also being in-

ducted in the cluster scheme, opened," it added.

"The contract of 650 low-floor buses has already been awarded by the Department of Transport for three clusters and these will start coming from January 2020," the statement said, adding that the tender for the remaining 350 buses was being floated soon.

The tentative schedule of induction of 650 low-floor AC buses entails the induction of 60 buses in January 2020, 104 in February, 130 in March, 160 in April and 196 in May. "The government is also inducting 1,000 electric buses. In the 1st phase, the tender for 300 electric buses was floated on October 15. The last date for submission of bids is November 13, 2019. The financial bid for 1,000 low-floor, AC, CNG-run cluster buses has also been

### Air quality likely to plunge to 'severe' category after Diwali

Impact to remain for a short period with about 'half' the magnitude of 2018 Diwali

STAFF REPORTER

The air quality of Delhi is likely to spike to "severe" category in the wee hours of Monday due to the effect of firecrackers on Diwali night. But it will be for a short period with about "half" the magnitude of Diwali in 2018, according to governmentrun monitoring agency, System of Air Quality and Weather Forecasting and Research (SAFAR).

The level of PM2.5 (deadly respirable fine particles) is also expected to be less on Monday, a day after Diwali, than in the last three years.

"Higher boundary layer winds are likely to flush out the expected high impact of firecracker emissions," SA-FAR said.

Meanwhile, the air quality of Delhi on Friday improved slightly to the upper end of "poor" category but is expected to fall to "very poor" category on Sunday. The Air Quality Index (AQI) was 284

"The highest impact of firecracker emissions is expected in the early morning of October 24 [1 a.m.- 6 a.m.]. In a normal course, the stubble burning induced impact is expected to be moderate," SAFAR said.

The boundary layer and surface winds are likely to intensify by October 27 and may sustain for the next two days, which will not allow accumulation of pollutants due to stubble burning, said SA-

#### **Less emission**

SAFAR had considered two scenarios in its Diwali prediction: First, zero firecracker emissions and second, 50% of average firecracker emission of 2017 and 2018. Under the first condition.

the AQI will remain in "very poor" category on Monday and under the second it will spike to "severe", but the second condition is more likely to happen.

"We considered 50% of the average emission of 2017 and 2018 as only green crackers are allowed this year and their emissions are lesser by about 30-40%. On top of that due to increased awareness, we expect a dip of about 10% in use of firecrackers and hence the emissions are expected to be 50% less than last two years," a SAFAR official told The Hindu.

But, SAFAR also cautioned that pollution could be higher. "Combination of several rapidly changing weather parameters play a role in controlling the air pollution at this time and dynamics changes, even if one parameters behaves erratically," it said.

### PMO tells States to address stubble burning issue

Meeting held to oversee implementation of Graded Response Action Plan

SPECIAL CORRESPONDENT

The Prime Minister's Office (PMO) has instructed Punjab and Harvana to address the issue of stubble burning. P.K. Mishra, Principal Secretary to the Prime Minister chaired a meeting on Thursday night with members of a task force that oversees implementation of the Graded Response Action Plan (GRAP), government sources confirmed to The Hindu.

Officers from these two States have committed to the PMO that they would immediately deploy as much machinery as possible to address stubble burning.

The meeting was also attended by representatives of the Delhi government, municipal bodies of Delhi, experts from the Indian Institute of Technology-Delhi, The Energy Resources Institute and the Ministry of Environment and Agriculture

According to Friday's assessment by weather forecast agency SAFAR, the impact of stubble burning from Haryana & Punjab is "moderate but gradually increasing." Experts had earlier said that this weekend is particularly crucial for air quality due to Diwali which will see bursting of crackers as well as heightened traffic.

#### Dip in AQI from Nov.

The relative contribution of the particulate matter due to stubble burning has increased in the last week from the beginning of the month. However, experts said that a significant dip in air quality, primarily due to unfavourable weather conditions is fo-

On Thursday, the GRAP Task Force recommended that hot mix plants, stonecrushers and construction activities that generate dust are prohibited from October 26 to 30 in Delhi and its satellite towns, a committee overseeing the implementation of GRAP said on Thursday.

Coal-based industries, except power plants, would also have to cease operations on those days in Delhi as well as the satellite towns of Faridabad, Gurugram, Ghaziabad, Noida, Greater Noida, Sonipat and Bahadurgarh.

#### **EPCA seeks** intervention of apex court in pollution fight

The Supreme Court-appointed Environment Pollution (Prevention & Control) Authority (EPCA) on Friday urged the apex court to issue "urgent" directions to Delhi, Haryana, Uttar Pradesh and Ragovernments iasthan against polluting activities in those States.

The issues includes, massive quantities of plastic, industrial waste being dumped on vacant land and then burnt; dust from construction sites and industries visibly emitting black smoke among oth-

Meanwhile, Delhi Chief Secretary, Vijay Dev, chaired a meeting on air pollution and directed officials to take necessary actions.

"The municipal corporations of Delhi were asked to use chemical dust suppressants on dusty areas on a pilot basis. Also the Chief Secretary ordered to increase mechanised sweeping and water sprinkling in all 13 hotspots," a government official who attended the meeting told *The Hindu*.

The official also said that the government will be forming teams to check the construction ban to be in place from 6 a.m to 6 p.m. from October 26-30 and also to intensify night patrolling.

### Rajasthan results a major setback for BJP

Party loses Mandawa seat to Congress, had to be content with poll partner RLP's win in Khinvsar

The results of by-elections to two Assembly constituencies in Rajasthan have come as a major setback to the Bharatiya Janata Party, which lost the Mandawa seat to the Congress and had to be content with the Rashtriya Loktantrik Patry winning the Khinvsar seat as its newly formed alliance partner. The massive defeat has exposed a rift in the Opposition party, which is facing resentment among its workers.

Congress candidate Rita Chaudhary won the Mandawa seat in Jhunjhunu district by a huge margin of 33,704 votes, defeating her nearest nearest rival, BJP's Sushila Sigra, while RLP candidate Narayan Beniwal scored victory in Nagaur district's Khinvsar by defeating Harendra Mirdha of the Congress by a margin of 4,630 votes.

Ms. Sigra, pradhan in the

Jhunjhunu Panchayat Samiti, was earlier expelled from the Congress and was inducted into the BJP a few hours before she was fielded as the party's candidate. The BJP's decision left the party workers disappointed and they did not take part actively in her election campaign.

BJP State president Satish Poonia said on Friday that while the party workers

wanted Jhunjhunu MP Narendra Khinchar's son to be fielded from Mandawa, the high command was strictly against the culture of promoting the family legacy. Mandawa has been the Congress' bastion since the first Assembly election held in 1952 and the BJP won the seat only once, in 2018, when Mr. Khinchar was elected.

In Khinvsar, the BJP did not field any candidate and supported RLP's Narayan Beniwal, younger brother of Nagaur MP Hanuman Beniwal, with whom it had hurriedly formed an alliance just before the 2019 Lok Sabha election. With the younger Beniwal's victory, the entire credit has gone to Mr. Hanuman Beniwal, who has been three-time MLA from Khinvsar.

The thin margin with which Mr. Beniwal won also depicted the tough fight put up by the Congress in the constituency. Congress candidate Mr. Mirdha, belonging to the politically influential Mirdha family of Nagaur, displayed his capacity to sway the Jat votes, though he was denied the party's ticket in the 2019 Lok Sabha poll.

Former Chief Minister Vasundhara Raje, apparently miffed over the alliance with the RLP, distanced herself from campaigning in both the constituencies. Mr. Hanuman Beniwal had floated the RLP a few months before the 2018 Assembly election after leaving the BJP following his differences with Ms. Raje.

#### Beniwal's accusation

Mr. Beniwal has accused Ms. Raje and her close confidant, former Minister Yunus Khan, of helping out the Congress candidates in both the Lok Sabha election and the Assembly bypolls despite the alliance with the RLP. "Senior BJP leaders should take strict action against Ms. Raje and Mr. Khan," he tweeted on Friday.

Chief Minister Ashok Gehlot said the by-election results had "shown the mirror" to the BJP, which had raised misleading issues in the campaign rather than talking about people's problems and their real concerns.

# VBA, AIMIM difference between Cong., NCP and victory in 20 seats

Votes polled by former allies similar to winning margin of Shiv Sena, BJP candidates

Though the Prakash Ambedkar-led Vanchit Bahujan Aghadi (VBA) fielded candidates in over 250 seats in the Assembly polls, not a single one of them emerged victorious when the results were declared on Thursday.

Meanwhile, VBA's former alliance partner, the All India Majlis-e-Ittehadul Muslimeen (AIMIM), contested 44 seats and was able to win only two seats. By going solo in the polls, the parties split the votes and stood in the way of the Congress and the Nationalist Congress Party (NCP) crossing the victory line in over 20 seats across the State. In several seats such as Nandgaon, Chandivali, Ulhasnagar, Pune Cantonment, Shivajinagar and Paithan, where the Congress and the NCP lost by slender margins, the votes polled by the VBA were often close to the margin of victory of the Shiv Sena or BJP candidate.

The VBA stood second in 10 seats and claimed the third spot in 23 seats in the State. In Nandgaon, the VBA polled 13,637 seats, where sitting MLA Pankaj Bhujbal of the NCP lost to the Sena's Suhas Kande by a margin of 13,889 votes. The party split votes in Jintur, Paithan, Ulhasnagar, Daund, Chalisgaon and Khadakwasla, where the NCP candidates lost by narrow margins.

#### Blow to fortunes

The AIMIM's entry into the electoral fary hit the NCP the hardest in Balapur. The AIMIM was contesting the seat for the first time and received the lion's share of the Muslim vote, polling nearly 44,507 votes. The NCP was relegated to the fourth position with 16,497 votes in the

constituency, which was won by the Sena's Nitinkumar Tale. The VBA stood second with 50,555 votes.

The VBA and the AIMIM also adversely affected the fortunes of the Congress. The impact was felt the most in Chandivali, where Naseem Khan of the Congress lost by a slender margin of 409 votes. The VBA and the AIMIM had both fielded Muslim candidates and they polled 8,876 votes and 1,167 votes respectively.

The AIMIM entered into a

direct contest with the Congress in Malegaon Central and won the seat for the first time. In Nanded North, AI-MIM's Feroz Lala polled 41,892 votes, resulting in sitting MLA D.P. Savant of the Congress losing to Sena's Balaji Kalyankar by a margin of 12,000 votes. The VBA stood fourth in the constituency with 26,569 votes.

Late Congress leader Vilasrao Deshmukh's sons, Dhiraj and Amit, have emerged victorious from Latur Rural and Latur City respectively. In Solapur district, NCP's Baban Shinde and his brother Sanjay have won from Madha and Karmala respectively. While Baban retained his Madha seat, defeating Shiv Sena's Sanjay Kokate by a margin of 68,245 votes, Sanjay contested as an NCP-backed Independent in Karmala, defeating Sena rebel Narayan Patil by a margin of 5,494 votes.

Vilasrao Deshmukh, who was chief minister between 1999-2003 and 2004-2008, nurtured his home district in during his decades-long political career. For Dhiraj, it was a maiden win by a margin of 1.21 lakh votes, while Amit retained Latur City for a third consecutive term.

Among the Shinde brothers, Baban has been elected from Madha for a sixth term. Sanjay was the NCP candidate from the Madha Lok Sabha constituency, where he was defeated by Ranjit Nimbalkar, who switched over to the BJP from the Congress in May.

### Accused in Walayar rape case acquitted

Prosecution fails to prove their involvement in the case

A POCSO (Prevention of Children from Sexual Offences) court here on Friday set free three men who had been accused of raping two sibling girls and abetting their suicide at Attappallam, near Walayar, in the district.

The case had run into a controversy as the police officers who investigated it initially faced allegations of helping the accused.

Additional district judge (I) S. Muraleekrishna, who is the POCSO judge in Palakkad, exonerated V. Madhu, alias Valiya Madhu, 27, from Attappallam; Shibu, 43, from Rajakkad, Idukki; and M. Madhu, 27, alias Kutty Madhu from Pampampallam, as the prosecution

failed to prove their involvement. There were five accused in the case. One of them, Pradeep Kumar, was earlier set free by the court. The fifth accused is a minor, whose trial will come up before a juvenile court next

#### 'It is unbearable'

The girls' mother was apparently heartbroken on hearing the judgment. "It's unbearable," she said crying in despair. She said neither the lawyer nor the policemen had informed her about the date of the judgment.

The two siblings were found hanging in their house at Attappallam on different days in 2017. When the 13year-old girl was found dead on January 13, 2017, her nine-year-old sister was found hanging on March 4, 2017.

The police launched an investigation after the postmortem reports said that both of them had been raped. A police team led by Deputy Superintendent of Police M.J. Sojan had carried out the final investigation and prepared chargesheet.

The sub-inspector of the Walayar police station had faced suspension for ignoring pieces of evidence. A departmental inquiry had been ordered against a circle inspector and two Deputy SPs in connection with the case. The suicide of a man, who had been questioned by the police, added sensation to the case.

### 7 more held for Alliance varsity ex-VC's murder

The Bengaluru police have arrested seven more people, including two women, who were allegedly part of the conspiracy to murder the former Vice-Chancellor of Alliance University, Ayvappa Dore. He was murdered while taking a walk at the HMT playground near his house in R.T. Nagar on October 15.

The accused have been identified as Kantharaju, 28, a drummer; Sunil Rao, 31, an executive in a private bank; his brother-in-law, Arun Kumar, 40; Fayaz, 29, a mechanic from J.C. Nagar; and Vinay, 24, cab driver also from J.C. Nagar.

The women have been identified as Fayaz's sister Rizwana, 38, and Salma, 28, a dance bar girl who was in a relationship with one of the prime accused in the case, Suraj Singh.

"Four of the accused actively took part in the reconnaissance and attacked Dore with lethal weapons along with Suraj, killing him on the spot," said a police officer. Suraj had allegedly been promised ₹1 crore by the Chancellor and co-founder of Alliance University, Sudhir Angur, to murder Dore. Sudhir had also instructed him to murder his brother and varsity co-founder Madhukar Angur so that he could gain control over the varsity, the police said.

The Central Bureau of Investigation, on a direction by the Kerala High Court, has registered an FIR to probe the killing of two Youth Congress leaders in Kasargode earlier this year due to an alleged political rivalry.

Kripesh, 21, and Sarat Lal, 24, were murdered on February 17 at Periya village. The case was earlier instituted by the Bekal police, on a complaint from one K. Sreekumar, a resident Kasargode.

The complainant alleged that the two were killed by CPI(M) workers. A day later, the investigation was hand-

ed over to the Crime Branch. The probe team filed a chargesheet on May 20 against the accused persons, including Peethambaran. A and 13 others. The case was committed to the principal sessions court in Kasargode and 11 persons are currently in judicial custody. The remaining three are out on bail, according to the FIR.

The victims' parents had approached the High Court seeking a reinvestigation of the case by the CBI. On September 30, the court transferred the case to the central agency, while setting aside the chargesheet filed by the Crime Branch.



### CSIR offers free mapping of Indian genomes

Anyone looking for a free mapping of their entire genome can sign up for the IndiGen initiative, a programme managed by the CSIR-Institute of Genomics and Integrative Biology (IGIB) and the CSIR-Centre for Cellular and Molecular

Biology (CCMB). Those who do get their genes mapped this way will get a card and access to an app, which will allow them and doctors to access "clinically actionable information" on their genomes.

The programme is a culmination of a six-month project by the CSIR in which 1,000 Indians had their genomes scanned in detail. They were chosen from across the land to represent the width of genetic variabil-The aim of the exercise

was twofold: to test if it's possible to rapidly and reliably scan several genomes and advise people on health risks that are manifest in their gene and to understand the variation and frequency of certain genes that are known to be linked to dis-

ease. However, not everyone who signs up will be guaranteed a scan.

### A delayed imperative

The move to revive BSNL and MTNL and merge them comes at a crucial time for the industry

The Cabinet's approval this week for a plan to revive the loss-making public sector telecommunications providers Bharat Sanchar Nigam Ltd. (BSNL) and Mahanagar Telephone Nigam Ltd. (MTNL) has come not a moment too soon. From having been monopoly providers of telephone connectivity, the state-run telcos have had to contend with sweeping change since the opening up of the industry to private players and entry of wireless telephony in the 1990s. In just over two decades, the mobile phone revolution has catapulted India to the second rank in terms of wireless subscribers, with only China ahead. But the radical transformation of the industry landscape – wrought by the runaway growth in user numbers, rapid technological advances, and bruising competition - has come at a substantial price. The private sector saw the relatively older, large firms using mergers and acquisitions to consolidate as smaller rivals found themselves unable to cope with bitter tariff wars and the capital costs of bidding for spectrum and upgrading their technologies. BSNL, for its part, was saddled with the legacy of having been a large-scale provider of jobs as well as state-mandated connectivity to remote corners of the country. It is in the fulfilment of the state's social objectives that the public sector enterprises (PSEs) racked up substantial costs, which the Centre's revival plan aims to help

The proposal includes the allotment of critical spectrum to the two PSEs for offering fourth-generation wireless services, including broadband. The Centre will fund the spectrum's cost through an infusion of ₹20,140 crore of capital while also bearing the related GST levy of ₹3,674 crore. And besides providing a sovereign guarantee on ₹15,000 crore of long-term bonds, which would help the firms restructure debt and partly fund expenses, the government will extend budgetary support of ₹17,169 crore for ex-gratia payments on a crucial voluntary retirement scheme. A lot will hinge on this VRS plan given that BSNL's workforce of over 1,65,000 employees end up cornering about 75% of the telco's total income. The Cabinet has also given an 'in-principle' nod for the two PSEs to merge, a move that would add market heft to the merged entity. A successful revival of BSNL will have far-reaching implications for the industry, this at a time when two of the three surviving private players are faced with not only sliding market share but a government bill of about ₹75,000 crore following the loss of a legal challenge. The reach of its network, especially in remote parts, makes BSNL a "strategic asset" that has national security implications given its role in serving the armed forces and responding to natural disasters. The revival plan, even if years late, is a clear recognition by the government of this indisputable fact.

### **Cutting risk**

Though India has excellent polio immunisation coverage, there is no room for complacency

The world polio day on October 24 marked an important milestone in the war against polio when the Global Commission for the Certification of Poliomyelitis Eradication officially declared that wild poliovirus type 3 has been eradicated. The last case of wild poliovirus type 3 was seen in northern Nigeria in 2012. This is the second wild poliovirus to be declared eliminated – the first was in 2015 when type 2 wild poliovirus was declared as eliminated. With two of the three wild polioviruses eliminated, only type 1 wild poliovirus is still in circulation and is restricted to just two countries - Afghanistan and Pakistan. As on October 23, there were 18 cases of polio caused by wild virus type 1 in Afghanistan and 76 polio cases in Pakistan this year. While the number of cases reported this year from Afghanistan is quite close to the 21 reported last year, there has been over six-fold increase in the number of cases in Pakistan. Though India has excellent polio immunisation coverage and measures have been put in place to prevent the spread from polio-endemic countries, there is no room for complacency.

What does the official declaration of wild type 3 poliovirus elimination mean in the war against polio? Put simply, it opens up the possibility of switching from the currently used bivalent oral polio vaccine containing type 1 and type 3 to a monovalent vaccine containing only type 1. The globally synchronised switch in April 2016 from a vaccine containing all the three types (trivalent) to a bivalent vaccine was done to reduce the number of vaccine-derived poliovirus (VDVP) cases. Until 2015, the type 2 strain in the trivalent oral vaccine accounted for over 90% of VDVP cases globally. While the type 3 poliovirus in the vaccine is the least likely to cause vaccine-derived polio, it has the greatest propensity to cause vaccine-associated paralytic polio (VAPP). Though the risk of VAPP is small, it is caused when the live, weakened virus used in the vaccine turns virulent in the intestine of the vaccinated child or spreads to close contacts who have not been immunised. VAPP can be greatly reduced if there is a switch from the bivalent to a monovalent vaccine containing only type 1. Alternatively, the risk of VAPP can be reduced 80-90% if every child receives the bivalent vaccine and one dose of inactivated polio vaccine injection. Though India does not count VAPP cases, a 2002 paper and a communication indicated that India had 181, 129 and 109 cases in 1999, 2000 and 2001, respectively. A recent paper suggests that post 2016, India might have 75 VAPP cases annually due to global IPV vaccine shortage and "delay in IPV implementation in India's national immunisation programme".

### India's big foreign policy shake-up

The Modi government's hyper-activism marks a clear break with the past. But is it also backed by an underlying vision?



ndia's foreign policy is undergoing a series of fundamental transformations in terms of its underlying narratives, processes and desired endgames. There is a conscious and consistent effort to break with the past, no matter how the outcomes might look

What could potentially make this change last longer than initially thought is that Prime Minister Narendra Modi has the mandate, the capability and the willingness to effect major changes and reconceptualise the country's external security orientation. And yet, one must ask: Does this really mark a fundamental policy shift or does it just amount to a slew of optics-friendly acts that are well-choreographed but not visionary?

#### Taking risks

One of the most striking features of the Modi government's foreign policy is its propensity for risk-taking – quite unlike most previous governments barring perhaps that of Indira Gandhi. Armed with a clear majority, the government is keen to play offensive, undoing the decades-old defensive Indian strategic behaviour. New Delhi's actions at Doklam; its surgical strikes against Pakistan in 2016 after the Uri terror attacks; and the Balakot air strikes in the wake of Pulwama attacks this February notwithstanding the questionable material outcomes in all these cases - are examples of this newfound offensive streak and risktaking tendency.

The August 5 decision by the Central government on Jammu and Kashmir (J&K) to read down Article 370 was also a risk-ridden move. When previous governments engaged in offensive behaviour, they couched it in normative language. Today, speech is act

A high-pitched rhetoric around Pakistan, J&K and terrorism complements the Modi regime's propensity for risk-taking even as these themes remain the mainstay of its foreign policy. There are unfailing invocations to these themes in almost all forums where India is represented as well as in bilateral meetings with countries ranging from the U.S. to New Zealand.

In an overstated manner, then, terrorism and Pakistan have come to dominate our foreign policy pursuits, instead of other forward looking and system-shaping narratives. One wonders whether this unrelenting obsession would require compromises by the government in its negotiations with other countries in return for their pro-India stance, which is rapidly running out as days pass by.

The fixation with terror, Pakistan and J&K also means that the country's valuable political and diplomatic capital as well as its accumulated goodwill in the comity of nations would have to be spent on tactical goals.

#### Clarity at the cost of nuance

Mr. Modi's foreign policy, for the most part, has displayed unprecedented doses of clarity, though often at the cost of nuanced approaches to complex issues. New Delhi appears, and certainly claims, to know what it wants, is willing to pursue it doggedly, and to pay the associated costs. In politics and foreign policy, there has traditionally been some distance between rhetoric and reality, but in this case, rhetoric seems to closely resemble reality. While past governments tried to balance their rhetoric and reality – for instance, when it comes to India's relations with Israel – the present government's policy resembles its rhetoric, with on occasion rhetoric forcing policy choices. A clear

example of this rhetoric-reality match is found in India's ties with the U.S. - the two are unprecedentedly close and despite its nativist leanings, the present regime seems to offer no excuses or qualifiers for getting so close to a superpower, for it knows that hardly any challenges are posed to its foreign policy pursuits in the domestic sphere. Consequently, there is little talk of 'strategic autonomy'.

However, too much clarity tends to blur out some muchneeded nuance. Take, for instance, New Delhi's apparent inability to play a noteworthy role in the emerging Afghan geopolitics at a crucial time such as this. It is imperative, as many commentators have pointed out, to engage the Taliban, which is bound to be a dominant actor in Afghanistan in the days ahead. And yet, New Delhi is unable to reach out to the group thanks, at least partly, to its hyperventilating and un-nuanced positions on extremism and terrorism. How can India talk to the Taliban and at the same time remain adamant that it won't engage the many militant groups or even the proautonomy voices in J&K?

India's foreign policy has traditionally been, for the most part, couched, if not always practised, in a normative grammar. It desired to practise a normative foreign policy, often struggled to match its rhetoric with its actions, and more often seemed uneasy with the mismatch. As a consequence, New Delhi often refused to act with determination; the use of raw power for political outcomes was tempered with normative language when it did act; and deliberate ambiguity was deployed when this posed a moral dilemma. This moral sheen has seemingly come off now, by design.

New India's foreign policy has not only given up the Nehruvian normative angst but has even shunned the pretences of normative behaviour. Economic and military power today are seen as tools to gain advantage vis-à-vis others, be it neighbours or the larger international system. To that extent, there is a strong link between internal and external posturing, unlike in the case of most previous governments which made a deliberate attempt to be internally liberal and externally realist.

#### Weighing domestic costs Foreign policy, for the Modi go-

vernment, is a two-level game, to paraphrase political scientist Robert Putnam. While traditionally, foreign policy has had little impact on domestic political outcomes, today, given the manner in which external behaviour has been domestically politicised, the leadership seems to weigh the domestic costs while making foreign policy decisions. More to the point, foreign policy decisions are often undertaken to cater to domestic opinion. To that extent then, audience costs will continue to determine Mr. Modi's foreign policy choices.

Being cognisant of the domestic political implications of foreign policy behaviour in the age of mass communication and social media is understandable. But the flip side is that it leads the leadership to a commitment trap as well as binds its hands when the external circumstances demand a change in behaviour.

Domestic politicisation of foreign policy also instils a 'winnertakes-all' mentality in the ruling dispensation, thereby shrinking the domestic space for consensus building. Looking similar to the Opposition, which domestic consensus building in a way leads to, doesn't help the government in the eyes of the public but looking different does win it brownie points. This is already making the Opposition irrelevant, and decision making is centralised.

Is there, however, an underlying vision to India's new foreign policy? For instance, does India's hyper-activism on the foreign policy front enable it to be a systemshaper and a global rule-maker or is it still a rule-taker? What, in that sense, are the big foreign policy achievements of this government à la, for instance, the India-U.S. nuclear deal of the United Progressive Alliance (UPA) vintage? Are membership of the Nuclear Suppliers Group (NSG) or the UN Security Council in the offing? Or has our diplomacy resolved any of our key conflicts? For, after all, it's the foreign policy outcomes that we should not lose sight of.

### When the abstract destroys the physical being

Human rights should not be defined on the basis of religious, national or cultural differences



There are families in South Asian nations who would kill their child - usually a daughter – for the sake of 'family honour.' Here, the concept of 'family' is detached from its constituent: the daughter. In order to 'preserve' the concept of 'family,' such families actually kill their children – or, at least, rob them of a chance to lead the life that would make them happy. I, for one, have never understood how one can destroy the physical fact of a family – a child, who is always a link to the future for any family - for the abstract concept of a family.

But, of course, this happens at larger levels too. We kill or hound people who believe differently in our religion for the sake of that religion. We persecute and brutalise citizens who have a different vision of our nation for the sake of that 'nation'.

#### **Caste violence**

Recently, I read of Dalit children being beaten to death for defecating in the open. Apart from the

caste violence that this exposed, it struck me with force that the necessary movement to stop open defecation is being misunderstood by many Indians. It is being seen in terms of prestige, when actually it is a matter of health and welfare.

Open defecation is bad not be cause it reduces the prestige of our nation in the eyes of passing tourists or journalists. It is revealing that nationalists who claim to be inordinately proud of our 'Indianness' should be so inordinately conscious of the opinions of foreigners, usually white. No, open defecation is bad because of the health hazards it poses – not only in terms of diseases, but also in terms of what it does, physically, to those who do not have access to decent toilets. There are scientific papers that have highlighted the connection between open defecation and low nutrient levels in children. To brutalise someone forced by circumstances to defecate in public makes the concept of 'national prestige' more important than the person of national citizens. But what is a nation without its citizens? This is similar to killing a daughter for the sake of family honour.

One of the greatest drawbacks of idealist definitions of 'religion' or 'nation' is actually this: the concept takes over and destroys the



human being. It is also in this context that one needs to be very adamant about not defining 'human rights' on the basis of religious, national or cultural differences.

**Universal rights** If this sounds like a contradiction to what I have said about abstract concepts until now, let me rephrase it: just as a family cannot be separate from or above family members and a nation can only be its citizens, human rights have to be rooted in the actual biological existence of human beings in society. Various other rights may differ from society to society, but basic human rights have to be the same across all such differences. If differences of nationality, culture,

gender, colour, sexuality, etc. mean that basic human rights have to change across these categories, then we are basically arguing that realities. This has often been the argument of racists in the past, and is sometimes assumed by extreme sexists today: the former have denied the 'humanity' of certain races, and the latter implicitly reduce the 'humanity' of women.

This has always been my main objection to those religious Muslims, some of them friends and even relatives, who justify a different standard of treatment for women. As long as these standards do not limit the human scope of women – which means their right to have the same access to shelter, food, inheritance, reproductive rights, education, and freedom of movement as men – I am willing to accept it, just as I am willing to accept the fact that in India we drive on the left while in Denmark we drive on the right.

But basic human rights – that is, access to shelter, food, inheritance and reproductive rights, education, and freedom of work and movement – cannot be denied on the basis of gender differences, just as they cannot be denied on Tabish Khair is an Indian novelist and the basis of 'race'. It is a pity that

today, in India, there are politicians who do not seem to realise this. To claim differences of basic human rights on the basis of diffethe 'human' does not exist, or it rence of culture or nationality is to exists only as an abstract concept, fall into the same trap than many un-rooted in biological and other Muslims have fallen into with reference to their understanding of their religion. And it is a double pity, because just as the sacred texts of Islam can be read in ways that are compatible with human rights, the history and cultures of India can also be read in ways that are compatible with human rights. The choice is always ours.

However, it is not a choice that many in power are willing to give to us. The reason for this is simple. I will illustrate it with reference to my original example: if you are a patriarch running your family with an iron hand, your power depends almost entirely in using the abstract and alienated notion of 'family' against the actual opinions, desires and experiences of flesh-and-blood family members. And you would be willing to occasionally sacrifice a family member to maintain this power. In that sense, finally, whether it is a family or a nation, human rights are inseparable from a full understanding of democracy.

### A lifeline called Jan Soochna

On September 13, the Rajasthan government launched Jan Soochna, a single window portal hosting information and databases on 32 different schemes of 13 departments. **Priscilla Jebaraj** reports on how the initiative is empowering people, especially villagers who have been denied entitlements

n early 2018, Tolaram Kumhar, 73, suddenly stopped getting his pension Lof ₹750 per month. "I went to the bank after a while, but they didn't have any answers. I didn't know what to do until Baluji came," he says, holding a creased booklet that documents the saga of his pension payments. Tolaram gestures to the man sharing the charpoy with him on a breezy October evening. "Baluji looked up information on his phone and found that I had been removed from the government's pension list," he says. Why? "Because they said I was dead.'

Tolaram, who wears a torn blue Tshirt and a dirty white dhoti, spends most of his days in a small hut located high above the fields and grazing grounds of Thana village in Bhilwara district of Rajasthan. The land looks lush, but excess rainfall in this typically water-starved region has destroyed the maize crop this year, leaving marginal farmers and agricultural workers like him on the brink of destitution and deeply dependent on the government's pension scheme for basic sustenance.

It is people like Balulal Gujjar, popularly called Baluji, who have come to the rescue of people like Tolaram. Baluji is dressed in an intricately tied white dhoti, pleated white kurta-jacket, a silver neckband, and a red turban. He has been a social activist with the Mazdoor Kisan Shakti Sangathan (MKSS) for half of his 62 years. Now an elected ward member in Thana, Baluji with his faded pink jhola is a familiar sight to villagers for 30 km around.

Baluji carries a well-used Samsung smartphone in his pocket, through which he accesses the Jan Soochna (public information) portal, which is the Rajasthan government's latest effort to offer wider and easier access to the State's increasingly digitised databases. The single window portal aims to increase transparency and accountability in governance. It has 82 different information request options for 32 schemes across 13 departments. It not only explains the schemes but also provides real-time information on beneficiaries, authorities in charge, progress, etc. Jan Soochna was launched with great fanfare by Congress Chief Minister Ashok Gehlot in Jaipur on September 13. Different elements of the portal have been on trial for more than two years, with gradual public access to databases being provided under the previous regime of BJP Chief Minister Vasundhara Raje.

For example, in 2017, MKSS activists got access to a list of 10 lakh people across the State who had been excluded from the government's pension scheme when the payment system switched from the post office to Aadhaar-linked bank accounts. Overnight, the number of pensioners dropped from 68 lakh to 58 lakh. According to the government, almost three lakh of the excluded names were dead, while another two lakh were fake or duplicates.

By painstakingly tracking down names from the list of the supposedly dead, activists like Baluji found that thousands of people like Tolaram had been wrongly excluded. "We sent in the papers to show he is alive, and finally they restarted his pension three months ago," says Baluji. He navigates search queries and Excel sheets on his phone with a fluency that is enviable in a 62year-old who has only studied till Class 8. "See, he got ₹8,000 worth of back pay, pensions unpaid for 11 months, on July 25, 2019," Baluji points to the screen. Tolaram cannot read the information there, but nods vigorously with a gap-toothed smile. "Overall, I have helped people who were denied pensions get more than ₹80,000 worth of unpaid pensions," says Baluji. In the neighbouring Bhim tehsil alone, more than 1,300 wrongly excluded names were added back to the pension scheme after a re-verification exercise. "It is only possible because we are able to see this information in detail," Baluji says.

#### Digital Dialogues, the beginning

Over the last five years, Rajasthan has been digitising and integrating databases, including flagship social sector schemes, using Aadhaar-based verifications and payments. In 2017, the Department of Information Technology and Communication (DoITC) began to host 'Digital Dialogues'. Bimonthly meetings were held with interested citizens including activists from MKSS and the wider collective of the Soochna Evam Rozgaar Adhikar Abhiyan, to discuss how to open access to such databases and present them for public use.

"Digital Dialogues was the real beginning of the Jan Soochna portal," says R.K. Sharma, an additional director who oversees the project. Sharma joined the DoITC in 1988, the year it was formed, and can speak at length about the State's efforts to use "technology for integrated service delivery" over the last three decades. "Through our discussions with citizens and activists, we developed this portal to share whatever real-time, individual-level data are

needed by the common man, to reduce corruption and to increase transparency of governance."

In the month since its official launch. the Jan Soochna portal (jansoochna.rajasthan.gov.in) has had 3.3 lakh visitors and almost 15 lakh information hits. Apart from this, there have been another 50,000 information hits from the Jan Soochna mobile app.

The portal provides information in Hindi and English on universal social security, health and education schemes as well as welfare schemes specifically aimed at farmers, construction workers, miners and students. Land revenue records, case listings, and grievance redressal databases are also available. While some categories, such as forest rights, have very limited data, some others have a lot of detail - on individual beneficiaries and specific details of payment, for instance.

"This is a much-needed step inspired by the spirit of Section 4 of the Right to Information Act, which mandates governments to maintain computerised records and provide this information suo moto to the public, so that there is minimal need to file RTIs," says Nikhil Dey, an MKSS activist who has been at the forefront of the RTI movement. A recent NGO study of orders by the Central Information Commission in 2018 found that 70% of the original RTI applications requested information which should have been put out in the public domain already. "You have made people go through so much pain for digitisation, getting multiple cards made, giving their biometric data... At least, let them get some benefits from it. Through Digital Dialogues, we argued that the public has a right to all the information the government collects about them. There should be no password-protected login barring access to these databases," says

#### The role of facilitators

"It was activists like Baluji who gathered initial information on what data are most needed by marginalised villagers," says Vineet Bhambhu, earlier a U.S.bound software engineer and now a grassroots activist, who helped lead MKSS conversations with the DoITC for Digital Dialogues. "We found that people mostly needed data on their own entitlements: food, pensions, job guarantee, educational scholarships, labour welfare benefits, health insurance, treatment for occupational diseases such as silicosis, land rights, etc.," he

says. Bhambhu points out that many poor people had no way to track what happened if payments had been diverted to a different bank account or if forest rights applications had been rejected. In other words, they had no way of finding out what happened to payments if they could not access the databases and processes that form the backbone of a particular scheme or law.

Take the case of Sovani Devi. A 45year-old widow in Bherukeda Amner village in Rajsamand district, lack of information cost her a flock of goats, a loss she could ill-afford. Sitting in her bare courtyard, Devi is flanked by her sons, both disabled. Ram Singh, 18, cannot use his legs and drags himself around on his knees, while his 16-year-old brother Kishore can neither hear nor

"Two years ago, I was diagnosed with a tumour in my uterus and I went to the hospital because I had Bhamashah [health insurance]," says Devi. The Bhagwan Mahavir Hospital, a private hospital, is empanelled as part of the State's cashless health insurance scheme, the Bhamashah Swasthya Bima Yojana, and should have treated a cardholder without payment. "But they said I would have to first pay for the operation and that I would get the money back only later," Devi says, showing the folder from the hospital. which is located in Deogarh town, 40 km away.

Faced with a demand for ₹15,000 for the operation plus additional charges for medication, Devi saw no choice. "I used up all my savings. I went back home and sold 12 [out of 16] goats for ₹30,000 and used that to pay the hospital," she says. Apart from the operation, Devi says she paid ₹8,600 for medicines, of which bills were provided for only ₹4,600. The rest of the money from the goat sale was soon gone too, in paying for food and travel, with a one-way trip to hospital by taxi costing ₹600.

After she recovered from the operation in June 2017, Devi made several vi-

sits to the hospital, but failed to recover her money. "I took all my papers, but they told me they have applied to the insurance company and nothing has come yet," she says. "Only when Vineet bhai looked on his computer, he found that the hospital had already got the money." Devi also says that after her operation, she put her fingerprint on a form that she could not read. Later she found out that the form falsely stated that she had not paid any money to the hospital as she was covered by the cashless insurance scheme. In March 2018, Bhambhu, armed with information from the Bhamashah database, accompanied Devi to the hospital and recovered ₹19,600.

'After that, my husband got cancer, so we had to use up the money for my husband's treatment. He died last year," Devi says, as her two remaining goats enter the courtyard along with her youngest child, 13-year-old Radha. "I never went to school, but my daughter has finished Class 8 and I want her to study till Class 12 at least. Without education, there is nothing," she says.

#### Strength of unity

For unlettered villagers, the Jan Soochna portal is of little use without facilitators like Bhambhu and Baluii. However, in Gomaka Badia village in Thana panchayat, villagers have also discovered the strength of unity when armed with

"There is not enough signal for the Internet to work properly," Khatik says apologetically. "Imagine, if it is so bad in Bhim town, it's much worse in the village panchayats. At least, with the urban machines, they can be connected to Wi-Fi even if the speed is slow. Rural machines must be connected to Rajnet [the State operator]." Data available with the government show that in one year, only 10 transactions have been made on this particular machine. Of the 14,440 machines installed across the State over a year ago, 914 have never been used.

Khatik adds that all 37 of the kiosks installed in Bhim block have private operators who act as middlemen anyway. "There is no incentive for the operator to even login to the machine in many areas, because he can charge more for the same services without using it," he says. DoITC data show that the kiosks are used more frequently in urban areas mostly to print out digitally signed certificates and pay for phone and electricity bills. The Jan Soochna portal itself has been accessed only 16,000 times on these machines over the last month.

Although the Jan Soochna portal was launched with much publicity, information about it is still to reach many people in Rajasthan. "No one outside our office has heard the name of this Jan Soochna. But it is a new scheme, it will take some time to become popular," explains Khatik.

In the villages of Rajsamand and Bhilwara district, there is no visible publicity regarding the portal as yet. Even villagers who have personally benefited from the expanded database access are yet to hear the term Jan Soochna.

"We have put out advertisements in papers and are planning awareness programmes. So far, the entire expenditure on Jan Soochna has come from our own internal budget, but the DoITC has now proposed a budget of ₹5 crore over the next five years to maintain the software and popularise the portal," says Sharma. He sees the Jan Soochna initiative as the next step of the government's integrated service delivery efforts, a natural evolution of its franchisee-based e-mitras or service centres. He argues that emitras are the ideal facilitators for the Jan Soochna portal.

According to the MKSS activists who helped evolve the concept of Jan Soochna, e-mitra operators are often part of the problem, acting as middlemen who have a vested interest in blocking access to information. "We see Jan Soochna as a natural evolution of the RTI movement. This information is meant to back up an accountability and grievance redressal framework, and as such needs government-run information and facilitation centres," says Dey.

MKSS wants training on Jan Soochna usage to be imparted to front-line government workers at anganwadis and panchayats as well as grassroots social workers. Local databases need to be made visible offline as well, says Dey. "Specific data on ration beneficiaries should be painted on the walls of the ration shop itself, so it can be seen even by those who cannot go online," he says.

The DoITC is also seriously considering an MKSS suggestion that printouts of information from the Jan Soochna portal should automatically come with a digital signature, giving them the same legal validity as RTI responses.

At the Jan Soochna launch, the Chief Minister gave a big boost to the point of view that the portal is part of a wider RTI framework rather than a mere service delivery, reminiscing about his engagement with the early RTI movement. "About two decades ago, I reached the sit-in protest organised by social worker Aruna Roy and her companions demanding RTI. I agreed to their demands. Then, fortunately, we formed the government and Rajasthan became the first State of Indian to initiate for this law," he said.

As the Rajasthan experiment evolves, other States are already making plans to follow suit and are thus closely watching these debates. Just five days after the launch of Jan Soochna, the Karnataka government directed all departments with beneficiary schemes to begin sharing datasets in preparation for the launch of a similar portal. The real success of the story will depend on how well the Rajasthan government can help empower the marginalised with the biggest tool at its disposal: information.

### BJP, JJP join hands to form govt. in Haryana

Earlier in the day, outgoing Chief Minister Manohar Lal Khattar left for New Delhi to meet the Independent candidates and party's central leadership to discuss the permutations and combinations of forming the government.

Party sources said five Independent MLAs - Nayanpal Rawat, Sombir Sangwan, Dharampal Gonder, Rakesh Daulatabad and Randhir Golan - met Mr. Nadda and extended their support to the BJP.

Controversial former minister Gopal Kanda (MLA from Sirsa) of the Haryana Lokhit Party and two other Independent MLAs – Balraj Kundu and Ranjit Singh have already announced their support to the BJP.

Congratulatory posters sprang up in Worli projecting Aaditya Thackeray as the "future chief minister." Later in the day, the Shiv Sena leaders met party president Uddhav Thackeray to present a demand on the same lines, senior leaders

### It's a lost opportunity for the Congress in Haryana

BJP fell short of the majority mark, despite its high-profile campaign that harped on national security & clean governance

Contrary to the ruling Bharativa Janata Party's slogan of "Abki baar 75 paar" (more than 75 seats this time) in Haryana and the predictions of a landslide by most of the exit polls, the party fell short of even the majority mark in the 90-member Assembly.

The ground reports suggest that the issues of livelihood, farmers' distress, unemployment and economic slowdown took precedence over national issues in the State and thus there prevailed a strong anti-incumbency sentiment, among other things.

Hoping to romp home riding on the wave of nationalism in the wake of dilution of Article 370, the BJP in Haryana carried out a "high-pro-

file" campaign, including seven rallies by Prime Minister Narendra Modi, harping on national security and resorting to Congress bashing, but the electorate was left unamused. The claims of the BJP leadership of a clean and transparent governance also failed to impress the voters.

As this dawned on the party campaign managers as well as on Mr. Modi, there

was an obvious shift from his earlier addresses. He began to talk about farmers, traders and youth towards the last leg of electioneering, but it was too late by then.

The Congress' rather "silent" campaign, on the other hand, led by two-time Chief Minister Bhupinder Singh

Hooda, his son and ex-Rohtak MP Deepender Hooda and State party chief Kumari Selja, successfully weaved a narrative around the farmers' distress, unemployment and tapped the discontent among the traders and the government employees.

Having already supported the dilution of Article 370 go-

ing against the party line, Bhupinder Singh Hooda not just managed to blunt the BJP's attack on the Congress over nationalism, but also made it a Hooda vs Khattar election to his advantage.

The Congress central leadership also remained strategically away from the campaign leaving it entirely to Mr. Hooda. "Every vote to Congress candidate will be a vote for me," Mr. Hooda said at every rally, not forgetting to remind the audience as to how his government had waived ₹1,600 crore pending electricity bills of the farmers and allotted over three lakh plots to the Scheduled Castes.

The party's promise to increase old age pension and free electricity and free travel for women in Haryana roadways buses also caught the voters' fancy.

The much-talked about Jat and non-Jat divide in the State, especially in the wake of the Jat reservation agitation in 2016, also appeared to have been negated by the anti-incumbency, strong with the Congress gaining 10 seats along the Grand Trunk Road belt, considered a stronghold of the BJP with a large non-Jat population. Nine of these seats were previously held by the BJP. The results even shocked the BJP leaders since the party had swept the municipal and Mayor elections in the belt less than a year back.

Of the 11 BJP Ministers in the fray, only three managed to win highlighting the extent of the electorate's anger.

However, the split in the Indian National Lok Dal and the much delayed change in Haryana Congress State leadership worked to the advantage of the BJP. The ticket distribution and the infighting among the BJP cadres, however, hit the party hard.

Harvana is a lost opportunity for the Congress and a lucky comeback for the BIP.

### U.S. seeks 'road map' to restore normalcy in Kashmir

Demands release of detainees; asks Pakistan to take sustained and irreversible steps against militants in its territory

The U.S. has sought from India a "road map" to political and economic normalcy in Kashmir and immediate release of all political detainees even as it asked Pakistan to take "sustained and irreversible" steps against militants and terrorists in its territory.

Most of the top-level and second-rung separatists of Jammu and Kashmir have been taken into preventive custody while mainstream leaders, including former Chief Ministers Omar Abdullah and Mehbooba Mufti, have been either detained or placed under house arrest in view of the Centre's decision to revoke special status to Jammu and Kashmir and splitting the State into two Union Territories.

"We continue to press for the release of detainees for the full restoration of everyday services, but most importantly, for road map to the restoration of political and economic normalcy," said Acting Assistant Secretary of State for South and Central Asia Alice G. Wells.

The U.S. remains "deeply concerned" about the situation in the Valley where the daily life of nearly eight million residents has been severely impacted since the decision to revoke Jammu and Kashmir's special status and

### 24 elected unopposed in BDC polls in Kashmir

Elections held in 310 blocks in State

The maximum number of chairpersons of Block Development Councils (BDC) who were elected unopposed in Kashmir Valley were from the two worst militancy-affected districts of Shopian and Pulwama.

Of the 24 chairpersons elected without contest in 133 blocks in the Kashmir Valley, 10 were from the Bharatiya Janata Party (BJP) and 14 were Independents. In the block elections in Shopian, six BJP candidates won unopposed and, in Pulwama, two BJP candidates won without a fight.

Elections were held in 310 blocks in Jammu and Kashmir on Thursday. Thirteen winning candidates

were women. The elections of BDC chairpersons are indirect and they are elected by Panches and Sarpanches of a Panchayat falling within a particular block. The Congress, the National Conference and the Peoples De-

mocratic Party did not take part in the polls, the first to be held after the revocation of the special status of J&K in August. Most cadres of the political parties, except the BJP, are in detention. The panchayat elections

were held in J&K in 2018 and total of 27,281 panches and sarpanches were elected. There are 12,776 vacant sarpanch and panch seats in

As many as 217 Independents won in the BDC elections, of which 101 were from the Kashmir Valley.

On Friday, Prime Minister Narendra Modi tweeted that the BDC polls held for the first time since 1947, "witnessed a historic turnout of 98%". "I am delighted to share that the BDC polls in Jammu, Kashmir, Leh and Ladakh were conducted in a very peaceful manner. There was no violence. This shows the people's unwavering faith in democracy and the importance they accord to grassroots level governance," he tweeted.

### Criminal investigation opened into Mueller's Russia inquiry


Move likely to raise alarms that the U.S. President is going after his perceived enemies

For more than two years, President Donald Trump has repeatedly attacked the Russia investigation, portraying it as a hoax and illegal even months after the special counsel Robert Mueller closed it. Now, Mr. Trump's own Justice Department has opened a criminal investigation into how it all began.

Justice Department officials have shifted an administrative review of the Russia investigation closely overseen by Attorney General William Barr to a criminal inquiry, according to two people familiar with the mat-

The move gives the prosecutor running it, John Durham, the power to subpoena for witness testimony and documents, to impanel a

grand jury and to file criminal charges.

The opening of a criminal investigation is likely to raise alarms that Mr. Trump is using the Justice Department to go after his perceived enemies. Mr. Trump fired James Comey, the FBI director under whose watch agents opened the Russia inquiry, and has long assailed other top former law enforcement and intelligence officials as partisans who sought to block his election.

Mr. Trump has made clear that he sees the typically independent Justice Department as a tool to be wielded against his political enemies. That view factors into the impeachment investigation against him, as does his long obsession with the origins of the Russia inquiry. House Democrats are examining in part whether his pressure on Ukraine to open investigations into theories about the 2016 election constituted an abuse of power.

The move also creates an unusual situation in which the Justice Department is conducting a criminal investigation into itself.

Mr. Barr's reliance on Mr. Durham, a widely respected and veteran prosecutor who has investigated CIA torture and broken up Mafia rings, could help insulate the Attorney General from accusations that he is doing the President's bidding and putting politics above justice.

It was not clear what potential crime Mr. Durham is investigating, nor when the criminal investigation was prompted. A Justice Department spokeswoman declined to comment. NY TIMES

### 3 held for human trafficking over London truck deaths

Some Vietnamese could be among the victims

The police investigating the deaths of 39 people in a truck near London said they had arrested three more suspects on Friday on suspicion of human trafficking amid signs that some of the dead may be Vietnamese.

As forensic experts began the process of identifying the victims, the Vietnamese embassy in London said families from the southeast Asian country had got in touch about missing relatives. There were growing concerns at least 10 of the victims could have been from Vietnam.

Hoa Nghiem from Human Rights Space, a civic network based in Vietnam, said that Pham Thi Tra My, 26, had sent a text message to her mother saying she could

not breathe at about the time the truck container was en route from Belgium to Britain.

"Im sorry, mum and dad. My path abroad was not a success. I love you both so much. I cant breathe. I'm from Nghen Town, Can Loc District, Ha Tinh, Vietnam ... I am sorry, Mom," the message said, according to Ms. Hoa who said it had come from Tra My's family.

She said Tra My had gone to China and was planning to reach England via France and that the organisation was getting more alerts about possible Vietnamese victims in the refrigerated trunk, which was found on Wednesday.

The police have said they believe the dead were Chinese but Beijing said the nationalities had not yet been confirmed. Chinese and Vietnamese officials are now both working closely with the British police, their respective embassies said.

"We owe it to those who have died to get this investigation right and speculation is not helpful," Essex Police's Deputy Chief Constable Pippa Mills told reporters. "It may in fact hinder our investigation and its progress."

On Friday, the police also arrested a man and woman, both aged 38, in Warrington, England, and a 48-year-old man from Northern Ireland at London's Stansted Airport. They are suspected of conspiracy to traffic people and manslaughter.

### EU keeps Britain guessing on the length of its Brexit lifeline

The European Union agreed on Friday to London's request for a Brexit deadline extension but set no new departure date, giving Britain's divided Parliament time to decide on Prime Minister Boris Johnson's call for a snap election.

There was full agreement on the need for an extension," an EU official said after Ambassadors from the 27 countries staying in the bloc met to discuss postponing Britain's exit, less than a week before the current dea-

dline of October 31. "Work will continue over the weekend" and envoys will meet again in Brussels on Monday or Tuesday, the person said.

"Of course October 31 is still possible – we could leave on October 31 - unfortunately it depends on what the EU says," he said, adding that if opponents frustrate his bid for an election on December 12 his minority government would not engage in pointless "Brexitology" in Parliament.



### Credit growth gets festive boost

### In a flip-flop, Odisha govt. retracts advisory on deposits

Move comes after RBI advises it against giving such direction

The Odisha State government retracted its advisory to various departments, cautioning them about depositing funds in banks, after the Reserve Bank of India (RBI). in a strongly worded letter, advised it against giving such directions.

The finance department of the Odisha government, in a communication to various departments on October 21, had cautioned them about depositing government funds in empanelled banks.

Citing media reports about the 'health' of banks and reminding that deposits are insured only up to ₹1 lakh, the State government said, "government departments, PSUs, or agencies have to be very careful while



keeping deposits in any banks and proper enquiry about the financial health of the concerned bank for making any deposit must be made. It shall be the personal responsibility of the concerned authority for such deposit." The advisory had not gone down well with the RBI, which had given assurance about the safety of the Indian banking system.

In a strongly worded note, the RBI warned that such advisories coming from public authority may create unnecessary misgivings among public and could have unintended consequences for the financial system stability.

This prompted the State government to issue a clarification saying it does not have any view on the health of any particular bank. comes under the domain of RBI. There is no reason for anyone to get apprehensive about the financial health of banks in general," it said.

Reliance Industries Ltd. on Friday said its board had approved the formation of a wholly owned subsidiary for digital platform initiatives and investment of ₹1.08 lakh crore in the unit.

The subsidiary will also acquire RIL's equity investment of ₹65,000 crore in Reliance Jio Infocomm Ltd. (RJIL), it said in a regulatory filing. RIL said that the RJIL board had approved a scheme of arrangement between the company and certain classes of its creditors, including debenture holders, for transfer of identified liabilities of up to ₹1.08 lakh crore to RIL.

"Rights Issue of Optionally Convertible Preference



Shares (OCPS) aggregating up to ₹1,08,000 crore for the purpose of payment of consideration for transfer of identified liabilities - WOS (wholly owned subsidiary) to subscribe to this issue," it added.

As a result, RJIL will become virtually a net debtfree company by March 31, 2020, with exception of spectrum-related liabilities, it noted. "This new company will be a truly transformational and disruptive digital services platform. It will bring together India's No. 1 connectivity platform, leading digital app ecosystem and world's best tech capabilities globally, to create a truly Digital Society for each Indian," RIL chairman and MD Mukesh Ambani said. He added that given the

reach and scale of its digital ecosystem, the company has received strong interest from potential strategic partners. "We will induct the right partners in our platform company, creating and unlocking meaningful value for RIL shareholders," he added.

More recently, in June, three of his jewels, including a highly-architectural diamond and emerald bead brooch inspired by the Mughal flowerpot motif, sold for two to three times their estimates at Christie's Maharajas & Mughal Magnificence auction in New York. They were showcased alongside vesteryear objects such as jighas (turban ornaments), swords and the 'Nizam of Hyderabad necklace' - all from the (ruling family of Qatar's) Al Thani collection. "Most Indians carry the Maharaja baggage. I can relate to it, but it is also important to move forward," says Viren, 62. "My endeavour is to present jewellery in today's context by creating pieces that are modern and India-inspired at the same time."

#### Living by his rules


With an almost scholarly appearance (he is said to resemble his late father, Vajubhai Bhagat, an artist and lecturer at Sir JJ School of Art), the fourthgeneration jeweller is fastidious both in his work and his appearance (his crisp white shirt cuffs and collars just so). He also insists on keeping a low profile, which is one of the reasons why, outside of a small circle of high jewellery connoisseurs, he is virtually unknown. He is, however, generous with his time when it comes to sharing his passion. In the last few weeks alone, he has addressed crowds at Saffronart's biennial jewellery conference, Mapping a Legacy of Indian Jewels, and the AD Design Show.

identity for Indian jewellery, the 'gem whisperer' (as he calls himself on Instagram) is regarded in the league of French luxury house Cartier and American jeweller, Joel Arthur Rosenthal (who, incidentally, is a close friend). His creations find a place in museums and private collections. But he follows his own rules: he never takes commissions, never repeats his designs, and creates only 60 pieces a year. "The passion to create something new drives me to work every day. I make jewellery to please myself," says Viren, who will be showcasing some of them next March, at TEFAF Maastricht in Netherlands, considered the foremost fair for fine art, antiques and design.

Born into a family that's been in the jewellery business for over a century, he was drawn to the craft at the young age of 11. He would observe his father and uncles interact with gemstone dealers and spend hours watching the setters and polishers at the workshop of his family's department store, Bhagat Brothers. "They taught me how to judge the colour, clarity and origin of the stones," he shares. Once the family business folded up, Viren, along with his brothers, Bharat and Rajan, opened a jewellery atelier in 1991. His sons, Varun and Jay, have also joined the business. "Sometimes, it takes six months to make a ring because of the time we spend on every detail. The younger generation doesn't have this kind of patience but, thankfully, my boys share my vision and passion," he adds.

Viren is open about the role his father played in shaping his design aesthetics, his sense of proportion and his interest in drawing. "He taught Akbar Padamsee and Tyeb Mehta, among other artists. On Sunday mornings, they'd visit him [at our house on Marine Drive] and argue about art for hours. Listening to them, I felt like picking up the pencil and

realised that I could draw, too," he says. But he does not often speak about the other man who also encouraged him to embark on his journey - Italian jewellery designer, Gianni Bulgari. While on a holiday in Europe in the

late 1980s, Viren had visited the Bulgari store in Rome. "I gasped at what I saw on display. It was a defining moment in my life," he recalls. On returning to Mumbai, he sent a collection of his drawings to Bulgari by post. "Six months later, I got a reply saying he liked them and I could visit him in Europe.'

Viren's hopes of working with Bulgari were dashed when the designer said he couldn't employ the young man for just a couple of years and teach him his secrets, only to have him return to India. But, as Viren later told Vanity Fair, Bulgari also told him, "I can see that you're talented and I'm sure that you'll be successful wherever you go." This stamp of approval, he says, "inspired

#### **Everyday inspirations**

Viren draws to scale and his inspirations range from Mughal miniatures to Art Deco, textiles, and everyday life. Peek at his Instagram, and odes to the geometry of Spain's Alhambra palace share space with Japanese signage. "On my morning run, I come across fisherwomen heading to the Sassoon Docks. It is amazing to see the way they dress, the jewellery they wear. That's inspiring, too," says the designer, who works with historic gems and a limited palette of diamonds, rubies, emeralds, sapphires, spinels and natural pearls.

#### **Future challenges**

Viren's design process begins every morning, drawing on white A5 paper with pencils that he sharpens to a point himself – "because my drawings are so precise" - while listening to trance music "to cut off all disturbances". "I pick a

gemstone from the collection acquired on my travels and see if it matches the design [he once spent 10 years collecting 24 Burmese cabochon rubies for a necklace]. If not, I place

the stone in front of me and create a design inspired by it." Most of the time, however, when he buys a stone, he knows what he will make with it.

At his workshop, the design dictates the cutting of gemstones. Closely supervising his craftsmen for three

decades now, he has developed a strong relationship with them. "They turn my flat, onedimensional paper designs into three-dimensional jewels. We work with a shared passion and, over the years, I've come to a level with them that there's telepathy," he says.

However, he admits there will be challenges, going ahead, "It is becoming tough to find the next generation of craftsmen. They don't wish to sit on a bench and work with their hands because of the technology available. I believe my sons will face this challenge even more in the future," he concludes.

Despite the many horrors that have scarred human history, few exemplify the personification of hate as starkly as the slaughter of six million Jews by the Nazi party during World War II. In Steven Spielberg's Schindler's List (1993), the protagonist saves about 1,200 Jewish lives from the Holocaust.

The film won seven Academy awards and further established Spielberg in the pantheon of great American directors. However, a question never stopped haunting him: why and how do humans become such despicable vessels of hate? The desire to dig deeper gnawed at him for years until he met Alex Gibney (Academy Award winner for Taxi to the Dark Side, 2007), and they decided to create a documentary called Why We Hate.

Soon, Geeta Gandbhir, an accomplished documentary filmmaker with an Emmy award under her belt, received a call to join the project as a director, along with her mentor and friend, Sam Pollard. " When Spielberg, Alex Gibney and Sam Pollard call you, you don't say no," she

chuckles. "And, of course, the theme was timely; we're living in a polarised world. If we can educate people on this topic, maybe we can stop hate in its tracks."

#### **Political undertones**

Born to Indian parents who emigrated to America in the '60s, much of Gandhbir's experience growing up as an immigrant informed her filmmaking, right from casual racism to being told point-blank to go back to her country.

"What's interesting is that my parents were allowed to settle here only because of the Chinese Exclusion Act which was in place until 1965," she says, adding, "It is ironic how America, historically made entirely of immigrants, treats immigrants today. The realities of white supremacy and xenophobia are there for us to see, especially with the current powers in charge."

Why We Hate takes a journalistic approach and draws on historical investigations and research in psychology, biology, and neuroscience. The six-part documentary traces the evolutionary basis of hatred and its impact on individuals and societies

But what exactly is hate? Gandbhir says that it can be complex to define, but a clue can be taken from how scientists and experts talk about it. "Essentially, they begin by talking about love – not essentially in the romantic sense, but in the incredible ability of humans to cooperate, build societies, share resources and take care of each other," she says. "Hate is the antithesis of this. It is rooted in tri-

> balism - refusing to share resources and committing violence of various degrees. This was a necessary survival tactic in the Stone Age, but in a global economy, we need to be selfmore aware of how this affects our behaviour." Interestingly, what counts as hate is usually collectively determined by society. This

its own set of troubles. "Consider slavery in America or the caste system in Hindu society," she says. "Both were normalised until people took a stand and said they weren't okay."

For Gandbhir, the most interesting insight from her research was from the work of Laurie Santos about the persistence of tribalism in influencing our behaviour. "Santos talks about how we are born with a tribal filter which informs how we view the world. It forms a mechanism through which we identify with a certain group and, sometimes, without even being aware of it, we vigorously de fend that group identity."

#### On the internet

When I ask her if we live in uniquely polarised times, she disagrees. "If you talk to our elders, they will tell you stories that will make your blood curdle: stories of slavery, rape, deliberate social exclusion of certain groups. We've come a long way from that." However, social media brings its own set of perils.

Whether it is by promoting hateful and negative content, or actively abetting genocide in countries such as Myanmar, she says the internet must be used with care and viewed with suspicion.

However, it is not all doom and gloom. Hate is not necessarily inevitable. Our inner wiring can be modified. One way to combat hate, says Gandbhir, is to affiliate ourselves with as many different identities as possible. "The more groups we associate with, the less likely we are to hold staunchly to our membership of one particular group. I find young people today quite open-minded."

In the space of mainstream biographical films, Saand Ki Aankh (SKA) manages to achieve what Super 30 could not. As opposed to the inyour-face, cringe-inducing righteous artifice of the life of mathematician Anand Kumar that was the latter, SKA comes across as spontaneous and easy-going in its celebration of Chandro and Prakashi Tomar (Bhumi Pednekar and Taapsee Pannu respectively), the octogenarian sharpshooters from Johri village in Baghpat, who have been unwitting initiators of a unique feminist movement in the heart of patriarchy.

Yes, the bad prosthetics do irk and irritate at the start, but slowly you begin to overlook the cakey make-up on the faces of Pednekar and Pannu and begin warming up to the place, its people, stories, struggles and, most of all, a matter-of-fact rustic sense of humour.

It is as real as it can get within the confines of the fantastical world of popular entertainment, be it the daily, dreary grind of the women in rural households, or their encounters with seemingly benign patriarchy that suddenly rears an ugly head at the slightest hint of a supposed rebellion.

In the sprawling Tomar joint family, three sisters-in-

### Dazed and utterly confused

Made In China suffers from an identity crisis, never knowing what it wants to focus on and achieve







### 'Different, Non-Conformist, Individual': the story of Germany's underdog, cult club

From a pocket of resistance during the East German regime to a fan-built club punching above its weight in the Bundesliga, 1.FC Union Berlin has come a long way. It faces its sternest football test this weekend — Bayern away

.FC Union Berlin is no ordinary football club. The Lfirst East Berlin team in the German top flight, Union has a poignant past and a fanatical following that has done incredible things to keep it alive. It's a wonder that the club still exists; many of its fans can't believe even now that it will play Bayern Munich in the Bundesliga this weekend, given the hardships it has survived.

Saturday's game in Munich will train the spotlight on Union, which won promotion to the premier division for the first time in the club's history after defeating VfB Stuttgart in the relegation play-offs.

The Berlin outfit has already felled a giant this season - it stunned Borussia Dortmund 3-1 for its first Bundesliga victory in late August – but the prospects of an encore aren't bright.

#### Fighting chance

Although Union did its best in preseason, stretching a little money a long way, signing 11 new players to give coach Urs Fischer a fighting chance of avoiding relegation, it doesn't exist on the same financial planet - and doesn't want to - as Bayern.

What Union does have is players with top-flight experience (Neven Subotic, Christian Gentner and Anthony Ujah) and a spirited defence that, after shipping four goals in the opening game against RB Leipzig, has

shown it can cope at this level. "Is there an easy fixture for us in the Bundesliga?" wondered coach Fischer before the Dortmund match. It's a familiar feel-

"Different, Non-Conformist, Individual" is how Union describes itself on its website - an identity that can be traced to its anti-establishment roots. Associated Press reported that the club was immensely proud of "its resistance to the East German regime, in contrast to its fiercest rival, Dynamo Berlin, which was Stasi chief Erich Mielke's club".

#### Strong bond

Given those circumstances, it's no surprise that Union and its fans have forged an exceptionally strong bond, a bond that has helped the club stay afloat after Germany's unification and saved it from extinction.

to raise money and supplement Zingler's contribution, which helped Union avoid bankruptcy. Zingler became club president, a position he still holds.

#### Fans to the rescue In 2008, the fans again came to

the rescue when the club needed to modernise its stadium, the delightfully named Stadion An der Alten Forsterei (Stadium near the Old Forester's House). According to reports, about 1,600 volunteers, many of whom had no expertise in construction work, sweated it out for an estimated 90,000 hours to rebuild the stadium and help the club save money.

Then, in 2011, Zingler told a German newspaper, "We've decided to sell our soul. To our own members."

He was speaking of a move to sell 10,000 shares or a maximum of 58% of the club to the fans to raise funds for improving the stadium's infrastructure; shareowners were to get a vote

on all major decisions affecting the stadium.

Union supporters are consumed by the idea of staying true to their values - the club hymn, sung by German punk legend Nina Hagen, has lyrics about never selling your soul - and so the decision to raise money from members, and not a corporate sponsor, resonated with the fan-base. But surviving at the top level, where football is a cut-throat business, will challenge Union's adherence to its ideals


#### Reality check When Union

signed shirt-sponsorship deal with a Luxembourg real-estate company, for instance, rival fans and critics who found Union preachy let the club and its supporters know exactly what they thought. And when Union fans decided to greet RB Leipzig with silence at the beginning of the Berlin club's first Bundesliga game, protesting what they saw as Leipzig's corporate model, it caused many a snide remark.

Union fans are also grappling with what the club's time in the Bundesliga will mean for them. While some are ambitious and want to stay up, others are wary of the damage the demands of top-division football could cause to the club's identity. These are challenging times for Union and its supporters, but they have endured worse. SPORTS BUREAU, ASSOCIATED PRESS

### Sixth title in Hamilton's sights

The Briton needs to score 14 points more than teammate Bottas to win the championship in Mexico

ewis Hamilton is closing in on a sixth world title, ⊿but a challenging weekend awaits him in Mexico.

The task in front of Hamilton is clear - he needs to score 14 points more than teammate Valtteri Bottas at the Autodromo Hermanos Rodriguez on Sunday to clinch the drivers' world championship.

But things are seldom that straightforward. Hamilton and Bottas, the winner in Japan, will be able to race without any team considerations now that Mercedes has clinched the constructors' title. So, expect Bottas, as well as Ferrari and Red Bull, to go flat out to make Hamilton wait at least until Texas, the following weekend.

The 34-year-old Briton has also not finished in the top three at Formula One's high est altitude circuit, in Mexico, since he won in 2016.

If Mercedes struggles in the thin air, as it has for the past two years, then Ferrari and Red Bull can scent an opportunity. Red Bull's Max Verstappen is chasing an unprecedented Mexican hat-trick while Ferrari's Se-

Karnataka found another star performer in fast bowler A. Mithun, who claimed a hat-trick in his five for 34 spell.

It was a tame end to the visitors' innings, which mustered just 65 runs in the last 10 overs.

Abhinav was strong off the back-foot, cutting and flicking with aplomb. Aparajith was as solid as ever.

Debutant left-arm pacer Prateek Jain broke the partnership, getting Abhinav to chop a short ball to cover. Aparajith was undone by a poor piece of running, keen on taking a double when his partner Vijay Shankar was

Vijay Shankar (38, 35b) and Dinesh Karthik (11, 18b) looked to finish proceedings in style, but it was not to be.

Rahul and Mayank then took centrestage. Mayank carried on from the terrific form he showed in the South Africa Tests, taking apart the bowlers with ease

He got going with a lofted six over cover off Vijay Shankar, and stroked left-arm speedster T. Natarajan for three boundaries in the next over. Tamil Nadu simply could not stop the Mayank

#### Close call

Hip injury forces Williamson out of England T20 series

New Zealand captain Kane Williamson will miss the upcoming Twenty20 series against England after a recurring hip injury flared up,

team officials said on Friday. Paceman Tim Southee will lead the team in Williamson's absence, with the batsman hoping to return for a two-Test series in late

### Shtembuliak, Polina crowned champs

Indians remain medal-less; Karthikeyan, Aakanksha finish fifth

Indians finished medal-less after the overnight leaders, Armenia's Evgeny Shtembuliak and Russia's Polina Shuvalova, performed to expectations to claim their maiden World junior (under-20) chess crowns here on Friday.


On a day when Armenian boys and Russian girls won two medals, the champions took contrasting routes on their home-run. Polina, playing black, drew in just 30 moves against China's Song Yuxin and won the girls' title with a tally of 9.5 points from 11 rounds.

Seventh seed Shtembuliak took his time to overpower Russian prodigy Volodar Murzin in 63 moves and raised his tally to an unsurpassable nine points.

Later, Armenia's Shant Sargsyan stopped Spain's Miguel Santos Ruiz in 95 moves in the sixth hour to take the silver. Sargsyan's compatriot Aram Hakobyan (8) claimed the silver following a 64-move draw with third seed Aravindh Chithambaram.

Iran's Mobina Alinasab (9) fought for 67 moves to beat Kazakhstan's Bibisara Assaubayeva for the girls' silver. The bronze went to Polina's compatriot Eliaveta Solozhenkina who prevailed in an 83-move marathon over teammate Dinara Dordzhieva.

After three years, India again finished without a medal. Second seed M. Karthi-

keyan signed off with a win and took the fifth spot, like he did in 2016.

Among the girls, Aakanksha Hagawane was the best finisher. She won the last

round to take fifth place.
