# Terror in Kashmir a big problem: MEPs

India's move to revoke Article 370 an internal issue, say the members, who were on a visit to the State

he delegation of Members of European Parliament (MEPs), on a visit to Srinagar on Wednesday, said "terrorism is a severe problem in Kashmir" and named Pakistan as its source. They felt India's decision to revoke provisions of Article 370 that gave special status to Jammu & Kashmir was an internal issue. "It should not be used [against India]," they said.

The MEPs described the killing of six non-locals by suspected militants in Kulgam, south Kashmir, as "inhuman". "Terrorism is not finished yet in Kashmir. Terrorism in Kashmir is not only the problem of India. I think it's our problem, as well as of the international community. We support India in fighting for a solution to the problem," three of the delegation told a select group of journalists in Srinagar's Old Airfield.

### 'Allow Indian MPs too'

Another MEP, Nicolaus Fest, however, said the Indian Opposition parties should also be allowed to visit the Kashmir Valley. "I think if you let in European Union parliamentarians, you should also let in Opposition politicians from India. So there is some kind of imbalance. The government should somehow address it."

## J&K, Ladakh become Union **Territories**

The bifurcation of Jammu & Kashmir into two Union Territories came into effect at midnight Wednesday. Girish Chandra Murmu and Radha Krishna Mathur will be sworn in as Lieutenant Governors of J&K and Ladakh respectively at two separate ceremonies on Thursday.

J&K Chief Justice Gita Mittal will administer the oath to Mr. Mathur at 7.15 a.m. in Leh district of Ladakh. Around 12.45 p.m., she will swear in Mr. Murmu in J&K's summer capital Srinagar. A special plane has been kept ready in Leh to meet the deadlines of the two ceremonies. Multiple security layers have been finalised to ensure peaceful and smooth ceremonies.

Ms. Mittal arrived in Leh on Wednesday, while the Lieutenant Governordesignates also reached their respective stations.

The Rajasthan High Court on Wednesday quashed a cow smuggling case registered against Haryana dairy farmer Pehlu Khan, who was allegedly lynched by a mob of cow vigilantes in

The relief covered Khan's two sons and the owner of the pick-up truck in which they were transporting the cattle.

The court ruled that Khan, 55, had purchased the animals for dairy and not slaughter.

Justice Pankaj Bhandari

# Delhi's pollution spikes to 'severe' category

Capital chokes from stubble burning in Punjab, Haryana; AQI recorded at 419

Air pollution in Delhi hit the 'severe' category on Wednesday, with an Air Quality Index of 419, the season's highest. Government agencies attributed the spike to stubble burning in neighbouring States.

The contribution of stubble burning in Punjab and Haryana to Delhi's air pollution was 35% on Wednesday, which is the highest this season, said government-run monitoring agency SAFAR (System of Air Quality and Weather Forecasting and Research).

### **Pollution numbers**

"The overall air quality of Delhi after recovering from firecrackers' smoke has again plunged to severe since wee hours of today [Wednesday], purely attributed to stubble fire which has

touched the season's highest share of 35% today," it said.

"Last night's [Wednesday] extremely calm surface wind conditions further aggravated the situation by accumulation of pollutants," the forecasting agency added.

The AQI on Wednesday was 419 at 4 p.m., which is the average of the past 24 hours, up from 400 on Tuesday and 368 on Monday, according to the Central Pollution Control Board.

The air quality, however, is expected to improve from Friday. Effective stubble fire counts in Harvana and Punjab have significantly declined to 1,057 during the past 24 hours, compared with 2,577 in the 24 hours prior to it.

The Delhi government has identified five locations -Wazirpur, Anand Vihar, Ashok Vihar, Vivek Vihar and Ba-

wana - which have been critically polluted in the last two days. Acting on the directions of Chief Secretary Vijay Dev, different government agencies have intensified pollution control measures in "The DPCC [Delhi Pollu-

tion Control Committee] has deployed 16 night patrolling teams to impose environmental compensation on agencies, units for construction and demolition waste, garbage burning, and dumping," an official statement said. SAFAR also advised people to avoid all outdoor physical activities, give morning walks a miss, and keep all windows closed. "Stop any activity if you experience unusual coughing, chest discomfort, wheezing, or fatigue and consult a doctor," its advisory said.

## All forms of authority under challenge, says Justice Bobde

'Personal attacks on judges uncalled for and destructive'

Chief Justice of India-designate, Justice S.A. Bobde, said every religion has beliefs not supported by reason.

"Every religion has its own practices which are a mystery. There are beliefs not supported by reason. Look at the very act of praying... every religion has its own way of praying and conditions for offering prayers," Justice Bobde told The Hindu on Wednesday.

Justice Bobde, who would be sworn in as the 47th Chief Justice of India on November 18. believes we live in an age where authority itself, be it of parents or Parliament, is under challenge.

# Chidambaram seeks interim bail from HC in INX Media case

Former Union Minister has cited poor health as reason

Former Union Finance Minister P. Chidambaram on Wednesday approached the Delhi High Court seeking interim bail in the INX Media money laundering case citing health grounds.

Mr. Chidambaram has sought interim relief for six days to enable him to consult and get examined by his regular doctor at the Asian Institute of Gastroenterology, Hyderabad, as he was not responding to the treatment at the AIIMS, Delhi.

The plea also said that for

dambaram was suffering from chronic abdominal pain due to Crohn's disease, with which he was diagnosed in 2017. Additionally, the plea stated that Mr. Chidambaram had lost weight from 73.5 kg to 66 kg due to the ailment.

Mr. Chidambaram was on Wednesday sent to judicial custody till November 13 by a Delhi court which said sufficient time had been given to

Special judge Ajay Kumar Kuhar dismissed a plea of the ED seeking a one-day custodial interrogation of the former Minister. The agency had already been granted 14 days of his custody. The agency is preparing to file a chargesheet in connection with the the INX Media case.

The Congress leader has already been granted bail by the Supreme Court in the INX Media case, which is being probed by the CBI.

to such humiliation? I'm going to meet top officials at the headquarters," he added. On the official side, there

was denial. Samastipur Superintendent of Police Vikash Burman said, "There is no official pledge form. We have taken a serious note of the report. A senior police officer will inquire."

Mr. Burman said there was no question of granting leave at all, as leave had been cancelled in view of the Chhath.
