Low growth forecast, rate cut trip mkt

RBI slashes growth estimate to 6.1%, brings down interest rate to decade low


Tn a clear admission about the I poor health of the economy, the Reserve Bank of India (RBI) on Friday slashed its GDP growth estimate for the current fiscal to 6.1 per cent from 6.9 per cent and reduced the interest rate by quarter of a per cent even as the stock market benchmark BSE Sensex plummeted by 434 points due to heavy sell-off in banking and FMCG stocks.

The market was disappointed by such a massive downward revision of growth forecast and less than expected reduction in interest rate. Given the tame inflation rate and feeble growth, the street was expecting at least 40 basis point rate cut. The disappointed triggered a collapse in the market. It was the fifth straight rate cut that brought interest rate to almost a decade low.

With all six members of the Monetary Policy Committee (MPC) voting in favour of a rate cut and for retaining the accommodative stance, the benchmark repurchase rate was cut by 25 basis points to 5.15 per cent. The previous lowest repo rate of 5 per cent was recorded in March 2010.

Following the rate cut, the reverse repo rate was reduced to 4.9 per cent. While five members voted for a 25 bps cut, Ravindra Dholakia voted for a 0.40 per cent reduction.

The RBI revised down-

6.1 per cent from 6.9 per cent it had previously estimated after lower-than-expected 5 per cent growth rate in April-June and no substantial uptick in the following quarter. Risks on the 6.1 per cent GDP growth estimate are "evenly balanced", it said.

The repo rate cut is aimed pushing consumption up during the ongoing festival season by reducing borrowing costs for home and auto loans, which are now directly linked to this benchmark

growth in the current fiscal to momentum remains as it is now and growth revives, the MPC will continue with an accommodative stance while ensuring inflation remains within the target." The RBI will continue accommodative stance as long as it is necessary and growth revives," he said.

> In the four previous rate cuts since February, the RBI had cut interest rates by 110 basis points whose transmission to borrowers in form of lower lending rate has 'remained staggered and incomplete", the Central bank said in a statement.

As against the cumulative


policy repo rate reduction of 110 bps during February-August 2019, the weighted average lending rate (WALR) on fresh rupee loans of commercial banks declined by 29 bps. However, the WALR on outstanding rupee loans increased by 7 bps during the same period.

Central banks around the world are loosening monetary policy to offset a global slowdown, worsened by US-China trade tensions. The rate cut by the RBI follows a series of fis-cal steps taken by the Government over the last six weeks to spur growth, including steepest ever cut in tax paid by companies, cost the exchequer ₹1.45 lakh crore.

Asked if the corporate rate cut would impact fiscal deficit target of 3.3 per cent of the GDP, Das said the Government has stated that it will maintain fiscal deficit target and "we have no reason to doubt that".

Admitting that the impact of the 135 bps rate cut will "take time" to filter in, Das said, "While the recent measures announced by the Government are likely to help strengthen private consumption and spur private investment activity. the continuing slowdown warrants intensified efforts to restore the growth momentum.

The RBI raised its nearterm inflation forecast slightly to 3.4 per cent for the second quarter of the fiscal started in Åpril, while projecting it would stay below its medium-term



target of 4 per cent.

On reviving growth, the MPC welcomed the recent moves by the Government as the ones in the right direction, but the resolution did not have any reference to the fiscal deficit or fiscal management, which is generally deemed to have an inflationary impact.

Meanwhile, after opening nearly 300 points higher, the Sensex gave up all the gains to turn negative shortly after the policy announcement by the RBI. The Sensex gyrated 770 points during the day to end 433.56 points or 1.14 per cent lower at 37,673.31. It hit an intra-day low of 37,633.36 and

a high of 38,403.54. The broad er NSE Nifty plunged 139.25 points or 1.23 per cent to close at 11,174.75. During the holiday-truncated week, Sensex plummeted 1,149.26 points or 2.96 per cent, while Nifty declined 337.65 points.

Top laggards included Kotak Bank, ICICI Bank, HDFC Bank, Tata Motors, L&T, SBI, Tata Steel and Axis Bank. On the other hand, TCS, Infosys, ONGC, Tech Mahindra, IndusInd Bank and NTPC rose up to 1.03 per cent. Rate-sensitive banking stocks faced the heat, finance, auto and realty indices tanking up to 2.45 per cent.

Ankara, which has issued several statements on Kashmir since August 6, to have a proper understanding of the situation in Kashmir before making further comments. "India and Turkey are

friendly countries. We, therefore, deeply regret that since August 6, there have been repeated statements by the Turkish Government on a matter completely internal to India. These statements are factually incorrect, biased and unwarranted," Kumar said. Malaysian Prime Minister

"Government of Malaysia should bear in mind the friendly relations between the two countries and desist from making such comments," he added.

Shooters of Feb 27 copter won't be spared: IAF Chief 7 were killed in friendly fire when MI-17 chopper in Budgam was brought down

Indian Air Force (IAF) chief RKS Bhadauria on Friday said "it was a big mistake" by IAF men to bring down the MI-17 chopper on February 27 in Jammu & Kashmir, killing all on the ground. He said the Commission of Inquiry (CoI) is over and action will be taken against the guilty.

Officers may face charges of culpable homicide not amounting to murder as per provisions of the military law and IAF top brass will decide on the quantum of punishment, said sources.

Hit by a surface-to-air missile of the IAF, the helicopter crashed in Budgam shortly after take-off from Srinagar.

The incident took place on a day when the Pakistani fighter jets intruded into Indian airspace and tried to hit Indian military targets in Rajouri sector in retaliation to the IAF air strikes against terrorist infrastructure in Balakot a day earlier.

"It was a big mistake, action being initiated against two IAF personnel," said Bhadauria, adding following the CoI corrective measures have been taken so it does not happen again and those who

lost their lives will be declared battle casualties.

He said this at his first annual Press conference as IAF Chief ahead of the 87th Air Force Day on October 8. Bhadauria took over as the IAF Chief on September 30 from outgoing Chief BS Dhanoa. He also said the Court of Inquiry got over last week.

The Commission of Inquiry confirmed that the chopper was shot by Israeli origin ground based Spyder surface to air missile system of the IAF. The probe found at least five officers, including a Group Captain responsible for the crash, defence sources had

stated earlier. The Pioneer had reported on August 23 that the high-level probe by the IAF had held five officers guilty as it was found out that the helicopter went down after getting hit by an Indian missile.

These findings formed part of the mandatory court of enquiry. The officers found guilty of negligence and not following procedures include one Group Captain, two Wing Commanders and two Flight Lieutenants, sources said.

The enquiry found that the 'Identification of Friend or Foe' (IFF) system on board the helicopter was switched off and there was a "vital gap" in communication and coordination between the ground staff and the crew of the illfated helicopter. The IFF helps air defence radars identify whether an aircraft or helicopter is friendly or hostile. In early May, the IAF transferred (AOC) of Srinagar base to ensure a thorough probe into the incident.

Officials said the CoI was also specifically focusing on examining the role of various people, including those controlling the air defence system when the helicopter was hit by a surface-to-air missile. Incidentally, the helicopter

was shot down around the same time when Indian and Pakistani fighter jets were engaged in the aerial battle. Moreover, the incident took place when the Indian forces on their highest alert following the Pakistani aerial raid. The helicopter crashed within ten minutes of take off after getting hit by own missile. Earlier, the then IAF Chief

Now travelling will be easy for the people living in rural belts of South West Delhi, as the much awaited 4.2 kilometers (km) long Grey Line of Delhi Metro has finally thrown open to the public on Friday. Buying sensors to thwart drone attacks: IAF Chief





¬he Bombay High Court on The Bombay High Court on Friday dismissed all petitions challenging the proposed felling of 2,646 trees in Aarev Colony at Goregaon in north Mumbai to make way for construction of a car shed for Metro phase-III, after addressing the environmental concerns raised by the petitioners.

Holding that the decisionmaking process on tree felling adopted by the Tree Authority of the Brihanmumbai Municipal Corporation (BMC) as "fair, transparent and based on reason", a HC division bench of Chief Justice Pradeep Nandrajog and Justice Bharati Dangre noted: "The Carbon dioxide sequestration of 2,702 trees for their entire lifetime calculated at 12,79,062 kg would be compensated in 3,948 fully loaded trips of Metro Trains operating".

The HC bench refused to declare Aarey Colony a forest and also declined to quash the BMC tree authority's decision allowing felling of over 2,646 trees in the green zone to make way of a metro car shed.

Dismissing the petitions filed by green activist Zoru Bhathena and Shiv Sena corporator Yashwant Kamalakar Jadhav, the HC bench observed: "Thus, as in the two companion



petitions which we have dismissed today, the Greens fail even in these two petitions, but not on account of sailing their boats in the wrong channel, but

The HC bench imposed a fine of ₹50,000 on Yashwant Jadhav, who had filed a petition against the approval granted by the civic body's tree authority. He is a member of the BMC's tree authority.

Terming all the petitioners "Davids" (environmentalists) taking on the industrial "Goliaths", apparently suggesting that they are fighting an unequal battle, the court said: "Relationship with nature and love for environment alone is true and all other relationships are unreal and temporary, is their (environmentalists) belief. Their hearts are a temple of devotion to flora and fauna".

concerns raised by the petitioners, the Judges noted: "In connection with the issues of environmental concerns, it has to be noted that the project proponent has already planted 20,900 trees with GPS tagging on each plant in Sanjay Gandhi National Park and the survival rate is 95%, proved by the letter dated 27th September 2019 addressed by the Chief Conservator Forest and Director Sanjay Gandhi National Park to the Chief Project Manager of MMRCL. This establishes that about 7 times the number of trees to be felled have been replaced by planting saplings of trees, which process commenced two years

"Further, the project is being financed substantially by Japan International Cooperative Agency ("JICA") and the project is registered with The United Nations Framework for Climate Change (UNFCC). It is thus being monitored by Foreign Agencies on the environmental

impact," the judgement stated.
"The project report demonstrates that the benefits and/or emissions by virtue of the project demonstrate that the same would be reduced by 2,61,968 tonnes over ten years because of reduced dependence on motarised transport," the HC bench observed.

The green activists, of which Bhathena is part, have been protesting vehemently against the decision taken by the BMC's tree authority on August 29 to allow cutting of 2,185 $\bar{\text{trees}}$ and transplantation of 461 trees.

While giving a go-ahead to the MMRCl to cut 2,185 trees and transplant 461 trees in Aarey Colony for construction of car depot for Metro-3 corridor, the BMC's Tree Authority had said that the MMRCL would have to plant 13,110 trees

In its petition filed in the high court, activist Bhathena had challenged the proposed felling of 2,648 trees in Aarey Colony to make way for construction of a metro card there by saying that the decision taken by the BMC's Tree Authority, taken on August 29 this year, approving the felling of trees to make way for a metro car shed was not in accordance with a previous order of the high court.

Rahul attacks PM over FIR

Muzaffarpur/Wayanad: An FIR has been lodged in Bihar's Muzaffarpur against nearly 50 celebrities, including Aparna Sen, Adoor Gopalakrishnan and Ramchandra Guha for alleged sedition after they wrote an open letter to Prime Minister Narendra Modi voicing concern over growing incidents of mob lynching.

Police said the FIR was lodged on Thursday under several sections of the Indian Penal Code, including those related to sedition, public nuisance, hurting religious feelings and insulting with an intent to provoke breach of peace.

Reacting sharply to the registration of the FIR against eminent film personalities, writers and others, Congress leader Rahul Gandhi alleged the country was moving towards becoming an "authoritarian state" where anybody who said anything against Modi or his government was put behind bars.

The case was lodged following an order by Muzaffarpur Chief Judicial Magistrate Surya Kant Tiwari on a petition by local advocate Sudhir Kumar Oiha, who claimed, among other things, that the letter supported secessionist tendencies"

"The CJM had passed the

order on August 20, accepting my petition upon the receipt of which an FIR was lodged at the Sadar police station here," Ojha said. He said nearly 50 signatories to the letter were named as accused in his petition, which accused them of having "tarnished the image of the country and undermined the impressive performance of the prime minister", besides "supporting

secessionist tendencies" The letter was written by 49 eminent personalities, also including filmmakers Mani Ratnam, Anurag Kashyap, Shyam Benegal, actor Soumitra Chatterjee and vocalist Shubha Mudgal in July this year.

Rahul Gandhi, who was away in his constituency Wayanad in Kerala, denounced

He said it was not a secret anymore that the country was moving towards an authoritarian state, adding that the prime minister should tell the country why had he "destroyed" the economy and created "massive joblessness".

"Everybody knows what is going on in the country. It is not a secret. In fact, the whole world knows it. We are moving towards an authoritarian state. It is pretty clear," the Wayanad MP, who has come to his constituency to express solidarity with the protests against the night traffic ban on a highway passing through the Bandipur

'Anybody who says anything against the prime minister, anybody who raises anything against the government is being put in jail and attacked. The media is crushed. Everybody knows what is going on. This is not a secret," he said.

An FIR was filed at Bihar's Muzaffarpur on Thursday against around 50 celebrities, including Ramachandra Guha, Mani Ratnam, Adoor Gopalakrishnan and Aparna Sen, who had written an open letter to Prime Minister Modi raising their concern over the growing incidents of mob ynching in the country.

Burdwan (WB): Ten persons were arrested here on Friday for alleged assault on Debanjan Ballav — a Sanskrit college student who was accused of heckling Union Minister Babul on September 19.

In his complaint, Ballav, who has been in the eye of storm over the JU campus episode, claimed that he and his girlfriend were dragged out of a bus and assaulted by the activists of Akhil Bharatiya Vidyarthi Parishad (ABVP) near Burdwan on Wednesday.

"Based on Ballav's complaint, we have arrested 10 persons. We are still investigating the matter," East Midnapore Superintendent of Police Bhaskar Mukherjee said.

He, however, declined to comment on whether those arrested were members of the

ABVP. The right-wing students' outfit, on its part, said Ballav's charges were "baseless and politically motivated".

Slump in sponsorship, Durga puja loses its shine

Kolkata: The economic slowdown has dimmed the lights of Bengal's biggest festival this time, forcing Durga puja organisers to scale down celebrations due to shrinking sponsorship.

Not just small-budget pujas, big-ticket ones have also curtailed their budget by nearly 15 per cent to 30 per cent, mostly compromising on marquee decoration, according to organisers.

On an average, setting up a theme-based marquee for the five-day fiesta, replete with safety arrangements and basic amenities, costs anything between ₹12 lakh and ₹30 crore in Bengal. "Owing to economic slow-

down, we failed to achieve our target of Rs 65 lakh. We are running short of Rs 20 lakh. Most

sponsors, this time, either declined to make a contribution or paid less than what they do,' Sudipto Kumar, an official of Deshapriya Park community Puja in south Kolkata, said.

Corporate firms are not willing to spend on advertisements, he claimed.

"Every year, huge advertisement hoardings and posters greet revelers outside the puja pandals, but this time, the numbers have shrunk considerably," he added.

Echoing similar sentiments, Ekdalia Evergreen Club said several sponsors have gone back on their promise, citing the ailing economy. "Some sponsors, who had

signed a contract with us, have also backed out. In 2008-2009 (during global recession), we had faced a similar situation," club secretary Gautam Mukherjee said. Organizers have made sev-

eral modifications this year, mostly cutting down on promotional activities. Kajal Sarkar, the president

of Forum for Durgotsab, said sponsorship has fallen by 30-50 Donations, subscriptions

and retail advertisements cover about 30 per cent of the expenses, the rest is usually taken care of by corporate funding," Sarkar said. The situation has gone worse for small-budget Durga pujas committees, with some of the organisers opting for a marquee without any distinct

theme.

Since 2014, the DMK has been attacking the Centre of trying to impose Hindi over non-Hindi States in the country.

In an exclusive interview given to the popular Tamil literary journal Kanaiyazhi (Tamil for Ring) in its April 1967 issue,

The journal had carried the interview with Annadurai in its April 1967 and has since then, formed one of the prized items of Kanaiyazhi. 

Capt Amarinder Singh has pre-empted Pak's invitation by including the ex-PM in the all-party jatha to Kartarpur shrine



he Congress, against the backdrop of Indo-Pakistan tension, has had to battle a perception war whenever it has tried to play the responsible Opposition and critique Government policy. For Pakistan has mischievously played up comments made by party leaders in the domestic context to justify its stand on internationalising Kashmir, making them look like its ally than nationalist. This time, too, the Congress was stumped by the Pakistan regime's surprise move to invite its senior leader and former Prime Minister Manmohan

Singh for the inauguration of the Kartarpur corridor, considering his stature as a Sikh notable. This caused embarrassment in Congress circles because an official invite for the corridor, that will connect Darbar Sahib, set up in 1522 by Sikh faith founder Guru Nanak Dev to Dera Baba Nanak shrine in Gurdaspur district on our side, was clearly meant to ignore protocol and bypass Prime Minister Narendra Modi. Had it been well-intentioned, there could have been a joint inaugural from either side or at least an official communication sent. But it was maleficent, aimed at embarrassing an Opposition party, which would look weak-kneed and a pawn in Pakistan's designs to a home audience and rile up the ruling BJP at once. Islamabad's hypocrisy is stark considering it had not responded to Singh's offer of visa-free access to the shrine in 2004 when he was the Prime Minister.

The matter though was deftly handled by Punjab Chief Minister and Congress veteran Amarinder Singh. To blunt both Pakistan and any liberal query as to why Singh would not qualify as a Sikh notable worthy of visiting the hallowed shrine, the Punjabi strongman has now proposed that he be part of an official State Government jatha or delegation that would visit the shrine. He also clarified that the jatha would stay clear of the Pakistan-organised ceremony as it was in the nature of a pilgrimage. He has even invited Modi and President Ram Nath Kovind for celebrations on the Indian side. Clearly, now that its level-playing field has been upturned in Jammu & Kashmir, and with both the West and the Islamic world supporting India's position on its changed status, Pakistan doesn't want to isolate the Sikhs or lose the trumpcard of Khalistan. Particularly, after its Prime Minister Imran Khan's "cry wolf" threats of a nuclear war have dented the nation's credibility at international fora. So the Pakistan Army, without whom Khan would not have been in the chair, has decided to up the pro-Khalistan extremist agenda and foment trouble in Punjab. While announcing the Kartarpur project initially, Pakistan had appointed several Khalistani separatists on the committee, much to India's discomfort. Its former Army chief Gen Mirza Aslam Beg openly advised the military and the Government to use the Kartarpur corridor for Khalistan terror and "create trouble for India." Recently, the Pakistan Army even got pro-Khalistani supporters to challenge the reorganisation of Kashmir. No matter how hard India may try to make Kartarpur a matter of people-to-people concern, the fact is that Pakistan's initiative on the Kartarpur corridor will never be free of politics. Pakistan seized the first mover's advantage in the propaganda warfare by declaring its intention to operationalise it soon after Capt Amarinder blamed Pakistan and the ISI for the grenade attack on a Nirankari gathering near Amritsar. With that announcement, it got its own minority Sikhs on board, a favourable opinion from the extended community around the world, revived the hardline Khalistan sentiment and eventually tried to foment disturbance in Punjab. India had no choice but to get into the act immediately before it could assess if it was another attempt by Pakistan to woo the Sikh community. India has to be alert that the base camp on the Pakistan side doesn't become a hotbed for Khalistani propaganda and meetings in the name of allowing faith congregations. Pakistan Army chief General Qamar Bajwa stood in Kartarpur, shaking hands with known Khalistani face Gopal Singh Chawla, much to India's discomfiture. Pakistan is trying to project itself as a champion of minority rights and their religious freedoms and India cannot afford to let its guard down or allow a new proxy war to brew

Turtle poaching

As the species is culled to cater to the food and medicine market, there is a glaring gap in enforcement of wildlife laws



f there was any doubt about man being the worst predatory species that is depleting animal life as we know it, digest this. At least, 200 freshwater turtles and tortoises per week have been poached in India to cater to the illegal gourmet food, live pet and medicine market since 2009, taking the number to a whopping 1,11,310 till September 2019. It is known that India is a major hotspot in illegal wildlife trade because even though it is only 2.4 per cent of the world's land area, it contributes about eight per cent of known

global wildlife. While the main consumer markets are China, South East Asia, the Gulf states, Europe and Northern America, what is alarming is that the domestic demand for exotic meat and pets is also growing. The size of seizures of Indian species within the country is indicative of a well-organised network of collectors, transporters and traffickers operating this trade. Another fact sheet showed how the Indian star tortoise, marked as a vulnerable species by the International Union for Conservation of Nature, accounted for 49 per cent of the total reptiles seized and were high in demand by gourmets and mendicants. Most turtles and tortoise species of India are protected under various Schedules of the Wildlife (Protection) Act, under which hunting, trade or any other form of utilisation of the species or their body parts and derivatives is banned. All turtle and tortoise species from India are also listed under the Convention on International Trade in Endangered Species of Wild Fauna

and Flora (CITES) regulating their international trade. But it's not just these reptiles that are bearing the brunt of the flourishing illegal wildlife trade, some of the species and products incessantly poached and smuggled out of the country are tiger and leopard skins, their bones and other body parts, rhino horns, ivory, sea horses, snake venom, musk pods and rare birds. Despite laws, lack of awareness, anonymous e-commerce, greed and low-risk, high-reward opportunities fuel wildlife crime in the country. Also, in India like in many other countries, the problem is not of the laws but poor communication, implementation and enforcement. Arrests have hardly worked as a deterrent. So making laws is not enough, we need synergy between all law enforcement agencies. In addition to this, providing grant through National Tiger Conservation Authority (NTCA) for patrolling in the tiger-rich sensitive forest, combing forest floors in order to keep a check on the snares for the animals by poachers, improved surveillance using thermal cameras are some of the measures needed on a larger scale.

Harness the power of sun

To achieve the target of installing 100 GW of solar energy by 2022, a more comprehensive manufacturing strategy is needed. We cannot remain dependent on imports

ecently, while addressing the UN Climate Action Summit 2019 in the US, Prime Minister Narendra Modi said, "We believe that an ounce of action is worth more than a tonne of preaching' and announced that India had ambitious plans to harness solar energy. A target of installing 175 gigawatt (GW) of renewable energy by 2022 has been set, which may further increase to 450 GW by 2030. The Government had an initial target of 20 GW of solar capacity by 2022, which was achieved four years ahead of schedule. Encouraged by this performance, the target was revised in 2015 to 100 GW, which has now been further raised, as the Prime Minister informed in his address.

To meet this goal, a series of solar power projects such as the Solar Parks and Ultra Mega Solar Power Projects, Canal Solar Power Project and the installation of 1,00,000 solar pumps for farmers are at different stages of implementation. Solarisation of nearly 50,000 petrol stations across the country is also being promoted. Over 3,000 fuel stations are already solar-powered. Considering that India is the fourth-largest emitter of carbon dioxide in the world, solar energy appears to be a very convenient alter-

India is lucky that sunlight is available in abundance but the challenge lies in the procurement of solar Photo Voltaic (PV) cells, which is one of the major constrain ing factors in our efforts to realise the full potential. According to a report submitted by the parliamentary standing committee, in order to achieve the target of 100 GW of solar electricity capacity by 2022, India should have had an installed capacity of 32,000 megawatt (MW) by 2017-18. But as of January 31, 2018, the country only had a capacity of 18,455 MW. As per the standing committee, the Ministry of New and Renewable Energy has to install the remaining 81,545 MW in just four years - this is over 20,000 MW a year and appears difficult to achieve.

A serious lacuna in the entire exercise is our poor record in indigenous manufacturing of solar panels. Today China is the only country that caters to most of the global PV cell demands. It produces the cheapest solar panels. It is difficult for any country to match such low prices. This has led to a situation where China has a virtual monopoly and this may not be desirable in the long run. accounted for 90 per cent of 2017 sales, up from 86 per cent in 2014. Thus, it is paradoxical that both our sources of energy and oil as well as solar are currently

heavily dependent on imports. The world's annual solar capacity reached close to 500 GW last year, which may go up to 3,000/5,000 GW by 2030, a



ten-fold increase. In the next 30 years, this demand is likely to increase by hundred times and the major beneficiary will be China.

Strategically, it will not be logical for India to continue nourishing the Chinese monopoly as it would introduce serious imbalances in the global situation. This calls for the need to prioritise the expansion and investment in the manufacture of PV cell industry. In the near future, hydrocarbon resources are going to be scarce and, hence, the emphasis on electric vehicles (EVs). They can be charged directly using PV cells. This will not only bring down the carbon dioxide emission levels but also reduce our dependence on fossil fuels.

To actualise such a situation, we must start investing in lithium ion batteries. Here, too, the Chinese have an upper hand and, hence, the need to look for alternatives. Lithium with PV cells, once they lose their efficiency in cars, can be reused for domestic solar battery applications.

lishment of solar plants in a densely populated country like India can become a major issue. It has been estimated that the setting up of a 1 MW power solar plant requires two to three hectares of land. In case the solar panels are thinfilm based, requirement of land can go up to four to five hectares. As for the first case, wastelands or land that is not available for cultivation can be used for the setting up of solar parks.

In order to improve efficiency of solar panels in these parks, directional limitations in the existing design have suitably been addressed by devising a tracking system. A solar tracker is a device that is used to orient the panel towards the sun. For flat panel PV systems, a solar tracker ensures that the sun's rays fall at the correct angle of incidence. A solar tracker fitted PV panel can show considerable improvement in its efficiency.

on two axis and follows the sun vertically as well as horizontally so that the panel gets the best incidence of sun rays, thus increasing its efficiency by about 20 per cent. Nevertheless, in areas where land is available like Rajasthan,

dust is a major problem, which over a period of time, tends to erode the efficiency of the solar panels.

But all is not lost as we may not have to put all our eggs in the Chinese basket. For direct generation of electricity, the solar thermal route can also be explored. An array of parabolic mirrors helps put the focus of the sunlight at the right place to produce sufficient heat, which raises steam and can be used to run a turbine, thus generate power.

Currently, this technology being used in the US (California), Israel, Spain and Germany. In India, two plants are already operational in Raiasthan and six others are under construction, all in the private sector. The model experimental plant to harness solar energy through the thermal route was inaugurated just outside Delhi in January this year and is running up to 50 per cent efficiency. The develmanufacturing facilities is important to harness solar energy. This needs attention and on priority.

Take a page out of UAE's book

Modi should emulate the Gulf nation to attract foreign investment and bring the country out of the economic crisis it is in

Indian stock markets are worrying investors, the auto sector is going through a bumpy ride, the aviation industry has already witnessed an emergency landing with the collapse of Jet Airways, and in between the land and sky, the rupee is sinking in the foreign exchange markets. All these indicate that the health of the country's economy is not very sound, if not critical. Right now, the dream of making India a \$5 trillion economy by 2025 seems quite distant and with the Gross Domestic Product (GDP) at five per cent, there is a dire need to get closer to all trade allies, including America, the United Kingdom (UK), Germany and the United Arab Emirates (UAE),

Recently, during his trip to the UAE, Prime Minister Narendra Modi said, "India has found a valuable partner in the UAE to achieve its ambitious dream of becoming a \$5 trillion economy." He went on to add that, "There has been an increasing interest in investments in India in sectors ranging from renewable energy, food, ports, airports, defence manufacturing and other industries.

Close on the heels of Modi's visit to the UAE, the most recent development which came into focus was National Security Advisor (NSA) Ajit Doval's trip to the Gulf nation and his meeting with Sheikh Mohammed bin Zayed Al Nahyan, Crown Prince of Emirate of Abu Dhabi. Both these diplomatic initiatives are considered quite meaningful for reinforcing trade ties between the two countries, especially oil deals, as the UAE accounts for eight per cent of India's oil imports and is the fifth-largest supplier of crude oil to the country. The NSA also met Tahnoun bin Mohammed Al Nahyan, chairman of the UAE's state-owned oil company, the Abu Dhabi National Oil Company (ADNOC). His initiative is expected to foster the joint investment initiative of Saudi Arabia's Aramco and ADNOC as they are planning to invest \$44 billion in a refinery in India's west coast.

After China and the US, the UAE is the third-largest trade partner of India and the trade between the two countries registered a 20 per cent growth in the fiscal year 2018-19. Consequently, Indian exports grew by seven per cent whereas the UAE's exports increased by 37 per cent. Now, the two countries are keen to exceed the \$100 billion-mark in bilateral trade by 2020.

Also, as the UAE accommodates around 3.3 million Non-Resident Indians (NRIs), it is the highest contributor to India's remit-

The UAE is known for maintaining good relations with its trade allies. Be it the US, the UK, Japan, Germany, China or France, the Gulf state has cordial business relations with all the leading economies of the world. Consequently, due to its friendly trade policies and good infrastructure, the UAE acquired 17th position in the Global Competitiveness Index (GCI). Its smart strategies of enticing foreign investors and retaining them by providing quality infrastructure enables it to perform better even in a difficult scenario.

The demands of foreign businesses and investors are advanced infrastructure, business-friendly policies, 100 per cent foreign ownership, zero or minimal taxation and political stability. The UAE has all these advantages and that's why it attracts investors. Also, its policy reforms like unification of local financial markets, new laws to facilitate mergers and acquisitions, the establishment of the public debt management office and creation of a more efficient labour market have played a vital role in strengthening the coun-

India provides ample business opportunities due to the large domestic market, availability of natural and human resources, improved transportation and logistics, plus easy and affordable access to the internet. Besides, it is emerging as a hub for startups and the job market is full of competitive talent. In the last few years, the Government has launched some commendable programmes such as 'Make in India' and 'Start-up India' to boost economic growth but they failed to bring the desired results, primarily due to lack of funds. Unfortunately, these initiatives couldn't impress international investors, and many promising ventures were shut down due to the non-availability of working capital. Indeed, attention was not paid by policymakers on factors responsible for assuring for-

Thereby, to provide the required stimuli to the Indian economy, Modi should emulate the UAE to attract foreign investment and bring the country out of the economic slowdown. Foreign investment is the most pressing need today and all possible steps should be taken to invite it. India has close business allies such as the US, UK, Japan, Israel and Russia and they have enough investment potential. New Delhi needs to convince them that the country is full of highly rewarding opportunities.

Toothless tigers

Independent directors should be able to question the promoter group and serve the interest of minority shareholders in boardrooms. For this to happen, the SEBI has to empower them

strong independent director is an asset to an organisation if he/she has the ability to Lobjectively analyse affairs to bring about a convergence in the views of different shareholder groups and works towards protecting the interests of minority stockholders and the company as a whole. Such a person increases the transparency and accountability of the board and can pave the way to making it strong.

After the ₹7,000 crore 2009 Satyam financial

fraud, several committees were set up and their recommendations paved the way for India's new Companies Act, 2013, which clearly established the responsibility and accountability of independent directors and auditors. Over the years, there has been a sea change in their duties and obligations, with an increased expectation to play an active and vigilant role in the decisions that are being taken by the company at the board level. In order to make the corporate governance

structure stronger, the Government has tightened the norms and taken the relatives of independent directors under its ambit and amended the Companies (Appointment and Qualification of Directors) Rules, 2014. It has ordained that no relative of an independent director should be in any way "indebted" to the company, its holding, subsidiary or associate company, promoters or directors. Additionally, relatives cannot give guarantee or provide any security in case of indebtedness of any third person to the company or its promoters and subsidiaries. The new rules would govern all transactions involving an amount starting from ₹50 lakh in the preceding two financial years or even the current year.

Now the question arises, whether independent directors are caught in a catch-22 situation with stringent regulations on one side but do not have enough power to govern company operations as they are not involved in day-to-day function-

It is common knowledge that many boards are more of a "friends club" with directors rarely raising any contentious issues. According to the theory of critical mass, any person, being in minority in a group, would not be able to exert his/her point of view and generally tends to go with the decisions of the majority. So, any independent director with a divergent view may not be comfortable in expressing his/her views and may quite prevalent, considering the fact that many corporate governance mismanagements, like the liquidity crisis among the NBFCs due to the unexpected default by IL&FS, have come to light recenty and the independent directors were also

Now, a majority of independent directors are finding it difficult to discharge the stringent statutory duties that have been thrust on them by the changes made to the Companies Act. Consequently, the number of resignations this year went up by 30 per cent and many eligible and experienced members of business and bureaucracy refused to accept positions as independent directors. Although almost all have cited personal reasons for quitting, it's clear that they are resigning because of some inkling of corporate mismanagement. However, Anil Khandelwal, former Chairman and Managing Director of Dena Bank and Bank of Baroda and also independent direc-

One cannot expect independent directors to function at their best with possible information asymmetries, which stems from the fact that the structure of Indian companies is quite different from that of firms in the West. In the US, the ownership is diverse and not concentrated in a few hands and the role of independent directors is to protect the interests of shareholders. For instance, 61.1 per cent of Dow Jones-listed technology major Apple, is owned by various institutional investors, 27.89 per cent by mutual funds and 1.06 per cent by Levinson, Chairman and CEO Tim Cook and so on and 9.95 per cent by other investors. Compare this with Indian technology giant Wipro, 74 per cent of whose ownership is with the promoter/promoter group, 16 per cent with institutional investors and a mere 5.66 per cent with the general public or retail investors. This shows that ownership and management are not separate in India, mostly dominated by families and maintaining freedom of independent directors is questionable, peculiar and challenging.

This brings us to the major difficulty that is being faced by independent directors — the selection process. Will the monitoring role not be hampered, given that the majority shareholders have a strong influence on selection and sus-

tenance of independent directors? In an attempt to enhance their eligibility criteria and role, the Securities and Exchange Board of India (SEBI) has accepted the recommendations of the Kotak Committee that an independent director must provide an undertaking of his/her liberty and this declaration must be taken on record by the board of directors of the listed company after duly assessing its veracity. In addition, there must be no "board inter-locks", which means that if A, being a non-independent director of a listed company X, is an independent director of company Y, then any non-independent director of company Y cannot be an independent director of the listed company X.

The second problem faced by them in exercising wisdom is inadequate knowledge about the organisation, as ownership and access to information

ownership and access to information remain in the hands of the controlling stockholders. This is the case in most companies and independent directors just have a ceremonial presence. They and their reputation can get tarnished because of the wrongdoings of firms. For instance, the Satyam episode defamed six famous corporate and academic per-

Their plight is apparent from the fact that after the confession by Satyam founder B Ramalinga Raju on January 7, 2009, some 115 independent directors of more than 100 listed companies quit within a month.

As per sub-section four of Section 149 of the Companies Act, 2013, at least 50 per cent of the board should have non-executive directors. If the chairman is a non-executive director, then at least one-third of the board should comprise independent directors. If the chairman is an executive director, then independent directors should make up at least

half of the board. If an independent director resigns or is removed from the board, he/she has to be replaced by a new one within 180 days. With these changes, it is expected that India Inc. would need an additional 5,000 of them by 2019-end, which is quite challenging in itself. According to the Kotak Committee, there must be at least one independent woman director on the board of the top 1,000 listed companies by April 1, 2020. With the slew of recent resignations, there is a definite gap here. Although databanks are available from where independent directors can be selected, this experience has not been encouraging as companies prefer having a known than an unknown face on their boards.

Concrete steps need to be taken to improve the functioning of independent directors. First, apart from the controlling shareholders having a say in their appointment and removal, minority shareholders should also participate in the process for the sake of transparency. Second, SEBI should also create an tors can report any malpractices. If they have to honestly monitor performance, advise the Chief Executive Officer and protect the interests of minority sharenolders, they must unite and become a robust team capable of extracting infor-

mation for better decision-making. Finally, they should not be held liable for any mismanagement by firms unless they have power and knowledge to prevent the same. Independent directors should have the power to question the promoter group and dispassionately serve the interest of minority shareholders in boardrooms. For this, SEBI has to create structures to ensure that they are more than mute and passive participants in board meetings.

The success of Howdy Modi is a reaffirmation of India's global impact and its growing soft power in the world



he USA loves India", tweeted American President Donald Trump as he enthusiastically shared the Indian Prime Minister's Offices' message thanking and applauding the energetic presence of the huge Indian diaspora at Houston, to mark the successful celebration of the Howdy Modi event. The strength and show of personal chemistry between Prime Minister Narendra Modi and Trump at Houston does mark a watershed moment in Indo-US relations. As Modi called for a standing ovation for Trump from the 50,000-strong Indian-

thanked the American people for their "exceptional welcome and hospitality" during his visit to the US.

Beginning from the meeting between former US President Obama and Modi in 2014, to the first-ever trilateral engagement between India, Japan and America in 2018, the leadership of both the countries has reaffirmed the importance of strong Indo-US ties. There is a greater set of convergence between both the nations, ranging from a "free and open" Indo-Pacific region to the fight against global terrorism. Over the years, the relationship between these two mature democracies has evolved significantly, which is not subject to any kind of "transactional framework" and rather is witnessing a more robust "strategic alignment."

India has sought to transform itself from being a "balancing power" to a more "willing state" in redefining its pri-

The same is reflected in India's active public diplomacy in the last few years, seeking increased global footprints with an emphasis on the nation's soft power attributes and civilisational strengths. The Indian-American community has been one of most successful in driving the advanced technological revolution in the US.

Modi's charismatic and popular leadership appeal and its hyper-energetic diplomacy have backed this process in recent years across the globe. The soft power credential of India is now backed by hard power choices in terms of strategic alignment and tactical diplomacy in foreign policy-making under his leadership.



In the last few years, the Indian Government has sought to build on developing new linkages in Indo-US relationship. The Declaration of Friendship to elevate strategic dialogue to a strategic and commercial dialogue in January 2015, the Joint Declaration against Combatting Terrorism in September 2015, developing

International Solar Alliance in 2016 and the initiation of the 2+2 Dialogue between India and the US are some key developments which define the nature of bilateral relations in recent years. Indo-US defence ties have also seen an increased level of engagement. In 2016, the two governments signed the Logistics Exchange Memorandum of Agreement

(LEMOA) and in 2018, the Communications Compatibility and Security Agreement (COMCASA). İt enabled India access to US technology and utilisation of its existing platforms. Today, India is a major defence partner of the US, and there has been a significant amount of increase in military hardware imports to the country. Moreover, after a gap of nearly eight years, the Cope India exercise between Indian and American air forces was organised.

Nonetheless, bilateral relations still face limitations on the trade front as market access has been a key issue of contention. However, Modi pitched for US investment support as India looks to build a \$5 trillion economy. While Modi reassured Trump that he was learning from the President the "art of the deal", it remains to be seen how both the leaders surmount difficulties in bilateral

trade negotiations. On the global level, these

developments do pave the way for a greater understanding and better institutional cooperation. More importantly, the developments in the Indo-Pacific have come with their own set of challenges that underline the necessity of cooperation. The meeting of foreign ministers from India, the US, Japan and Australia expressed their commitment to strengthen "rules-based order" in the Indo-Pacific.

At his speech at the United Nations General Assembly, Modi highlighted the importance of global action to fight against terrorism; climate change and healthcare challenges. The visit in his own words has been an "extremely productive one", as he engaged with a wide and different set of people from industry to diplomacy; civil society; business communities and political leaders. To mark the 150th birth anniversary of Mahatma Gandhi, Modi invoked his

vision for peace and prosperi-

ty for all at the inauguration of the Gandhi Solar Park. In his meeting with leaders from Pacific island nations, he underlined India's commitment to advance their development priorities. The show of political

warmth and trust between both the leaders shall lead to something more tangible in terms of trade negotiations and cooperation. This will allow them to set more long-term objectives for commercial and trade engagements. As both India and the US

seek to consolidate on gains from this comfort in relationship, it is necessary that both move beyond the framework of a "top-down approach" and seek to institutionalise this "strategic alignment" at different levels to make it a more cogent and structural partner-

CII Director General Chandrajit Banerjee said the cumulative 135 basis points rate cuts this year along with a slew of measures announced by the government to provide growth stimulus to a variety of sectors is expected to lift growth from its current stupor and unleash animal spirits.

"This further reduction of repo rate will not only bring down the lending rates but also incentivise investment and boost consumption," said Surendra Hiranandani, CMD, House of Hiranandani.

The RBI's latest move to trim repo rate comes at a time when the economic growth has hit a six-year low of 5 per cent. This is the fifth straight rate cut by the central bank in as many policy reviews in 2019, and takes the total quantum of reductions to 1.35 per cent. Exporters body FIEO's President Sharad Saraf however, said the challenges in exports will continue and may aggravate with geo-political situation.

Donald Trump openly called on China as well as Ukraine to investigate his potential 2020 election rival Joe Biden, taunting Democrats seeking his impeachment for inviting foreign election interference.

Trump's request that Ukrainian President Volodymyr Zelensky probe the activities of Hunter and Joe Biden, the frontrunner for the Democratic presidential candidacy, has sparked an impeachment probe in the US.

Prosecutor-General Ruslan Ryaboshapka told reporters his office would revisit about 15 cases but stressed that they were not necessarily connected to Biden's son, Hunter Biden.

"We are conducting an audit of the cases that were earlier

overseen by the Prosecutor-General's Office," said Ryaboshapka, who was appointed in August.

"We are reviewing all cases that were closed or broken up into separate cases, to make a decision on whether this was illegal." Ukrainian authorities have previously said the investigation into gas firm Burisma focuses on a period before Hunter Biden joined the company's board.

Ryaboshapka also suggested the prosecutors may focus not on Hunter Biden but on Burisma's founder Mykola Zlochevsky and other figures.

"As far as we can see, this is more a question of Zlochevsky and Ukrainian businessman Sergei) Kurchenko than Burisma and Biden," he said.

Greece has felt under increasing pressure. For the first time since 2016, the country has become the main port of entry into the European Union for migrants and refugees arriving via Turkish shores.

The UN refugee agency (UNHCR) announced on

Tuesday that arrivals by sea from Turkey to Greece, mostly Afghan and Syrian families, increased to 10,258 in September It said this was the highest

monthly total since 2016, when the European Union reached an accord with Turkey to stem the flow of arrivals. Turkey has welcomed near-



IN A LEAGUE OF HER OWN

PRIYANKA CHOPRA JONAS is a contemporary global Indian icon and has undoubtedly mapped her own path, riding crests and jumping troughs her way. Her life lessons have shaped her truth, the only one she walks with, facing life head on and punching above her weight, and now, building cross-cultural bridges. An actor, producer, speaker, UN ambassador and techpreneur, she met us during the promotions of The Sky is Pink, which she is co-producing. In between conversations, she was clued into social media updates about trailers and campaigns, never once dropping guard on what matters in the film business. It is no secret how driven she is. But underneath all that, she is a great conversationalist, who enjoys being with people. Excerpts from a tete-a-tete with RINKU GHOSH:

□While you are continuing your acting career, you have also turned into a successful producer, foraying majorly into regional films before The Sky is Pink. What's the story of Purple I started my production house

because I wanted to create something that would stand outside of me and engage with meaningful cinema. Which is why I've produced regional films that have amazing stories to tell, be they Marathi, Sikkimese, Punjabi and Gujarati. You can call Purple Pebble my dream, so named because purple is the colour of royalty and I consider myself a queen (laughs). And like a little pebble, like a rolling stone, I go from one place to the other, chasing newer horizons. It has a very deep meaning but it's also a cute name. When

I started the production house with my mother. who is also a director in the company, the idea of it was to be able to tell a story that I wanted to tell but couldn't always as an actor. And I believe a lot in the kind of cinema I want to make, which is content-heavy. I Sky is Pink not because it is a Hindi film but it being a real human story. The characters are not superheroes, they are just everyday people, a regular couple, who have thrived in extraordinary

circumstances and survived them in such a positive and amazing way. I feel in such a cynical world, people look for inspiration and surprisingly, we forget that they exist among us. Families should watch this film and see how if you stick together, you can come out of difficult circumstances. It is one of those films.

Considering you are a global star, how do you manage your projects?

I worked around the clock for a year. Now I am just dividing my time between what I do in the US and what I do here. But that is manageable because I have always been selective about all my characters. If you go through my filmography, I have never played the same person ever. I get bored by doing the same things. Once I choose not to repeat myself, I find newer areas to work on.

∃How do you manage this multi-national to and fro?

It is multi-continental, actually. It was a very difficult balance to achieve but I was up for the challenge.

□What made you take up the TV show Quantico in Hollywood? You were anyway at the top of your game here, why did you choose to begin again from the base in another industry, especially one that isn't too absorptive of Asians?

As I said, I do not like repeating myself and I was honestly looking to evolve. I did my rounds of the studios and had to introduce myself all over again. The struggle was tremendous. I had to take meetings and tell them, 'I am Priyanka Chopra. I am an actor from India and this is the kind of work I want to do.' I had the humility to do that and I feel that it is required when you want to start any-



thing new, not just films. Just because I am a star here doesn't mean the world knows me.

☐But let's face it, keeping it real is a difficult adjustment to make, right?

It is difficult for people who don't have humility, whose pride is bigger than them or the end result. I am sorted that way. I started from scratch and I didn't have my career handed over to me. I made my career bit by bit. Since I had done it once, I did it again this time. Of course, this was a tougher task a woman's career in showbiz is over. I am very happy to be proving them wrong. I have an almost two-decade long career now. I think it's all because I had humility and though it was difficult at times and took a mental adjustment, I knew what I wanted to do. And I wanted to do it well. I didn't want to do sidekick roles in Hollywood. Since I had been a leading lady here, I wanted to take off from that point and start out in a lead role there. I have to give kudos to ABC that they could see me as the leading lady. In the process, I became the first Asian ever to helm their show. It had never happened before. So that was a big achievement and post that, it has been an amazing experience, doing the work that I have, people giving me that space and accepting me in the US. Yes, it did take a lot.

As somebody who is a fan of technology, your app, Bumble, is now a big hit in India. So now, you are a techpreneur?

I love technology and wanted to be an aeronautical engineer when I was young. Physics and Mathematics were my favourite subjects in school and I have been a nerd all my life. (Laughs) Like they say, nerds will rule the world, if they don't already! Anyway, my manager in the US is a venture capitalist. And told her that if I ever wanted to diversify, would want to focus on something related to women and their education. I was having dinner when Bumble got launched in New York. Its founder Whitney (Wolfe Herd) was giving a speech, detailing why she decided to create it. At that instant, I thought how amazing it would be to take this to women in India to encourage conversations that they may be diffident about, and to help them express themselves better. I lost no time and asked her if she was planning to expand overseas? She said "no" but I told her that I was thinking of taking the platform to India. An application, which allows women to make the first move, is such a powerful tool as women making the first choice doesn't happen too often in our country. She liked the idea and we worked on it for a year. I'll never forget the date when I launched it in India, which was right after my wedding December 5. I was super excited about it. We never expected the numbers we got.

The only thing I told Whitney was that you have to culturally reform it to be able to protect the girls in the country. So we added the privacy feature and gave the user the right to send the first text and not be inundated by queries. There is also a photo verification option, so that you know the person you are speaking to is actually the person you're speaking to. Besides, Bumble BFFs and networks allow women to not just date but also

find like-minded people and friends. And in case, you're a homemaker or a home entrepreneur and are looking to expand your business, you can also find people who can help you do that. So it is just a tool to empower Índian women and take command of their own lives in their own hands. I just knew it in my gut that this is what I wanted to create for the girls here. And I'm happy that it has done so well

☐How do you see the transformation of Indian women over the years, having traersed a bit of that journey yourself?

To reach a place of equality and be treated the same as guys is going to take a long time. But the most important thing is to have women support each other and have each other's backs. Who else is going to do that if not women themselves? The reason why it didn't happen for a long time was that women didn't have the time and opportunity. There were such few opportunities that they had to fight each other off to get what they wanted. Now, we are creating more opportunities for women and have men who are feminists. For example, in this film, Farhan (Akhtar), Sid (Siddharth Roy Kapur) and Ronnie (Screwavala) are feminist men. They believe in a female filmmaker and a producer. So that is the world we want to create in our generation in the hope that may be and hopefully, the work that we do is what our grandchildren also follow without even thinking about it. It really depends on us and I am seeing such a massive change, not just in India but around the world. Of course, it is a really long conversation and has to go deep. Education is a really big part of it and I think the government is taking necessary steps and initiatives when it comes to that. I think that it will also require parents to have that understanding of giving exposure to the girl child instead of devaluing her. They need to give her the ability to stand up on her feet and understand that for her, education matters a lot. This kind of thought process will dig a deeper road to a smarter India. And I feel it will require us talking about it more

circumscribed by societal taboos. You yourself have been at its receiving end in public life, as recently as when you chose to marry. How do you fight them?

We are one of the oldest civilisations and cultures in the world, so traditional taboos have existed for thousands of years. But they will take as much time to be obliterated as it will take us not to succumb to societal pressure. I don't succumb.

☐How do you handle trolls? I really want young boys and girls to consider seriously what I say right now. These young people seek validation through social media, from people who are not even their friends. They are not "your people" and their validation wouldn't even matter. That should come from your friends and loved ones and those who are, most importantly, invested in vour growth. Criticism from those people shouldn't be taken seriously as someone sitting behind the anonymity of a computer, telling you how you should behave doesn't matter. There is a reason why they are called trolls. But why has trolling become news I never understood! I have blamed the media a lot for it about how they have started to literally report tweets. We should just stop magnifying their worth; it's just crazy. You can react to tweets where may be my mother is saying something about me. But it's crazy when some random people starts writing anything s/he fancies and that becomes news. And if you see the numbers of trolls, they are just about 100-150 people. So it's basically making a headline out of 100-150 people writing something absurd.

☐How do you maintain a work-life balance?

The most important thing is to have a partner who understands and supports your individual ambition outside of him. Nick and I may be a unit but we are also individuals. We both support our personal ambitions.

And the second bit, which me and he have, is communication. No matter where we are, we update each other about the entire day. I tell him if I am doing interviews or having dinner. He knows what is happening in my life just as I know what's happening in his. Besides, video-calling has saved our longdistance relationship tremendously. We video-call each other all the time. I think eventually it is also about how much you want to make it work with the other person. And most importantly, to have time for each other and support each other's ambitions and not just boast one's own.

Festive food is one thing that helps create memories. However, with the changing times and a growing dependence on pre-packaged foods, takeaways and dining out, today's generation doesn't fit into the picture. As a result, many delicacies have confided themselves only into cookbooks and long-lost grandmother's recipes. Manoj Rawat, executive chef at Hilton Garden Inn Gurgaon Baani Square, tells us that this time "there is again a shift towards traditional dishes," which have stood the test of time and are sure to keep their presence alive.
