

Uranium plant polluting water, say A.P. leaders

Leaders of the Opposition parties in Andhra Pradesh who visited the Uranium Corporation of India's plant in Pulivendula (represented by Chief Minister Y.S. Jagan Mohan Reddy in the Assembly) in Kadapa district on Sunday, called the plant a "major pollutant." The team led by Kalava Srinivasulu and Bhuma Akhila Priya of the TDP and CPI leader K. Ramakrishna said the plant had polluted groundwater.

Two trainee pilots killed as aircraft crashes in Telangana

Flight caught in heavy rain crashed into cotton fields near Sultanpur village

HYDERABAD

Two trainee pilots were killed when their trainer aircraft crashed into a cotton field on the outskirts of Sultanpur village in Telangana's Vikarabad district, 100 km from the State capital, on Sunday afternoon.

The victims were identified as Prakash Vishal from Bihar and Amanpreet Kaur from Punjab, both aged 21.

The four-seater trainer aircraft belonging to Wings Aviation Private Limited, operating out of the Old Airport at Begumpet in Hyderabad, crashed due to bad weather. "It was raining heavily in the area and the aircraft apparently nosedived into the farm belonging to Bantu Balakrishna," Bantawaram SI Venkateswarulu said.

"The aircraft first hit the ground and then dragged for some time. Wreckage of the aircraft was found spread ov-

er a radius of 100 yards. Its two occupants died on the spot. Their bodies were lying close to the scene of the crash," Vikarabad District

Collector Ayesha Masrat Khanam told The Hindu.

The locals of Sultanpur were the first to reach the spot in pouring rain. They scouted the cotton fields and found the bodies and the wreckage of the aircraft.

On receiving information, the police arrived and cordoned off the area. The aviation academy in Hyderabad was informed; its founder Y. Prabhakar Reddy rushed to the crash site.

Knee-deep slush

Vikarabad Superintendent of Police M. Narayana and Ms. Khanam oversaw the retrieval of the bodies. It was still raining heavily. Police personnel and the medical team from the Marpally Primary Health Centre found it difficult to wade through knee-deep slush to the accident spot, the police said. The post-mortem was conducted at the crash site itself. Later, the bodies were handed over to Mr. Reddy.

More arrests likely in Kerala serial murder case

Police team investigating 20 contacts of prime suspect

More arrests are likely in the Kerala serial murder case as the Crime Branch is investigating 20 more persons who reportedly maintained close connections with Jolly Shaju, the prime suspect in the murders of her in-laws, husband and three relatives between 2002 and 2016 at the Koodathayi village in Kozhi-

The suspects also include some family members who were reportedly aware that the deaths occurred due to deliberate poisoning.

Ms. Shaju allegedly poisoned them to death with cyanide to grab their property and marry another man.

Crime Branch sources said Ms. Shaju and two others - M.S. Mathew and P. Prajikumar – were formally arrested after interrogating about 200 people in the area. Hundreds of phone calls were scientifically analysed with the support of cyber cell experts to find the

The available photographs and video footage of all the six deaths in the family were also collected to check the presence of others who may be involved.

Party workers involved?

A few active political party workers are also under the scanner of the police. Two of them who were very close to Ms. Shaju were served notice to appear before the Crime Branch team for recording their statement.

Sources said the political party leaders were suspected of using their influence to cover up the incident. The house of one of the party leaders had been inspected by the Crime Branch squad for gathering evidence.

Along with the murder case, the involvement of some suspects in forging documents to grab the property of the murder victims too would be investigated.

Soon after the probe was relaunched into the sensational case by the Crime Branch, there were suspected attempts by some of the other family members to divert the direction of the probe and influence the complainant to withdraw the petition.

An officer attached to the Crime Branch said they required more incriminating evidence, including the forensic examination reports. to scientifically prove the involvement of Ms. Shaju in the death of five members in the family.

As of now, her active role was evident only in the case of murder of her ex-husband, he said.

House sealed

The Crime Branch will soon move the Thamarassery Judicial First Class Magistrate Court seeking the police custody of the three suspects who were remanded in judicial custody on Saturday.

The house where Jolly Shaju lived along with her new husband Shaju after the deaths was sealed by the

Bid to shift papers

It was put under surveillance as Mr. Shaju apparently tried to move some documents from the house to another location.

There could have been property documents in the bundle, since the police had found that there were serious property disputes within the family, and may have led to the murders.

Crime Branch sources said they would again interrogate Mr. Shaju to verify his claim that he was not aware of the role played by his wife in the murder of six persons, including his former wife and child. Though he was taken into custody on Saturday for interrogation, he was later allowed to go. According to police sources, he had seemed unaffected by the death of his former wife Sily and child Alphine.

Though M.S. Mathew and P. Prajikumar were arrested on suspicion that they arranged cyanide for Ms. Shaju, police sources said they were not directly involved in the murders. During the interrogation, they claimed that the woman secured cyanide for killing a dog.

KCR sacks 50,000 striking bus staff

Telangana CM says there will be no further talks; calls for speedy recruitment

Toughening his stand against the striking employees of the State-owned Telangana State Road Transport Corporation (TSRTC), Chief Minister K. Chandrasekhar Rao on Sunday said the government will not compromise under any circumstances and there would be no further talks with the striking unions.

The employees began their indefinite strike on Saturday, demanding, among other things, merger of the TSRTC with the government. The government said a

firm no to taking back the employees who did not join duty before the deadline it set. "There are just 1,200 employees left in the TSRTC as of now," Mr. Rao said, even as about 50,000 employees continued their strike for the second consecutive day, disrupting bus services across the State.

The Chief Minister directed the officials to hire 2,500 buses as an immediate measure while another 4,114 private buses could be deployed as stage carriers. Officials were already holding discussions with the private managements in this regard.

Mr. Rao, who held a review meeting, termed the employees' decision a "serious mistake" and said there was no question of merger of the TSRTC with the government. "The government is firm

Death of four-year-old was not due to assault, say police

Autopsy reveals that she died of pneumonia, meningitis

The police registering a case of unnatural death following the sudden demise of a fouryear-old in Kerala had sent media into a frenzy on Sunday with speculation of physical assault doing

help Indians

Union Minister of State for External Affairs V. Muraleedharan has said that the Centre will intervene to help Indian workers stranded in labour camps in Saudi Arabia. The Minister promised the support at a meeting held with K.V. Adbul Khader, MLA, chairman of the Assembly Committee for Pravasi Welfare,

at Guruvayur on Sunday. More than 600 Indians, including 70 from Kerala, are languishing in Saudi labour camps without food, wages or drugs, the MLA said. They worked in companies that faced action for not implementing the Nitaqat law that makes it mandatory to hire local labour.
