SC stays Aarey tree felling India gets 1st tranche of Swiss a/c details

Metro car shed has been done; Section 144 relaxed, 29 protesters released

PNS NEW DELHI/MUMBAI

The Supreme Court on Monday restrained authorities from cutting any more trees in Mumbai's Aarey colony for a Metro car shed, but the order came too late to save what is known as the 'lung of the city'. The Maharashtra Government told the court that whatever was required to be cut has already been done.

According to report, aware of the SC hearing the Mumbai Metro Rail Corporation (MMRCL) deployed an army of personnel to cut the trees throughout the night.
The speed with which the

authorities carried out the task is amazing. Only three days ago on October 4, the Bombay High Court refused to declare Aarey colony a forest and declined to quash the Mumbai municipal corporation's decision to allow felling of over 2,600 trees in the green zone to set up a Metro car shed.

Despite massive protest by green activists and local residents, the Government cut down nearly 3,600 trees in three days and didn't wait for the SC hearing. The MMRCL started cutting the trees from Friday night to make way for the car shed triggering angry protests, hours after the High

Court dismissed four petitions filed by NGOs and activists challenging the decision.

A specially constituted Bench gave the stay order after the apex court took suo motu (on its own) cognisance of a petition addressed to Chief Justice of India Ranjan Gogoi by law student Rishabh Ranjan seeking a stay on felling of trees in the colony. The apex court is on a week-long Dussehra break from Monday.

As many as 29 protesters were arrested for allegedly obstructing and assaulting police personnel during the felling of trees. They were released from jail in the wee hours of Monday after being granted bail by a local court, officials said. Mumbai Police have also relaxed prohibitory orders imposed in the Aarey Colony and its surrounding areas.

Solicitor General Tushar Mehta, appearing for Maharashtra and Mumbai's civic body, told the special Bench of Justices Arun Mishra and Ashok Bhushan that whatever was required to be cut for the Metro car shed has already been done and they would not fell any more trees

"We will decide this. Do not cut more trees," said the Bench, adding, "Do not cut anything now." It further said, Bench would take up the matter for further hearing on October 21

Senior advocate Gopal Sankaranarayanan, appearing for one of the petitioners before the Bombay High Court, said States are required to notify an area as forest as per an earlier direction of the apex court but Maharashtra has still not done so.

In a major step towards fighting black money, India got the first tranche of Swiss Bank details of its residents under the Automatic Exchange of Information agreement.

India is among 75 countries with which the Federal Tax Administration (FTA) exchanged information on around 3.1 million financial accounts. It took place within the framework of the global standard on the automatic exchange of information (AEOI). Following the first exchange last year, in which no technical problems were encountered, this year, the AEOI involved a total of 75 countries.

With 63 of these countries, the exchange of information was reciprocal. In the case of 12 countries, Switzerland received information but did not provide any, either because those countries do not yet meet the international requirements on confidentiality and data security (Belize, Bulgaria, Costa Rica, Curacao, Montserrat, Romania, Saint Vincent and the Grenadines, Cyprus) or because they chose not to receive data (Bermuda, British Virgin Islands, Cayman Islands, Turks and Caicos Islands).

Currently, around 7,500 reporting financial institutions (banks, trusts, insurers, etc.) are **Continued on Page 10** registered with the Federal Tax

Administration. These institutions collected the data and transferred it to the FTA.

The FTA sent information on around 3.1 million financial accounts to the partner states and received information on around 2.4 million from them.

The largest exchange was with Germany (in both directions), as was the case in the previous year. The FTA cannot provide any information on the amount of financial assets.

Switzerland has committed itself to adopting the global standard for the international automatic exchange of information in tax matters. The legal basis for the implementation of the AEOI in Switzerland came into force on January 1, 2017. Identification, account and

exchanged, including name, address, state of residence and tax identification number, as well information concerning the reporting financial institution, account balance and capital income. The exchanged informa-

financial information i

tion allows the cantonal tax authorities to verify whether taxpayers have correctly declared their financial accounts abroad in their tax returns. Next year, Switzerland's network of AEOI partner states will expand further, to around 90 countries. The OECD Global Forum on Transparency and Exchange of Information for Tax Purposes (Global Forum) reviews the implementation of the AEOI.

SPG for Gandhis on foreign trips must

Centre tweaks security rules, makes it mandatory for **Gandhis to submit** details when abroad

The Centre has issued fresh guidelines related to the security cover given to the Gandhi family, including Sonia Gandhi, Rahul Gandhi and Priyanka Gandhi Vadra. The revised guidelines make it mandatory for the Special Protection Group (SPG) personnel to accompany Gandhis during their foreign trips as well.

Before the changes in the guidelines, the SPG personnel accompanied Gandhis till their first location abroad and were subsequently sent back to India by them apparently preferring privacy over security.

The new guidelines also make it mandatory for the Gandhis to submit itinerary of all foreign trips. They have also been reportedly asked to furnish information of their recent tours.

The Centre has also reportedly made it clear that nonacceptance of these new guidelines could lead to curtailment on their foreign visits on account of security considerations. The SPG was set up in 1985 after the assassination of former Prime Minister Indira Gandhi and Parliament passed

the SPG Act in 1988 dedicating

the group to protect the Prime

Minister of India. In 1989,

then VP Singh Government

had withdrawn the SPG protection given to the outgoing

PM Rajiv Gandhi. After Rajiv was assassinated in 1991, the SPG Act was amended providing SPG protection to all ex-PMs and their families for a period of at least 10 years. The rule was amended again in 2002. Ex-PMs like HD Deve Gowda no longer enjoy the security cover after the review as

provided in the SPG Act. In August, the Government withdrew the SPG protection from former PM Manmohan Singh's security cover.

Following the withdrawal of the SPG cover of Singh, the Government had said, "The current security cover review is a periodical and professional exercise based on threat perception that is purely based on professional assessment by security agencies. Manmohan Singh continues to have a Z+ security cover.

Taliban free 3 Indians in exchange of 11 militants from Afghan jails

Three Indian engineers held by the Taliban in Afghanistan since May 2018 have been freed by the militan group in exchange for 11 of its top members from Afghan jails, according to media reports on Monday, amid fresh efforts to revive the Afghan peace talks.

The release of Indian hostages follows key meetings between US Special Representative for Afghanistan Reconciliation Zalmay Khalilzad and Taliban repre-sentatives led by Mullah Abdul Ghani Baradar in Islamabad during the weekend.

Two Taliban officials told Radio Free Europe/Radio Liberty on Sunday that the swap took place earlier in the day, but they did not disclose the location.

The officials spoke on condition of anonymity, citing what they described as the

sensitive nature of the issue. Seven Indian engineers

and their Afghan driver were abducted in the first week of May, 2018 in the Bagh-e-Shamal area of northern Baghlan Province where they were working on an electricity sub-station. The Indians were working for KEC, a global infrastructure engineering, procurement and construction company of RPG Enterprises.

No group has claimed responsibility for their abduction. One of the seven Indian hostages was released in March. The Taliban officials refused to say whether the freed Taliban members were being held by Afghan authorities or US forces in Afghanistan.

The Taliban were reportedly released from one of Afghanistan's largest jails at the Bagram military base, north of the capital, Kabul, the Associated Press reported. While the US troops years ago handed over the sprawling base to Afghan security forces, it still maintains a military presence at Bagram. It was not clear whether the US or Afghan forces released the Taliban.

Afghanistan's Both Defence Ministry and the president's office declined to comment on the developments, the report said. The identities of the released hostages were not disclosed by the militant group, The Express Tribune newspaper_quoted the report by Radio Free Europe/Radio Liberty as saying.

The officials said the freed

Taliban leaders include Sheikh Abdur Rahim and Mawlawi Abdur Rashid, who had served as the insurgent group's governors of Kunar and Nimroz provinces respectively during the Taliban administration before it was deposed by the US-led forces in 2001. A member of the powerful Haqqani family was also among the 11 militant leaders released, the BBC Pashto service reported.
