# BEYOND PAKISTAN

India and Saudi Arabia are finally consolidating a partnership on the basis of shared interests

HE EXPANSION AND institutionalisation of strategic cooperation between India and Saudi Arabia during Prime Minister Narendra Modi's visit to Riyadh, the second in three years, marks the consolidation of a partnership that has long struggled to realise its full potential. Efforts to end the prolonged mutual indifference began during the tenure of Atal Bihari Vajpayee when his foreign minister, Jaswant Singh, traveled to the Kingdom in early 2001. Five years later, King Abdullah visited Delhi, the first visit to India by a Saudi monarch in half a century, to announce a new phase in bilateral relations. Progress in building the partnership, however, remained elusive. It seemed confined to India buying oil from the Kingdom and exporting manpower. There were the beginnings of counter-terror cooperation but the Pakistan factor continued to cast a shadow over the relationship — until recently.

The Saudis sought to maintain a balance in their relations with India and Pakistan, which has long demanded religious solidarity and unending financial support from Riyadh. India, in turn, seemed hesitant to adopt a bolder approach towards Saudi Arabia amidst the lingering obsession with the Pakistan question in engagement with the Kingdom. As recently as in February, when the Crown Prince of Saudi Arabia, Mohammed bin Salman, visited Delhi, the question of India's tensions with Pakistan figured quite prominently. This time around, the joint statement issued at the end of PM Modi's visit made no reference to Pakistan. This was long overdue. It is rooted in Delhi's long overdue realist appreciation that Saudi Arabia has a lot more on its mind than protecting Pakistan in the name of religious solidarity; and that it is possible to build a solid partnership with Saudi Arabia on the basis of shared interests.

Within its immediate neighbourhood, Saudi Arabia has been struggling to cope with an assertive Iran and Turkey, both of whom seek to undermine the authority of the Saudi monarchy within the Kingdom and the region. If Iran mobilises the Shia militancy against the Kingdom, Turkey chips in with its support to Sunni radicals threatening the House of Saud. To make matters worse, the long-standing ally of the Saudis — Washington — increasingly looks unreliable. Meanwhile, the rapidly growing Saudi population can no longer be kept pliable with a rigorous diet of religious orthodoxy and generous subsidies from oil revenues, no longer the source of perennial comfort. To cope with these challenges, Saudi Arabia has begun serious social and economic reforms at home and diversification of its security and commercial partnerships abroad. Delhi has recognised the urgency of seizing this moment and building a strong security and economic partnership. The agreements signed during the PM's visit include the establishment of a strategic partnership council, deepening energy interdependence, and expanding defence and security cooperation bilaterally as well as in the Indian Ocean region. The challenge for Delhi now is to translate this bold new agenda with Saudi Arabia into quick and tangible results.

## BATTLE ON AIR

Confrontation between Delhi and its neighbours is unfortunate. Local and regional sources of pollution must be acknowledged

N THE RUN-UP to Diwali, the Delhi government gave the impression that it was alert to the pollution concerns associated with the festival. It ran awareness campaigns to wean people off fire crackers, arranged cleanliness drives and organised a laser show. Yet the post-Diwali smog has kept its date with Delhi. On Wednesday, two days after the festival, the city's Air Quality Index exceeded the "severe level". Delhi's Chief Minister Arvind Kejriwal seems to believe that the bad air this year is due to reasons beyond his government's control. "The people of Delhi are doing what they can to control pollution. I request the BJP to talk to their governments in Uttar Pradesh and Haryana and the Congress to speak to their government in Punjab to ensure that they don't burn stubble," he said. The Delhi CM's statement has drawn an angry reaction from his Punjab counterpart, who accused Kejriwal "of blaming others for his lapses". "Delhi's air pollution is directly related to construction activity, industrialisation and mismanagement of traffic," says Amarinder Singh

The jury is still out on the prime source of the capital's pollution. But by all accounts, Delhi's air quality is the outcome of the complex interplay of the pollution footprints of local activities and pollutants from upwind states. It would be facetious, therefore, to rule out the impact of stubble burning on the city's air. Data from the Punjab Remote Sensing Centre shows that the state recorded more than 15,000 stubble burning incidents between September 23 and October 28. The Centre-run System of Air Quality and Weather Forecasting and Research estimates that more than 35 per cent of Delhi's pollution on Wednesday was a fallout of stubble burning in the city's neighbourhood. Governments in Punjab and Haryana have been providing subsidies to farmers to buy modern farm equipment for management of paddy straw. But, as a report in this paper shows, many farmers in Punjab do not want to invest in these machines because they lie idle for most of the year — unlike tractors.

It would be unfortunate if the battle for clear skies in Delhi and its neighbourhood is reduced to a confrontation between the national capital and its neighbouring states. At "very poor", the post-Diwali AQI in Ludhiana and Jalandhar in Punjab, and Ambala, Kurukshetra and Sirsa in Haryana is only a notch better than that of Delhi. It is imperative, therefore, that Delhi and its neighbouring governments acknowledge the local and regional sources of the problem — and cooperate to resolve it.

# LOOK WHO'S JOKING

A study claims that most people believe men are funnier than women. They don't tell you why

CIENCE, IF THERE is such an over-arching activity, should have better things to do than try and provide an empirical basis for stereotypes. "Are men really funnier than women?" is the title of an article by Gil Greengross in Psychology Today, where he discusses the findings of a study he conducted which shows that most people believe so. Greengross clarifies: "This stereotype is shared by both men and women — but of course, just because it exists does not mean it is true." The study, according to the author, "means that to the best of our knowledge, on average, men appear to have higher humour production ability than women".

After it was reported widely in the media this week, the study has unsurprisingly annoved women, and women comedians. And, given the fact that there is an increasing number of professionally funny women, it is pointlessly provocative. Here's how you find out if someone is funny, male or female. They make you laugh. For far too long, women have been told that they must laugh with others, boost the male ego, but never make themselves the centre of attention. And it is in this socially constructed constraint that the roots of measuring "humour production" likely lie.

When women fake a laugh — giggle at the bad pun from their friends, family or paramours — the joke, in fact, is on men. There are enough studies to show that most men overestimate their own sense of humour. Like the emperor in his new clothes, they stare expectantly at their captive audience, feeling entitled to a polite laugh. And for too long, too many have been obliged. Perhaps the best way to break the stereotype that men are funny, and women less so, is to stop this charitable massaging of male egos.

# Warning in the Valley

Pakistan-sponsored terrorists target migrants, minorities to show that normalcy in Kashmir is far away

THE TARGETING OF non-Kashmiris by terrorists in South Kashmir and the killing of 11 persons in less than two weeks could seem puzzling to observers. However, this is nothing new. It just revisits a tactical method that terror groups, under the guidance of Pakistan's ISI, employ to remain relevant and promote Pakistan's interests. It has happened many times in the past too. So, the question should be: Why should it be allowed to hap-

In the late Nineties, while I coordinated operations in South Kashmir from Avantipur's Rashtriya Rifles headquarters, we were suddenly hit by a spate of two kinds of incidents — minority killings and targeting of non-Kashmiri labour. The two prominent minorities in Kashmir – Kashmiri Hindus and Sikhs — live in pockets of both urban and rural areas. The urban areas are relatively safe, it's the rural pockets that pose a challenge. While there may have been an exodus of Kashmiri Hindus in 1990 under a focused Pakistani strategy, some of them did stay back, and the Sikhs hardly migrated. Both communities became the target of attacks by Pakistani terror groups from time to time. Who can forget the Nandimarg (2003) and Wandhama (1998) killings of Kashmiri Pandits and the Chittisinghpura massacre of the Sikhs in 2000. Since the latter occurred just as the-then US President Bill Clinton was to address India's Parliament, the motive behind the attack was obvious. In 1999, just as the army was redeploying troops from Kashmir to Kargil to meet the sudden occupation of winter-vacated areas, labour from Bihar working at brick kilns and in the construction industry were targeted with mass killing, leading to their exodus.

A careful analysis of the trends at that time led to the conclusion that the Pakistani terror group Lashkar-e-Taiba (LeT) had decided to execute a high-profile attack against soft targets in certain areas to announce its arrival and demonstrate its domination of the terror scene. It was almost akin to an unfurling of the LeT flag in areas of its choosing and became a signature method.

Migrant non-Kashmiri labour in those days, too, were accommodated in small

major threat to them and gathering them into camps which were well protected and organising their secure movement to orchards or construction sites. Yet, the nature of the terror threat at that time — with more terrorists and lesser number of troops on the ground prevented any such counter measures. The J&K Police (JKP) on its own could not provide the necessary security. Minority killings and targeting of non-Kashmiri labour tapered off in the early part of the first decade of the millennium and did not come to the fore despite the obvious soft nature of targets available. I, however, continued to harbour fears that the tactic would be used again when the levels of frustration of the Pakistani terror groups or the more radical of the Kashmiri terror elements would cross limits. connection between the two occurrences in this case, as some are attempting to deduce. What Pakistan, through its proxies, wants to try and propagate is the idea that return of normalcy in Kashmir is yet very far away and that the security space is in their hands even with a limited number of terrorists. It wants to send the broad signal that the abrogation of the special constitutional provisions for J&K is meaningless and changes nothing. With the numbers of terrorists down but some quantum of successful infiltration, as

admitted by the JKP, the terrorists have had some time to reorganise, recalibrate and reselect their targets. Intelligence during the last three months has been of a lower order with a not-so-free movement of sources and non-availability of mobile communication. What we are witnessing in South Kashmir is a manifestation of this.

The focus of the security establishment would unmistakably have shifted towards the prevention of street agitation and mass protests. This was the correct response, as it responded to what was the bigger threat from 2008 onwards. Thereafter, the focus has

been on counter infiltration — not that the army and police cannot perform multiple tasks and they have done so creditably in the past. However, such situations do result in a shift of priorities and balancing them is a challenge. Much of this happened in 1999-2000 when the counter terror space was severely challenged after the shift of the army's focus to Kargil. Countering an aggressive terrorist phase involving so called "fidayeen" suicide attacks on government and other security targets proved more than challenging. The security establishment bounced back very quickly to neutralise 2,100 terrorists in 2001, the highest number ever. I have no doubt that with a little recalibration, the same will happen this time too. However, what has to be realised is that this takes away the larger focus from the more important factor of comprehensively neutralising the general ecosystem which enables the Pakistansponsored proxies and separatists to challenge the Indian nation's will.

The "tactical pause", so to say, must not allow for a return to the situation at the end of 2016 when the army and the police jointly launched Operation All Out. The latter was a very successful operation but we must not be drawn once again into the game of just neutralising terrorists. What the government had correctly done was to pay equal attention to dismantling financial networks and high-profile over-ground worker's networks. That is still a work in progress as it cannot be an overnight affair. Any slippage in this is bound to embolden the Pakistani sponsors and give a boost to their capability.

India goes beyond just neutralising terrorists. It's the elusive "terrorism", which we have rarely targeted, that should be the priority. By giving leeway on potential minority and current non-Kashmiri targeting, we may hand the initiative back to the other side. The security establishment should heed the warning that not only migrant non-Kashmiri labour but also minority elements in Kashmir are currently vulnerable.

# THE UNCOMPROMISING COMRADE

Gurudas Dasgupta fought for the rights of working people throughout his life

COMRADE GURUDAS Dasgupta, who passed away on October 31, remained a fighter for the causes of the working class till the end of his days. From the beginning of his active political life as a student, to his leadership of both organised and unorganised labour, his career as a preeminent parliamentarian, and in the leadership of the Communist Party of India (CPI), he remained an uncompromising champion of people's rights.

Dasgupta made his mark in politics in 1957, when he became the general secretary of the students' union of the Asutosh College in Calcutta. Thereafter, he continued to be associated with student and youth politics for some time. He served as general secretary of the All India Students' Federation (AISF), the students wing of the CPI, and was one of the party's most prominent youth leaders in West Bengal. From the 1970s onwards, he was known on the national stage.

In 1985, Dasgupta was elected to the Rajya Sabha, where he served three terms. He was also elected to the Lok Sabha twice. In his time in Parliament, Dasgupta was a ferocious debator. He was outspoken on critical issues, holding the governments of the day to account. Using his considerable oratorical skill, he championed the rights of labour, farmers and the people of India as a whole. His work on multiple parliamentary committees earned him the respect of his colleagues across the political spectrum. He was a member of the parliamentary com-

He even received awards for his work in the JPC, but gave away the proceeds to organisations like the Punjab Stree Sabha.

Comrade Dasgupta also served as general secretary of the All India Trade Union Congress (AITUC). The AITUC, a premier Indian trade union, has worked for the welfare of the working classes since 1920, when the communists stood against imperialist rule. Stalwarts such as Indrajit Gupta and A B Bardhan have also served as its past general secretaries. It is a bitter-sweet irony that on the day of Dasgupta's passing, the centenary commemorations of the AITUC have commenced.

Dasgupta served as the deputy general secretary of the CPI, a position he held till the last party Congress in 2018, in Kollam, Kerala I have had the pleasure of serving with him both in Parliament and as a colleague in the CPI leadership. His commitment to egalitarian principles remained steadfast in every

When the Congress government in the 1990s introduced the neoliberal economic agenda and implemented it through policy and law, Dasgupta was uncompromising in his opposition. Inside the House, he passionately argued against moves that would go against the peasantry, labour and other sections of society who have suffered as a result. But Dasgupta's inspiring presence was not limited to Parliament. As a trade union leader, he organised numerous agitations of the working class. Throughout his long life of political and public service, Dasgupta stood against corporate forces and those that further ideas and policies of exclusion and religious bigotry. He had the unique ability to organise and mobilise, as well as motivate the people to fight the status quo, and recognise the fact that such a battle was in their own interest as well as for the benefit of the nation as a whole.

# The remaking of Ladakh

As attention remains focused on the Valley, the other newly carved out Union Territory grapples with its own set of concerns



LITTLE DID THE people of Ladakh realise that they would be caught in a bubble of history which would last for 185 long years when the forces of Zorawar Singh overran Ladakh and made it part of Gulab Singh's fiefdom in 1835. Ladakhis struggled with their identity, having nothing in common with their rulers, neither the Dogras nor the Kashmiris, in terms of language, religion, food, dress or even physical features. It was a gunshot marriage which ended on October 31 when Ladakh finally became a Union Territory. This historic moment will be celebrated by all Ladakhis, and specially by its architect, former MP Thupstan Tsewang, whose lifetime goal will see fruition.

Had it not been for Zorawar's adventurism, Ladakh's trajectory in history could have been quite different and more akin to the other Himalayan kingdoms of Sikkim, Bhutan and Nepal. It had been an independent kingdom with a glorious history. It peaked during the reign of Gyalpo Singhe Namgyal (1616-1642) with its borders stretching up to Nepal and Tibet in the east and north and included the present district of Lahaul Spiti in Himachal to the south. The Gyalpos of Ladakh had defeated the Tibetans and even annexed the rich and fabled kingdom of Guge in Western Tibet for some time. The historic and strategic importance of Ladakh, linking the rich plains of India and Punjab through Mandi, Kullu, Lahaul and Leh with the Silk Route through Karakoram was very critical to the British for its shawl wool trade as well as success of the Great

This jubilation amongst Ladakhis about its newfound status as a UT is not difficult to understand. In 1990, on visiting Ladakh, people voiced their deep sense of alienation vis a vis their government in Srinagar. Apart from a diesel genset, there was no electricity supply while at the same time in neighbouring Himachal Pradesh electricity had reached every nook and cranny. Also, many villages remained unconnected by road and the existing pukka roads were mostly courtesy the Indian Army. Since then many changes have taken place, especially after the creation of the Autonomous Hill Council and the boom in tourism. Budget allocation remained a sore point throughout, about which, Jamyang Namgyal, the young MP from Ladakh, effectively spoke in his maiden speech before the Parliament.

Till now Ladakh's communication route remained principally through Srinagar and Jammu. All this is set to change. The Manali-Leh axis will become more important since it will not only be shorter but safer as well in comparison to the Kargil-Srinagar road. With the tunnel below Rohtang being commissioned shortly and another one being planned under the Shinkun La, travel time and distance between Manali and Leh will reduce substantially. In the foreseeable future, journey by road from Chandigarh to Leh could be a

day's affair. The proposed 365 km Bilaspur-Manali-Leh railway line will not only strengthen the country's defence requirements but will also enhance people to people contact between Ladakh and Himachal in an unprecedented way. For this to materialise, the Government of India will have to up its game to match with that of China's which has deployed Fortune 500 Companies to build road and other infrastructure on the other side of the border.

Ladakh and Himachal have a shared past. Many of the Gyalpos, erstwhile rulers of Ladakh, married from the ruling families of Lahaul and Spiti. Several important Gompas (monasteries) in Lahaul are affiliated even today to Hemis and other Gompas in Ladakh. Ladakh is indebted to Himachal for coming to its rescue in 1948 when two of Himachal's brave officers Major Prithi Chand (MVC) and his cousin Major Khushal Chand (MVC) and 16 other soldiers of the 2nd DOGRAS, mostly from Lahaul, Kinnaur and Kangra crossed the formidable Zoji La in the dead of winter and repulsed the armed Pakistani and tribal intruders. The local militia they motivated and trained later metamorphosed into the famous Ladakh Scouts which played a stellar role in defence of Ladakh in 1962 and in the Kargil operation of 1999. An ornate Chorten standing next to the Khalatse bridge which Major Khushal Chand destroyed in 1948 stands today as a joint symbol of solidarity and courage of the people of Lahaul and Ladakh.

The recognition of Bhoti as a scheduled language by the Government of India is another important area which both can help galvanise along with other Himalayan states like Uttarakhand, Sikkim and Arunachal Pradesh. This will not only lead to the emotional integration of borderland people with the rest of the country but also strengthen our claim to these areas as an integral part of India vis a vis that of China.

# Most marginalised of them all

On socio-economic indicators, Muslim youth fare worse than SCs and OBCs. Is this linked to community's political marginalisation?

THE 2019 Lok Sabha elections have reconfirmed the political marginalisation of Muslims — MPs from the community are very few in Parliament's lower house. This process is converging with the equally pronounced socio-economic marginalisation of the community. Muslims have been losing out to Dalits and Hindu OBCs since the Sachar committee submitted its report in 2005.

Using the recent "suppressed" NSSO report (PLFS-2018) and the NSS-EUS (2011-12), examine the socioeconomic status of Muslim youth vis-à-vis other social groups in India. We use the same set of 13 states covering 89 per cent of the 170 million Muslims enumerated in 2011. We use three variables: Percentage of Muslim educated youth (21-29 age) who have completed graduation, percentage of the community's youth (15 to 24 age) in educational institutions and the percentage of Muslim youth who are in the NEET category (not in employment, education or training). These variables together reflect pathways of educational mobility for the country's youth.

The proportion of the youth who have completed graduation — we call this, "educational attainment" — among Muslims in 2017-18 is 14 per cent as against 18 per cent among the Dalits, 25 per cent among the Hindu OBCs, and 37 per cent among the Hindu upper castes. The gap between the SCs and Muslims is 4 percentage points (ppt) in 2017-18. Six years earlier (2011-12), the SC youth were just one ppt above Muslims in educational attainment. The gap between the Muslims and Hindu OBCs was 7 ppt in 2011-12 and has gone up to 11 ppt now. The gap between all Hindus and Muslims widened from 9 ppt in 2011-12 to 11 ppt in 2017-18.

Muslim youth in the Hindi heartland fare the worst. Their educational attainment is the lowest in Haryana, 3 per cent in 2017-18; in Rajasthan, this figure is 7 per cent; it is 11 per cent in Uttar Pradesh. Madhya Pradesh is the only north Indian state where the Muslims are doing relatively better in education — their educational attainment is 17 per cent. In all these states, except MP, SCs fare better than Muslims. The gap between SCs and Muslims with respect to educational attainment is 12 ppt Haryana and Rajasthan and 7 ppt in UP. In 2011-12, in all these states, SCs were slightly above the Muslims on this parameter.

In eastern India, the educational attainment among the Muslim youth in Bihar is 8 per cent, as against 7 per cent among SCs, in West Bengal it is 8 per cent, as against 9 per cent for SCs, and in Assamit is 7 per cent as against 8 per cent for SCs. While the gap between Muslims and SCs has narrowed in the last six years, the latter still fare better.

In western India, the educational attainment figures for Muslims are better compared to 2011-12. But they do not necessarily reflect a significant educational improvement when compared to the SCs and Hindu-OBCs. In Gujarat, the gap in educational attainment between the Muslims and SCs is 14 ppt in 2017-18; six years ago, it was just 8 ppt. In Maharashtra, the Muslims were marginally – by 2 ppt – better off than SCs in 2011-12, they have now not only lost to SCs but the latter has now overtaken them by 8 ppt.

With 36 per cent graduate Muslim youth, Tamil Nadu tops the educational attainment parameter with respect to the community in the country. In Kerala, this figure is 28 per cent, in Andhra Pradesh, it is 21 per cent and in Karnataka, 18 per cent of the Muslim youth are graduate. While the community is giving a close competition to SCs in Tamil Nadu and AP, it is losing out in Kerala. The developments in South India have more to do with the relatively faster mobility of SCs than the marginalisation of Muslims. The community's achievements also have to be seen in the context of positive discrimination Muslims enjoy in these states - Dalit and OBC Muslims are given reservations under the OBC quota.

The marginalisation of Muslims on socio-economic indicators becomes clear when we evaluate the statistics related to youth currently in educational institutions. The percentage of youth who are currently enrolled in educational institutions is the lowest among Muslims. Only 39 per cent of the community in the age group of 15-24 are in educational institution as against 44 per cent for SCs, 51 per cent for Hindu OBCs and 59 per cent for Hindu upper castes.

A sizable proportion of Muslim youth are leaving the formal education system and moving into the NEET category. Thirtyone per cent of youth from the community fall in this category — the highest from any community in the country — followed by 26 per cent among the SCs, 23 per cent among the Hindu OBCs, and 17 per cent among the Hindu upper castes. This trend is more pronounced in the Hindi belt – 38 per cent of Muslims youth fall under NEET in Rajasthan, in UP and Haryana, this figure is 37 per cent and in MP, it is 35 per cent. In South India, the proportion of Muslims outside the formal eduction system is relatively low — 17 per cent in Telangana, 19 per cent in Kerala, 24 per cent in Tamil Nadu and 27 per cent in AP.

While the marginalisation of Muslims began several years ago, the phenomenon seems to have gathered pace in recent years. As Sam Asher et al point out in their recent study, 'Intergenerational Mobility in India: Estimates from New Methods and Administrative Data', "Muslims are being left out from educational mobility in India while the SCs are getting integrated into it". More studies are needed to link this disturbing process to the political marginalisation of Muslims. The activities of vigilante groups could possibly have led young Muslims to withdraw in to their shell.

South Asia does not give its Nobel winners their due

EVERY YEAR when the Nobel Prizes are announced, Indians lament that they have been deprived of their "due recognition". Yet when an Indian, such as Abhijit Banerjee, is awarded the Nobel Prize, Indians, as a whole, take no pride in it. India does not love its Nobel laureates. Nor does the rest of South Asia. Pakistan and Bangladesh too, berate and belittle their laureates. South Asian laureates are treated in a shabby manner at home, as if they are undesirables, best got rid of.

This year, the response was somewhat mixed. Generally, "progressive" sections of the intelligentsia cheered when the prize was awarded to Abhijit Banerjee, along with Esther Duflo and Michael Kremer. Though there were conspicuous exceptions.

Bengalis felt they had a particular reason to be proud. Banerjee, though a US citizen now, is a Bengali. Bengalis have produced five of the 10 Indian Nobelists, beginning with Rabindranath Tagore in 1913, the two foreigners — Ronald Ross in 1902, for discovery of the malaria parasite, and Mother Teresa in 1979. The other two are Amartya Sen in 1998 and Banerjee in 2019. Of the three laureates from Madras (now Chennai), the first, Sir CV Raman, who got the Nobel in Physics in 1930, worked in Calcutta. While Tagore was the first Asian to receive the Nobel (for literature), Raman was the first Asian to get one in the sciences. Both had a Bengal connection.

Bengalis may also recall that when

While the prime minister and a galaxy of eminent individuals greeted Banerjee, there were big names in academia and public life, including Union ministers, that trolled and trashed this year's Nobel winner and his seminal work which is part of a global trend among economists concerned with the poor. > ing the scheme for a minimum income, lauded by parties other than the BJP. Though the applause for his Nobel is fulsome, Banerjee's focus on choices of the poor as opposed to the structural causes of poverty is debatable. This is a matter of ideology, difference in approach and something that concerns him and his peers, although it affects public policy. It is not a reason to be churlish about his Nobel. Just as Amartya Sen and Raghuram Rajan, in spite of their divergences, can be civil, have a dialogue and support each other at times, Banerjee's peers

should applaud him unabashedly now, as

INU, have done. In fact, being from INU earned Banerjee much applause and support across academia and the thinking class. Above all, if his focus is on poverty, regardless of his method, his heart is in the right place.

Baneriee's Nobel has earned him a vastly more flattering response at home than Amartya Sen or Kailash Satyarthi, who in 2014, shared the Peace Prize along with Malala Yousufzai of Pakistan.

India's philosopher-economist Sen has been vilified for his criticism of Narendra Modi — for the killing of Muslims in Gujarat under his watch in 2002. Sen is outspoken on issues of identity and academic freedom, and the majoritarian forces resent this. Instead of being honoured, valued and utilised in national interest, Sen was hounded out of the Nalanda University. The campaign of calumny and slander against Sen may have abated, but it continues.

Satyarthi and Malala were not cause for celebration in either India or Pakistan. Far from home, in the mid-December Nordic winter, snow-bound Oslo came alive with Prize-related events where Satyarthi and Malala were the toast of the town. They were feted as one for their work on child rights, without any trace of the hostility that marks India-Pakistan ties. But, many in India, including in the government, felt it was no honour, as the focus was on child rights, where India has a poor record.

Malala, who was forced by extremists to flee abroad for her life, did not evoke even a single cheer in Pakistan. Living in the West has earned her enemies at home where she's seen as an agent of anti-Islamic forces. Sadly, she was not sought after elsewhere in South Asia either.

The benign "neglect" of Satyarthi and Malala, compared to the shabby treatment meted out at home to Pakistan's Abdus Salam and Bangladesh's Grameen Bank founder Muhammad Yunus, is no cause for comfort. Somewhat like Sen, Yunus had a hard time in Bangladesh: He was reviled, including by Prime Minister Sheikh Hasina, and ousted from the board of the iconic institution that epitomises his work, and which inspired the micro-credit movement worldwide. Pakistan refused to accept Salam, one of the world's greatest physicists, as one of its own because he was an Ahmadiya — an excommunicated Muslim minority. Pakistan disowned both Salam and Malala.

It is cold comfort that Indian laureates are not consigned to obscurity (like Salam in Pakistan or Yunus in Bangladesh) when South Asia treats its globally acclaimed eminences in such a despicable manner.





A NEW study says that carbon impacts from the loss of intact tropical forests has been grossly underreported. Published in *Science Advances*, the study has calculated new figures relating to intact forest lost between 2000-2013. It has found that the long-term net carbon impacts, through 2050, are six times the current estimates. The revised total equals two years' worth of all global land-use change emissions, the World Conservation Society (WCS) said in a statement.

Conventionally, only carbon emissions from readily observed forest clearance are considered. This study accounted for less readily observed degradation processes that follow forest clearance - selective logging, edge effects, and defaunation. Another metric used in the new study is "forgone carbon removal" — which could have occurred had cleared or degraded forest areas remained intact beyond 2000. Full accounting of these additional factors led to a 626% increase in cumulative net carbon impact from intact forest loss, the study says.

"Our results revealed that continued destruction of intact tropical forests is a ticking time bomb for carbon emissions. There is an urgent need to safeguard these landscapes because they play an indispensable role in stabilising the climate," the WCS statement quoted lead author of the study, Sean Maxwell of WCS and the University of Queensland, as saying.



# Meet spyware Pegasus

What is the Israeli-made malware that WhatsApp has said was used to snoop on journalists and activists around the world this summer, including in India? Are you personally at risk, and should you stop using WhatsApp?

On Thursday, The Indian Express reported that the popular messaging platform WhatsApp was used to spy on journalists and human rights activists in India earlier this year. The surveillance was carried out using a spyware tool called Pegasus, which has been developed by an Israeli firm, the NSO Group.

WhatsApp sued the NSO Group in a federal court in San Francisco on Tuesday, accusing it of using WhatsApp servers in the United States and else-

where "to send malware to approximately 1,400 mobile phones and devices ('Target Devices')... for the purpose of conducting surveillance of specific WhatsApp users ('Target Users')".

The surveillance was carried out "between in and around April 2019 and May 2019" on users in 20 countries across four continents, WhatsApp said in its complaint.

In an Op-ed in *The Washington Post*, the head of WhatsApp, Will Cathcart, wrote that the surveillance "targeted at least 100 human-rights defenders, journalists and other members of civil society across the world". He underlined that "tools that enable surveillance into our private lives are being abused, and the proliferation of this technology into the hands of irresponsible compa-

nies and governments puts us all at risk". WhatsApp, which is owned by Facebook, is the world's most popular messaging app, with more than 1.5 billion users worldwide. About a quarter of those users — more than 400 million, or 40 crore — are in India, WhatsApp's biggest market.

The NSO Group is a Tel Aviv-based cyber-security company that specialises in "surveillance technology" and claims to help governments and law enforcement agencies across the world fight crime and terrorism.

#### So what exactly is Pegasus?

All spyware do what the name suggests — they spy on people through their phones. Pegasus works by sending an exploit link, and if the target user clicks on the link, the malware or the code that allows the surveillance is installed on the user's phone. (A presumably newer version of the malware a link. *More on this below.*) Once Pegasus is installed, the attacker has complete access to the target user's phone.

The first reports on Pegasus's spyware operations emerged in 2016, when Ahmed Mansoor, a human rights activist in the UAE, was targeted with an SMS link on his iPhone 6. The Pegasus tool at that time exploited a software chink in Apple's iOS to take over the device. Apple responded by pushing out an update to "patch" or fix the issue.

In September 2018, The Citizen Lab, an interdisciplinary lab based at the Munk School of Global Affairs & Public Policy, University of Toronto, showed that Pegasus delivers "a chain of zero-day exploits to penetrate security features on the phone and installs Pegasus without the user's knowledge or permission". Pegasus spyware's operations were live in 45 countries at the time, The Citizen Lab research showed.

(A "zero-day exploit" is a completely unknown vulnerability, about which even the software manufacturer is not aware, and there is, thus, no patch or fix available for it. In the specific cases of Apple and WhatsApp, therefore, neither company was aware of the security vulnerability, which was used to exploit the software and take over the device.)

In December 2018, Montreal-based Saudi activist Omar Abdulaziz lodged a case against the NSO Group in a court in Tel Aviv, alleging that his phone had been infiltrated using Pegasus, and conversations that he had with his close friend, the murdered Saudi dissident journalist Jamal Khashoggi, snooped on. Khashoggi was slaughtered by Saudi agents at the kingdom's consulate in Istanbul on October 2, 2018; Abdulaziz said he believed

The brochure, called *Pegasus: Product* Description, says Pegasus can work on BlackBerry, Android, iOS (iPhone) and Symbian-based devices. The mention of the now discontinued mobile OS Symbian and the no longer popular BlackBerry suggests the document is old — and Pegasus has certainly been upgraded over the years.

#### And how did Pegasus exploit WhatsApp?

That's the big question for many, given that WhatsApp has always tom-tommed its end-to-end encryption. The *Financial Times* report in May this year said that a missed call on the app was all that was needed to install the software on the device

 no clicking on a misleading link was required. WhatsApp later explained that Pegasus had exploited the video/voice call function on the app, which had a zero-day security flaw. It did not matter if the target did not take the call — the flaw allowed for the malware to be installed anyway. The exploit impacted WhatsApp for

#### Can Pegasus be used to target just about anyone?

Technically, yes. But while tools such as Pegasus can be used for mass surveillance; it would seem likely that only selected individuals would be tar geted. In the present case, WhatsApp has claimed that it sent a special message to approximately 1,400 users who it believed were impacted by the attack, to directly inform them about what had happened.

WhatsApp has not said how many people it contacted in India. The Indian Express reported on Thursday that at least two dozen academics, lawyers, Dalit activists, and journalists were alerted by the company in India.

It is not known who carried out the surveillance on the Indian targets. The NSO Group, while disputing WhatsApp's allegations "in the strongest possible terms", has said that it provides the tool exclusively to "licensed government intelligence and law enforcement agencies", and not just to anyone who wants it.

#### Is WhatsApp's end-to-end encryption now compromised? Should you switch to another app — perhaps Signal or Wire or Telegram?

The very popularity of a messaging app makes it a target for hackers, cyber criminals, or other entities. Even law enforcement agencies across the world want messages to be decrypted — a demand that WhatsApp is fighting, including in India.

WhatsApp uses the Signal app protocol for its end-to-end encryption, which seems safe so far. WhatsApp has an advan-

> tage over Telegram: in Telegram, only the "secret chats" are endto-encrypted, while on WhatsApp everything is endto-end encrypted by default. Those rattled by the WhatsApp episode might want to switch to Signal or Wire. However, it is important to be aware

that unknown 'zero-day' exploits could exist for virtually every software and app in the world — and that they might be exploited at some point in the future by individuals or agencies determined to do so.

# What National Health Profile says about targeted, actual health spend

AT A time when Universal Health Coverage has become the new buzzword of healthcare in India since Ayushman Bharat, the National Health Profile 2019 throws up sobering figures. Between 2009-10 and 2018-19, India's public health spend as a percentage of GDP went up by just 0.16 percentage points from 1.12% to 1.28% of GDP, and remains a far cry from the 2.5% GDP health spend that has been India's target for some years now.

The National Health Profile (NHP) is an annual stocktaking exercise on the health of the health sector.

#### The current situation

"The cost of treatment has been on rise in India and it has led to inequity in access to health care services. India spends only 1.28% of its GDP (2017-18 BE) as public expenditure on health. Per capita public expenditure on health in nominal terms has gone up from Rs 621 in 2009-10 to Rs 1,657 in 2017-18," NHP 2019 says.

Compare this with the average total medical expenditure per childbirth in a public hospital: Rs 1,587 in a rural area and Rs 2,117 in an urban area. Based on Health Survey (71st round) conducted by NSSO, average medical expenditure incurred during hospital stay during January 2013-June 2014 was Rs 14,935 for rural and Rs 24,436 in urban India.

In his Independence Day address in 2011, then PM Manmohan Singh had declared

that financing of health would be upped to 2.5% of GDP, during the 12th Five Year Plan (a concept since discontinued). In 2018, Prime Minister Narendra Modi said at the Partners' Forum meeting in Delhi: "We are committed to increasing India's health spending to 2.5% of GDP by 2025, reaching to more than \$100 billion. This will mean an actual increase of 345 per cent over the current share, in just eight years."

#### **Blueprint for meeting targets**

In 2011, the High Level Expert Group of the erstwhile Planning Commission submitted its seminal report on the roll-out of Universal Health Coverage (UHC) in India. Recommendation 3.1.1 reads: "Government (central government and states combined) should increase public expenditures on health from the current level of 1.2% of GDP to at least 2.5% by the end of the 12th plan and to at least 3% of GDP by 2022."

The report adds: "Financing the proposed UHC system will require public expenditures on health to be stepped up from around 1.2% of GDP today to at least 2.5% by 2017 and to 3% of GDP by 2022. The proposed increase is consistent with the estimates by government as well as our preliminary assessment of financial resources required to finance the NHP. Even if we assume that the combined public and private spending on health remains at the current level of around 4.5% of GDP, this will result in a five-fold increase in real per capita health expenditures by the government (from around Rs 650-700 in 2011-12 to Rs 3,400-3,500 by 2021-22).

There will also be a corresponding decline in real private out-of-pocket expenditures from around Rs 1,800-1,850 in 2011-12 to Rs 1,700-

1,750 by 2021-22." Universal Health Coverage, according to the World Health Organization, means that "all people and communities can use the promotive, preventive, curative, rehabilitative and palliative health services they need, of sufficient quality to be effective, while also ensuring that the use of these services does not expose the user to financial hardship." The three objectives are: equity in access to health services; quality of health services should be good enough to improve the health of those receiving them; people

should be protected against financial-risk ensuring that the cost of using services does not put people at risk of financial harm.

#### The states

There are wide disparities in the health spend of states, the NHP points out. The Northeastern states had the highest and the Empowered Action Group (EAG) states plus Assam had the lowest average per capita public expenditure on health in 2015-16. EAG states are the eight socio-economically backward states of Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Odisha, Rajasthan, Uttarakhand and Uttar Pradesh. Among the big states (erstwhile) Jammu

and Kashmir leads with a 2.46% GSDP spend spend were Mizoram with 4.20% GSDP spend and Arunachal Pradesh with 3.29%.

Even states seen as better performers on health parameters, such as Tamil Nadu and Kerala, fare poorly on the health finance index. Tamil Nadu spent 0.74% of its GSDP and Kerala 0.93% of its GSDP on healthcare.

#### India and world

The NHP does some very telling calculations on India's per capita health spend and how it stacks up against countries who are on the UHC path. In 2016, India's Domestic general government health expenditure stood at \$16 per capita. This is lower than Norway (\$6,366), Canada (\$3,274), Japan (\$3,538), Republic of Korea (\$1,209) and Brunei Darussalam (\$599). Among the 23 countries including India that the Central Bureau of Health Intelligence chose for that comparison, the highest per capita spender is the United States at \$8078. The American system, though, is considered neither ideal nor economical. This data has been sourced from the Global Health Expenditure Database of the World Health Organisation.

The epidemiological transition, however, varies widely among Indian states: 48% to 75% for noncommunicable diseases, 14% to 43% for infectious and associated diseases, and 9% to 14% for injuries," the NHP notes. DALYs are an international standard of disease burden that measures how much of a normal life span of an individual is taken away by a disease related morbidity of mortality.

The NHP has also noted that medical education infrastructure has shown rapid growth over the past few years. "The country has 529 medical colleges, 313 Dental Colleges for BDS & 253 Dental Colleges for MDS. The total number of admissions for academic year 2018-19 in Medical Colleges is 58756. The Dental Colleges saw an admission of 26960 in BDS and 6288 in MDS in the academic year 2018-19," it says.

## Harris campaign lays off dozens of staffers

Sacramento: Democratic presidential candidate Kamala Harris is laying off several dozen staff members and transferring others in an effort to salvage her prospects in the Iowa caucuses. The move, which comes roughly three months before the caucuses formally usher in the Democratic contest, make the California senator the most prominent candidate so far to announce a major campaign restructuring. Harris's campaign turned to history to make the case that in order to win the leadoff caucuses, candidates sometimes have to overhaul their operations. "Plenty of winning primary campaigns... had to make tough choices on their way to the nomination," her campaign manager, Juan Rodriguez, said.

#### 'CIA-backed militia killing with impunity'

Kabul: CIA-backed Afghan paramilitary groups operating with impunity are summarily executing civilians during botched nighttime raids and are responsible for the disappearances of suspects, Human Rights Watch said in a report on Thursday. The report documented 14 cases from late 2017 to mid-2019. The secretive militias, whose support from the CIA continues a tradition stemming from the Soviet-Afghan war of the 1980s, have long hunted the Taliban and are seen as an important tool as the war against the insurgents intensifies. But their tactics have long sparked controversy across Afghanistan.

#### **BANGLADESH**

#### 400 Rohingya have returned, says Myanmar

Dhaka: Around 400 Rohingya have voluntarily returned to Myanmar from Bangladesh, Myanmar's embassy there said, but with previous repatriation attempts having failed, Dhaka was yet verify the claim. Bangladesh is home to nearly a million Rohingya refugees. Myanmar's embassy posted photos on Facebook that purported to show "46 more voluntary returnees" being "warmly received" in Myanmar, taking the total number going back to 397 in an unspecified timeframe.

# Twitter says it will ban all political ads

TWITTER SAID Wednesday that it would ban all political ads, putting a spotlight on the power and veracity of online advertising and ramping up pressure on Facebook's chief executive, Mark Zuckerberg, to reverse his hands-off stance.

Jack Dorsey, Twitter's chief executive, said political ads, including manipulated videos and the viral spread of misleading information, presented challenges to civic discourse, "all at increasing velocity, sophistication, and overwhelming scale." He said he worried the ads had "significant ramifications that today's democratic infrastructure may not be prepared to handle." He added that he believed that the reach of political messages "should be earned, not bought."

His move sets up a clash of principle with Facebook and Zuckerberg, who this month said that he would allow politicians to run any claims — even false ones — in ads on the social network. Zuckerberg reasoned that Facebook had been founded to give people a voice and said his company stood for free expression. Politicians' ads. he said. were newsworthy.

# Scientists say quarter of all pigs in the world may die of swine fever

**ASSOCIATED PRESS** SYDNEY, OCTOBER 31

AROUND A quarter of the world's pigs are expected to die from African swine fever as authorities grapple with a complex disease spreading rapidly in the globalisation era, the World Organisation for Animal Health's

president said Thursday. A sharp reduction in the world's pig population would lead to possible food shortages and high pork prices, and it might also cause shortfalls in the many products made from pigs,

such as the blood-thinner heparin that's used in people, said Dr Mark Schipp, the organisation's president.

The disease's spread in the past year to countries including China, which has half the world's pigs, had inflamed a worldwide crisis, Schipp told reporters at a briefing in Sydney. "I don't think the species will

be lost, but it's the biggest threat to the commercial raising of pigs we've ever seen." he said. "And it's the biggest threat to any commercial livestock of our generation." African swine fever, fatal to

hogs but no threat to humans,



African swine fever is fatal to pigs, but not a threat to humans

has wiped out pig herds in many Asian countries. Chinese authorities have destroyed about 1.2 million pigs in an effort to contain the disease there since August 2018. The price of pork has nearly

doubled from a year ago in China, which produces and consumes two-thirds of the world's pork. And China's efforts to buy pork abroad, as well as smaller outbreaks in other countries, are pushing up global prices.

"There are some shortages in some countries, and there's been some substitutions using other sources of protein, which is driving up the prices of other proteins," said Schipp.

Progress had been made toward a vaccine, but Schipp, who is officer, said the work was challenging because the virus itself is large and has a complex structure. He said a big step forward was the announcement last week that scientists had unravelled the 3D structure of the virus.

# With modified norms now in force, premium for health policies set to rise

HEALTH INSURANCE premiums are likely to rise, in the wake of the recent changes in regulations under the health policies of insurance firms.

The Insurance Regulatory and Development Authority of India (IRDAI) had recently modified regulations for standardisation of certain wordings, conditions which cannot be excluded under health insurance policies and coverage for modern treatments. "It is possible that insurance premiums could increase due to these changes, especially due to coverage being made mandatory for certain conditions which were hitherto excluded under health insurance policies," said Subramanyam Brahmajosyula, head underwriting and reinsurance, SBI General Insurance.

"It is too early to comment on the quantum of increase as insurance companies would have to monitor and assess the impact of these changes on their loss ratios before approaching the regulator for approval for increased premium rates. The quantum of increase may also vary from company to company," he added. However, insurance experts said premium can rise by 10-15 per cent in view of the changes.

Experts say the primary objective of these modifications is to promote uniformity, keeping the customer in focus.

These changes will enable customers to take more informed decisions while purchasing their insurance cover, they say.

The modifications on guidelines, effective October 1, 2019, basically cover three areas: definition of pre-existing disease; optional covers and costs that are included in the definition of room charges, medical or surgical proce-

dures; and treatment costs "Optional covers and costs are basically clarificatory in nature and will help standardisation in health products across insurers. But these lists can't be fixed for all time to come and IRDAI may have to bring out need-based and knowledge-based changes from time to time," said KK Srini-

vasan, former member, IRDAI. Regarding definition of pre-existing diseases, a simple reading gives an impression that as per the new definition, conditions ore illnesses discovered within 3 months of issuance of policy will be treated as pre-existing. "It does hit the conditions.

policy holders but can prevent frauds," Srinivasan added. Insurers would have to incorporate all these modifications in their existing products

Experts say the primary objective of the modifications by IRDAI is to promote uniformity in policies, keeping the customer in focus

by October 1, 2020 and any new products filed post October 1, 2019 would have to be in conformity with the regulations. There could be some impact on pricing of health insurance products as a result of these changes, said an official.

During FY18, insurance firms collected Rs 37,029 crore as health insurance premium, registering a growth of 21.8 per cent over the previous fiscal. The share of group health insurance was the highest at 48 per cent, followed by individual business (41 per cent) and the government business (11 per cent). Five states — Maharashtra, Tamil Nadu, Karnataka, Delhi UT and Gujarat — contributed 68 per cent of total health insurance premium, according to IRDAI.

As per the IRDAI Annual Report 2017-18, the insurance sector has covered 48 crore lives under health insurance, of which 36 crore persons are covered under various government schemes. The industry has processed 1.6 crore health insurance claims during that year. The PMJAY scheme, launched in September 2018, had 18 lakh plus pre-authorisations approved amounting to over Rs 2,400 crore as on March 31, 2019.

In a circular issued to the CEOs of insurance companies recently, IRDAI allowed health insurers to effect a decrease in minimum and/or increase in maximum premiums and maximum entry age. Typically, the maximum age limit of health insurance policies filed is up to 65 years; but if the insurer feels that the age limit can be extended, then it can be increased beyond 65 years or as per maximum age filed.

IRDAI has allowed general and standalone health insurance firms to collect premium in various frequencies or instalments such as monthly, quarterly or half-yearly without filing with the regulator.

The regulator has also allowed additional distribution channels to be introduced for specific products on certification basis without waiting for the regulatory approval without changes to the terms and

There is a provision to change the premium by increasing or decreasing by 15 per cent, depending on the loss-ratio range.

# US HAD FILED COMPLAINT STATING EXPORT SCHEMES WERE A 'DETRIMENT' TO AMERICANS Withdraw prohibited subsidies: WTO panel to India

IN A move expected to put Indian export subsidy programmes claimed to be worth over \$7 billion at risk, the World Trade Organization (WTO) dispute settlement panel has sided with the United States on a complaint that these subsidies were not compliant with the multilateral trade body's norms. At the same time, sources told *The Indian Express* that India will appeal the ruling, which may prevent the adoption and implementation of the panel's decision.

The dispute panel formed to look into US' complaints last year found that exemptions from customs duties and Integrated Goods and Services Tax and tax deductions provided under some sections or conditions of India's export-oriented schemes were "inconsistent" with provisions of WTO's Subsidies and Counter-

Measures (SCM) Agreement. This includes India's Export

Oriented Units (EOU) scheme, Electronics Hardware Technology Parks (EHTP) and Bio-Technology Parks (BTP) schemes, Export Promotion Capital Goods (EPCG) scheme, Special Economic Zones (SEZ) scheme and the Duty-Free Imports for Exporters Scheme (DFIS). It also found the duty credit scrips awarded under the Merchandise Exports from India Scheme (MEIS) to be inconsistent with these provisions.

The panel — in its 113-page report released late Thursday — recommended that India "withdraw the prohibited subsidies" under these schemes within 90-180 days (depending on the scheme) from the adoption of its report.

At the same time, the panel rejected US' claims that the exemption from central excise duty on domestically procured goods under the EOU/EHTP/BTP schemes and the exemptions from customs

duties on importation under certain conditions of the DFIS scheme are inconsistent with SCM.

These subsidies, worth "over \$7 billion", are enjoyed by producers of Indian steel products, pharmaceuticals, chemicals, informa $tion\, technology\, products, textiles$ and apparel "to the detriment of American workers and manufacturers". said the office of the United States Trade Representative (USTR).

"This is a resounding victory for the United States," said USTR Robert Lighthizer in a statement

"Exports under the SEZ have increased over 6,000 per cent from 2000 to 2017 and in 2016 accounted for over \$82 billion in exports, or 30 per cent of India's export volume. The report comes a little over a month before the WTO dispute settlement mechanism is likely to be paralysed as its appellate body, which is supposed to consist seven members, will only be left with one member. At least three members are required to hear an appeal on a dispute panel's ruling, and experts feel this may keep WTO from enforcing the ruling against the Indian export promotion schemes that were scrutinised in the present report.

"Since the appellate body is likely to be dysfunctional by December, if India appeals the report, then the panel report does not stand a chance of getting adopted by the dispute settlement body. In that situation, there would be a huge question mark on the legal sanctity of this report," said Abhijit Das, head of the Centre for WTO Studies at the Indian Institute of Foreign Trade.

"If the appellate body had up-

held the contentions of the US India would have had to withdraw the export-contingent subsidies without delay," he said.

Meanwhile, the Centre has already begun work on making some of the debated schemes more WTO-compliant. In September, it announced various schemes for promotion of exports, including the Remission of Duties or Taxes on Export Product (RODTEP) to replace the MEIS under the Foreign Trade Policy of India (FTP 2015-20).

"The new scheme which is being proposed is a different scheme as compared to the MEIS ... the overall envelope for the duty forgone under the new scheme will be more or less the same as MEIS which is at present around Rs 40,000-45,000 crore (annually). Otherwise, MEIS will have to be closed as it is not WTO compliant,' Directorate General of Foreign Trade Alok Chaturvedi had said. "The new scheme is WTO compliant and will go on."

# Mirroring slowdown, core sector output shrinks 5.2% in Sept **ENS ECONOMIC BUREAU**

NEW DELHI, OCTOBER 31

GROWTH IN the eight core sectors of India's economy declined by 5.2 per cent in September 2019 – a drop that analysts say has not been witnessed so far in either of the two base years used to calculate growth in production of the core sector industries. Overall growth has been hit by declining production in most core sectors except for fertilisers, according to data shared by the Commerce Ministry Thursday. This indicates that the country's economic slowdown may be deepening.

Core sector growth in August, earlier expected to be at a threeand-a-half year low, was revised upward to 0.1 per cent from a decline of 0.5 per cent earlier. The growth of India's eight core sectors — coal, crude oil, natural gas, refinery products, fertilisers, steel, cement and electricity — is a lead indicator of the monthly industrial performance. These sectors had grown by 4.3 per cent in September last, and their cumulative growth during fiscal 2018-19 was 4.4 per cent. The growth in April was recorded at 5.2 per cent, the highest this fiscal so far, before it began to decelerate.

In September, production in refinery products — which make up nearly 30 per cent of the Index of Industrial Production (IIP)—declined 6.7 over the same month in 2018, continuing the mostly negative trend of growth witnessed in May 2019, when de-growth was 1.5 per cent. Coal production, accounting for 10.33 per cent of IIP, fell the most, posting a decline of over 20 per cent in September.

Production in natural gas and cement segments also declined, registering a de-growth of 4.9 per cent and 2.1 per cent, respectively.

Steel production, which accounts for 17.92 per cent, declined 0.3 per cent from 5.1 per cent in August and 13.3 per cent in April. Growth in the electricity secEXPLAINED Fertilisers an outlier, may grow in Oct too SEVEN OF the eight sec-

tors registered negative growth rates in September, with only the fertilisers industry showing positive growth.

This could augur well for the nation's agricultural sector, which is all set for the rabi sowing season and will be gearing up for a rise in demand for food crops. The fertilisers industry could also record positive growth in October.

tor, which accounts for nearly 20 per cent of the index, contracted for the second month this year, registering a 3.7 per cent degrowth. In August, de-growth was 0.9 per cent. The crude oil segment maintained a 5.4 per cent de-growth for the second month this fiscal. However, drop in production has slowed since April, when contraction in this sector was over 6 per cent — a trend that continued until July.

Fertilisers was the only segment registering growth. In September, production in this sectorwas up 5.4 per cent — the highest in FY20.

"Such a low growth in core sector industries has not been witnessed so far in either 2011-12 base or 2004-05 base series. This clearly indicates the severity of the ongoing industrial slowdown, said Sunil Kumar Sinha, principal economist, India Ratings and Research.

# Rajan: Much of my term as RBI Governor was under BJP govt

FORMER RBI Governor Raghuram Rajan, who faced a stinging attack from Finance Minister Nirmala Sitharaman for presiding over the "worst phase" of the Indian banking sector, on Thursday reminded her that two-third of his tenure as the head of the central bank was under the BJP government.

Rajan — who was Governor of the Reserve Bank of India (RBI) from September 5, 2013 to September 2016 – said during his term a clean up of the banking sector that was "clogging" with bad loans had begun and the job remains unfinished. He said India needs a new generation of reforms to accelerate economic growth. At 5 per cent GDP growth rate, India was witnessing substantial economic slowdown.

"I had just over eight months in the previous (Congress) government and I had 26 months under



this (BJP) government ... much of my term (as RBI Governor) was under this government," he told CNBC in an interview.

He was asked about Sitharaman's comments in New York earlier this month where she said that the Indian public sector banks had the "worst phase" under the combination of former Prime Minister Manmohan Singh and Rajan. Rajan, however, hasten to add that he doesn't want to get into a political debate on the issue.

Besides, Sebi has issued a format in which such disclosures need to be made.

# Sanofi inks pact with Unitaid; to reduce key TB drug's price by 70%

GLOBAL BIOPHARMACEUTICAL company Sanofi will lower the price of rifapentine, an important drug used to prevent tuberculosis (TB), as part of the agreement with Unitaid, the Global Fund to Fight AIDS, Tuberculosis and Malaria, an official release said on Thursday.

The agreement brings the price of rifapentine 150 mg tablets down from €4.62/pack of 24 tablets to €3.60/pack of 24 tablets.

Paula Fujiwara, scientific director at The International Union against Tuberculosis and Lung Disease welcomed the slashing of the price of the drug. The deal will bolster efforts to treat latent TB infection — currently estimated to affect 1.7 billion people worldwide — by broadening access to better preventive therapy,

Fujiwara told The Indian Express.

The volume-based agreement will discount the price of a three-month treatment course of rifapentine by nearly 70 per cent, from approximately \$45 to \$15 (ex-works) in the public sectors of 100 low- and middle-income countries burdened by TB and TB/HIV co-infection.

A quarter of the world's population is infected with latent TB, which have no symptoms and are not contagious. Without treatment, 5 per cent to 10 per cent of these people — 85 million to 170 million people globally — will develop active TB.

The vehicles, including Datsun Redigo, were found to be unstable on several parameters with exposure to different kind of injuries, raising questions over the reliability of Indian cars, especially the mass segment ones meant for middle class buvers.

While Ertiga got three stars for adult and child protection, the MPV's bodyshell was rated borderline unstable, with the footwell region rated unstable, exposing front-seat occupants to foot injuries, according to the global new car assessment programme (GN-

FIAT CHRYSLER and Peugeot owner PSA plan to join forces in a 50-50 share merger to create the world's fourth-largest automaker, seeking scale to cope with costly new technologies and slowing global demand.

Fiat Chrysler (FCA) and PSA said on Thursday they aimed to reach a binding deal to create a \$50 billion group with listings in Paris, Milan and New York, and with PSA's Carlos Tavares as chief executive and FCA's John Elkann as chairman.

It was less than five months ago that FCA abandoned merger talks with PSA's French rival Renault and the move comes as carmakers grapple with a downturn in their markets as well as hefty investments in electric and self-driving vehicles.

FCA would get access to PSA's more modern vehicle platforms, helping it to meet tough new

# The art of darkness

Vladimir Putin flaunts Russia's increasing influence in Africa



On October 23 and 24, Russia's President Vladimir Putin hosted more than 40 African leaders at a first-of-its-kind summit in Sochi. Reuters

IN OCTOBER 2017 Faustin Archange Touadéra was in a difficult spot. The president of the Central African Republic (CAR), one of the world's poorest and most fragile countries, was struggling to quell a dozen or so militias that threatened his regime. A year earlier France had withdrawn troops from its former colony. An arms embargo meant that the government of CAR could not equip its own soldiers. Short of options, Mr Touadéra did what desperate African leaders sometimes do: he turned to President

Vladimir Putin of Russia.

The impact was swift. Within weeks a mining and a security company linked to Yevgeny Prigozhin, Mr Putin's crony, were reportedly registered in Bangui, the capital. That December Russia successfully lobbied for the arms embargo to be lifted. Soon after, it dispatched weapons and mercenaries to shore up Mr Touadéra's regime, as well as a former GRU (military intelligence) operative to act as the president's security adviser. A few months later Lobaye Invest, the mining company, won concessions to look for gold and diamonds. When three Russian journalists tried to investigate their country's shady operations in CAR they turned up dead in July 2018.

Mr Putin would like to have the world believe that his country's approach to the continent is about more than chicanery. To that end, on October 23rd and 24th, Russia's president hosted more than 40 African leaders at a first-of-its-kind summit in Sochi. As at the triennial summit of African leaders hosted by China, which the Sochi summit aped,


there was much talk of trade and investment. "We have a lot to offer to our African friends," said Mr Putin, ahead of the event. But Russia's actions in CAR—and in other weak states—capture the nature of its operations in Africa much better than the rhetoric of Mr Putin, who overstates his country's influence.

Russia has a long history of intervening in Africa. Its volunteers fought the British in the second Boer war. During the cold war the Soviet Union inculcated post-colonial leaders in Marxism-Leninism and backed liberation movements in countries such as Angola, Mozambique and Guinea-Bissau, often as part of proxy wars with the

Russia's ambitions shrank after the Soviet Union collapsed. But over the past decade, and especially after America and the European Union imposed sanctions on Russia

related to its annexation of Crimea in 2014, the Kremlin has viewed Africa as an increasingly important arena. Since 2015 a dozen African leaders have visited Russia. From 2006 to 2018 Russia's total trade with sub-


Russia does not just supply arms, however. In several countries it has become deeply involved in internal affairs. These engagements reflect the defining theme of Russia's Africa policy: opportunism. One of Mr Putin's skills is an ability to spot openings presented by a mix of fragile states and a distracted West. Once it has identified an opportunity, the Kremlin looks to increase its influence and to make money for cronies who operate on its license. Ideally these moves can be done at low cost, with high re-

CAR is the emblematic example of this approach. For an estimated

cost of just €5m (\$5.6m), Mr Putin's cronies gained access to minerals, provided jobs for mercenaries, also allegedly controlled by Mr Prigozhin, and tested out their tactics for interfering in the politics of other countries—a speciality of Mr Prigozhin, who was placed under sanctions by America for allegedly meddling in its election in 2016.

But CAR is far from the only case. In Madagascar Russian operatives allegedly helped at least six of the 36 candidates in the presidential election in 2018. In Zimbabwe Russians advised the ruling Zanu-PF party before elections last year, and Kremlin-linked firms have signed mining and fertiliser deals. Western diplomats believe Russia tried to sway elections in the Democratic Republic of Congo in favour of a candidate chosen by the former president, Joseph Kabila. And in Guinea, which supplies Rusal, a Russian aluminium firm, with 27% of its bauxite, Russia is supporting efforts by President Alpha Condé to defy the constitution and run for a third term.

Another surge of support is beginning in Mozambique. Following a visit by Filipe Nyusi, the country's president, to Russia in August, Russian hardware and advisers have been spotted by intelligence analysts in Cabo Delgado province, near to where Rosneft, a Russian energy company, has gas contracts.

The advisers are believed to have been asked to subdue an insurgency that threatens both Rosneft's interests and those of the corrupt ruling party, FRELIMO.

All of this activity is worrying some in the West. In a speech last year outlining America's Africa strategy John Bolton, the former national-security adviser to President Donald Trump, called Russia and China "great power competitors" on the continent which are keen "to gain a competitive advantage over the United States.'

But there is a danger of conflating the brazenness of Russia with its actual influence. In nearly every area it lags behind America, the EU and China. "China got the juiciest bits. Russia was left to mop up the leftovers," says Alexander Gabuev, Russia's leading expert on China.

A closer look reveals Russia's limits. Its favoured candidates did not win in Madagascar or Congo. Its attempts to prop up Omar al-Bashir, Sudan's former dictator, failed earlier this year. And it could not get a nuclear-energy deal with South Africa, despite wooing the allegedly corrupt former president, Jacob Zuma.

There is also less to Russia's military efforts than meets the eye. Ahead of the Sochi summit Mr Putin claimed more than 30 military co-operation deals with African states But many amount to little more than the odd training exercise. African states often keep their options open, striking deals with America and China as well. Both have a base in Djibouti, a small east African country Russia, though, does not, despite years of lobbying. American pressure on the local gov-

ernment has kept it out. There is a similar gap between rhetoric and reality when it comes to economic deals. In 2018 the total value of Russia's trade with sub-Saharan Africa was \$5bn, less than Turkey, Singapore or Thailand. (American and Chinese trade was worth \$120bn and \$35bn, respectively.) Many deals that are announced at lavish signing ceremonies by Rosneft or Rosatom, Russia's state nuclear company, never end up happening. "It offers remarkably little that African states actually need," explains Paul Stronski of the Carnegie Endowment for International Peace, a think-

For all the pageantry on show in Sochi, Russia remains a bit player in Africa. It is influential among beleaguered leaders with few options. But as more and more countries scramble to engage with the continent, its leaders see Russia as one of many suitors. Mr Putin may want Africans to think of Russia as a great power. But a summit does not make it so.

# Digging up Franco

Franco's exhumation is both historical duty and electoral stunt

AFTER DYING in his bed in 1975 General Francisco Franco, Spain's dictator for 36 years, was buried in haste at the Valley of the Fallen,  $the\,grandiose\,monument\,on\,a\,mountainside$ outside Madrid that he built to celebrate his victory in the Spanish civil war. But his presence there, in one of only two named tombs amid 34,000 anonymous war dead, is now widely seen as an aberration. On October 24th, in an operation organised by Pedro Sánchez, the Socialist prime minister, and attended by 22 of the dictators' descendants, Franco's coffin was dug up. In scenes broadcast live on television it was then carried by the family, first to a hearse and then a helicopter, which took it for reburial at a quiet public cemetery at El Pardo, on the outskirts of the capital where his wife is buried.

Mr Sánchez was carrying out a resolution of the Spanish parliament and a promise he made on becoming prime minister last year. It took more than a year to overcome legal objections from Franco's family who wanted to rebury him, prominently, in the crypt of Madrid's cathedral—and the

threatened disobedience of the Benedictine prior who administers the basilica and monastery at the Valley. The Vatican slapped down the prior; last month the Supreme Court ruled unanimously that the government could rebury Franco at El Pardo.

"No enemy of democracy deserves a place of worship nor institutional respect," Mr Sánchez said of the court ruling. "It's a great victory for Spanish democracy". More Spaniards agree with him than disagree. But the delay means the exhumation comes

barely a fortnight before a general election, the fourth in as many years. The Socialists hope it will rally their faithful. Only Vox, a far-right party, actively opposes what it calls a "profanation" of Franco's tomb. The conservative opposition, which descends from moderate former franquistas who embraced

democracy, would rather discuss the future. The Socialists want to turn the Valley into "a museum of memory". There is a risk in that of history once again being written by one side. Perhaps the best thing would be to deconsecrate the site and create a museum that explains what happened at the Valley itself. Franco's dictatorship relied partly on forced labour to build it. Originally intended only to honour its own side, the dictatorship ended up filling its crypts, too, with dead from the vanguished Republic, extracted secretly from mass graves. Its architecture is forbidding, that of a militant Christianity. Its basilica is dug deep into the mountainside, and lined with statues of avenging archangels. It is topped by a cross half as high again as the Statue of Liberty.

Modern Spain is not in thrall to Franco's ghost. Most Spaniards have no memory of the dictator. Only an aging minority still reg-


ularly attend mass. But the lack of unanimity over the exhumation shows that the country has yet to agree on the past. Perhaps








# Ghosts of a City

An exhibition reveals a nostalgic side of Delhi through the lenses of Raghu Rai, Madan Mahatta and Habib Rahman

A STUNNING black-and-white photograph of the late classical dancer Indrani Rahman, who was the first Miss India, 1952, to represent the country at the Miss Universe pageant. Her reflection shot by her famous architect-husband Habib Rahman, after they shifted to the Capital, offers a ringside view of Delhi of the '50s. Famous for sporting a bindi and a gajra in the swimsuit round of the international competition, not many are aware that she won the Miss Calcutta competition as part of a fundraiser. Many such stories emerge from the exhibition "Delhi That Was" at Ojas Art Gallery, Delhi, which offers a rather unusual look at the Capital, beginning from the 1950s and follows it through the next five decades, with the works of Rahman and renowned photographers Raghu Rai and Madan Mahatta.

Indrani's son Ram Rahman, who manages the Habib Rahman Archives, mentions how actor Raj Kapoor wanted to cast his mother in his film but she thought of Bollywood as being 'vulgar and cheap'.

In the exhibition are photos of Kashmirborn Madan Mahatta, who passed away in 2014. He had photographed the Gandhi family — Indira, Sanjay, Rajiv and Sonia — sitting in the front row of a Pierre Cardin fashion show in 1967. The frame is a far cry from the fashion shows of today that mostly have nonentities and token presence of the Indian film industry. Mahatta's 1978 photograph of the Delhi Zoo entrance, designed by Habib, has turbaned youngsters and women wearing

shirts, pants, and salwar suits. Mahatta also captured a flooded serpentine lane in Delhi's popular Connaught Place (CP), full of Chevrolets, Fiats, Padminis and Ambassadors, that have wandered into oblivion in present day. It shows an almost empty Inner Circle with barely three cars parked around the shops. In a 1961 frame, there's Queen Elizabeth with Dr Rajendra Prasad, the first President of India. She is seen waving to the crowd that has assembled on the roads, terraces and roof of CP. A young boy in a red sweater seems to be running along the corner to catch a glimpse of the royal convoy. Mahatta also turned his lens to an elephant procession at Rajpath in 1955 and photographed MF Husain painting a colourful cinema hoarding in 1974. The canvas brims with elephants, tigers and rhinoceros.

New Delhi-based veteran photographer Raghu Rai is known for the way he captures the emotions of the city and its people. Be it



the bare minimum clothing and drums inside a drummer's house in a Delhi village in 1968, or a cluster of men who have assembled in front of Jama Masjid 50 years ago, which has now been overpowered by a concrete jungle and markets. A man thrashes wheat in front of Humayun's tomb in the company of bullocks in Rai's photograph from 1967, while labourers put all their energy into pulling ropes and installing a mammoth Lord Mahavir statue at Ahinsa Sthal in 1990.

Calling it a nostalgic exhibition, the curator of the show Anubhav Nath says, "The hope is to make people experience and view a Delhi that was, which is so romanticised and get a glimpse of how things were. In these photos, one sees what a commendable job Archaeological Survey of India (ASI) has done to maintain these

monuments."

and gloomy place."

Institutions designed by Rahman become his focus of attention and were photographed right when they were built, be it Rabindra Bhavan and its interiors, the Curzon Road Hostels, IP Bhavan or Patel Bhavan. For instance, Rabindra Bhavan — which was ini-

tially designed to be seen from the gol chakkar - shines in a 1961 photograph and sits without the current temporary structures, boundary wall or planting. Ram says, "All that we get to see is the wall of trees now and we can no longer see the building from the road." There's also a photo of its interiors. The top glassed portion is full of light, in place of the artificial ones that are there today. Ram says, "All proportions that were carefully designed were messed up. The light coloured cement flooring was ripped apart and replaced with cheap wooden flooring. The sky lights have been blocked for no reason and it spoilt the whole sense of light. Natural light used to fall on the central staircase but now it is a dark

# Migrations in Verse

Lovers of Urdu gathered in Delhi to read poetry on Lord Ram and the Ramayana

IN HIS poem *Ram*, Urdu poet Allama Igbal terms the deity as 'Imam-e-Hind', the prelate of India, in whose existence the entire country took pride in. The poet calls Ram zindagi ki rooh (the soul of life) and roohaniyat ki shaan (the pride of spirituality). For Iqbal, Ram, the great warrior king, was "humane" and "morally upright". Urdu poetry is replete with references to Lord Ram and the episodes from The Ramayana. An evening organised by author, translator and literary historian Rakhshanda Jalil, in New Delhi recently, had lovers of the language read from well-known literature. These included Rashmi Aggarwal, Jonathan Gill Harris, Fouzia Dastango, Chinna Dua, Zehra Kazmi, Kartikeya Pradhan, Arnav Diwan and Vidit Singh.

The rendition of Iqbal's poems by Aggarwal, Delhi-based Sufi singer, had the audience hooked to her intonations. In one line, Iqbal says, "Labrez hai sharaab-e-haqeeqat se jaam-e-hind/sab falsafi hain khitta-emaghrib ke Raam-e-hind (the goblet of India is brimful with the wine of reality/The philoso-

phers of the West only echo Hind's Ram). "There are over 300 Ramayanas written in Urdu, many in Urdu verse known as manzum Ramayanas. The event was meant to showcase a sampler from the verse Ramayanas as well as the reams of poetry written on Ram, Sita, Urmilla, Lakshman and the other dramatis personae," says Jalil.

Conceptualised and curated by Jalil, "Kahani Ram-e-Hind Ki" was held at the India Habitat Centre. Its organiser, Hindustani Awaaz, promotes Urdu zubaan and tehzeeb through content-based programming.

Gill Harris, professor of English at Ashoka University, recited Kaifi Azmi's Doosra Banwaas. The poem imagines Ram coming back to Ayodhya on December 6 and feeling exiled again after he is a witness to the dance of madness (rags-e-diwangi) in his Capital. "It was written immediately after the destruction of Babri Masjid in 1992, but it resonates all the more now in a time when the name of Ram has been weaponised by Islamophobic mobs in ways that make a mockery of him," says Harris.

Before his recital, Harris said, "Urdu includes so many different variations, but also words that have migrated from so many other languages. It makes room for everyone because it is a true rekhta or mixture."

A young student, Zehra Kazmi, recited a poem by Tripurari, a Mumbai-based contemporary Urdu poet. Titled Urmila, the poem is about Lakshman's wife and Sita's sister. When Lakshman decides to accompany Ram in exile, leaving Urmila alone in Ayodhya, a desire tossed in pain (tadapti aarzoo) would have fallen from Urmila's lips to the floor, broken into a thousand shards. The poet says that there is no part of the epic that is not drenched with her tears, and yet there is no trace of her pain anywhere.

# To The Manor Reborn

The Delhi hotel that once housed India's most famous restaurant reopens with a new look and a new restaurant

FOR A boutique hotel tucked away in a tiny — albeit, posh — corner of Delhi, The Manor is fairly well-known. Of course, a large part of its fame came from Indian Accent, known to be one of the country's best restaurant. While chef Manish Mehrotra moved to a larger premises in The Lodhi Hotel in 2017, The Manor itself was closed for a makeover. It has now emerged, with a lot of fine-tun-

ing and a pared-down aesthetic. "The Manor opened as an inn in the 1950s, and then underwent a complete makeover in the '90s. When it opened again in '99, it was with Vinay Kapoor and Shirley Fujikama (of multidisciplinary design firm u+a) at the helm. The hotel changed hands a couple of times after that, but with this reopening, Vinay and Shirley are again our principal promoters," says Akshay Chawla,

general manager at The Manor. The hotel has been partially operational since January this year, with the rooms, fitted out with new furniture and a beige-andgrey minimalist theme. "The previous room design featured heavy furniture, which was the trend 20 years ago, and had wall-to-wall carpeting. So while some of the old elements have been retained, like the layouts of the bathrooms (with new plumbing and fixtures) and the woodwork, the furniture

has been fully replaced and the carpeting has been removed to show the new terrazzo tile flooring," says Chawla.

In the space that was once occupied by Indian Accent in the hotel block is a new restaurant called In-Q. Helmed by chef Aditya Jha, formerly of the Oberoi, New Delhi, and Gaggan, Bangkok, the new place, like its predecessor, serves progressive Indian cuisine. The lifestyle block of the

property — which used to house Zehen Spa - has been completely overhauled. The ground floor will soon see the opening of a casual, all-day cafe called Noci Caffe and Cucina, serving small plates, wood-fired pizza and coffee. The first floor houses the fitness centre, STUDIO60, and the aesthetic clinic, ISAAC Luxe, both of which are operational, while the second floor will soon have a new spa called House of Ayurveda, by the Kairali Ayurvedic Group.

Chawla says that some space has also been carved out to house art galleries. "While those who stay with us will be guaranteed privacy and the sort of intimate setting that they experience in boutique hotels all over the world, the lifestyle block is where we hope to encourage other guests from

# Bangladesh learning to live without Shakib

While all-rounder Al Hasan leaves a big vacuum in the team, his absence also gives youngsters a chance to step up

NEW DELHI, OCTOBER 31

FEROZ SHAH Kotla was enveloped in a thick layer of haze when the Bangladesh team arrived for training on Thursday afternoon. For the third day in a row, Delhi's air remained 'severe', recording an abysmal 410 on the air quality index. Bangladesh opener Liton Das took the field wearing a mask, saying it was a precautionary measure.

With their star all-rounder Shakib Al Hasan banned, Bangladesh too need to take many preventive measures as they face a strong Indian side. The all-rounder's absence will surely rattle this outfit. However, it will also hand opportunities to some of the lesserknown players to step up on the big stage.

Since his debut in 2007, Shakib has been the pivot on which Bangladesh have hinged as a team. During the World Cup in England, he was instrumental in giving them a sniff of entering the knock-outs. Despite finishing with 606 runs at the showpiece event, Bangladesh failed to qualify because Shakib rarely found substantial support from the other end to match his scintillating stroke-play.

Das did not mince words when he said: "Shakib's absence is a huge loss for us. He is the best player that Bangladesh has ever produced, and to lose him in such a manner before this tour will hurt us no doubt. Having said that, these things are not under our control. Our job is to focus on the upcoming T20 series and hopefully, if some of our youngsters can step it up, it will serve us well."

Mahmudullah's men will seek inspiration from their performance in the Asia Cup last year, where they marched into the final despite the absence of Shakib, who sat out of that tournament due to a finger injury. In the summit clash, they came close to giving India a scare, before Dinesh Karthik sealed the match with a sensational cameo. "It's not like Shakib had played non-stop cricket for Bangladesh. There was a phase in 2018 when he sat out for more than six months due to an injury. He even missed the Asia Cup last year where we reached the final," Das explained.

#### A-listers missing

Shakib is the not the lone high-profile player who will miss this India tour. Bangladesh's incumbent opener Tamim Iqbal has also opted out so that he can be with his wife for the birth of their second child, while fast bowling allrounder Mohammad Saifuddin has been sidelined for at least four months after a relapse of his long-standing back injury.

Iqbal's paternity leave hands a rare opportunity to Imrul Kayes. The top-order batsman last featured in an ODI more than 10 months ago. His T20 appearances have been even more sporadic, having been out of action in this format since 2017. Apart from Kayes, Bangladesh's batting in this series will hinge on their seasoned wicket-keeper batsman Mushfigur Rahim, the belligerence of Soumya Sarkar, opener Das, and captain Mahmudullah.

Bangladesh's batting may exude a semblance of hope, but their bowling looks short on experience and confidence. Shakib would have ensured four overs of parsimonious, yet attacking, left-arm spin. Without him, the onus falls squarely on their left-arm pacer Mustafizur Rahman, who has been quite a revelation for the Sunrisers Hyderabad in IPL. Like Kayes, the selectors have taken a bold decision to induct left-arm spinner Arafat Sunny in the mix. After intermittent appearances in the shorter formats, Arafat was reported for suspect action in 2016, which relegated him into the wilderness. More than three years later, and with a remodelled action, the 33-year-old now finds himself back in the cauldron.

As Bangladesh braces for life without Shakib, their fortunes in India will largely depend on this motley bunch, some experienced, while others are desperately looking

to recalibrate their international careers.

# In the (bad) light of air pollution, Ganguly says scheduling needs to be 'practical' in the future

WITH FARM fires raging across north-western India, the outlook for Sunday evening, when India take on the visitors in the first T20 International, is grim. While BCCI president Sourav Ganguly said the Kotla T20I will go ahead despite the pollution, he agreed that scheduling of matches in the northern part of the country — especially during this time of the year — needs to be a little more practical in the future.

"In the future, when we schedule, especially in the northern part of India during the winter, we will have to be a little bit more practical," Ganguly told reporters at Eden Gardens.

He added that it's now "too late" to make a switch from Kotla.

"It's too late to do anything, because a lot of preparations go into matches tickets, crowds everything... So it's not possible to cancel things at the last minute. Fingers crossed," the BCCI president said. "I hope the match gets through. I spoke to the DDCA and they are confident to get through it. I know post-Diwali it's a bit

tough in the North. As I said, fingers crossed. It's too late to change. I hope everything goes fine."

Ganguly, though, has received assurance from the Kotla ground staff. "I spoke to the groundsman. He says once the sun comes out, it will be fine. He was my groundsman in Delhi Capitals. I know him well, so he said everything will be fine. We want the game to happen."

Post-Diwali, Delhi's air is 'severe' as usual. Back in December 2017, when Kotla had hosted a Test between India and Sri Lanka, a lot of Sri Lankan players wore face masks. Some of them gasped for breath and needed on-field treatment. And yet, the first match of the upcoming home series against Bangladesh was slotted in Delhi, on the heels of Diwali. Three T20Is and two Tests would be played in the series, with Rajkot and Nagpur being the venues for the second and the third T20Is, and

Indore and Kolkata hosting the two Tests. After registering the new BCCI constitution, the Committee of Administrators (CoA), which helmed the cricket board till the October 23 elections, had disbanded almost all the committees and sub-committees. The BCCI's tours and fixtures commit-

"We will also create a system where Ravi's involvement is more at the NCA till the time he is coach. We will make it a good Centre of Excellence. We have Rahul Dravid, Paras (Mhambrey), Bharat Arun..."

During his NCA visit yesterday, the BCCI president had a separate meeting with the NCA director, Dravid, to find out "what is the way forward".

# D/N Test good move as long as dew isn't a factor: Tendulkar

INDIA'S FIRST ever Day/Night Test will be a success only if the dew factor is countered effectively at the Eden Gardens, says the iconic Sachin Tendulkar, apprehensive that wet conditions might severely hamper pacers and spinners alike.

Tendulkar welcomed the introduction of Tests under floodlights in India, saying it is a "good move" and will pull back crowds for the traditional format. India will play their first-ever Test under lights with pink ball against Bangladesh from November 22

"As long as dew does not become a factor, it is a good move but if dew is going to be a factor then seamers as well as spinners are going to find it challenging," Tendulkar told PTI. "Because once the ball gets wet neither seamers can do much nor the spinners. So in that way, bowlers will be put under the test. But if there is no dew, then surely it is a good addition," the maestro said about a historic first in Indian cricket.

The dew was a factor at the Eden Gardens during ODI games under floodlights, something Tendulkar is apprehensive about.

Tendulkar's homework before facing any particular bowler, be it Shoaib Akhtar or Shane Warne, is a stuff of legends and he offered a tip to the Indian batsmen for their net session.

"The batsmen will need to practice with different balls at the nets. A new pink ball, a 20-over pink ball and a 50-over pink ball and an 80-over ball. See how differently a new, semi-new and old ball behaves. Accordingly prepare your strategy," he suggested.

## **BCCI** ethics officer summons Dravid again

New Delhi: BCCI ethics officer D K Jain has asked Indian cricket great Rahul Dravid to appear in person for the second time, on November 12, for "further submissions and clarifications" on the conflict of interest allegations levelled against him.

The 46-year-old former India captain had earlier explained his case in the personal hearing held in Mumbai on September 26.

MPCA life member Sanjiv Gupta had filed the complaint against Dravid, alleging conflict of interest in his current role as National Cricket Academy (NCA) Head and being an India Cements employee.

"Jain wrote to Dravid on Wednesday night, asking him to depose on November 12 in New Delhi. Gupta too will be heard," a BCCI official told PTI.

Dravid is currently the NCA Director in Bengaluru besides being a vice-president in the India Cements group, which owns the IPL franchise Chennai Super Kings.

He was also the head coach of the India A and Under-19 teams before being handed the NCA role, which includes monitoring the progress of these two sides as well.

Dravid has already given a reply and defended himself saying he has taken leave of absence from India Cements and he has nothing to do with the Chennai Super Kings. PTI





# Daylight between India and Russia

THEY ARE not here. But India can't seem to stop talking about Pakistan. Partly in awe, partly as a warning. The Green Shirts' spunky show against the Netherlands in the Olympic qualifiers last weekend has been the talk of the hockey world. For India, it was a lesson in avoiding complacency.

Not just Pakistan, in fact. France too featured heavily in coach Graham Reid's team meeting as he pressed upon the team to shrug off its habit of underestimating lowerranked teams, as India take on Russia in a two-match Tokyo 2020 qualifier.

"We had a meeting after those games (Netherlands-Pakistan and Spain-France) and what was really good is that we've been talking about exactly those things... When you don't start well and when you don't follow the game plan early," Reid says.

Russia, ranked 22, have never qualified for an Olympics or the World Cup. To say that they are a nation with no hockey pedigree would be slightly misleading. The erstwhile USSR was one of the most dominant European teams in the 1980s, managing podium finishes at the 1980 Olympics and European Championships.

The break-up of the Soviet Union spelt the end of hockey in the region and Russia has never come close to achieving anything major. "We don't have any money. Ice hockey has 4,000 times more funding than we do,'

team manager Arkadii Kondratev says. This week, Kondratev adds, will be historic for the team because both the matches will be shown live on TV back home. Unfortunately for them, if past results are anything to go by, the Russians are likely to

witness a thrashing. It was the lowest point for the team in a tumultuous 2018, which also saw two changes of coach, failure to medal at the Commonwealth Games and inability to go beyond the quarterfinals in a World Cup played at home, at this very venue.

This year, in comparison, has been quiet; perhaps a much-needed antidote. India have not had a single major assignment – the FIH Series Finals technically was but it was a competition full of minnows except Asian Games champions Japan – and most of the time has been spent playing practice matches around the globe.

#### Old hands return

Yet, some uncertainty remains. After dabbling with the policy of focusing on younger players and phasing out the veterans for a major part of this four-year Olympic cycle, India will ironically enter the two-match qualifying series with most of the senior players back in the squad.

Drag-flicker Rupinderpal Singh, defender Birendra Lakra, forwards Ramandeep Singh and Lalit Upadhyay are all back in the squad after being in-and-out for a major part of last year. Forward SV Sunil, who was dropped for the World Cup last year, returns as the vicecaptain. "I don't know the history but what I was told is he was injured," Reid says about Sunil. Curiously, injury was never mentioned as a reason to drop Sunil and when he was excluded from the World Cup, it seemed like the end of his career. "The 18 players here are all equal. Those who deserve to be in the team are there," captain Manpreet Singh says.

The return of these veterans makes India overwhelming favourites to win this tie. Then again, they are quick to give the Pakistan example. Sunil, the only player in this squad to suffer the ignominy of failing to qualify for the Olympics, even cited the 2008 example. "Our mindset should be about winning. But we don't want to underestimate Russia," Manpreet says. "Sunil has given us the example of 2008.

# Us versus US

USA showed how far India was in world hockey, now hosts have a chance to beat them to book Tokyo berth

AFTER THE 4-0 drubbing at the hands of the

USA in the 2008 Olympic qualifiers, Suman Bala grabbed Rani Rampal by the arm and whispered in her ear, "one day, you have to become like them and beat them."

Bala was 26 and on the last legs of a once flourishing career. Rani was half her age; the qualifiers, a first brush on the canvas for her. The Americans, with their superior strength and bigger physique, struck fear in the hearts of both players.

"They were so tall and so strong," Rani gushes even today. "We were scared of

On Tuesday, 11 years after that defeat and three days before India were to take on the USA in the 2020 Olympics qualifier, Bala called Rani to remind her of the promise she had extracted. Till a couple of years ago, this would have passed off as wishful thinking. Not so much right now.

Since that rout in Kazan, the two teams have routinely played against each other. Their physical and tactical superiority unwittingly turned USA into a gold standard for India even though they have not quite been the gold standard themselves in world hockey.

But after a decade of losing to them, this weekend will be the first time in the 36-year competitive history between the two teams that India will enter a contest against the USA as equals. "We feel we can beat them. So far, we had an underdog mindset but that is not the case anymore," Rani says.

It's taken 18 months of relentless and borderline obsessive focus on improving the team's speed and structure to close this gap. And its genesis lay in an embarrassment at the biggest stage of all – the Olympics.

The Rio Games were India's maiden appearance at the Olympics in more than 30 years. India hoped to show the world how much they had improved, but what they got was a rude reality check. The team scored just three goals, allowed 19 and finished last in the 12-team tournament.

A few months after the debacle, Hockey India appointed Sjoerd Marijne as coach. "When Sjoerd first joined the team, I think he would have thought, 'oh my god, what is this team!" Rani says.

Marijne, who coached the world number 1 Dutch women before coming to India, laughs that what surprised him more was that the players called him 'sir.' But then, he saw the team train.

"There was no speed at all. And they did

not have much understanding of tactics," he says. "So what kind of structure are you going to play if your team does not have any speed? Are you going to do high press? But, you know, one ball and the opposition will overlap you. If you want to play counter, you don't have the speed... It was very difficult in the beginning."

#### Speed, structure

Marijne and his assistant Eric Wonkink, both tactical nerds, and South African physio Wayne Lombard became fixated with improving these two aspects of the team. Every training session since early 2017, including the phase when Harendra Singh coached the team, has been used to make the girls quicker and fitter, which in turn helped enhance their understanding and implementation of structures and tactics.

A similar approach in 2011 had worked wonders for the men's team and catapulted them into the top five of the world before they stagnated once again. As Marijne saw it, this was the only way to make sure the women's team did not have to wait another 30 years to play at the Olympics.

It helped that the women's team was re-

ceptive to his ideas. "They have leadership and are willing to take responsibility," says Marijne, whose brief stint with the men's team ended because some players were not comfortable with his philosophy of players taking ownership for their decisions on field.

The results were visible against USA, who else. At the Rio Olympics, the Americans had trounced India 3-0.

At the 2018 World Cup, India turned the tables and even though the match ended in a draw, it was enough to take India into the quarterfinals and knock USA out. "They play with a lot of pace now," USA captain Kathleen Sharkey says.

A couple of years ago, such a comment would have been unthinkable for a team that looked like playing in slow-motion every time they stepped on the field. Now, the team can adapt and switch between playing long balls from the centre line, indulging in patient build-up by being strong on the ball, and create goal-scoring opportunities from set-pieces. This is perhaps the best-trained and most settled Indian women's team, with 10 players featuring in all tournaments this year. Of the 26 matches India has played, they have won 16 and lost just four, scoring on an average three goals every match. Given that they scored just three times during their entire 2016 Olympics campaign, this is a massive improvement.

India have relied heavily on Gurjit Kaur's penalty corners for goals. Lalremsiami, Navneet Kaur, Vandana Katariya and Rani consistently chip in with field goals while Deep Grace Ekka leads the defence.

In USA, however, India will face a bogey team – the 2018 World Cup result was seen as an improvement, but it was still only a draw. The inferiority complex that once gripped the team may have vanished, but USA remain tricky opponents.

No one understands that better than Rani. "After we lost the match in 2008, so many players who were towards the end of their career were in tears because they missed the opportunity to play in the Olympics," she

# Springboks' Catch 22: Kolisi or not

The rugby case for the inspirational but fading South Africa skipper is powerful, but less so from a historical and political perspective

STUART BARNES of *The Times* who has written extensively on Springboks rugby has struck a chord of disruption with his suggestion that rugby logic dictates that Rassie doesn't include inspirational captain Siya Kolisi in his Starting XV. We look at the merits of the argument in the backdrop of Kolisi's rise to leadership and what it means to South Africa. (For the record. Kolisi has been used in an extended 40-min first-half burst mostly, and subbed or called on in latter half, throughout the World Cup.) **BARNES' BURNING ISSUE** 

"South Africa have more chance of winning without their captain," Barnes writes, adding that Erasmus, if he can ignore the "historical and political perspective", should select his captain on the bench.

"The No 6 shirt should be worn by the South African who knows the game of Sam Underhill, England's key man, better than anyone — his fellow Bath flanker Francois Louw," he says, urging for a colour-blind decision. "The best chance of uniting 57 million South Africans is to play Louw from the kick-off. One man's inspiration will not suffice if South Africa

are incapable of nullifying England at the breakdown. Kolisi has not appeared to be the force that he was before a knee injury that he suffered in Super Rugby in May." The rugby case for benching Kolisi is powerful, Barnes insists. "Pieter-Steph du Toit has been far more influential in his lineout and counter-rucking than his fellow flanker. He has to start. But even Du Toit cannot compete quite like Louw at the breakdown."

He cites Louw's 74th-minute turnover in the semi-final win over Wales — a few minutes after coming on — as the match-winning moment to put South Africa in the final. "From the penalty, South Africa ended up with a kick to win the game. Would Kolisi have made that turnover? On the evidence of what came before, probably not," he argues. Barnes hinges his theory on the breakdown not being the strength of Kolisi's game. "It is with Louw. New Zealand gambled with an extra lineout man and lost the gamble as England controlled collisions and, with it, the tempo of the game. South Africa will be more comfortable than the All Blacks with slow possession — they will kick a great deal — but defensively, the Springboks have to halt the momentum that England bring to the game, especially early on."

Barnes stresses that Louw will be wasted

in the last 25 minutes; the damage will be done. "Far more sensible to ask him to match Underhill and Tom Curry in contact and keep South Africa within range to throw everything, Kolisi et al, for an unstoppable Springbok surge in the final 20 minutes.'

The team had a three-test series against England as their immediate goal, the 2019 World Cup as their ultimate target and they needed to choose a captain. Siya Kolisi sat amongst his teammates not thinking for a second it might be him. Rassie Erasmus, the head coach, speaks matter-of-factly, his tone rarely changing. Kolisi remembers everything up to the moment Erasmus said that he, Kolisi, would captain the team for the series against England. Everything that came after that sailed right past him without stopping.

Later that morning Erasmus would say he'd known Kolisi since he'd entered the Western Province academy as an 18-year-old and chose him to lead the Springboks because of his leadership and humility."


