Rajoana gets reprieve from death penalty

The Ministry of Home Affairs (MHA) has sent a letter to the Punjab government to commute the death sentence of Balwant Singh Rajoana, convicted for the assassination of former Chief Minister Beant Singh.

The MHA took an "in principle" decision on September 30 to commute the sentence as a "humanitarian gesture" ahead of the 550th birth anniversary celebrations of Guru Nanak, the founder of Sikhism.

India's cancer care facilities 'highly inadequate'

Systematic failure to address needs results in 20% higher mortality, says panel

India's cancer care infrastructure is "highly inadequate" and forces a majority of patients to travel "thousands of kilometres" for treatment.

The "systematic failure" to address the needs of patients contributes to a 20% higher mortality among Indian cancer patients than in countries with a "high" Human Development Index, said a report by a Parliamentary Standing Committee on Science, Technology and Environment.

"The Committee would like to lay emphasis on the fact that mortality to incidence ratio of 0.68 in India is higher than that in the very high human development index (HDI) countries (0.38) and the high HDI countries (0.57)," it noted in the report viewed by The Hindu.

The International Agency for Research on Cancer expects India's cancer burden to increase from an estimated 13 lakh cases in 2018 to about 17 lakh in 2035, and cancer deaths are expected to rise from 8.8 lakh in 2018 to 13 lakh in 2035.

Delhi's odd-even scheme makes inroads in Haryana

Rohtak implements scheme, Gurugram evinces interest

GURUGRAM

The Delhi government's odd-even scheme to curb air pollution has found new takers in the National Capital Region. The Rohtak administration replicated the scheme for autorickshaws last week after pollution levels in the city increased manifold to reach the 'severe' category. And now, even the Gurugram administration is willing to consider the idea.

Gurugram Deputy Commissioner Amit Khatri told *The Hindu* that the scheme

could be implemented in the Millennium City as well in future with an improved public transport system in

place. The Air Quality Index in neighbouring Rohtak breached the 400 mark in the first week of November, forcing the district administration to shut schools for two days. "It was then decided at a high-level meeting to implement the odd-even formula at least for autorickshaws," said DSP, Rohtak

implemented on November 7 and 8.

Divided opinions

The district administration and the autorickshaws' union, however, differed on the usefulness of the scheme. While Mr. Kumar claimed that it brought down the pollution levels considerably, Harvana Pradesh Autorickshaw Kalyan Sangh's Rohtak president Vicky Pehalwan said there was hardly any impact and the plan needed to be extended to all vehicles for any plausible result.

Evo Morales flees Bolivia following deadly clashes

He has been granted asylum by Mexico

Bolivia faced its worst unrest in decades amid a political vacuum on Tuesday, while Evo Morales, who transformed the Andean nation as its first indigenous President, fled the country following weeks of violent protests.

Mr. Morales flew out on a Mexican government plane late on Monday, hours after being granted asylum, as his supporters and foes fought in the capital, while an Opposition leader laid out a path toward new elections. Mr. Morales stepped

down on Sunday, following weeks of widespread protests fed by allegations of fraud in the October 20 presidential election that he claimed to have won.

Alphonsos from Malawi, for Mumbai

A small venture to graft the special variety on a 26-hectare farm in Africa now exports 700 boxes a day

It is not summer, but there are almost-fresh alphonso mangoes in Mumbai's retail shops. They smell and taste almost like the Devgad alphonso, but come from distant Africa. Mangoes from Malawi have hit the market in Maharashtra's capital.

The alphonso trees in Malawi took root in a farm some nine years back, when mango sticks from Ratnagiri were grafted and a new venture was launched. The farm is now spread across

exporting the produce to India last year. "In 2018, the import of mangoes was small, since it was the first time. This time, around 700 boxes a day are expected to arrive, starting Tuesday. All big retailers are purchasing them, as they liked the quality last year," Sanjay Pansare, a trader in the APMC fruit market, said.

harvest windows. "Indian mangoes are not available during October-December, but mangoes are harvested in Malawi during that period. Indian alphonsos arrive from January through August from various parts of the southern and Konkan areas of Maharashtra," Mr. Pansare said. "The African venture,

Malawi Mangoes Operations, was started by British, German and African promoters. They planted the mango sticks by grafting them on 26 hectares first, and it has grown into a 600-hectare farm," Niranjan Sharma, who handles the firm's operation from Pune,

The organisation has around 800 employees. Each imported box has 3 kg of mangoes, priced between ₹1,400 and ₹2,000. Absence of direct flights

from Malawi has an impact: a kilo incurs around ₹200 in freight. The import duty is about 38%, adding to the cost. "Qualitywise, they meet European norms as they go through hot water treatment. The sand and weather in Malawi are similar to what we have in Maharashtra, making the fruit taste almost like Indian ones," Mr. Pansare said.

JNU Executive Committee to discuss hostel fee hike today

Students plan to protest outside convention centre; demand rollback of hike

A day after thousands of students agitated outside the Jawaharlal Nehru University (JNU) convocation ceremony against a hike in hostel fee, all eyes are now on the Executive Committee (EC) meeting scheduled to be held on Wednesday.

The protesting students had been assured by Union Minister for Human Resource Development Ramesh Pokhriyal that he would look into their demands.

The EC is the highest decision-making body of the university and sources said that the draft hostel manual, which was passed in the Inter Hall Administration meeting on October 28, would be

The JNU Students' Union (JNUSU) has called for a strike outside the Convention Centre, where the meet-

ing will be held. The union said it would not allow the meeting to take place without the rollback of the fee hike. The students are also running a social media campaign to raise awareness about why the hike is an important issue. "An estimated 40% of students studying at INU come from families that

have an annual income of less than ₹1.44 lakh, as per annual reports of JNU. With the fee hike, these students will not be able to continue their studies at the universi-

ty," the JNUSU said. The students have also called for November 14 to be observed as National Protest Day, to protest against rising costs of higher education and the New Education Policy. The ABVP has also called for a protest on Wednesday at the UGC to ask for a rollback of the fee hike and to reject the draft hostel manual. On Tuesday, the protesters received support from students of other universities

as well as JNU alumni. Swaraj India president Yogendra Yadav, tweeted his support for JNU students: "I could study at JNU (1981-83) because my NTS scholarship of ₹250 per month covered all expenses (university fee, hostel fee, mess charges). If the hostel fee was not subsidised, my parents may have found it difficult to afford my

education. Affordable hos-

tels must be part of Right To Education."

AAP MP Sanjay Singh also lent his support: "The unexpected increase in JNU hostel fee is a gross injustice. Mr. Pokhriyal and the JNU V-C must meet the demands of the students and withdraw

the hike." The All India Democratic Students' Organisation protested at Jantar Mantar against the Delhi Police for using water cannons against JNU students during their protest on Monday.

Left condemns police action against students

'Hike will destroy JNU's character'

The Communist Party of India (Marxist) has condemned the use of water cannon by police against JNU students who were protesting against recently announced hike in hostel fee.

Thousands of JNU students had protested against the hike outside the AICTE auditorium on Monday.

"This hike will ensure that JNU will become an elitist university as against its current character that promotes students from diverse backgrounds to afford higher education," the CPI(M) said in a statement here.

"JNU has produced generations of socially conscious citizens and nation builders

viding affordable education, drawing in students from backward regions and marginalised sections. This blossoming of talent at affordable cost is what is being attacked," the Polit Bureau said. The CPI (M) blamed JNU Vice-Chancellor Jagdeesh Kumar for his "obduracy" for this situation.

JNU students are not agitating for the sake of agitation, Communist Party of India (CPI) General Secretary D. Raja said.

"It is a very genuine issue. The way the JNU authorities have dealt with the students is atrocious. They should have first called them for a conversation. JNU is being targeted and attacked by forces known to every one,"

Street vendors demand stay on evictions

Vendors ask for halt on action against them till survey is over; to go on strike today

Representatives of street vendors who faced eviction this year have appealed for a stay on such action until a survey of survey of hawkers is done by the Delhi government, bids for which will open on Wednesday.

On October 31, the Delhi government invited bids for carrying out a demand survey of vendors in the city.

Under the Street Vendors Act, 2014, a photo census of vendors along with GIS mapping and other aspects are to be surveyed before issuing identification cards. In September, the Delhi government had announced that it would be the first State to implement the Act.

Conducting survey

Arbind Singh, coordinator of the National Street Vendors' Association of India (NSVAI), argued that letting private parties conduct the survey could lead to corruption, political manipulation, and the process being stalled.

Mr. Singh said that the survey should be carried out by an independent authority or by the existing 28 Town Vending Committees (TVCs) and vendors' organisations, so that the survey is "authentic and credible".

The TVCs, comprising elected vendors, area representatives, and others, is chaired by the municipal de-

puty commissioner of the respective zone.

Abdul Ajeez, representative of the Jama Masjid Patri Association and a member of the area TVC, complained that vendors in the area had been evicted despite having received a stay from the High Court in 2015.

"This year, without any directions, authorities lifted our goods," claimed Ajeez.

"They say it is the Supreme Court's directions, but no where in that order does it talk about street vendors. What about properties of rich people that are built without authorisation? We are treated as pest because we are easy to deal with. They will not do anything to the rich people," he said.

Mr. Singh further argued that vendors should not be removed till the survey is completed. "Who will you survey if the vendors are removed?" he asked. Adding to the argument, Mr. Ajeez said that the survey was of the people and their biometrics have to be carried out, "not of the land after all".

'We bear the brunt'

Sunil Mishra of the Karol Bagh Raidi Patri Association and a vendor from the area complained that they had been chucked out in the name of pedestrianisation and beautification of the area. "But most of the encroachments in the area were by shopkeepers who extended their stores onto the footpaths, Mr. Mishra said.

We bear the brunt of this. Any direction for removal of encroachments from any court, falls directly upon vendors," he said, adding

that UTTIPEC guidelines for creating alternative "hawkers zone" were not being followed in the area.

Kanchan Devi from Sarojini Market accused the New Delhi Municipal Council of behaving "irresponsibly", arguing that goods seized by authorities were released at high costs and often got lost.

Vendors also alleged that they were being pushed around from one authority to another when they raised their concerns. "When we go to the Chief Minister, we are told to take our concerns to the TVC, but the TVC meetings are not taking place," said a vendors' representa-

tive from Shastri Nagar. Vendors also attacked the Delhi government for not implementing provisions of the Street Vendors Act, 2014. "Only with the elections around the corner, did the government bring in the notification," said Mr. Singh.

They also attacked the BJP, which is in power in all three municipal corporations of Delhi. The deputy commissioners of the civic bodies are chairpersons of the TVCs.

The NVASI has said that vendors would go on an indefinite strike at the Civic Centre on Wednesday. Their demands include a stop to evictions until the survey is completed, restoring of recently evicted vendors and an adherence to the TVCs for vendor-related issues.

Bill for ownership rights to be tabled in upcoming Parliament session

Residents of over 1,700 unauthorised colonies set to benefit

The Centre's plan to grant ownership rights for properties in 1,731 unauthorised colonies of Delhi is moving a step colser to reality with the Union Housing and Urban Affairs Ministry prepared to introduce a Bill to facilitate it in the upcoming Parliament

session, said officials. The Bill would provide for an exemption from a 2011 Supreme Court judgment that held sales on general power of attorney illegal and said immovable property could only be sold or transferred through registered deeds, Housing and Urban Affairs Ministry secretary Durga

Shanker Mishra said. Since these colonies had been developed without government sanction, the residents did not have registered deeds and would require an exemption.

Last transaction

Mr. Mishra said the Bill would also recognise the last transaction alone and not all past transactions for calculating stamp duty.

He added that the Income Tax Department would be also be issuing a notification to give the applicants relief from income tax liability. The Bill, he said, was likely to be introduced in the Parlia-

The 'indefinite strike' by Delhi University students against the proposed construction of a 39-storey building near North campus entered its fourth day on Tuesday.

One student has been sitting on a hunger strike for the past three days.

The proposed construction of a private residential apartment complex has been opposed by multiple university stakeholders, including the administration. The protesters say the building is coming up near women's hostels and will impinge on their privacy.

Protesters demanded that Lieutenant-Governor Anil Baijal put a stay on the construction, and that the land, which they claimed was meant for public purpose, be given to Delhi University. Women happy with free bus rides; fear it will be scrapped

Many apprehensive that govt. will discontinue scheme after the Delhi elections

Two weeks after the Aam Aadmi Party (AAP) government made rides on Delhi **Transport Corporation buses** free for women, most of the beneficiaries The Hindu spoke to said the scheme was extremely useful but would not last long.

The scheme for women came into effect from October 29 when the city was celebrating Bhai Dooj.

The government had said the initiative would ensure women's safety and increase their role in the Capital's economy.

Holding her pink ticket for route number 405, 45-yearold Shammo, a resident of Pul Prahaladpur, said she lost her husband 11 years ago after which she put her two children in an orphanage near Daryaganj. Whenever she would go to work at houses, the children would not go to school and it had become difficult for her to manage funds which led her to make a difficult decision. "Earlier, it cost me around ₹100 to reach Daryagani on buses or the metro. There were times when I would skip coming to meet my children on Sundays worrying about travel expenses. But

Hi-tech features to boost security at new PHQ

Plan to strengthen access control system in the building

SAURABH TRIVEDI NEW DELHI

The Delhi Police is planning hi-tech security measures at its new headquarters on Jai Singh Marg in Lutyens' area. Key features include RFID (radio-frequency identification) tags for staff, visitors and vehicles, intelligent display system and anti-terror bollards.

"We are strengthening access control system in the new building. A committee on security surveyed the building and recommended the security features to be embedded in the system. We have issued a tender and invited bidders to apply for it at the earliest," said a senior police officer.

Enhanced security

As part of the enhanced security measures, RFID tags will be distributed to staff members, visitors and vehicles in order to restrict entry of unauthorised persons and vehicles. Visitors and staff members will not be allowed entry to certain high-security areas in the building. Such areas will be accessed only by authorised personnel. Around 5,000 RFID tags will be ordered for staff and visitors and 2,000 for vehicles.

"We are also installing anti-terror bollards at the main

In the old police headquarters located at ITO, most of the security features were manually operated.

The new police headquarters on Jai Singh Road has been built at a cost of ₹286 crore under public-private partnership. The state-ofthe-art complex is spread over an area of about eight acres and the building has 17 floors. It was inaugurated by Union Home Minister Amit Shah on October 31.

"On whom will [Chief Minister] Arvind Kejriwal shift the blame now? Even he knows that oddeven does not have any impact on pollution levels. The Delhi government is not worried about pollution levels despite the air quality being hazardous," Mr. Goel said.

Air quality likely to be 'severe plus' today

No respite from the extreme air pollution is likely for the next two days, says monitoring agency

STAFF REPORTER

The air quality of Delhi nosedived to 'severe' category on Tuesday and may further deteriorate to 'severe+' on Wednesday.

A respite from the extreme air pollution is not likely for the next two days and a "slight improvement" is expected only by Friday, said government-run monitoring agency System of Air Quality and Weather Forecasting and Research (SAFAR).

'Severe' air quality can

cause respiratory problems in healthy people and has serious health impact on people with lung or heart diseases. People are advised to avoid outdoor physical activities, skip morning walks and close room windows. "Stop any activity if you experience any unusual coughing, chest discomfort, wheezing, breathing difficulty or fatigue and consult a doctor," read an advisory by SAFAR.

The average level of PM2.5 on Tuesday was six times (366.8 ug/m3) the safe limit (60 ug/m3) in Delhi-NCR at 7 p.m., as per the Central Pollution Control Board.

Causes for spike

The contribution of stubble burning in neighbouring States to Delhi's pollution was 25% on Tuesday, up from 18% on Monday. The contribution was as high as 44% earlier this season.

riorated due to low wind speed, cloudy conditions, low mixing height and an increase stubble burning, said authorities.

Mixing height is the height of the atmosphere in which pollutants are spread out. Lesser mixing height leads to higher pollution.

"The sky is likely to be partly cloudy for the next two days under the influence of an approaching western disturbance, but no precipitation is expected," said SA-FAR. Cloudy conditions lead to lesser hours of sunlight, which increases pollution.

"Sunlight heats up the surface and the air near it. Due to this, the air rises, along with water vapour and pollu-

Court acquits man of sexually assaulting son

Minor's mother turned hostile during trial

A Delhi court has acquitted a man of the charge of sexually assaulting his minor son

Additional Sessions Judge A.K. Sarpal acquitted the accused as the complainant, victim's mother, turned hostile in the trial and said she had lodged an FIR against her husband "in anger because he was not living with her".

She alleged that her husband had assaulted his son. In her statement before a Magistrate under Section 164 of Cr.P.C., the complainant reiterated the charges.

Victim had injuries

Though she admitted that the victim had sustained injuries and the doctors who examined him said he was sexually assaulted but she gave a clean chit to her husband saying that she had implicated him in the case as he had abandoned her.

"Admittedly, the complai-

nant is not the eyewitness of the incident and she also stated that she has no suspicion on anyone but due to anger, she made the accused confined in the jail. She also said in the statement given to the Magistrate that she had mentioned the name of the accused due to anger," the Judge said.

"Thus, the complainant has totally exonerated the accused and accepted that whatever she told to anyone about the incident was told at the instance of the police as well as due to her own anger," the judge further said.

Mr. Sarpal said that the complainant had committed perjury by implicating her husband but he let her off saying that the couple is now living together happily.

"However, the complainant is only cautioned to be careful in the future and this time she is spared simply by giving warning. The accused is hereby acquitted of all the charges which are not proved," the judge added.

On Monday, a total of 794 incidents of farm fires were reported from Sangrur, Mansa and Bathinda districts witnessing 178, 162 and 158 cases respectively, an official of the Punjab Remote Sensing Centre said.

TMC MP Mahua Moitra violated model code: BJP

False, misleading complaint, says Trinamool in letter to CEO

The West Bengal unit of the BJP has alleged violation of the model code of conduct by Trinamool Congress MP Mahua Moitra, who, it claimed, was being accompanied by a police officer while campaigning for the Karimpur Assembly bypoll scheduled for November 25.

In a complaint filed on Monday with the office of the Chief Electoral Officer (CEO), West Bengal, it said, "Officerin-charge of Thanapara Police Station, Nadia District, Sumit Kumar Ghosh has been seen regularly going for

door-to-door campaigning with the MP [Mahua Moitra]. This is a blatant violation of the model code of conduct which is in force in the entire district." The party has attached a photograph to sup-

port its charge and demanded action against the officer.

In response, the Trinamool Congress leadership wrote to the State CEO on Tuesday claiming it to be a "false, misleading complaint based on a classic case of fake news, which is a criminal offence under the IT Act". The party claimed that the photo dated back to August 18, 2019, [well before the model code came into effect] and was uploaded on the MP's official Facebook page that day.

Ms Moitra was an MLA

from Karimpur before being elected to the Krishnanagar Lok Sabha seat.

Odisha announces award in name of youth whose organs saved 6 lives

CM allots land, house, ₹5 lakh relief to Suraj Sethi's parents

To encourage organ donation, Odisha Chief Minister Naveen Patnaik has announced that an annual award will be instituted in the name of a youth from Ganjam district whose organs were transplanted in six persons following his death in a road accident.

Mr. Patnaik made the announcement after parents of Suraj Sethi, father Babuli Sethi and mother Gitanjali, met him at the Lok Seva Bhavan here on Monday.

Suraj, a bachelor who was working in Surat, met with an accident on October 29. After struggling for about five to six days in hospital, he was declared brain dead on November 2.

Six organs transplanted

The parents of Suraj were contacted by a Surat-based non-government organisation. They decided to donate their son's organs to save the lives of others. Accordingly, his heart, liver, two kidneys and both eyes were transplanted in six different persons.

While his heart was carried by plane to Fortis Hospital in Mumbai and transplanted into the body of a woman, his kidneys and liv-

er were transplanted into three persons in Ahmedabad, and the two eyes given

to two persons in Surat.

Appreciating the noble act of Suraj's parents, the Chief Minister announced allotment of a homestead land and a house under the Biju Pucca Ghar scheme for them. He also announced an assistance of ₹5 lakh from the Chief Minister's Relief Fund as recognition for their inspiring act.

The award to be instituted by the Odisha government will be given to persons and organisations working for promotion of organ donation in the State.

Sena to work out common minimum programme with Congress, NCP

We had asked for 48 hours, Governor has now given us six months, says Uddhav Thackeray

MUMBAI Shiv Sena chief Uddhav Thackeray on Tuesday clarified that the party will work out a common minimum program with the Congress and NCP. He said he would also study unusual alliances in the country for information. He maintained that Sena's claim to form a government still stays and that it is the BJP that caused their alliance to fall apart.

After Shiv Sena MLAs started celebrations at their Madh island resort on Monday in anticipation of their party forming the government, legislators and karyakartas were in a state of confusion on Tuesday.

Several Shiv Sainiks expressed fears about allying with Congress-NCP, especially after speculations of a CM from the NCP started doing the rounds.

"We are all eagerly awaiting some news from our party. News channels are showing that there might be an NCP CM in the State, there is nothing concrete from Congress either. Our minister in the Union government has already resigned. We are just waiting for some news," said a Sena MLA on condition of anonymity on Tuesday morning.

As news of President's Rule being imposed in the State came in the evening, Mr. Thackeray, along with son Aaditya and other senior Sena leaders, went to the resort for a meeting with party MLAs. Before the meeting, he excused himself "to make two-three calls".

After the meeting, there was speculation of Mr. Thackeray having told legislators that BJP is trying to get in touch with Shiv Sena.

A Shiv Sena MLA on condition of anonymity said, "Uddhavji has told us in the meeting that BJP is also getting back in touch. If they agree to share CM post and equal sharing of power, we might go with them. It now depends on who reaches out to us first. In case both reach out to us, we will go with BIP as that will be our first preference. Uddhavji told us to stay calm and keep patience. He also told us that even in

FIR against makers of national award film

Makers of the Gujarati film Hellaro, which bagged the National Award for Best Feature Film at the 66th National Film Awards, were booked for the alleged use of a "derogatory term" in a dialogue to refer to a Scheduled Caste character, the police said on Tuesday.

Hellaro (The Outburst) was released in theatres on November 8.

"An FIR was registered against the director, producers and dialogue writer of Hellaro over the utterance of word 'Harijan' by one of its characters, considered derogatory by members of Scheduled Caste to which it referred," an official of Kagdapith police station here said.

The FIR was registered on Monday evening after a complaint was filed by Congress corporator Jamnaben Vegda, who claimed she was agitated after hearing the word uttered by one of the characters in the film a few minutes post-interval.

Director Abhishek Shah, and producers Ashish Patel, Aayush Patel, Mit Jani, Pratik Gupta, and dialogue writer Saumya Joshi have been booked under Sections 3 (1) and 5, among others, of the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, the police official said.

Fadnavis ceases to be caretaker CM

With the imposition of President's Rule on Tuesday, Devendra Fadnavis ceases to be caretaker Chief Minister and the de facto administrative control of the government passes into the hands of Chief Secretary Ajoy Mehta. The Governor would soon get an advisor to assist him in day-to-day activities of the government. The advisor could be anybody including a bureaucrat or even a person with political affiliations, officials said.

Senior officials in the state Law and Judiciary department said no major policy decisions could be taken during the time. Provisions for any natural calamity would come from the consolidated funds. If the rule stretches till the Budget is due, the Parliament could pass an appropriation Bill, also known as supply Bill or spending Bill, as the law authorises the expenditure of government funds in the State.

"The Bill brings with it approval of the legislature necessary for the government to spend money. It has happened in the past in Maharashtra and can be done again if necessary," said a senior official.

Sources said the ministers also get 15 days to vacate their official bungalows including the Chief Minister.

Pune court rejects Gautam Navlakha's anticipatory bail plea

Also denies application seeking three-day extension from arrest

A special UAPA court in Pune on Tuesday rejected the anticipatory bail plea of Delhi-based journalist, author and civil rights activist Gautam Navlakha, an accused in the Elgaar Parishad case as well as for alleged links with the outlawed Communist Party of India (Maoist).

It is expected that Mr. Navlakha will be soon taken in custody by the Pune police as the extension of his interim relief period granted by the Supreme Court in October expired on Tuesday.

Additional Sessions Judge S.R. Navandar passed the order on Mr. Navlakha's plea, while also rejecting an application filed by defence counsel Ragini Ahuja seeking a three-day extension of his interim protection to enable him to move the Bombay High Court.

In his order, Judge Navandar observed that it was clear that there is prima facie sufficient material to show that the applicant is not only a member of banned organisation (CPI-Maoist) but an active leader (of the outlawed outfit).

Pune city police authorities, meanwhile, refused to comment on whether the process to take Mr. Navlakha in custody had been set in motion.

"I cannot comment anything on when he [Mr. Navlakha] will be arrested. We will inform in due course of time," said Deputy Commissioner of Police Suhas Bavache.

The Pune police is probing Mr. Navlakha, along with 21 other prominent lawyers, academics, Dalit and human rights activists, in this case in which so far nine persons have been booked under re-

levant provisions of the Unlawful Activities Prevention Act (UAPA) and the Indian Penal Code (IPC).

"Prima facie, it can be noted that organisation of Elgaar Parishad at Pune was a part of a larger conspiracy of the banned organization [CPI (Maoist)] and Bhima Koregaon episode is one of the instance of execution of the said conspiracy. Therefore, the question of jurisdiction either of Pune police or of this Court [as challenged by the defence] cannot be said to have merits, at least at this stage," read Judge Navan-

dar's order. It further noted that the investigating machinery had been making efforts to arrest the applicant for custodial interrogation since August

"However, the applicant was getting protection from higher courts either in the matter of quashing for FIR or in the matter of challenging the legality of his previous arrest," read the judge's order, which observed that as a result, the investigating machinery had not been able to interrogate Mr. Navlakha effectively till this

"From the above facts, what is transpired is that unless the applicant [Mr. Navlakha] is taken in custody and interrogated thoroughly, it is not possible to go to the root of the case and to trace out the different links which have been traced in the letter communication of the members of the banned organization [CPI (Maoist)]," said Judge Navandar in his order.

Earlier, the Bombay High Court had directed Mr. Navlakha to approach the Pune sessions court for anticipato-

The Delhi-based activist had accordingly withdrawn his anticipatory bail plea in the Bombay High Court and filed a plea the next day.

In September this year, the Bombay High Court had refused to quash the Pune police's case against Mr. Navlakha. The case was registered under Sections of the Unlawful Activities (Prevention) Act (UAPA) and various sections of the IPC, which included charging the activist with sedition.

However, the high court had extended his interim relief from arrest by three weeks, allowing him to appeal in the Supreme Court.

On October 4, the apex court had extended him protection from arrest till October 15. This was extended by a further four weeks and is due to expire today.

Last week, the Pune court had heard the arguments of both the prosecution and the defence on Mr. Navlakha's plea.

Pneumonia, diarrhoea still a big threat


Progress short on ensuring children have access to prevention and treatment services, finds global study

The 10th pneumonia and diarrhoea progress report card has found that health systems are falling short of ensuring the world's most vulnerable children access to prevention and treatment services in the 23 countries that together account for 75% of global pneumonia and diarrhoea deaths in children under five.

India, which is home to a large population of underfive children, accounts for a major portion of these deaths, notes the report.

"Rollout of rotavirus vaccines, beginning in 2016, and the pneumococcal conjugate vaccine, beginning in 2017, helped India's scores improve. India's exclusive breastfeeding rate, at 55%, is among the highest of the 23 countries. However, the proportion of children receiving important treatments, as

and support countries in developing smart, sustainable strategies that close gaps and accelerate progress. Globally, pneumonia and diarrhoea led to nearly one of every four deaths in children under five years of age in 2017.

Released ahead of World Pneumonia Day, on November 12, the 2019 Pneumonia and Diarrhoea Progress Report Card, by the International Vaccine Access Center (IVAC) at the Johns Hopkins Bloomberg School of Public Health, describes progress in fighting pneumonia and diarrhoea in countries with the highest absolute number of deaths, and for the first time in countries with the highest rates of deaths from these illnesses.

Chhattisgarh moots law to protect journalists

A committee headed by former Supreme Court judge Aftab Alam has sought public comments on a draft Bill to safeguard mediapersons in Chhattisgarh from harassment, intimidation and violence.

"Justice Alam will visit Raipur, Ambikapur and Bastar from November 16 to 18 to take suggestions from lojournalists, media groups and the general public," Ruchir Garg, a member of the committee and the Chief Minister's media adviser, told The Hindu. Minister Bhupesh

Baghel was committed to introducing a pro-journalist law, Mr. Garg added.

The committee was set up in March to draft a law to foster an atmosphere wherein journalists could perform their work fearlessly, the State government said in a statement. The draft Chhattisgarh Protection of Mediapersons Act proposes that within 30 days of enactment of the law "the government shall constitute a Committee for the Protection of Mediapersons to deal with complaints of harassment, intimidation or violence, or unfair prosecution and arrests of media persons".

Centre likely to release data on drinking water, sanitation soon

KOLKATA By the end of November, the Centre is expected to release the data on drinking water, sanitation, hygiene and housing conditions, which will provide a comprehensive idea about the on ground success or failure of the Swachh Bharat campaign, Pravin Srivastava, Chief Statistician of India, Ministry of Statistics and Programme Implementation (MoSPI), said on Tuesday at the sidelines of a two-day

conference of Central and State statistical organisations here.

The 76th round of the countrywide survey of the National Sample Survey Office (NSSO) under the MoSPI was conducted between July 2018 and December 2018. "We are looking at the results and hopefully, I think, within this month it should get out," Mr. Srivastava said.

The survey will formally indicate how the Swachh Bharat campaign performed over the last half a decade.

So far, private agencies have done such surveys and acknowledged the achievements of the campaign.

"Achievements of the campaign are not only in completion of toilet construction. The campaign will be considered successful when it would be able to influence other indicators like outbreak of disease or access to clean water. This round of survey is important as it would provide information on those indicators," said a public health expert.

C-295 transport plane clears cost negotiations

YMCA in T.N. barred from receiving foreign funds

FCRA registration of over 1,800 NGOs, educational institutes has been cancelled

More than 1,800 NGOs and academic institutes found to be violating laws pertaining to foreign funding have been banned by the government from receiving overseas funds this year, officials said on Tuesday.

Among those whose registration under the Foreign Contribution (Regulation) Act has been banned include the University of Rajasthan,

Allahabad Agricultural Institute, Young Men's Christian Association, Tamil Nadu, and Swami Vivekananda Educational Society, Karna-

"With the cancellation of the FCRA registration, all NGOs and academic institutions were prohibited from accepting foreign contribution," a Home Ministry official said. The FCRA registration of these organisations was cancelled mostly due to their failure to submit annual income and expenditure statement on foreign funding for up to six years despite repeated reminders.

As per FCRA guidelines, registered associations are required to submit electronically an annual report with scanned copies of income and expenditure statement, receipts and payment account, and balance sheet within nine months of the closure of the financial year.

Associations which do not receive foreign contribution during a particular year are also required to furnish a 'NIL' return.

Other associations whose FCRA registration has been cancelled include Institute of Pulmocare and Research. West Bengal, National Geophysical Research Institute, Telangana, National Institute of Virology, Maharashtra, and Baptist Christian Association, Maharashtra.

Proposed relocation of 'killer' jumbo leads to protest in Assam

Shutdowns and protests are dime a dozen in Assam. The latest is over the reported relocation of a "killer" elephant from a jungle in western Assam to another in the central part of the State, 300 km away.

A large number of people in central Assam's Lumding took to the streets on Tuesday to protest against the State Forest Department's alleged move to relocate the elephant that was captured on Monday.

Padma Hazarika, a BJP legislator, whose family has a history of taming wild elephants and keeping them as

pets, had helped a team tranquillise the rogue from the Rangjuli area of western Assam's Goalpara district.

"What does the govern-

ment want by sending a killer elephant to our part of the State? Are we expendable?" asked P. Dutta, a Lumding resident among protestors. Wildlife officials said no

decision had been taken to send the elephant to the Lumding Reserve Forest, as rumoured.

"The elephant bears injurv marks and needs treatment. We are not thinking of relocating it now, as the priority is on providing treatment," Chief Conservator of Forest Akashdeep Baruah, who headed the committee to catch the elephant said to have killed five people, told The Hindu.

Betrayal of the mandate

The Sena overplayed its hand in Maharashtra,

and a fresh poll seems the best course now The political drama in Maharashtra that continued unabated since the Assembly election results on October 24 has been brought to an end, albeit temporarily, by the imposition of President's rule. The Maharashtra verdict was unambiguous and in favour of the BJP-Shiv Sena pre-poll alliance, but the partners could not agree on the terms of power sharing, leading to prolonged haggling between them. The Sena's claim for the Chief Minister's post initially appeared to be brinkmanship to extract a hard bargain with the BJP but it tripped over its greed and intrigues. The Sena is the BJP's oldest ally and both are bound by a competitive adherence to Hindutva. The Sena's claim was also not justified by the verdict – it got 56 seats of the 288, while the BJP won nearly double that figure. The BJP, ensconced at the Centre and ever willing to use power to constrain its adversaries, did not relent. The Sena overplayed its hand by parting with the BJP and quitting the Union government. It miscalculated the alternative scenario of leading a State government with the support of the Congress and the Nationalist Congress Party (NCP).

The idea of a Congress-NCP-Sena coalition government is toxic. The NCP and Congress fought in alliance, and as Sharad Pawar said, got a mandate to sit in the Opposition. Post-poll coalitions are a legitimate route to government formation when the legislature is hung but the situation in Maharashtra is far from it. There were two pre-poll alliances, one got a clear majority and the other clearly lost. If the Congress and NCP want to keep the BJP out of power for ideological reasons, handing over power to a more virulent strain of Hindutva would be disingenuous. The formation of an NCP-Congress-Sena government, whatever may be its facade, will not only be a betrayal of the mandate but also be indefensible in ideological terms besides being suicidal tactically. Such an alliance, if at all formed, would not be stable or sustainable. All these parties will be rightly blamed for being opportunistic and devoid of political convictions. The BJP will be the sole beneficiary of such a thorough delegitimisation of the entire Opposition spectrum in Maharashtra. In the inevitable mid-term election that will happen sooner rather than later, opportunists will pay a price. The Congress and the NCP would be better off losing this opportunity and leave the birds of the same feather to potentially flock together again. That said, it was inexcusable of the Governor to not give the Sena or the NCP adequate time to explore the possibility of an alternative government. While a government without the BJP might lack moral or political legitimacy, the Governor should have exhausted all avenues before recommending President's rule. The BJP must be hoping to pressure the Sena back into the alliance, but the best course now seems a fresh election.

Anarchy in Bolivia

Both Morales and his opponents failed to ensure a peaceful, orderly transition

The forced resignation of Bolivian President Evo Morales has thrown the poorest country in South America into its biggest political crisis in 13 years. As Bolivia's first indigenous President, who rose to the top office through left-wing unionism, he presided over one of the most stable governments. But cracks began to appear in his Movement for Socialism party when he sought a fourth consecutive term earlier this year. He was declared winner of the October 20 election. But the Opposition contested the results and launched widespread protests, demanding a fresh election. After the Organization of American States alleged widespread poll fraud in an audit report, the military forced Mr. Morales and his allies to resign. In asylum in Mexico, he has vowed to fight the "coup". According to the Bolivian Constitution, if the President steps down, the Vice-President should take over. The heads of the Senate and chamber of deputies are the other leaders in the hierarchy who could assume acting presidency. But in this case, all four officials, all Socialists, have resigned. And it has left a vacuum, which the military could exploit.

Mr. Morales came to power, in 2006, riding South America's so-called "pink tide", and promising economic development and equitable wealth distribution. Under his fairly good track record, Bolivia has seen a drop in extreme poverty, from 33% of the population in 2006 to 15% last year. His government also stepped up public investments, opened more schools and health clinics. The economy has also seen a steady growth rate. Mr. Morales made some major political mistakes as well. Primarily, he failed to bring up a second-rung leadership in the Movement for Socialism to whom he could pass the baton of his "21st century socialist revolution". In 2016, his push to end presidential term limits through a referendum failed. He then said he accepted the verdict. But later, a constitutional court lifted the term limits, allowing the President to seek re-election. This had galvanised the Opposition, which claimed that the President's electoral participation itself was unconstitutional. This was followed by allegations of electoral fraud, which further weakened him. Facing protests, Mr. Morales had offered another election. That should have been the way forward. A free and fair election being held under the supervision of international electoral monitors would have allowed the Bolivians to choose their legitimate leader. But the violent protesters who insisted on Mr. Morales's resignation, the police forces who rebelled against the government, and finally the generals who forced the President to go all destroyed the possibility of a peaceful transition. They threw Bolivia into anarchy and chaos. And more violence could be awaiting the country.

The problem with re-basing GDP estimates

Introducing a new series without any changes will only entrench methodological problems and affect data credibility

n the next few months, the Central Statistics Office (CSO) pro-**■** poses to replace the gross domestic product (GDP) series of 2011-12 base year with a new set of National Accounts using 2017-18 as the base-year. According to the chief statistician, this will be done as soon as the new consumer expenditure survey and the Annual Survey of Industries (ASI) results become available. Normally, rebasing is a routine administrative decision of any national statistics

Background to the dispute

But these are not normal times in India for users and producers of the national accounts. For the past four years there has been a raging controversy over the current GDP figures on account of questionable methodologies and databases used. According to official data, the annual economic growth rate has sharply decelerated to about 5% in the latest quarter, from over 8% a few years ago. The reality may, however, be far worse. Independent studies using multiple statistical methods to validate the official GDP estimates by the former Chief Economic Adviser, Arvind Subramanian, and Sebastian Morris of the Indian Institute of Management, Ahmedabad, have suggested that the annual GDP growth rates during the last few years may have been overestimated by 0.36 to 2.5 percentage points.

Why is there such distrust in the official GDP figures? To understand the origins of the dispute, one has to go back to early 2015 when the CSO released a new se-

ries of GDP with 2011-12 as baseyear, replacing the earlier series with the base-year 2004-05. Periodic rebasing of GDP series every seven to 10 years is carried out to account for the changing economic structure and relative prices. Such re-basing usually led to a marginal rise in the absolute GDP size on account of better capturing of domestic production using improved methods and new databases. However, the underlying growth rates seldom change, meaning that the rebasing does not alter the underlying pace of economic expansion.

The 2011-12 base year revision was different, however. The absolute GDP size in the new base year 2011-12 contracted by 2.3% (compared to the old series), and the annual GDP growth rate went up sharply from 4.8% in the old series to 6.2% in 2013-14. Similarly, the manufacturing sector growth rate for 2013-14, swung from (-) 0.7% in the old series to (+) 5.3% in the 2011-12 series. Such large variations in growth rates for the same year may be justified if the material conditions of production warranted. But the higher growth estimates recorded by the new series did not square with related economic indicators such as bank credit growth, industrial capacity utilisation or fixed investment growth. Thus began the questioning of the new GDP series.

Demonetisation as shock

The suspicion of official output estimates became particularly intense after the demonetisation of high valued currency notes in November 2016. By most analyses, the economic shock severely hurt output and employment. For example, the Ministry of Finance's Report on Income Tax Reforms for Building New India (September 2018; convenor: Arbind Modi), provided data on fixed investment in the private corporate sector

based on actual corporate tax returns. It shows that the fixed investment to GDP ratio in the private corporate sector fell sharply from 7.5% in 2015-16 to 2.8% in 2016-17 (suspected to be on account of demonetisation). However, surprisingly, the ratio in the national accounts went up from 11.7% in 2015-16 to 12% in 2016-17.

Similarly, chief economist of the International Monetary Fund, Gita Gopinath's academic research paper (co-authored) published by the highly regarded National Bureau of Economic Research in the U.S. in May 2019 showed an adverse effect of demonetisation on growth rate. Yet, the official GDP for the year 2016-17 grew at 8.2%, the highest in a decade.

The root of the problem

The source of the problem, according to many economists, is the underlying methodologies for calculating GDP (in the 2011-12 series) which they claim are deeply flawed, as well as the new dataset used in estimating the private corporate sector's contribution. Some of the recent, prominent criticisms are as follows.

In a first, the CSO estimated value addition in the private corporate sector using the statutory filing of financial results with the Ministry of Corporate Affairs. The private corporate sector accounts for about a third of GDP, and spans all production sectors, and roughly about half of the private corpomanufacturing. The database of the Ministry of Corporate Affairs has been criticised by many as unreliable; hence it is possible that the private corporate sector output has been overestimated. For example, the Ministry's database on "active" companies – that is companies claiming to have submitted audited financial results regularly for three years – seems to contain many companies that are actually inactive (not producing output on a regular basis). Last year when the National Sample Survey Office (the government's premier, independent, data-gathering agency), used the Ministry of Corporate Affairs list of active companies to canvass a sample of companies in the services sector, it found that up to 42% of the sample companies were not traceable, had failed to provide the information for the survey, or had failed to provide audited accounts.

For estimating GDP of the private corporate sector, questionable methods are also used for blowingup unverified "sample" estimates for the unknown and varying universe of "working" or active companies.

State domestic product (SDP) estimation uses many of the same databases and methodologies used in all-India GDP estimation. The methodological changes made in the 2011-12 base-year revision have adversely impacted the quality of SDP estimates on two counts. First, the Ministry of Corporate Affairs data does not have factory identifiers (that is, location of production units, but only has the location of the company head office); it has distorted distribution of the SDP estimates across States. Second, for estimating value-added in the informal or unorganised sector, State-specific labour productivity estimates are unavailable in the 2011-12 series. Hence the method used distorts output

The CSO has denied the claim that the underlying methodology is flawed and that there are serious problems with the new database being used. The official response throughout the debate has been that the 2011-12 GDP series follows global best practices (meaning, following the latest United Nations System of National Accounts guidelines) and applies better methods using much larger datasets; hence the official estimates are blemish-less. This ignores the fact that India has always followed UN guidelines, and that larger data sets are not necessarily better.

Need for a review

The proposed change over to a new base-year of 2017-18, is, in principle, a welcome decision. Hovever, considering the methodological disputes and data related questions relating to the current national accounts series, as illustrated above, what would the rebasing potentially accomplish? Doubts will persist so long as the underlying methodological apparatus remains the same; feeding it with up-to-date data is unlikely to improve its quality.

In view of the problems with the current series, a chorus of academic and public voices has proposed setting up an independent commission of national and international experts to review the GDP methodology. The ideal time to do this would be now so that solutions could be found and incorporated into the new GDP series. Conversely, if a new rebased series is introduced without any changes it will only entrench the existing methodological problems, and ensuring that the debate will continue for the next half decade. And as the debate continues, so will the loss of credibility.

We welcome the statement made by Brazilian President Jair Bolsonaro in Osaka about the importance of strengthening the dialogue within BRICS, which will enable the BRICS countries to make the best use of ongoing global changes.

Today, alignment of efforts of our countries is particularly important. Global politics continues to reel. Various regions of the planet still retain significant conflict potential. The arms control architecture is deliberately undermined – the U.S.'s unilateral withfrom the Intermediate-Range Nuclear Forces Treaty was a rather dangerous

step. Structural imbalances in the world economy are yet to be overcome. A serious threat to global economic growth is posed by such unfair competition practices as unilateral economic sanctions, trade wars and flagrant abuse of the U.S. dollar status as the world $\frac{\circ}{6}$ reserve currency. The international community is yet to find effective responses to a whole number of critical challenges of our time – from terrorism to climate change.

It got to the situation when there are attempts to replace the international legal system, established after the Second World War with the UN Charter remaining as its main source, with the socalled "rules-based order", where "rules" were being invented in secret, in "small groups", and then, depending upon a political situation, imposed on the whole world.

Multipolarity is not a recipe for competition and chaos in international relations, as some of our critics say. On the contrary, this is the only order attuned to presentday realities, which should promote the comprehensive development of all states - both big and small - and enhanced mutually beneficial cooperation among us on the basis of shared interests.

Common goals Russia, as other BRICS countries, rejects diktat and pressure, blackmail and threats, let alone the use of force without the UNSC's decision. In contrast, it proposes to follow the path of a mutually respectful dialogue aimed to reach the consensus that takes into account the interests of all actors in interstate relations. We are convinced

that any agreements on most im-

da should be reached with the widest and equal participation of all stakeholders and be based on universally recognised legal norms. The BRICS countries are firmly committed to democratisation of international life and its development under the principles enshrined in the UN Charter, the principles of respect for cultural and civilisational diversity of the world, and the right of peoples to forge their destiny themselves. It is of fundamental importance

that our approaches to key global and regional issues are the same or rather similar. We have consistently called for a peaceful and politico-diplomatic settlement of crises and conflicts in various regions of the world. We continue to be engaged in a comprehensive dialogue in such fields as counterterrorism, international information security and the fight against organised crime and corruption.

We can state with confidence that having entered the second decade of its activity, BRICS, being one of the pillars of the emerging fairer polycentric world order, plays an important stabilising role in global affairs, for which it has all the necessary capacity. The group

accounts for almost a third of global GDP at purchasing power parity. Last year, BRICS even outperformed the G7 on this indicator.

BRICS is becoming a magnet for many emerging economies. They are looking at us because the group protects values of multilateralism, supports transparent, non-discriminatory, open, free and rejects unilateral economic restrictions and protectionist measures in developing international economic ties. In their statement following the meeting on the margins of the G20 Summit in Osaka last June, the BRICS leaders explicitly indicated their willingness to protect the pillars of the equitable multilateral trading system and the role of the World Trade Organization as its centre, and to advocate International Monetary Fund

The New Development Bank (NDB) created by the BRICS countries - one of the promising multilateral development institutions – works successfully. Only this year, the NDB Board of Directors has approved 12 new investment projects in the BRICS countries. And since the start of its operation in 2015, 42 investment projects worth over \$11 billion have been approved.

The work to strengthen the **BRICS Contingent Reserve Arran**gement (CRA) is ongoing. Its total capital of \$100 billion is to be a guarantor of the BRICS financial stability in case of crisis.

We appreciate the efforts of the Brazilian chairmanship to implement five-party initiatives in economy, science, innovations and health. We take a positive note of the systematically increased density of humanitarian exchanges cooperation in the areas of culture, education, sport and youth policy is gaining momentum and people-to-people contacts are developing.

Russia's turn next

In 2020, Russia will take the helm and inclusive international trade, of BRICS. We intend to ensure continuity and harmonious transition from the Brazil chairmanship to the Russian one. We will continue the policy of progressive and comprehensive enhancement of the strategic partnership of the BRICS countries. Certainly, we are interested in increasing financial and economic cooperation among the participating countries, effective industrial interaction and practical cooperation in developing and implementing new joint energy, telecommunications and hightech projects. Our priorities include enhanced foreign policy coordination within leading multilateral fora, primarily in the UN, which will turn 75 next year.

> I am confident that in the storming ocean of world politics, the BRICS 'ship' will steer a steady course and further contribute significantly to maintaining international stability and ensuring global economic growth. The Brasilia Summit is aimed to be another important milestone in pentalateral cooperation and on its way to new
