

SC has doubts over Aadhaar as money Bill, turns to big Bench

Says 2018 ruling did not discuss effect of 'only' in Art 110(1) on money Bill

EXPRESSING DOUBTS over the correctness of a five-judge Constitution Bench's 2018 verdict upholding the Aadhaar Act which had been passed as a money Bill, a five-judge Constitution Bench, hearing a challenge to certain provisions of the amended Finance Act, 2017, Wednesday decided to refer the question to a seven-judge Bench.

Like the Aadhaar Act, the amended Finance Act, 2017 too had been passed as a money Bill.

The Bench said "the analysis in K S Puttaswamy (Aadhaar-5) makes its application difficult to the present case and raises a potential conflict between the judgements of coordinate Benches". Incidentally, petitions seeking review of the Aadhaar Act ruling are still pending in the Supreme Court.

Finance Act: Tribunal rules struck down, Govt told to draw fresh norms

IN A setback to the government, a five-judge Constitution Bench, headed by Chief Justice of India Ranjan Gogoi, Wednesday struck down provisions of the amended 2017 Finance Act, passed as a money Bill which altered the structure and functioning of various tribunals. It directed the government to formulate fresh

norms on the appointment of tribunal members.

The Bench, also comprising Justices N V Ramana, D Y Chandrachud, Deepak Gupta and Sanjiv Khanna, said the amendments are struck down in entirety as these are "contrary to the principles envisaged in the Constitution as interpreted by this Court".

Financial deals with Ranbaxy brothers, admits Beas sect head

THE HEAD of Radha Soami Satsang Beas, Gurinder Singh Dhillon, has, for the first time, admitted to financial transactions between himself and ex-Religare Enterprises (REL) promoters Malvinder and Shivinder Singh.

In an affidavit filed with the Delhi High Court dated November 12 and reviewed by The Indian Express, Dhillon admitted that the Singh brothers had in 2010, through RHC Holding (a company controlled by the brothers), approached him and his family to subscribe to a rights issue of REL that was not fully subscribed "at that moment". A part of the rights issue was funded by RHC and the Singh brothers, who CONTINUED ON PAGE 2



SC: 17 Karnataka MLAs remain disqualified, but can contest Dec 5 bypolls

THE SUPREME Court Wednesday upheld the disqualification of 17 Congress-JD(S) MLAs in Karnataka but allowed them to contest the December 5 Assembly bypolls to 15 seats, setting aside the Speaker's July order which disqualified them till the end of the term of the Assembly in 2023. The rebellion of the MLAs — 14 from Congress and 3 from JD(S) — led to the fall of the H D Kumaraswamy government and the return of the BJP.

Stating that "the satisfaction PAGE 8

of the Speaker is subject to judicial review", the bench of Justices NV Ramana, Sanjiv Khanna and Krishna Murari said "it is clear that the Speaker, in exercise of his powers under the Tenth Schedule, does not have the power to either indicate the period for which a person is disqualified, nor to bar someone from contesting elections".



be achieved only by denial of access to information." He added that the "independence in a given case may well demand openness and transparency by furnishing the information."

"Reference to the principle of judicial independence is not to undermine and avoid accountability which is an aspect we perceive and believe has to be taken into account while examining the public interest in favour of disclosure of information. Judicial independence and accountability go hand in hand as accountability ensures, and is a facet of judicial independence", the order said.

The bench said that the type and nature of the information is also a relevant factor to be consid-

"Distinction must be drawn between the final opinion or resolutions passed by the collegium with regard to appointment/ele-

vation and transfer of judges with observations and indicative reasons and the inputs/data or details which the collegium had examined. The rigour of public interest in divulging the input details, data and particulars of the candidate would be different from that of divulging and furnishing details of the output, that is the decision...Transparency and openness in judicial appointments juxtaposed with confidentiality of deliberations remain one of the most delicate and complex areas. Clearly, the position is progressive as well as evolving as steps have been taken to make the selection and appointment

Justice Ramana cautioned on the need to balance between the right to information and right to privacy. Instead of treating them as conflicting, a balancing formula can be worked out depending on case to case, he said

Referring to Section 8(1)(j) of the Act, Justice Ramana wrote that its "purport ... is to balance privacy with public interest". He prescribed a two-step test - first, "whether there is a reasonable expectation of privacy" and second, "whether on an ultimate balancing analysis, does privacy give way to freedom of expression". He added that "we should acknowledge that these two tests are very difficult to be kept separate analytically".

He added that that "there are certain information which are inherently private and are presumptively protected under the privacy rights. These informationinclude age, gender, sex, sexual preferences etc" and that they should be kept in mind while evaluating whether there is a reasonable expectation of privacy.

"It must be kept in the mind", he added "that the transparency cannot be allowed to run to its absolute, considering the fact that efficiency is equally important principle to be taken into fold", Justice Ramana said and added that RTI "should not be allowed to be used as a tool of surveillance".

Justice Chandrachud wrote that "candour and frankness cannot be the reason to preclude disclosures of correspondence beconstitutional

functionaries which concern the appointment process of judges" and that "it cannot be countenanced that public gaze or subsequent disclosure will detract an individual from discharging their duty in an effective manner true to the dignity and ethic associated with their office".

He added that "judicial independence does not mean insulation of judges from the rule of law. Transparency and the right to information are crucially linked to the rule of law itself. Judicial independence is not a carte blanche to arbitrary behaviour. Where the provisions of the Constitution secure a standard of judicial independence for free and impartial adjudication, the independence guaranteed by the Constitution must be employed in a manner that furthers the objective for which it was secured. The independence of the judiciary was not envisaged to mean its insulation from checks and balances that are inherent in the exercise of constitution power."

"The contention that merely because a judge cannot be elected out of office, the conduct of judges and their general administration is not a matter of great public interest cannot be countenanced. The disclosure of information about the conduct of judges and their administration is necessary to ensure that the broader societal goals in the administration of justice are achieved," he added.

is deemed to be a money Bill if it deals only with matters specified in Article 110(1)(a) to (g) taxation, borrowing by the

government and appropriation of money from the Consolidated Fund of India among others. A money Bill can only be introduced in Lok Sabha and does not need the consent of Rajya Sabha.

Sikri, A M Khanwilkar, D Y Chandrachud and Ashok Bhushan, the Bench said: "Its interpretation of the provisions of the Aadhaar Act was arguably liberal and the Court's satisfaction of the said provisions being incidental to Article 110(1)(a) to (f), it has been argued is not convincingly reasoned, as might not be in accord with the bicameral Parliamentary system envisaged under our constitutional scheme. Without expressing a firm and final opinion, it has to be observed that the analysis in K S Puttaswamy (Aadhaar-5) makes its application difficult to the present case and raises a potential conflict between the judgements of coordinate Benches.'

"Given the various challenges made to the scope of juAadhaar Act, 2016, it becomes essential to determine its correctness. Being a Bench of equal strength as that in KS Puttaswamy (Aadhaar-5), we accordingly direct that this batch of matters be placed before Hon'ble the Chief Justice of India, on the administrative side, for consideration by a larger Bench." The order noted the

Attorney General's submission that "constitutionality of the Finance Act, 2017 would be safe if its dominant provisions, which form the core of the enactment, fall within the ambit of Article 110(1)(a) to (f). Other minor provisions, even if not strictly incidental, could take the dominant colour and could be passed along with it as a Money Bill. As per such interpretation, provisions ought not to be read in a piece-meal manner, and judicial review

ought to be applied deferen-

While the observations and reference to a larger bench do not have any immediate ramifications on the Aadhaar law, its validity will be subject to a fresh review by a larger bench.

Incidentally, Justice Chandrachud had been the lone dissenter in the Aadhaar ruling of 2018, criticising the government for passing the Aadhaar Act as a money Bill.

In 2016, the Congress had challenged the passage of the Aadhaar legislation as a money Bill at a time when the BIP-led NDA was well short of a majority in Rajya Sabha. Congress leader Jairam Ramesh, who had moved five amendments in Rajya Sabha, had filed the writ petition, accusing the government of bypassing the Upper House by bringing the Aadhaar law as a money Bill. Congress leader and senior advocate P Chidambaram had argued the case.



The former MLAs had challenged the Constitutional validity of then Speaker K R Ramesh Kumar's orders of July 25 and 28 which rejected their resignations saying these were not voluntary or genuine, and disqualified them till the end of the term of the 15th Legislative Assembly in 2023.

The bench concluded that their act of defection, which constituted the basis for their disqualification, happened prior to their resignations and, therefore, would not become infructuous by submitting the resignation letters.

"Disqualification relates back to the date when the act of defection takes place. Factum and taint of disqualification does not vaporise by tendering a resignation letter to the Speaker. A pending or impending disqualification action does not become infructuous by submission of the resignation letter, when act(s) of disqualification have arisen prior to the member's resignation letter," said Justice Ramana, writing for the bench.

The bench ruled that "in the light of the existing Constitutional mandate, the Speaker is not empowered to disqualify any member till the end of the term".

"However, a member disqualified under the Tenth Schedule shall be subjected to sanctions provided under Articles 75(1B), 164(1B) and 361B of Constitution, which provides for a bar from being appointed as a Minister or from holding any remunerative political post from the date of disqualification till the date on which the term of his office would expire or if he is re--elected to the legislature, whichever is earlier," it said.

The bench also dwelt on the powers of the Speaker while dealing with resignations and said the Speaker can reject a resignation only if an inquiry demonstrates that it is not "voluntary" or "genuine".

"...although the word 'genuine' has not been defined, in this context, it would simply mean that a writing by which a member chooses to resign is by the member himself and is not forged by any third party. The word 'genuine' only relates to the authenticity of the letter of resignation. Similarly, the word 'voluntary' has not been defined. In this context, it would mean the resignation should not be based on threat, force or coercion."

The bench said "the inquiry" by the Speaker when a resignation is received "should be limited to ascertaining if the member intends to relinquish his membership out of his free will. Once it is demonstrated that a member is willing to resign out of his free will, the Speaker has no option but to accept the resignation. It is Constitutionally impermissible for the Speaker to take into account any other extraneous factors while considering the resig-

It voiced its concern on the "growing trend of the Speaker acting against the Constitutional duty of being neutral".





Get back to work or face contempt: Bar to lawyers

IN A strongly worded statement, the Bar Council of India (BCI) Wednesday asked all lawyers on strike since the Tis Hazari clash to resume court work from Thursday — or face contempt proceedings.

Stating that even the Supreme Court had expressed anguish and serious concern over lawyers abstaining from work, the statement said: "We would like to inform that prolonged absence of lawyers from courts in Delhi may be taken very seriously by the Supreme Court of India. Leaders of the BCI; Bar Council of Delhi: Co-ordination Committee; and all Bar Associations of Delhi may have to face contempt proceedings as per the SC's judgment."

Lawyers have been on strike since the November 2 clash with police at Tis Hazari district court, over a parking issue which snowballed into violence. Over lawyers were injured.

The BCI said action would include removal from respective office of Bar Council or Bar Association, and disqualification from contesting future elections.

Urging lawyers to resume work. BCI chairman Manan Kumar Mishra said: "If any demonstration is to be held... it (is to) remain calm and peaceful."

The Council also said it was "shocked to know through newspaper reports that an application was moved by the District Bar Association, Tis Hazari, in the court of the Chief Metropolitan Magistrate... seeking an order to arrest the guilty police officers".

Lawyers, along with bar association members, have

planned a march to Parliament on November 20.

Meanwhile, the plea by two ASIs, who were suspended in connection with the incident following the Delhi High Court's order, was not listed. The policemen sought protection from coercive action against them, with respect to the FIRs filed in the wake of the clash.

A bench headed by Chief Justice D N Patel, while leaving the courtroom, expressed its inability to hear any kind of "Tis Hazari matter" today.

"No urgency. No Tis Hazari 21 police personnel and eight matter," said the Chief Justice, on being requested by a counsel that his 65-year-old client has been arrested and the case could not be heard at Tis Hazari due to the strike.

> Over 10 police personnel, including senior officials and advocates, waiting in the Chief Justice's courtroom post lunch, could not mention the matter related to the ASIs for urgent listing. As per a source, police, in their application, sought that the ASIs be protected till pendency of the judicial inquiry.

It is learnt that the ASIs highlighted protection given to the lawyers — the High Court had directed that no coercive action be taken against the advocates "in pursuance of FIRs (lodged) with regard to the incident".

Heard lawyers might free clients from cell: ASI who fired 2 rounds

NEW DELHI, NOVEMBER 13 IN HIS statement to police, an

assistant sub-inspector (ASI) who fired two rounds during the Tis Hazari clash has claimed he did so on hearing that some lawyers were planning to break into the court lock-up and help some inmates escape.

The ASI is one of 21 personnel who were injured and have recorded their statements with a Crime Branch special investigation team (SIT), headed by Delhi Police Commissioner Amulya Patnaik.

Sources said the SIT is corroborating the claims made by the personnel with CCTV footage from the court complex. "In his statement, the ASI, posted with the 3rd Battalion, said he was incharge of the police lock-up and he tried to stop lawyers as per standard operating procedure. He highlighted the rules before the SIT, issued by the Delhi Police, which mention that the

lock-up in-charge can use excessive force to disperse a crowd if it is breaking the lock-up. He claimed several lawyers had barged into the lock-up and attacked policemen there," a police source said.

"He further claimed police first used pepper spray, but advocates didn't stop and tried to break the lock-up. He said he came to know that some advocates were allegedly planning to break in and free some clients lodged inside. He trained his revolver on the gate from a height with an intention to disperse the crowd, but one of the two bullets hit a lawyer," the source said.

The team comprises three inspectors from different units of the Crime Branch, including ACP Arvind Yadav.

"With help of CCTV footage and video recorded by the policemen, the SIT has so far identified eight advocates who allegedly created a ruckus and vandalised court property. At 3.32 pm, they also damaged a camera installed outside the entrance gate," the source said.



WiFi project to take

HOTSPOTS UNDER the Delhi government's WiFi project will gradually be activated from the first week of December, with a city-based company bagging the tender for the project which will cost the state around Rs 100 crore per year.

A senior official privy to the development said the PWD's work advisory board is likely to accord its approval, which is required before commencement of work, within a week.

The cabinet had cleared the project in August.

The WiFi project was one of AAP's key poll promises. Under the approved project, 11,000 hotspots are supposed to be put up across public places in Delhi,

including at 4,000 bus shelters.

Each hotspot will cover a radius of 50 metres, and up to 200 people will be able to simultaneously access the internet at such points.

"Installation of hotspots will begin by November-end or the first week of December. They will gradually be activated, instead of waiting for the completion of the entire installation

work," the official said. Every unique user will be able to consume up to 15 GB data per month. However, the actual number of hotspots might be lesser as the tender document had said the numbers may vary "30 per cent on plus or minus

The Delhi government will make payments to the firm executing the project following a 'per hotspot per month' model.

EPCA WRITES TO DELHI, NEIGHBOURING STATES OVER AIR EMERGENCY

Choking hazard: Schools forced to shut yet again

SCHOOLS IN Delhi and adjacent National Capital Region towns have been directed to remain closed Thursday and Friday in view of the "air emergency situation", which is not expected to improve before November 15.

Chairman the Environment Pollution (Prevention and Control) Authority (EPCA), Dr Bhure Lal, Wednesday wrote to chief secretaries of four NCR states after receiving recommendations from a task force led by the Central Pollution Control Board

The task force meeting was held Wednesday as air quality in Delhi-NCR crossed emergency levels, with Delhi's 24hour average air quality index recorded at 456, Ghaziabad's at 467, Gurgaon's at 447 and Noida's at 470.

Dr Lal said in the letter, "The task force has reviewed all possible actions that can be taken to combat this high pollution situation and finds that measures enumerated in the (Graded Response Action Plan) for all levels of pollution, including 'Severe+' have been imposed and are being implemented."

He added, "Keeping in mind the hazardous exposure to children, the task force has recommended, which EPCA is directing, that all schools must remain shut for the next two days, that is November 14 and 15." As per the CPCB, the condi-

tions witnessed Wednesday were a result of low surface winds, low mixing depth, which meant that pollutants were concentrated not very high above the surface and could not be dispersed due to weak wind speed. Contribution of farm fires

also had an impact as northwesterly winds brought pollutants from Punjab and Haryana, the minutes of the task force meeting said.

The levels of particulate matter of 2.5 and 10 micrometres (PM 2.5, PM 10) — fine particles suspended in the air which can enter the bloodstream through respiration, causing health problems — reached beyond emergency standards of 300 and 500 micrograms per cubic metre air on Wednesday.

As per the CPCB, in Delhi-NCR, PM 2.5 on average has remained above 300 since Tuesday noon and was recorded at 345.5 as of 7 pm Wednesday. PM10 crossed the emergency level around 1 am Wednesday and again after 6 pm, when it

was 500.3.

Of the 33 Delhi air quality monitoring stations for which data was available with the CPCB, 31 were in the 'severe' category, with two stations, Mundka and Najafgarh, on the borderline as of 7.30 pm. Among the stations with highest AQI as of 7.30 pm were North Campus (494), Dwarka Sector 8 (492) and Patpargani (491).

In addition to directing closure of schools, the EPCA has also extended the ban on operation of hot mix plants and stone crushers till November 15 morning.

Delhi's air quality is expected to improve marginally by Friday, said the central government's monitoring agency SAFAR, but a reasonable improvement to the 'very poor' category is expected by November 16.

Might extend odd-even scheme beyond Nov 15 if required: CM

TAKING NOTE of severe air pollution in Delhi, Chief Minister Arvind Kejriwal Wednesday said the odd-even road-rationing scheme could be extended beyond November 15 if required. In a statement released

Wednesday, he appealed to the Opposition parties not to oppose the scheme, which aims to reduce pollution by allowing only half of privately owned cars on the roads on any given day.

"All of Delhi is demanding odd-even and at such a time, the Opposition should support the people's wish," the CM said. He blamed the rise in pollu-

tion on crop residue burning in neighbouring Punjab and Haryana. "Stubble burning started after October 10 and the pollution levels in Delhi started rising to severe category due to that... I am highly disappointed that the states are not even obeying directions given by the Supreme Court. The people of Delhi are suffering and I am very concerned about their health," Kejriwal said.

He added that weather changes and rain witnessed in

the two states this season meant there was relatively less intrusion of smoke to Delhi for a pe-

Centre told to explore Hydrogen-based tech to deal with pollution

A SUPREME Court bench, headed by Chief Justice of India Ranjan Gogoi, allowed the Centre to look into the feasibility of a Hydrogen-based Japanese technology to deal with air pollution in the National Capital Region.

This came after Solicitor General Tushar Mehta brought this to the notice of the bench, also comprising Justice S A Bobde. The court told Mehta that there was a need for a permanent solution to the air pollution situation.

Mehta replied that a Japanese university had conducted research, keeping in view the air pollution in the National Capital Region (NCR) and Northern India, and also introduced the researcher Vishwanath Joshi to the bench.

Mehta said the government was of the view that the technology can be put to use to eradicate air pollution in the NCR.

Another Supreme Court bench, meanwhile, asked the Delhi government and Central Pollution Control Board to furnish pollution-related data in Delhi from October till November 14 this year.

Issuing notice to the Aam Aadmi Party government on a plea challenging the odd-even scheme, a bench of Justice Arun Mishra and Justice Deepak Gupta also sought data from October 1, 2018, to December 31, 2018.

The court was hearing a plea by a Noida-based advocate, who alleged that the odd-even scheme violated fundamental rights and people's right to practice any profession; carry out any occupation, trade or business; and to move freely throughout the country.

Non-smoker lung cancer cases have spiked: Doc

WITH DELHI-NCR experiencing its worst episode of air pollution in the last three winters, a surgeon from Sir Ganga Ram Hospital Wednesday said the number of non-smoker lung cancer patients has increased four-fold in the national capital

Dr Arvind Kumar, foundertrustee of the Lung Care Foundation and chairman of Centre for Chest Surgery at Sir Ganga Ram Hospital, said, "When I started operating on cancer patients in 1988, I found their lungs were pink. At the time, 90% of the lung cancer patients were smokers and the rest non-smokers Now, the ratio stands at 50:50. Half my cancer patients are nonsmokers. Worse, the lungs of almost all patients are dotted with black spots."

He was speaking at a conference, titled 'Sustainable Action Dialogue on Air Pollution', organised by The Energy and Resources Institute (TERI).

Speakers at the event agreed that the argument of economic cost to combat air pollution is untenable. "As per a 2016 World Bank study, India lost 8.5% of its GDP in welfare and labour productivity due to air pollution. So vou shouldn't let anvone get away with the argument that air pollution is very expensive to deal with," said Mitch Bernard, interim president and general counsel of Natural Resources Defense Council, a US-based advocacy group.

Just like Delhi, Los Angeles in California was blanketed by smog in the 1970s. "It was a concerted effort that helped clean LA's air. The EPA (Environmental Protection Agency, the leading environment agency in the US) said for every dollar invested in air pollution control programme by LA, the return was \$30 in terms of health and increased productivity," said Bernard.

Secretary of the Ministry of Environment, Forest and Climate Change C K Mishra said it is better to have a cleaner air than a booming economy and noxious air to breathe.

Ex-NGT chief says odd to even try the scheme buses? Why can't we provide

FORMER NATIONAL Green Tribunal chairperson Justice Swatanter Kumar Wednesday said the Delhi government's road-rationing scheme, which is currently enforced in the capital, is "itself odd, even to try". Calling air pollution the most

vital issue at the moment, Justice Kumar said various sources contribute to it. "We emphasise a lot on vehicles. We try odd-even, which itself is odd, even to try. The ingredients of air pollution are not only vehicular pollution. There are 10 sources of air pollution... most dangerous is the burning of waste," he said at an event Wednesday.

Other sources of air pollution include brick kilns, crop residue burning and unregulated construction activity, Justice Kumar said, adding that for 70% of the time in a day, Delhi's roads are "bumper-to-bumper".

"If you're going to introduce something like 5,000 buses, where are they going to ply?... Why can't we start destination

Gargava said stubble burning has contributed almost 44-45% to air pollution in Delhi this year, and garbage dumping and burning also creates a problem for which a cleaning drive could be carried out in July, August or

September, before air quality

starts becoming 'poor'.


"We must also quickly and heavily invest in public transportation... Involve private people in this. It's not DTC (Delhi Transport Corporation) vis-a-vis private people. It must be together," Gargava said.



PROTESTS CONTINUE DESPITE EC MEETING

Revised hostel fee fails to quell protest, JNU says it will benefit poor students

NEW DELHI, NOVEMBER 13

FOLLOWING large-scale protests by students, the Jawaharlal Nehru University administration Wednesday reviewed the hostel fee structure.

The bulk of changes were reserved for students falling in the "BPL (below poverty line) category" — according to the JNU administration, they will have to pay 50% of the revised room rent, service charges and utility charges (see box). For everyone else, only the refundable security deposit has been reduced to Rs 5,500 per annum from the Rs 12,000 mentioned in the draft hostel manual.

What exactly constitutes this category and who falls under it remained unclear till late Wednesday, with the HRD Ministry saying JNU will provide the finer details, and the university Registrar saying they will go by the government definition.

The previous BPL line fixed under the Tendulkar committee was Rs 1,000 per capita per month in urban areas. But most universities and schools now use the EWS (economically weaker sections) category to extend benefits. Even JNU had this year reserved 10% of its seats for those from the EWS category, with a family income of less than Rs 8 lakh per annum.

Asked about who will be covered under the BPL category, Registrar Pramod Kumar told *The Indian Express*: "We will consider those people BPL whom the government considers BPL." He refused to provide more details. A senior HRD ministry official, on the other hand, said, "The university will soon elaborate on who all are covered in the said category."

Asked if BPL had been a criteria for determining fee, either in his tenure or earlier, former

The JNUTA referred to the changes as "purely cosmetic" and noted that the increase in monthly charges for most students will still remain at around Rs 3,000.

"This will be an exorbitant increase for several students even if they are not in the BPL category as many low income households are not counted in that category. Even for BPL category students, the increase in charges will be to the order of Rs 1,500 per month immediately — a burden which no BPL household can possibly bear," read a statement by the association.

JNUSU vice-president Saket Moon said the Centre's BPL limit will push a large number of economically weaker students out of the university.

Executive Council meet shrouded in mystery, confusion

AGAINST THE backdrop of a massive student protest, JNU's Executive Council meeting was held outside the campus Wednesday. Five Deans and three elected EC representatives had reached the original venue, JNU's Convention Centre, when they were told roughly an hour later that the venue had been changed. The meeting was eventually held at the Association of Indian Universities near ITO.

The three representatives, all teachers, in a statement claimed they were asked by security guards to get into a car to be taken to an "undisclosed location", which they refused to do.

Former JNU Teachers' Association (JNUTA) secretary Bikramaditya Chaudhary said, "The only time the EC meeting was held outside campus was on April 15, 1997, at Chandigarh. But never before has the meeting been held outside the campus in the same city, in this manner."

Students, led by the JNU Students' Union, marched to the Administrative Block and entered the building. Messages like "You are not our V-C" were painted on Vice-Chancellor M Jagadesh Kumar's office door, and similar messages were painted on floors and the rector's room. "We will continue to stay here till the V-C meets us," said JNUSU vice-president Saket Moon.

Deans of the School of Social Sciences, School of Life Sciences and School of Environmental Studies alleged they were not allowed to leave the Convention Centre by protesting students, although the JNUSU distanced itself from the incident. "They stopped us from going. This was not at all decent or proper," said SSS Dean Dipendra Nath Das.

The three representatives — Sachidanand Sinha, Moushumi Basu and Baviskar Sharad Prahlad — in a statement said they reached the venue at 10 am

to find a "no-show by the V-C and his team of Rectors and Registrar".


"We tried calling the Registrar and V-C's office, but didn't get any communication. We waited till 10.40 am without news from the administration... It was clear from the lack of preparedness, that a decision was probably taken to not have the meeting at the venue. However, we as members... were not informed of the change," they said.

Around 11.15 am, they said "a security official told some members to accompany him to an undisclosed location, without any official communication of the same".

"At around 12.40 pm, we saw a mail from the administration to some of us, not all, informing about the change in venue... It was obviously not possible for us to make our way to the venue 18 km away through Delhi traffic in 20 minutes," the trio said.

The JNUTA called the meeting a "farce" and said the V-C must resign: "The JNU V-C has once again proved that he is utterly incapable of leading the University's administration and governance. JNUTA wants to make it clear that no meeting held under these circumstances can be considered a properly convened one. No decision taken at such a meeting can, therefore, be considered lawful."

Diabetes: A lifestyle epidemic

How relevant is the theme, 'family and Diabetes', for World Diabetes Day?

The primary aim of the World Diabetes Day campaign is to raise awareness of the impact that diabetes has on the family, and to promote the role of the family in the management, care, prevention and education of the condition. The family plays a vital role on various aspects of diabetes care, from recognising the symptoms of diabetes early on in family members, preventing type 2 diabetes, as well as managing diabetes when it occurs in a family member. The family can identify the early signs of diabetes, such as excessive thirst, urination, increased appetite, weight loss and fatigue, leading to early testing of blood sugar and early diagnosis. A family that adopts a healthy lifestyle, incorporating a healthy diet and physical exercise, can help prevent the onset of diabetes. Furthermore, the family plays a vital role in the management of diabetes once it has developed — from blood sugar monitoring, taking the medication on time to learning the art of injectable treatment, which most often is insulin. Thus families play a key role in addressing the conundrum of diabetes, and they must be provided with the necessary education and resources to help prevent diabetes and facilitate diabetic patients to lead a healthy life.

Most people are unaware of the different types of diabetes that exist. Please give a brief introduction to diabetes. What complications and health problems can diabetes cause?

Talking very simplistically, I would say that there are three broad categories of diabetes - type 1 diabetes, type 2 diabetes and gestational diabetes. Type 1 diabetes accounts for about 5% of diabetics around the world, though there are countries where the prevalence of type 1 diabetes is much higher. It is generally considered to be a disorder of children, but can occur at any age, and is now more frequently recognised in adults as well, masquerading as type 2 diabetes. The most important aspect is that treatment with insulin is vital and lifelong.

On the other hand, the most common type of diabetes is type 2 diabetes, occurring in adults, comprising ~ 90-95% of all diabetics. An important issue in type 2 diabetes is that though classically it was thought to occur in adults, usually above 30-40 years of age, it is now often recognised in children and adolescents who are obese. The implications are obvious — they have many more years to live, hence they are prone to develop the entire spectrum of complications of diabetes at an early age.

The third important group is gestational diabetes - gestational because it is diagnosed during pregnancy in the 24th or 26th week, and blood sugars return to normal after delivery. However, this puts her at an increased risk of developing type 2 diabetes in future. Furthermore, it results in the birth of a 'big baby', medically termed macrosomia.

The symptoms of diabetes are increased thirst, urination and appetite, weakness, fatigue and loss of weight in some patients. Some patients have all these symptoms. On the other hand, almost 50% patients have no symptoms and hence remain undiagnosed. Hence people at a high risk for developing diabetes should be screened for it.

Diabetes is a disease of complications, such as blindness (retinopathy), chronic kidney disease requiring dialysis or kidney transplantation, nerve involvement and arterial disease in the lower limbs causing gangrene, which may necessitate amputation of the limbs. Apart from this, heart attacks and strokes result in increased mortality and morbidity. What are the first few things that you tell a newly diagnosed diabetic person?

Well that depends on whether the patient has type 1 or type 2 diabetes. Most young patients with type 1 (age group 4-10 years), are brought by their parents, with a brief history of an acute illness. Most are devastated by the diagnoses and just do not accept the diagnosis. The very fact that they need to take insulin for life, and that to 3-4 times a day, added to which is blood sugar testing with finger pricking maybe 2-3 times a day, sends the parents, in particular, into a state of shock. It takes two to three consultations for them to accept the reality.


On the other hand, a diagnosis of type 2 diabetes is not all that disastrous. Yet getting the patients to diet, exercise, check blood sugars and take medicines or insulin, is no easy job. As a doctor you have to spend time with the parents explaining to them in detail about the disease, its treatment and complications. So the first few things we tell the patients and their families are - to accept the diagnosis of diabetes, be realistic about it, and to expect that it is going to last lifelong. It's a serious disorder and we tell them that upfront. Obesity, physical inactivity, and eating habits are the things that can be changed and managed, but not the genes or family history of a diabetic person.

Growing up with diabetes becomes an emotional issue for many. What will be your suggestions to tackle this disease on an emotional front?

When young children are diagnosed with type 1 diabetes then it comes as a big shock to them and their families. At such a young age, children generally find it very difficult to adjust with the restrictions that diabetes imposes on them, with regard to dietary changes, exercise routine, medication which is invariably insulin, monitoring sugar levels. Type 1 diabetes children need emotional support from the



Diabetes is a lifestyle disease causing other equally severe complications that can be life threatening. Diabetes affects various parts of our body, including eyes, kidney, heart, nerves etc. Currently, in India, there are 72-75 million diabetics, and the figure is likely to go up to 150 million by 2045. Hence, awareness in families regarding diabetes and prevention on part of the patient are the need of the hour to maintain a healthy lifestyle. ABHISHEK PATHAK from The Indian Express speaks to **DR (COL) SUDHIR TRIPATHI**, Vice Chairman & Senior Consultant, Department of Endocrinology & Metabolism, Sir Ganga Ram Hospital, on diabetes and its complications, with a special focus on family care, risk factors, prevention, new advancements and future care to manage the same



family and at school where they are subject to the vagaries of school life. They may need counselling and behavioural therapy.

On the other hand, even type 2 diabetics may find it difficult to cope with the disease. Particularly, the elderly with multiple medications for multiple disorders accompanying diabetes are often depressed and overwhelmed by their disease and need great deal of emotional care and support.

What has led to an explosion of type 2 diabetes in younger generation?

betes in younger generation?

The first factor is that Indians as a race or an ethnic group are genetically pre-disposed to develop type 2 diabetes. Superadded on this genetic background are the environmental factors such as our dietary habits, which include high carbohydrate contents, and the lack of a culture of exercise, leading to the explosion

of this epidemic. A sedentary lifestyle and adoption of unhealthy dietary patterns seem to be the reason for the increasing prevalence of diabetes in India.

Indians are often 'lean obese' i.e., Indians have a larger amount of intra-abdominal fat — also called central obesity. The intra-abdominal fat is the bad fat, which causes insulin resistance, leading to diabetes.

Thus the combination of genetic risk and environmental factors leads to the obesity epidemic, consequently increasing the prevalence of diabetes, occurring at an earlier age, often in the teenage years.

The tsunami of the diabetic epidemic has already hit India. The prevalence of diabetes in adults aged 20 years or older in India increased from 5.5% in 1990 to 7.7% in 2016. This can only be averted by a concerted effort on the part of the medical fraternity, so-

etary habits and an exercise-oriented culture. What is the doctor's role in the prevention of diabetes? How to avert and minimise the effects of this disease?

Doctors play a crucial role in the efforts to prevent diabetes. They need to emphasise the importance of lifestyle, dietary, and behavioural changes as the first-line treatment to prevent diabetes. In a recently published study, the most important risk factor for diabetes in India was obesity to which 36.0% of the diabetes disability adjusted life years in 2016 could be attributed. The prevalence of obesity in adults in India increased from 9.0% in 1990 to 20.4% in 2016. For every 100 obese adults aged 20 years or older in India,

there were 38 adults with diabetes, compared with the global average of 19 adults in 2016.

In order to prevent type 2 diabetes, adults should be regularly screened for "all five components" of metabolic syndrome. Doctors should measure — blood pressure, waist circumference, fasting triglycerides, LDL and HDL cholesterol and blood sugar, in order to identify patients at "high metabolic risk," i.e. those possessing at least three of the five components. It is suggested that high-risk individual be screened for these five factors of metabolic syndrome every 3 years and waist circumference every year.

Patients with established pre-diabetes - defined as a fasting blood sugar from 100-125 mg/dL - should undergo yearly type 2 diabetes screening. If patients are not responding to lifestyle intervention, metformin is recommended as the first pharmacological intervention to reduce glucose levels.

What kind of exercises do you recommend?

Children and adolescents with type 1 or type 2 diabetes or pre-diabetes are advised to exercise for about 60 min/day or more of moderate to vigorous aerobic activity at least 3 days/week. On the other hand, most adults with type 1 and type 2 diabetes should engage in 150 min or more of moderate to vigorous aerobic activity per week, with not more than 2 days interval between two exercise days. Adults with type 1 and type 2 diabetes should also perform resistance exercises 2-3 times per week. If weight loss is the consideration, then 60 minutes of moderate to intense exercise is advised i.e. ~ 300 minutes a week.

What is more effective — visiting a diabetes centre or an endocrinologist for diabetes?

Visiting an endocrinologist would be good, but the problem is the shortage of endocrinologists. It would be impossible for endocrinologists to see all patients with diabetes. The diabetic patients are seen by doctors at all levels, from general practitioners to physicians. Thus, in my opinion, all doctors should be empowered to treat diabetes. They should be trained to manage patients in a scientific and structured manner. The treatment of diabetes should be handled by a team, comprising the endocrinologist, physician, diabetes educator and a trained dietician. The patient can be referred to an endocrinologist for advanced care and to handle complicated cases.

Can pancreas be rejuvenated using allopathic medicines?

This concept of rejuvenating the pancreas essentially pertains to type 2 diabetes. The treatment of diabetes revolves around blood sugar control and also the management of associated conditions like hypertension and high cholesterol. The overarching idea is to protect the pancreas so that they continue to function by making insulin as long as possible and to ensure that the insulin thus secreted functions effectively. Some of the newer generation of oral sugar-lowering drugs help preserve the beta cells in the pancreas. It has also been seen that early aggressive treatment of diabetes at diagnosis, with insulin, can result in remission of diabetes for variable periods of time, stretching to about one year.

What are your views on the policies of the government regarding the pricing of drugs?

It's very important to have easily affordable drugs. The cost of treatment of diabetes is escalating rapidly and some of the newer generation of drugs are frightfully expensive. Even the overall treatment of diabetes and its complications is staggering. Generic drugs or biosimilars produced in India should be able to reduce the cost. However, quality assurance is very important.

Which Indian insulin companies are making these drugs? By when can we expect Oral Insulin?

Biocon and Wockhardt are two such Indian companies making these drugs. Biocon is currently working on the concept of Oral Insulin. Insulin Tregopil, a first-in-class oral insulin molecule being developed by Biocon, is a fast-acting oral insulin which can improve post-meal sugar control, and holds the promise to transform type 1 & type 2 diabetes management. Currently, it is in trials, and we hope to see some positive results in the next couple of years.

some positive results in the next couple of years. How do you think the future of diabetes care will develop in India?

I think the future of diabetes care depends on tremendous efforts by all the stakeholders involved in the care of diabetes. A lot of effort from the private health sector, the research bodies, government and pharmaceutical companies is needed. The state-level differences in the prevalence of diabetes, as demonstrated in recent studies, should guide policies of the government in this regard. Recent advances in diabetes-related technology, including real-time continuous sugar monitoring and closed-loop insulin pumps, have revolutionised treatment of diabetes. Recently a fully implantable sensor, which works for 90 days, has also been approved for use. All this put together should have a significant impact on the future of diabetes care in India and worldwide.

Your message to the readers.

Early diagnosis of diabetes is crucial for the management of the condition, which would reduce the risk of complications and mortality. The treatment of diabetes revolves around adopting a healthy lifestyle, monitoring the sugar levels and watching for the complications of diabetes and taking medication as prescribed by your doctor. Do not fear diabetes and nor should you be scared of taking insulin if required for the improvement of blood sugar levels.

The other judges who delivered the verdict — Justices Chandrachud, Gupta and Khanna do not feature in the list.

Putin invites Modi for Victory Day celebrations

Modi, who is in Brazil for the 11th BRICS Summit which will focus on building mechanisms for counter-terrorism cooperation and strengthen India's ties with the world's five major economies, met Putin on the sidelines of the

During the bilateral meeting, Modi said that "frequent meetings have strengthened our relations".

"Our bilateral relations are growing. You have invited me to visit Russia in May for the Victory Day celebrations. I am happily waiting that I will get an opportunity to meet you once again," the

The two leaders are meeting over two months after holding extensive talks in Russia's Vladivostok city on the sidelines of the Eastern Economic Forum.

BJP raised Rs 700 cr in 2018-19, half of it from Tata-controlled trust

THE BJP raised more than Rs 700 crore in 2018-19, and its largest donation – Rs 356 crore – came from an electoral trust controlled by the Tata Group.

An electoral trust is a not-forprofit company established with the sole purpose of distributing the contributions received by it to different political parties. While electoral trusts can raise funds from individuals and corporations, the largest chunk of the donations come from the latter. Hence, contributions by electoral trusts to political parties are usually identified as corporate donations.

In 2018-19, the BJP received approximately Rs 470 crore from all electoral trusts as opposed to 167.80 crore in 2017-18.

Prudent Electoral Trust, which paid Rs 67.3 crore to BJP, is the second higher donor among electoral trusts. The Bharti Airtel Group is one of the largest contributors to this trust, which is

also backed by Hero MotoCorp, Jubilant Foodworks, Orient Cement, DLF and JK Tyres, among others.

This is as per the party's contribution report submitted to the Election Commission. In the contribution report, a political party provides details of all donors who donated more than Rs 20,000. The funds generated through such donations are only a fraction of the total annual income of political parties.

Donations from electoral trusts to the Congress pale in comparison to the BJP. It received roughly Rs 90 crore from all electoral trusts in 2018-19. However, this is a big jump for Congress from the Rs 10 crore it received from electoral trusts in 2017-18.

The Progressive Electoral Trust, which gave Rs 346 crore to the BJP, gave Rs 55 crore to the grand old party. Prudent Electoral Trust, on the other hand, gave Rs 39 crore. The Aditya Birla General Electoral Trust, which gave over Rs 28 crore to the BJP, donated Rs 2 crore to the Congress.







two decades, according to a new study in *The Lancet*. Children will be among the worst sufferers from a rise in infectious diseases, the study said, pointing out that cholera is rising 3 per cent a year in India since the early 1980s with climatic suitability for Vibrio bac-

teria, which cause the disease. As temperatures rise, infants will be vulnerable to malnutrition and rising food prices. The study said average yield potential of maize and rice has declined almost 2 per cent in India since the 1960s, and malnutrition is already responsible for two-thirds of under-5 deaths.

Diarrhoeal infections, a major cause of child mortality, will spread into new areas, while deadly heatwaves, similar to the one in 2015 that killed thousands of people in India, could soon become the norm."

She said: "Over the past two decades, the Government of India has launched many initiatives and programmes to address a variety of diseases and risk factors. But this report shows that public health gains achieved over the past 50 years could soon be reversed by changing climate."

The 'Lancet Countdown on Health and Climate Change' is a comprehensive yearly analysis tracking progress across 41 key indicators, demonstrating what action to meet Paris Agreement targets — or business as usual means for human health. The project is a collaboration between 120 experts from 35 institutions, including the World Health Organization (WHO), World Bank, University College London, and Tsinghua University, Beijing.

Extreme weather events, the report points out, will intensify into adulthood, with India seeing an additional 21 million people exposed to wildfires between 2001 and 2004, and 22 billion additional hours of work lost due to extreme heat since

Court extends Chidambaram's judicial custody till Nov 27

MHA clears CISF,

THE UNION Ministry of Home Affairs (MHA) has granted "in principle" approval for the permanent deployment of the Central Industrial Security Force (CISF) on the Visva-Bharati University campus Santiniketan.

As reported by *The Indian* Express on October 30, Visva-Bharati Vice-Chancellor Bidyut Chakrabarty had sought CISF personnel on the campus, citing incidents of confrontation between the university administration and students and karamcharis (staff). The HRD Ministry had written to the CISF Director-General last month, backing his request.

Speaking to *The Indian* Express on Wednesday, Higher Education Secretary R MHA's approval, but added that the HRD Ministry has dropped the plan and is now exploring "other options" to address the university's security concerns.

Currently, no central university has paramilitary forces or even police personnel stationed permanently on campus. In 2017, the Banaras Hindu

University (BHU) had made a similar request, claiming that its security was inadequate to handle such a huge campus. The request is still pending.

The MHA has granted approval to the CISF to carry out a joint survey to assess the university's requirement for security personnel as well as the accommodation facilities on campus. Visva-Bharati, MHA has clarified will have to bear the cost of deployment, including the provision of meals and suitable accommodation for the security personnel.

In his letter to the HRD ministry, V-C Chakrabarty had said that the private security personnel currently employed by the university owe their allegiance to the "TMC local bosses" and hence, "disobey" Visva-Bharati's security officer "with impunity".

He had also cited the protest Subrahmanyam confirmed the by students in May this year against the increase in the price of application forms. The students had held a sit-in protest preventing faculty members and officials from leaving the campus. The V-C alleged that in such instances, the security guards "remained silent onlookers" and even created enabling conditions for the protesters.

He sought to stress that "judicial independence is not a carte blanche to arbitrary behaviour", and that "independence of the judiciary was not envisaged to mean its insulation from checks and balances that are inherent in exercise of constitution power".

The judge expressed the view that "judicial power, conferred in public interest as a necessary element in administration of justice, cannot be used to achieve extraneous ends" and that judges are not above the law.

On the need for accountabil-

ity, Justice Chandrachud wrote,

"Adjudicators in robes are human and may be predisposed to the failings that are inherently human. But the law demands that they must aspire to a standard of behaviour that does not condone those failings of a human persona in discharge of judicial duties. To equate the actions of an individual which have no nexus with the discharge of official duties as a judge with the institution may have dangerous portents. The shield of the institution cannot be entitled to protect those actions from scrutiny".

He wrote, "The contention that merely because a judge cannot be elected out of office the conduct of judges and their general administration is not a matter of great public interest cannot be countenanced..."

Verdict bringing CJI under RTI comes 10 yrs after first plea denied

WEDNESDAY'S SUPREME Court judgment bringing the office of the Chief Justice of India under the Right to Information (RTI) Act came on three appeals filed by its Secretary General and Central Public Information Officer (CPIO) against the order of Central Information Commission (CIC) and the Delhi High Court.

The appeals arose from applications by RTI activist Subhash Chandra Agarwal.

On July 6, 2009, Agarwal had moved an application before the top court's CPIO, seeking a copy of the "complete correspondence with then Chief Justice of India as the Times of India had reported that a Union Minister had approached, through a lawyer, Justice R Reghupathi of the High Court of Madras to influence his judicial decisions". The SC registry denied it on

the ground that the information sought was not handled and dealt with by the Registry of the Supreme Court and the information relating to it was neither maintained nor available with it. After Agarwal's first appeal was dismissed, on his second appeal the CIC directed that the information be furnished.

Agarwal filed a second appli-

cation on January 23, 2009, before the CPIO seeking a copy of complete file/papers as available with the apex court, including copies of complete correspondence exchanged between the constitutional authorities concerned with file notings relating to appointment of Justices H L Dattu, A K Ganguly and R M Lodha, superseding seniority of Justices A P Shah, A K Patnaik and V K Gupta, "which was allegedly objected to by the Prime Minister".

The CPIO denied this information observing that the registry did not deal with the matters pertaining to appointment of SC judges. It said that appointment of judges to Supreme Court and High Courts are made by the President as per proce-

dure. On further appeal, the CIC

accepted the appeal and directed

In November 2007, Agarwal also sought information on declaration of assets made by judges to the Chief Justices in the States.

furnishing of information.

This was dismissed by the SC CPIO "stating that information relating to declaration of assets of judges of the Supreme Court and High Courts was not held by or was not under control of the Registry of the Supreme Court".

On first appeal, the appellate authority directed that the matter be remitted to the SC CPIO to follow the procedure under RTI Act and to inform Agarwal about

the authority holding the information sought for.

The CPIO subsequently asked him to approach the CPIO of High Courts, following which Agarwal appealed before the CIC.

The CIC allowed the appeal. Later appeals by the CPIO to Delhi High Court were also decided in Agarwal's favour.

On Wednesday, the apex court upheld the CIC order, directing its CPIO "to furnish information on the judges of Supreme Court who had declared their assets". The court said "such disclosure would not in any way, impinge upon personal information and right to privacy of the judges".

On the other applications, the court allowed them partly with an order of remit to the CPIO to re-examine the matter after following the procedure under RTI Act, as the information relates to third parties.

NEARLY 100 workers, most of

them women, fell sick in a case of suspected gas leak at a prawn processing unit in Odisha's Balasore district on Wednesday night.

Doctors said the situation is under control and many of the affected people are being discharged after first-aid, PTI reported.

Odisha's coastline is dotted with many units that culture shrimp for domestic and international markets. The state exports prawn worth approximately Rs 2,000 crore annually.

The accident is reported to have occurred in Panapana village of Balasore's Bahanga tehsil. The affected workers were taken to Khantapada community health centre (CHC). Visuals emerging from the

being carried out of buses and into the CHC. Many women were unconscious and shivering as they were laid on the floor.

Fifty patients were later shifted to the district headquarters hospital, PTI reported, quoting a Balasore police officer.

Initial reports by local news channels said the CHC had only one doctor and a nurse, before the district administration rushed a team of doctors for additional support. Some nursing students were also allowed to join the teams treating the affected workers, according to information.

"We hear that the gas leaked is ammonia," a district administration official said. But one of the first women to revive said the gas in question was a chlorine compound. "My eyes and throat started burning. I was sneezing violently and rushed outside," she said.

SC order on tribunals warning to govts on abusing Money Bill route: Cong

EXPRESS NEWS SERVICE NEW DELHI. NOVEMBER 13

THE CONGRESS on Wednesday welcomed the Supreme Court's decision to refer to a larger bench the question whether the 2017 Finance Act was a Money Bill while setting aside provisions relating to working of tribunals. The party said it was a victory for Rajya Sabha and democracy and a big defeat for the Narendra Modi government.

"The verdict will have farreaching consequences on any future attempts by the Modi government to abuse the Money Bill route and is also a reminder to future governments that any attempt at diluting our institutions will not be allowed," Congress

leader Jairam Ramesh said at a

press meet.

The apex court order came on a batch of petitions, including one by Ramesh, challenging the "form and substance" of the 2017 Finance Act.

Ramesh said the ruling was a victory for democracy in general and Rajya Sabha in particular. He said it is important to have a discussion on the Money Bill in Parliament. He alleged that the government has been misusing Article 110 over the past three years and converting key Bills to Money Bills for avoiding a vote and passage in Rajya Sabha.

He said the government had sought to dilute appointments to 19 different tribunals, including the National Green Tribunal and the Central Administrative Tribunal.

"All terms of conditions had been changed. The qualifications had been changed, the tenure

had been changed, the terms which govern the appointment of judicial members and technical members all had been changed. Basically, the objective was was to make these tribunals answerable only to the Prime Minister and the Prime Minister's Office. That has been quashed today," Ramesh said.

He said the government had made changes in the rules relating to the working of the tribunals "with the furtive intention of vesting greater control in the central government on the appointments of judges to these judicial and quasi-judicial bodies".

"Knowing fully well the Finance Act (and the Rules framed thereunder) would not pass parliamentary muster, the Modi government classified it as a Money Bill so as to prevent voting in the Rajya Sabha," he said.



MP govt puts Kartarpur in pilgrimage scheme

IN ANOTHER gift to the Sikh community in Madhya Pradesh, the Kamal Nath-led Congress government Wednesday included Kartarpur Sahib in Pakistan in the Mukhyamantri Teerthadarshan Yojana.

Haryana Cabinet expansion today, BJP gives JJP key portfolios

EXPRESS NEWS SERVICE CHANDIGARH, NOVEMBER 13

THE JANNAYAK Janata Party (JJP) has succeeded in getting key portfolios like revenue, excise and taxation, and development and panchayats ahead of the first cabinet expansion of the BJP-JJP government in Haryana on Thursday.

On the advice of Chief Minister Manohar Lal Khattar, Governor Satyadeo Narain Arya on Wednesday allotted 11 departments to Deputy Chief Minister and JJP leader Dushyant Chautala. These include excise and taxation, development and panchayats, industries and commerce, food and civil supplies, revenue, labour and employment, civil aviation, archaeology and museums, rehabilitation and consolidation, among others.

Sources said the Deputy CM will distribute some of the portfolios among two ministers to be inducted into the Cabinet from the JJP quota. While JJP leader Anoop Dhanak is expected to take oath as minister on Thursday, another party leader may be inducted in the Cabinet later.

A JJP leader told *The Indian* Express that the allocation of key departments like revenue and panchayats will enable the party to work for people in rural areas, especially farmers. "IIP has got the excise and taxation portfolio. We will take liquor vends out of residential areas in villages."

This comes after the CM's announcement in September that places associated with visits of Guru Nanak Dev will be developed as sites of religious tourism in the state.

The spiritual department issued an order to amend the list of places covered under the popular scheme that was launched by the Shivraj Singh Chouhan

government in 2012. Under the Mukhyamantri Teerthadarshan Yojana, the government spends on travel, food and stay of pilgrims. Pilgrims are generally taken by rail but the government also spends on bus travel, guide fee and other incidental expenses whenever required.

MP domiciles who are above 60 years of age and do not pay income tax are eligible under the scheme. The age limit is 58 for women. Those aged above 65 can take one attendant with them.

The BJP government included nearly 30 places considered sacred by different religious communities on the list. Kartarpur is the first shrine located in another country that has been put on the list.







Supreme Court does well to open CJI office to RTI. But transition to greater judicial transarency won't be easy

HE SUPREME COURT'S decision to open the office of chief justice of India to scrutiny under the Right to Information Act is enormously welcome. The ruling comes nine years after the Delhi High Court ruled in favour of bringing the CJI's office under RTI. It is a remarkable case where the Court, in its administrative avatar, appeared as a litigant before its judicial avatar, argued against transparency and eventually ruled against itself. For an institution that has insulated itself from public scrutiny and one that gives little insight into its own functioning, the verdict pushes the envelope on greater judicial accountability. The tug of war between the executive and judiciary on appointments is often complicated by the reluctance of the court to make the reasons and compulsions behind its decisions public. While the government discloses its reasons for not accepting the collegium's recommendations, the judiciary's defence remains absent from public debate.

However, there is reason to be circumspect in celebrating the verdict. The verdict binds the court to accept applications seeking information but the process of obtaining it may not be easy. The ruling allows for an ordinary citizen to seek information on appointments, transfers of judges to the high courts and Supreme Court but the reasons behind these recommendations could still be clouded in secrecy as the decisions of the collegium are largely based on reports of the Intelligence Bureau which is exempted from providing information under RTI. The verdict itself asks information commissioners to keep in mind the right to privacy and the independence of the judiciary while deciding on RTI requests. Justice NV Ramana, in his separate opinion, cautions that the RTI must not be used as a tool of surveillance against the court.

Institutionally, the transition to transparency may not be easy and hinges on the actions of the chief justice of India, as administrative head of the court. Eight chief justices retired without hearing this difficult case. Even when former CJI Dipak Misra decided that collegium decisions, along with reasons, will be published on the Supreme Court website, CJI Ranjan Gogoi signalled a departure from the practice after 256 decisions were published. Just two months ago, when criticised for transferring former Madras High Court Chief Justice VK Tahilramani to Meghalaya High Court, the collegium headed by CJI Gogoi issued an unusual statement that though "it would not be in the interest of the institution to disclose the reasons for transfer, if found necessary, the Collegium will have no hesitation in disclosing the same." The reasons never came and Justice Tahilramani resigned subsequently. However, the fact that the five-judge bench comprises of three future chief justices — NV Ramana, DY Chandrachud and Sanjeev Khanna — is reason to hope for a new era of transparency in the Supreme Court.

FAILURE TO LAUNCH

Andhra CM Jagan Reddy needs a governance vision that goes beyond undoing Chandrababu Naidu's work in office

AGANMOHAN REDDY WON office in May by defeating Chandrababu Naidu. His YSR Congress swept Andhra Pradesh, winning nearly 50 per cent of the votes and 151 of 175 assembly seats; Naidu's Telugu Desam was reduced to a rump in the House. But six months into his tenure, Reddy, one of the youngest CMs in the country at 47, threatens to be a major disappointment. The latest in a series of actions, undertaken, ostensibly, to undo Naidu's legacy in the state, is the move to terminate the Andhra Capital Region Development Authority's (CRDA) agreement with a Singapore consortium to develop a 6.84-km greenfield start-up area in Amaravati, the designated capital of Andhra Pradesh post bifurcation in 2014. The start-up area was to have a host of facilities, including pay-and-plug offices and generate nearly 50,000 jobs on completion.

The decision to cancel the project must be read in the backdrop of the Reddy government maintaining that it doesn't intend to develop Amaravati as a world-class city, as Naidu had wanted. Clearly, Reddy is haunted by the spectre of Naidu's legacy looming over Amaravati. It is not as if Reddy has an alternate plan for the new capital. His vision, unfortunately, seems to be blinded by his obsession with all that Naidu built or proposed. So, bureaucrats have to drive out to meet Reddy in his camp office outside Amaravati, instead of the latter receiving them in the CM's chamber in the secretariat, built during Naidu's tenure. Elsewhere in Amaravati, work has stalled on many infrastructure projects. Funding agencies, including the World Bank and Asian Infrastructure Investment Bank, have backed off. With dismal signals being sent out by the government, the city is unlikely to attract any fresh investment, which the state desperately needs. Amaravati needs to be built not merely as a legacy project, but also to ensure that neighbouring Vijayawada is not forced to shoulder the burden of an under-developed state capital. Moving beyond Amaravati, Reddy's initiatives, such as village secretariats, a parallel bureaucracy of 1.26 lakh new recruits, and the push for re-tendering old projects, are likely to result in cost overruns and bleed the state economy.

The government's lack of a governance plan is compounded by its hostile approach to critics. Government departments have been told to sue the media in the event of reports that officials perceive as defamatory. Reddy needs to realise that governance calls for a more generous vision of both the past and the future.

NEHRU'S CHANAKYA

India's first PM was his own vocal critic. That served democracy well, and is something leaders today can emulate

N 1937, AN article published in Modern Review, written by Chanakya, described the then president of the Congress as having "all the makings of a dictator in him vast popularity, a strong will directed to a well-defined purpose, energy, pride, organisational capacity, ability, hardness, and, with all his love of the crowd, an intolerance of others and a certain contempt for the weak and the inefficient." Ten years later, Jawaharlal Nehru became the first Prime Minister of India. Chanakya's fears and doubts about Nehru's liberal and democratic character turned out to be largely unfounded. Or, given that Chanakya was Nehru's pseudonym, it is perhaps the ability to reflect on his own shortcomings that kept them from consuming the man and the young democracy he led.

It is hard, today, to imagine India as anything other than a democracy. But all around the young nation, other newly-decolonised countries crumbled to dictatorships, military and political, and the promise of freedom gave way to despondency as the leaders of freedom struggles did not brook opposition. Curiosity, erudition, decency, diversity these were the underpinnings of India's first prime minister's personality and for long, and in no small part, they influenced the country of which he is a founding father.

Chanakya also wrote: "A little twist and Jawaharlal might turn a dictator sweeping aside the paraphernalia of a slow-moving democracy. He might still use the language and slogans of democracy and socialism, but we all know how fascism has fattened on this language and then cast it away as useless lumber." In its first 17 years, the Indian republic was fortunate to have a check over executive power that was more than just constitutional — it stemmed from the personal and political morality of a flawed and yet great man. Perhaps India, on his 130th birth anniversary doesn't need a Nehru — its political landscape is painted in colours too stark for his complexities, it is too inebriated by a politics of identity. But Nehru's alter ego, Chanakya, remains an example of how politics can be a space more capacious.

Listen, Mister Muslim



Let's recognise our own complicity in becoming the convenient 'Other' for Hindu nationalists

LISTEN, MISTER MUSLIM. You are rightly upset with the verdict of the Supreme Court on the Ayodhya land dispute as it puts faith above law. Not for the first time, secular India has let you down. But truth to tell, you too have let secular India down. In this zero sum game between the Indian state and you, it's been advantage Hindutva all the way.

This is not to rub salt in your wound. But to point out that Muslims as a community are guilty of the very same thing they are accusing the Supreme Court of: Pitching Shariah law against the Indian Constitution, faith against the law of the land. The rigid, intransigent Islam that our ulema and political leadership continue to preach leaves us little space for manoeuvre or room to negotiate a respectable place for ourselves in a secular-democratic polity. It's time for some honest introspection. Was it not us who took to the streets in 1985, protested aggressively against the apex court's judgment in the Shah Bano case, insisted that Shariah law took precedence over the secular law of the land?

The then Congress government under Prime Minister Rajiv Gandhi capitulated and the result was the Muslim Women (Protection of Rights on Divorce) Act, 1986. Faith triumphed over a secular law (Section 125 of the CrPC) and Muslims were euphoric. The consequence: Secular-minded Indians were outraged, while Hindutva organisations grabbed the opportunity to up the ante. If the law can be changed in deference to Muslim religious sentiments, what about Hindu religious sentiments? In a balancing act, the Rajiv government engineered the opening of the locks of the Babri Masjid in Ayodhya. Could it be, Mister Muslim, that in setting a dangerous precedent, we lost the "plot", not on November 9, 2019 but way back in 1986?

As the Babri Masjid-Ram Janmabhoomi agitation snowballed, thanks to the ulema's myopia, what should have remained a legal

between faiths, a conflict between Ram and Rahim. The militant "mandir wahin banayenge" war-cry of the "Ram Bhakts" was matched by the equally belligerent "once-amosque-always-a-mosque" posture of the Muslim leadership, It's a position that the All India Muslim Personal Law Board (AIMPLB) upholds even today. The leader of the All-India Majlis Ittehadul-Muslimeen (AIMIM), Asaduddin Owaisi, has recently reiterated: "A mosque belongs to Allah and no Muslim has any right to give or gift it away". In Islamic Saudi Arabia any number of mosques have been demolished or relocated for road widening and other public purposes. But in secular India, it's a different Islam. The escalation of communal conflict well

suited the designs of the Sangh Parivar in convincing more and more Hindus that "Babar ki aulad" are preventing the building of a temple at the birth place of Lord Ram. From two seats in the Lok Sabha in 1984, the BJP's tally shot up to 85 seats in 1989 and 120 seats in 1991. This should have been a wakeup call for Muslims. But as riot after riot claimed more and more Muslim lives, the leadership remained blind to the reality that a state which failed to protect lives was unlikely to save a mosque.

Does anyone recall the statement of the late Atal Bihari Vajpayee a year or two before the demolition: "The mosque is sacred to Muslims, the spot is sacred to us Hindus as the janamsthan of Bhagwan Ram. I appeal to my Muslim brothers. We Hindus will respectfully lift the Babri Masjid brick by brick and re-build it at another spot. You let us build our Ram Mandir there." The Muslim response: A mosque does not mean four walls but the land on which it stands. In other words, it's not a question of law but a matter of faith.

Five months before the Babri masjid was demolished (December 1992), in an article published in the now defunct weekly Sunday Observer, yours truly had argued why in the interest of the minority community and the national interest, Muslims should unilaterally hand over the Babri Masjid, either to the president of the Indian republic or the Supreme Court. Let the chief custodians of secular India decide whatever they thought to be in the best interests of national unity and communal amity. The article reminded Muslims that the Places of Worship (Special Provisions) Act, 1991, offered statutory protection against any future agitations concerning all other mosques in the country. In response, I got a mouthful from even secular Hindu friends who asserted: "The Babri Masjid is not just a property of Muslims. It is a symbol of secular India. Who are you to gift it away?"

We, Mister Muslim, lost the opportunity for winning Hindu goodwill by our gesture, arresting if not reversing the rising tide of militant Hindutva and strengthening secular forces. The outcome: For Muslims, the loss of an estimated 3,000 lives since then in the recurring communal flare-ups; for Hindu nationalists, Ayodhya proved to be the chariot to ride to power.

Fast forward to November 9, 2019. Yes, the Supreme Court's verdict is disturbing. More disturbing is the fact that it was unanimous; not one of the five judges voiced a dissenting note. Even more disturbing, consider how it is that well before judgment day the Sangh Parivar had not the least doubt that the impending judgment would be in favour of Ram Mandir. How else does one understand their overnight switch from *mandir* wahin banayenge vow to an appeal to all Indians to "wholeheartedly support" the verdict, irrespective of which way it goes? Also, consider this: Most self-proclaimed secular parties are content with having expressed their respect for the verdict.

It's time we realised, Mister Muslim, that our clinging to the ulema's brand of Islam gives every conflict a Hindu-Muslim complexion when the ongoing battle is, in fact, between secular India and Hindu Rashtra. We mustn't become the convenient "other" for the Hindu nationalists to hide their real agenda.

NEHRU, RATIONAL SPIRITUALIST

For him, spirituality was rooted in Indian tradition and connected to ethics

JAWHARLAL NEHRU WAS a rationalist but he did not dismiss the human mind's spiritual quest. Being modern does not mean being unconcerned with or contemptuous of tradition and culture. It means identifying with the dynamism in tradition and accelerating its modernising tendencies.

A nuanced and essentially Indic understanding of the spiritual quest guided Nehru's endeavours in this respect. This understanding, achieved through reflection spread over millennia, came almost intuitively to a sophisticated Indian like Nehru, as it did to several ordinary people in his country. That is why Nehru could win the faith of countless Indians despite a sustained campaign against him for not being "culturally rooted and sufficiently Hindu/Indian". He never hid his aversion to "superstitious practices and dogmatic beliefs" and "uncritical credulousness" that often go with religion. But, he also knew that, "religion had supplied some deeply felt inner need of human nature, and the vast majority of people all over the world could not do without some form of religious belief. It had produced many fine types of men and women, as well as bigoted, narrow-minded, cruel tyrants."

Nehru felt "at home" in a "pantheistic atmosphere" and was attracted to "the advaita philosophy of Vedanta". In his own words, "I can appreciate to some extent the conception of monism, and I have been attracted towards the advaita (non-dualist) philosophy. The diversity and fullness of nature stir me and produce a harmony of the spirit, and I can imagine myself feeling at home in the old Indian or Greek pagan and pantheistic atmosphere, but minus the conception of God or gods that was The need to address the 'spiritual' was not merely personal for Nehru. attached to it." He further notes, "Some kind of ethical approach to life has a strong appeal for me, though it would be difficult for me to justify it logically. I have been attracted by Gandhiji's stress on right means."

In the Hindu worldview, "ethics and conduct" are much more important than the acceptance of a particular doctrine. That is why Nehru, who always emphasised scientific temper, could win the love and confidence of not just ordinary people but religious schol-

As first-hand received knowledge of the freedom struggle fades, misconceptions like Nehru was "ignorant" of Indian culture and had "contempt' for Hinduism have become widespread. In 2004, at a conference of scholars of Indian religions and cultures at Esalen institute, California, I was amazed to hear from a very respected scholar of philosophy and history that "the rise of Hindutva politics in India is due to the fact that Nehru suppressed religion, particularly its public display".

Any Indian brought up in "Nehru's India" would find this statement bizarre. Nehru and his colleagues, in continuation of Gandhi's idea that "every religion has some element of Truth", tried to evolve a state which sought to neither privilege nor suppress any religion it sought to provide space to atheists as well. Even after Nehru's demise, when the word "secular" was inserted into the Preamble of the Constitution, through the 42nd amendment, care was taken to translate it in Hindi not as "dharma-nirpeksha' but "panth-nirpeksha" – because in several Indian languages, the term "dharma" stands not for a religious doctrine, dogma or faith system, but for the "inherent nature" of things, or for law. The need to address the "spiritual" was not merely personal for Nehru. Reflecting on the

human condition, he noted in a conversation with R K Karanjia in 1960, "the need to find some answer to the spiritual emptiness facing our technological civilisation". He had realised quite early on, the deep interconnection between the poetic and the spiritual. In 1922, while in prison, he read a lot of "religious" works. In a letter to Gandhi, Nehru insightfully described the Ramcharitmanas as "a

spiritual autobiography" of the poet Tulsidas. After Independence, Nehru was as insistent on having autonomous national institutions of letters, fine arts, music, drama and film as he was eager to have institutes of technology and nuclear reactors. The most important function of these initiatives in Nehru's vision was to address the "spiritual emptiness facing our technological civilisation". What he could not tolerate was using religion for political gains — communalism and the politics of hurt sentiments.

The recent Ayodhya verdict reflects a situation characterised by the helplessness of law instead of its rule, the reason being that the judiciary was expected to resolve a matter which though apparently legal, was essentially political. It is for us to think whether Nehru's insistence on running our polity "in accordance with political principles, not religious sentiments" has become more important with time.
