# IOA wants to host 2026 CWG but remains firm on boycotting next edition

THE INDIA Olympic Association (IOA) went into the meeting room with the Commonwealth Games Federation(CGF) squabbling on a boycott. Somehow, at the end of it, they ended up expressing interest to host the very event they wanted to snub. Whether it was the CGF officials pulling off some sort of a salesman trick or their IOA counterparts shooting from the hip, one can't say.

But even as the impasse continues over India's participation in the 2022 Commonwealth Games and beyond, IOA secretary general Rajeev Mehta announced they are considering a bid for the 2026 edi-

tion. "We are willing to host 2026 CWG. We will first take approval from the (IOA) executive board and general assembly. Then we will approach government. If they allow, we can host the Games," Mehta said.

The declaration surprised CGF president Louise Martin and CEO David Grevemberg, who shared the stage with Mehta at a media briefing after the meeting on Thursday. Even IOA president Narinder Batra, sitting next to Mehta, looked a little perplexed. No one offered an immediate response to it, with a few other IOA members saying it was Mehta's 'personal opinion'.

The same was said in June as well, when Mehta floated the idea of India boycotting the 2022 Games because the organisers excluded shooting, a sport where the country wins the bulk of its medals. The stray remark by the IOA secretary general snowballed into a major controversy. And when the IOA's president

forced to undertake a trip to Delhi to broker peace. The CGF hoped they would explain the rationale behind shooting's exclusion and also remind the IOA that Mehta and then president N Ramachandran were among the representatives of 71 Commonwealth nations who

appointing because it was a unanimous decision. But we are where we are right now." Martin said.

Multiple options were considered on Thursday to appease India. The CGF has suggested that the Commonwealth Shooting Championship, which will be held simultaneously, offers world ranking points - that call, however, will be taken by the International Shooting Sport Federation. The IOA, on the other hand, has demanded that the medals won by shooters at the Championship be counted in the CWG medals tally.

A lot of vague scenarios but at the end of the meeting, two things were clear: shooting will not be a part of the 2022 CWG, against India's wishes and the IOA has not withdrawn its boycott threat, contrary to what the CGF hoped. But India did soften its stand, with Batra saying 'boycott was not an appropriate' word. "It should have been 'withdrawal'. It was a successful and productive meeting but the proposal of with-

drawal from 2022 CWG still

stands," he said.

Batra said the bigger concern for him was the short gap between the Commonwealth and Asian Games. The Asiad, he said, assumes significance for a lot of sports where Olympic qualification berths are up for grabs. "You can't expect an athlete to peak today and then again after 32 days, given that is the gap between the 2022 CWG and Asian Games," he added. "It's not that CWG medals are not important, they are. So are

Asian Games, which is also an Olympic qualifying event for some. And how do I increase my Olympic medals if we have to bid for the 2032 Olympics? We keep everything in mind."

The IOA has already expressed interest to host a bunch of events, including the 2026 Youth Games, 2030 Asian Games and 2032 Olympics. Mehta's announcement that India will also bid for the 2026 CWG means the country has now thrown its hat in the ring for almost all multi-discipline events during that cycle. At the moment, however, confusion prevails over whether the IOA wants to boycott the CWG or host it. Perhaps, they feel the safest way to ensure shooting returns to the CWG programme is by hosting it.

# Captain Sparv ready to lead Finland to the promised land

AFTER 17 years of service in his nation's colours, Finland captain Tim Sparv is on the cusp of doing something that no senior male Finnish footballer has managed leading his side to the finals of a major soccer tournament. A win against Liechtenstein in front of a capacity crowd in Helsinki on Friday will guarantee the Finns, better known for their prowess at winter sports such as ice hockey and cross-country skiing, a berth at Euro 2020.

achievement. Instead, they have waited patiently to take their place among the footballing nations of the world, with Sparv cheering them on from the terraces before first lining up for them at under-15 level in 2002 and then for the senior side for the last decade.

"It was a dream of mine to represent the national team when I was growing up. If you were a young Finnish footballer back then, you looked up to Sami Hyypia, Jari Litmanen, Antti Niemi, Jussi Jaaskelainen- it was a big deal for me when I first came into the national team in 2009.

"These guys were still there, so it was a fantastic opportunity for me to learn from guys who had played in big clubs, won Champions Leagues. That was pretty cool. You have to remember, this was the golden generation," the midfielder explained. "Everybody expected them to

bring Finland to a championship, so I think it was a surprise and maybe a disappointment for many that they never managed it." The names and clubs of the current squad may be less wellknown -- Sparv plays for FC Midtjylland in Denmark -- but a combination of defensive organisation, team spirit and the goals of striker Teemo Pukki, who plays for Norwich City in England's Premier League, have put them on the brink of qualification. "Pukki brings that X-factor, the simple playing philosophy that everybody knows has helped us. He's

> been so amazing for us." he said of the 29-year-old Pukki, who has netted seven of Finland's 12 goals in qualifying.

"We know that if we create a for chance Teemo, he'll score nine times out of 10. He's really developed into a star player.'

Citing his side's defensive stability and Iceland's recent success in qualifying for Euro 2016 and the 2018

World Cup as sources of inspiration, Sparv said Finland's heart and togetherness would see them through. "Everybody plays for the flag

on the front of the shirt, rather than the name on the back. You can see that the players in the Finnish national team love the team. No-one creates any issues or problems," he said.

Armenia and Bosnia could still pip the Finns to second place, but not if Sparv's side beat Liechtenstein, a team with no wins and only two points and two goals scored so far in qualifying. "I can't imagine what it will be like if we win. People have been talking about these final two games for weeks," Sparv said. # Tsitsipas wins Next Gen battle

21-year-old Greek demolishes 22-year-old Zverev 6-3 6-2 to book a place in the last four of the ATP Finals

**DEBUTANT STEFANOS Tsitsipas** crushed defending champion Alexander Zverev 6-3 6-2 on Wednesday to book his place in the last four of the ATP Finals with a match to spare. The 21-year-old, the first

Greek player to qualify for the elite eight-man season-ender, backed up his opening roundrobin win over Daniil Medvedev with another virtuoso performance at the O2 Arena and is yet to lose a set. His emphatic victory secured a top-two place in the group and left Zverev, world number one Rafael Nadal and Medvedev scrapping to join him in Saturday's semi-finals.

A year ago Tsitsipas was winning the NextGen title in Milan -- the ATP's showcase event for up-and-coming players -- and in his two matches so far in London he has bolstered the impression that he has the game to start collecting Grand Slam titles.

His swashbuckling all-court game, with a booming serve, aggressive groundstrokes, deft volleys and silky movement have made him an instant crowd favourite at the O2 Arena.

All those weapons were on display against Zverev in what was the youngest, in terms of combined age, match at the ATP Finals since Andy Murray played Juan Martin del Potro in 2009.Zverev's last three matches at the O2 were straight sets victories over Roger Federer, Novak Djokovic and Nadal -- a trio with 55 Grand Slam titles between them.

But the form of Monday's group-stage win over Nadal deserted him as Tsitsipas, with whom he is said to have a frosty

relationship, beat him for the fourth time in five matches.

Tsitsipas broke in the eighth game when Zverev opted to follow in a weak second serve and made a mess of a low volley. From that point on it was

one-way traffic. Zverev's level tailed off alarmingly in the second set and Tsitsipas wrapped things up with an ace. Tsitsipas later

revealed he had needed a

painkilling injection in a

foot injury.

Yet despite having already reached the semis, he will not take his foot off the gas against Nadal on Friday when he could knock the Spaniard out.

"I'm going to give it my all. I'm going to try to give my soul, and I think it's also a very good challenge for me in order to prepare for more difficult matches in the semi-finals," he said. "It's going to educate me, and I'm going to try to get and absorb as

much as I can from that."

## **Consolation win**

Matteo Berrettini will leave the ATP Finals with a victory after beating Dominic Thiem 7-6

(3), 6-3 on Thursday. The match was essentially meaningless as Thiem had already qualified for the semifinals after winning his first two round-robin matches, while Berrettini had no chance of ad-

vancing after two losses.

A year ago Tsitsipas was winning the NextGen title in Milan and in his two matches so far in London he has bolstered the impression that he has the game to start collecting Slam titles.

Thiem didn't play anywhere near as well as in his wins over Roger Federer and Novak Djokovic but came from a break down to force a tiebreaker in the first set. However, Berrettini raced out to a 6-1 lead in the tiebreaker and converted his third set point with an ace.

In the second set, the Italian broke for a 4-2 lead and served out the match at love, sealing the win with a forehand drop shot.

Berrettini surprised many just by qualifying for the yearend event for the world's top eight players, and said he enjoyed the experience despite the early exit. "It was a great week,"

Berrettini said. "For sure being here wasn't a goal at the beginning of the year. . It's just crazy that it happened." After hitting 50 winners in

his three-set victory over Djokovic on Tuesday, Thiem finished with just 13 in this match.

"Of course I felt a little bit the two first matches, and then also it's a bit of a tricky situation to know that I'm already through," the Austrian said. "Of course I was still trying to win that match 100%, but also, in the same time, I knew in my head that I have to take care for Saturday, because obviously it's the way more important match there."
