Sabarimala case: larger Bench to decide role of courts in religion

Chandrachud and Nariman deliver a dissenting judgment

LEGAL CORRESPONDENT

A majority judgment delivered by a five-judge Bench led by Chief Justice of India (CJI) Ranjan Gogoi on Thursday kept a final decision on the Sabarimala review and writ petitions in abeyance till a larger Bench of seven judges delivers an "authoritative pronouncement" on the exact role a non-epistolary court can play in deciding whether a particular practice is essential or integral to a religion.

The review Bench, however, did not pass any interim order for stay of its September 28, 2018 judgment, which upheld the right of women aged between 10 and 50 to enter and worship at the temple in Kerala.

Chief Justice Gogoi, delivering the majority opinion along with Justices A.M. Khanwilkar and Indu Malhotra, framed a series of questions for the larger Bench.

These include whether a court can probe if a practice is essential to a religion or should the question be left to the respective religious head; should "essential reli-

⁺ Man faces life term for bomb hoax call

He tried to stop wife from flying abroad

SPECIAL CORRESPONDENT

The NIA has registered a case under the stringent Anti-Hijacking Act against a 28-yearold man who allegedly made a hoax call to the Delhi airport in August to stop his wife from leaving the country for work, claiming she was a suicide bomber.

This is the second such case to be investigated by the NIA under the Anti-Hijacking Act, 2016, that prescribes life imprisonment for making false calls of bomb threats.

The accused, Nasrudeen, hailing from Bihar's Sitamarhi and a resident of Chennai, was arrested from the Bawana Industrial area in Delhi for making the hoax call to the international airport.

On August 8, at 9 p.m., a call was received at the Delhi International Airport Limited's call centre in Gurugram that a woman named Zabina had reached the airport and could cause a blast on a Dubai or Saudi Arabia-bound flight. On investigation, it was found out to be a hoax and Nasrudeen was arrested the next day.

In June, a special NIA court in Ahmedabad sentenced a businessman to life term and imposed a fine of ₹5 crore for placing a hoax hijack note on a Jet Airways plane in October 2017. This was the first case in-

vestigated by the NIA under the Act after it came into force in 2017. The Act had replaced the 1982 Act

The businessman, Birju Kishore Salla, said he committed the crime to force let to shut its Delhi operation, which would eventually lead his girlfriend, who worked in the airline's Delhi office, to come to Mumbai.

ED arrests former Ranbaxy promoter

One more held in fund diversion case

The Enforcement Directorate (ED) on Thursday arrested former Ranbaxy promoter Malvinder Singh and the then chairman-cummanaging director of Religare Enterprises Limited (REL), Sunil Godhwani, in a money laundering case.

The two accused were in judicial custody after they were arrested last month along with three others by the Economic Offences Wing (EOW) of the Delhi police for alleged diversion of Religare Finvest Limited (RFL) funds and losses to the tune of ₹2,397 crore.

RFL is a subsidiary of REL. The ED's application for the custodial interrogation of Mr. Singh and Mr. Godhwani will be taken up by the court on Friday. The agency may also seek permission

The EOW registered the FIR in March on a complaint lodged by Manpreet Singh Suri of the RFL, alleging cheating and misappropriation. They were accused of putting RFL in a poor financial condition by disbursing loans to firms controlled by them and had no financial standing. The companies allegedly wilfully defaulted on repay-

India's requests for Facebook user data rising sharply

The social media company got 22,684 official queries for information, second only to the U.S., in 2019

The Indian government's requests for user data from Facebook increased nearly 37% in the first half of 2019, and at 22,684 queries, was the second highest globally, according to the Transparency Report of the US-based social networking

In comparison, Facebook received 16,580 requests in the January-June 2018 period and 20,805 requests during July-December that year. Of the 22,684 data requests, Facebook said it had produced some data in 54% requests for data in accordance with applicable

reviewed for legal sufficiency and we may reject or require greater specificity on requests that appear overly broad or vague," the company said.

Majority complied with Globally, it received 1,28,617 such requests from governments. Of these, Facebook produced some data for 73.6% of cases. The US government submitted the maximum number of 50,714 requests for details of 82,461 Facebook users/ accounts during the first half of the current year. The US was followed by India, whose 22,684 requests were

The report showed that during January-June 2019, Facebook had nearly 70 internet disruptions that affected its products in

about 17 countries. India topped the list with 40 disruptions. However, as far as total

duration of disruptions was concerned, India came in at number two with eight weeks, 2 days and 22 hours. During the period

reviewed, the social media giant also restricted access to 1,233 items of content, including 1,211 posts, two profiles, 19 pages and groups and one comment. "We permanently restricted access to content in India in response to legal requests from law enforcement agencies, court orders, and the Ministry of Electronics and Information Technology," the company said.

JNUSU distances itself from defacement row

Students say it's an attempt to malign movement against fee hike

The walls inside the JNU administration block building leading up to the Vice-Chancellor's office, the door of the office and the pedestal of a yet to be unveiled statue of Swami Vivekananda were allegedly defaced by protesters during the ongoing agitation against fee hike on the university campus.

The JNU Students' Union on Thursday distanced itself from the defacement controversy and said it condemned the attempts to malign the students' movement through acts which do not represent it.

"Our movement against the fee hike and the imposition of a draft hostel manual without consultation is a democratic movement against authoritarian ways of administrative functioning. Students with their future at stake due to the fee hike can never be perpetrators of any violence or undemocratic action," the JNUSU said.

It added that the student community does not endorse any act of vandalism carried out in its name and whoever is involved is doing it in his or her own name and should not use the name of the movement to justify such acts. The JNUSU said the defacement was being

used as a tool to divert atten-

tion from real issues that stu-

dents were fighting for.

Members of the ABVP blamed "left-wing" students for defacing the pedestal and scribbling objectionable

messages, mostly directed towards right-wing outfits, on it. They said that it would derailing the movement to roll back fee hike. In an appeal, the JNUSU asked the student community to exercise restraint and not encourage recklessness.

The JNU administration has not yet indicated whether it would be taking any action against those involved in the defacement activities.

Reacting to the defacement row, JNU V-C M. Jagadesh Kumar tweeted: "Vandalising Swami Vivekananda statue at JNU admin block which is yet to be unveiled is the most despicable act one can commit. Swami Vivekananda is India's youth icon. Disrespecting him in our University by some miscreants is not at all acceptable."

Teachers from central universities protest NEP

Students, leaders join march against policy

Several students and teachers from various central universities here took out a rally under the banner of Federation of Central Universities Teachers' Association (FEDCUTA) from Mandi House to Parliament Street, demanding the withdrawal of the proposed New Education Policy (NEP).

"The NEP makes a mockery of public trust in higher education and research by removing all standards of quality and equity from public-funded institutions," the group said. Speakers at the rally, including leaders from political parties such as D. Raja (CPI), Dilip Pandey (AAP), Ashok Tanwar (Congress) and those from universities such as DUTA president Rajib Ray and former JNUSU president N. Balaji, attacked the government for the in-

creasing privatisation of higher education.

The protesters said, "The NEP limits regulation to an outcome-based approach, which would empower private bodies such as a board of governors to run universities on commercial lines, appoint teachers through fear or favour, denv democratic participation, hike students' fees at will." A precursor to the NEP can be seen in the "authoritarian fee hikes" that have prompted massive unrest among students in JNU and IITs, they added. Attacking the Union government, the FEDCUTA said it was trying to pull out of the responsibility of funding education and appointing regular faculty through this policy. It also argued that students from marginalised sections would be hit the hardest as it would make "quality education and research unaffordable."

JNU students continue to protest fee hike

JNUSU says it will not have any dialogue with the V-C on Twitter

Students of Jawaharlal Nehru University on Thursday continued their protest against fee hike by organising a sit-in at the administrative block. The protesters said they have rejected the decision taken at the "secret" Executive Council meeting offering a "partial rollback" of the fee hike and would continue their protest until the old rates are reinstated.

"It is clear that the current movement in JNU has become the vanguard of a larger movement nationwide, a movement for affordable education that sees education as a right instead of a commodity. The impetus gained by our movement has put the MHRD, which is sin-

gle-handedly responsible for cutting down the funds for higher education, on the defensive," said the JNU Students' Union.

It added: "Cruellest of jokes has been played by the MHRD and the admin in the name of special concessions for Below Poverty Line [BPL] students. The criteria of the government states that any household whose annual income is less than ₹27,000 per annum is enumerated as BPL. This makes the monthly income for a BPL household equal to or less than ₹2,250. However, the scheme proposed by the admin would make a monthly mess bill of a student from a BPL background approximately ₹4,108 for single seater and ₹3,958 for double seater. This would

make the annual hostel expenditure for a student from a BPL background ₹49,300 for single-seater and ₹47,500 for double seater."

The group said JNU's own data shows that since 2013. over 50% of the students are women, many of whom have been able to sustain their education against patriarchal norms because of the university's fee structure and fellowships. "With the new fee structure, all the students mentioned above will have to discontinue their education as the common fellowships MCM – ₹2,000 per month – and Non-Net – ₹5,000 per month - will prove to be inadequate," the JNUSU said, adding that it would not tolerate a dialogue with the V-C via Twitter and press releases.

MHA tells CIC it doesn't recognise any police force association

Home Ministry's submission challenges validity of IPS Association

The legality of the Indian Police Service (IPS) Association has suddenly come under a cloud as the Ministry of Home Affairs (MHA) has informed the Central Information Commission (CIC) that it does not "recognise or approve" any police force association.

A September 26 order of the CIC mentions the MHA's submission that it has "not recognised or approved any Police Force Association, thus, no information regarding Indian Police Service Association is available with them".

The RTI reply has stirred a debate in the police community as the IPS Association and other similar groups spear-

headed the social media campaign against alleged atrocities on police personnel after the clash with lawyers at the Tis Hazari Courts on November 2. To correct the anomaly, the MHA will soon file an affidavit before the CIC where it is expected to submit that the restrictions on forming unions, as per the Police-Forces (Restriction of Rights) Act, 1966, does not apply to All India Services officers, including the IPS. Section 3 of Police

Forces Act states that no member of the police force has the right to form any association without the express sanction of the Central Government.

RTI plea

The RTI plea was filed by Nutan Thakur in 2018, seeking details regarding IPS Association. "The Commission, after hearing the submissions of the respondents and perusing the records, observes that as per the respondent, since the MHA has not approved the constitution of a Police Force Association, the information sought for by the appellant is not available with the respondent. The Commission, therefore, directs the respondent to file an affidavit with the Commission deposing that MHA has not approved the constitution of a Police Force Association. Hence, no information can be provided to the appellant," the CIC order said.

A senior officer said that IPS officers are not appointed under any statute mentioned in the Police-Forces Act. "We are appointed under the All India Services Act, 1951. IPS is a civil service, not a police force. Else, it would have been India Police Force. Besides, it only acts as a platform for meeting of minds and representing service issues. It's on par with other service associations," he said.

Two directors of a firm get 3-year jail term in coal scam

A Delhi court on Thursday sentenced two directors of a private company to three years' imprisonment and imposed a fine of ₹40 lakh each in a coal block allocation case.

"The directors - Gyanchand Prasad Agarwal and Umesh Prasad Agarwal are sentenced to imprisonment for three years each and to also pay a fine of ₹40,00,000 each for the offences under Sections 420 IPC and 120B/420," said Special Judge Bharat Parashar. The company, Pawanjay Steel and Power Limited, has to give ₹75 lakh fine. The third accused in the case, S.K. Kanungo, was awarded two years imprisonment and fined ₹one lakh. A team of Anti Human Trafficking Unit, Crime Branch, Rohini, rescued 27 children from railway stations and ISBTs in the city between November 1 and 14, they said. Of the 27 children, 11 were

reunited with their families with the help of an NGO. Most of the children were from Bihar, Uttar Pradesh, Madhya Pradesh, Haryana and Maharashtra, while two of them had come from Nepal, said the police.

Each child had a different story to tell. Some had been abandoned while others had left their homes after a scolding from their family members. Most children had boarded a train without ticket and had reached different railway stations in

Additional Commissioner of Police (Crime Branch) B.K. Singh said, "We traced their parents after speaking to the children and checking police records. On Children's Day, their parents were called to Delhi and the children were reunited with them." The children were offered books, clothes and other gifts by the police.

Since January 1, the Crime Branch has rescued 617 children from bus stands and railway stations of Delhi under Operation 'MILAP', a Delhi Police initiative. Further, the Police Control Room unit has reunited 146 children with their families and rescued six kidnapped children between January 1 and November 13, said DCP (PCR) Sharat Kumar Sinha.

32-year-old convict in Rohini jail dies

Four men injured in fight Labourer dies after falling from second over parking in east Delhi

"Bharat had parked his car in front of his brother's shop. Amit had also parked his bike there. After shopping, Amit asked Bharat to move his car so he could take out his vehicle but Bharat re-

fused. An argument broke out between the two which soon turned violent and they thrashed each other," the officer said.

Bharat said the accused hit him and his brother with a helmet. Amit alleged that the Bharat and his brother beat him, his brother and mother. All the injured were then rushed to a hospital from where Bharat and his brother were referred to Lal Bahadur Shastri Hospital. A case under Section 308 (attempt to commit culpable homicide) of the IPC has been registered based on the complaint by Bharat. Another case under Sections 323 (causing hurt) and 341(punishment for wrongful restraint) have been registered based on Amit's complaint. No arrests have been made and probe is under way, the police added.

AQI remains in 'severe' category for second consecutive day

Air quality in the city continued to be in the 'severe' category for the second consecutive day, precipitated by dense clouds and stalled winds. Schools in the National Capital Region were shut, and government orders banning use of hot-mix plants and stone-crushers in Delhi-NCR continued to remain in force.

Meteorological agencies said that the overall air quality index in the city was at the "higher end of the severe category".

HC pulls up govt., civic bodies for deteriorating air quality

Court says authorities have not followed its orders

The High Court on Thursday pulled up the city government and civic bodies over the dangerous level of air pollution in the Capital, noting that the conditions would have been much better had they followed the court's orders.

A Bench of Justice G.S. Sistani and Justice Anup J. Bhambhani remarked that the problem lies in the implementation of the order and not because of a lack of ideas. It also noted that air pollution needed to be tackled as a collective responsibility.

Felling of trees

Senior Advocate Kailash Vasudev, who was appointed as amicus curiae in the case, referred to a report of the Comptroller and Auditor General (CAG) regarding the felling of trees to highlight that the Forest Department has not met the afforestation target.

He also attributed air pollution to construction activities and vehicular traffic.

The court then directed the Chief Conservator of Forests of Delhi government to appear before it on the next date of hearing. The Forest Department will have to ex-

plain its plan for increasing

the forest cover here. It also asked the authorities here to ensure that building materials or 'malba' are not left uncovered and using the water sprinkling process while removing them.

The court additionally asked the standing counsel of all departments to be present on the next date of hearing. The case was initiated by the High Court in February 2015 and since then it has passed a slew of directions to curb air pollution here.

The Supreme Court is also seized of a separate case on the issue of air pollution in the Capital. Earlier this week, it had directed the city government to furnish day-to-day Air Quality Index (AQI) data of Delhi.

BSES ties up with Australian company

Electricity discom BSES has tied up with an Australian company to set up a consumer-to-consumer solar power trading system based on blockchain technology, the firm said on Wednesday.

Change of land use for developing eco-parks gets green tick

The Delhi Development Authority (DDA) on Thursday approved modifications in the Master Plan for Delhi 2021 pertaining to household or service industries.

"The authority approved a proposal under which household industrial unit with maximum of nine workers and 11 KW power operating in residential areas and new industrial units will not need to take mandatory statutory clearances from labour and industries department or the Delhi Pollution Control Committee with the condition that no polluting in-

dustrial units will be permitted as a household industry," the urban body

Additionally, the proposal to change the mode of disposal of institutional category plots from leasehold to freehold basis was also approved. "Earlier stakeholders had to pay an additional charge of 2.5% annually on the land but this will cease to exist with the change in mode of disposal. However, this will be permitted as long as stakeholders don't change the purpose behind using the plots as institutional plots are meant for schools, colleges and so on," a DDA offi-

In a meeting chaired by Lieutenant Governor Anil Baijal, who is also the Chairman of the DDA, the change of land use for developing eco-parks was also approved.

"To make Delhi greener and pollution-free, the authority approved a final proposal to change the land use of 64.22 acres of land located in ash disposal area of Badarpur Thermal Power Plant, New Delhi from manufacturing to recreational," the land-owning agency said. It approved a proposal to modify existing policy guidelines for and shifting of petrol pumps and gas godowns currently existing on the DDA land.

Not just the humans, pets, especially dogs are also prone to diabetes and the clinics in Gurugram have witnessed a spurt in such cases over the past few years. Obesity and lack of awareness among pet owners are leading causes of the disease.

Though World Diabetes Day is observed on November 14, vets feel very little has been done to create awareness among owners about diabetes in pets.

Interestingly, like humans, male dogs are more affected by the disease compared to female dogs. The mean age for onset of diabetes in them

is 7-9, though it tends to

middle age - 5-12. Cats, on the other hand, are less at the risk and the

occur to older dogs in the

mean age for them is 10. Dogs are mostly affected by Type 2 diabetes caused due to the lack of insulin production, whereas cats have Type 1. The vets,

however, differ on the issue.

Spokesperson of DLF Phase-III-based CGS Hospital, Salisha Whitney Correi, said that a significant increase was witnessed in the number of cases of diabetes in dogs over the past few years, adding that obesity is one of the leading causes. Sudden onset of the symptoms accompanied by less awareness among owners is

also a reason. "We have



treated around 30 dogs and cats this year so far. In 2018,

the number of diabetic pets treated at our hospital was 20," said Dr. Correi, a veterinarian. Sandeep Yadav, Director, SKRD Veterinary Hospital, Sector 31, lamented that

Gurugram. He said only 1-2 % of pet parents knew that diabetes was common in dogs and were surprised when they were told the same. In the last seven years, Dr. Yadav has seen 25-35 diabetic pets and the number awareness on the disease was is increasing. poor among pet owners even

should take their pets for routine blood check-ups and annual full body check-ups to prevent the disorder. Canine diabetes was a chronic disease and could be managed with the help of advise of vets, added Dr. Yadav. Samoyeds, Miniature

Schnauzers, Toy Poodles, Pugs, German Shepherd, Golden Retrievers and Labradors are among the breeds, which are at risk.

Polyuria (frequent urination), polydipsia (frequent water intake), polyphagia (frequent food intake), weight loss, lethargy, bulging of eyes and ants coming on the urine are some of the common symptoms of diabetes in

pets. In a few cases, urination is painful and the pets start licking their genitals.

Canine diabetes is generally treated with insulin injections. Dogs need to be admitted for a few days to monitor insulin dose and blood glucose levels

Diabetic cataract is a common complication seen in canines with uncontrolled blood sugar levels. "Some dogs suddenly start banging into objects driven by diabetic cataract. We are the first private veterinary hospital to set up a dedicated Veterinary Ophthalmology Unit in India. We have all the latest veterinary-specific, high-end ocular machines," claimed Dr. Correi.

NGT panel to hold meet on solid waste management

Following orders of the National Green Tribunal (NGT), the first meeting of an NGT-appointed committee on municipal solid waste management will be

held on November 19. The committee comprises representatives from the NITI Aayog, Ministry of Urban and Housing Affairs, Ministry of Jal Shakti, National Mission for Clean Ganga, Ministry of Environment, Forests and Climate Change and the chairman of the Central Pollution Control Board (CPCB).

Earlier, the green panel had observed that according to data provided by the CPCB, there are more than 4,000 legacy waste

dump sites across the country that require remediation under the relevant solid waste management rules.

"Besides, this will unlock the land occupied by such waste sites which is urgently required for setting up integrated waste management and processing facilities or for afforestation, green belts, biodiversity parks and buffer zones in accordance with the environmental laws," a Bench headed by NGT Chairperson Justice Adarsh Kumar Goel had observed.

The Bench had also added, "If necessary, a part of the land could be monetised is so decided by the state governments concerned.

Khattar Ministry takes shape

Governor administers oath of office to 10 Ministers: 8 from BJP and one from JJP

Eighteen days after the BJP and the Jannayak Janta Party (JJP) formed a government in Harvana with Manohar Lal Khattar as Chief Minister, Governor Satyadev Narayan Arya on Thursday administered the oath of office and secrecy to 10 Ministers. Six of them are of the Cabinet rank and four Ministers of State

Eight of them are from the BJP, one is from the JJP and one is an Independent. The sole woman Minister belongs to the BJP.

Five of the six Cabinet Ministers are from the BJP. They are six-time MLA Anil Vij; former Speaker Kanwar Pal Gujjar, who belongs to

the Other Backward Class; Banwari Lal, the BJP's Dalit face; Mool Chand Sharma, a Brahmin and two-time MLA; and Jai Parkash Dalal, a Jat and a first-time MLA. The Independent MLA from Rania Ranjit Singh was also given a Cabinet berth.

Ministers of State with independent charge are Om Parkash Yadav of the BJP, who is an MLA from Narnaul; Ms. Kamlesh Dhanda, the BJP MLA from Kalayat; Anoop Dhanak, the JJP MLA from Uklana; and Sandeep Singh, the former Indian hockey team captain and BJP MLA from Pehowa.

The Cabinet can have 14 members, including the Chief Minister and the Deputv Chief Minister.

Later in the day, the Chief Minister recommended to the Governor the allocation of portfolios. Mr. Vij will look after Home and Health and Mr. Pal will handle Education and Forest. Mr. Sharma has been given Transport and Mines. Mr. Ranjit Singh will handle Power, Mr. Dalal Agriculture and Mr. Lal Cooperation.

Mr. Khattar was sworn in

on October 27 as the Chief Minister for the second time. Dushyant Chautala of the Jannayak Janta Party took the oath as Deputy Chief Minister. However, no Ministers were sworn in that day. Governor allocated eleven portfolios on November 13.

As per a notification, the Deputy Chief Minister has been given excise and taxation, industries and commerce, revenue and disaster management, public works, development and panchayats, food, civil suppliesconsumer affairs, labour and employment, civil aviation, archaeology and museums, rehabilitation and consolida-

Compensation plan may not fetch desired results: experts

Punjab govt. to pay ₹2,500 per acre to stop stubble burning

VIKAS VASUDEVA

While the Punjab government has decided to pay ₹2,500 per acre as compensation to small and marginal farmers, who have not burnt paddy residue in the ongoing harvesting season, farmers' unions and agriculture experts feel that the move may not fetch the desired results.

"The government's decision would only have a limited benefit... They have announced compensation to farmers who own land up to five acres, but what about others? If any farmer has even a little over five acre then compensation will not be given, what's the point of putting conditions? The government should compensate every farmer otherwise the desired result will not be achieved," said Harinder Singh, general secretary of the Bharti Kisan Union (Lakhowal).

Mr. Singh said FIRs registered against farmers for defying the ban on stubble burning should also be immediately withdrawn.

The government data

shows that between October 1 and November 13, as many as 48,689 cases of farm fires were reported in Punjab. Last year, during the same period there were 44,845 such incidents.

Sangrur district has seen the highest number of farm fire incidents at 6,558, while Bathinda with 5,522 is in the second spot. Firozpur recorded as many as 4,537 cases to be placed third on the list, according to the Punjab Pollution Control Board.

Stubble burning, close to the autumn season every year, has been a key contributing factor to air pollution across the northern region, including Delhi.

For management of paddy straw, the Centre and the State government are providing subsidised agro-machines and equipment to farmers and cooperative societies to achieve zero burning, yet farmers continue to burn the crop residue claiming lack of alternatives.

'Not a lasting solution'

Lakhwinder Singh, professor of Economics at Punjabi University, Patiala, who has been mapping rural Punjab for decades, also feels that the State government's decision to pay compensation is not a long-lasting solution to the problem.

compensation "The amount is good but it's not a permanent solution. Let's say even if all farmers are given compensation and they don't burn the residue... They collect it then what next? What will they do? How will they dispose it? The solution lies in alternative uses of residue for which the State government needs to infuse investment," said Mr. Singh.

'Top priority to curbing crimes against women'

Sarpanch's husband held for officer's death

Odisha Minister of State Dibya Shankar Mishra on Thursday told the Assembly that the government accords highest priority to curbing crimes against women and it was committed to ensuring a safe working environment for women of the State.

Replying to an adjournment motion moved by the Opposition Congress on the issue of safety and security of women in the wake of the death of panchayat executive officer Smitarani Biswal in Jajpur district, Mr. Mishra informed the House that the post-mortem report conclud-

ed that "the cause of death of Ms. Biswal was due to asphyxia and may be suicidal in nature".

Mr. Mishra further said that as the investigation suggested the involvement of Rupesh Bhadra, husband of the local sarpanch, in abetting the suicide of Ms. Biswal on October 16, he was arrested on October 19 and is now in jail.

Govt. report recommends ₹2,904 crore compensation for Marathwada farmers

A compensation of 2,904.36 crore needs to be paid to farmers in Marathwada region for the crop loss caused by unseasonal rains, a government report has

The report prepared by Aurangabad divisional commissioner's office said unsearains affected 44,33,549 farmers, ruining crops over 41,49,175 hectares in eight districts.

The report, based on a survey conducted by the revenue department, was submitted to the State administration on Wednesday, said deputy divisional commissioner Parag Soman.

The State is currently under President's rule. The perennially droughtstricken region of Marathwada received poor rainfall this monsoon, but was pounded by heavy showers in October, destroying standing kharif crops.

"We require ₹2,904.36 crore to compensate farmers in the region," Mr. Soman

"In majority of cases, ready crops were damaged in the fields before they could be harvested," he added.

Nanded, Beed and Aurangabad districts were the worst hit, and require over ₹400 crore each in compensation, he said.

While unirrigated lands dependent solely on rain will get compensation at the rate of ₹6,800 per hectare, irrigated lands will receive ₹13,000 per hectare and orchards ₹18,000 per hectare,

A total of 50,20,591 hectares of land had come under cultivation in the region this monsoon, the report

The government had recently approved ₹10,000 crore as immediate assistance to farmers affected by unseasonal showers. Meanwhile, Nationalist

GoAir flight veers off runway, DGCA probing

Flight from Nagpur was diverted to Hyderabad due to bad weather

The Directorate General of Civil Aviation (DGCA) said on Thursday that it was probing how an Airbus A320 Neo aircraft with 180 passengers went off the runway onto the unpaved area travelling 200 meters over grass, while carrying out a last minute goaround, in Bengaluru airport on November 11.

The GoAir flight from Nagpur was diverted to Hyderabad following a sudden change in weather conditions, as it was making a scheduled landing in Benga-

luru. Upon landing in Hyderabad, officials noticed mud and grass deposits on the main landing gear. An inspection by officials of the regional DGCA office and Kempegowda International Airport, Bengaluru reported landing gear marks on the unpaved surface.

While the aircraft has been grounded for a detailed inspection, the pilot,

an expatriate, barred from flying for now and called to join the probe.

Senior DGCA officials said that the GoAir A320 Neo aircraft VT-WGR operating as flight G8-811 was cleared for approach for runway 09 at Bengaluru around 7.15 a.m. on November 11.

After landing at Hyderabad mud deposits were observed on left main landing gear, indicating that aircraft rolled on to soft ground/ unpaved surface. "As per the officials, the aircraft deviated to its left during go around at Bengaluru. Aircraft has been grounded for detailed investigation at Hyderabad. Digital Flight Data Recorder (DFDR) data along with other recorder data is being analysed for further investigation," DGCA officials said.

No stay on 2018 order on Sabarimala: Trupti

'We urge Kerala government to ensure that police escort women right inside the temple'

Gender rights activist and Bhumata Brigade leader Trupti Desai on Thursday welcomed the Supreme Court's decision to refer review petitions to a larger bench against its verdict last year removing the ban on women aged between 10 and 50 years to offer worship at Sabarimala in Kerala.

Even as the Kerala government sought more legal clarity on the SC's decision as to whether the apex court had maintained status quo on its 2018 verdict, Ms. Desai, known in Maharashtra for her 'temple-entry' agitations, interpreted that the Supreme Court's verdict of last year to allow women of all age groups to worship at Saremained operational.

She said she was planning to visit Sabarimala in the next few days and added that

mere police protection by the Kerala government was insufficient to ensure that women could worship at the

Ayyapa shrine in peace. "The judges today have referred the Sabarimala case to a larger Supreme Court Bench of seven judges by saying that Sabarimala was only part of a larger issue which included the question of entry of Muslim women in mosques and Parsi women in their fire temples...While we were expecting a final decision on Sabarimala today, we

are nevertheless happy that the judges have not stayed the order," Ms. Desai told *The* Hindu.

"We urge the Kerala government to ensure that police escort women right inside the temple, near the sanctum sanctorum... While my date of visit has yet to be finalised, I, along with other Bhumata Brigade members, will be visiting the shrine sometime on or immediately after November 17," she said.

On 28 September 2018, the apex court had ended an age-old practice of keeping out women in their menstruating age from the temple by calling the practice as "discriminatory". In November last year, Ms. Desai had made an ineffectual attempt at entering the temple despite the SC lifting the ban.

Her announcement of visiting the Sabarimala temple was followed by a barrage of death threats.

At the time, Ms. Desai had written to Kerala Chief Minister and the Kerala Director General of Police (DGP) demanding police protection for herself and six other women activists from her outfit, while accusing functionaries of the Rashtriya Swayamsevak Sangh (RSS), the Bharatiya Janata Party, the Congress and devotees of Lord Ayyappa of bombarding her with graphic threats if she tried to

enter the temple complex. Ms. Desai's highly publicised temple-entry 'crusades' over the past few years to demolish gender barriers at shrines across Maharashtra led to intransigent temple trustees opening the inner sanctum of the historic Shani Shingnapur Temple in Ahmednagar district to women in April 2016.

She had also mounted a campaign for entry of women in the core area of the Haii Ali dargah.



The Indian Army will deploy one battalion group comprising troops from the 19 Madras and BMP-II infantry combat vehicles from 7 Guards unit. The Indian Air

Force is deploying one C-130J super Hercules aircraft, Mi-17 transport helicopters and rapid action medical team.

The U.S. Task Force consists of U.S. Navy Ship German Town, a landing ship dock with integral landing craft air cushions and amphibious assault vehicles and specially trained troops from the U.S. III Marine Expeditionary Force. The joint force comprises marine mechanised rifle company, a marine logistics element and medical regulatory team.

Review and reference

An omnibus reconsideration by the SC of all issues of religious freedom was unnecessary

rdinarily, a reference to a seven-judge Bench for an authoritative pronouncement on the entire gamut of issues arising from Article 25 and 26 of the Constitution, which protect the religious freedoms of individuals and denominations, would have been welcome. However, the order of a Constitution Bench in making such a reference, while delivering the verdict on petitions seeking review of last year's judgment allowing women in the 10-50 age group to offer worship at the Sabarimala temple, is problematic. The order, passed by a narrow majority of three judges, with two dissenting, means that the review petition, as well as fresh writ petitions, on the issue will be kept pending until there is clarity on the nature of religious rights. The majority, headed by Chief Justice Ranjan Gogoi, held that the petitions against the 2018 verdict, which laid down that the practice of keeping women of ovulating age out of the shrine is discriminatory and violative of the right to equality, have revived the question whether an individual's right to worship can outweigh a religious group's right to manage the affairs of its religion. An issue resolved by a 4:1 majority is sought to be reconsidered by formulating fresh questions on the interplay between religious freedom and other fundamental rights, especially the right to equality.

The majority anticipates that similar basic questions on the conflict between individual freedom and constitutionally-protected religious beliefs may arise in other situations too. It cites pending petitions concerning the entry of women into a dargah, the entry of Parsi women married to non-Parsis into an agyari, and the practice of female genital mutilation among Dawoodi Bohras. It is shocking that the Bench includes the abhorrent practice of female genital mutilation in this genre. It is well-established that freedom of religion, under Article 25, is subject to public order, morality and health, and it may not be difficult for any court to test the validity of the practice against the restriction on grounds of a woman's health, and this may not require an exalted panel of seven judges. In keeping the petitions on Sabarimala pending further, the court has displayed a disquieting inability to stand by its previous transformative judgment. Further, it may lead to a repeat of the unsavoury incidents of last year when religious groups and political activists blocked and attacked women devotees. Justices Fali Nariman and D.Y. Chandrachud, in their dissent, rightly call out such transgressions against the rule of law and, while rejecting the need for review, want all authorities to remember their constitutional duty to work in aid of the Supreme Court and the law laid down by it. An omnibus reconsideration of all issues related to religious freedom was not the way out of the serious issues posed by the Sabarimala judgment.

Open, all the same

With the CJI under the RTI Act, there will be greater transparency by public authorities

The adage, "sunlight is the best disinfectant" is often used to delineate the need for disclosure of matters related to public interest through the Right to Information mechanism. The declaration of assets by ministers and legislators, besides electoral candidates, has gone a long way in shedding light on public authorities and provided the citizenry more relevant information about their representatives. Yet, judges of the Supreme Court had hitherto refused to share information on their personal assets, citing the express lack of public interest. The welcome ruling by a five-member Constitution Bench of the Supreme Court that the office of the Chief Justice of India is a "public authority" under the RTI Act, as much as the apex court itself, now enables the disclosure of information such as the judges' personal assets. The judgment's majority opinion, written by Justice Sanjiv Khanna, emphasised the need for transparency and accountability and that "disclosure is a facet of public interest". In concurring opinions, Justice D.Y. Chandrachud asserted that judicial independence was not secured by secrecy while Justice N.V. Ramana argued for the need of a proper calibration of transparency in light of the importance of judicial independence. The Bench unanimously argued that the right to know under the RTI Act was not absolute and this had to be balanced with the right of privacy of judges. But the key takeaway from the judgment is that disclosure of details of serving judges' personal assets was not a violation of their right to privacy.

The main opinion also argued that information related to issues such as judicial appointments will also be subject to the test of public interest and procedures mandated in the RTI Act that specify that views of third parties (in this case, judges) must be sought. While laying out the importance of the assessment of public interest in any RTI query besides bringing the office of the CJI under the purview of the Act, the decision has gone on to uphold the Delhi High Court verdict in 2010. The RTI Act is a strong weapon that enhances accountability, citizen activism and, consequently, participative democracy, even if its implementation has come under strain in recent years due mainly to the Central government's apathy and disregard for the nuts and bolts of the Act. Yet, despite this, the Supreme Court judgment paves the way for greater transparency and could now impinge upon issues such as disclosure, under the RTI Act, by other institutions such as registered political parties. This is vital as political party financing is a murky area today, marked by opacity and exacerbated by the issue of electoral bonds, precluding citizens from being fully informed on sources of party incomes.

Peace bought by an unequal compromise

We must be wary of verdicts that align cleanly with what appears to be the dominant public sentiment at a given time

The Supreme Court's Ayodhya Bench had a difficult task. The case before it was a property dispute: who had title to those 2.77 acres of land in Ayodhya? But embedded within it was an act of political and religious violence: the destruction of the Babri Masjid. The Court faced an agonising choice. It could have decided the case as a property dispute, leaving the events of 1992 to be adjudicated on other forums (where they still linger). Or, it could have acknowledged that property rights had become inseparable from the question of justice. Instead, the Court tried to do both. The result is a judgment that falls short both on law and justice.

Civil disputes in India are decided on "a preponderance of probabilities." A court weighs the available evidence and determines which of the competing claims is more likely to be true. The Ayodhya judgment applies this standard. But the Supreme Court's conclusion that the balance of probabilities was tilted in favour of the Hindu parties, despite the vast swathes of both documentary and testamentary proof that it cites, is almost glib.

Departure from 2010 verdict

The inference turns on a surprising departure from the Allahabad High Court's ruling in 2010, which had split the land into three portions. The Supreme Court, instead, designates the disputed property as a single, composite

unit. This finding allows it to use evidence of the exclusive use of the outer courtyard by the Hindus in determining the probability of the possession of the entire property. While the Court recognises that prayers were offered by Muslims between 1857 – after the annexation of Oudh by the British and 1949, it takes the view that this fact is not sufficient proof of exclusive possession of the inner courtvard. This, the Court holds, is because the Hindus, in continuing to worship in the outer courtvard through their behaviour (such as offerings made to the 'Garbh Griha' while standing on the railing between the courtyards) had exhibited a belief that Lord Ram's birthplace was within the precincts of the central dome. Therefore, that the Muslims showed no interest in the outer courtyard was effectively held against them, although they consistently treated the inner courtyard as a mosque. Given that the property was categorised as an indivisible whole, this meant that the Hindus were exempted from the need to demonstrate possessory rights over the inner courtyard, beyond an exhibition of interest. Thus, although the nub of the dispute concerned the inner courtyard, eventually it was the Hindus' exclusive possession of the outer courtyard that tipped the balance.

The court notes that events subsequent to the annexation of Oudh in 1856 "form the continued basis" through which the parties have claimed their respective legal rights. But having done so, it, inexplicably, while recognising that the dispossession of the Muslims in 1949 (when Hindu idols were installed in the inner courtvard) was an act of desecration, fails to hold this against the claim made by the Hindus over the property. After all, it was this action that deprived



the Muslims in many ways of their ability to establish a more entrenched possessory right over the inner courtyard. Having concluded that the possessory rights of the Hindus over the disputed site stood on a better footing, the court nonetheless thought it fit to recompense the Muslims for the mosque's desecration in 1949 and its ultimate destruction in 1992 by ordering an allotment of five acres of alternate land in Ayodhya to the Sunni Central Waqf Board. It is here that the questions of law and the question of justice become entangled once again. And it is that entanglement that underlies much of the praise that the legal community has showered upon the judgment. Legal scholar Upendra Baxi called it a "miracle" of "complete justice." Justice (Retd.) Santosh Hegde said the judgment "is in the larger interest of the nation and peace in society." Encomiums such as this – focussing not on legal analysis but on 'statesmanship' have come thick and fast.

But it is important to take a step back and ask: what does this really mean? There are two possible ways in which, despite the law, the Supreme Court's judgment may be defended for its 'statesmanship.' One may argue that the court used its powers under Article 142 of the Constitution to deliver "complete justice", without being shackled by the chains of civil law. Or, one may claim that the court acted "pragmatically" to bring about

manner that would allow the country to move on. The first justification is flawed. Basic principles of restitution demand that parties be restored to their original positions, where possible. If the court believed that the Muslims had been wronged in 1949 and 1992, it could quite easily have ordered a reinstitution of the status quo that prevailed before those events. As it stands, the court's direction has an air of condescension to it – not iustice.

Favouring the strong But it is the second justification one that hails the judgment as an exercise of "pragmatism" in order to ensure peace - that is disturbing. There is a crucial distinction between resolving a dispute on the basis of principle, and achieving "peace" simply by endorsing the existing balance of power – or by not provoking the strong. The Greek historian Thucydides recalled how the conquering Athenians told the rulers of Melos: "right... is only in question between equals in power, while the strong do what they can and the weak suffer what they must." The rule of law exists to save society from such a permanent state of matsya nyaya, and the judiciary exists to enforce that rule of law. And it is the commitment to the rule of law that defines the distinction between a just peace, and peace bought by an unequal compromise.

There is another important reason why such considerations should play no part in judicial rulings. And that is that judges – like the rest of us – are neither savants nor seers. The consequences of judgments, in the medium and long-term future, are impossible to predict. Perhaps peace will last; but perhaps, as experience tells

closure to a festering dispute in a us, wounds that are papered over only fester further. Therefore, we must be particularly wary of verdicts that align cleanly with what appears to be the dominant public sentiment at a given time, on the apparent basis that the strict application of law and justice must give way, temporarily, to the interests of peace; because history tells us that the "temporary" can slip all too easily into the permanent.

> It was reported that at a recent gathering, one of the judges of the Supreme Court, highlighting the unanimity of the decision, compared it with the famous U.S. Supreme Court verdict in Brown v Board of Education, which ordered American schools to be desegregated. Unanimity aside, Brown v Board of Education is, however, a case that is defined by the opposite logic. In Brown, the U.S. Supreme Court went against the dominant opinion, which was strongly in favour of keeping black and white schoolchildren "separate but equal." The Court went against it because, quite simply, it was the right thing to do. The status quo was disrupted. There were demonstrations and protests. But under immense pressure, the Court held firm. And the schools were desegregated.

In Ayodhya, on the other hand, the final verdict appears to strike an uneasy detente with a pernicious political ideology that resists substantive justice, reparations for past wrongs, and mutual tolerance. What else is the final relief of giving the Muslim parties some land at another site to make it up to them for the destruction of the mosque – but only another way of telling them, "you are equal, but must be separate"?

The minority factor in Sri Lankan election

In 2010 and 2015, the minorities voted en bloc in favour of Mahinda Rajapaksa's principal rivals

ri Lanka's November 16 presidential election is being keen-Usly watched by the international community for more than one reason. One of the factors attracting curiosity from within and outside the country is which way ethnic minorities will vote this time. This is the third presidential election in the country since the end of the civil war in 2009.

On the previous two occasions (2010 and 2015), the minorities -Sri Lankan Tamils, Hill-country Tamils and Muslims - voted en bloc in favour of the principal rivals of Mahinda Rajapaksa. The six electoral districts known for predominant or dominant presence of the minorities went against him. This uniform mandate was remarkable, despite the three groups being heterogeneous and having, at times, an uneasy relationship among themselves.

In 2010, the former President, who sought a second term and won the election by a huge margin of around 18.43 lakh votes, secured around five lakh votes from these districts. His immediate rival and former Commander of the Sri Lanka Army, Sarath Fonseka, polled nearly 7.5 lakh votes. As per the final result, the former got 60.16 lakh votes nationwide and the latter, 41.73 lakh.

Sirisena's margin

However, five years later, Mr. Rajapaksa suffered a stunning defeat at the hands of Maithripala Sirisena. The six districts made a huge difference to the eventual outcome, as Mr. Sirisena walked away with about 12.5 lakh votes of around 17.57 lakh valid votes. This made a critical contribution to Mr. Sirisena's eventual margin of victory of around 4.49 lakh votes.

The six districts in question, accounting for about 16% of the country's electorate, include two in the Northern Province – Jaffna and Vanni; three in the East - Batticaloa, Ampara (also known as Digamadulla) and Trincomalee; and one in the Central Province, Nuwara Eliya.

The voting pattern that the six districts witnessed in 2010 and 2015 was, in a sense, a repeat of the 2005 situation, when Ranil Wickremesinghe got about 6.95 lakh votes and Mr. Rajapaksa received 3.26 lakh votes. In the final nationwide count, the latter outsmarted the former by a narrow margin of 1.75 lakh votes. But, an important aspect of the 2005 election was the declaration by the Liberation Tigers of Tamil Eelam (LTTE) of "absence of interest" in



the presidential election, the impact of which was felt more in Jaffna than in other districts. In Jaffna, the turnout was a mere 1.2% whereas it ranged from 34.3% in Vanni to 72.7%. in Ampara. The "boycott" call, according to many observers, had determined the end result of the 2005 presidential election. Otherwise, voters in the Tamil-speaking areas, especially Jaffna, would have become the "kingmakers" by voting en bloc for Mr. Wickremesinghe.

Statistically speaking, Mr. Wickremesinghe's victory was a possibility in 2005. But the participation of Jaffna voters had always been subdued between 1988 and 2005. The primary reason for this could have been the LTTE factor. It was open knowledge that the Tamil rebels had no "great faith" in the Sinhalese political class or its system. Another reason is that a considerable section of the regis-

tered voters were living in other countries as Sri Lanka allows dual citizenship. Even in 2015, when the popular mood among the minorities was to vote out Mr. Rajapaksa, the turnout in Jaffna was 66.28%, whereas the figure ranged from about 71% in Batticaloa to around 81% in Nuwara Eliya.

The presence of candidates is a crucial factor that decides voters' participation. In the present election, there are 35 candidates, the prominent among them being Sri Podujana Peramuna (SLPP)'s Gotabaya Rajapaksa, United National Party (UNP)'s Sajith Premadasa, Janatha Vimukthi Peramuna (JVP)'s Anura Kumar Dissanayake and former Army Chief, Mahesh Senanayake. However, the race is between Mr. Gotabaya and Mr. Premadasa.

More support for Premadasa

Both the main candidates have been able to secure support from political parties representing the minorities, even though Mr. Premadasa appears to be enjoying the support of the stronger parties. At the same time, at the all-island level. Mr. Premadasa's position is not similar to that of Mr. Sirisena in 2015, who had been backed by the IVP too.

While Mr. Gotabaya, who served as Defence Secretary during his brother's presidency, has named his manifesto as "ten-fold policy framework for inclusive go-

vernance," he has to apportion the blame that falls on Mr. Rajapaksa, whose track record on devolution and human rights was, according to his critics, "dismal."

On the other hand, though Mr. Premadasa is backed by the Tamil National Alliance (TNA) and has talked about, in his manifesto, completing the process of constitutional reforms, there is a guestion mark over his specific position on devolution.

The anti-Muslim riots in Kandy in March 2018 and this year's Easter blasts are expected to have a bearing on minorities' psyche. Further, there are factors like the internal bickering within the ruling coalition and "lackadaisical performance" of the Sirisena-Wickremesinghe government on the economic front that may in-

Given the Rajapaksas' "reach out" programmes in the North and the possibility of the UNP candidate facing anti-incumbency, the SLPP nominee could net more votes than his brother in 2015. Regardless of this, Mr. Premadasa's victory prospects rest on his ability to exceed or even match the support enjoyed by Mr. Sirisena among the minorities in the six districts. Even a semblance of apathy among voters may only benefit the SLPP, a factor Mr. Premadasa should be aware of.

Transparency in SC The Supreme Court's verdict opening the office of Chief Justice to public scrutiny under the Right to Information Act (RTI) is historic (Front page, "Office of Chief Justice of India comes under RTI Act," Nov. 14). While the judiciary enjoys high public trust owing to its unflinching commitment to the rule of law, it has for long shied away from subjecting itself to public scrutiny. Concerns over the secrecy surrounding the present collegium system are genuine. While the executive has had no problems in disclosing the reasons for rejecting the collegium's recommendations, the Supreme Court's defence

has remained absent from

the public debate. The landmark ruling allows public to seek information on appointment and transfer of judges, but the reasons behind these recommendations could still be clouded in secrecy as decisions of the collegium are largely based on reports from the Intelligence Bureau (IB). However, what should not be forgotten here is the fact that a transition to the era of transparency hinges upon the actions of the Chief Justice who is the administrative head of the Supreme Court. Will the Kartarpur Corridor survive India-Pakistan hostilities?

PARLEY

The happiness could be overpowered by toxicity unless India-Pakistan relations improve

Over the past few days, thousands of pilgrims have visited the Kartarpur shrine through the special corridor built between India and Pakistan, which brought to reality a long-cherished dream of many Sikhs. After the celebration following the inauguration of the Kartarpur Corridor on November 9, many in the diplomatic and security establishment have expressed reservations about the project. In a conversation moderated by Suhasini Haidar, K.C. Singh and Ajai Sahni discuss the potential and the pitfalls of the India-Pakistan initiative. Edited excerpts:

The Kartarpur Corridor is a reality after seven decades. With Prime Ministers Narendra Modi and Imran Khan comparing the corridor to the Berlin Wall coming down, what are your thoughts?

K.C. Singh: This was always welcome – not just the Kartarpur Corridor, but also perhaps the idea that other religious corridors may be built between the two countries. I think there may not be too many other religious spots like this, just four kilometres from the border.

But let's not conflate two things: the demand for the Kartarpur Corridor with India-Pakistan relations. If India-Pakistan relations were on a positive trajectory, Kartarpur would have been a confidence-building measure. Incidentally, this was never a part of the India-Pakistan comprehensive dialogue structure. Now if it was a confidence-building measure, you could see it helping the relationship further. But since the relationship is sour, and made worse by the August 5th decision on Article 370 in Jammu and Kashmir, you are dealing with two separate processes: a relationship going south and this kind of an initiative sticking out like a sore thumb.

Ajai Sahni: I would agree, and add something. I believe both sides have entered into this Kartarpur arrangement for divergent, conflicting, and partisan political and domestic reasons. This is not a decision in good faith, to my mind. In 2017, a parliamentary committee had mulled ov-

er this idea, consulted widely with security and intelligence agencies, and come to the conclusion that however desirable, the Kartarpur Corridor was not advisable due to the situation on the ground. This was completely ignored.

Now, when you enter initiatives with the wrong motives, you can be fairly certain that no Berlin Walls are going to come down. This is not about India-Pakistan relations, but about Pakistan's leadership trying to address its own strategic, tactical objectives, and about our ruling party trying to secure some political advantages. When negotiations are in bad faith, outcomes cannot be positive.

Given that there were no other bilateral talks, isn't the fact that the Kartarpur talks went on for an entire year a miracle of sorts?

KC: Well, I think the question arises as to why Pakistan has gone ahead with the initiative despite the Balakot strikes, the Pakistan-bashing rhetoric during the elections this year, as well as dilution of Article 370.

In the past year, the Kartarpur Corridor seems to have been pushed by Pakistan's military, with General Qamar Javed Bajwa making the first move when he offered the project. Government officials have also said that this project has been completed with "military precision". Do you think Kartarpur is a military project for Pakistan?

AS: Absolutely. The basic objective

has been to give a fillip to the Khalistan [separatist] project. And this combines with efforts of the past 3-4 years of creating problems in Punjab through a terrorist proxy. AS: Marginally, yes. From what we have recorded, in the eight years preceding 2016, we saw no fatalities relating to activities from separatists in Punjab. Thereafter we have seen some. There is some limited uptick, but no major traction.

If the volumes are substantial, as I am sure they will be eventually, they [the Pakistani establishment] will set up systems to expose these people to diaspora elements. Are you saying that the government has allowed Pakistan to put issues of faith above national policy?

AS: Well, it is abundantly clear that they neglected issues relating to national security policy and the declared national policy on Pakistan. This [Kartarpur Corridor] contradicts what the practice was over the last 4-5 years. The diplomatic and political ecosystem towards Pakistan has been one of hostility and within that Kartarpur stands out not only as a positive exception but a contradiction.

Given all that, will the Kartarpur Corridor survive?

AS: I think it will be a perpetual hostage to a major terrorist event. And the moment something occurs, our political system will have to deal with the far greater disappointment of losing something we had gained as opposed to not having something the Sikh community desired. If Kartarpur is shut down now after having been opened up, the sense of loss will be far greater than not having access to Kartarpur for 72-73 years.

KC: Well, you saw the engagement and the message that Prime Minister Khan sent [with reference to Kashmir at the opening]. You also saw that the Indian Prime Minister could not go across, and asked Punjab Chief Minister Amarinder Singh to carry offerings and pay obeisance

on his behalf. So it cannot be seen in isolation to other problems. Those have become more toxic after the dilution of Article 370, and Mr. Khan said that, raising issues of human rights. So what can the corridor do by itself? It's a happy occasion which will be overpowered by the toxicity unless we can find a way to move the whole relationship forward. It can be a beginning, but cautiously so, and won't mean much unless the rest of the relationship goes forward.

Finally, many have said that Punjab bore the brunt of Partition. Can this engagement at least try and heal the wounds of the past?

KC: No, I think when Punjabis meet they always get along. They speak the same language, discuss the same culture, food is the same. The two Punjabs having better connectivity should be a natural outcome. After all, in the past, Punjab was land-locked but connected to Central Asia. During Maharaja Ranjit Singh's time, Lahore was connected by the Indus river, the Sutlej, and had riverine ties with the region. After Partition, all of that was delinked. So [Indian] Punjab has become completely land-locked and looks at the rest of India for goods and services and markets. There is no [cross-border] trade left, and so Amritsar, which was on a major trading route to Central Asia, is now completely land-locked, and the same goes for Pakistan's Puniab province too. They are losing their links to the booming economy of India, simply because of their fixation on Kashmir.

AS: We could always enumerate all the many advantages. There are economic and social advantages that would come from better relations between India and Pakistan. The difficulty is that politics always trumps economics. As long as you have this politics of hatred that is entrenched in Pakistan because of a certain religious doctrine, and that seems to be something that is increasingly being seeded in India as well, I don't think one can imagine a very dramatic transformation or a very positive people-to-people relationship between the people of Puniab on this side of the border and people on the other side at present.

Back from the brink

The nearly year-long measles outbreaks in the U.S. offer lessons for India

On October 3, 2019, the U.S. just about managed to retain its measles elimination status declared nearly 20 years ago. A month earlier, New York State declared the end of a measles outbreak, which began on October 1, 2018 and continued for almost a year, bringing the country very close to losing the status.

The last case of measles in New York State occurred on August 19 and completed 42 days (two incubation periods for measles) after the onset of rash. It ended just a couple of days before the duration of the outbreak could cross the one-year mark. This was crucial as a country loses the measles elimination status if a chain of transmission from a given outbreak is sustained for more than 12 months

An outbreak in New York City, which began on September 30, 2018, led to more than 600 confirmed cases. The outbreak in nearby Rockland County, New York, started the next day and led to more than 300 cases. While 29 other States in the U.S. reported outbreaks in the past year, these did not last long. The reason why they were both limited in size and short-lived was mainly because the vaccination coverage was high leading to high immunity protection in the population.

Reasons for outbreak

The nearly year-long transmission in New York highlights the possibility of a sustained spread of measles in small pockets of an under-immunised community even when vaccine coverage with two doses nationally is high. Inequities in vaccine coverage, or gaps in vaccine coverage between communities, age groups and geographic areas in countries with high coverage at the national level, provide a fertile ground for outbreaks and for prolonged spread in such under-immunised groups.

Gaps and disparities in vaccine coverage between communities was the reason why the two outbreaks among the children of New York lasted for almost a year. Vaccine coverage among children belonging to the ultra-Orthodox Jewish community was not high; measles vaccination

coverage in schools in the outbreak area was only 77%. In addition, there was also a delay in vaccination. The reason? Parents had refused to vaccinate their children fearing that the vaccine might cause autism. Low protection in children of this community meant that they ran a high risk of getting infected by unvaccinated people returning from countries with ongoing measles transmission.

While 1,249 cases of measles were laboratory-confirmed in 2019 from 22 outbreaks in 31 States, 75% of the cases were restricted to the Orthodox Jewish community in New York.

Problem in India

These details are important for India, which has a twin problem. The first is that it has huge pockets of under-immunised children. Second, the immunisation coverage with two doses at the national level is far below the World Health Organization level of 95% needed for protection and elimination. Intensified efforts to increase immunisation coverage in recent years have led to a sharp drop in the number of measles cases annually in India. Yet, in the October 2018-2019 period, India reported 71,834 cases, the third highest number in the world, according to the WHO.

While India intends to eliminate measles by 2020, the vaccination coverage has nowhere reached the 95% threshold for two doses. According to the June 2019 WHO and UNICEF estimate for national immunisation coverage, measles vaccine coverage in India in 2018 for the first dose was 90%. It was 80% for the second dose. But the reported coverage levels are "likely an overestimation", the report cautions, based on a coverage evaluation survey.

Protection offered by maternal antibodies last for only four-five months, while the first dose of measles immunisation is at nine-12 months of age. Thus there is a huge window during which infants are vulnerable to measles infection. Also, about 15% of children in India fail to develop immunity from the first dose of measles vaccine. Till such time older children are fully protected with two doses, infants will remain vulnerable.

It has been happening for more than a decade now. During this season, smoke from the fields of Haryana and Punjab, where farmers set fire to rice stubble, combines with Delhi's local sources of pollution to worsen the air quality. Research shows that the contribution of stubble burning to Delhi's pollution is, at worst, 25%-40%. The rest is contributed by local industries, vehicles, power plants, and construction dust generated in the National Capital Region. Yet stubble burning makes for high-decibel 'conflict' reporting: Delhi's Aam Aadmi Party government blames Punjab and Haryana for the mess, while the Bharatiya Janata Party-led government at the Centre blames the Delhi government for not doing enough. On our way back, some television reporters, who had been expecting visuals of burning fields, were disappointed. The skies were blue and there were no smoke plumes. Ergo, zero footage. Finally – and to

the annoyance of one of the Environment Ministry officials with us – we saw a dark cloud of smoke. We drove to the field. There we saw a man with a flaming torch setting fire to his rice field. "Who are you? Why are you doing this? Don't you know this is illegal?" He was met with an avalanche of questions from us and photographed. His field was suddenly on camera. "This is not my land. I'm just following my master's instructions," the man from Bihar said. At this point, an official

from the local pollution control board whispered to us that "it would be best to head back to the bus as things could turn violent". But within minutes came the 'master', a burly Sikh farmer, accompanied by burlier acolytes. The questions we had posed earlier came back to us: "Who are you? Why are you here? Oh, from Delhi!" What fol-

lowed was an instructive

half-hour. We were told that subsidised machines were available only to a few farmers. He explained the economics of farming, how the unavailability of labour made it hard for farmers to switch from burning fields to other methods of disposing stubble. Many farmers couldn't be convinced that it was possible for pollutants to travel hundreds of kilometres to Delhi while their own skies were blue. And how did people in Delhi know that pollutants from Punjab were affecting them and that Delhi itself was not the culprit?

That was three years ago when I hadn't yet understood how air quality sensors worked. I learnt about this because of my privilege of being a journalist — the job gives me access to authorities, scientists, and detailed explainers on the Internet. Paradoxically, knowledge is often least accessible to those who need it most.

Giri on Nehru varsity

The Jawaharlal Nehru University, described as "a living memorial" to Nehru and the principles he stood for, came into being today [November 14, New Delhi] with the President Mr. V.V. Giri formally opening it. Both the President in his inaugural speech and the Prime Minister, Mrs. Indira Gandhi, in her address to the university's first convocation underlined the importance of developing the university on "unique" lines to develop centres of advanced learning imbued with Nehru's spirit of nationalism, international approach, and his passion for science and technology. Mr. Giri said naming the university after Nehru "has indeed been fully justified as a grateful nation's humble tribute to the memory of a great leader who was in the vanguard of the freedom movement and who also gave it a sense of direction and a stable Government firmly rooted in democratic traditions." Mr. Nehru had an "abiding faith" in the great contribution which universities could make to national development, Mr. Giri told a large gathering of distinguished people from all walks of life who filled the vast auditorium of Vigyan Bhavan against the backdrop of a life-size portrait of Nehru in one of his most elegant and cheerful moods.

A HUNDRED YEARS AGO NOV. 15, 1919.

Death of Sir V.C. Desika Chariar. Kt.

It is with feelings of profound regret that we have to announce the death of Sir V. C. Desika Chariar, yesterday evening, at his residence 'Padma Vilas,' Mylapore. The end was quite sudden and unexpected, and it is believed it was due to heart failure. Sir V. C. Desika Chariar was a distinguished and prominent citizen of Madras being connected with a number of public institutions and was ever active in the promotion of objects of public utility. Born in the year 1861, he was educated at the Presidency College, took his B.L. Degree in 1886 and commenced practice as Vakil of the Madras High Court in the next year. He was an active member of the Corporation of Madras in 1896-1908, lecturer in the Law College in 1896-1900, Additional Member of the Legislative Council in 1904-1908 representing the Corporation of Madras and Fellow of the University of Madras. He took a keen interest in public movements and was associated with the Congress Sessions held in this city as an office-bearer before he became a Government servant.

SC dismisses pleas to review Rafale ruling

Justice K.M. Joseph, the third judge on the Bench, agreed with the conclusions arrived in the main opinion of the Bench but suggested that the CBI should take prior sanction and register an FIR in case it found any material in the former Ministers' complaint.

The court allowed the government's application for correction of certain factual portions of the December last judgment. The main opinion said these mistakes only pertained to the narration of facts and did not affect the rationale of the judgment.

The two judges said the December 2018 judgment merely misconstrued between "what has been and what was to be done". The verdict had misinterpreted facts on whether the government had shared the price details with the Comptroller and Auditor General (CAG).

Secondly, it had conveyed the notion that the CAG report on the Rafale purchase was already before Public Accounts Committee of Parliament, when it was not.

Thirdly, the government had claimed that a redacted portion of the report was placed before Parliament and was in public domain.

Pricing issue

The court rejected the allegations on the pricing of the jets. It said it was not the function of the court to determine the prices.

The court noted how the review petitioners claimed they had got more information from "sources" about the Rafale deal after the court decision in December. In March, the court, in an order, agreed to examine various documents published in The Hindu to decide the veracity of the allegations against the Rafale purchase.

"We decline to, once again, to embark on an elaborate exercise of analysing each clause, perusing what may be the different opinions, then taking a call whether a final decision should or should not have been taken in such technical matters," the court said.

Larger Bench to decide role of courts in religion

Once a Constitution Bench has laid down the law, both legislature and the executive, were bound to comply.

Instead of complying with the Supreme Court judgment, the country was witness to the "sad spectacle of unarmed women between the ages of 10 and 50 being thwarted in the exercise of their fundamental right of worship at the Sabarimala temple". Rahul renews demand for JPC investigation

Surjewala dares Centre to order probe

Former Congress chief Rahul Gandhi on Thursday said the separate opinion of Supreme Court judge Justice K.M. Joseph in the Rafale review case has opened a door for an investigation into the Rafale fighter aircraft deal, and reiterated his demand for instituting a joint parliamentary committee (JPC) to probe the pact.

At a separate press conference, Congress chief spokesperson Randeep Surjewala alleged that the BJP was trying to "mislead" the people and dared the government to carry out an open investigation.

Asked whether the party would stick to its chowkidar chor hain (the watchman is the thief) slogan, he replied in the affirmative. It would remain until a proper inves-

pects of the Rafale deal, he said. "Justice Joseph of the Supreme Court has opened a huge door into an investigation of the Rafale scam. An investigation must now begin in full earnest. At a press conference, Mr. Surjewala said the BJP should stop celebrating and focus on an investigation as the court decision had paved the way for a probe.

Rafale ruling has ended vilification exercise: MoD

'Court has upheld the govt. position'

The Supreme Court's dismissal of the Rafale review petitions has brought to a close "an exercise of vilification and casting doubts" on the defence acquisition process, the Ministry of Defence (MoD) said on Thursday.

"Today, the Supreme Court has categorically rejected the review petitions filed subsequently against the order on merits bringing to a close an exercise of vilification and casting doubts on the defence acquisition process which has an adverse impact on the morale of the security forces," the Ministry said in a statement. The apex court had given a clear verdict on December 14, 2018 on the petition seeking an inquiry into the procurement of 36 Rafale fighter aircraft, it noted.

The November 14 judgment had stated that the review petitions were without any merit and dismissed, the statement said.

The Ministry listed out several points of the judgment while putting emphasis on certain portions concerning various aspects of the deal. "On pricing, the court has upheld the position of the government that the price of the aircraft is lower than the previous deal...," it stated. In another instance, the statement said, the court had "rightly observed" the need for fighter aircraft and the delay in the procurement process.

whom politics is above national interest, must apologise to the nation," he said. Defence Minister Rajnath

Singh said the allegations of corruption were aimed at maligning the Prime Minister and demanded that the Congress apologise.

"The allegation of corruption in the Rafale deal was nothing but an attempt to malign the clean and honest image of Prime Minister Narendra Modi and his government. The people of India will not forgive the Congress for its slanderous campaign and calumny. The Congress should apologise for misleading the people," he said, while on a tour of Arunachal

He said the government had bought the Rafale jets in a transparent manner, keeping in mind the urgency for enhancing India's defence preparedness.

Hailing the court's order

as a victory for national security, Union Law Minister Ravi Shankar Prasad said, "It is the recognition of the honest decision-making process of the Narendra Modi government... *Jayete* [Truth alone prevails]. The Congress must apologise and Rahul Gandhi, in particular, must apologise to the country."

Mr. Prasad said, "People having a saga of corruption from the jeep scandal to Bofors to submarine to AgustaWestland - were undertaking a political programme masqueraded as the quest for justice. Raising false allegations over the Rafale deal was the lowest point of political discourse: he [Mr. Gandhi] stooped to the shameful extent of misquoting the Supreme Court deliberately."

The Bench, including Justices S.K. Kaul, R. Subhash Reddy, B.R. Gavai and Surya Kant, did not pass any interim orders.

NDA won't cross 25 in Jharkhand: R.P.N. Singh

Congress State in-charge stops short of predicting the number the party and its two allies will win

The BJP and its allies will not cross 25 seats in the Jharkhand Assembly election, R.P.N. Singh, Congress State in-charge, said on Thursday, a day after the last date for filing nomination for the first phase of polls. The BJP's pre-poll alliance

has nearly collapsed, with all its three allies - the Jharkhand Students Union, the Janata Dal(U) and the Lok Janshakti Party – deciding to go solo in the elections, giving the IMM-Congress-RID alliance a moral boost.

"People of India have started teaching the BJP a lesson for its arrogance. In Maharashtra, they spoke of a target of 220 seats and they

could get only105 seats. In Haryana, they spoke of 75plus, and they won only 41 there," Mr. Singh told The Hindu. According to the feedback from ground, the BJP and its allies will not be able to cross 25 seats in the State, he claimed.

Mr. Singh, however, stopped short of predicting the number of seats the Opposition alliance would win. The alliance will definitely form the government. I am not a psephologist to give a number," he said.

In the 2014 Assembly election, the BJP won 37 seats in the 82-member Assembly and got past the majority mark as a number of MLAs from other parties joined the

Verdict on women's right to enter Sabarimala final: Nariman

Two judges strike dissenting note to majority opinion

Justices Rohinton Nariman and D.Y. Chandrachud on Thursday lashed out at the "organised" violation of the Supreme Court's judgment in September 2018 that allowed women between the age of 10 and 50 to worship at the Sabarimala temple.

Justice Nariman, in a dissenting opinion on Thursday, said a judgment of the Constitution Bench was "openly flouted" when the nation had to witness the "sad spectacle of unarmed women between the ages of 10 and 50 being thwarted in the exercise of their fundamental right of worship".

"When the (legal) process is complete and a decision is pronounced, it is the decision of the Supreme Court and binds everyone. Compliance is not a matter of op-

tion," the judge said. Justice Nariman directed the Kerala government to give wide publicity to the dissenting opinion through the medium of television and newspapers and take steps to secure the confi-

dence of the people. The majority opinion led by Chief Justice Ranjan Gogoi and two other judges on the Bench, referring certain issues to a seven-judge Bench, however, superseded the opinion of Justices Nariman and Chandrachud.

Whoever flouts a Supreme Court judgment, be it the Prime Minister, Chief Minister or legislators, they would be violating their constitutional oath to uphold, preserve, and defend the Constitution, Justice Nariman observed.

"Once this is clearly understood and followed, the rule of law is established, and the shameful spectacle of political parties running after votes, or instigating or tolerating mob violence, in defiance of decrees or orders passed by the Supreme Court of India does not reign instead," Justice Nariman

Terrorism has caused a loss of \$1 trillion to the world economy and the atmosphere it created has indirectly and deeply harmed trade and business, Prime Minister Narendra Modi said at the BRICS Summit here on Thursday, as he welcomed increased cooperation from the members of the grouping.

Addressing the plenary

session of the 11th BRICS Summit at the iconic Itamaraty Palace in the presence of the Presidents of Brazil, China, Russia and South Africa, Mr. Modi said terrorism had emerged as the biggest threat to development, peace and prosperity. "According to some estimates, the economic growth of developing nations has decreased by 1.5% due to terrorism," he said, adding that the scourge had caused a loss of \$1 trillion to the world economy. In 10 years, terrorism had claimed the lives of 2.25 lakh people and des-

At a gathering on the occasion of the 130th birth anniversary of Jawaharlal Nehru, she said the past six years had seen "bigotry, injustice and mismanagement of the country".

"The forces unleashed by our present rulers want to dictate to us what we can do, say or think. Their idea of unity is uniformity. They disrespect and fear diversity, which means they deny our pluralism, our freedom of choice, which are integral to our fundamental rights," she said.
"Their language may be

modern, but they seek to take India backward, not forward. For after all, they made no sacrifices to shape India's destiny. It falls on each and every one of us to pull away this hypocrisy and reveal the darkness lurking beneath. We must unite and speak up against the bigotry, injustice and mismanagement of the last six years," she added. She said the four pillars of Nehruvian ideology - democratic institution-building, staunch secularism, socialist economics and a non-aligned foreign policy - were under attack.

Earlier, she offered floral tributes at Nehru's memorial at Shanti Van.

Review Taseer OCI decision, + says PEN letter

More than 260 writers, journalists and artists, including Margaret Atwood, Orhan Pamuk, Salman Rushdie, Chimamanda Adichie, Perumal Murugan and Amitav Ghosh, have written a letter to Prime Minister Narendra Modi, asking that the government review its decision to rescind writer Aatish Taseer's Overseas Citizenship of India (OCI) status.

"We are extremely concerned that Taseer appears to have been targeted for an extremely personal form of retaliation due to his writing and reporting that has been critical of the Indian government," says the letter from the authors who have joined PEN America, English PEN and PEN International, a network of writers, to express their "grave concern" over the government's action.

Official complaint

"In May 2019, amid a contentious Indian election season, Taseer wrote a cover story for *TIME* magazine headlined 'India's Divider in Chief', which drew an official complaint from the Indian government and sustained online harassment," the letter says.

The Home Ministry had revoked Mr. Taseer's OCI status last week, saying he had "concealed the fact that his late father was of Pakistani origin". Mr. Taseer, a British citizen and American permanent resident, has denied concealing this fact, and has days to hand in his OCI document to the Indian Consulate in New York or risk being barred from applying for an Indian visa again, *The Hindu* had reported.

"In his application for the OCI status, Taseer listed his father's name and never tried to hide his identity; in fact, a number of his books and articles have extensively covered his heritage and past," the letter says.

Clashes test interim leader of Bolivia

Jeanine Anez pledges to 'hold elections in the shortest possible time', receives support from the U.S.

Interim President Jeanine Anez moved on Thursday to consolidate power in a deeply polarised Bolivia, winning recognition from the U.S. and immediately shifting the country's foreign policy on erstwhile ally Venezuela.

Ms. Anez was expected to complete her government line-up, having named new military chiefs and half of her proposed 20-member Cabinet the night before.

In a press conference at the presidential palace on Wednesday, she reiterated a pledge to "hold elections in the shortest possible time."

Rejecting Mr. Morales's claims that her presidency amounted to a coup, she said: "There is no coup in Bolivia. There is a constitutional replacement."

The only coup d'Etat in this country has been by Evo Morales," she said, referring to a 2016 referendum that blocked the ex-President from running for re-election, but which Mr. Morales had overturned by the Constitu-

tional Court. Mr. Morales, who became the country's first indigenous President in 2006 and ruled for nearly 14 years, resigned on Sunday and fled Bolivia after losing the support of the Army and the police.

Normal business resumed in the main cities after weeks of deadly protests, but schools and universities remained shut due to the continued threat of demonstrations. Many gas stations remained closed because of

a lack of supplies. Nearly a month of protests have left 10 people dead and nearly 400 injured.

Mr. Morales's supporters launched fresh protests on Thursday, marching toward government headquarters in La Paz. Riot police had clashed with hundreds of Mr. Morales's supporters the night before during a demonstration against Ms. Anez. A 20-year-old man was shot and killed in a village

near the eastern city of Santa

Cruz during a clash between Mr. Morales's supporters and the police, a doctor said.

'Ready to return'

"If the people ask me, we are ready to return to pacify" Bolivia, Mr. Morales told a news conference in Mexico City on Wednesday. He called for a "national dialogue" to resolve the crisis, and rejected Ms. Anez's legitimacy.

Mr. Morales called the "coup" against him "a political and economic conspiracy coming from the United

Ms. Anez told reporters on Thursday that new Foreign Minister Karen Longari would "make representations" to Mexico to insist that Mr. Morales be held to the terms of his political asylum.

The 52-year-old interim leader gave the first indication of her government's foreign policy on Thursday, recognising Venezuelan Opposition leader Juan Guaido as his country's President, a key shift of alliance in the volatile region. The announcement removes one of Venezuelan President Nicolas Maduro's main allies as he fends off efforts to oust him amid a deadly economic and political crisis.

The U.S. on Wednesday recognised Ms. Anez as Bolivia's interim President. Secretary of State Mike Pompeo, in a statement, said the U.S. looked forward to working with Bolivia and its people "as they prepare to hold free, fair elections as soon as possible."

China on Thursday said eliminating tariffs was a "condition" for reaching a trade agreement with the United States, a demand U.S. President Donald Trump said earlier this month that he had rejected.

The Commerce Ministry's remarks showed that a sizeable distance still separates Washington and Beijing despite Mr. Trump's announcement last month that they had reached a "phase one" deal

Beijing and Washington have been embroiled in an 18-month trade war which has weighed on the global economy, and two sides have slapped punitive tariffs on hundreds of billions of dollars in two-way trade.

Amid signs of easing tensions, the Chinese Commerce Ministry last week said the two sides had agreed on a plan to roll back tariffs in stages - only to

to reach an agreement."

Mr. Trump last month held off on a round of tariff increases, and White House officials have suggested that as part of the current minideal he could delay fresh tariffs on \$160 billion worth of Chinese goods planned for mid-December.

Mr. Gao said the elimination of tariffs was "in line with the interests of producers and consumers, in line with the interests of China and the United States, and in line with world interests."

Separately, China's Customs administration on Thursday said that it was removing restrictions on U.S. poultry imports and "allowing U.S. poultry imports that abide by the requirements of our country's laws and regulations."

In Washington, the U.S. Trade Representative's office welcomed the decision, saying it should help drive annual US poultry exports above \$1 billion.

Italy declares state of emergency in Venice

Italy on Thursday declared a state of emergency in Venice after an exceptional tide surged through churches, shops and homes, causing millions of euros worth of damage to the UNESCO World Heritage site. Ceasefire takes hold after Gaza violence

34 Palestinians killed, say officials

A ceasefire between Israel and Palestinian militants in Gaza took hold on Thursday after two days of fighting triggered by an Israeli strike on an Islamic Jihad commander, with 34 Palestinians killed in exchanges of

Both Palestinian militant group Islamic Jihad and Israel's military confirmed the ceasefire early on Thursday brokered by Egyptian and UN officials- the usual mediators between Gaza and Israel.

Five rockets were fired at Israel from Gaza after the ceasefire came into effect and air defences intercepted two of them, the army said, but the incident did not appear likely to set off another severe round of fighting.

"#Egypt and the #UN worked hard to prevent the

most dangerous escalation in and around #Gaza from leading to #war," tweeted Nickolay Mladenov, UN envoy for the Israeli-Palestinian conflict, who travelled to Cairo for the talks. "The coming hours and

days will be critical. ALL must show maximum restraint and do their part to prevent bloodshed." The agreement, which

entered into force at 5.30 a.m., came after the death toll from Israeli air strikes rose to 34 since Tuesday. Islamic Jihad claimed a number of the dead as members.

Palestinian officials said eight members of the same family had been killed in an Israeli strike overnight, including five children.

Israel's military said the man killed in the strike in Deir al Balah in the central Gaza Strip was an Islamic Iihad rocket commander.

Xi wants an end to violence in Hong Kong

China's President Xi Jinping warned on Thursday that protests in Hong Kong threaten the "one country, two systems" principle governing the semi-autonomous city.

Hong Kong has been ruled by a unique system guaranteeing greater freedoms than on the mainland since its handover from British rule to China in 1997. But protests, which began against a nowshelved extradition Bill to China, have spiralled into wider calls for democracy and police accountability as violence and demonstrations roil the city.

In rare comments on the violence, Mr. Xi repeated Beijing's unwavering support for the Hong Kong government and the police, warning recent actions by protesters have "seriously challenged the baseline principle of 'one country,

two systems'."

Speaking at a summit in the Brazilian capital of Brasilia, he said "stopping violence and controlling chaos while restoring order is currently Hong Kong's most urgent task,' in comments reported Chinese across media.

Meanwhile, a 70-yearold man has died after he was hit by a brick during clashes between pro- and anti-government protesters, a hospital said.

Sri Lankan author stabbed ahead of poll

Lasantha Wijeratne's book, released last week, had criticised Gotabaya Rajapaksa

Armed men stabbed and injured a writer in Sri Lanka on Thursday, a week after he published a book criticising the main Opposition candidate at Saturday's presidential polls, the police said.

The attackers stormed the home of Lasantha Wijeratne, who released his book Wasteful Development and Corruption last week and gave a copy to ruling party candidate Sajith Premadasa.

"Four men broke into the house and stabbed him in the arm after holding a pistol to his wife's head," Mr. Wijer-

atne's lawyer Tharaka Nanayakkara told AFP by telephone. "They smashed furniture before escaping."

The police said they have tack," a spokesman for Mr. launched an investigation into the pre-dawn attack in Galle, 115 km south of Colombo, but no arrests had been made. Mr. Nanayakkara said the attackers accused Mr. Wijeratne of harming the campaign of Gotabaya Rajapaksa who is believed to be in a close race with Mr. Premadasa for the top job.

Rajapaksa's party said in a statement. "We are a disciplined party... we condemn this attack with contempt."


'Highly biased'



Purity of mind

From time immemorial, it has been acknowledged that the highest human achievement is the conquest of the mind. "He who has conquered his mind can easily conquer the world" say the wise. In simple terms, to conquer the mind means keeping it clean and free of impurities caused by sinful thoughts. He who strives to do this is sure to find success, and above all peace while dealing with day-to-day activities; and in addition, it pays rich dividends in his search for salvation as well, said Swami Mukundananda in a discourse.

In this context it is interesting to observe and analyse the staunch prevailing belief about the sacredness and the sanctifying power of the waters of the Ganga based on what the scriptures claim. The river is personified as a goddess and bathing in the Ganga is believed to purify and absolve people of sins. Pitted against this idea are also arguments that question the truth and validity of this belief. Does this mean that those who happen to live on the banks of the Ganga and have occasion to bathe in the waters daily are cleansed of their sins? Or is the fish that lives in the Ganga able to

achieve moksha by virtue of its association with the Ganga? To answer these, one has to understand the meaning of 'bathing' in the Ganga and the state of one's mind when bathing. It is not just washing the physical self to clean the external impurities. It is the awareness of the symbolic impurity such as sinful thoughts that reside in the individual's mind. One has to consciously empty the mind of these to attain purity. Otherwise his Ganga 'Snan' is like immersing a bottle of dirty water in the Ganga.

No matter how long it is immersed in water, if the dirty water does not come into contact with the Ganga, it continues to be dirty.
