# **Standing,** still funny

The world of comedy — stand-up comedy in particular — has seen plenty of ups and downs recently, but it is now looking at a revival. So we ask three popular comics to delineate the way forward, especially in comparison to the road already traversed.

Indian comedy has changed drastically over the decades — both in terms of content and its delivery across platforms. Several eras, each with its set of comedians, have come and gone, but one thing has remained constant: the importance of the genre in the enter-tainment industry.

Comedy in India has seen the same diversity as, well, the country itself. It has been the home ground for many rib-tickling geniuses such as Johnny Walker, Mehmood, Kader Khan and Johnny Lever. But stand-up comedy, however, has always taken a backseat on the larger screen.

Luckily, the past few years have witnessed the boom of stand-up comedy in India. "The Indian comedy scene is at a great point right now. It is growing very rapidly; every two years, the entire scene changes. Initially, we all were trying to do as many shows as possible — from Delhi to Mumbai to Bengaluru. Then few years later YouTube

came up and people started making sketches, and started making videos for it, and a year later after OTT platforms like Amazon Prime came on board, stand-up specials became a big thing," shares Sapan Verma, a well-known stand-up comedian. "In the last few years we have seen comedians becoming content creator,

"In the last few years we have seen comedians becoming content creator, just like I created *One Mic Stand*, Sumukhi Suresh created *Pushpavalli*, and now it has become a world where comedians are also doing non-standup things and creating comedy shows and fiction," Sapan added. The digital video revolution is still sweeping India and comedy shows are

The digital video revolution is still sweeping India and comedy shows are continuing to get lined up for the Indian market.

"When we see comedy in 2019 from a comedian's perspective, people are performing way more now. The quality of content is also improving. The kind of topics that we all are picking these days are from across styles and are exciting to watch from an audience's perspective. The number of people who are watching live comedy is obviously growing, we have audience coming from tier 2 and tier 3 cities also," adds Angad Singh Ranyal, another prominent stand-up comedian.

Most of the earlier comics relied heavily on slapstick or mimicry for their on-stage acts. One of the most popular talk shows of the '90s, Movers and Shakers, used to have stand-up comedy as a filler, not as the main attraction. But slowly, Hindi stand-up comedy found a platform — The Great Indian Laughter Challenge, for instance. Finally, there were stand-up comedians who looked like us and killed it on stage.

Kathmandu: India has released nearly \$28 million financial aid to the Nepal government for rebuilding houses in Nuwakot and Gorkha districts that were damaged in the devastating earthquake in 2015. Over 9,000 people died and nearly 22,000 were injured in the tremor that hit the landlocked country in April 2015. The Indian government on Thursday released 3.10 billion Nepali rupees (\$27.9 million) to Nepal from the concessional Line of Credit as part of reimbursement of the third tranche of financial aid to rebuild houses in Nuwakot and Gorkha districts, the Indian Embassy here said in a press release.



### **2 MORE HELD FOR KUSHINAGAR MOSQUE BLAST**

Lucknow/ Gorakhpur (UP), Nov. 15: Two more people were held in connection with the Kushinagar mosque blast case on Friday, taking the total number of arrests to six, a senior official said. Earlier in the day, four other accused were sent to police remand for 48 hours. A man identified as Haji Qutubuddin, who is associated with the mosque and was injured in the blast, was interrogated. Inspector General, Gorakhpur zone, Jai Narayan Singh said said. Qutubuddin's grandson – Ashfaq, who works in the army and was posted in Hyderabad too was called for questioning, he added. Both of them have been arrested. "Six persons including Qutubuddin and his grandson Ashfag have been arrested in the case. No terror link has been found so far. We are probing the matter," inspector-general, law and order, Praveen Kumar said in Lucknow. Earlier in the day, the other four accused — Maulana Azimuddin, Izhar, Ashiq Ansari and Javed Ansar were sent to police remand following their arrest on Tuesday, a day after the blast rocked the mosque in Bairagi Patti village in Turkpatti of Kushinagar district on Monday. - PTI

### SC call on Sabarimala is counterintuitive

he framers of the Indian Constitution picked the three ideals of the French Revolution — liberty, equality and fraternity — and put them on its preamble. They are unconditional and non-negotiable; all other freedoms, including the right to profess and practise reli-gion, have been put a notch below them. The courts have all along upheld that principle. The historic judgment by a Constitution Bench on the Sabarimala issue on September 28, 2018, was the latest to reiterate the primacy of equality, pronounced in Article 14 of the Constitution, and decreed that the idea of gender justice gets its protection. It also held that a ban imposed on women in the menstruating age from entering the hill shrine

was illegal and ultra vires of the Constitution. In the 70th year of the Constitution's coming into being, the Supreme Court of India has ordered a review of that long-held idea. In a majority 3-2 judgment, the bench headed by Chief Justice of India Ranjan Gogoi which heard a batch of review petitions on the 2018 judgment on Thursday ordered that a larger bench take up for discussion and bring in clarity on seven issues, the first one being "the interplay between the freedom of reli-gion under Articles 25 and 26 of the Constitution and other provisions in Part III, particularly Article 14". agitating the minds of a lot of people, espe-cially in South India, pending. Those who believe that young women's entry in the hill shrine will alter the character of the deity at Sabarimala rushed to the court to have its order reviewed, but got no conclusive ruling. Neither the majority nor the minority order stayed the 2018 order, nor overruled it. As per the majority verdict, there will be no decision on the review petitions until a larger bench decides on the seven questions. It would be unfair to them to keep the issue pending for long. The apex court must bring a closure to it at the earliest.

The minority judgment, however, opens a window for the state government as to how to approach the Supreme Court order. Justice Rohinton Nariman, who wrote the dissenting judgment and later on Friday reiterated that the original judgment sustains, has said the "government may have broad-based consultations with representatives of all affected interests so that the modalities devised for implementing the judgment of the court meet the genuine concerns of all segments of the community". The state government must act on it.

### Rafale verdict regrettable

t seems an absurdity that in its verdict Thursday dismissing the plea by three eminent persons — former Union ministers Yashwant Sinha and Arun Shourie, and senior advocate Prashant Bhushan — for a CBI inquiry into salient aspects of the Rafale fighter deal, the Supreme Court should repeat in substance what it said almost a year earlier, although it had more time to consider the material on record. Citizens would deem it galling that the regrettable judgment, which doesn't even make a pretence of heeding close arguments in a case of suspected governmental financial malfeasance, and discards them in cavalier fashion, should say: "The endeavour of the petitioners was to construe themselves as an appellate authority to determine each aspect of the Rafale purchase..."

The three-judge ruling was co-authored by outgoing Chief Justice Ranjan Gogoi and Justice S.K. Kaul. The CJI seems to have overlooked that on a cold January day, before his elevation, he had stood along with three other judges to question his predecessor's conduct. # Modi's diplomacy: Law of diminishing returns?

Jarendra Modi attending the 11th Brics summit in Brasilia, the Brazilian capital, on November 13-14 left most ordinary Indians foxed, and Delhi's residents irate over a silent and missing leader as they were asphyxiating under a cloud of smog. This group initially comprised four emerging economic powers — Brazil, China, India and Russia — as originally envisioned by Jim O'Neill of Goldman Sachs in 2001 as the four most likely to influence the geo-economics of the early 21st century. South Africa was added, mostly at China's insistence, in at China's insistence, in 2011, turning "Bric" into "Brics". However, in recent years, Jim O'Neill and others like S&P Global Ratings have noted that the group has lost relevance over the diverging long-term growth trajectories of its members. The latest summit has to be viewed against this background. India's external affairs minister Subrahmanyam Jaishankar, delivering the Ramnath Goenka Memorial Lecture in New Delhi as Mr Modi attended the summit, expounding on the Modi government's arch-realistic foreign policy of multi-alignment, said India sought to "fashion Brics into a major forum". But his remark ignores that the orientation and internal dynamics of the five members has not remained a constant since its founding. South Africa has still not recovered from the decade-long misrule of former President Jacob Zuma, which ended with his recall in early 2018. Its GDP growth slowed from 1.3 per cent in 2017 to an estimated 0.7 per cent in 2018. It is expected to rise to 1.5 per cent this year. Part of the problem has been the slowdown of the Chinese economy and the resultant effect on both South Africa and

Brazil as nations dependent on exporting com-modities. Brazil saw the jailing of former President Luiz Inacio Lula da Silva, whose socialistic politics and presidency (2003-2010) saw Brazil's active par-ticination in the graation ticipation in the creation and nursing of Brics. Brazil also joined India, Japan and Germany in another group called G-4 to seek reform of the UN Security Council and the inclusion of these four nations as permanent members. The election of Jair Bolsonaro, a former middle-level military officer, has swung Brazilian foreign policy and domestic discourse way to the right. US President Donald Trump is the role model for Mr Bolsonaro. He even talked of a mili-tary base for the United States, which ironically, in a nation which saw decades of military rule, was overruled by the Brazilian military. In a role reversal, the diplo-mats and the Brazilian military are trying to contain the over-enthusiasm of their President for seeking almost an alliance with the US. Inviting Mr Bolsonaro as chief guest at next year's Republic Day would not send a great signal to the other nations in Latin America that are wrestling with antidemocratic forces. Alberto Fernandez, the newly-elected Peronist President of Argentina, a nation that considers itself, besides Mexico, as Brazil's rival in South America, was not even congratulated by Mr

## **Rafale dogfight: Exoneration of process, not graft**



December 14 last year, the Supreme Court had ruled that there was no reason to the doubt decision-making process behind the Rafale fighter deal.

It has reaffirmed its position on November 14, 2019. The Supreme Court's order, however much the government may make it seem, does not mean exoneration from corruption. It relates to the process.

Even in terms of the process, there are some questions. For instance, the Acceptance of Necessity (AON) required to set off the acquisition process, was given after Prime Minister Narendra Modi, during an offi-cial visit to France in April 2015, announced that India would acquire 36 fully built Rafales citing a "critical opera-tional necessity". The Defence Acquisition Committee (DAC) meeting chaired by the defence minister to grant only held in May 2015. the Defence

higher per aircraft than Dassault's quote of 19.5 billion euros for 126 fighters — or 155 million euros per Rafale — that it submitted in response to an eventually aborted tender issued in 2007.

Now something about the next controversy on the "India-specific capabilities" built into these 36 Rafales. In the Air Staff Qualitative Requirements (ASQR) provid-ed by the IAF, there were 13 " I n d i a - S p e c i f i c Enhancements" demanded by India during the 126-aircraft MMRCA contract. These included radar enhancements, helmet-mounted display, towed decoy system, low-band

jammer and the ability to oper-ate from high-altitude airfields. That these were the same for the 36 Rafales ordered by Mr Modi is made clear by the joint statement of April 10, 2015 issued by French President Francois Hollande and Mr Modi, which reads '...that the aircraft and associated systems and weapons would be delivered on the same configuration as has been test-ed and approved by the Indian Air Force

The comparable costs of the 126 and 36 aircraft deals can only be assessed when all the costs are factored in. The cost of the new deal for 36 Rafale fighters is 3.42 billion euros as the cost of the bare planes; 1.8 billion euros for associated supplies for infrastructure and support; 1.7 billion euros for India-specific changes to the plane; and 353 million euros for 'performance-based logistics support"; with the weapons package of 700 million euros being the extra.

What is new here are the performance-based logistics support and the weapons package. So, take 1,053 million euros out and you have the comparable cost, which means it is 7.1 billion euros. It appears the fiddle is in the India specific costs, additional infrastructure and support, and performance logistics support. The first MMRCA deal also would have included India-specific specifications, as is in the case of the IAF's SU30MKIs. Thus, for comparison's sake, the argument can be made that 36 Rafales now cost 7.1 billion euros while 126 Rafales in 2012

cost 7.75 billion euros. The IAF's "spokesmen" have been justifying the Rafale pur-chase because the package includes the Meteor air-to-air missile. The Motoor is an missile. The Meteor is an active radar-guided beyond-visual-range air-to-air missile (BVRAAM) developed by MBDA. It will offer a multishot capability against longrange manoeuvering targets in a heavy electronic counter-measures (ECM) environment with range in excess of 100 km. The Meteor is said to be five times as lethal as a conventional equivalent such as the American AMRAAM carried by the Pakistan Air Force's F-16 fighters.

The Meteor is not exclusive to the Rafale. The fact is that Sweden's Gripfen has now been integrated with the Meteor and open sources indicate the IAF too is contemplat-ing integrating the SU-30MKIs and the Meteor. Even the Tejas can be fitted out with Meteors. We are therefore not buying the Rafale for the Meteor.

The cost of procuring Meteors is hard to come by. Limited figures came to light in Germany in 2013. The Luftwaffe will acquire 150 mis-siles at a cost of around \$323 million plus a further \$175 mil million, plus a further \$175 mil-lion for integration. That compares favourably with a price tag of \$423 million for 180 AIM-120Ds, which the Pentagon paid in 2012. Today each Meteor will cost about 2.5 million euros each. I don't think the IAF will need more Meteor missiles than the USAF or the Luftwaffe. Missile purchases can never be part of the capital cost of a fighter. Since they are expendable, and presumably meant to be expendable, they should be part of revenue expenditure.



December 12 and the list of candidates who will stand has now been finalised. Very many MPs of the dissolved Parliament have declared they are standing down, some because they are past retirement age but very many because they don't wish to be associated with the parties to which they have long belonged.

Both the main parties of the UK, the Tories and Labour, have suffered deep schisms over Brexit.

The Tories expelled 19 of its MPs for voting against Prime Minister Boris Johnson's Brexit policies. Similar schisms occurred in the Labour Party over Brexit policy, with MPs quitting, being thrown out and defecting to the Liberal Democratic Party

Other Labour MPs resigned over the allegation that Labour, under the present leadership of Jeremy Corbyn, has become an anti-Semitic party, an allegation which Labour strenuously denies. Nevertheless, several Jewish MPs have left the party and will not now stand.

The more startling reason for MPs to stand down and abandon their political ambitions is new and nasty. Several women MPs say they no longer want to serve as such because in doing their duty they face a deluge of abuse and threats. Nicky Morgan, former education secretary and a minister in the Boris Johnson Cabinet, is standing down. She says for this reason. Opponents of her government's policies or just psychopaths and nasty, anonymous "trolls" have threatened her with rape, death and attacks on her family. She and several of the honourable female members are standing down for this precise reason.

The one exception to these various motives for the termination of a parliamentary career is the Labour MP for Leicester East, one Keith Vaz. He has been a controversial figure throughout his career as an MP, which began in

Mr Vaz announced last week that he will not be standing. In 2016, Mr Vaz, married with two children, was exposed by the Sunday Mirror as having hired two male prostitutes in his London flat and offered to buy cocaine for them.

At the time the scandal broke, he had the distinguished job of chairing the parliamentary home affairs committee. His away-from-home affair was then investigated by the parliamentary standards committee to which such matters are referred. According to the chair of that committee, Mr Vaz offered "frankly ludicrous excuses "and "did himself no favours by his inability to provide a single, consistent, plausible account". The standards committee an of Indian origin

He also has the unofficial reputation of being a chancer — if not, in an indictable sense, a crook. In Britain, all MPs are supposed to register their financial remuneration, whether these be paid employment, inducements to lobby on behalf of some company or vested interest or indeed free trips paid for by foreign governments or their proxies. Mr Vaz, through his 32-year career, has enjoyed all these and broken the parliamentary obligation to declare them.

His first breach of the guidance or obligation on standards was failing to declare that he was paid a salary by the Leicester Law Centre while earning his MP's wages

Between 1992 and 1997, a parliamentary committee gathered evidence that Mr Vaz would use his clout as an MP to lobby for Leicester businessmen and three separate religious groups who were seeking licences and permissions. In 2000, Mr Vaz was seriously implicated in what the media called the "Hinduja Affair". The Hinduja brothers, billionaire residents of Britain at the time, applied for UK citizenship and then minister Peter Mandelson had to resign from the Cabinet when it was proved that he had attempted to facilitate their application in return for funding Labour government-sponsored projects. Mr Vaz's wife, a solicitor, was employed by the Hindujas at the time and it was alleged that Mr Vaz was paid by the family to lobby on their behalf. Elizabeth Filkin, the commissioner in charge of Commons standards, said Mr Vaz and his wife were guilty of "deliberate collusion over many months to conceal this fact and to prevent me from obtaining accurate information about his possible financial relationship with

the Hinduja family". In later years, Mr Vaz was investigat-ed on at least four counts of paid lobbying on behalf of convicted crooks and fraudsters and for falsely claiming parliamentary expenses. What his long career of dodging proves is that the bark of the watchdogs of the UK Parliament is more potent than their bite.

The MPs of parliamentary democracies, subject in our world to the party system, should surely represent their constituents and their parties' polices rather than their (undeclared?) bank balances.

It should be one of the first conditions of any parliamentary democracy to have effective mechanisms and scrutiny of the financial dealings of its members, from small bribes to major backhanders and profitable lobbying and even blackmail

In her latest series, Intimate Etre, she puts up a fight against labels, stereotypes and genres through 12 encounters, 12 portraits and 12 stories. She speaks to Shraddha Nair about her journey and her experiences with this series, of stories told from the homes of her subjects

### Tell us about yourself as an artist how your practice developed into creating this series today

I'm a people person, I photograph human beings and capture human stories. I always think it is important to take pictures and create images on sub-jects you are interested in... this conviction has actually almost put a halt to my commercial work as I like to work solo and decide my ways. The past few years I have developed an interest in people, communities which are different and who do not always have solutions to be heard. My photography practice has given me the opportunity to believe that the fact that I am interested in someone s life and develop an interaction with that person or group of people can have a therapeutic influence sometimes... The relationship between the model and the photographer is getting more and more important to me as time passes. It surely has a huge impact on what I decide to work on. I love the proximity of what the camera allows me to show, I love the way the camera shields me or exposes me. I love colour and drama. I love natural light.

The anti-defection law, Tenth Schedule, the jurisdiction of the Speaker... Karnataka politics set off an intense discussion on all three aspects as the Supreme Court weighed in and gave the go-ahead to the 17 MLAs, disqualified by then speaker Ramesh Kumar, to contest the December 5 assembly bypolls. The BJP is elated as it can look to their support - if they win the bypolls - to shore up their numbers. The opposition Congress and JD(S) will be straining every sinew to wreck their poll prospects. The Asian Age taps political and legal experts on this momentous verdict, as our elected representatives look to the main chance with the winning party.

# A win FOR BJP AND the disgualified, really?

he Supreme Court stand on the status of the 17 disquali-fied Karnataka MLAs was on expected lines. While the Court upheld their disqualification it has lifted the ban on their contesting elections during the term of the current Assembly. This implies that they would be free to contest the by-elections due next month. The verdict of the Supreme Court opens up a 'world of possibilities',

which merit detailed attention. In the first place, the 17 disqualified MLAs now being eligible to contest the by-elections would immediately place pressure on the BJP to accommodate those who are keen to enter the electoral fray. If the Supreme Court had upheld the Speaker's decision, the BJP would have had a convenient excuse not to nominate them by taking shelter in the ban on their contesting. Now with that 'pretext' not available, the BJP would find it very difficult to deny them their 'reward' for helping bring down the Congress-JDS coalition government and come to power! Further, with these disqualified former MLAs likely to openly join the BJP, the factors that motivated their decision to invite disqualification become patently transpar-ent. Will those disqualified be formally adopted and endorsed by the central leadership of the party or leave it to the state leadership to nurture and care for the new entrant will be an interesting to watch and see.

Secondly, the internal contradictions within the BJP would now clearly come out in the open. Many of those from the BJP who were defeated by the 17 disqualified MLAs have already been

appeased and accommodated by being given plum posts by the BJP government. This of course does not guarantee that they would participate actively in the by-poll

campaign of those who defeated them less than a year and a half ago. Many others have not yet

been rewarded and continue to put pressure for the BJP ticket in the constituen-

cies going to the by-polls. How does the BJP reconcile the claims of the old 'loyalists' with the new 'converts' will be keenly watched.

Thirdly, all the 17 seats that face by polls were seats held by the Congress/JDS. Some of them were won by these parties by quite impressive margins. Many of those seats had not seen a strong BJP presence in previous elections. The by-elections would indicate whether the personality of the disqualified MLAs can actually swing the seat towards the BJP or did they win the last time around, simply because of the support that the party enjoyed in that constituency.

Fourthly, this set of by-elections will also help gauge the public mood on elected representatives switching politi-cal sides. The recent Satara Lok Sabha by-poll in Maharashtra showed that voters do not take kindly to party switching by their elected representatives. Would that trend be repeated in Karnataka or would those who switched political sides be able to convince the voters of the rationale behind their decision.

Finally, if past political history is any indication, the developments after the BJP came to power in the state in 2008 seems to be coming back to haunt the party. A decade ago, the BJP managed to hold on to power thanks to 'Operation Kamala' and the support of 'new converts' to the party. Will the same trend be repeated? Will the BJP retain its majority in the state on account of those who switched sides or will their presence be the factor that

AGE DEBATE here, the disqualified MLAs were not legally aggrieved except by the differences between a resignation and disqualification. By the time

this matter came up for judgment today, the bypoll itself was announced and scheduled and so, the Supreme Court did not find much of a complication once they saw that the Tenth Schedule does not impose disqualification for the rest of the term of the House. So, the Speaker's Order to the effect that the disqualification will run until 2023 has been set aside.

Also, the Supreme Court has observed that the Speaker had enough material with him to find that those MLAs had indulged in anti-party activity and so, were covered by the clause 2(1)(a) of the Tenth Schedule – 'voluntarily giving up membership of the House'. Though the Speaker gave lesser time to these MLAs to give their response, the Supreme Court has held that that alone is not a reason to interfere with the Speaker's Order. Also, the Supreme Court has held that if a person is liable to be disqualified, he cannot escape it by simply submitting his resignation. Though the Supreme Court has said nothing at all about the Yediyurappa tapes that were submitted to it at the fag end, it appears that the Supreme Court was very strongly influenced by it. Yediyurappa is the Chief Minister of Karnataka; he is not some low-ranking politician gossiping in the corridors, he spoke in a closed-room public gathering of his party men and, he was, of course, the biggest beneficiary of those 17 MLAs defection. His own admission of the BJP party engineering and managing the defection could not have gone unnoticed by the Supreme Court.

In their judgment on the Karnataka MLAs disqualification case, the MLAs but did not validate his decision to disqualify the MLAs from contesting further elections to the Karnataka Legislative Assembly in its current term. However, if they had accepted this decision of then-Speaker Ramesh Kumar, they would have strengthened the Anti-Defection Law and fulfilled their stated goal.

Clearly, the Speaker was innovating when he extended the MLAs disqualification till the end of the tenure of the Assembly. Such a provision is not provided under Article 191 (2) of the Constitution which contemplates removal of members of a State Legislature when disqualified under the

10th Schedule. But, in Prof. Rajeev Gowda

the light of the realpolitik of defections in India, this was an innovation that would have achieved the goals of the Anti-Defection law in letter and spirit.

The purpose of the anti-defection law is to prevent the MLA from negating the voter's faith. When a voter casts a vote for an MLA candidate, that vote is both for the person and for the party. We are not in a position to separate

the two. When the Speaker, acting in a quasijudicial capacity, determines that an elected candidate has left a party because of inducements rather than a point of principle, then a suitable penalty needs to be devised. In this instance, the Yediyurappa tapes have revealed horse trading, and he is the inventor of the infamous "Operation Kamala." Judicial activism would have helped counter these egregious violations of democratic verdicts. In other contexts, the Supreme Court has framed rules to strengthen laws. It could have done the same here as well

After all, the Speaker is the custodian of the propriety of the House and should be entrusted with powers which can allow him to effectively discharge his duties. An election is a social contract between the voters and the elected representative. The voters elect an individual to be their representative for five years. Any resignation by an MLA in the absence of cogent and lawful reasons violates that social contract. Elected representatives will have no incentive to honour their part of the contract if the punishment is not punitive enough. Allowing a disqualified MLA to immediately seek re-election does little to deter defections aimed at black-mailing or toppling governments.

Thus, the Speaker, who already has tremendous power under the Anti Defection Law, must be empowered to take necessary actions where constitutional and moral violations have taken place, as per his discretion. Such was the need of the hour. Clearly, in this instance, the learned judges have missed out an opportunity to stem the continuing rot in the domain of electoral politics.





### **Trade deficit** better than estimated **VRISHTI BENIWAL**

NOV. 15

India's trade deficit widened less than estimated last month, as a third-straight month of decline in exports offset a sharp plunge in imports amid weak global demand conditions.

The gap between exports and imports was at \$11 billion in October fr-om \$10.9 billion in Septe-mber, data released by the Commerce Ministry showed Friday. That was lower than the median estimate for a \$11.9 billion deficit in a Bloomberg survey of 20 economists. Imports declined 16.3 per cent from a year ago to \$37.4 billion, compared with a 13.9 per cent fall in September, showing muted demand in the September, domestic economy.

Exports fell 1.1 per cent to \$26.4 billion, against a 6.6 per cent drop the previous month.

The numbers are the latest in a slew of data that points to weaker economic activity, with purchasing managers' surveys earlier signaling muted activity in manufacturing and services sectors. Bloomberg





won't improve enough to stimulate the interest of investors. Equally, the coddling of subpar government companies compromises the efficiency of entire sectors of the Indian economy. The reforms required to address these problems are well-known by now. The market for capital has to be overhauled by privatizing at least two of the largest state-owned banks. The market for labor requires more flexible laws that would persuade companies to use India's cheap and

abundant workers instead of scarce and expensive capital. If China and other rivals provide land to industry for free, India cannot have a system where a huge multiple of the mar-

ket price needs to be paid for land. Both failing and successful public-sector companies need to be sold. Right now, despite recent pro-business measures, the government is sending mixed signals. Its decision to stay out of RCEP will look defensive and in favor of the status quo unless it is followed by a spate of domestic reforms. That impression could undermine the reforms already undertaken, deter foreign investors in particular and reinforce the vicious cycle which is dragging growth down. A big bang package of

reforms is more possible than nervous ministers may believe. They can spend the next two months before the next budget developing credible plans in consultation with busistate governments. And once unveiled, the changes don't all need to be implemented at once. A calibrat ed approach over 12 to 18 months would suffice; the important thing is to signal to the market that the government is serious and ambitious. By then, too, the BJP should have a clear majority in the upper house of Parliament, which will making passing bills easier. Modi remains massively popular and can claim to have fulfilled most of the BJP's social agenda already. But for his government to be considered truly transformative, it must revive economic growth and put it on a higher trajectory for the next two decades. There are no longer any excuses for delay.

## A stinky dustbin of '80s Bollywood

f, for some reason, you have an urgent craving for a rather tacky and soulless recap of Bollywood in the half-decent late-Seventies and its quick descent into the terrible Eighties, you could try to sit through Marjaavaan, otherwise a cretin of a film that is a complete waste of time, energy and money. The film, directed and hardly written by Milap Milap Zaveri,

has everything borrowed from the worst Bollywood of that

trashy era. It's as if

there existed a dumping ground of all used and discarded items stories and plots, stock characters (good and bad, male and female, main and peripheral), fight sequences, costumes and acces-sories — and Milap Milap Zaveri simply went in and walked out with as many things as he could carry. He then came home and dumped them all on a paper and

called it a screenplay. So obviously, this illegitimate offspring of many B-grade items mating with each other is worse than C-grade. It is third-rate.

There is nothing, and I mean NOTHING, absolutely nothing original in this film. The story, no item of clothing, no character,

not even a weapon, plot line, villain, hero, location... nothing. Even four of the six songs are what's now called "reloads" of old hits.

ducted the annual sale-purchase of girls, Raghu, his son-like min-ion, did his bidding, which included killing off all pesky rivals.

Meanwhile, in a bedroom in Anna's bizarre apartment skulked his own son, Vishnu (Riteish Deshmukh). Nurturing complexes about many things, including the fact that he was a midget and that his father loved Raghu more, Vishnu grew up to be seriously stupid and sulky.

Arjaavaan is set in Mumbai and the location is split between two places - the strange apartment of Anna, which is on some very high floor of a building that's under con-struction and doesn't have a lift, but his house is nicely done up except for the balcony wall. There is no balcony, and there is no wall. It's just an open season to toss out men who irritate. The basti is where Raghu lives,

with three besties who behave like his orderlies, and Arzoo (Rakul Preet Singh), the dance

bar girl who dotes on him. Despite this, Raghu doesn't think twice before dumping her for the samaj sevika from Kashmir, Zoya (Tara Sutaria).

Zoya is speech impaired and yet she proceeds to ask long-winding *pahelis* in sign language. Thankfully, she has a curly-haired human translator always in tow. She also has a purpose — she wants to exchange all guns in all bloody hands with harmonicas. She hands one to Raghu.

Zoya, like most nubile newcomers paired with established male actors in desi action thrillers, is a prop, an impetus. First she must make the hero, who is on the wrong path, to think of living a lovey-dovey life with her and thus, must, piss off his boss. Having done that, she must die. Because only then will the climax

have some raison d'etre.

There is also a cop in the scheme of things. We could call ACP Ravi Yadav (Ravi Kisen) The Empathetic Gyani. He gives gyaan to all and doesn't impede upon any proceedings involving sharp objects, firearms and dead bodies. In fact, so bored is he of *Marjaavaan* that I think he and his entire *thana* went on Keto diet and lost several kilos.

f you borrow things from not one but multiple sources, and have not a single original thing or thought, is it called plagiarism or dacoity? Just asking.

Raghu's character is a rag doll created from various desi action avatars, especially those created by Manmohan Desai for Amitabh Bachchan, including his Ali-Bajrang Bali filmy secularism.

Though his bandana is very Jaggu Dada (Jackie Shroff, Hero), the red sando vest (Amar Akbar Anthony), the matchstick he sucks on (a la Vijay's beedi in Deewaar) are Big B's. At some point one of his three friends turns into Abdul (Mazhar Khan's

one and only memorable character in Ramesh Sippy's Shaan). Vishnu, the evil midget who talks big and is always waving

about a pistol with a long nozzle, is without menace or meaning. A big *pheku*, he is very crying about his daddy not loving him and talks only in long monologues in which he likes to expound upon "What is the height of... Kamingi, deewangi.

I wish he had also asked: What is the height of stupidity? The five people in the hall would have screamed in unison, "You, your character, your acting, your dialogue..." Though *Matrjaanvaan* is an

action film, its fight sequences are bad and bizarre.



DEATH OF COLONEL BLIMP Released in 1943 Review written

ne of the many miracles of *The Life and Death of Colonel Blimp* is the way the movie transforms a blustering, pigheaded caricature into one of the most loved of all movie characters. Colonel Blimp began life in a series of famous British cartoons by David Low, who represented him as an overstuffed blowhard. The movie looks past the fat, bald military man with the walrus moustache, and sees inside, to an idealist and a romantic. To know him is to love him. Made in 1942 at the height of the Nazi threat to Great Britain, Michael Powell and Emeric Pressburger's work is an uncommonly civilised film about war and soldiers — and rarer still, a film that defends the old against the young. Its hero is a bluetoning old windbac Oline Winne Condu e war blustering old windbag Clive Wynne-Candy, a warhorse of the Army since the Boer War, now twice retired from regular duty and relegated to leading

the Home Guard. As the film opens, the General has ordered military training exercises and announced, "War starts at midnight". A gung-ho young lieutenant decides that modern warfare doesn't play by the rules, and jumps the gun, leading his men into the General's London club and arresting him in the steam room. When Wynne-Candy bellows, "You bloody young fool — war starts at midnight!" the lieutenant observes that the Nazis do not observe gentleman's agreements, and insults the old man's belly and moustache. Wynne-Candy is outraged. "You laugh at my big belly but you don't know how I got it! You laugh at my moustache but you don't know why I grew it!" He punches the young lieutenant, wrestles him into a swimming pool — and then, in a flashback of grace and wit, the camera pans along the surface of the water until, at the other end, young Clive Candy emerges. He is thin and without a moustache, and it is 1902.


The Life and Death of Colonel Blimp has four story threads. It mourns the passing of a time when professional soldiers observed a code of honour. It argues to the young that the old were young once, too, and contain within them all that the young know, and more. It marks the General's lonely romantic passage through life, in which he seeks the double of the first woman he loved. And it records a friendship between a British officer and a German officer, which spans the crucial years from 1902 to 1942.

This is an audacious enough story idea to begin with, but even more daring in 1942, when London was bombed nightly and the Nazis seemed to be winning the war. Powell at first wanted Laurence Olivier to play his title role, but the screenplay ran into fierce opposition from Winston Churchill, and the ministry of war refused to release Olivier from military duty. Then Powell cast Roger Livesay, a young actor who had worked for him before, and as the German officer, an emigre Austrian actor named Anton Walbrook. That led to an encounter between Churchill and Walbrook, recounted by the British film critic Derek Malcolm: "Churchill's reaction was furious. He is said to have stormed into Walbrook's dressing room when he was appearing in a West End play demanding: 'What's this film supposed to mean? ] suppose you regard it as good propaganda for Britain.' Anton's reply was quite telling, he said, 'No people in the world other than the English would have had the courage, in the midst of war, to tell the people such unvarnished truth' Ah, but he praised his adopted homeland too soon. Churchill continued to resist. Powell could not borrow gear and trucks from the Army, "so we stole them". The film was at first banned, then reluctantly released in a shorter version, and in the US, it lost 50 minutes of its 163-minute running time; the entire flashback structure was replaced by a chronological storyline. Only in 1983 was the film finally restored, and hailed as a masterpiece. "It stands," wrote the critic Dave Kehr, "as very possibly the finest film ever made in Britain". The Life and Death of Colonel Blimp is a film of balance and insight — a civilised film, which even in a time of war celebrates civilised values. What it regrets is the loss, in two World Wars, of a sense of decency and fair play that had governed the European military classes. Near the film's end, the German refugee corrects the sentimentalism of the old general, telling him from first-hand experience that Nazism is the greatest evil the world has ever known, and saying there is no point in playing fair when the enemy plays foul, if that means you lose, and evil wins. Despite this sober undercurrent, Colonel Blimp is above all a comedy of manners, and Powell and his writing and producing partner Pressburger conduct it with style and humour. Jolly music underlines an opening sequence in which motorcycle messengers distribute news of the war games, and there is wit in the movie's ingenious flashbacks and flash-forwards. Photographed by Georges Perinal with help from Jack Cardiff, the movie is one of the best-looking Technicolor productions ever made, its palate controlled to make wise use of bright contrasts in a world of subdued harmony. Several scenes surprise us by how they pay off. Note the early duel between the British and German officers (they do not even know one another; the German was drawn by lot to respond to an insult to the German Army). The most poignant passages involve the General growing older. He looks like a caricature to younger officers — with his beefy face, pink complexion, moustache (grown to hide the duelling scar) and raspy voice. But in his heart he is still young, still in love, still idealistic. At the end of the movie he looks at a water pool in the basement of his bombed-out house, and is reminded of a lake across which he once pledged love. And he insists to himself that it is the same lake, and he is the same man. Rarely does a film give us such a nuanced view of the whole span of a man's life. It is said that the child is father to the man. Colonel Blimp makes poetry out of what the old know but the young do not guess: The man contains both the father, and the child.

# 'Ford v Ferrari' is a very pleasant (fast) ride

The first three-quarters of *Ford v Ferrari* sets the stage for the furious 40-minute restaging of the exhausting Le Mans race – a 3,000-mile, 24-hour slalom through country roads. So meticulous have the filmmakers been that they built an entire accurate Le Mans in Georgia because the original has been too altered in the intervening years. (There are not many cases when Georgia acts as a stand-in for La France.) Damon plays the legendary American driver and car designer Carroll Shelby, who won Le Mans in 1959 but gets sidelined from driving due to a bad heart. He considers the best driver in the world to be Ken Miles, a daredevil British missile played by Bale.

If Damon is a bad boy, then Bale is a badbad boy, a role perfectly in his wheelhouse, another intense, almost-over-the-top role But it's Damon, almost subdued

Bernthal, perfectly cast, showing layers) tells Ford. "We need to think like Ferrari." Ford initially tries to do that by just buying Ferrari — but Italian head Enzo Ferrari tells the Ford delegation to "go back to Michigan, back to your big ugly factory." Boo! Shelby fights back: "You can't win a race by committee.

The film then goes to the 24 Hours of Le Mans — fake grainy TV and radio broadcasts help set up the tension — and you can almost smell the burnt rubber. "She's hot, mate. Crack on!" one driver says of the Ford's GT40 Mark II. Enzo Ferrari owers from his box in the stands and the filmmakers don't bother to translate everything the Italian team says, so clear is the acting. Many of the songs we hear are well placed - it's got a soundtrack of The Animals, The Sparkles and The Quarrymen — plus, you'll marvel at another past technology: Sunglasses in the 1960s would make anyone look cool. Perhaps the only thing overshadowing the two Oscar-winning lead actors in this film are the cars. They're truly drool-worthy. But be gentle on your gas pedal on your way home. -AP

The film has a small town quality to it which it gets that from the banter of its female characters, and the nashta of many fried items that everyone is having all the time

It's warm, feels real and is very funny. It's also super smart and sharp.

This shame of Indian families is very nicely captured in a moving scene.

The film also usurps relations and resets power equations, like when the angry saas and bahu conspire together.

But it's the film's dialogues, superb and often raunchy, that stay with you. Like *mausi's* advice to Annie on her suhag raat, when she calls to complain of her inability to conjure any carnal or romantic feelings — "just close your eyes and think of Burj Khalifa". I fell off laughing.

Athiya, who made a very disturbing debut in Hero (2015), has really come into her own here. She holds on to a tough MP Hindi dialect throughout the film and despite Nawazuddin's very apparent reluctance, tries to forge some chemistry.

For most of the film, Nawazuddin seems quite out of it, as if he decided to give the film and his role just 20 per cent.

That makes Athiya's job harder, and yet she carries the film, succeeding in selling us this very odd, awkward pair.



**City lose Financial Fair Play appeal** 

Lausanne: Manchester City have lost their appeal against the decision of UEFA to refer the English champions to its adjudicatory chamber over alleged Financial Fair Play violations, the Court of Arbitration for Sport (CAS) said on Friday. City reacted angrily when they were referred to the adjudicatory chamber of UEFA's club financial control body by its investigatory chamber in May. The club said it would appeal to CAS, but the sports court dismissed their initial appeal, saying on Friday that City had not "exhausted the legal remedies available to it prior to the appeal". It means City have failed in their attempt to stop UEFA from investigating the allegations they supplied false financial information, with CAS saying their appeal was "inadmissable".

The investigatory chamber had also recommended that City be sanctioned by UEFA Possible punishments include a suspension from the Champions League, a transfer ban or a fine. - AFP


### **PARA ATHLETE SHARAD WINS SILVER**

Dubai: India's celebrated para high-jumpers Sharad Kumar and Mariyappan Thangavelu qualified for next year's Tokyo Paralympics after claiming the silver and the bronze medal respectively in the World Para-Athletics Championships here. **Two-time Asian Para Games** champion Sharad Kumar cleared the bar with season's best effort of 1.83 metres, while Mariyappan, a Rio Paralympic gold-medallist, settled for the bronze, also with a season's best performance of 1.80 metres here on Thursday evening. The gold went to Sam Grewe, who won the top honours with a championship record of 1.86 metres. Sharad, the former world no.1, stayed in the lead initially clearing the bar at 1.67m until 1.83m before Grewe surged ahead with 1.86m to be on top Mariyappan, who failed to clear 1.83 metres in his last attempt, later admitted that he couldn't perform his best. Also performing in the same event was Ramsingh Padhiya who settled for the fifth place with an effort of 1.77 metres. Earlier in the day, Lal Vinay Kumar, the Asian Para Games bronze-medallist. claimed the bronze in men's 400m T44 event, and a Tokyo 2020 spot, finishing in 55.49 seconds After the penultimate day's action, India has nine medals two gold, two silver and five bronze – from the Championships. China lead the medals tally with 53 medals including 23 gold medals, followed by Brazil (37). – PTI


