# Betrayed by a bank

The virtual collapse of Punjab and Maharashtra Cooperative Bank following grave financial irregularities has left thousands of depositors in distress. **Gautam S. Mengle** reports on the crisis and the ongoing fight for justice

t was late September when Andrew Lobo, 71, was brought home from a ▲ hospital in Mumbai after undergoing treatment for lung infection. Andrew had no reason to be relieved, however. He had come home to the devastating news that Punjab and Maharashtra Cooperative (PMC) Bank, where he had an account, had been placed under 'directions' of the Reserve Bank of India (RBI) for six months, after irregularities had been found in lending. This meant that the RBI was practically taking over the bank's operations. Crucially, it meant that customers like Andrew could withdraw only up to ₹1,000 of the total balance in any account they had in the bank.

The infection had already weakened Andrew's lungs; he needed oxygen machines to breathe. While his family had managed to pay for his treatment, they had been relying on four fixed deposits in PMC Bank to buy the oxygen machines needed to pull him through. Each of the machines cost ₹49,000. With no access to the fixed deposits, Andrew could not recuperate. On October 31, he became the seventh account holder of PMC Bank to lose his life.

"He had no children of his own. All of us - the children and grandchildren of his siblings – were his family," said Chris Lobo, Andrew's nephew. "It was hard to see him suffer. He was a strong and independent person. Just as we were talking about withdrawing the fixed deposits he had in PMC Bank, we saw the news that restrictions had been placed on the bank's transactions. We had no other money to pay for the oxygen machines, because not just Andrew uncle, but even my father and all of our close friends had accounts in PMC," he said.

The family said stress had caused Andrew's health to deteriorate further. He couldn't believe that he had no access to his own money. He refused to eat. Andrew's family could only watch helplessly as he began wasting away in front of their eyes. "On October 31, all of a sudden, he started breathing heavily. Within five minutes he was gone. He had suffered a cardiac arrest," Chris

Andrew was among the hundreds of depositors with PMC Bank who suddenly found themselves financially crippled, for no fault of theirs. Ironically, the same bank that customers had trusted to safeguard their money had become responsible for their misery.

### **Questionable dealings**

PMC Bank is a multi-State scheduled urban cooperative bank with operations in Maharashtra, Delhi, Karnataka, Goa, Gujarat, Andhra Pradesh, and Madhya Pradesh. Started in 1984 as a single branch bank, it now has 137 branches.

It is alleged that PMC Bank had been hiding bad loans for a long time. Addressing a press conference soon after the RBI barred the bank from carrying out its routine transactions, the suspended Managing Director of PMC Bank, Joy Thomas, admitted that ₹2,500 crore of exposure to the Housing Development and Infrastructure Limited (HDIL) group had been left unnoticed in the annual audit of RBI. Thomas was arrested days after the press conference.

But how did the fraud come to the surface? The RBI said a complaint had been filed by PMC Bank against its officials and borrowers associated with the financial irregularities in the bank and manipulation of its books of accounts. Based on this, the Economic Offences Wing (EOW) of the Mumbai Police registered an FIR against officials of the bank as well as the HDIL group. Shortly thereafter, the Enforcement Directorate, too, registered a separate offence under the Prevention of Money Laundering Act, 2002.

The directions imposed by the RBI in September, under sub-section (1) of Section 35A of the Banking Regulation Act of 1949, also barred the bank from extending any new loans or making any investments, except in government securities. The bank was allowed to pay salaries to the staff and also rent, as well as renew term deposits of customers on maturity.

The restrictions triggered a huge public outcry as customers were unable to withdraw their savings. This prompted the RBI to gradually increase the withdrawal limits. On September 26, the deposit withdrawal limit was increased to ₹10,000, and on October 3, to ₹25,000. On October 14, the limit was raised to ₹40,000, and on November 5, further to ₹50,000. With withdrawal limits raised to ₹50,000, 78% of the depositors of the bank can now withdraw their entire ac-

The move by RBI came as a surprise at first because PMC Bank's financials were not in a bad shape. The bank has made a net profit of ₹99.69 crore in 2018-19 as compared to ₹100.90 crore in the previous year. The net non-performing asset ratio of the bank was 2.19% as of end-March 2019, which is much lower than many public sector banks. The deposit base of the bank was ₹11,617 crore

as of end-March 2019, a growth of 17% a year, while advances growth was 13% to ₹8,383 crore. The police, too, has confirmed that the bank's finances were not in troubled waters.

"Inquiries have revealed that there was a systematic effort to hide the loans advanced to HDIL in the bank's annual audit. Crucial information about the borrowings of HDIL was kept suppressed, and falsified records were furnished to the RBI, with the Chairman, MD, and members of the loan committee all being involved. More people opened accounts with the bank as a rosy picture was projected. According to our investigations, HDIL's accounts should have been declared as non-performing assets in 2013 itself," an EOW officer, who is part of the investigation,

According to the EOW's estimate based on the documents examined so far, the outstanding debt of HDIL stands at ₹4,635.62 crore as of August 2019.

The EOW found 21,049 accounts that were in the name of fictitious parties, which had been used to replace the 44 actual accounts of the HDIL group in the bank's records. The amount advanced to the HDIL group was spread out evenly in the fictitious accounts. This was why the outstanding balance on paper was significantly lower than the actual

As with any economic offence where a large number of people have lost – or stand to lose – their money, one of the top priorities of the police was to try and ensure that the depositors were compensated.

From September 30, when the FIR was filed, to date, the EOW and the Enforcement Directorate have collectively attached assets belonging to Rakesh Kumar Wadhawan and his son Sarang Wadhawan, promoters of the HDIL group, worth ₹3,800 crore. The EOW has also filed an application in the court, seeking permission to release the assets, so that they can be auctioned off and the depositors compensated. The assets include large tracts of land in Thane district, high-end cars, speed boats, and a private aircraft. The auction is supposed to begin within 14 days of the assets being released, with the RBI overseeing the process of using the proceeds of the auction to reimburse the depositors.

The RBI has appointed an administrator along with the three-member advisory committee for speedier resolution. It was on the administrator's recommendation that the plea seeking discharge of the assets was filed. The Wadhawans, through their lawyer, have already conveyed to the Enforcement Directorate, the EOW and the RBI that they have no objections to their assets being sold off to compensate the customers. "We urge the Enforcement Directorate and the EOW to take timely action by disposing of the assets to get the fair market value for the same. We further give our unconditional consent for the appropriation of the money received from the sale of these assets to be adjusted and appropriated towards the principal loan amount procured by us," a letter signed by them on October 16, 2019, stated.

The customers, however, are not convinced. "What is the guarantee that someone will even buy the tainted assets?" Kishore Modsingh, a customer who banked with the PMC's Santacruz branch, said. Modsingh is a cancer survivor who has been unemployed for the last two years due to his illness and was completely dependant on the money he had saved. His wife is a home-maker and his daughter, a student.

"All I had was the money I had deposited in PMC Bank. All my treatment was being funded by it, and my household expenses taken care of. Then, suddenly, the RBI placed restrictions on it and I am left with nothing. Every day is a struggle. Those responsible for our condition are getting home-cooked food with the court's permission while in jail, and we are fighting for two square meals," Modsingh said.

Eleven account holders with various branches of the bank have lost their lives due to various medical problems since the crisis broke. Apart from pacifying the depositors, whose anger mounted with every life lost, the police also had its hands full trying to dispel the rumours surrounding the issue.

One such instance was on October 11, when Nivedita Bijlani, who had over ₹1 crore in the bank, committed suicide in her Andheri residence. Thanks to WhatsApp, the news of her death went viral within an hour. The police found themselves besieged with phone calls, and senior police officers quickly passed down orders instructing the Versova police to get to the bottom of the matter. By evening, the police found that while she was indeed a PMC bank account holder, there was no evidence of her death being linked to the ongoing crisis.

"The deceased had been suffering from depression and was under treatment for the same. She had had two failed marriages and had recently moved back from the U.S. to stay with her father in Andheri after her second marriage," Additional Commissioner of Police (West region) Manoj Kumar Sharma said.

Meanwhile, the EOW arrested Sarang and Rakesh Wadhawan; former chairman of PMC Bank, Waryam Singh; former PMC Bank Managing Director, Joy Thomas; and Director Surjit Singh Arora in connection with the case. All of them are in judicial custody and are lodged in the Arthur Road central jail.

With the process of compensating the depositors under way and some of the key accused under arrest, the next task for the EOW was to pinpoint culpability on the part of all the parties involved, including the auditors who conducted the audits.

### **Auditors face the music**

The EOW identified two auditors, Jayesh Sanghani of Ashok Jayesh and Associates, and Ketan Lakdawala of Lakdawala and Co. Both were brought in for questioning on November 11 and grilled for hours. They were confronted with

the financial records of the bank. The results of the sustained questioning yielded evidence of not only wilful negligence but also signs of a larger conspi-

The EOW first asked both of them to explain how the gross irregularities in HDIL's loans alone had managed to slip through their scrutiny year after year. When they could not provide satisfactory explanations, they were placed under arrest.

We also found that the two auditors had been appointed by Thomas and Singh on specific instructions from the Wadhawans. This is not only a contravention of the Multi-State Co-operative Societies Act, but also indicates that the whole fraud was planned well in advance by the Wadhawans and the PMC Bank officials. Both of them have been functioning as auditors of the bank for more than two decades," the EOW offic-

The EOW's application seeking custody of Sanghani and Lakdawala also mentions that the agency has received information about both the auditors having had other business dealings with the Wadhawans in the past. The EOW is now trying to find evidence, either in the form of documents or testimony, to establish this beyond doubt. Both the auditors are also facing a separate inquiry by the Institute of Chartered Accountants. A third auditor, Anita Kirdat, was arrested on November 13. She was a concurrent auditor and used to conduct monthly audits.

Meanwhile, the other directors have all gone underground. An EOW team is at present in Punjab, working on a tipoff that two of the directors, Daljit Singh Bal and Gurnam Singh Hothi, might be hiding there. Bal, like Arora, was a director of the bank and on the loans committee till the time its affairs were taken over by the RBI.

Two other directors, Parmeet Sodhi and Surjit Singh Narang, filed anticipatory bail applications, which were rejected by the Sessions Court on Novem-

### Protests across the city

The PMC Bank crisis has sparked off protests across Mumbai. On November 6, a group of protesters stood outside the RBI building in the Bandra Kurla Complex for hours till an official came out to talk to them.

"All that we were told was that everything is being done to ensure justice. But no one is telling us exactly how that justice is going to come. The Finance Minister has already passed the buck, saying that the matter comes under the RBI's purview, while the RBI won't even entertain us," Modsingh said.

The depositors have also been staging protests outside the court every time an accused is produced for remand or other purposes. Around 150 depositors have now hired their own lawyers to oppose any applications for bail that the accused file.

"The crisis is a case of gross negligence not just by the bank but by the RBI. Those concerned should also be booked and arrested. The Indian banking system will not improve unless such strict steps are taken, and account holders will continue to suffer. What happened amounts to criminal negligence." advocate Nitin Satpute, who is representing the depositors, said. Satpute filed independent applications on November 6 opposing the anticipatory bail pleas submitted by Sodhi and Narang.

Earlier, on September 30, another group of depositors, filed petitions before the Bombay High Court seeking withdrawal of the restrictions on the bank's transactions. The court has sought a formal reply from the RBI regarding the steps taken so far to protect the interests of the depositors.

"You are the banker's bank. We are not inclined to interfere or dilute your authority. We just want to know what you are doing," Justice S. Dharmadhikari, who was hearing the petition along with Justice Riyaz Chagla, told the RBI's lawyer at a hearing on November 4.

The grievance against the RBI has also been voiced repeatedly by depositors in several meetings that Mumbai Police Commissioner Sanjay Barve had with them at the Mumbai Police headquarters in Crawford Market. The meetings were held to apprise the depositors of the progress in the case and more than one of them lamented that there has been no coherent response from the RBI so far.

Barve, who also has a banking background, confirmed that the whole crisis arose from a criminal breach of trust on part of the bank, an institution that is supposed to safeguard the interests of the depositors but did exactly the

Not all the depositors, however, have much faith in protests.

"I attended a protest a month ago but only saw political leaders taking the opportunity to further their own agendas. I have seen enough protests happening over the issue to know that they are bringing no results. The system will take its own time and maybe, someday, we can have full access to our own money again," Chris Lobo said.

Chris and his friends, who had accounts in the PMC, have now taken it upon themselves to keep the issue alive and ensure that no development goes unnoticed. All the account holders in Thane and nearby towns are now connected via WhatsApp groups where all updates are regularly shared. With the establishment showing scant regard for their problems, all they can do is to stand with each other.

Operational creditors, on the other hand, were beneficiaries of amounts lent by financial creditors.

## Govt. will be formed, no mid-term polls: Pawar

President's Rule was imposed in Maharashtra on Tuesday after Governor Bhagat Singh Koshyari recommended it to the Union Cabinet. None of the four major parties in the State have secured a majority of 145 in the 288-member Assembly.

The BJP emerged as the single largest party with 105 seats while the Sena, the NCP and the Congress won 56, 54 and 44 seats respectively. After the BJP's refusal to share the CM post for 2.5 vears with its oldest ally the Sena, the latter resigned from the Union government and has sought support from the other two parties to form the government.

Mr. Pawar is likely to meet Congress president Sonia Gandhi on Sunday in Delhi. In a joint press conference, senior Congress leader Ahmed Patel and Mr. Pawar had clarified that they will first reach a consensus between themselves and only then will announce the decision on alliance with the Sena

Earlier, Mr. Pawar had said that talks on power sharing are yet to take place and he is not in a position to confirm who will get the Chief Minister's post. However in Mumbai, Mumbai NCP president and chief

spokesperson Nawab Malik repeated that the Sena will have the CM post for five

Asked whether the Con-

gress and NCP can get along with the Sena which promotes Hindutva ideology, Mr. Pawar said, "We are not against Islam, Hinduism or Buddhism But we are the people who insist on secularism when it comes to running a government. I don't know what discussions took place on this issue in the meeting of the three parties as I was not there."

#### Some precedents

Sena Rajya Sabha MP Sanjay Raut said, "There have been instances earlier where parties of different ideologies have come together. Vajpayee ji (BJP leader and ex-PM late Atal Bihari Vajpayee) headed an alliance of parties who came together on a common minimum programme. In Maharashtra, Sharad Pawar had led a Progressive Democratic Front (PDF) government (1978-80) of which the Jan Sangh, the BJP's earlier avatar, was a part."

Mr. Raut said Maharashtra's next government will be led by his party and the CMP will in the State's

## MHA officials quizzed on J&K situation

As many as 23 Members of the European Parliament (MEPs) were taken on a twoday visit to Srinagar to assess the ground situation last month.

The officials gave a detailed presentation on the current situation in J&K and also presented photographs of busy roads and traffic movement.

"We told them you are showing us pictures of places where vehicles are plying; why don't you show us pictures of places that are dark and shut," said another MP, also at the meeting.

The MPs also raised the Internet blockade in the Valley. The officials replied that restrictions were imposed as the Internet could be used by terrorists and also to spread rumours.

Meanwhile the Congress party asked whether sitting Lok Sabha MP from Srinagar Farooq Abdullah would be allowed to attend the winter session of Parliament from Monday. "Kashmir has been in a lockdown situation for the last 103 days. The Prime Minister is going around the world saying *sab changa si* (all is well)," party spokesperson Pawan Khera said.

"Is it not that Omar Abdullah and Mehbooba Mufti take their oaths under the Constitution of India? Omar Abdullah has held several positions in the Atal Bihari Vajpayee Cabinet. You [the BJP] have been in a government with Mehbooba Mufti, and today you have put them in the same category as separatists," Mr. Khera said. "When Farooq Abdullah sings Ram Bhajan or says Bharat Mata ki Jai, he does not think what the response of separatist forces will be," he added. The party also questioned the government for allowing a delegation of European Union (EU) lawmakers to visit Srinagar but not Indian MPs.

The Congress is expected to raise the issue of the EU delegation's visit and the detention of the Kashmiri leaders during the winter session of Parliament.

"How come foreign countries can gather courage to ask questions on our internal issues," Mr Khera asked and added, "We would like to make it clear... Kashmir was, is and will always be an integral part of India."

## Mufti, other detainees being shifted to warmer locations

PDP leader's family cited discomfort faced due to power cuts and the cold

The beginning of Kashmir's harsh winter has forced authorities to shift around 35 political detainees, including former Chief Minister and Peoples Democratic Party president Mehbooba Mufti, to "warmer locations" in Srinagar.

Senior officials told The Hindu that Ms. Mufti will be shifted to government accommodation, house number 6, located at Transport Lane on the Maulana Azad Road in Srinagar from the hut-turned sub-jail at Chashma Shahi.

The hut was located on the slope of Zabarwan hills and the place would get colder than the lower areas in winter. "The Deputy Commissioner, Srinagar, had received a formal request from Ms. Mufti and her family about the discomfort being faced by her due to power cuts and growing cold waves in the wake of the recent snowfall," the officials said.

Ms. Mufti's daughter Iltija Mufti too had approached the administration formally and cited a medical report to "have her unwell mother shifted to a location with better heating facility."

Heavy snowfall on November 7 has set off a cold wave in Kashmir and even struck a major blow to electricity supply, affecting the detention centres too.

Sources said the sub-jail of Hari Niwas Palace, also located at the foothills of Zabarwan, where former Chief Miand National Conference vice-president Omar Abdullah is detained, also faced major power cuts between November 7 and 10. Sources said a visibly angry Mr. Abdullah offered to pay for the fuel to run the generator sets to the security per-

## 'CBI should begin Rafale probe'

Petitioner Prashant Bhushan cites separate opinion given by Justice K.M. Joseph

Lawyer Prashant Bhushan on Friday said the Supreme Court ruling earlier this week, dismissing petitions seeking a review of the December 14, 2018, judgment on the Rafale issue, had, in fact, paved the way for a Central Bureau of Investigation probe into the deal.

prior permission from the competent authority under Section 17-A of the Prevention of Corruption Act and registering an FIR on their pending complaint.

Quoting the separate opinion of Justice K.M. Joseph, one of the three judges of the Bench, Mr. Bhushan said the judgment did not stand in the way of the CBI in taking

action as per law. He said the CBI was bound by a Constitution Bench's decision in the Lalita Kumari case that registration of FIR was mandatory if the information disclosed commission of a cognisable offence.

Stating that he would ask from the CBI about the status of the complaint, Mr. Bhushan said: "We had in fact, in our complaint of October 4, 2018, asked the CBI to seek necessary approval... It has been more than a year since the complaint was submitted to the then Director of CBI, Alok Verma."

"Accordingly, we expect Rishi Kumar Shukla, his successor, to seek the necessary approval...to begin the necessary inquiry into the complaint in earnest, in conformity with the judgment," he said. Mr. Bhushan and Mr. Shourie said the court had misconstrued their plea, which was to assess if a prima facie case was made out for investigation.

"The same mistake had been made by the original judgment dated December 14, 2018, in the writ petition which became the ground for seeking review," said a statement released by them.

## Delhi HC dismisses Chidambaram's bail plea



# Centre drops plan to bring in changes to Forest Act of 1927

Union Environment Minister Prakash Javadekar told a press conference that the draft was withdrawn. "Let me clarify that this wasn't a government draft as such. We had just consolidated views from various States with a significant forest cover. Over a few months, we've learnt that this has led to wrong interpretations. So we are withdrawing the zero draft."

#### Munda hails decision

draft. "The proposal to amend the Indian Forest Act was rejected after a consultative meeting of all stakeholders, including representatives of political parties, civil society organisations and officials," Mizoram's Minister of Environment, Forests and Climate Change T.J. Lalnun-

tluanga had said.

"Forest-officer not below the rank of a Ranger shall have power to hold an inquiry into forest offences...and shall have the powers to search or issue a search warrant under the Code of Criminal Procedure, 1973...," said a copy of the document. *The Hindu* had reported on this draft in March.

Siddhantha Das, Director-General, Forestry, told *The Hindu* that an amendment to the Forest Act was due. "We will revise it and look at it with fresh eyes. But we will definitely have an amended Act and have wider discussions."

The legislation also proposed a forest development cess of up to 10% of the assessed value of mining products removed from forests, and water used for irrigation or in industries. This amount would be deposited in a special fund and used "exclusively for reforestation; forest protection; and other ancillary purposes connected with tree planting, forest development and conservation," the draft document noted.

"We welcome this withdrawal," said a statement by Campaign for Survival and Dignity, an activist collective.

Trade negotiators from the Office of the U.S. Trade Representative (USTR) are expected to visit New Delhi next week, or at the latest, the week after next, to continue discussions with Commerce Minister Pivush Goval and his team, at least three independent sources, from the Indian and U.S. sides, told The Hindu. This follows Mr. Goyal's visit to Washington, DC, on Wednesday for discussions with USTR Robert Lighthizer and his team to progress a limited trade package between the two countries.

The visit by Mr. Lighthizer's deputies to New Delhi was discussed on a telephone call between Mr. Goyal and Mr. Lighthizer on Thursday, when Mr. Goyal was back in New York City for industry interactions.

#### **Key differences**

On Wednesday, Mr. Goyal was accompanied to the trade talks by officials from the Agriculture and Health Ministries as well as members of the Indian Council of Medical Research (ICMR). Price caps or 'trade margin rationalisation' for knee implants and cardiac stents have been one of the key differences between the two sides. Also under discussion for months has been the Generalised System of Preferences - a preferential market access programme the U.S. offers developing country partners.

#### 'Unfair treatment'

India's GSP benefits were revoked in June on the grounds that India had not assured the U.S. that it would provide "equitable and reasonable" access to its markets, as per U.S. President Donald Trump's proclamation on the issue. Mr. Trump believes the world trading system, and more broadly, the multilateral system, treats America unfairly.

India has wanted its GSP benefits restored but it is unclear whether any limited

trade agreement reached between the sides will result in a full or partial restoration of GSP benefits to India. The meant to go on till noon but continued till at least past 2 p.m., The Hindu learned from a reliable source.

**Progress made** 

Sources close to both sides expressed optimism that progress had been made and a limited trade package was being finalised.

This optimism, that a limited deal can be reached, appears to be higher than it was at the end of September when Mr. Goyal and Mr. Lighthizer met in New York City hoping to stitch together a limited deal prior to the September 24 bilateral between Prime Minister Narendra Modi and Mr. Trump. The Hindu had then reported that a deal was out of reach at the time.

#### 'Symbolic win'

"I am increasingly optimistic that a deal can be struck. It won't be very big value wise, but after roughly 18 months of negotiating and almost six months since GSP was suspended, it would be a symbolic win for both sides," former USTR official Mark Linscott, who is currently a fellow at the Atlantic Council, told *The Hindu*.

"Hopefully no intervening developments derail an agreement before it can be concluded or is fully implemented," Mr. Linscott said.

## CJI rues 'indifference to decorum'

'Hooliganism is the order of the day in some pockets of court system'

Chief Justice of India Ranjan Gogoi on Friday addressed, through video-conference, judges across the country about the "increasing indifference to the decorum and discipline" within and outside courts.

Chief Justice Gogoi retires on November 17.

He will leave behind the legacy of the judgments in the Ayodhya, Rafale and Sabarimala cases. He delivered the lead opinion for the Constitution Bench which allows the construction of a temple in the Ayodhya land and referred the question of the role courts should take in religious cases in the Sabarimala review. The court under him dismissed a review in the government's purchase of Rafale jets.

On Friday, his last working day, he spent a few minutes in court, admitting all 10 cases listed before his Bench.

In his speech, the Chief Justice said the "indifference" is seen among those who are stakeholders in the justice delivery infrastructure but are apathetic to its health and progress

"The indifference of such stakeholders to the dignity of our institution has reached new lows in the recent past, as rank hooliganism and intimidatory behaviour has become the order of the day in some pockets of our court system " he stated

He said that as judges it was not their business to suffer such belligerency from a handful who masquerade as stakeholders and browbeat the seekers of truth and justice.

## Prasar Bharati working to get fresh content under new policy

As part of the first step towards overhauling the dated content on many Doordarshan channels, the Prasar Bharati Board on Friday approved a new content acquisition policy. The move will allow the public broadcaster to acquire the rights of series such as the *Mahabharata* and the *Ramayana* that it telecast in the past but of which the government has no ownership.

"The current policy was outdated and restrictive. With the new policy, we have tried to break the bureaucratic red tape to make the process simpler, and it offers us many more options to purchase new content," Prasar Bharati CEO Shashi Shekhar Vempati told *The Hindu*.

Under the old policy, the maximum price that the broadcaster could offer to acquire an episode was ₹50,000. Now it has been increased to ₹1 lakh-₹5 lakh. And if the cost of a particular programme is higher or the rules need to be relaxed to acquire a piece of exclusive programming then, as per the new policy, an empowered committee can decide on the viability. "For the last two years, we have just been recycling the old content. On any given day, none of the channels offers more than one or two hours of fresh content," a senior official said.

## Women free extremist leader in Manipur

A group of some 500 women in Manipur have managed to "rescue" a top extremist leader from a paramilitary force that had caught him for illegal possession of arms and ammunition.

The incident happened in Ukhrul district on Thursday night soon after Assam Rifles personnel caught "Brigadier" Thotmathing of the Isak-Muivah faction of the National Socialist Council of Nagalim (NSCN-IM) and two others, including the driver of the SUV he was travelling in.

As the news of the detention in Hoomi village spread, at least 500 women blocked the road that the convoy of eight Assam Rifles vehicles were travelling on. They pulled the trio out and "set them free."

The Tangkhul Shinao Long (TSL), a tribal women's organisation, justified the action of its members.

Gotabaya, Premadasa to square off in an election fought on national security and economic concerns

Nearly 16 million voters will have a say in Sri Lanka's biggest election on Saturday, that is being closely fought by presidential hopefuls Gotabaya Rajapaksa and Sajith Premadasa, though a total of 35 candidates are in the race.

National security and economic concerns dominate this presidential poll, coming seven months after the deadly Easter Day suicide bombings that killed over 250 people. Apart from gripping the country in fear – after a decade's relative peace since the civil war ended the terror attacks delivered a huge blow to Sri Lanka's tourism sector and economy that heavily relies on it.

Gotabaya Rajapaksa, candidate of the opposition Sri Lanka Podujana Peramuna (SLPP or People's Party), was a powerful war-time defence secretary, who has now made an entry into politics. The younger brother of former President Mahinda Rajapaksa, Mr. Gotabaya, 70, is pitching himself as a "strong leader", promising a safe country in the wake of prevalent anxiety over national security since the terror attacks. He has promised technocratic fixes to the economy that, he has said, will be knowledge-based under his possible leadership.

On the other hand, Sajith Premadasa, 52, of the ruling United National Party (UNP) was named candidate after an insurgent campaign within. Drawing huge support from grassroot organisers, he has since been trying to





All the same, Mr. Premadasa himself comes with a relatively untainted political record and appears to speak to the concerns of the poor. Further, he has drawn the main parties representing Tamil (in the north-east, and hill country) and Muslim minorities this election and is seen to be projecting a more inclusive approach to national politics, which has reassured his supporters.

Counting of the votes will begin on Saturday, soon after polling ends. Early trends are expected on Sunday, though the Election Commission will declare the final, official results on Monday. Sri Lanka follows a preferential voting system where voters can mark up to three preferences on the ballot. Preference votes will come into play if neither of the top two candidates secures over

## Trump attacks diplomat as she testifies in impeachment probe

Schiff says 'witness intimidation is taken very, very seriously'

As the second day of public hearings in the U.S. House of Representatives impeachment inquiry unfolded, U.S. President Donald Trump took to Twitter, attacking former Ambassador to Ukraine, Marie Yovanovitch, as

she sat in the witness chair.

As a hearing that brought to light threats and disparagement Ms Yovanovitch had faced, was underway, Mr. Trump tweeted, "Everywhere Marie Yovanovitch went turned bad. She started off in Somalia, how did that go? Then fast forward to Ukraine, where the new Ukrainian President spoke unfavourably about her in my second phone call with

"It's very intimidating," Ms. Yovanovitch said, when asked how Mr. Trump's tweets would impact those who were coming forward to testify. "I can't speak to what the President is trying to do, but I think the effect is to be Marie Yovanovitch

"I want you to know that some of us here take witness intimidation very, very seriously," Intelligence panel chairman Adam Schiff said.

Smear campaign

Ms Yovanovitch, who was abruptly removed from her post as Ambassador to Ukraine in May, testified that a smear campaign was run by the U.S. President Donald Trump's personal lawyer, Rudy Giuliani, and his son. Donald Trump Jr., and other Trump allies that led to her removal. She Also denied giving former Ukrainian prosecutor Sergiy Lutsenko a "Do Not Prosecute" list, to protect Americans.

Ms. Yovanovitch said she

was "absolutely shocked" and "devastated" when she learned of Mr. Trump's comments about her during his July 25 call with Ukrainian President Volodymyr Zelensky. "A person who saw me actually reading the transcript said that the colour drained from my face," Ms. Yovanovitch said.

## Roger Stone guilty on all charges

A jury convicted U.S. President Donald Trump's longtime adviser Roger Stone on Friday on all charges, finding the Republican operative and self-proclaimed "dirty trickster" guilty on seven criminal counts of lying to Congress, obstruction and witness tampering.

The verdict, in a trial arising from former Special Counsel Robert Mueller's investigation that detailed Russian interference in the 2016 U.S. election, is not only a blow to Mr. Stone but renews scrutiny on Mr. Trump's actions as a candidate at a time when he faces an impeachment inquiry that could derail his presidency. Mr. Trump denounced the verdict.

Mr. Stone, 67, was one of several former Trump aides to have been charged in Mueller's investigation.

## Israel to probe injuries to civilians in Gaza strike

Five children were among eight killed

Israel's military said on Friday it was investigating "harm caused to civilians" from an air strike it carried out in Gaza that Palestinian medics said killed eight members of one family, including five children.

It was the single deadliest incident in two days of hostilities between Israel and the Palestinian militant group Islamic Jihad in the Gaza Strip this week during which 34 Palestinians were killed, almost half of them civilians, according to Palestinian officials





## \_ Exports decline 1.11% in October

The country's exports dipped by 1.11% to \$26.38 billion in October on account of contraction in sectors such as petroleum and leather.

In September also, exports had contracted by 6.57% to \$26 billion.

Imports too declined by 16.31% to \$37.39 billion, narrowing trade deficit to \$11 billion in October, according to official data released on Friday. Trade deficit in October last year stood at \$18 billion.

Oil imports, in October 2019, fell 31.74% to \$9.63 billion as compared to the same month last year.

Exports during April-October this fiscal dipped by 2.21% to \$185.95 billion. Imports were down by 8.37% to \$280.67 billion.

## 'Regulation on cooperative banks soon'

## Essar verdict: banks to see profitable Q3

Lenders expect payment to be in by December 31; recovery to directly go into profit and loss account

Profitability of banks is set to get a major boost in the current quarter, with the Supreme Court on Friday paving the way for the acquisition of Essar Steel by ArcelorMittal. Banks have an exposure of about ₹50,000 crore to Essar Steel.

Some of the bankers said, according to the original resolution plan, ArcelorMittal will have five days to pay the creditors. "In any case, the payment will definitely come by December 31. So, this will boost the profitability of the banks for the Oct.-Dec. period," said a senior official of a public sector bank. Banks have already provided 100% for the loans given to the steelmaker. As a result, the recovery from this account will directly go into the profit and loss account, which will improve the profit.

State Bank of India will be one of the biggest beneficiaries which will get around ₹12,000 crore. "This muchawaited judgment also settles to rest numerous points of law under the Insolvency and Bankruptcy Code which were tested in various courts. This should significantly reduce the scope for long drawn litigations under IBC and would eventually lead to faster resolutions of stressed assets," SBI Chair-





## CoC getting final say, a big plus, opine lawyers

'Less challenge to NCLT orders likely'

The Supreme Court's ruling on the Essar Steel insolvency case will have far-fetched implications on the Insolvency and Bankruptcy Code (IBC) process and will quick-

en resolution, lawyers said. "The judgment is significant in many ways. It will make the process more expedient and efficient," Ajay Bhargava, Partner, Khaitan & Co, said.

He said, now that the Committee of Creditors (CoC) has the final say, it will lead to more certainty when a plan is accepted and there will be less challenge to the orders of NCLTs.

Mehul Bheda, partner, Dhruva Advisors said, "Prior to the SC ruling, banks and financial creditors' faith in the resolution through IBC mechanism was on the verge of being lost because of fear that the adjudicating authority may alter the distribution of resolution proceeds at its own discretion.

"[With] this judgment, the SC has restored the overarching object of IBC by upholding that it is the commercial wisdom of CoC which will determine the distribution of resolution proceeds. This will also facilitate speedier resolution of other IBC cases, since any litigation around treatment of operational creditors in the resolution plan should

now be put to rest," he said. Vaibhav Bhure, advocate, Bombay High Court, said, "The recognition of superior right of the financial creditors in proportion to their security interest in an insolvency resolution process would show a positive

attitude of such class of financial creditors in taking the insolvency resolution process to its logical end."

He said the 'equality for all' approach would prompt secured financial creditors to vote for liquidation rather than for the resolution process, which would defeat the very object of the insolvency Code.

Makarand Joshi, partner, MMJC and Associates, said operational creditors will now have to find ways and means to secure their payments against supplies made to companies, as post this judgment; they will not be considered on par with financial creditors like banks.

#### Paradigm shift

"This landmark judgment, which in a way has given its approval to amendment made to IBC, will bring a paradigm shift in the way operational creditors now deal with companies for their supplies in the eventuality of default to secure their interest," he said.

Since the SC has struck down the 'mandatory' timelimit of 330 days for completion of the resolution process, the decision will facilitate resolution, especially in cases where delays are caused due to capacity constraints of NCLT.

Anupam Dighe, partner at India Law Alliance said, "The rigidity of timelines which was faced in the closing process is also now interpreted to be more flexible so that the objectives of the code are achieved in true

## Approval ups investor confidence in IBC process

IBC's aim is time-bound resolution: RP

The Supreme Court's decision in the Essar Steel case sets a precedent for other cases under the Insolvency and Bankruptcy Code (IBC).

## Top court extends 330-day limit for insolvency resolution

Current limit restricts 'right to carry on business', says SC

In a judgment significant for India's fledgling corporate resolution process under the Insolvency and Bankruptcy Code, the Supreme Court on Friday increased the time limit for corporate resolution to extend beyond the mandated 330 days.

As of now, the time limit for resolution process is mandatorily 330 days in all cases. If debts are not resolved and the bankrupt firm cannot be brought back liquidation of its assets to pay creditors. A Bench led by Justice Nariman, in the ArcelorMittal judgment, observed that many litigants suffer the prospect of liquidation for no fault of theirs. Delay in legal proceedings leads to the resolution process being dragged beyond the 330-day mark.

The court said the 330day time limit was no longer mandatory. Justice Nariman said it would be arbitrary to let litigants suffer liquidation unnecessarily. The court held the mandatory frame, the only option left is of the 330-day mark as a violation of Article 14 (right to equal treatment) of the Constitution and an "excessive and unreasonable restriction on the litigant's right to carry on business under Ar-19(1)(g) Constitution".

The court mellowed the provision saying the 330-day mark should be followed in the 'ordinary course'. Extension of time should be granted by the NCLT if parties are able to prove there is very little time left in the resolution process and the delay has

## Rules notified to bring financial firms under IBC

RBI will decide which companies will be taken up under these rules, says FM

The Centre on Friday issued rules that provide a framework for bringing 'systemically important financial service providers' under the purview of the Insolvency and Bankruptcy Code (IBC).

"Section 227 of the [Insolvency and Bankruptcy] Code enables the Central government to notify, in consultation with the financial sector regulators, financial service providers (FSPs) or categories of FSPs for the purpose of insolvency and liquidation proceedings, in such manner as may be prescribed," it said in a release.

"Accordingly, the Ministry of Corporate Affairs has notified the Insolvency and Bankruptcy (Insolvency and Liquidation Proceedings of Financial Service Providers and Application to Adjudicating Authority) Rules, 2019 today to provide a generic framework for insolvency and liquidation proceedings of systemically important FSPs other than banks."

Finance Minister Nirmala Sitharaman said the notification was necessitated because there was no system

like the IBC that was designed exclusively for financial institutions. "This notification was brought out in an environment where it might be necessary to invoke an IBC-like proceeding on a financial institution, but where there is no exclusive arrangement for financial institutions," she told repor-The Minister added that it

was up to the Reserve Bank of India to now decide which financial companies would be taken up under these rules. However, she did add that the government was

rules exclusively for financial companies as well. "We want to bring in an IBC equivalent for financial companies."

"The introduction of an interim framework for resolution of financial service providers under the IBC is a timely and important step for resolution of financial service providers permitting an interplay between regulators, creditors and the NCLT (National Company Law Tribunal) for appropriate actions," L. Viswanathan, partner, Cyril Amarchand Mangaldas said.

He doesn't seem to withhold information or be guarded like many actors, and there's a sense that he gives of himself even in an interview, but he does seem to draw from a script (perhaps like a

He prefers the word patra, or vessel, used best as a receptacle for water. He says actors must have the three qualities of water: transparency, fluidity, and the ability to quench thirst. Hussain comes across as someone who has read widely (he talks about everything from quantum mechanics to spirituality), thought deeply about using words wisely, and delivers much like someone used to taking a class. In fact he does take classes

Reading about the lives of great actors, who were miserable in life, Hussain took the journey to be a good actor and a decent human being. "The quest, when you look for answers of the five basic Ws, which we were taught by Stanislavski, the father of modern

good actor he has prepared for this role too), answering different interviews in a similar vein. His performances though, are always contained, bringing together experiences of a lifetime to the here and now.

"Life is really short. I would love to sing. I'd like to learn dancing. I love painting and I have done a few which turned out to be good. I enjoy it, but I have to learn the craft. I would like to learn about herbal medicines." He is a part of The Green Hub, a video documentation centre to record the biodiversity of the North-East.

As for the size of the bicep – his Hollywood costume designers will know. After all they took eight days to do the perfect fit. Hussain jokes that in India, we're okay with mediocrity because "Agle life mein dekh lenge." The upside is that "It's not the end of the world, it's just a film."

## A quiet passion 📉

A little-known independent-artistrun school and gallery from Tripura is marking its sixth year at the ongoing India Art Festival

At the ongoing India Art Festival, a two-part stall near the back rows is occupied by a gallery called Kala Bhawan in Tripura. A far cry from the 30-odd galleries from the metro cities, Kala Bhawan is an independent school and gallery run by Delhi-based Nitai Das, who works with Doordarshan (DD).

His mother Shanti, a musician, had started the school in 1966, a year before he was born. "It was a very small school at the time and she used to charge only ₹5 a month for music and art classes. But I loved everything about them," he recalls. It was when Nitai returned after he'd graduated with a Bachelor's degree in Fine Arts from Santiniketan in West Bengal that he

began to get involved, first by teaching art, and slowly taking over the operation, later building a third floor space for the gallery. Over the course of his 26-

year-employment with DD, Nitai has also been growing his own art practice, having had solo shows at the likes of the Jehangir Art Gallery in Mumbai (2009), the Academy of Fine Arts in Kolkata (2010), and the Lalit Kala Akademi in Delhi (2011).

This is his sixth time participating in the festival, representing both himself as well as the various folk and tribal artists he brings under the Kala Bhawan banner. Sitting in his booth amidst his acrylic-on-canvases, Nitai talks about his future plans for this school, located in Ranirbazar, about half an hour away

from Agartala. Edited excerpts from a conversation.

#### Why did you start working with DD?

Around 1991 I was taking care of the school full time, when Doordarshan was opening its operations in the state. They needed someone who could read and write Hindi. I applied, got it, and have been working with them since 1993.

My first thought when I got the job was that, 'Okay, great I'll have enough money to run Kala Bhawan

#### Who has been looking after the school since you moved out?

I've put my younger brother, Gour Das in charge. He's a singer too. He's now also introduced mainstream education. Our parent organisation is called Pragya Shanti, with Kala Bhawan as the arts wing. There are now 450 students.

#### What art have you brought with you to the **India Art Festival?**

I have brought in a total of 43 artists, focusing on tribal art forms. This includes people from various states. There are tribal artists from Tripura like Swapan Deb Barman, and from Assam like Nilakshi Bezbaruah. I have some more from Bhopal too. I've made a little gallery with the works of all these artists. If I can manage to sell, then I give them

#### How often do you go back to the school?

I go back home twice a year. Every January, from whatever is left of our income – usually this is about ₹20-25,000, not more – we give an award to honour practising artists, who are 80 years and over. We haven't been able to do this over the last three years because we are doing construction and repairs at the school. But we are re-starting the awards in January 2020. I'm also currently making sculptures to install at the school's premises artists, authors, freedom fighters - we will put up their busts along the school's compound walls.

## Unapologetic feminism, trite action

The good intentions of the latest *Charlie's Angels* is wasted in an absolute dud of a thriller

As an answer to decades of being sidelined in mainstream Hollywood classics, women, both on and off camera, are demanding control of their narratives. Reboots with an all-female cast appear to be the answer for many.

Films like Oceans 8 (2018) and Ghostbusters (2016) swapped the gender of its leads, but contained all their messaging to 'if men can do it so can women'.

Charlie's Angels is an anomaly in this trend. The franchise always had women at the fore, yet the gaze was questionable.

The unapologetically feminist 2019 reboot, helmed by Elizabeth Banks in the director's seat, is an explicit (often self-proclaimed), and in some instances metaphorical (not that subtle) way of saying, 'Time's up' to the men (older white especially) who have enjoyed the position of power.

From opening the film with dialogues like, "Do you know it takes men additional seven seconds to perceive women as a threat?", the use of pop music by female artistes, a montage of women in various avatars supplementing the title appearance, to showcasing sisterhood in-between fights - the film demands to be 'feminine'. The women are neither the centre of desire nor are they 'macho-fied' to make them palatable to a male audience.

As an aside, the film is also conscious of race and sexuality-inclusion (although the latter with Kristen Stewart's character is speculative). All the right intentions and details are there in abundance. but if you take them all out,

the film is an absolute dud of an action thriller.

The film is one chase/fight scene after another, with an inability to build up to a gripping finale. The climax, which is supposed to be the most engrossing part of an action thriller, is its weakest section with a setup that is least imaginative – a party. The conflict wants to be as contemporary as it can with the plot revolving around a whistleblower in a potentially destructive tech company. But the narrative devices and storytelling are done and dusted - betrayal, big reveals, et al.

The space which the characters inhabit is an integral part of action sequences. The first big showdown happens in a Hamburg cafe, which is a luke-warm start, with characters flipping tables and kicking guns. Then a long sequence is shot in Hamburg's Elbphilharmonie, pretending it to be a swanky and well-guarded research centre for the evil company. More than the use of space, it's the getup of the Angels (bowl hair wigs) that's amusin in this scenario. The only setting that stands out is a factory with giant conveyor belts and concrete mixers, where the space interacts with the characters in a manner that generates some amount of thrill. Rest, be it a derby in Istanbul or the criminally-banal party in the climax, Charlie's Angels is

unable to be imaginative. The only takeaway then circles back to its messaging. There are ample instances where men are egging the Angels on with misogynistic, patriarchal, and patronising comments like, "It can be manufactured in pastel colours for ladies" or "If women can, that does not mean they should".

The women's response, both verbally and physically, counter these agitations. The climax, without saying too much, is also symbolic of 'we no longer will take it lying down'.

But what's the point of the feminist overtones when the film itself is unremarkable and highly likely to be consigned to oblivion?

Marjaavaan is an oddly structured film. From the beginning till the interval there is a "movement" which makes the first half a complete film in itself. In fact, that's where director Milap Zaveri should have shouted "cut" and wrapped it up.

The second half is utterly pointless, inane, and unbearable and therefore eminently avoidable. Not that it makes the first half seem like Citizen Kane in comparison. Far from it.

A deliberate throwback to the '80s masala genre, the film is eventually nothing more than a random stringing together of scattered scenes. Verbal confrontations alternate with elaborately staged fight sequences. Every conversation is bombastic, the wordplay irritating with characters throwing dialogue at each other.

Sample: "Todunga bhi aur tod phod ke jodunga bhi", "Maarunga kanpati pe, dard hoga Ganpati *pe*". Rain and slo-motion shots are used to give the impression of slickness to the action scenes, where actually there is none. Zaveri uses every available trope of '80s Hindi cinema right down to women being confined to the margins and the evocation of communal harmony with token Muslim figures, swing-

ing between being loyal friends or betrayers who are given the chance to return to the fold by the largehearted hero. Why, there's even a character called Mazhar who harks back to Mazhar Khan in Shaan

There is some chatter about Hindu-Muslim unity and the fights play out to Hanuman Chalisa alternating with Muslim prayers. All of it staged and orchestrated, rather than organic, while the world remains largely majoritarian. Violence is all pervasive, law and order and the cops are pushed to the corner. In the midst of this, Zaveri tries to contemporise things just a wee bit with a reference to Kashmir.

In a nutshell, the film is about a henchman (Sidharth Malhotra) caught between his love for an innocent, young girl (Tara Sutaria), his loyalty for the local mafia don (Nassar) and his rivalry with the

don's vertically challenged son (Riteish Deshmukh). Zaveri sticks to rendering characters into "types" than personalities throbbing with any complexities.

Nassar tries hard to give gravitas to the proceedings, Sutaria is sweet and listless and keeps smiling and weeping alternately.

Malhotra is a terrible fit for the action role. It's hard to let go of disbelief seeing him wrench a pipe out of the ground. This is the kind of stuff better left to Sunny Deol. The matchstick in the mouth is supposedly Rajinikanth. What was the point in dwarfing Deshmukh other than have him mouth some infantile lines that play on "height"?

Marjaavan is loud, overcooked and overdone. Turgid and tedious it just passes you by, without you caring for anyone or anything on the big screen.

## Pedal to the metal

Set in 1960s America where men in suits ruled the boardroom, Ford v Ferrari is less about America against Italy and more about the internal politics at the car company. The crux centres round the eternal debate of how far an ego will stoop to achieve petty vindication. This tussle is brilliantly machined by Josh Lucas playing the scheming Ford executive Leo Beebee.

While Damon and Bale's characters don't explicitly embrace their bromance that's just about lingering beneath the surface, the duo's moments of levity are heartwarming. AShelby's quiet Texan restrain perfectly complements Mile's Cockney brash, giving emotional breadth to Ford v Ferrari. But the film also soars because of a brilliant supporting cast, Bernthal - Netflix's The Punisher - steals plenty of attention with his turn as the only temperate character cooling hot tempers and egos. Letts shines in an emotion-fuelled breakdown that's both awkward and brave.

In spite of substantial car spec chatter, Ford v Ferrari still ensures a fun ride for all.



## The game-changer

Harmanpreet Kaur's power-hitting and athletic fielding have been at the forefront of revolutionising women's cricket in India

₹rowing up in Moga, Punjab, all Harman-Jpreet Kaur wanted in life was to be a cricketer. Since hardly anyone in her hometown – or most of the country, for that matter followed women's cricket at that time, she used to get teased.

"What will you do - open with Sehwag?" her younger brother would ask her.

She may not have walked out to bat with her idol, but

> the dashing former India opener once tweetea: "An innings of a lifetime, Harmanpreet Kaur...Fan!"

Sehwag was referring to the innings widely regarded as the greatest ever in the women's game and among the finest overall. That knock, against Australia in the semifinal of the 2017 World Cup at Derby, changed women's cricket in India forever.

Not since Kapil Dev's unbeaten 175 against Zimbabwe in Tunbridge Wells at the 1983 World Cup has an innings made such an impact. Two years after her epic 171 not out off 115 balls, Harmanpreet remembers every shot, every moment.

"I am grateful to god that I could play that innings," she told *The Hindu* in Surat on the day she became the first Indian cricketer to play 100 T20Is

"Earlier, I used to have talks with senior players like Jhulan Goswami about the lack of interest in women's cricket. We used to wonder when people would start coming to watch us play. I am glad that I could play a role in making that happen before I retired."

The innings may never have happened – she had feared that her World Cup was over when she injured her left ring finger earlier in the tournament. But for team physio Tracy Fernandes, she may have been sent home.

Biju George, India's fielding coach at the time, says it was a privilege watching Harmanpreet's innings at close quarters. "It is the best innings – by a man or a woman – I have ever seen in 50-over cricket," he says. "All of us in the dressing room knew that we were watching something special."

Snehal Pradhan, who played alongside Harmanpreet for India before becoming a journalist, says the feeling inside the press box was similar.

"That was the time when no Indian media house sent reporters for women's matches, but there were several from England and Australia, and we were discussing whether this was the greatest innings in ODIs," she

"It was after that match that I started getting calls from people wanting to know about women's crick-

Snehal first saw Harmanpreet during the 2008 Challenger Trophy at Ahmedabad. "She was my India-B teammate and was included as a medium-pacer," Snehal says. "But even in that match, she showed her ability as a hard-hitter though she had come in at

Harmanpreet was trained to strike the ball hard. Her first coach, Yadwinder Singh, would make her hit 100 to 150 sixes per day. This regimen enhanced her wirv strength and innate timing.

Biju says her high back-lift and smooth swing add distance to her hits. It's no surprise then that at just 19, in her first year of international cricket in 2009, she was turning heads with the might of her ball-striking.

"I have never seen any

woman hitting a cricket ball with as much power," says R.P. Singh, a Chandigarh-based coach who has worked with Harmanpreet. "I had only to suggest some slight changes to her technique and help her become

mentally strong." The combination of skill and will has contributed towards making her one of the biggest names in the game. She remains among the fittest in the squad – her yo-yo test scores are consistently high. With 2,372 runs from 99 ODIs and 2,032 runs from 103 T20Is, she is much sought-after in T20 leagues overseas.

Harmanpreet believes it is time India had a league of its own. "I think we are ready," says India's T20I captain. "Look at the way crowds responded to the Women's T20 Challenge at Jaipur a few months ago; there were full houses."

She says there is enough talent in India to have four or five teams in an IPL-like league. "There is already a group of 40 talented players in the domestic pool," she "Look at the case of Shafali Verma.'

Shafali was discovered at that four-match series in Jaipur. Last weekend, during the first T20I against West Indies in St. Lucia, the 15-yearold became the youngest Indian to score an international fifty, breaking her idol Sachin Tendulkar's record.

"We will get more stars like Shafali if we have a women's IPL," says Harmanpreet. "Such a league will reduce the gap between domestic and international cricket for our players."

The very fact that the BCCI has started to think about the possibilities of a women's league shows how much ground the sport has covered in the country. "Now people are coming out to watch women's matches and we are covered extensively by the media," she says. "The quality of our cricket has also improved drastical-

ly, the fielding in particular." Harmanpreet herself is a prime example of the fast rising standard of India's fielding. At the beginning of this month, she took an absolute blinder to send back West Indies' Statanie Tayioi in the first ODI at Antigua. She leapt high into the air and held a one-handed catch at long-on.

It was one of the finest catches you will ever see. Clearly, Harmanpreet knows how to change the game and entertain all at once, even without bat in hand

## For Formula One, the future is now

With little competitive interest remaining this season, teams are planning for the shake-up in 2021

There's a distinct endof-term feel about the penultimate race of the season - and it isn't just because of Brazil's traditional carnival atmosphere. With the drivers' and

constructors' titles decided, there isn't much competitive interest this weekend. The thoughts of those associated with the sport have turned to the future, which looks both uncertain and exciting. Next season is the last

## Mayank toys with a hapless Bangladesh attack

When he blasted Taijul Islam through square-leg for a four, raised his arms and turned towards the dressing room, Mayank Agarwal saw captain Virat Kohli signalling to him to concentrate and convert his 150 into a double hundred.

#### **Objective achieved**

A little over an hour later, the in-form opener charged down the wicket and heaved Mehidy Hasan into the stands, again turned around to the dressing room and raised two fingers to indicate to his captain that the objective had been achieved.

Mayank's second doublehundred in as many series ensured that India was on track to take a lead in the two-Test series against Bangladesh.

Thanks to Mayank, the protagonist, ably supported by Ajinkya Rahane and Ravindra Jadeja, India continued to toy with a hapless Despite Bangladesh. Mayank's marathon knock coming to an end towards the fag end of the second day's play, India finished with 493 for six – with a lead

#### Delight for the crowd

of 343.

Barring the first half an hour, when Cheteshwar Pujara (caught in the cordon just after crossing his fifty) and captain Virat Kohli (missed one that shaped back in for a rare duck) perished to an impressive Abu Jayed, the rest of the day's proceedings were a delight for the 13,500strong turnout at the Holkar Stadium.

Mayank continued his prolific run in Tests this season by making a mockery of the Bangladesh bowlers. He first rescued the team from a spot of bother after Kohli's dismissal with a 190-run association with Rahane.

By the time Rahane played an uppish cut to deep point and lost out on a deserved hundred, Mayank had alrea-

dy switched gears. Ravindra Iadeia ioined Mayank and the duo ensured that India finished the day with a bang.

#### **Going berserk**

India pounded 407 runs off 88 overs to put the Indore fans in danger of being deprived of enjoying cricket on Sunday. A whopping 190 of those were scored off the 30 overs in the last session, with Mayank going berserk.

The stylish opener tonked all the Bangladesh bowlers as he added 87 off 79 balls. He was especially harsh on the spinners Taijul and Mehidy, the two giving away 212 runs off the 48 overs they bowled on the second day.

While Mayank showcased drives trademark through covers and straight punches to the seamers, his prowess against the spinners came to the fore time and again. His nimble footwork and astonishing timing were reflected in the distance his

sixes travelled - all eight, in-

cluding the one that took

him to his double hundred,

sailed well over the fence. With Mayank on song, Rahane, after starting the innings with a couple of confident boundaries, switched to a supporting role in the afternoon session. Still, the Mumbai batsman's crafty innings was yet another example of his ability to bail the team out.

In the second over after tea, with the second new ball still being hard, Rahane was dismissed against the run of play and gave Jayed his fourth wicket.

Jadeja, after a cautious start, cut loose to put India in a position to declare overnight. It will be interesting to see if Kohli lets Jadeja go for his hundred on Saturday morning or unleashes his bowlers on the Bangladesh batsmen straight away on
