# Muslim law board to file review plea against Ayodhya verdict

Declines five acres allotted to Muslims, says it will 'not heal the wounds caused'

SPECIAL CORRESPONDENT LUCKNOW

The All India Muslim Personal Law Board (AIMPLB) on Sunday declined the five acres of land allotted to Muslims in Ayodhya and decided to file a review petition against the Supreme Court verdict in the Babri Masjid-Ram Janmabhoomi case.

The "restitution by granting five acres of land, where fundamental values have been damaged to the extent of causing national shame, will not in any manner heal the wounds caused," the Board said here, after a meeting of its working committee, chaired by president Maulana Sayyad Mohammad Rabe Hassani Nadwi.

The two decisions were taken through a "unanimous resolution," Board secretary Zafaryab Jilani told the me-

Jamiat Ulema-e-Hindu president Arshad Madni also issued a statement in favour of filing a review petition and argued that there was no question of taking up any alternative land for a mosque.

#### 'Not permissible'

The Board argued that mosques "are essential for the religious practice of Muslims" and that "building the same mosque at some other site in situations like this is also not

"We, on behalf of the community at large, make it clear that the five-acre land, as directed in the present judgment, will neither balance equity nor repair the damage caused in the country," the AIMPLB said in a separate statement. Stating that there was "no dearth" of mosques in Ayodhya, 27 of them functional, Mr. Jilani said the matter was not about a mosque but "rights to a land" and justice.

The AIMPLB argued that it decided in favour of filing a review petition, claiming there were "apparent errors in the verdict.'

'Installed by force' Mr. Ilyas also asked if the placing of idols of Lord Ram under the dome of the Babri Masjid "by force" on the intervening night of December 22-23, 1949, was "illegal", how were such illegally placed idols considered a deity? Even under "Hindu dharma shastra," they could not be a deity, he argued.

Further, the AIMPLB asked if "it was proven that Muslims had possession of the Babri Masjid from 1857 to 1949 and also offered namaz there," on what basis was the land of the mosque given to

Board was related to the use of Article 142 by the court. Mr. Ilyas said that while using Article 142, the judges did not consider that the exchange or transfer of masjid land was barred under Sections 104-A and 51(1) of the Waqf Act.

How could another piece of land be given in exchange for the masjid land, going against the statute and legal restrictions, he asked.

The AIMPLB's decision stands in contrast to the stance of the Sunni Central Waqf Board, whose chairman Zufar Faruqui, on the day of the verdict, stated that it would not go in for any review of the Supreme Court ruling or file any curative petition. Whether the Sunni Waqf Board would accept the five-acre land to be allotted to it by the Central government on the directions of the court would be decided at a meeting on November 26.

Asked to explain the AIMPLB's locus standi, as the court directed that the land be given to the Sunni Waqf Board, Mr. Jilani said the AIMPLB "represents the Muslims" and the case was filed on behalf of the community and not the Sunni Waqf Board alone.

## Gotabaya wins in presidential poll

Ruling party candidate in Sri Lanka loses despite leading in northeast

Gotabaya Rajapaksa, Opposition candidate in Sri Lanka's presidential election, on Sunday emerged winner, securing 52.25 % of the mandate and marking the return of the Rajapaksa family to power. Mr. Rajapaksa beat the

government's candidate Sajith Premadasa – who got nearly 42% of the vote share. Mr. Rajapaksa will be sworn in as Sri Lanka's seventh executive president on Monday in the historic city of Anuradhapura, his Sri Lanka Podujana Peramuna (SLPP or People's Party) said.

The Tamil and Muslim minorities in the northern and eastern districts, averse to a Rajapaksa return, voted decisively for Mr. Premada-

sa. However, this did not make up for the ground he lost to Mr. Rajapaksa in much of the Sinhala-majority areas. "I am the President of not only those who voted for me but also those who voted against me and irrespective of which race or religion they belong to," Mr. Rajapaksa said, following his victory.

Meanwhile, Prime Minister Ranil Wickremesinghe has said he will discuss the possibility of a parliamentary election with the Speaker and party leaders soon.

On Sunday, three Cabinet members, including Finance Minister Mangala Samaraweera, resigned.

### Allow Farooq to attend House: Oppn.

The Opposition parties in unison questioned the Narendra Modi government on the detention of Lok Sabha member and former Jammu & Kashmir Chief Minister Farooq Abdullah, but once again got no definite response from the government.

Speaking to the mediapersons after the all-party meeting convened by the government ahead of the winter session of Parliament, Leader of the Opposition in the Rajya Sabha Ghulam Nabi Azad said, "How can a parliamentarian be detained illegally? He should be allowed to attend Parliament."

While Prime Minister Narendra Modi and others heard the Opposition's demand, they did not respond, Mr. Azad said. "We anyway do not get any replies from the government on any issues," he added.

The question was raised by other lawmakers, including T.R. Baalu of the DMK

and Sudip Bandhopadhyay of the Trinamool Congress.

PM chairs coalition meet, responds positively to demand

The National Democratic Alliance, diminished after the exit of one of its oldest constituents, the Shiv Sena, met on Sunday, with the remaining allies of the BJP asking for a coordination committee and a convener for the grouping to avoid further alienation within the alliance. Prime Minister Narendra Modi responded positively to the demand.

Speaking to the media after the meeting, Lok Janshakti Party president Chirag Paswan said he personally felt the absence of the Shiv Sena at the meeting, and suggested that the grouping needed more cohesiveness.

The differences between the NDA allies, which we witnessed in Maharashtra, should not happen. That's why a convener or a coordination committee should be

### Marriage not 'good enough' to quash rape FIR: Delhi HC

Verdict will have implications on rape cases

Is marriage a "good enough" reason to quash an FIR for rape if both the offender and the victim decide to settle the case? The Delhi High Court says no.

In a significant verdict that will have implications on a large number of rape cases in India, the High Court has ruled that the offence of rape falls under the category of "heinous and serious crime" which cannot be quashed even if the parties have settled their dis-

pute or got married. A large chunk of the rape cases in India are reported against those who were

known to the victim. The latest report of the National Crime Records Bureau (NCRB) shows that of a total of 32,559 cases of rape reported across the country in 2017, in one-third or 10,553 cases the victim and offender were

husbands. The High Court verdict delivered last week by Justice Brijesh Sethi came on a petition by a man seeking to quash an FIR for rape registered against him in September 2013 at the Safdarjung Enclave police station here



## Delhi water is 100% safe: DJB

Agency criticises study done by Centre

The study by the Bureau of Indian Standards (BIS), which stated that Delhi's water was the most unsafe among 21 State capitals, is not reflective of the ground reality, the Delhi Jal Board (DJB) said on Sunday.

The study had noted that water samples from Delhi failed in 19 of 28 parameters.

DJB CEO Nikhil Kumar said, "We have tested 1.55 lakh samples since January and they were found to be satisfactory as per both BIS and World Health Organization (WHO) norms." He said that the WHO considers 5% unsatisfactory results as acceptable, but "the DJB results were much better".

"We have not received the [BIS] report and we do not know when and from where the samples have been taken. We assure Delhiites that DJB water is absolutely potable and 100% safe as per BIS and international standards," said Mr. Kumar.

Compared to the 1.55 lakh samples we have tested since January, the 10 samples is not reflective of the ground reality," he added.

A senior DJB official said that sometimes tap water has problems due to issues in connections from the main supply line to the households. "Many times we notice that complaints are due to problems in the connections from the main pipeline. It is the responsibility of the housing society or individual household to rectify it. The DJB is not responsible for problems in connections from the main supply line,"

the official added. The official further said that people often mix DJB water with supply from borewell, which can also result in lower quality of water.

### 19-year-old killed in road accident

A 19-year-old student died after he allegedly lost control of his SUV and rammed a stationary water tanker in southeast Delhi on Sunday.

Ansh Girdhar, a resident of Kalkaji Extension, was returning home when the incident took place on Okhla Estate Road near Hanuman Mandir, said the police.

The police received a call about the accident around 3.30 a.m. Ansh was rushed to AIIMS where he succumbed to injuries, said Deputy Commissioner of Police (South-East) Chinmoy Biswal.

Ansh was speeding when he swerved to avoid a tree trunk and lost control. The car hit a water tanker parked on the roadside before overturning, he said. Ansh was pursuing a course in physiotherapy at an institute in Vasant Kunj, the police said.

A case has been registered at Govindpuri police station, said the police, adding that the body has been handed over to the family after postmortem.

## Fake call centre that duped foreigners busted, 32 arrested

Illegal software, 55 computers, and 35 phones seized

The Delhi police have busted a fake international call centre, being operated from west Delhi's Kirti Nagar, allegedly involved in duping foreign nationals by posing as Canadian police officials. the police said on Sunday.

"We have arrested 32 people, including telecallers, in connection with the scam and have seized 55 computers, 35 phones, and illegal software along with other equipment from the call centre," said a police officer.

The police said that on November 15, they received inputs about fraudsters posing as Canadian police officials over the phone and duping foreign nationals on the pretext of saving them from Social Insurance Number (SIN) violations.

"SIN is a nine-digit number that is required to work in Canada and to have access to government programmes and benefits," said the officer.

A complaint was received from Canadian national Elvis Henry, who was allegedThe accused in custody.

ly duped of \$13,500, the police added.

Additional DCP (West) Sameer Sharma said that the police, along with a team from the Department of Telecommunications, raided the call centre in Moti Nagar. Jasjot Singh, Sarabjot Singh and Sagar Jain were found supervising the activities of the telecallers.

#### **VOIP** calls

Upon interrogation, the supervisors disclosed that they impersonated Canadian police officials and targeted Canadian nationals through Voice Over Internet Protocal (VOIP) calls, said Mr. Sharma.

Explaining the modus operandi, the officer said:

"The call centre was operational during night hours. The accused began with a robocall claiming to be from Service Canada and informed the recipient that there are several allegations linked with the victim's SIN. The victims were threatened with arrests if they failed to call back.'

"Those who called back were subjected to further threats, but then offered a one-time chance to pay and settle the matter," said the officer. The victims were asked to transfer money either through Bitcoin or gift cards.

The accused used callspoofing technology to mislead victims and one of the phones found at the spot had 'Bitcoin Blockchain Wallet App', which was used to receive money from victims in the form of Bitcoins, he added.

Raids are being conducted to nab others, including call centre owners - Raja, Sushil, Naveen, Bunny Arora and Pankaj, the police said, adding DoT officials are also probing the case.

### AAP to launch 'mass contact campaign'

In the run up to the Delhi Assembly polls, likely to be held early next year, Aam Aadmi Party (AAP) city convener Gopal Rai on Sunday announced the launch of a booth-level 'mass contact' campaign, which will be led by party MLA's in each of 70 Assembly constituencies.

The MLAs will organise 'Jan Samwads' at 4-5 booths in their constituencies every day, Mr. Rai said. At these meetings, work carried out by previous city governments, as well as AAP's own track record over the last five years, will be discussed.

In constituencies without an MLA, the campaign will be carried out by the Vidhan Sabha incharge along with the 'Sangathan Mantri'. The party will also begin forming booth-level poll committees through this campaign, Mr. Rai said.

Around 2,700 'mandal incharges', already appointed by the party, will be present at these meetings and lead the process to form the panels, he said. The campaign will be monitored by up to 70 "observers".

### 3 held for duping finance firm of ₹20 lakh

One of the accused is an employee of the company

Three men have been arrested for allegedly duping a finance company of ₹20 lakh. One of the accused is an employee of the firm, the police said on Sunday.

Sunil Kumar (25) was working as a marketing agent at Leyland Finance Limited. Harish Dhingra (40) worked as a share broker, and Mohammad Sualeheen (28) is a dealer of old tyres in Jama Masjid, they said.

According to the police, a complaint was received stating that Sunil and his associates had fabricated documents of customers and obtained loans from the company for himself.

After getting the loans, the accused procured 28 scooters on 'hire-purchase' basis, said Deputy Commissioner of Police (South-East) Chinmoy Biswal.

A case was registered in this regard at Okhla Industrial Area police station.

During interrogation, Sunil disclosed the names of his associates, who were later nabbed by the police.

It was revealed that Harish was the mastermind behind the fraud and lured marketing agents of finance companies, who worked in automobile showrooms, and facilitated loans for prospective buyers, said

## Man killed in Narela factory fire

Smoke trapped victim inside the building, says fire official

A 32-year-old man was burnt to death after a fire broke out at a shoe factory in outer Delhi's Narela, the police said on Sunday.

The body was beyond recognition and it is suspected to be of security guard Mangal Mandal, a resident of Bihar, they said.

Chief Fire Officer Atul Garg said they received a call regarding the fire around

12.45 a.m. "The fire started from the ground floor of the factory and spread to the other floors. A total of 24 fire tenders were rushed to the spot. Firefighters brought the blaze under control within an hour," he said.

Mandal's body was near the stairs on the top floor of the factory, the official said, adding that the floor's gate was locked from the inside.

"We suspect that he was trying to escape but got

stuck in the building as raw material inside the factory created a lot of smoke," the fire official said, adding that the victim worked on the night shift. All three stories were engulfed in the blaze.

Factory owner Praveen Kumar told the police that it was a holiday on Saturday and only Mandal was inside. We are probing if there was any other person trapped inside," said Gaurav Sharma, DCP (Outer North).

### JNU students to march to **Parliament** today

JNU students on Sunday announced that as part of their protest against the hike in hostel fee, they will organise a "long march" from the university to Parliament on the first day of its winter session on Monday.

The JNU Students' Union (INUSU) said that the march was to "save public education" and they would like to ask Parliamentarians to ensure that "education remains a right and not a pri-

The JNUSU appealed to students from other universities to lend their support to the protest and join them on their march.

"JNU is on the brink of destruction and if the university administration has its way, fees will rise by over 1.100%.... As per INU's own data, over 40% of students will have to dropout and possibly leave their education," said the students'

## 'If JNU doesn't roll back hike, I may have to abandon studies'

Many students say they will not be able to sustain themselves without subsidised education; 'partial roll back of hostel fee hike is of no help'

NEW DELHI

When Devika, a second-year BA student, left her home in Kerala to study at Jawaharlal Nehru University (INU), she entered the gates of the university with an assurance that she would get quality education at a cost she would be able to afford on her own.

However, two years into her course, she feels cheated as the hike in hostel fee has left her wondering whether she will be able to continue to fund her studies.

"When we took admission here, we were assured that we could study and live here by paying a small amount. Now, out of the blue, the JNU administration has increased the fee and we feel cheated," says Devika.

There are hundreds of students who are worried as they do not rely on their parents for money and were given permission to come to Delhi to study only because it was not a financial burden on their family, she adds.

Henna, a first-year MA stu-

dent who also hails from Kerala, echoes Devika's views.

"I am only in my first year and I am considering going back home to complete my education if the hike in hostel fee is not rolled back. We came here keeping a certain budget in mind. We could have gone elsewhere also. It is like buying a ticket for a particular event and then being told that the show has changed. The administration could at least have brought in the changes in a phased manner so that students coming here would be able to take an informed decision with respect to their financial planning," says Henna.

**Protests on** 

Since October 28, hundreds of students have taken to the streets against the hike in hostel fee, some of them have never taken part in any activism or missed a single class but are now on the roads demanding a roll back to secure their future.

The JNU Executive Council's decision on a "partial

roll back" has not managed to pacify the students as they feel that the exemption to Below Poverty Line (BPL) students is vague.

Nandini Sharma, a second-year student, says she had to fight with her father, a farmer, to study at JNU.

"My mother and uncles supported me but my father did not want to send me to Delhi from Bihar to pursue my studies because we could not afford it," she says.

"When I came here I stayed in a dormitory with a friend the first night. It was only after learning that the cost of living was affordable did my father let me stay on and continue my education. I give tuition in the evenings to sustain myself but if the

Yash, an MA student, says those who are saying that the fee hike is only marginal do not understand the background of students studying here. Most of them are firstgeneration learners, without subsidised education they will not be able to sustain themselves here, he says.

"I have read comments on social media questioning the protests saying ₹600 per month is not a huge amount. If these people come to JNU and speak to the students from rural and deprived backgrounds, then they will understand the background many students come from and what they had to sacrifice to continue their studies,

Former INUSU president Geeta Kumari says she will have to discontinue her studies if the fee hike is not rolled back.

"My father retired from the Army and now receives a pension of ₹30,000 per month out of which ₹15,000 goes for loan repayment. We do not have any land or other assets. We are surviving only because we live in a village. I have two other siblings who are dependent on my father. If I am able to complete my PhD, I will be the first to do so from my family. But the administration is making things very tough. I cannot ask my father to support me as I know he does not have the money. I will have to reconsider the future

of my education," she says.

The cost of raising her voice has come in the form of a fine and it has risen to almost ₹50,000 during the fee hike protests. She still has pending fines from protests she participated in during her tenure as president of

the JNUSU. "The administration wants to ruin the life of students by increasing hostel fee and then imposes fines when we protest. But this is a fight not just for JNU students but for the future of affordable higher education in the country. Why should only the rich have access to higher education," says Geeta.

Depanjan, a final year PhD student participating in the protests, says he has completed his stay at the university but is attending the protests so that future students will not have to think twice before taking admission.

"After finishing my M.Phil at Hyderabad Central University, I got a job that paid me ₹20,000 but it was because of the affordable fee at JNU that I could let go of the job and think about pursuing a Ph.D here. With the current hike in hostel fee, students will not be able to do research as they will have to think about how to earn money to support themselves instead of concentrating on

# JNUSU has not been notified: Umesh Kadam

'Administration open to dialogue, but can't have it with non-notified students' union'

Umesh Kadam, Dean of Students at Jawaharlal Nehru University, on Sunday said that the JNU Students' Union representatives were not invited for the inter-hall administration meeting held on October 28 as the university had not notified the students' union for the year.

He added that the JNU administration was open to dialogue with elected hostel representatives but not with the "non-notified" students' union, to end the stand-off by students over the hike in

"The JNUSU election results are still lying with me in my office in a sealed envelope. The election committee announced the results without taking that sealed envelope from me. How can we notify the students' union when the results are still with me," he said.

Mr. Kadam was speaking at a press conference organised by "concerned" faculty members of the university who said that they were working to end the strike by students on the campus so that academic life could resume.

'Politically motivated'

Also present at the conference was Vandana Mishra, Associate Dean, who alleged that she had been confined to her classroom for 29

hours by protesting students last week. Sharing her experience,

Ms. Mishra said that the entire protest was politically motivated as during the time she was confined by students to her classroom, none of them wanted to discuss matters relating to changes in the hostel ma-

"The students were only interested in calling me names and were alleging that I was affiliated to certain political outfits. They never engaged me in a discussion about the hostel rules or hostel fee hike. This shows that it is only a protest with political animosity.'

She added that students

have every right to protest democratically but the protests that were going on were not democratic.

"You cannot reason with a mob of students. If they want to discuss or debate any point in the manual, they must do so through proper channels. The JNUSU has not been notified by the university. It is the elected hostel presidents that need to come forward and discuss matters and they were the ones who were invited to the IHA meet."

Mr. Kadam said that the university was only following guidelines from the UGC that directed universities to generate internal receipts + for hostels.

## DU teachers write to President Kovind over 'looming crisis' in SOL

They call for revoking of semester system

Expressing concern over a "looming crisis" in Delhi University's School of Open Learning (SOL), where for the first time semester examinations are to take place later this month, several teachers have written to the university visitor, President Ram Nath Kovind, calling for postponement of the exams and rolling back of the semester system for this

Delhi University had introduced the Choice Based Curriculum System (CBCS) to the distance learning programmes it runs, including the SOL and NCWEB, in the current session. As a result, instead of annual mode of examinations, students will have to sit for the semester examinations. Since the start of the academic session, several students, under the banner of Krantikari Yuva Sangharsh (KYS) have been highlighting the lack of preparation to implement the new system and have been carrying out regular protests against it.

"There has been chaos at all study centres of SOL since the introduction of the system," the group reiterated in a statement on Sunday. The group also alleged that study material had not been made available to most. "All this while the exams are due this very month," it added.

"We have been observing the growing agitation of SOL students and the high handedness with which the university is circumventing to their objections regarding the manner in which the system has been intro-

East Delhi's congested Krishna Nagar Market may soon witness on-street parking charges with the civic body planning to tender out the parking here to a private concessionaire, a senior official said.

The market is one of three sites in the city where the Environment Pollution (Prevention & Control) Authority (EPCA) has instructed the civic body to carry out pilot parking projects that may be replicated in other areas.

The EDMC had in the second week of October carried out a temporary pedestrianisation of the market, with multiple roads blocked for vehicles. The pilot project involved the deployment of several traffic policemen and municipal staff to keep a check on traffic movement and illegal parking.

Nodal officer in-charge, Assistant Commissioner Aman Rajput, said that the private contractor would be in-charge of various aspects such as barricading and security apart from which it would also turn parking here into a source of revenue.

The EDMC will soon issue a short-period tender for the same and hopes to have the system along pedestrianised stretches in place by the first week of December, the official said.

Parking in the area is currently free, but as per the new parking policy by the Delhi government, Mr. Rajput pointed out, onstreet parking is not permitted.

Nagarro CEO Manas Fuloria said: "Nagarro employs 5,000 people in Gurugram and the National Association of Software and Services Companies [NASSCOM] employs may be 100 times this number here and form the main engine of the economy. On behalf of NASSCOM, Haryana, I can state that we are suffering greatly on account of air pollution. Our people are unwell; they are frustrated. They are leaving for other cities and countries. And our international clients are ner-

vous. They are cancelling

their trips to India."

Mr. Fuloria, along with several other protesters, also held a token hunger-strike at the venue. The protesters carried placards pleading with the government to grow forests and sought the right to live and breathe clean air.

Pawan Tayla of Art of Living said that it was heartwarming to see the people of Gurugram from all walks of life voicing their concerns for


turday, as per CPCB data. The air quality is likely to improve marginally on Monday but may deteriorate on Tuesday, said forecasting agency SAFAR.

Pointing out that there is a "strong correlation" between stubble burning and pollution in north India, Chief Minister Arvind Kejriwal said: "The stubble burning has stopped and with it, the air quality in Delhi has improved."

Meanwhile, BJP MP Vijay Goel and members from the party's Delhi unit held a protest at Jantar Mantar on Sunday accusing the AAP government of failing to curb pollution in the Capital.

otorists have increasingly become more willing **▼ ⊥** to comply with the oddeven restrictions, as per analysis of prosecution data of the three editions of the scheme that the city has seen since 2016. The third and latest edition concluded on November 15.

The scheme was initiated by the Aam Aadmi Party (AAP) government as a measure to tackle rising air pollution in Delhi. Oddeven is a road-rationing system in which vehicles with registration numbers ending with even digits are allowed to run on even dates, and those ending with odd numbers are permitted to ply on odd dates. The restrictions do not apply on Sundays.

During its 13-day debut from January 1 to January 15, 2016, a total of 10,058 motorists were penalised for not following the regulations.

The rule was enforced again from April 15 to April 30, 2016. In the 14-day period, 9,576 drivers were issued the ₹2,000 fine for violating the rules.

The third and latest edition of the scheme has been the shortest. It was implemented from November 4 to November 15, but the scheme was suspended on Sikh community could observe Guru Parv without any restric-

In effect, the third iteration of the scheme lasted only nine days. During that period 4,885 fines were issued to violators. This time the penalty was ₹4,000.

The Delhi government has said that the dip in prosecution figures was evidence of the scheme's increased acceptability among the Capital's citizens.

"The decrease in fines issued this time indicates an increase in voluntary compliance with the regulations of the scheme. It also shows that the people of Delhi are ready to do their bit for better environmental conditions if governments in power make an effort to address the issue," said Jasmine Shah, vice-chairman of the Dialogue and Development Commission of Delhi, a government think-tank.

#### **Scheme extension**

"As far as environmental impact [of the scheme] is concerned, there are many studies which have proved its effectiveness in bettering the air quality of the Capital," Mr. Shah said, adding that the Delhi government is monitoring the Air Quality Index (AQI) of the city on an hourly basis and a decision on whether or

A senior traffic police officer said they identified 200 traffic points in more than 50 traffic circles across the city to enforce the scheme - in coordination with the Delhi Transport and Revenue departments.

"This time, it was easier for the traffic police to identify violators as there was no exemption for CNG vehicles. In 2016, traffic policemen first had to look for a CNG sticker before noticing the registration number," a police officer said, adding that the Delhi Traffic Police issued on-the-spot e-challans to violators.

### Schools shut; fine doubled

After the implementation of the new Motor Vehicle Act this year, motorists were "very cautious" and sought to avoid violating any traffic rules, the officer said, adding that this may have had an impact on the downward trend


"This time, the fine amount

was ₹4,000... double the fine amount issued when the rule was first introduced," a traffic policeman pointed out.

"Fewer cars were seen on the roads as people voluntarily carpooled. Schools remained shut for four days due to extreme pollution levels during the scheme," said another traffic policeman.

Despite a clash between police and lawyers at the Tis Hazari Courts on the day the odd-even scheme came into effect, the force managed to fine 233 violators. A day after the clash, policemen staged a massive protest at the Delhi PHQ at ITO; but they still managed to catch and fine 213 motorists violating the oddeven rule.

After the conclusion of the second edition, the Delhi government formed a six-member committee to study the impact of the opening of schools and hot weather on the scheme. The committee had concluded that the second iteration was "largely successful" as car owners voluntarily complied with the initiative. It also pointed out that

## It's BJP vs. the rest in Jharkhand

JMM, Congress and RJD have stitched a seat-sharing arrangement for the polls

With just two weeks to go for the first phase of Assembly elections in Jharkhand, it appears it's going to be the ruling BJP versus the rest. The opposition Jharkhand Mukti Morcha (JMM), the Congress and the Rashtriya Janata Dal have stitched a seat-sharing arrangement, while the BIP and its alliance partner All Jharkhand Students' Union (AISU) are not admitting publicly that the alliance between them has fallen apart.

The BJP's other alliance partners in neighbouring Bihar, the JD(U) and the Lok Janshakti Party (LJP), are contesting alone in Jhark-

Senior BJP leader and Minister for Civil Supplies, Food and Consumer Affairs in the Raghubar Das Ministry, Saryu Roy, 68, on Sunday declared he was contesting the poll independently.

Mr. Roy, who has regularly been exposing corruption in the State and raising his voice against his government's "wrong policies", appeared hurt over his name missing from the BJP's list of 72 candidates for the 81member Assembly.

**Minister upset** 

On Saturday, he wished the JMM chief ministerial candidate Hemant Soren a "bright future". Mr. Roy is also said to be upset with his own party for giving ticket to Bhanu

Pratap Shahi, who is an accused in a ₹130-crore mediprocurement scam which had rocked the then Chief Minister Madhu Koda's government between 2006 and 2008.

While speaking to a national news channel, Mr. Roy disclosed that BJP president Amit Shah didn't like his "friendship" with Bihar Chief Minister Nitish Kumar. "Now. I'm not going to beg for a ticket from my party", he told journalists in Jamshedpur. Mr. Roy, originally from Bi-

har's Buxar district, represented Jamshedpur (West) seat in the Jharkhand Assembly and this time he is likely to contest both from Jamshedpur (East) against Chief Minister Raghubar Das and Jamshedpur (West). Polling for Jamshedpur East and West seats will be held on December 7 and the last date for filing nomination is No-

Earlier, the JMM, the Congress and the RJD had announced that their alliance was contesting 43, 31 and seven seats respectively.

The BJP's alliance partner AISU had demanded 17 seats but the BJP was unwilling to give them not more than 13 seats. Meanwhile, the BJP announced its candidates for some of the seats the AJSU wanted to contest and, later. AJSU too fielded its own candidates against BJP nominees. "They want to play the victim card telling voters that the alliance fell apart because of the other", said JMM leader Soren.

Besides, the JD(U) and LJP too have declared they are contesting in 81 and 50 seats respectively and this is likely to make a dent in the BJP vote bank. Former chief minister Babulal Marandi-led Iharkhand Vikas Morcha (JVM) too is contesting the election independently.

## Vehicles of U.P. govt. agency that acquired land torched

Farmers protested on Saturday over compensation issue

Plastic pipes and vehicles outside a State infrastructure agency godown here were set ablaze on Sunday, a day after farmers clashed with police demanding adequate compensation for their land that was acquired for an upcoming township by the agency.

The incident took place around 11 a.m. outside the godown of the Uttar Pradesh State Industrial Development Authority (UPSIDA) which acquired the land for the Trans-Ganga City project near Kanpur, officials said.

"Some anti-social elements had set fire to plastic pipes kept outside the godown. Apart from this, two vehicles were also set afire," Additional District Magistrate Rakesh Singh said.

"No farmer has so far

claimed responsibility for Sunday's act, which means that the work has been done by anti-social elements," District Magistrate Devendra Kumar Pandey said.

On Saturday, farmers demanding better compensation for their land clashed with the police when government officials visited the project site to clear the encroachment.

Several farmers were injured as the police batoncharged them, used tear gas and water cannons. Many police personnel were also injured as the protesters targeted them with stones.

Meanwhile, the Rashtriya Kisan Manch, a forum working for welfare of farmers, claimed that the growers were not indulging in violent protests and were only demanding adequate compensation for their land.

"Nearly 30% of the farmers of the clash-hit area are yet to get compensation from the government," RKM president Shekhar Dixit said on Sunday.

The district magistrate, however, had said on Saturday that the farmers were adequately compensated.

#### Priyanka tweet

Congress general secretary Priyanka Gandhi Vadra shared a 22-second-long video of the clash on Twitter.

"UP Chief Minister is making big speeches in Gorakhpur, but see the condition of his police. A farmer in Unnao is lying semi-conscious after being beaten by laathi (stick). He is still being beaten up. There should be some shame. A person who grows grains for you is subjected to such cruelty," she tweeted.

## 'Give ₹2,500 per acre to Haryana farmers for not burning stubble'

State govt.'s ₹1,000 per acre not enough: Hooda



Former Haryana Chief Minister Bhupinder Singh Hooda on Sunday demanded that the Haryana government give compensation of at least ₹2,500 per acre for crop residue management to small and marginal farmers who did not burn stubble.

If Punjab can give ₹2,500 per acre as compensation to small and marginal farmers who refrained from burning crop residue, why can't Haryana do the same, the senior Congress leader asked.

Speaking in his home town, Rohtak, Mr. Hooda said the State government's announcement of giving ₹1,000 per acre as operational charge for managing crop residue would not be enough.

The Leader of Opposition in the Harvana Assembly al-

so suggested the government to fix a minimum support price for crop residue and purchase it from farmers the same way it procures

"The government should fix MSP and purchase the crop residue, which can be put to use in various industries, including in power plants," he said.

Regarding pollution levels

increasing due to stubble burning, the 72-year-old opined that blaming farmers who set fire to crop residue was not going to solve the problem as various stakeholders need to find a solution to the issue.

### 'Various factors'

"There are various factors that cause pollution. Burning stubble is only one of them. There is pollution caused by vehicle fumes, industries, construction activities and several other factors that are responsible for it. Just putting the blame on farmers is not the right thing to do," Mr. Hooda said.

Notably, burning of crop residue by farmers in Haryana and Punjab is being stated to be one of the major reasons behind the severe pollution levels in Delhi-

"The Centre believes tribals should be heard before any decision is taken. Issues should be resolved locally and States should do their bit. So far nine States have submitted status reports," Union Minister of State for Steel Faggan Singh Kulaste told The Hindu.

According to a report of the Standing Committee on Forests, 25,000 hectares of forests were diverted for industrial use every year across the country, said Madhuri Krishnaswamy, of Jagrit Adivasi Dalit Sangathan.

'Eye on polls'

As for the Centre's withdrawal of the proposed changes to the FRA, she said, "This was done keeping an eye on the Assembly elections in Jharkhand. We fear they will revive the plan after the

## Protests lined up against Citizenship Bill in Assam

Bharatiya Janata Party is likely to reintroduce the Bill during the winter session of Parliament

More than 100 civil society and students' organisations and political parties have lined up protests against the BJP's move to reintroduce the Citizenship (Amendment) Bill during the winter session of Parliament.

The Bill seeks to fast-track the process of granting citizenship to non-Muslims who have allegedly fled religious persecution from Afghanistan, Bangladesh and Pakistan till December 31, 2014.

The Left Democratic Front, Assam, a coalition of nine political parties including the Communist Party of India (Marxist), Janata Dal (Secular) and Nationalist Congress Party, has called for a State-wide protest on Monday.

#### 'Anti-Assam'

"The Bill is communal and anti-Assam, as it would render the expensive exercise of up-

dating the National Register of Citizens meaningless," a spokesperson of the Front said on Sunday.

About 30 organisations aligned with the All Assam Students' Union have chalked out a series of programmes for drumming up support against the push for the "jatidhwangshi" (race-destroying) Bill.

According to the Union, the six-year Assam Agitation for ejecting illegal migrants would go waste if the Bill is passed by

Parliament.

The Assam Accord of August 1985 that put an end to the agitation had prescribed March 24, 1971, as the cut-off date for detecting and deporting illegal migrants from the

#### 1966 base year

The NRC is being updated on the basis of this cut-off date, although officials have allegedly considered 1966 as the base year for ascertaining the citizenship of people belonging to the non-indigenous

communities.

Another 70 organisations, led by the Krishak Mukti Sangram Samiti, have also announced a "door-to-door" campaign against the Bill from Monday.

A Samiti spokesperson criticised Assam Health and Finance Minister Himanta Biswa Sarma for insisting that the Bill would be in the State's interest.

# Police launch probe into hacking of ATM booths in Agartala

The Cell marked three ATM booths of the State Bank of India and one of the Tripura State Cooperative Bank in the bank heist. "ATM card skimmers were installed in the booths to commit

the fraud," an officer connected with the probe told *The Hindu*.

He said CCTV footage of the booths was being checked to identify the accused. Those who lost money are customers of the SBI. The Cyber Cell, which is taking support of the bank's technical wing, has made some progress in the investigation. Sources said the hackers worked out of Kolkata.

Meanwhile, the Tripura police have appealed to those who have used any of the four ATM booths in the past couple of days to change their PIN immediately.

## Uncertainty looms large as Pawar set to meet Sonia today

Meeting may decide if Cong., NCP, Sena stitch together alliance

The uncertainty over who will form the government in Maharashtra looms large with all eyes now set on the meeting between Congress president Sonia Gandhi and Nationalist Congress Party (NCP) chief Sharad Pawar in Delhi on Monday.

Other senior leaders of both parties are likely to reach Delhi on Monday and Tuesday as the talks between the party chiefs are likely to stretch for more than a day. The meeting in Delhi is likely to finalise the fate of the State's political situation, and whether a Shiv Sena, Congress and NCP government will take

shape for the first time. "Our president Sharad Pawarji will meet Congress president Soniaji Gandhi in Delhi on Monday. We held a core committee meeting and decided to plan our next move only after discussions with the Congress, as we fought the election together. Other party leaders will meet on Tuesday, and a decision on forming a government will be announced soon," the NCP's chief spokesperson Nawab Malik said.

The Congress, meanwhile, is silent on the possible outcome of the meeting as the State leadership has been kept out of the loop on the developments in Delhi. "We have presented our side to Soniaji and requested her that this opportunity should be taken up. But everything

## 11 leopards trapped in three weeks in Gujarat

Suspected to have caused 8 deaths

Eleven leopards have been captured over three weeks in Guiarat's Junagadh and Amreli districts on suspicion that they are responsible for the deaths of eight people since April this year, a senior forest department official said on Sunday.

The latest among the 11 was a female leopard, which was trapped on Saturday night from the farm of one Kurjibhai Kyada in Manekvada village in Amreli, chief conservator of forests, Junagadh Wildlife Circle, Dushyant Vasavada said.

A leopard was trapped from Lunghiya village in Amreli on November 13 and another in Shivthali in Junagadh the next day, over 300 km from here. "These leopards have been captured in the region around Visavadar taluka of Junagadh, and Dhari and Bagasara talukas of adjourning Amreli, from where eight deaths have been reported due to leopard attacks since April this year," Mr. Vasavada said.

He said scat and pug marks were being analysed to zero in on the leopards responsible for attacks on humans, adding that the big cats were being kept at the Sasan rescue centre. "We suspect these leopards are behind the attacks. They have been held as a preventive measure, and they are not going to be released any time soon," the official said.

The decision to catch the leopards was taken last month after a 60-year-old man, Valabhai Maru, was killed in Visavadar, Prior to this, a 5-year-old boy was killed in Champathal village, and two others in Molvel.

## Seismometer, other key devices at Jayakwadi dam goʻout of order'


Retired MERI staff to be enlisted to repair equipment

The seismometer, which helps measure the magnitude of an earthquake, and several other key instruments installed at the Jayakwadi dam in Aurangabad district have stopped functioning properly, an official said on Sunday.

Retired staff of the Maharashtra Engineering Research Institute (MERI), who have expertise in repairing these devices, are being roped in to get them fixed.

"The seismometer was installed at the Jayakwadi dam after the devastating earthquake in Killari in Latur district in 1993. This instrument is powerful as it has a range of 10,000 km. In the past, it has recorded the epicentres of earthquakes in Pakistan, Afghanistan, Rus-

sia and Nepal," executive engineer Rajendra Kale said.

"But this and other instruments, like the piezometer, earth pressure cell and slope meter, have been out order for the last two years. Every instrument is important and we are trying to get them re-

Kerala government can act only according to court orders, says Balan

Kerala Law Minister A.K. Balan said on Sunday that there was a de facto stay on the Supreme Court's September 2018 order granting unrestricted entry for women to the Sabarimala Ayyappa temple, adding that the State could act only on the basis of the verdict.

In a 3:2 verdict on November 14, the five-judge Constitution Bench decided to refer the matter to a larger Bench to re-examine religious issues, including those arising out of its 2018 verdict lifting the centuries-old ban on women of menstruating age visiting the temple.

"In this case, a constitutional government can act only according to the orders of the court. Now, we have a new problem. The question is whether the November 14 verdict has stayed the earlier order. De jure, there is no stay..., but de facto, there is a stay. The 2018 order has been stayed in effect, though it was not officially mentioned," Mr. Balan told reporters.

De jure means existing or holding a specified position by legal right, while de facto means existing or holding a specified position in fact, but not necessarily by legal

Though the court did not stay its 2018 order allowing the entry of women into the temple, the LDF government in Kerala has said the shrine is not a ground for activism and has made it clear it will not help women who want to visit the temple for publicity. On Saturday, the police said some women were sent back from the Pamba base camp as they were in the "barred" age group.

Supreme Court verdict, permitting entry for women of all age groups into the temple.

The rituals began with chief priest (Tantri) Kandararu Maheshwararu Mohanararu, performing the Ashtadravya Maha Ganapati homom in the morning. Both the Tantri and the Melsanthi distributed prasadom (sandal paste with flowers offered to the deity) to the devotees.

Neyyabhishekom, the ritualistic pouring of ghee over the Ayyappa idol, which the devotees consider an important offering to the deity, began at 3.30 a.m.

The 41-day Mandalam pilgrim season will come to close on December 27.

Rebellion seems to be festering in four constituencies

He will accompany N. Nagaraju (MTB) as he files his nomination as BJP candidate for the bypolls from Hoskote on Monday.

BJP MP B.N. Bache Gowda's son Sharath Bache Gowda, the defeated BJP candidate from the constituency in the 2018 Assembly polls, has filed his nomination as



an Independent candidate for the bypolls. "We will expel Mr. Sharath," the Chief Minister said. He also said that the order appointing Mr. Sharath as chairman of the Karnataka Housing Board will be withdrawn.

Ranebennur has turned a headache for the party. Shortly after the Chief Minister placated rebel MLA R. Shankar from the constituency with the promise of being made an MLC and Minister, other ticket aspirants

A delegation of supporters of Basavaraj Kelagar, defeated BJP candidate in the 2018 Assembly polls and a ticket aspirant, held a protest outside the Chief Minister's residence demanding ticket. The party recently announced ticket for Arun Kumar Pujar, defeated BJP candidate in the 2013 polls.

High drama ensued in Athani, as supporters of Deputy Chief Minister Laxman Savadi gheraoed him at his residence in an attempt to dissuade him from attending a workers meeting called by Mahesh Kumathalli, the BJP candidate. Mr. Savadi was a ticket aspirant but failed to make the cut.

Meanwhile, Raju Kage, defeated BJP candidate in the 2018 Assembly polls from Kagwad, who switched sides, has been announced as Congress candidate from the constituency.

## As officials don't act, residents rebuild bridge

Fighting many odds, including fund crunch and sand mafia, the locals are continuing their work

With the administrative machinery going into mute mode, the residents of Pavoor-Uliya Kudru (river island) in the middle of the Nethravati, about 10 km off Mangaluru, have again started to rebuild the 750-ft footoverbridge over the river – a yearly affair.

About 40 families have been building the makeshift bridge made of steel scaffolding with the help of the local parish for the last couple of years to reach the mainland soon after the monsoon season. During monsoon, they have no option but to dismantle the bridge and cross

the river in spate using boats. With a majority of the residents depending upon employment opportunities outside the island and having meagre resources, they are forced to source funds from well-wishers. They spent

about ₹18 lakh initially last year to procure steel fabrication and are spending nearly ₹3 lakh on wooden planks and labour, said the parish priest of Infant Jesus Chapel, Capt. Gerald Lobo, who is guiding the construction. He added that there has been no financial support from the local administration.

A major part of the expenditure is towards labour even though the residents themselves are helping out extensively. The river bed is 20 ft deep at some places because of excessive mining, and this poses a challenge for bridge construction.

Vandals from the sand mafia damaged a portion of the bridge in January this year after the residents protested the indiscriminate sand extraction. However, the residents rebuilt the bridge soon after with help coming from the area MLA, U.T. Khader.

For every daily need, the residents have to come to the mainland at Adyar on NH 75.

Capt. Lobo told The Hindu that the residents have been demanding a permanent solution in the form of a concrete bridge. His plea to the Prime Minister reached the State government, and the PWD sent a proposal on a ₹5-crore project to the government.

However, things have not moved since, he said.

## Cracking the online ad game - the BJP outperforms the Congress

In the States where it swept all seats, the party was the biggest spender

Data on online political advertisements on Facebook show that there is a direct correlation between electoral success and online ad spend. Facebook recently released an Ad Library and Ad Library API to make political advertising "more transparent", which allows users to see who exactly posted a political ad and how much was spent on the campaign.

Data culled from the API by two researchers, Nayantara Ranganathan and Manuel


Beltran, on their website ad-.watch offers good insights into the ad spending strategies of political parties and the efficacy of the ads.

Unsurprisingly, official pages of India's two largest parties, the BJP and the Congress, are its two biggest spenders.

Despite the BJP's 40% more expenditure than the Congress, the Congress has an additional 1,040 ads. Even so, the BJP's ad outreach, measured in "impressions", is higher by 10%. In the States where the BJP won by sweeping all seats, the party was

the biggest spender on online ads.

In New Delhi, for instance, the BJP won all seven seats and spent ₹35,058,591 on Facebook ads. In contrast, the Congress spent ₹6,483,277 – one-fifth that of

There were just three ex-

ceptions to this correlation of ad expenditure and electoral success - Kerala, Punjab and Odisha. The BJP, which drew a blank in Kerala, had spent ₹28,166,172.

The Congress that won 15 out of the 20 seats, on the other hand, had spent just ₹3,818,667, which is one-seventh of what the BJP spent.

**Campaign strategies** The BIP ran 3 main campaigns: #MeinBhiChowkidar, #PhirEkBaarModiSarkar and #MyFirstVoteForModi. At least 1,500 of the 2,600 plus ads in 2019 from the BJP official page used the Chowkidar hashtag. 'Here's how a doctor is also a chowkidar', 'Here's how the youth are fighting corruption', 'Let's together build a clean India' and 'Giving up subsidy is an important contribution' are some ways that this campaign generated traction.

Over 1,000 Phir Ek Baar ads and 30 My First Vote ads, in different formats were pushed. Most of the 3,700 plus ads by the Congress spoke of the party "delivering" on their 2019 manifesto promises. 'We promise to reserve 33% of Central government jobs for women', 'We will provide 24 lakh private and public sector jobs' and 'A minimum yearly income of ₹72,000 to 5 crore poorest families' formed the content of their creatives.

#AbHogaNyay, which was

the Congress' war cry on other media, was used sparignly, in about 20 ads.

While the BJP pushed ads in English and Hindi, the Congress had at least 100 ads each in Kannada, Tamil, Telugu, Malayalam and Bengali.

The Congress thus spent lots of little money on lots of different ads and the BJP pumped in a lot of big money to make a few good ads.

The BJP having high impressions despite lesser number of ads, could imply one of three things, says Cyril Sam, co-author of The Real Face of Facebook in India. "The BJP has more followers than the Congress, so post receives high organic impressions and additional money

spent brings additional impressions; that the BJP's content is organically more engaging than the Congress'; that the Congress is optimising for impressions and the BJP for engagement."

Number of impressions is the number of times an ad was displayed to users. While they were a measure of success of advertisements used in traditional media, impressions aren't telling on digital media. Someone browsing through their newsfeed without paying attention to the screen would still count as an impression. Actual engagements in the form of clicks, shares, comments, and reactions are better measures than plain impressions.

### Drones scan CRPF camp in Naxal hub

Centre issues shoot-at-sight orders across States

Shoot-at-sight orders have been issued to security forces across States affected by left-wing extremism after drones or unmanned aerial vehicles (UAVs) were seen hovering over a strategically important Central Reserve Police Force (CRPF) camp in the worst Naxal-violence affected district of Sukma in Chhattisgarh's south Bastar

### Narmada flood victims struggle without amenities

Families hit by the Sardar Sarovar dam project after the swelled up Narmada backwaters submerged 178 villages in August, took part in a public hearing in Bhopal on Sunday as the protests demanding rehabilitation entered the second day.

The hearing was conducted by journalist L.S. Hardeniya, Madhya Pradesh Kisan Sabha president Jasvinder Singh, Gandhian Dayaram Namdev and former Chief Secretary S. C. Behar outside the Narmada Bhavan and was led by the Narmada Bachao Andolan (NBA).

"Instead of following the Supreme Court orders in 2000, 2005, 2017 and the rehabilitation policy, the Narmada Valley Development Authority had let 178 villages submerge. This shows the government's callous attitude towards us,"

## SC discusses 'voluntary code of conduct' for Cabinet Ministers

The court is examining if additional restrictions should be put on public functionaries' right to free speech and expression

A Constitution Bench of the Supreme Court is hearing arguments on whether Cabinet Ministers at both the Central and State levels should have a "voluntary model code of conduct" which addresses their private and public activities.

The submissions about such a code were made before the five-judge Bench led by Justice Arun Mishra, which is examining if "grea-

ter restrictions" should be imposed on the right of free speech and expression of high public functionaries to protect the citizen's fundamental right to lead a dignified life.

### Two petitions

The question was framed after family members of the Bulandshahr rape case victim complained about former Uttar Pradesh Minister Azam Khan's public statements that the rape case was

part of a political conspiracy against the then Akhilesh Yaday government. The Bench

is also hearing a separate petition filed by a Kerala-based man, Joseph Shine, represented by senior lawyer Kaleeswaram Raj, about the public comments made by State Minister M.M. Mani.

Both Attorney General K.K. Venugopal and Mr. Raj, who are assisting the Constitution Bench, were against introducing additional restrictions.

Mr. Venugopal argued that the SC has taken a consistent stand in the past against invocation of any further restrictions on free speech of citizens, and public men are no exception.

Mr. Raj asked the court to direct the government to frame the code of conduct for Cabinet Ministers, with the Cabinet head ensuring a collective responsibility for the activities of the individual Ministers.

"The code of conduct should reflect constitutional morality and values of good governance. The acts of the persons holding public offices can be thus subjected to better and meaningful public scrutiny," Mr. Raj argued before the Constitution Bench.

He said the Union Ministry of Home Affairs already has a code of conduct for Ministers, which is essentially concerned with financial discipline. "Nothing is emanating from the code which addresses the private and public activities of the Ministers in general. This is too narrow and inadequate," he said.

High-end hotels which offer valet parking cannot escape responsibility if a guest's vehicle is stolen or damaged even if the parking slip contains a non-liability clause, the Supreme Court has held. "In a situation where the

hotel actively undertakes to park the vehicle for the owner, keep it in safe custody and return it upon presentation of a parking slip in a manner such that the parking of the vehicle is beyond the control of the owner, a contract of bailment exists. Thus, the hotel would be liable as a bailee for returning the vehicle in the condition in which it was delivered," a Bench of Justices Mohan M. Shantanagoudar and Ajay Rastogi observed in a recent judgment.

The verdict came after an appeal filed by the Taj Mahal Hotel on an incident which happened in 1998. A guest gave his Maruti car for valet

parking and returned to find that it was stolen. The hotel staff said a young man had flicked the car keys from the holder and driven off.

'Implicit expectation'

"The guest has an implicit expectation that the repute and standards of five-star hotels would entail adequate safety of the vehicles handed over for valet parking... In our view, the standard of care required to be taken by the hotel is sacrosanct and cannot be contracted out of," the court

Once possession of the vehicle is handed to the hotel staff, there is an implied contractual obligation to return it in a safe condition upon the direction of the

However, the hotel is not responsible for damage caused to a vehicle by an event outside their control like a natural disaster, it

### Back to the Rajapaksas

With a decisive mandate, Gotabaya Rajapaksa should work to prove detractors wrong

The convincing victory of Gotabaya Rajapaksa in Sri Lanka's presidential election was not entirely unexpected. His main rival Sajith Premadasa's spirited campaign was not enough to overcome the anti-incumbency mood in much of southern Sri Lanka. An overwhelming majority of Tamils and Muslims voted for Mr. Premadasa, largely over fears that Gotabaya Rajapaksa evokes from his days as Defence Secretary under his brother, former President Mahinda Rajapaksa. If Tamils blamed the Rajapaksas for the death of thousands of civilians at the end of the civil war in 2009, and the subsequent reluctance to probe war crimes and disappearances, Muslims were worried about being targeted by majoritarian elements backed by Gotabaya Rajapaksa. But in a country where over 70% of the population is Sinhalese, Mr. Premadasa required a significant chunk of the majority vote too. Besides, there were other factors behind Gotabaya Rajapaksa's impressive performance in the south: anxieties arising from the state of the economy, revulsion towards unabated corruption and fears set off by the Easter Sunday bombings. Events since President Maithripala Sirisena dismissed Prime Minister Ranil Wickremesinghe in October 2018, leading to a constitutional crisis, made this election a referendum on the failures of the powersharing arrangement between the two leaders.

Mr. Sirisena and Mr. Wickremesinghe had come together in an alliance of rival parties to defeat Mahinda Rajapaksa in 2015. There was much euphoria in the early days, as people sensed a return to the rule of law and a departure from the authoritarian tendencies of the Rajapaksa era. They felt the days of the subversion of independent institutions were over. However, with the bitter parting of ways, especially in the backdrop of corruption allegations and poor economic performance, the arrangement collapsed. The worst fallout was perhaps the April 21 bombings, which happened despite advance intelligence, indicating a staggering breakdown of communication within the government. This is a sobering moment for all Sri Lankans. A mandate for reform and progress has been frittered away. Those blamed for the past democratic deficit are back in power. The country is nowhere near the promised constitutional reforms, either to address minority concerns or to abolish the executive presidency. Fears that the twoterm limit on running for President, as well as constitutional curbs on the chief executive's powers, will be removed in future are not misplaced. The new President should strive to allay such fears and work on strengthening the economy and ethnic harmony. He should refrain from antagonising the international community. In relations with India, he should assuage concerns that he would promote the interests of China to the detriment of India's. To truly make a mark, Gotabaya Rajapaksa should aim to disappoint his detractors.

### Quality on tap

Empowering consumers with rights is essential in improving quality of water supply

The report of the Ministry of Consumer Affairs, Food and Public Distribution red-flagging tap water quality in major Indian cities comes as no surprise, given that many official water distribution agencies routinely advise consumers to consume only boiled water. Going by the matrix of tests carried out by the Bureau of Indian Standards for the Ministry, Delhi has abysmal water quality, Chennai and Kolkata rank very low, and Mumbai is the only city with acceptable results. City water systems are normatively required to comply with the national standard for drinking water, IS 10500:2012, but most obviously feel no compulsion to do so. Their lack of initiative could be attributed partly to the expanding footprint of packaged drinking water, especially in populous cities, coupled with the high dependence on groundwater in fast-growing urban clusters where State provision of piped water systems does not exist. On paper, the Indian standard has a plethora of quality requirements, including absence of viruses, parasites and microscopic organisms, and control over levels of toxic substances. But in practice, municipal water fails these tests due to the lack of accountability of the official agencies, and the absence of robust data in the public domain on quality testing.

The Centre's approach to the issue relies on naming and shaming through a system of ranking, but this is unlikely to yield results, going by similar attempts to benchmark other urban services. Making it legally binding on agencies to achieve standards and empowering consumers with rights is essential, because State governments would then take an integrated view of housing, water supply, sanitation and waste management. A scientific approach to water management is vital, considering that 21 cities – including many of those found to have unclean tap water – could run out of groundwater as early as 2020, as per a NITI Aayog report. Moreover, the Central Ground Water Board estimates that nearly a fifth of the urban local bodies are already facing a water crisis due to excessive extraction, failed monsoons, and unplanned development. On the issue of regular testing, there is a case to entrust a separate agency with the task in each State, rather than relying on the same agency that provides water to also perform this function. If data on water are made public on the same lines as air quality, it would ratchet up pressure on governments to act. For too long, the response of water departments to the challenge has been to chlorinate the supply, as this removes pathogens, ignoring such aspects as appearance, smell and taste. It is time to move beyond this and make tap water genuinely desirable.

## The fountainhead of India's economic malaise

The citizenry's distrust in institutions and lack of confidence in the government have caused a prolonged slowdown

The state of India's economy is deeply worrying. I say this, not as a member of the Opposition political party, but as a citizen of this country and as a student of economics. By now, the facts are evident to all – nominal GDP growth is at a 15-year low; unemployment is at a 45-year high; household consumption is at a four-decade low; bad loans in banks are at an all-time high; growth in electricity generation is at a 15-year low - the list of highs and lows is long and distressing. But the state of the economy is worrying not because of these disturbing statistics. These are mere manifestations of a deeper underlying malaise that plagues the nation's economy today.

A nation's state of the economy is also a function and reflection of the state of its society. The functioning of any economy is the result of the combined set of exchanges and social interactions among its people and institutions. Mutual trust and self-confidence are the bedrock of such social transactions among people that foster economic growth. Our social fabric of trust and confidence is now torn and ruptured.

#### Industrialists live in fear

There is a palpable climate of fear in our society today. Many industrialists tell me that they live in fear of harassment by government authorities. Bankers are reluctant to make new loans, for fear of retribution. Entrepreneurs are hesitant to put up fresh projects, for fear of failure attributed to ulterior

motives. Technology start-ups, an important new engine of economic growth and jobs, seem to live under a shadow of constant surveillance and deep suspicion. Policymakers in government and other institutions are scared to speak the truth or engage in intellectually honest policy discussions. There is profound fear and distrust among people who act as agents of economic growth. When there is such distrust, it adversely impacts economic transactions in a society. When transactions among people and institutions are negatively impacted, it leads to a slowdown of economic activity, and eventually, stagnation. This perilous state of fear, distrust and lack of confidence among citizens is a fundamental reason for our sharp economic slowdown.

There is an air of helplessness too. Aggrieved citizens find nowhere to go to air their grievances. Public trust in independent institutions, such as the media, judiciary, regulatory authorities and investigative agencies, has been severely eroded. With the erosion of trust, there is a lack of a support system for people to seek refuge against unlawful tax harassment or unfair regulations. This makes entrepreneurs lose their risk appetite even further for undertaking new projects and creating jobs. This toxic combination of deep distrust, pervasive fear and a sense of hopelessness in our society is stifling economic activity, and hence, economic growth.

The root cause of this rupturing of our social fabric is the Modi government's 'mala fide unless proven otherwise' doctrine of governance. The premise of the government's policy framework seems to be that economic participants have mala-fide intent unless they can prove otherwise. This suspicion that every industrialist, banker, policymaker, regulator,



entrepreneur and citizen is out to defraud the government has led to a complete breakdown of trust in our society. This has halted economic development, with bankers unable to lend, industrialists unable to invest and policymakers

unable to act. The Modi government seems to view everything and everyone through a tainted prism of suspicion and distrust due to which every policy of previous governments are presumed to be of bad intent, every loan sanctioned considered undeserving and every new industrial project deemed to be crony in nature. And the government has positioned itself as some saviour, resorting to foolhardy moral-policing policies such as demonetisation, which have proved to be ill-thought-out and catastrophic. Wrongful evil characterisation of everyone and a 'good-vs.-evil governance' doctrine cannot be a recipe for healthy economic growth.

The role of social trust in economic development has been well-documented, right from the times of Adam Smith to the modern-day discipline of behavioural economics. The tearing of our so-

cial fabric of trust is the fountainhead of our current economic malaise. For economic growth to revive, it is very important that our torn social fabric of fear and distrust be stitched and knitted together to enthuse trust and confidence. It is very important for businessmen, capital providers and workers to feel confident and exuberant rather than being fearful and nervous. This is possible only if the government sheds its 'mala fide-unless-proven-otherwise' doctrine and begin to trust India's entrepreneurs.

India's economy is perched in a precarious state currently. Incomes are not growing. Household consumption is slowing. People are dipping into their savings to maintain similar levels of consumption. Headline GDP growth is accruing almost entirely to the creamy layer at the top.

### Risk of stagflation

The real worrying trend is that the most recent retail inflation numbers have have shown a sharp increase, especially the food inflation figure. Retail inflation is expected to rise even further in the coming months. Continued increase in inflation combined with stagnant demand and high unemployment will lead to what economists term as 'stagflation', a dangerous territory from which it becomes very hard for large economies to recover. While we are currently not in stagflation territory yet, it is prudent to act quickly to restore consumption demand through fiscal policy measures since the impact of monetary policv seems muted.

It is my belief that India's fragile economic situation calls for the twin policy actions of boosting demand through fiscal policy and reviving private investment through 'social policy' by inspiring trust and confidence in the economic

participants in our society.

India is now a \$3-trillion global economic powerhouse driven largely by private enterprise. It is not a tiny command and control economy that can be bullied and directed at will. Nor can it be managed through colourful headlines and noisy media commentary. Shooting down messengers of bad news or shutting off economic reports and data is juvenile and does not behove a rising global economic powerhouse. No amount of subterfuge can hide the performance and analysis of a \$3-trillion market economy of 1.2 billion people. Economic participants respond to social and economic incentives, not diktats or coercions or public relations.

Sadly, this self-inflicted economic wound comes at a time when there is a unique and opportune moment in the global economy for India to capitalise. The slowing down of China's economy and exports has opened up a large export opportunity for India to fill. India should aim to garner an elephant's share of this export opportunity by fostering a climate of confidence and economic dynamism away from the current climate of fear, distrust and pessimism. With the government having an absolute majority in the Lok Sabha and the global oil prices being low, this is a once-in-a-generation economic opportunity to catapult India to the next phase of economic development and create new jobs for hundreds of millions of our youth. I urge the Prime Minister to set aside his deep-rooted suspicion of industrialists and entrepreneurs and nurse us back to a confident and mutually trustworthy society that can revive the animal spirits and help our economy soar.

## The false allure of English-medium schooling

Andhra Pradesh's push to make English the medium of instruction in state-run schools will prove counterproductive



he Y.S. Jaganmohan Reddy government in Andhra Pra-L desn is set to make all go vernment elementary schools 'English-medium' from the next academic year. There has been the expected party-political denouncement of the decision, despite the fact that it is really just the scaling up of a policy proposal made during N. Chandrababu Naidu's tenure, when English was introduced as the medium of instruction in a select number of schools as a pilot project.

The push for English as the medium of instruction in government schools in Andhra Pradesh, as in other States including Karnataka and Tamil Nadu, is due to two related factors. First, there is a belief that English-medium schooling can guarantee good jobs. Second, economically constrained families are shifting their children from free government schools to private English-medium schools. It is to try and reverse this trend (which also poses a threat to government teaching jobs) that many State governments have made at least

some of their schools English-medium or started English-medium

Research, from India and across the world, shows that children who get educated in their mother tongue learn better than those who start school in a new language. A new language in the early school years, especially one that is not used outside school, can become a parrier to learning. This is also plain common sense: if a child speaks or understands the classroom language, engaging with new concepts, ideas and information is easier, as is learning to read and write. Even researchers who advocate privatisation of schools as a quality improvement measure accept that English-medium schools are not the solution. A study of learning outcomes in government and private elementary schools in Andhra Pradesh has found that children perform best in Telugu-medium schools.

Ignoring the evidence Governments, while making policy changes favouring English-medium schools, have ignored the evidence. For politicians, it is a win-win situation – they are able to give a mass of voters what they appear to want, at no significant additional cost. For the influential middle class, it is comforting to believe that poor children are getting a leg-up through English-medium

government schools. Even some

Dalit intellectuals who claim to

speak for the most vulnerable hold

that it is English-medium schools that will emancipate them, and that those who disagree are hellbent on retaining the status quo. Even ignoring all the evidence about language and learning, what sort of English-medium schools does the government promise? At the very minimum, such schools will need teachers who, apart from being knowledgeable in the subjects they teach, are also fluent in the medium of instruction. No State government can claim that a majority of teachers, especially in elementary schools, are Englishfluent, not even the ones who

teach English. The vast majority of

them have had their entire educa-

tion in their mother tongue or the

State language, and have spent

their working lives teaching in that

language. With rare exceptions,

transform them into teachers for English-medium schools. On the contrary, it will handicap them, making the best of them resentful, and the disinterested even more In-egalitarian system

The problem lies not in the medium of instruction, but in an inegalitarian education system that is completely skewed in favour of the intergenerationally privileged. This is a system whose design from the annual school calendar to the syllabus and textbooks to teacher engagement to the highstakes board exams - ignores the vastly different socioeconomic realities of a majority of children. The focus on English medium pulls a veil over these knottier pro-

blems. Politicians and the middle class (whose powerful voices make or influence policy) have for too long promoted the canard that if you give everyone the "same thing" in this case English-medium schools – it makes everything equitable. Making Telugu-educated school teachers instruct children, with no English, in English will not transform Andhra Pradesh government schools into institutions of the kind Mr. Jaganmohan Reddy's children go to. On the contrary, such schools will be a parody of the elite schools, like the — 'affordable' private English-medium schools that children most often move to from government schools. In these schools, teachers with barely any or no English read from English textbooks and use the mother tongue or State language to communicate; students have to cram the English textbooks or prepared answers 101 their tests. The result is that they develop a hold over neither their mother tongue/State language nor English.

This is what the government English-medium schools will offer, with the only difference that they will be free. This sort of 'Englishmedium education', far from making education more equitable and closing the social gap, will accentuate inequity.

A government really concerned about education and making English accessible to poor children in government schools should focus on the children's natural receptiveness to new languages by teaching English as a language. Investing in modern language-teaching education (not short-term training) for English-language school teachers is essential. Anything else is just an eyewash that people will soon be wise to.

# Return of the Rajapaksa regime

Sri Lanka's great liberal democratic experiment has now been overcome by authoritarian populism



The 2019 presidential election will be a watershed in Sri Lankan history. The Rajapaksa regime was decisively defeated in both the 2015 presidential and parliamentary elections. Since then, remnants of the regime have persevered to rebuild. Rejected nationally and isolated internationally, their crafty politics, ideological consolidation, and political mobilisation ensured a powerful political base among the Sinhala constituencies. While the minorities, worried about their future, voted overwhelmingly against presidential candidate and former Defence Secretary Gotabaya Rajapaksa, the Sinhala political base, built by the Rajapaksas, has brought them back to power.

The Rajapaksa camp took the risk of forming their own party, the Sri Lanka Podujana Peramuna, which has now engulfed the Sri Lanka Freedom Party. They built a base in their Sinhala constituencies by engaging the rural population and lower middle classes. They spoke to the discontent with a long-neglected drought and deteriorating economic situation. They turned the corruption discourse that had damaged them in power back onto the incumbent government, as the Central Bank bond scandal exposed the newly appointed Central Bank Governor and provided an irredeemable blow to the promise of "good governance".

They tested their strength and gained confidence with the local government elections of 2018, where their newly constructed party machine made a landslide victory in the Southern constituencies. They kept Parliament at boiling point with noconfidence motions, and even attempted a parliamentary coup, with President Maithripala Sirisena appointing Mahinda Rajapaksa as Prime Minister. They capitalised on the Easter attacks, and claimed to be the only actors who can address national security, even as the President and Prime Minister pointed fingers about the security lapses that could

have averted the disaster. Not only did they miss no opportunity to attack the government over the last four years, but also worked incessantly on the ground to build up their base, whether with the disgruntled Sinhala rural masses, the bureaucrats comfortable with their politics of patronage, the business classes that sought to gain from their economic policies, or the chauvinist social movements that thrived on their backing for majoritarian and xenophobic politics. With the presidential election victory, the Rajapaksa juggernaut now looks well poised to

was in fact a failure of the Sirisena-Wickremesinghe government. The coalition government was rocked by infighting, and its aloof leadership with grand projects of trade liberalisation and foreign investment neglected people's everyday concerns. With the global Islamophobic discourse on the rise, the government did little to confront the chauvinist forces that ideologically mobilised the Sinhala constituencies by constructing the Muslims as the new enemies. Amid acute joblessness, soaring living costs, mounting household debt and people's still rural livelihoods, coupled with fear since the Easter terror attacks, the people turned to a "strong leader" for relief from gripping insecurity. These are the grounds on which Sri Lanka's great liberal democratic experiment of 2015 has now been overcome by

authoritarian populism. If the neoliberals under Ranil Wickremesinghe lost the plot on the economy, there was nevertheless liberal progress with state and social institutions. Militarisation and surveillance in the country, in the North and East in particular, was considerably reversed with democratic space providing room for freedom of expression and protests. Military-held lands in the North were released to their private owners. The judiciary regained independence. The media and social movements gained the confidence to critique the state. The excessive powers of the executive presidency were clipped, and independent commissions for human rights and right to information were strengthened.

In this context, the normalisation away from an excessive security mindset hung over from the war years were undone by the Easter attacks, and the room for scrutiny of the security apparatuses are now shutting down. Independence of institutions are also now at risk: either through legislative moves with consolidation of power in Parliament or through crass politicisation. These are blows to the democratic space gained over the last five years.

It is those concerns that brought the loose set of actors opposing the return of a Rajapaksa regime. What was necessary, however, was a strong coalition that also addressed fundamental political-economic concerns, but that was not to be with the Janatha Vimukthi Peramuna (JVP) seeking to build a third force and United National Party (UNP) leader, Mr. Wickremesinghe, seeking to undermine his party's candidacy to ensure his own leadership of the party.

#### **Electoral outcomes**

In this context, the electoral map reveals certain divisions. The Tamiland Muslim-heavy regions of the North and East, the UNP and upcountry Tamil strongholds of the Central Highlands, and the minorityheavy and UNP strongholds around Colombo voted for Sajith Premadasa, while the vast majority of the other electorates voted for Mr. Rajapaksa.

The electoral map may immediately hint at a polarised country along ethno-nationalist lines, but a deeper look into the politics of each region may reveal different dynamics. The voter turnouts in the Northern constituencies were much higher than in the past, despite neither candidate addressing their aspirations and a crass call from the Tamil nationalist fringe for boycott of the elections. In voting overwhelmingly for Mr. Premadasa, the Northern constituencies have entered the realm of national politics seeking to shape it as opposed to the decadeslong approach of exclusionary politics that refused to even consider national changes. Similarly, while the simplistic narrative of the Sinhala voter supporting a majoritarian regime may be tempting, in reality it is perhaps lower and middle class economic disenchantment and youth disillusionment that ensured a mass vote for Mr. Rajapaksa.

While the responsibility for the defeat of the liberal democratic experiment of 2015 falls squarely on Mr. Wickremesinghe and Mr. Sirisena, salvaging what is left of that democratic space now becomes the task of the dispersed actors and forces that have to regroup ahead of the imminent parliamentary elections. The Muslim and Tamil minority parties that sought to keep the Rajapaksas at bay, the failed third force experiment of the JVP with allied left forces, and various social movements now have the unenviable task of defending the democratic space from an authoritarian populist regime about to consolidate power.

## The integrity of numbers

Journalism can be an effective warning system only when society decides to act on its findings



Argentine author Jorge Luis Borges made an important observation during World War 2, which also rings true in the second decade of

the 21st century: "Exclamations have taken over the function of reasoning; it is true that the scatterbrains who carelessly utter them give their slogans a discursive air, and that this tenuous syntactical simulacrum satisfies and persuades whoever happens to be listening".

Readers must remember that the critical distance between a news organisation and the ruling government is not only an ethical obligation but a democratic requisite. The society pays a huge price if truth is sacrificed for the sake of claims. Take the case of the East German newspaper, Neues Deutschland, the official mouthpiece of the Socialist Unity Party of Germany. In its edition dated November 10, 1989, the day after the fall of the Berlin Wall, it did not have a report on this historic event. Propaganda may serve a limited purpose for a limited time, but it cannot prevent the course of history. Whatever their ideological positions, leaders crave for some version of Neues Deutschland. Citizens want credible information for them to make critical choices.

#### Suppressing data

One of the effective journalistic tools to confront propagandist drivel has been data journalism. But what happens if the government suppresses data? How do we understand the current state of data poverty? While we may not have a direct correlation between data manipulation and the democratic deficit, the economic slowdown and the resultant hardship are starkly staring at us.

On November 15, the government decided not to release the household consumer expenditure survey results of 2017-18 due to "data quality issues". The unreleased survey showed that consumer demand had declined in 2017-18 for the first time in more than 40 years, validating the anecdotal evidence of the sad state of the Indian economy. The official statement said that the government is "planning the next consumer expenditure survey in 2021-22 after data quality refinement in the survey process". We have to remember the government did the same with the NSSO data on employment, using the weak defence that the study leaked to the media was a draft and should not be consi-

We have not done a systematic survey of citizens to understand their reaction to data manipulation and data suppression. Most policymakers are disturbed by the lack of credible numbers from the Indian government. Economist A. Vaidyanathan wrote a

### The importance of follow-ups

In the '80s and '90s, the general practice in Indian journalism was to do a systematic follow-up of major scoops. It did not matter who broke the story. But despite the proliferation of media outlets, we hardly find the idea of follow-up being taken seriously by journalists today. This newspaper carried an important article in August 2019 about an International Monetary Fund report ("IMF report flags several delays in India's data reporting"). The IMF report showed that inconsistencies have crept into the dissemination of fiscal datasets as well. The news report records how India failed to comply with multiple requirements prescribed in the Special Data Dissemination Standard, a practice mandatory for all IMF members, whereas comparable economies comprising the BRICS nations maintained a near impeccable record in the same period. The decline really began from 2016.

Journalism can be an effective early warning system only when society decides to act on its findings and not exhibit ostrich-like behaviour whenever uncomfortable truths emerge. In March, 108 major economists and social scientists from across the world issued an appeal to convince the Indian government to stop suppressing uncomfortable data, restore access to public statistics and reestablish the independence and integrity of institutions. If the government had not turned a deaf ear to the observations of economists in March and to The Hindu's August story, we may have had some real policy measures to stem the economic slowdown.

## Secularism in the time of security

It is to be seen whether the bogey of security will allow the BJP to circumvent constitutional strictures

After the verdicts on Ayodhya and Sabarimala, the focus will now shift from the Supreme Court to Parliament. There is a compelling case to suggest that the BJP has begun executing its ideological agenda through the arms of the Union government. With Amit Shah straddling two key positions as Union Minister for Home Affairs and national president of the BJP, the co-ordination and coherence in policymaking and political manouvering are palpable.

The party's 2019 election manifesto spoke about providing citizenship to minorities escaping persecution from neighbouring countries. The execution of this promise has come in the form of renewed vigour to enact the Citizenship (Amendment) Bill in the winter session of Parliament. If Parliament legislates the changes proposed to the Citizenship Act, this would mark an irrevocable shift away from India's secular credentials.

Speaking at a seminar in Kolkata last month, Mr. Shah emphasised that "all Hindu, Buddhist, Sikh, Jain refugees" will not be "driven out". He further announced that by bringing the Citizenship (Amendment) Bill into force, the Union government would ensure that "all the rights of an Indian national" would be extended to this cohort. It is trite observation that the definition of refugee, under the present government, contains conspicuous omissions.

### A Trojan Horse

Though the discourse is structured around persecution and refugees, there is little doubt that these actions, if carried through, would effectively mutate India into a "Hindu Rashtra" or a Hindu nation. Therefore, concern for refugees is nothing more than a Trojan to build a monoreligious country which will serve as a promised land for people belonging to the Hindu and other "Indic faiths". Naturally, this will alter the secular fundamentals underpinning the country and its Constitution.

Not long ago, a Minister of the Union government waded into trouble by talking about removing the word 'secular' from the Preamble to the

Constitution. There is no doubt that this demand is in line with the longheld Hindutva agenda. However, it is equally obvious that the constitutional courts may view any such amendment to the Constitution as a direct threat to its basic structure, as laid down under various judgments. Most notably, in Kesavananda Bharati v. State of Kerala (1973), the Supreme Court held that secularism was part of the basic structure of the Constitution and further, that the basic structure could not be abrogated. As such, it follows that the state must be secular and actions by the state shall not impinge on the secular fabric of the

A further legal impediment would arise on the basis of international law and humanitarian principles which prohibit the discrimination of refugees on the basis of religion. Recently, Indian courts have read international obligations under the Universal Declaration of Human Rights relating to stateless persons in consonance with Article 51(C) of the Constitution to endow them with force of law. In P. Ulaganathan v. Government of India (2019), the Madras High Court utilised the expansive powers under Article 21 of the Constitution to provide partial relief to refugees and stateless persons.

### **Security and state**

In recent times, Turkey has seen its secular foundations being reshaped under President Recep Tayyip Erdogan, as has been pointed out by Amitav Ghosh and Shashi Tharoor. However, whether this model can be executed in India would depend on how the judiciary perceives this challenge to secularism.

Perhaps anticipating such judicial resistance, recently Mr. Shah spoke extensively on "national security". He emphasised that no country "can run smoothly with the weight of so many intruders". It is to be seen whether the bogey of security will allow the BJP to circumvent constitutional strictures and convert India to





### Demand for inclusion of Chandigarh

A massive demonstration by several hundred thousand Haryanis demanding Chandigarh's merger with their State, was the highlight of a day of marches in the Capital, coinciding with the opening of Parliament's winter session. The organisers of the Haryana demonstration put the number of participants at more than a million, but independent observers estimated they numbered about 500,000. The lower figure still left it one of the largest demonstrations witnessed in recent times. The seven-mile long procession started at about 11 in the morning and the head reached the Boat Club, about two furlongs from Parliament House, at 12-30 p.m. Carrying their respective party flags, the processionists marched through the streets of Old Delhi and New Delhi shouting slogans like "Chandigarh for Haryana" and "Chandigarh hamara hai" (Chandigarh belongs to us). At 2 p.m. the Prime Minister Mrs. Indira Gandhi came to the Boat Club to receive a memorandum from the demonstrators. The demonstrators shouted "Indira Gandhi Zindabad". The Prime Minister spent about five minutes with the representatives of the demonstrators.

### A steamer's experiences

Bombay, November 16: The steamer 'Zayani' from Persian Gulf to Bombay with 1,200 pilgrims aboard, which arrived in Bombay this week after taking fourteen days on voyage which in ordinary circumstances would have occupied only six days, ran into wholly unexpected cyclone en route on the 5th November. The Captain was forced to run with the wind and, when he tried to bring the ship to the right course, the vessel refused to answer. The helm engines broke down and stopped in the middle of the night. At the same time, a deputation of pilgrims waited on the ship officers enquiring whether there was danger of the ship's foundering. They were told that the ship would have to fight the cyclone and if she succeeded they might reach Bombay all right. The chief officer personally saw that the pilgrims were supplied with biscuits and water. Eventually, the engines got going in full speed ahead again and, with the wind and sea moderating, a course was set for Bombay, the Zayani having already been blown 150 miles out of her course. Twelve deaths occurred among the pilgrims on the voyage.
