Jharkhand to vote in five phases from November 30

EXPRESS NEWS SERVICE NEW DELHI, NOVEMBER 1

ASSEMBLY ELECTIONS will be held in Jharkhand across five phases starting November 30. the Election Commission (EC) announced Friday.

Close to 2.5 crore voters in the state will exercise their franchise on November 30, and December 7, 12, 16 and 20. Thirteen seats will go to poll in the first phase, followed by 20 in the second, 17 in the third, 15 in the fourth and 16 in the final phase on December 20. The results will be announced on December 23.

The elections have been announced within ten days of poll results from Maharashtra and Haryana, where the BIP failed to match its Lok Sabha performance. The stakes, therefore, are high for the ruling party as Jharkhand is crucial to determine whether the BJP wave still prevails. Friday's announcement also scotched rumours of early

elections in Delhi. Iharkhand is currently under BJP rule with Raghubar Das as Chief Minister for a five-year term. In the 2014 Assembly elections, the BIP bagged 37 seats and formed the government with alliance partner All

IN A more robust joint statement than the one issued two years ago, India and Germany Friday called for a halt to "cross border movement of terrorists" and asked all countries to ensure that their territory is "not used to launch terrorist attacks on other countries".

Later, in a separate interaction with the German media, visiting German Chancellor Angela Merkel said she would discuss the issue of Kashmir with Prime Minister Narendra Modi. "The situation for the people on the ground as of now is not good for the long-term, this certainly has to change," she said, **CONTINUED ON PAGE 2**

A DAY after the Ministry of Electronics and Information Technology sought an explanation from WhatsApp on the alleged surveillance of phones of more than two dozen people by operators using the messaging platform to install Israeli spyware Pegasus, government sources said they are "disturbed" that neither did WhatsApp nor its parent company Facebook bring the privacy breach of Indian citizens to their notice though they have had numerous meetings since summer.

Late Friday, WhatsApp, however, said it had "notified relevant Indian and international government authorities" in May about "a security issue" that it had "resolved" and had also tried to reach out to the targeted

An establishment source countered the WhatsApp response, suggesting that the May notification was "too technical a jargon" and the messaging plat-

In Haryana, Rs 1,000 reward for information on farm fires

THE HARYANA government

Friday announced a cash award of Rs 1,000 to anyone who provides them information about cases of farmers burning crop residue in their area. The identity of the informant will be kept Chief Minister Manohar Lal

Khattar, who chaired a meeting on crop residue management here, also asked officers of agriculture and farmers' welfare department to visit the 10 villages of the state where maximum crop residues were burnt to ascertain the reasons.

He also directed deputy commissioners to take stringent measures to prohibit burning of crop residue.

In the meeting, the officers apprised Khattar that "a 34 per cent reduction has been registered in the area burnt in the state upto October 22 this year as compared to the corresponding period the last year". The government said "while crop residue burning was reported on 57,000 hectares of land last year, this year, it was reported only on 38,000 hectares".

Khattar also directed the concerned officers to encourage farmers not to burn crop residues and also apprise them of the different options of crop management. The CM also asked DCs to organise gram sabha meetings so that detailed deliberations could be held with farmers.

Khattar also directed officers to explore options for purchase of crop residue from the farmers.

Air Marshal B Suresh takes charge of IAF's western command

New Delhi: Air Marshal B Suresh took over as the Air Officer Commanding-in-Chief of the crucial Western Air Command on Friday.

Suresh, a decorated officer, was commissioned as a fighter pilot into the Indian Air Force on December 13, 1980, the air force said.

Suresh is a "strategist and tactician of repute within air force circles and as the exercise director, he is credited with having been the mastermind behind IAF's superlative performance during Exercise Cope India 2004, the first international bilateral exercise with the US Air Force held after nearly 40 years,"it said. **PTI**

The legal action in Tel Aviv, brought by nearly 30 human rights activists, is supported by Amnesty International as part of a joint project with NYU School of Law's Bernstein Institute for Human Rights and Global Justice Clinic. This centre specialises in questions of justice "for human rights defenders targeted with malicious software". Amnesty International has

said its own activists were targeted by Pegasus in June 2018. In a lawsuit brought before a US federal court Tuesday, Facebookowned WhatsApp alleged that the NSO Group targeted some 1,400 WhatsApp users with Pegasus. On Thursday, The Indian

Express reported that WhatsApp had confirmed that phones of human rights activists and journalists in India had been targeted for surveillance by operators using Pegasus. While declining to reveal the identities and "exact number" of those targeted for surveillance in India, a WhatsApp spokesperson said "it is not an insignificant number".

The affidavit filed by Amnesty in support of the petitioners in the Tel Aviv court speaks of the role of the Israeli government in ensuring that NSO takes responsibility for the end-use of its software and stops selling it to governments to target rights activists and political opponents.

"Despite the foreseeable risk of violations of the human rights to privacy, freedom of opinion and expression of human rights defenders resulting from the sale to and use by certain governments of NSO Group's technology, Israel is failing to prevent or restrict such sales. The Israeli government is therefore breaching its duty under international human rights law to protect against violations of rights guaranteed by the International Covenant on Civil and Political Rights," it stated.

Amnesty International's representatives said they are asking for "Israel's Ministry of Defence to cancel NSO's licence."

On Friday, a Reuters report from Jerusalem said the Israeli government denied any involvement in the alleged cyber-hack by NSO Group.

Distancing Prime Minister Benjamin Netanyahu's government from the alleged attempts to send malware to the mobile devices of a number of WhatsApp users, Israeli security cabinet minister Zeev Elkin said that if anyone had done anything "forbidden" they could expect to find themselves in court.

"NSO is a private player using capabilities that Israelis have, thousands of people are in the cyber field, but there is no Israeli government involvement here, everyone understands that, this is not about the State of Israel," Elkin told 102.FM Tel Aviv Radio.

In the interview, Elkin also said: "It is true that when people do things that are forbidden — I have no way of determining whether they did indeed do anything forbidden — then the justice system here and in other countries will throw the book at them."

The NSO Group has not so far revealed who is or who is not a client. Sources say contractual and legal constraints and its 'Transparency Statement of Principles' prevent it from divulging this. It has maintained that "the sole purpose of NSO is to provide technology to licensed government intelligence and law enforcement agencies to help them fight terrorism and serious crime. Our technology is not designed or licensed for use against human rights activists and journalists. It has helped to save thou-

sands of lives over recent years."

Responding to queries from

The Indian Express on the legal case filed by WhatsApp in the US, NSO said: "In the strongest possible terms, we dispute today's allegations and will vigorously fight them. The truth is that strongly encrypted platforms are often used by pedophile rings, drug

kingpins and terrorists to shield their criminal activity. Without sophisticated technologies, the law enforcement agencies meant to keep us all safe face insurmountable hurdles. NSO's technologies provide proportionate, lawful solutions to this issue." "We consider any other use of

our products than to prevent serious crime and terrorism a misuse, which is contractually prohibited. We take action if we detect any misuse. This technology is rooted in the protection of human rights — including the right to life, secu-

rity and bodily integrity - and that's why we have sought alignment with the UN Guiding Principles on Business and Human Rights, to make sure our products are respecting all fundamental human rights," it said.

Jharkhand

Jharkhand Students' Union that had won five seats. Six MLAs of former CM Babulal Marandi's party Jharkhand Vikas Morcha also joined the BJP soon after the elections.

Jharkhand Mukti Morcha (IMM) chief Hemant Soren had told The Indian Express this week that his party will tie up with the Congress for the polls, but lead the alliance and contest more than half of the seats in the state on its own. The JMM has 19 MLAs while Congress has eight legislators in the current Assembly.

There will be approximately 30,000 polling stations in the states and the Model Code of Conduct has comes into immediate effect. This is also the first state election in which senior citizens voters above the age of 80 years and voters who are physically challenged will have the option of casting their vote through postal ballots. The term of the current 81-member Assembly ends on January 5 next year.

Kulgam killings

The labourers, who worked in an apple orchard, were asked to step out of their rented accommodation in Kulgam, taken to a nearby area, and then shot dead. The deceased were identified as Naimuddin Sheikh, Murshalim Sheikh, Rafikul Sheikh, Rafique Sheikh and Kamaruddin Sheikh, all from Bahalnagar village in Murshidabad's Sagardighi.

The Chief Minister also claimed it was a pre-planned attack. "The manner in which they were murdered brutally after being abducted, I think it is preplanned," she said while demanding an investigation into the killings.

Hours after the incident Tuesday, Banerjee had expressed shock and sadness. "Words will not take away the grief of the families of the deceased. All help will be extended to the families in this tragic situation," she had tweeted.

The joint statement, which was issued earlier after Modi met Merkel, is far stronger than the one issued in May 2017 when he had visited Germany. From Delhi's perspective, it is aimed at Pakistan.

Friday's statement also indicated that Germany has moved closer to India's position on Afghanistan, as they agreed on the need for "dismantling of terrorist safe havens and sanctuaries".

After their meeting during the day, Modi said: "We have resolved to intensify bilateral and multilateral cooperation to deal with terrorism and extremism." Later, the two leaders met over an official dinner hosted by the Prime Minister. Responding to questions on

Kashmir earlier from the German media, Merkel said: "About Kashmir specifically we haven't spoken yet. It will be on the agenda tonight and I will say that we advocate de-escalation and relaxation....We hope that India and Pakistan will find a peaceful solution together...We know the Indian position. But I first also want to hear the arguments of the Prime Minister."

The joint statement, meanwhile, said Germany will work toward facilitating "export of military equipment as well as

technology sharing" with India. In another key upgrade, it also sought deeper cooperation between the defence industries of both countries to take advantage of "defence corridors set up in the states of Tamil Nadu and Uttar Pradesh" under the Make in India initiative.

The two sides also decided to establish regular dialogue between their defence ministers, alternately in India and in Germany, at least once every two years. The joint statement said

the two leaders expressed strong concern on the "global scourge" of terrorism and called upon all countries to work towards disrupting terrorist networks and financing channels. "The leaders underlined the need for all countries to ensure that their territory is not used to launch terrorist attacks on other countries in any manner," it said.

Referring to the need for presenting a united front in the fight against terror, the two leaders called for the finalisation and adoption of the Comprehensive Convention on International Terrorism (CCIT) in March 2020. While the CCIT was mentioned in the 2017 statement, this is the first time that a deadline has been spec-

While agreeing to continue cooperation within the framework of the Joint Working Group on counter-terrorism. they spelt out specific the areas this time: "information and intelligence sharing on terror networks" and experiences in dealing with the growing phenomenon of "radicalisation". The two leaders asked officials on both sides to schedule the next meeting of this working group at the earliest.

The two sides also agreed to "deepen efforts to restart" stalled negotiations between India and the European Union (EU) on the Bilateral Trade and Investment Agreement (BTIA). Negotiations have been held up since May 2013 after both sides failed to bridge gaps on crucial issues.

On Afghanistan, India welcomed Germany's efforts at coorganising an Intra-Afghan Dialogue that includes the government and ensures an Afghan-led and Afghanowned peace process.

"They called for a cessation of violence; breaking of all ties to international terrorism; dismantling of terrorist safe havens and sanctuaries; preservation of Constitutional order and the respect for the universal human rights of all Afghan citizens as enshrined in the Constitution. Germany appreciated India's contribution in development cooperation and rebuilding of Afghanistan," the

Cricketers

The National Capital has been in the grip of a severe pollution crisis since last week, with the air quality index breaching the 'severe' mark of 400 to touch 484 Friday. Schools have been told to shut till November 5, and the government is distributing 50 lakh masks to students. From Monday the capital will roll out the oddeven road space rationing scheme to cut vehicular pollution.

It was not surprising then to see more than a few Bangladesh players with pollution masks. On Thursday, batsman-keeper Liton Das wore one briefly before removing it for his batting session. On Friday, the numbers swelled Domingo, batting coach Neil McKenzie, spin coach Daniel Vettori and allrounder Soumya Sarkar were among those sport-

For the Kotla regulars, though, it would not have been a rare sight. Two years ago, Sri Lanka physiotherapist Nirmalan Dhanabalasingham had to scamper to the nearby lanes in Daryagani for buying masks. During the match, their fast bowler Suranga Lakmal suffered

bouts of nausea and vomitted. That Test also saw Indian pacer Mohammed Shami slumping on a chair near the boundary ropes, and spinner Kuldeep Yadav passing him a mask. A year earlier, a Ranji Trophy match between Gujarat and Bengal was cancelled due to poor air quality.

None of the Indian players sported a mask on Friday, though. And batting coach Vikram Rathour deflected the pollution query deftly. "You are asking the wrong person. I have played all my cricket in North India. Yes, there is pollution, but there is a match that has been scheduled and we will give our 100 per cent,' he said.

SENDING THE security establishment into a tizzy, an unclaimed bag, initially suspected to contain explosives, was recovered from IGI Airport's Terminal 3 late Thursday night. Police said an explosive vapour detector (EVD) machine and a sniffer dog had indicated the bag could contain explosives, following which it was sent to a 'cooling pit'.

Panic spread following the discovery of the bag, as arrival gates were shut and the airport sealed for three hours.

Around 9 pm Friday, however, a man reached IGI police station to claim the bag, saying he had left it behind by mistake. He said the bag contained clothes, chocolates, earrings, a charger and toys — and when authorities opened it, they found the same things. The man, Shahid Hussain, had come to Delhi from Mumbai, police said.

Police said the black trolley bag was found outside arrival gate number 2 at 12.56 am, in an area which didn't have extensive CCTV coverage. Constable V K Singh of the CISF found it lying under a seat at the forecourt, and alerted

Sanjay Bhatia, DCP (Airport) said, "A guide dog also checked the bag and confirmed there could be an explosive inside. An X-Ray of the bag wasn't clear, so it was sent to the cooling pit." Security at the airport was beefed up and T3 became functional from 4 am onwards.

Before the man came forward, M Ganapathy, CISF Special DG,

Airport, had said it was too early to confirm whether there were explosives inside the bag. EVD machine and sniffer dogs are extremely sensitive when it comes to detecting such content, he said.

"For instance, if there was a bullet cartridge or weapon kept in the bag four-six months ago, the tests would detect those and be positive for explosive content. The tests don't confirm there's RDX or some other explosive inside," Ganapathy said. Later in the day, he said the bag's contents were "harmless" and the bag had been returned to its owner.

Meanwhile, people recalled that those inside the airport weren't allowed to leave, while those outside were told to clear out the area, leading to some tense hours.

Govinder (45), a cab driver, said, "Around 1 am, we saw CISF men outside gate 2. We thought they were clearing the way for a VIP, but later, police told us to leave immediately. We took pas-

Schools shut till Nov 5 as Delhi records worst AQI of season; CM trains guns at Khattar, Amarinder at school event

AS A public health emergency was declared in the capital Friday — after the air quality plunged further to 'severe plus' — the Delhi government ordered that all schools in the city remain shut till November 5 and distributed 50 lakh masks to students. "In the interest of the health and safety of our children, it has been decided to keep all schools – government, government-aided, private — in the NCT of Delhi closed till November 5, 2019. Accordingly, November 2, 4 and 5 be declared a holiday for all schools," read an order from the office of Deputy Chief Minister Manish Sisodia.

Sisodia later said the government might consider extending this period after noting pollution levels on November 5.

Delhi saw the season's worst air quality Friday as the 24-hour average index value was recorded at 484, up from Thursday's 410. The System of Air Quality and Weather Forecasting And Research (SAFAR) said the contribution of crop residue burning in Delhi's pollution was 44%

Thursday and an estimated 36% Friday. Both figures have breached previous highs this season.

The accumulation is because wind direction was Northwesterly, bringing high quantities of smoke from Punjab and Haryana to Delhi-NCR. Along with this, SAFAR said, calm winds had made the region more polluted. According to officials at the India Meteorological Department, the impact of a western disturbance, currently over Rajasthan, is expected to reach Delhi by the beginning of next week and wind speed will rise.

On Wednesday, the education department had sent out guidelines to all schools to ensure they do not organise outdoor activities like assemblies or sports "till severe pollution condition persists".

Before it decided to take the step of closing down schools, the government, earlier in the day, had conducted an event to distribute 50 lakh masks to students.

Chief Minister Arvind Kejriwal personally distributed N95 masks to students at the Rajkiya Pratibha Vikas Vidyalaya

in Civil Lines, during an event telecast across all government schools in the city. These masks have been dis-

tributed to all government

schools, with each student from classes VI to XII being given two masks and a pamphlet on how to use them. "We have done a lot of work

for your education and for your future, but your future can only be good if your health is good. We are giving you all masks... Go give these to your parents and let them decide who will use it according to their needs," said Kejriwal, addressing the students.

At the event, both Sisodia and Kejriwal pointed to stubble burning in neighbouring states.

"Experts say that air pollution has come down by 25% in Delhi while across the country, air pollution is increasing... Now in October-November, all this smoke from stubble burning from Punjab and Haryana has been coming. You should all write to Khattar uncle (Haryana Chief Minister Manohar Lal Khattar) and Captain uncle (Punjab Chief Minister Amarinder Singh) asking them to take care of your health," said Kejriwal.

EPCA orders complete construction ban, govt staggers office timings

Kejriwal asks Centre for a timeline to stop stubble burning

PUNJAB, HARYANA and the Centre should urgently fix timelines to stop stubble burning, Delhi Chief Minister Arvind Kejriwal said Friday, hours after **Union Environment Minister** Prakash Javadekar criticised him for "indulging in a blame game" over the issue of pollution. Even as Kejriwal and

Javadekar accused each other of politicising the issue of dip in air quality, BJP Rajya Sabha MP Vijay Goel, sporting a mask, sat on a fast "against pollution". A portrait of Mahatma Gandhi and the message "Kejriwal government is responsible for pollution" were put up at the venue. Speaking at an official event

on e-mobility, Javadekar raked up the issue of the Delhi government allegedly not paying its share in constructing the Eastern Peripheral Expressway till the intervention of the Supreme Court.

"The CM of Delhi is doing politics even over pollution and indulging in blame game. I will not stoop to that level, but would like to say the Delhi government was supposed to pay Rs 3,500 crore for the EPE and bypass road that would have bought down pollution of Delhi. According to guidelines issued by the Gautam Budh Nagar administration, construction activities, including the use of stone crushers and hot mixers, are banned in Noida and Greater Noida region till 6 am Tuesday. Coal and other fuel-based industries that are yet to shift to piped natural gas will also have to close operations, said officials.

Officials said a decision to shut schools will be taken later. "Since weekends are holidays,

we will review the air quality on Sunday and take a decision," said B N Singh, district magistrate of Gautam Budh Nagar. For residential and commer-

cial purposes, the use of generator sets have been banned, apart from exceptions listed by the EPCA. In case of brick kilns, only those with zig-zag technology are allowed to operate.

"The administration is coordinating closely with the State electricity departments to ensure that the electricity supply is 24x7 in the area and the use of gensets doesn't cause further inconvenience," said Singh.

In Gurgaon, Deputy Commissioner Amit Khatri said strict action will be taken against violators. "They will be penalised and an FIR will also be filed against them," said Khatri.

Meanwhile, dailywage labourers in Noida and Greater Noida remain uncertain about their salaries for the coming days. "Even a single day of no work impacts our incomes," said Kamlesh, a daily-wage labourer.





Cong infighting comes to fore at Haryana CLP leader selection meet

EXPRESS NEWS SERVICE CHANDIGARH, NOVEMBER 1

THE CONGRESS Legislature Party in Haryana Friday authorised AICC president Sonia Gandhi to pick its leader after the newly elected legislators failed to reach a consensus on electing a head.

The Congress, marred by factionalism and infighting, won 31 of the 90 seats in the Haryana Assembly polls last month.

A meeting of the newly elected MLAs to choose the CLP leader was called by the state party chief Kumari Selja at the party office here. AICC in-charge for Haryana Ghulam Nabi Azad and senior party leader Madhusudan Mistri also at-

Sources present in the meeting said the MLAs proposed two names — former chief minister Bhupinder Singh Hooda and former CLP leader Kiran Choudhary — for the post. Ahead of the polls, Hooda had replaced Choudhary as the CLP leader.

While 24 MLAs backed Hooda, seven favoured Choudhary, triggering a tug of war between the two groups.

For the past several months, Congress in Haryana had been suffering from a fierce infighting. After party's poor performance in Lok Sabha polls May this year, party high command had replaced state unit chief Ashok Tanwar and handed over the reigns to Kumari Selja. Tanwar had later quit the party.

Khattar takes stock of BJP's poll performance

HARYANA CHIEF Minister Manohar Lal Khattar Friday held a meeting with BJP leaders who held ministerial positions in the previous government and discussed the reasons for the relatively poor performance by the party in the recent Assembly polls. Against a strength of 47 in the

with absolute majority, BIP won 40 out of 90 assembly segments in 2019.

"A detailed discussion was held on the reasons due to which the party lost on various seats, also in the assembly segments from where ministers were contesting... Various people gave suggestions on how to improve party's performance and what could be the possible reasons for party's loss in 2019 assembly polls," Krishan Bedi, one of the ministers who lost his seat, said.

Cong frosty towards having tie-up with Sena, says Pawar

NCP CHIEF Sharad Pawar on Friday said that his party was not in talks with the Shiv Sena following reports that the latter was exploring options of staking claim to form the government in the state with the help of NCP and Congress. Pawar also said that the central leadership of the Congress has so far been inimical to the idea of having any pact with the Shiv Sena. "No one is in contact with us.

No one has spoken to us. (Sena MP) Sanjay Raut sits in Parliament with me and we have meetings. We do not speak about political dealings but about what the political situation is like around us. We have been having such discussions. However, neither has anyone come to us with any proposal nor have we gone to anyone with any offer," Pawar told mediapersons during his visit to Nashik district on Friday.

On Thursday, Shiv Sena chief Uddhav Thackeray had indicated that his party was exploring options beyond the BJP. Subsequently, Raut met Pawar at his residence Thursday evening.

Pawar also said that the possibility of the Congress supporting the Shiv Sena was bleak. There had been talks that the Sena could seek out both the Opposition parties for external support to form the government.

"I have seen the Congress leadership from up close. The national leadership as per my experience is cold towards such an arrangement... My feeling is that the Congress leadership will not support such an arrangement," he added.

NCP leader Nawab Malik, meanwhile, said the party was open to the option of finding an alternate to the Sena-BJP government. "Even after getting a majority, if the Sena and BJP fail to provide a stable government, we will definitely think of providing an alternate government," he added.

State Cong leaders meet Sonia, she may speak to Pawar soon

MANOJCG NEW DELHI, NOVEMBER 1

AMID THE uncertainty over govformation ernment Maharashtra due to the bickering between allies BJP and Shiv Sena, Congress president Sonia Gandhi, sources said, could meet or speak to NCP supremo Sharad Pawar in the next couple of days to discuss the situation. The Sena has signalled that it was in touch with both the Congress and the NCP.

Top Congress leaders from Maharashtra on Friday flew to Delhi and apprised Sonia of the evolving political situation in the state. Sources said the leaders have conveyed to her that the Sena is "feeling humiliated" and its chief Uddhav Thackeray is upset with the BJP over its reluctance to accept the 50:50 power sharing formula.

A section of senior Congress leaders from Maharashtra are of the view that the party should exploit the situation. Another sec-

tion of Congress leaders believe the party should not wade into the Shiv Sena-BJP tussle, arguing that the Sena is merely indulging in pressure tactics and the two parties will soon bury the hatchet.

A senior NCP leader told *The Indian Express* that he sees little possibility of the NCP and the Congress joining hands with the Sena. "The talk about Shiv Sena being in touch with the Congress and the NCP is superficial. They are just doing it to tease and instigate the BJP. I don't think there is anything serious...It is easy to say but I don't think it (Congress and NCP joining hands with the Sena) is happening," he said.

Maharashtra Congress leaders Ashok Chavan, Prithviraj Chavan, Manikrao Thakre and Balasaheb Thorat held discussions with Sonia and AICC general secretary in charge of organisation K C Venugopal. Sources said while the leaders apprised Sonia about the situation, there was no decision. "As of now, we are waiting and watching how the situation is evolving. We did convey to her that the Shiv Sena is feeling humiliated and Uddhav is unhappy with the BJP," one leader said. The leader said Sonia heard

the state Congress leaders and is likely to discuss the Maharashtra situation with NCP chief Pawar. Former Mumbai Congress

president Sanjay Nirupam, meanwhile, hit out at Congress leaders who are in favour of supporting the Sena to keep the BJP out of power.

"It is their temporary fight to grab more power share. They will be together again and will keep abusing us. How can some Congress leaders think of supporting Shiv Sena?" he said. "It is going to be a futile exercise. Hope the state leaders will realise the truth. Instead of getting into a futile exercise, we must introspect why the party lost 2 percentage of votes as compared to the 2014 Assembly election. As a party, we have come down to the 4th number from 3rd in the state," Nirupam said.

Shiv Sena says can form state govt on its own strength

State may head for President's rule if govt not in place by Nov 7: BJP's Mungantiwar

AMID THE ongoing tension between BJP and Shiv Sena over government formation, Sena MP Sanjay Raut on Friday said that his party could from the government in the state and install a chief minister if it wanted.

"If Shiv Sena decides, it can form the government on its own strength," Raut told mediapersons, adding that talks are yet to start between the two allies on government formation.

He added that there is no need to give political colour to his visit to NCP chief Sharad Pawar on Thursday. "It was a courtesy visit. If you are looking at it with doubts due to the current political scenario in the state, I am not going address your doubts," he said.

The comments came on a day when BJP leader and state Finance Minister Sudhir Mungantiwar said that Maharashtra may head for President's rule if the new government is not in place by November 7. The tenure of the existing Legislative Assembly ends on November 8.

"A new government will have to be in place within the stipulated time, or else the President will have to intervene... Else, like 2014, when BJP had won 122 seats, and was called to form the government, it can be called again by the Governor as it is the largest party," Mungantiwar said.

He, however, added: "The Sena and BJP are natural partners. Everything will be resolved amicably... Both understand the ground reality... In any discussion, there is always give and take. Gradually, both will arrive at some meeting point."

In the October 21 polls, the BIP won 105 seats, while the Sena got 56 in the 288-member Assembly. The NCP got 54 and

the Congress 44 seats. Sena is demanding the CM's post for half of the tenure years and 50:50 division of portfolios. Both these demands have been rejected by the BIP.

Insiders in BJP said that the party has adopted a wait and watch policy. A senior leader said: "Our talks are on the right track. We are working out a formula that would be mutually acceptable to both parties."

The party is hoping that the Hindutva plank would again bring the two warring allies together. "This is especially in the backdrop of developments on upcoming Ram temple verdict,' said the leader.

"Also, the BJP is willing to give more Cabinet berths to Sena when compared to the 2014 state polls. In 2014, it had given 12 portfolios and retained 30. Now, BJP is ready to concede 13 to 15 ministries, including PWD, revenue and excise," another leader said.

Sena chief Uddhav Thackeray, meanwhile, has decided to visit Aurangabad on Sunday to review losses following unseasonal rainfall in the state. Party leaders said that Uddhav would interact with farmers from the villages in Kannad and Vaijapur teshils. "He is also scheduled to hold a review meeting with the divisional commissioner," said a leader.

The editorial in Sena mouthpiece Saamana on Friday at tacked the BIP over the crops affected by unseasonal rain. The farmers are waiting for the assistance and not the new government, it said.

"Instead of standing behind the farmers, attempts are being made to garner support... the caretaker government is more focused on increasing its numbers for the government formation," it said. It added that attempts should be made to provide immediate relief to the farmers.



Ruling party to focus on scheme implementation, Oppn to highlight 'misrule'

SOON AFTER the Election Commission announced fivephase polls in Jharkhand, the political climate heated up in the state, with Opposition parties alleging that the poll panel did not heed their views on conducting the elections in one phase.

Leader of Opposition and JMM chief Hemant Soren said, "The five-phase elections show that everything is not right in Jharkhand." Congress working president Rajesh Thakur said, "The EC sought our views, but it was a fruitless exercise as our request was not heeded. We had demanded election in one phase. It is clear that Left-wing extremism has not reduced in the state."

Jharkhand's Nodal Officer for conducting elections and ADG (Operation) MLMeena said, "Leftwing extremism has been a challenge in Jharkhand, they boycott polls and target polling parties. We have started the preparations."

He said the polls have to be conducted in rough terrain and communication remains a challenge. In 2014, he said, Jharkhand had 21 Left-wing extremism-affected districts, which has reduced to 19 in 2019. "There were 16 most-affected districts, the number is now 13," Meena added.

BIP is in power in Iharkhand, which has a large tribal population, and an alliance of Opposition parties — mainly the Congress and Jharkhand Mukti Morcha (JMM) is making a bid to oust the Raghubar Das government.

While the Opposition parties try to recoup after a dismal performance in the Lok Sabha elections. the ruling BIP is eyeing a 65plus tally in the 81-member Assembly with the "Ghar ghar Raghubar" campaign. Their main poll plank will be the government's work on "effective implementation" of central schemes and setting up of companies under Momentum Jharkhand to provide employment.

Asked if BIP was perturbed by poll verdicts in Harvana and Maharashtra, Das had told The Indian Express, "Maharashtra and Haryana do not have 26 per cent tribal population and situation is very different here. We will definitely win."

The BJP now has 48 seats in the Assembly, with five MLAs from Opposition parties having



EXPLAINED LS poll spell broken, Jharkhand a new test

THE FIRST set of Assembly elections after the Lok Sabha polls was sobering for the incumbent BJP, which witnessed a slip in tally in both Maharashtra and Haryana. It also gave hope to the Opposition, which improved its performance. The Jharkhand elections follow the two Assembly elections that have broken the spell of Lok Sabha elections, in which the Opposition got swept away. Jharkhand will test whether the earlier two state elections marked the beginning of a new trend after Lok Sabha polls, or a one-off sobering reminder to the incumbent.

After recent poll dent, BJP may rethink strategy for Jharkhand

WITH THE below-expectation election results in Harvana and Maharashtra, the ruling BJP is treading cautiously in Jharkhand, where elections will be held in five phases from November 30. Sources said the

BJP will be careful in its ticket distribution and campaign strategy, despite the morale boost it received with a number of opposition MLAs joining the party. Like in Haryana and Maharashtra, the BJP leadership has assessed that the

Opposition's failure to come up with a formidable alternative, the goodwill created by populist measures of the Raghubar Das government and the surge in the wake of its spectacular performance in the Lok Sabha elections would prove advantageous to the BJP in Jharkhand, too. However, the October 21 election verdicts seem to have prompted the party to review its strategies for the polls to the 81member Jharkhand Assembly.

Sources pointed out that the BJP had never won a simple majority on its own in the state formed in 2000 – hence, setting a tall tally as a target was not on the cards. "The BJP will work hard to ensure that we retain power, and if we get a simple majority on our own it will be a big achievement," said a party leader from Jharkhand. The source added that a cohesive Opposition alliance between the Jharkhand Mukti Morcha (JMM) and Congress could pose a challenge. He pointed out that the Opposition could not project a credible alliance in the Lok Sabha polls as there was confusion till the last minute.

In 2014, the BJP won 37 seats in Jharkhand and formed the government after cobbling up an alliance with All Jharkhand Students' Union (AJSU), which won five seats. The coalition won 12 of the 14 Lok Sabha seats in the 2019 general election.

The recent Assembly results have underlined that the electorate may behave differently for national elections and state elections. For Jharkhand, sources said the situation was

not rosy for the BJP as the Lok Sabha poll results would suggest. In fact, they said, Chief Minister Raghubar Das's tactics to rally the non-tribal support base could be counter-productive for the party. The party's performance in tribal areas of Maharashtra were also a warning to the leadership, said a leader.

According to sources, the top leadership has received feedback from the state in-charge that tribals and minorities -Muslims and Christians together form around 20 per cent of the population — could consolidate against the BJP, if there is a formidable Opposition coalition in the electoral scene. Tribals form more than 26 per cent of the population.

The sources also said that populist measures, such as Rs 5,000 per acre to 22.76 lakh medium and marginal farmers, have built tremendous goodwill for the chief minister.

BJP president Amit Shah appointed O P Mathur as election in-charge for Jharkhand months earlier, but the poll results in Maharashtra — where the BJP is relying heavily on its partner Shiv Sena to form the government — and Haryana — where it had to stitch a post-poll alliance with newly formed Jannayak Janata Party as it could not cross the halfway mark – could lead the BJP to recalibrate its strategy and regroup.

Even as leaders like BJP gen-

Vijayvargiya have pointed out the the BJP could have performed better if the organisation had done effective micromanagement on the ground, O P Mathur, the party's election in-charge for Jharkhand, and Saudan Singh, party joint general secretary in-charge, have been working overtime to calm the waters. The BIP's vote share increased to 31 per cent in comparison to 20 per cent in 2009. Among the Opposition parties, the JMM's vote share increased from 16 per cent in 2009 to 20 per cent in 2014, while Congress's vote share came down from 12 to 10 per cent.

An analysis of the 2019 Lok Sabha election results shows that BIP emerged as the leading party in at least 57 Assembly segments in Iharkhand. whereas the Congress was in leading position on 11 seats, JMM 7 and AJSUP 6.

In the 2014 Lok Sabha elections, too, BJP was the leading

party in 56 Assembly segments, but the party could not repeat this performance in the Assembly election held a few months later. At the same time, the BJP's vote share was 40 per cent in the 2014 Lok Sabha election in Jharkhand and increased

Among the Opposition parties, the Congress and JMM too increased their vote share marginally, whereas Jharkhand Vikas Morcha (Prajatantrik), a state party, registered a decline in vote share from 12 per cent

BJP slams MP govt's liquor moves: Won't allow state to become 'Madira Pradesh'

THE BIP on Friday targeted the Congress government in Madhya Pradesh for its decisions aimed at increasing revenue from liquor sales.

The government had recently decided to simplify the procedure for bar licence for resorts to encourage tourism in the forest areas of the state. The bar licences will be provided near forest sanctuaries in addition to national parks.

The government has also decided to encourage liquor shops to create an adjacent facility where people can sit and drink. The government has argued that in the absence of such a facility, people drink on the roads and create trouble.

Leading the BJP's opposition to the moves was former chief minister Shivrai Singh Chouhan. who warned the Kamal Nath government that he would not let Madhya Pradesh become "Madira (liquor) Pradesh".

He claimed that most rapes are committed by people in inebriated condition, and said that the government's decisions would lead to an increase in crime against women and would result in a law-and-order issue.

Chouhan said his government did not allow a single new liquor shop to come up, and had made attempts to reduce the existing shops with an aim to gradually take the state towards prohibition. He cited the decision to close down shops close to the Narmada as a step in that direction.

"Even we used to get such

proposals to increase liquor

shops but our Cabinet used to reject all," the senior BJP leader said, alleging that the Congress government's bid to increase revenue will lead to more crimes. He also pointed out that the state government has taken

these decisions when the country is celebrating 150th anniversary of Mahatma Gandhi, who had referred to alcohol as "a major social evil". In response, Congress leader

Bhupendra Gupta accused the former CM of lying and dismissed his charges as ridiculous. "When you took oath as CM for third time you said there will be prohibition in the state. Why did you not do it? Who stopped you?" Gupta said, and alleging that Chouhan later went back on his announcement to claim that the BJP never promised prohibition and only said that "liquor was bad."

Gupta also alleged that previous BJP government had allowed liquor shops to remain open till late, and reminded Chouhan that his government had withdrawn a proposal to allow those with an annual income of Rs 10 lakh to stock 100 bottles at home.

He also claimed that the former CM was deliberately creating confusion by lying in order to "stay relevant".

The latest spat between the Congress and the BIP comes after the two parties clashed over the introduction of eggs in anganwadi meals, which the previous Chouhan government had not allowed. Leader of the Opposition in the state and senior BIP leader Gopal Bhargav had courted controversy on Wednesday after he wondered aloud whether children who eat eggs will grow up to become "man-eaters".



Sikhs from India won't need passport for visit, says Imran

SHUBHAJIT ROY NEW DELHI, NOVEMBER 1

PAKISTAN PRIME Minister Imran Khan on Friday said Sikh pilgrims from India would only need a valid ID and not a passport to travel to Kartarpur and are not required to register 10 days in advance to visit the Gurdwara Darbar Sahib.

In a tweet on Friday morning, Khan also announced that the pilgrims who arrive on the day of the Kartarpur corridor's opening on November 9 and on the 550th birth anniversary of the Sikh Guru on November 12 will not be charged a fee of \$20 to visit the holy shrine.

While there was no official word on Khan's announcement, sources in New Delhi said that while it is a move in the right direction, the gesture is limited to "only" Sikh pilgrims whereas Indians of all faith are going to be part of the pilgrimage.

Also, sources in Delhi said it would have been better if the fee is waived for all days, as has been their demand. Except the two days, each pilgrim would be required to pay \$20 as fee although India has requested Pakistan not to charge them.

"For Sikhs coming for pilgrimage to Kartarpur from India, I have waived off two requirements: i) they won't need a passport-just a valid ID; ii) they no longer have to register 10 days in advance. Also, no fee to be charged on day of inauguration and on Guruji's 550th

PDP expels sole MP for attending L-G swearing-in event

THE PEOPLE'S Democratic Party (PDP) on Friday expelled party leader and Rajya Sabha member Nazir Ahmad Laway for attending the swearing-in ceremony of J-K's first Lt Governor, Girish Chandra Murmu, on Thursday. Laway, however, questioned who had issued the order saying that the party president in presently in jail.

Laway, a resident of south Kashmir's Kulgam, was the only mainstream political leader, other than leaders of the BIP, who attended Thursday's ceremony at the Raj Bhawan in Srinagar.

In a release on Friday, the PDP said Laway was being expelled for "anti-party activities".

"Member of Rajya Sabha Nazir Ahmed Laway has been expelled from the basic membership of the party. The decision has been taken by the party leadership after learning about the participation of Laway in the official function of the swearing-in ceremony of the newly-appointed Lieutenant Governor in Srinagar, thus undermining the party leadership in entirety".

"The participation of the MP was in contravention to the party stand regarding the current political situation and revocation of Article 370," the release said.

It added that this was not Laway's first violation of the party's directives. "This is not for the first time that the MP has gone against the directives and instructions of the party. Earlier, he abstained from the voting against the Triple Talaq bill, which was tabled in the Rajya Sabha this year. Even after seeking an explanation for such an unruly behaviour, he remained adamant in violating the basic

party norms," the release added. Laway, however, defended his decision to attend the ceremony saying he had been invited as an MP.

"I am a leader and I know what I have to do and where I have to go," he told *The Indian* Express.

"I am a representative of the people. I have to go to the LG tomorrow with demands of people. If I didn't go today, I think, it would not have been appropriate for me to go tomorrow," he added.

"I had an invitation. I didn't go on my own. It is the highest forum and only dignitaries are invited there. I was invited and I went. I am an MP and this invitation was an honour for me. I had to honour it and go there, he said.

He asked who had ordered the expulsion. "But the question is who expelled me? Our party president is in jail. So who is doing it? Earlier also we were asked to resign (from parliament). We came to know about it through TV channels. We are being directed to do this and that. But who is giving these directions?" he asked.

Laway said he was not part of any plan to form an alternative political formation in I-K and continues to be a member of the PDP. "Who is part of that (plan) I don't know," he said.

No annual prayer at Srinagar shrine, police cite security

A DAY after Jammu and Kashmir officially became a Union Territory, police on Friday prevented thousands of people from holding special annual prayers at a shrine in Srinagar. While the cleric of the mosque termed this an "interference in religious affairs", police have cited the "pres-

ent security situation". The Khwaja Nagshband Sahib shrine in the old city area is visited by thousands for annual congregational prayers called Khoja Digar. These prayers were to be held on Friday.

On Friday morning, security personnel were deployed in large numbers to prevent people from reaching the shrine.

Mohammad Tavib Kaamli, the cleric of the mosque, told *The Indian Express* that police informed him on Thursday that prayers won't be allowed on Friday. "This is interference in religious affairs. This is against the Constitution and it is oppression on Kashmiris. Since 1976, this is the first time I am witnessing this," he said.

Local residents who tried to

reach the shrine had heated ar guments with the security personnel. "This is our fate after we became a Union Territory. The government has now started barring us from holding the prayers too. I feel very sad," said Ghulam Mohammed, a Srinagar resident who has been visiting the shrine for the last 32 years.

"People came and were wait ing for the prayers. I saw an elderly woman having an altercation with policemen," Moulana Khursheed Ahmad Kanoongo, a known religious figure in the Valley told *The Indian Express*.

Mufti Fareed ud Din, CEO of J&K Waqf Board, told The Indian Express that all preparations had been made for the prayers. "I don't know what happened May be due to security reasons. the prayers were not allowed, he said.

I&K police officers said they cannot afford to have thousands of people on road in the "present security scenario".

"It is only because of the present security scenario. In the present security situation, particularly in Srinagar, we cannot afford to have 20,000 men on road," Srinagar SSP Haseeb Mughal told *The Indian Express*.

BHARATDAS DARSHANDAS, a priest for whom the Election Commission had set up a polling station deep inside Gir forest during every major election for two decades, died in a hospital in Rajkot on Friday after prolonged illness. The 69-year-old was hospitalised four days ago with renal complications.

Bharatdas was the priest of Bangangeshwar Mahadev temple inside Gir forest in Una Assembly constituency. The EC would set up a polling station at

Banej, a forest outpost near the temple, and Bharatdas would be the lone registered voter there for every election. He would cast his vote without fail.

The EC would send a team of five to six staff and set up the booth inside the forest, as the law mandates that no voter should have to walk more than 2 km to cast his vote. The nearest other station from polling Bangangeshwar Mahadev temple is at least 20 km away.

"Bharatdas was diabetic and both his kidneys failed. He also had high blood pressure. We admitted him to Christ Hospital on Monday. But his health deteriodoctors put him on ventilator. Doctors said his heart was failing gradually, and declared him death on Friday afternoon," Haridas Darshandas, head of Jamadgni Ashram in Kodinar taluka of Gir Somnath, told *The Indian Express*. "He had been battling these ail-

ments for five years." Haridas is 'gurubhai' of Bharatdas. Both were disciples of Darshandas. Bharatdas's last rites will be performed at Jamadagni Ashram at 11 am on Saturday, Haridas said.







IN A big setback for Andhra Pradesh Chief Minister Y S Jagan Mohan Reddy, the Special CBI court hearing the disproportionate assets case filed by the CBI against him has dismissed his petition seeking exemption from his

personal appearance during hear-

ings every Friday. The CBI had filed cases against Jagan in 2011 for alleged quid pro quo investments by businessmen and industrialists in his firms in lieu of favours and benefits given by the government which was then headed by his father, late Dr Y S Rajasekhara Reddy. The CBI had filed 11 chargesheets against

Jagan and several others. The trial in the case is yet to start, but the court had directed Jagan to appear during hearings. It also directed several former ministers and IAS officers named in the cases to be present in the court. After becoming the CM in May, Jagan had filed a petition seeking exemption from personal appearances on the ground that as a chief minister, it was not possible to appear before the court every time. In the petition, Jagan's counsel told the CBI court that as a CM, he had many important duties to attend to everyday and it was not possible to come to

FOUNDATION Innovative New Diagnostics (FIND) on Thursday announced a new initiative, supported by Johnson & Johnson, that will help build and strengthen the capacity of at least seven tuberculosis (TB) culture and drug-susceptibility testing (C&DST) facilities in India, in collaboration with the country's Revised National **Tuberculosis** Control

Programme (RNTCP). FIND will work with state officials to establish and enhance the capacity of TB C&DST laboratories in the high-burden TB states of Maharashtra, Himachal Pradesh and Tamil Nadu.

TB is the world's deadliest infectious disease; in India, a person dies from TB every minute. Growing resistance to the most commonly-used drugs is compounding this public health challenge. India experienced about 1.35.000 new cases of drug-resistant TB in 2018, more than any other country. Globally, only one in three people with drug-resistant TB is diagnosed and put on treatment and, of those, only 56% are successfully cured.

To address this, the RNTCP established the National Strategic Plan (NSP) 2017-25, with the goal of eliminating TB in India by 2025.

The NSP emphasises the need for expanding and strengthening C&DST laboratory capacity.

The WHO recommends at least one TB C&DST laboratory per 10 million people — in India, this equates to 125-130 labora-

"Achieving India's ambitious TB goals depends not just on finding those with the disease, but also ensuring they can be treated with drugs that will work, and for this access to C&DST facilities is essential," said Dr Sarabjit S Chadha, Regional Technical Director, FIND India and South-East Asia region.

After drought, Marathwada's farmers hit by untimely rain

EXACTLY A year since the Maharashtra government declared an early drought in 151 talukas after a poor monsoon, torrential rain over nearly two weeks before Diwali has damaged standing crop on 54.22 lakh hectares of farmland across the state. Almost the entire state is affected, with officials in 325 talukas now receiving urgent requests to assess the crop damage so as to announce relief measures.

Marathwada's eight districts which bore the brunt of acute water scarcity through the first seven months of 2019, are now worst affected by the latest floods, with lakhs of acres of standing crop, including soyabean, cotton and bajra, washed out.

"There is nobody in our village and nearby areas who is not affected. Every single farmer has suffered damage and complete destruction on one or two acres of land," said Shrikant Gadale, a farmer in Beed's Kaij taluka, where moisture stress in August had already led farmers to anticipate only about 50 per cent of average yield for their soyabean and cotton. "Now that too has been destroyed," said Gadale, a resident of Dahiphal Vadamauli

In Latur, resident deputy collector Anant Gavhane said official panchnamas to assess damage have been slow due to the continuing rain, expected to last till mid-November. "Approximately 1,97,857 hectares of crop in 10 talukas of Latur are damaged, but the number may vary once assessment is complete," he said.

Soyabean, an important cash crop that has become very popular among farmers, suffered extensive damage across the region. Soyabean (18.69 lakh hectare), cotton (19.73 lakh hectare), tur (1.18 lakh hectare), maize (4.89 lakh hectare) are the main affected crops. State government officials estimate that total losses could be more than

In Jalna's Math Pimpalgaon village, Babasaheb Jige said he was preparing to harvest his soyabean when the rains began in mid-October. "It rained for 12 days without a stop, losses are tremendous," he said. In Nanded's Ardhapur, scores of farmers have been lining up outside the taluka's agriculture department office, hoping to get assistance in filling crop insurance claims. After a delayed start, the

southwest monsoon this year picked up pace in July. In Marathwada, with districts such as Beed and Jalna suffering a rain deficit until well into August, thousands of farmers delayed sowing. Sowing picked up later, with some regions receiving just enough rain for crops like soyabean, cotton and tur. Barring a dip in sowing of pulses like urad and moong, which are usually sown early in the season, acreage of other crops reported growth.

The cyclonic disturbances in the Arabian Sea and revival of the monsoon as it withdrew led to rain towards the end of October. Between June to November 1, Maharashtra reported an average of 1,353.11 mm rain as against the normal 1,199.4 mm. The eight districts of Marathwada have reported the maximum crop damage - 22.71 lakh hectare across 6,943 villages. Districts in North Maharashtra and Vidarbha have reported damage on 16.69 lakh hectare and 12.47 lakh hectare,

Meghalaya to bring entry law for visitors

Norms similar to inner line permits

THE MEGHALAYA Cabinet Friday approved amendments to the Meghalaya Residents Safety and Security Act (MRSSA) 2016, which will lead to laws that require nonresident visitors to register themselves on the lines of the Inner Line Permit (ILP) system of Arunachal Pradesh, Nagaland and Mizoram.

The move comes in the backdrop of demands for an ILP-like regime and concerns by civil society and political leaders, including Chief Minister Conrad Sangma, that people excluded from the National Register of Citizens (NRC) in Assam might try to enter Meghalaya. ILP is based on the Bengal Eastern Frontier Regulation Act (BEFR), 1873. It is a special permit required by "outsiders" from other regions of the country to enter the three states

where it is currently in force. Meghalaya Deputy Chief Minister Prestone Tynsong told reporters that the amendments, in the form of an ordinance, will come into effect immediately and be regularised in the next Assembly session. They came after consultations between the government with political parties, stakeholders and NGOs in the state. The amendments give more teeth to the laws in place the process "short and simple".

Tynsong, however, declined to

comment when asked about similarities between these amendments and the ILP. He also did not comment on the implementation of NRC in Meghalaya. Speaking to The Indian Express later, he said the amendments were not particularly for illegal foreigners, since there are other laws against them.

Tynsong told reporters that in the original Act, the focus was on registration and documentation of tenants and that the amendments will extend similar rules to cover all non-state residents visiting or living in the state.

"This Act is indicative only for those people who are interested in visiting our state as tourists labourers or for education and business. With this Act in place, they will need to comply with guidelines to be prepared in the form of rules," Tynsong said.

He said the new rules will encompass not only tenants but all visitors and tourists staying, for example, in hotels, home stays, relatives' houses, etc. "We are not stopping them. We welcome them, but with detailed information..." he said.

The Deputy CM said the government will soon draft new rules regarding what documents people need to submit. He said the government would try to make

Youth unemployment rising with educational qualifications: Study

A KEY takeaway from the study of India's unemployment trends by Santosh Mehrotra and Jajati Parida (of Jawaharlal Nehru University and Central University of Punjab, respectively) is the fast-rising trend of youth unemployment.

By youth, the study refers to people in the age group of 15 to 29 years of age. The total number of unemployed youth went up marginally from 8.9 million in 2004-05 to 9 million in 2011-12 but, has since shot up to 25.1 million in 2017-18.

What is worse is that the rate of unemployment (in per cent) is higher as one goes up educational attainment (see chart). Moreover, the authors have concluded that youth unemployment has risen for all categories of educational attainment. The states that housed most of these 25 million unemployed youth include Uttar Pradesh (3 mn), Andhra Pradesh (2.2 mn), Tamil Nadu (2.2 mn), Maharashtra (1.9 mn), Bihar (1.9 mn), West Bengal (1.5 mn), Madhya Pradesh (1.3 mn), Karnataka (1.2 mn), Rajasthan (1.2 mn), Odisha (1.1 mn), Gujarat (1 mn) and Kerala

According to Mehrotra, while

the total jobs in the agricultural sector have continued to decline massively from 232 million in 2011-12 to 205 million in 2017-18 — and this is a desirable trend — the rate of new job creation in

the other sectors of the economy has not been enough to absorb the excess labour. As such, while jobs have gone up in the services sector (from 127 million to 144 million in 2017-18) and the nonmanufacturing sector — which includes activities such as construction, mining etc. — from 55 million to 59 million, yet manufacturing, a sector which has the most capacity to soak up excess labour, saw total employment fall — far from growing — from 60 million to 56 million between 2011-12 and 2017-18.

"The slow growth (or scarcity) of non-farm jobs and the rising open unemployment together have resulted in a massive increase of disheartened vouth," state the authors. A reflection of this is that the number of youth (between ages 15 and 29) declaring themselves as "Not in Labour Force, Education, or Training" rose to over 100 million in 2017-18 from 83 million in 2011-12. "These are young people who are disheartened by the state of affairs and are neither looking for jobs, nor are they interested in studying or training themselves," says Mehrotra.
