Andhra hikes bar licence fees, says prohibition soon

SREENIVAS JANYALA HYDERABAD, NOVEMBER 24

THE ANDHRA Pradesh government has cancelled the existing licences of all the 798 bars in the state and announced a new policy which includes a sharp hike in the fees for obtaining a bar licence. This comes less than two months after the government reduced the number of liquor shops in the state. Deputy Chief Minister (Excise) K Narayana Swamy said the decision is in line with the government's commitment to implement total prohibition next year.

Under the new policy, which will come into effect from January 1 and remain in force for two years, only 479 bars will get new licences. The application fee for 3-star and above hotels has been increased from Rs 10 lakh to Rs 1.45 crore, with a 10 per cent hike after one year, while it

has been hiked from Rs 5 lakh to Rs 10 lakh for the other bars.

"The new (bar licence) policy issued on Friday is aimed at reducing the number of bars in the state by 40 per cent, as announced earlier. On October 1, we had issued a new policy by which the number of liquor shops in the state was reduced from 4,380 to 3,500, and the AP State Beverages Corporation took over these 3,500 liquor shops. These are steps towards implementing total prohibition in the state as Chief Minister Y S Jagan Mohan Reddy promised in his election campaign. Review plea will signal Muslims against important Hindu temple: NCM chief

NATIONAL COMMISSION for Minorities chairman Ghayorul Hasan Rizvi has said Muslims should refrain from filing a review plea against the Supreme Court ruling in the Ram Janmabhoomi-Babri Masjid case as it sends out the message that they are creating obstructions in the construction of a temple for Ram — "the most important Hindu God". It will also amount to breaking the "word" given to the nation to abide by the SC order, he said.

"It is important to understand that the entire country, Hindus, Muslims and even the AIMPLB (All India Muslim Personal Law Board) had promised the country before the judgment that they would abide by



Man gunned down at Hapur wedding

Attack could be linked to court case in which victim was witness, police

AMIL BHATNAGAR NOIDA, NOVEMBER 24

A MAN was killed and four others, including a minor, were injured after armed assailants opened fire at a wedding ceremony in Hapur on Sunday. The victim, Sudheer, was attending a relative's wedding when multiple masked men entered the venue and opened fire, police said. According to them, Sudheer was allegedly the target of the at-

"We received information that there was an attack during a wedding ceremony and that one person had succumbed to injuries. Chaos ensued after the firing at the function. Three injured people are out of danger while the minor continues to be critical. As per prima-facie information, the victim had been a witness to a case in Faridabad which had irked the accused side. This attack is linked to it. We are trying to ascertain further details," said Hapur Superintendent of Police Sanjiv Suman. According to the police, the

wedding procession had left from Faridabad to Nangla Udayrampur in Hapur. A part of the wedding formalities were taking place inside the pandal when the gunmen entered and opened fire. "The victim had appeared as

a witness in a prosecution case where his testimony aided the conviction of the accused. The case had been filed in Faridabad itself. Prima-facie, it appears that the accused in this case have a connection from that court case since Sudheer was the only target," said Suman. The police are yet to determine if the shooting was carried out by the accused on bail or hitmen allegedly hired

The attackers were wearing masks and allegedly fired multiple rounds from country-made pistols and fled, police said.


In view of the attack, checking at the border of Ghaziabad and Gautam Buddh Nagar has been intensified, police said.

Ban on NDFB extended by five years, says MHA

New Delhi: The Centre has extended the ban on Assam-based Bodo insurgent group NDFB by five years, saying the outlawed outfit has continued to indulge in violent activities, including killing and extortion, and undermining the country's territorial integrity in collusion with anti-India forces.

The National Democratic Front of Bodoland (NDFB) has

been indulging in illegal and violent activities, intending to undermine the sovereignty and territorial integrity of India in furtherance of its objective of achieving a separate Bodoland, said Union Home Ministry in a notification. It extended the ban under the provisions of sub-section (1) of section 3 of the Unlawful Activities (Prevention) Act, 1967.

His comments came moments after his tweets, in which he thanked Prime Minister Narendra Modi and insisted "Pawar saheb is our leader".

In one of the tweets, Ajit Pawar said,"I am in the NCP and shall always be in the NCP... and Pawar saheb is our leader. Our BJP-NCP alliance shall provide a stable government in Maharashtra for the next five years which will work sincerely for the welfare of the state and its people." In another tweet, he said,

"There is absolutely no need to worry, all is well. However, a little patience is required. Thank you very much for all your support."

Thanking Prime Miniter Narendra Modi, Ajit Pawar tweeted, "Thank you Hon. Prime Minister @narendramodi ji. We will ensure a stable Government that will work hard for the welfare of the people of Maharashtra.' Acknowledging his tweets,

Ajit Pawar told The Indian Express, "Yes, they are my tweets. I am in the NCP and we are all together. Our NCP-BJP government will win the floor test."

Hitting back at his nephew, NCP chief Sharad Pawar tweeted, "There is no question of forming alliance @BJP4Maharashtra. NCP has unanimously decided to ally with @ShivSena & @INCMaharashtra to form the government. Shri Ajit Pawar's statement is false and misleading in order to create confusion and false perception

among the people." Claiming that most of its MLAs are in touch with the party, the NCP on Sunday released separate videos and statements by four of its MLAs. The MLAs are among the five, apart from Ajit Pawar, whom the party could not make contact with until Saturday. They included Dindori MLA Narhari Zirwal, Shahpur MLA Daulat Daroda, Amalner MLA Anil Patil, Kalwan MLA Nitin Pawar and Ahmedpur MLA Babasaheb Patil.

On Sunday, the NCP released video statements of three MLAs -Babasaheb Patil, Daulat Daroda and Nitin Pawar - where they are seen pledging their fidelity to the NCP and saying that they will work under the leadership of both Sharad and Ajit Pawar. Anil Patil, meanwhile, released a statement saying he has faith in Sharad Pawar's leadership and that he had gone to Raj Bhavan on Saturday at Ajit Pawar's insistence. The only MLA the party has not been able to contact is twotime MLA Narhari Zirwal.

The NCP had on Saturday made a submission before the Supreme Court with documents bearing signatures of 41 of its 54 MLAs who turned up for a party meeting held to remove Ajit Pawar as legislature party leader. On Sunday, NCP leaders claimed they now had the support of 48 MLAs.

The NCP leadership, meanwhile, sent its senior leaders Dilip Walse-Patil and state NCP president Jayant Patil to goad Ajit Pawar to return to the fold. The two leaders held discussions with Aiit Pawar at his Churchgate residence, where he met supporters through the day.

"The bulk of the MLAs are with us. We do not want Ajit Pawar to be left alone. I will try to convince him to come back," said Jayant Patil.

Aiit Pawar, however, seemed in no mood to relent. His statement that the BJP-NCP government would rule the state came after his meeting with the NCP leaders.

His son, Parth Pawar, when contacted by The Indian Express, too sounded confident that the "NCP-BIP alliance" would win the trust vote. "Everything is on the right track, we will provide a strong government for five years," said Parth, who has been with his

The court was hearing a plea filed by the Sena-NCP-Congress, challenging the Governor's decision to recommend revocation of President's Rule and invite Fadnavis to form the government. Appearing for the Sena,

Senior Advocate Kapil Sibal said the BIP-Sena pre-poll alliance had broken down, and hence the question involved was of a post-poll alliance. He referred to the chain of events — from the declaration of Assembly poll results, to the break-up of the BIP-Sena coalition, and the Sena-NCP-Congress alliance holding a press conference on the evening of November 22, wherein it was announced that Uddhav Thackeray would be the Chief Minister candidate.

He said what happened after that was "bizarre". "...it also appears that he (Governor) was acting under direct instructions," said Sibal. The Governor's decision to recommend the lifting of President's Rule and the subsequent developments smack of bias, are mala fide and contrary to all norms set by the court, he said.

Sibal said if Fadnavis believes

passed by the NCP on Saturday, replacing Ajit Pawar as the legislature party leader, and said it had been signed by 41 of the party's 54 MLAs. Singhvi said an English translation of the resolution, which was in Marathi, had been submitted to the Governor on Sunday. "How on earth (Ajit Pawar) could be Deputy CM after 41 of the MLAs had said they don't support him," asked Singhvi, adding, "is this not murder of democracy".

Both Sibal and Singhvi cited the Supreme Court's 2018 ruling in the case of Karnataka, and said BIP leader B S Yediyurappa had been given only 48 hours to prove majority.

Recalling the court's judg-

tion to form the government is part of his discretionary power under Article 361 which is immune to judicial review. Justice Ramana said the is-

sue of who the Governor can invite is already a settled law. Referring to the petition,

Rohatgi said one of the prayers was to direct the Governor to invite a certain party to form government. "This is unheard of," he said. Justice Ramana replied, ap-

parently in a lighter vein, "Mr Rohtagi, in this court, sky is the limit for asking anything. Tomorrow, somebody may even come and say, 'make me Prime Minister'."

Rohatgi said the modalities

of government formation should be left to the House. "The House must respect the Court and the Court must respect the House. Both the organs of the State have to respect each other," he said, and asked how would it be if a House were to pass a resolution that courts should dispose of all cases in two years.

Amid laughter in the courtroom, Justice Ramana replied, "we won't be surprised even if it (such a resolution) is passed". Rohatgi questioned the

maintainability of the petition and expressed displeasure over the hearing on Sunday. "In my opinion, there was no need for a Sunday hearing. There is already a government in place, there is no prohibitory order, nobody is being executed," he said, questioning the urgency. Justice Bhushan replied that

it was the discretion of the Chief Justice of India when to hear it. Rohatgi said the parties con-

cerned should first be served notices and heard. "There is no tearing hurry... they did not form the government till now, they did not lift a little finger," he said, adding that this was the circumstance under which the Governor invited Fadnavis to form the government. When the bench asked

Mehta who was appearing for the Maharashtra government, Fadnavis and Ajit Pawar, the Solicitor General said he was appearing only for the Centre and had got no instructions from the state. The bench noted in its order that though the petitioners have served all the parties through e-mail, no one appeared for the state, chief minister and deputy chief minister.

While the NCP initially maintained that the public mandate was for the party to sit in the Opposition, Sharad Pawar took the initiative of convincing the Congress's central leadership to join a Sena-led government, after the BJP initially declared its inability to form the government without Sena's support.

After the core committee meeting, state NCP president Jayant Patil and national spokesperson Nawab Malik announced the party's intention to "form a non-BJP government in the state."

Pawar's daughter Supriya Sule, former ministers Jitendra Awhad, Anil Deshmukh and Dilip Walse Patil, and two other legislators specially invited by Pawar also attended the meeting.

The day after the meeting, when Sharad Pawar met Congress president Sonia Gandhi in New Delhi on November 18 to discuss the possibility of joining a Sena-led government, Ajit Pawar was also in Delhi. Sources confirmed that he did not accompany Sharad Pawar to Sonia Gandhi's residence, and may have met BJP leaders instead.

The same day, Navneet Kaur Rana, a Congress-NCP backed independent MP Maharashtra, told TV channels in Delhi that the BJP and NCP would soon come to power in Maharashtra. While Ajit Pawar was present

for all the subsequent discussions between Congress and NCP leaders in the state and also attended the Sena-NCP-Congress meeting on Friday, a senior Congress leader said he was uncharacteristically silent during the deliberations. Or Saturday, Sena leader Sanjay Raut who also attended Friday's meeting, had claimed that Ajit Pawar's body language during the meeting had aroused suspicion.

Ajit Pawar's departure from Friday's meeting midway went unnoticed as Sharad Pawar, who also stepped out around the same time, announced Uddhav Thackeray's name as the Sena-NCP-Congress alliance's chief ministerial candidate.

Hours later, Ajit Pawar submitted a letter of support in favour of Devendra Fadnavis and was sworn in as the Deputy CM.

According to police, Yusuf's family told them that he left home Friday morning to pick up a passenger from Pataudi and didn't return home.

Yusuf's brother Farrukh said, "On Saturday, I couldn't find him at his home or with his friends. Later, we learned that Yusuf's car was found near a drain in Sohna district. Police had seized the car and recovered his body. I went to the hospital and identified his body

Yusuf lived in a rented accommodation in Imam Nagar in Gurgaon.

A case of murder and causing disappearance of evidence was registered against unknown persons by Pataudi police after they found injuries on the victim's head and back.

Police suspect that he was killed in a robbery gone wrong and his body may have been dumped in the car later.

A post-mortem was conducted and police are awaiting its result.

Veer Singh, ACP, Pataudi, said, "A case was registered Sunday and we are checking the victim's phone for possible leads. We haven't identified suspects yet and are probing the matter."

Men on bike fall on 'chemical' in Gurgaon spilt on road, 2 dead, 1 injured

TWO MEN died and a third sustained injuries after the bike they were travelling on skidded and they fell on a "chemical" that had spilt on the road, police said. The incident took place near Mori Gate at 5.45 am on Saturday. Police suspect the substance caused severe burn injuries to the victims and led to their death Sunday. Investigation revealed that a truck was carrying the substance, which leaked on the road.

DCP(North) Monika Bhardwai said the three men were on a black Splendor. "After they fell, they experienced a burning sensation on their bodies due to the chemical which is suspected to have leaked from a vehicle. A picket team from Kashmere Gate police station rushed to rescue the men and took them to Aruna Asaf Ali Hospital. Later, the men were referred to Lok Nayak Hospital where two of them died during treatment. The third man is undergoing treatment."

The victims were identified as Mahesh Chand (23) and Shivam Lal (21), while the injured man has been identified as Monu Sharma (22). The men were contractual workers at the New Delhi Railway Station. Police said initial investigation showed that the men weren't speeding and that their bike skidded due to the substance. While Chand and Lal fell on the substance, Sharma fell on the footpath, said police.

A post-mortem examination was conducted and police are awaiting the reports to ascertain the cause of death. A case under IPC sections 285 (negligent conduct with respect

to combustible matter) and 337 (causing hurt by act endangering life) has been registered

against unknown persons. Police said the three men were returning home from a friend's wedding in Shiv Vihar and were using their phones to find their way. They had left around 4 am but lost their way and took a long route from Sadar Bazaar to Mori Gate. A senior officer said they have recovered their half-burnt bike.

Police scanned CCTV footage and identified a truck which they suspect was carrying the substance and are now trying to trace the owner. "A Crime branch team went to the spot and collected samples. We have sent them to the Forensic Science Lab to identify the substance and its nature," said DCP Bhardwaj.

Dr Kishore Singh, Medical Director at Lok Nayak Hospital, said Chand and Lal were in a coma when they were brought to the hospital: "Doctors attempted to revive them but they died. The injured man is undergoing treatment in the Neurology department."

He added: "It's hard to say what caused their deaths; we are checking the chemical and considering others factors as well."

'Men were squirming on the road, trying to tear off their clothes'

SECONDS AFTER the three men fell from their bike, eyewitnesses said they squirmed on the ground and tried to tear off their clothes. When police arrived at the spot, they noticed a foul-smelling substance on the

A head constable posted at Kashmere Gate police station said: "I was deployed with the picket staff at Pul Dufferin when I saw the bike skid around 5.45 am. We rushed to the spot and noticed a foul-smelling chemical. The men were screaming and trying to take off their clothes. Before we could help them, they fainted." An FIR was filed based on his statement.

Picket staff called an ambulance and a PCR van, and rushed Mahesh Chand, Shivam Lal and Monu Sharma to the hospital. Chand and Lal succumbed to their injuries Sunday morning.

Police later found that the substance had leaked from a vehicle a night before the incident. The victims' families were in-

formed around 9 am. Chand's father, Subhash (51), said that he took the bike to the wedding on Friday.

"He told me he would first drop his friends and then return home Saturday. I told him to stay back but he said he had to work

the next day. Later, I received a call from one of his friends that he was injured. I was shocked when I reached the hospital... his head, chest and limbs were red. Police told me that his vital organs were probably burnt but doctors told me to wait for the post-mortem report," said Subhash, who works for a local weekly newspaper. The family lives in a rented accommodation in Dayalpur.

Meanwhile, Lal's family said they are not aware of the cause of his death.

"Doctors said it was the accident, while police said the chemical killed Shivam. On Saturday, we thought that it was only a road accident and that Shivam would survive but doctors later informed us that he is critical. A day later, he died," said Ashish (26), Shivam's elder brother, who lives with his family in Rohini Sector 20.

The men were electricians and were contractual workers at the New Delhi Railway station.

Puri says will make Tiwari Delhi CM, clarifies later

A STATEMENT made by Union Minister Hardeep Singh Puri at a public event, where he said the BJP will contest polls in Delhi to make Manoj Tiwari the chief minister, which was followed by a clarification Sunday gave the Aam Aadmi Party a handle to target the party.

Addressing party workers in Tiwari's constituency of North East Delhi, Puri said: "Manoj Tiwari ke netritwa mein hum election ladne ja rahe hain aur inko hum chief minister bana kar hi chorenge (We are going to contest Assembly elections under the leadership of Manoj Tiwari and we will ensure that he becomes the chief minister)." Puri is also the the co-incharge of the Delhi BJP.

As AAP leaders, including Manish Sisodia and Sanjay Singh, started "congratulating" Tiwari on Twitter, Puri clarified in a tweet: "BIP is moving towards a victory in Delhi. The party has not named anyone as the CM face. Shri Manoj Tiwari is the Delhi BIP president. The party is working enthusiastically under his leadership. My statement meant that BJP will win the upcoming elections with a heavy majority under his leadership.'

According to sources, the BIP has no plans to project a CM face before polls.

Tiwari, who was present at the event, said: "As a state president, my duty is to ensure that we form a government in the state. The issue is not who will be CM; instead we should look at the AAP's restlessness. This shows that they will not be able to sleep at night."

Asked about the possibility of him being the CM face, he said that such decisions are taken by the parliamentary board. Soon after Puri's statement,

AAP leaders Sisodia and Singh had posted a series of tweets.

"I congratulate Manoj Tiwari for being declared the CM candidate for the upcoming assembly polls by BJP," Sisodia wrote.

Singh said that with the announcement, it is certain that AAP would perform better than it did last time. AAP had won 67 out of 70 seats in 2015 polls.

When Puri clarified his statement, Singh tweeted asking BJP to declare the name of its CM face: "Respected Hardeep Puri ji, People of Delhi want to know who is your face in opposition to Arvind Kejriwal. You took Tiwari ji's name but exited the battlefield within two hours. Has BIP given a walkover to Kejriwal?"

BJP sources said that apart from Tiwari, Union Minister Harsh Vardhan and former Union Minister Vijay Goel also fancy their chances should the BJP win in Delhi.

Air quality sees improvement

"We respectfully submit before the esteemed committee that its very formation is but an act of subverting the IHA (Inter-Hall Administration) Committee, which is a statutory body unto itself... It is the IHA Committee, and not a group of arbitrarily chosen members of the faculty with obvious vested interests, which has the mandate to look into issues

concerning the hostels," it added. The INUSU said the "only means by which the current impasse" could be broken was by "an unequivocal revocation of the IHA Manual "passed by the IHA Committee on October 28". in which fee hike was also passed. It also reiterated the demand for the V-C's resignation.

Kadam did not respond to calls and texts asking if suggestions had been received by other hostel presidents or councillors.



SANITATION WORKER DIES CLEANING DRAIN: MEN OFFERED Rs 300 FOR JOB

Forced by supervisor to enter drain, victim's co-workers tell police

NEW DELHI, NOVEMBER 24

CO-WORKERS of the 35-year-old sanitation worker who died after inhaling toxic fumes while cleaning a drain alleged they were forced to go inside the manhole by the site supervisor, said police. Investigation also found that the men were offered Rs 300 each for the job and promised safety gear — which they were never given.

The incident took place in North West Delhi's Shakurpur Saturday. Police arrested two men, Public Works Department (PWD) contractor Rajkumar (27) and private supervisor Babloo Ram (25).

DCP (North West) Vijayanta Arya said the men were contractual workers with the PWD and were pressed into service by the department to clean the drain which falls under its jurisdiction.

Police said the Delhi Fire

Services and locals helped rescue the workers. Ashok, who first entered the drain, was declared dead on arrival. Police said Rohit (30) is critical and was referred to Safdarjung Hospital Sunday. The other two workers, Sai (50) and Gorelal (35), re-

ceived minor injuries and have been discharged.

Police said the accused supervisor, Babloo, has been working with the men for five years. While Ashok's co-workers usually did odd jobs, he mostly worked on maintenance of

cleaning a sewer, which proved to be fatal, said police. The men begun working on

roads. This was his second time

the drain on Thursday and had noticed the fumes, added police.

Gorelal, in his complaint, alleged that he asked for safety equipment but Babloo did not give them anything: "Babloo assured us we would get masks and shoes for the job... When we asked for the safety gear after reaching the spot, he told us we wouldn't need it. When I insisted, he threatened us and said he wouldn't pay us for the previous job if we didn't clean the drain."

An officer said: "The victim wasn't aware of the equipment required to clean the manhole and, hence, went in first wearing just a jacket."

Police said Rohit followed Ashok into the drain. When the men didn't come out, Sai climbed down to help them. "All three got stuck inside. I immediately informed Rajkumar and

Babloo but Rajkumar fled the spot," alleged Gorelal.

Meanwhile, police are trying to trace the families of Ashok and Rohit who live in Madhya Pradesh. "We have uploaded their details, along with their pictures, on the Zonal Integrated Police Network and also sent teams to their villages to contact their families. Nobody has come forward to claim Ashok's body. We received information that the victim and his co-workers left their homes 25 years ago."

Meanwhile, hitting out at Chief Minister Arvind Kejriwal, Union Health Minister Harsh Vardhan visited the hospital Sunday and told doctors to ensure the worker gets the best possible treatment.

On Saturday, Leader of Opposition Vijender Gupta had claimed he was prevented by authorities from entering the hospital. Delhi PWD Minister Satyendar Jain has ordered an enquiry into the incident.

ASKING PEOPLE to be wary of the Centre's announcement that ownership rights in unauthorised colonies will be granted soon, Chief Minister Arvind Kejriwal Sunday said he will ensure that properties in these areas are registered soon.

"In 2008... two months before the elections, provisional certificates were issued. But the promise to regularise was not carried out. The BIP wants to regularise the colonies but does not want to register them. I promise you all I will do anything to register these colonies... Do not trust anyone unless they grant registration," said Kejriwal, who was speaking at Burari's Sant Nagar after inaugurating development work in the unauthorised colony.

On Saturday, Union Urban Affairs Minister Hardeep Singh Puri said the process of regularising unauthorised colonies will be completed within three

months, with the DDA set to launch a portal enabling people to file applications for ownership rights on December 16.

While residents from unauthorised colonies supported the AAP in 2013 and 2015 Assembly polls, the BIP is trying to capture the vote bank this time. "Delhi BJP is going from colony to colony to tell people about the announcement," said a senior BJP leader.

Meanwhile, the CM said that the Opposition will roll back initiatives such as free travel for women and 200 units of free power, if elected to power.

New detention policy in schools unlikely this year

DELHI SCHOOLS are yet to be notified of amendments in the nodetention policy, which were to be implemented in the 2019-2020 academic year. As a result, educationists believe it is too late in the day to enable schools to detain students in classes V and VIII this session.

Earlier this year, the no-detention policy of the Right to Education Act (RTE), 2009, was amended through a parliamentary bill, stating that a child who fails a regular examination at the end of classes V and VIII will take a re-examination. The relevant central or state governments were asked to decide if they will allow schools to detain children who fail the re-examination.

Amendments in Delhi's policy were cleared in August by the state government, allowing all government, MCD and private schools to hold back students in classes V and VIII if they are unable to clear the re-exam. However, implementation has been stalled.

An education department official confirmed that the notification had been drafted by the department but is still being processed.

"It has to be cleared by a number of different departments; at the moment, it is with the Delhi Law department. Our efforts are directed towards implementing it at the earliest," said the official.

Assessment based on written test, extra-curriculars

THE COMMITTEE has recommended changing the assessment model so children are assessed on a variety of criteria apart from standard testing. This includes 15% for attendance; 10% for participation in co-curricular activities like dance. theatre, debates, sports, community service and Olympiads; and 5% based on the attendance of any one of the student's guardians in PTMs.

The 70% of assessment on the basis of testing is recommended to be broken into three parts – 10% based on minimum competency to be attained at primary and upper primary levels; 30% based on 'generic assessment' through questions on a passage, picture or diagram from each subject; and 30% based on standard subject-wise testing as is practiced in schools.

However, another department official said: "It is too late in this year to introduce a change as momentous as this. This is something which needed to be done at the beginning of the academic year... At this stage, students cannot be told they might be detained in the final exams, which are a few months away."

Recommendations for changes in the policy had been made in March by a committee formed to help the Delhi government amend the Delhi Right to Education Rules.

"It will be difficult to notify schools of such wide ranging changes now. The recommendations had been made early, keeping in mind the amount of time that will be required to prepare for them," said a committee member.

The head of a government school said that while teachers are not ready to implement a "rollback in no-detention" this year, low learning levels in government schools could lead to a large number of drop-outs.

"Right now, many students are reaching class IX without even basic reading, and then are dropping out after not being able to clear class IX examinations. A sudden rollback might see an increase in the number of dropouts at class VI itself. I think we should wait for a few years, until learning levels have improved and at least 70% students are passing without the support of the no-detention policy," said the school head.

Helpline comes to patients' aid at Delhi govt hospitals

NEHA SRIVASTAVA (27), who was in her last month of pregnancy, had gone to Pt Madan Mohan Malviya Hospital last month for an ultrasound. Due to give birth on November 22, she was asked to wait till December for the test. After repeated requests to doctors failed, she finally called the Delhi government helpline, 1031.

The helpline is meant for patients and their relatives/attendants at government hospitals to report any kind of lapse in policies of providing free medicines, tests, and surgeries.

"Doctors were rude and told me to come back in December for a simple diagnostic test. They did not even refer me to another hospital. I saw a poster of the helpline number at the hospital, made a call and explained the problem. Within 20 minutes, I received a call from the hospital administration. They gave me a referral prescription and my test was immediately done at another hospital," said Srivastava, who gave birth to a healthy girl two days ago.

Launched by Delhi Chief Minister Arvind Kejriwal in 2014, the helpline, initially meant for anti-corruption complaints, was among the major initiatives introduced by the AAP government after free water and electricity. In 2015, services were extended to hospitals. Administrative charge of the number was given to the health department in 2017.

Dharmendra Kumar, a resident of Kalyan Awas in East Delhi, said: "I was refused medicines at Lal Bahadur Shastri hospital earlier this month. While leaving the premises, I saw the poster about the helpline number and called it to see how it works. Within 30 minutes, I received a call from the hospital's drug store and my problem was resolved." Long queues, shortage of

drugs, unavailability of surgery dates and beds are among top queries raised by patients, said officials. Delhi Health Minister

Satyendar Jain told *The Indian Express*, "Through this helpline number, we have been able to address patient-related issues across government hospitals in Delhi. Now, if any patient or an attendant is unable to get medicines, beds, or face any other issue, they can simply dial the number. We have a nodal officer in each hospital to coordinate with patients.'

As per officials, when a complainant dials the number, the issue is passed on to the nodal officer at the hospital concerned. The officer has to immediately call the patient to his/her room to address the issue and report the resolution.

Notices and display boards displaying the number have been put up in hospitals for patients to call if they do not get medicines for free; face problems in free tests or surgery in private hospitals; or if government hospitals fail to conduct surgeries within 30 days.

92 schools identified for conversion to co-ed

THE DELHI education department has identified 92 school buildings which will be suitable for conversion into single-shift co-educational schools, after construction of new classrooms in them is completed.

Last month, The Indian Express reported that the department had begun a process of mapping capacities of its 1,100-odd schools version to co-educational schools. As of now, approximately 178

of these schools are co-educational while the rest operate as double-shift schools — morning shift as girls' schools and the afternoon shift as boys' schools.

According to the department, after construction of new classrooms, these 92 school buildings are estimated to have 40 or less

students per classroom. A circular issued by the joint director (Land and Estate) said

"8,000 additional equivalent classrooms have been constructed in the first phase and construction of another 13.000 is underway".

This, the circular said, will "rationalise student-classroom ratio (SCR)" after which many double-shift schools can be converted to single shift. At present, 92 out of 285 school buildings have been identified "where SCR would be less than or equal to 40 after construction of addi-

tional equivalent classrooms un-

der Priority-II", it read.

An education department official had told The Indian Express that the aim is to transition a portion of these schools into co-ed single-shift schools by April, in time for the next academic session, and the rest by July, in time for when the children return from their summer vacation.

For now, deputy directors of education have been asked to "comment on the feasibility of the conversion" and send proposals for conversion of other schools.





A CHALLENGE has been thrown to the Aam Aadmi Party-led Delhi government by the Centre just before the national capital goes to polls early next year, this time over the city's water quality. A recent report by the Bureau of Indian Standards (BIS), released by Union Minister Ram Vilas Paswan, found the capital's drinking water quality as the worst among 21 cities surveyed, including Mumbai, Hyderabad and Kolkata. Soon after, debates raged in the Parliament, press conferences and online, with terms such as "politically motivated," "poison water" and "scaremongering" thrown into the mix. A retest is about to happen over the next few weeks of 3,000 water samples from across the city — a far higher number than the 11 samples assessed by the BIS — to determine the "truth".

Against this backdrop, *The Indian Express* followed the journey of Delhi's water, from the source to the tap, to understand and assess how it reaches our homes.

The process

"An experienced eye can easily tell the turbidity in water by just looking at it," said a central laboratory officer at the Delhi Jal Board's Haiderpur water treatment plant (WTP), who did not wish to be named. Turbidity is a measure of suspended particles in water — a higher turbidity makes water more cloudy.

"There have been times, around monsoon, when it reached as high as 6,000 and the water then looks red because a lot of mud gets mixed in it. But we can still bring it down to 1, as is the quality standard," the officer said.

Delhi's two main surface water sources are the Yamuna and Ganga which, officials said, account for around 90% of the water supply. The remaining is covered by ground water. Of the 10 treatment plants run by the DJB, the Sonia Vihar and Bhagirathi WTPs in East Delhi get raw water from the Ganga through pipelines stretching from Muradnagar in Uttar Pradesh, while eight others rely on the Yamuna and ground water supply. The process starts after raw water enters the treatment plant.

At Haiderpur, guards are on patrol near a Yamuna canal that supplies water to it to keep "miscreants" away. Inside, the water passes through four processes before it is released to the public. The first is pre-chlorination, which removes impurities at the start. In the next step, polyaluminium chloride and alum is mixed into the water to remove mud and dirt.

"Together they act as a coagulant, meaning they clump the suspended particles in the water so they can be removed in the clariflocculator," the Haiderpur officer said. In a clariflocculator, which is a large round open tank, clumped particles settle at the bottom and are scraped away as sludge from an outlet below, while clear water is sent further and passed through sand and gravel filters.


An officer, who is part of the treatment operations team in the plant, keeps a register with a neatly drawn table of 13 columns for each parameter that is checked in the water on an hourly basis, before and after treatment, including turbidity, pH level and ammonia. A recent graduate assists the team in testing the water samples in a oneroom laboratory.


The plant runs day and night, and staff keep changing every eight hours. The central lab in the plant, equipped with more advanced testing technologies, also checks raw and treated water quality against 30 parameters, with standards set by the BIS. "If any parameter is found to be higher than the standard, we have to make quick decisions. For instance, if ammonia is found to be high, then we either have to dilute raw water or

shut production completely," the officer said. In the BIS report, all 11 water samples had failed in 19 parameters, including ammonia,

turbidity and pH level. Paswan, who had released the report on November 16, had said in Parliament that water supplied by the DJB was not fit for drinking and had challenged Delhi Chief Minister Arvind Kejriwal for a retest. The CM, in turn, called the report false and politically motivated. At present, officials from both DJB and BIS have been appointed for a re-assessment.

Back at the Haiderpur plant, the "political situation" is mentioned occasionally and quickly shrugged off, but a certain pressure is apparent. "I can guarantee that the water which goes out to the public from here is safe for drinking," the operations officer at the plant said, holding up clear water in his hand after it has passed through the sand and gravel filters.

The final treatment process is post-chlorination. "We add chlorine because... if there is any bacteria, virus or contaminant somewhere in the pipeline, the chlorine reacts with it and kills it after which its own presence is reduced," said Ankit Srivastava, technical advisor to the DIB.

He said the presence of this "residual chlorine" is tested in about 500 water samples the DJB collects every day from its supply network across the city. If it is not found, then there's a possibility of contamination somewhere in the pipeline. The samples are also tested against over 25 other parameters.

Waste treatment plants to homes

After water is treated in the plant, it is released into the DJB water pipeline network stretching over 13,000 km. It first reaches a primary underground reservoir (UGR), a reinforced concrete water tank of a large ca-

pacity where water is supplied 24x7. However, a DJB officer revealed that while changing pipelines a few years ago, around 200 direct consumer connections were found in between water treatment plants and the primary UGRs something that is now prohibited. The department now keeps a track of the amount of water received and supplied with 2,200 flow meters installed across its network.

From the primary UGR, water is either supplied directly to

colonies based on a fixed time schedule, or is sent to a secondary UGR and in rare cases, a tertiary UGR, which cater to single or a group of colonies. Together, there are nearly 500 UGRs in Delhi. The water pipelines pass in front of houses and it is the responsibility of consumers to apply to the DJB for a connection, officials said. A DJB engineer then assesses the site and recommends how the connection can be made with the help of a DJB licensed plumber.

The water department assesses the quality of water supplied to homes every day, in addition to around 1,500 samples tested at WTPs and of raw water sources. Between January and September 24, 2019, over 1.55 lakh samples were tested by the DJB, of which 2,222, or 1.43%, were found unsatisfactory. In October, more than 16,000 samples were tested, of which 3.98% were unsatisfactory. The DJB states that as per guidelines of the World Health Organisation (WHO) on drinking water quality, 95% of the overall samples assessed in a city have to pass the test.

Kejriwal, too, has maintained that water quality of any city cannot be determined based on 11 samples, as done by the BIS. He said that as per WHO guidelines, one sample should be taken for every 10,000 people, based on which 2,000 samples should have been assessed from Delhi. Complaints of bad water quality are received from less than 125 areas in the city at present, the CM said, as against over 2,300 when the AAP came to power in 2015. The joint BIS-DJB survey would test five samples from homes in every municipal ward — apart from UGRs, treatment plants and raw water sources — and the results would be put out in public domain.

The AAP has questioned the process adopted by the BIS for its recent water quality report. DJB vice-chairman and AAP MLA Dinesh Mohaniya has alleged that the standards body may not have tested all 11 samples — he claimed one was taken from an address that did not exist and the occupant of another said no sample was collected from his place.

He also claimed that one sample was taken from the house of a member of Paswan's Lok Janshakti Party (LJP) and that at a fourth address, the occupant said an LJP worker had collected the water sample and not the BIS. The DJB also tested samples from 9 out of 11 addresses covered by the BIS, of which eight were found fit for drinking, Mohaniya said.

Paswan, on the other hand, has challenged the CM to remove ROs (reverse osmosis purifiers) from Delhi government offices: "If tap water in Delhi is pure, then Kejriwal should announce the removal of ROs from government offices and start providing tap water in official meetings."

Contamination

Sampling is done by the DJB every day during water supply hours, for which houses and UGRs are picked randomly. At a primary UGR in Rohini, a DJB employee drew in water from a tap to test whether it has "residual chlorine" To find out, a solution is put in a glass tube and water is added in it. The colour of the water added to the tube turned yellow right away meaning it had chlorine. Samplers also check the exact amount of chlorine present in the

> water using a separate method. The problem of contamination arises, Srivastava said, when consumers start using electrical pumps to draw in water during odd hours, when water is not supplied by the DJB and the pipelines are empty. "If a lot of people are using pumps at the same time, it creates a vacuum in the pipe; if there's a breakage somewhere, dirty water will seep through it... If someone has done unauthorised connection, and it's not done properly, the Jal Board line gets tampered and that will


contaminate further connections in that line as well," he said.

"When (improper connections) are made by a large number of people in a colony, then the water pipe becomes ruptured everywhere. You then have to replace the whole pipe," Srivastava added.

The problem also arises if a water pipeline has completed its lifetime and needs replacing but is still being used, or if any construction activity on the roads damage the pipes. On an average, the DJB changes around 250 km of its water network every year, officials said.

There's also the problem of ammonia, which is found in potable water supply if sewage mixes with it. Large amounts of it also enter the WTPs when industrial effluents are released by Haryana into a drain which gets mixed with raw Yamuna water, a DJB official said. This affects the Chandrawal, Wazirabad and Okhla WTPs. Production here has to either be stopped completely or affected water has to be diluted to treatable levels, with raw Yamuna water diverted through pipelines. All three WTPs are being fitted with advanced tech-


nologies to treat high levels of ammonia. With a re-assessment of the city's water quality about to take place, the DJB is positive it will meet all standards. Mohaniya also said water supplied by the department is fit for drinking without any additional purification required. The report of the re-test is expected to be released in a month.

THE UNNAMED MLAS

IN A repeat of the 2018 Supreme Court hearing in the Karnataka government formation case, a "group of independent Bharatiya Janata Party legislators" got a hearing in the apex court on Sunday in connection with the government formation in Maharashtra. Curiously, in both cases, the BJP MLAs remained unnamed and former Attorney General and senior advocate Mukul Rohatgi appeared for them. While the court noted that Chief Minister Devendra Fadnavis and the BJP were not represented, the arguments advancing the party's position were made by the unnamed MLAs.

EXPANDING OFFICE

THE BJP, which is keen to expand its footprints across the country, seems to be in a mood to expand its space in Parliament Building too. The room between BJP's parliamentary party office and the room used by Atal Bihari Vajpayee and LK Advani was allotted to the TDP. However, with the TDP shrinking in size, it has been officially slotted for the YSRCP, although the TDP is not in a mood to vacate it immediately. But the small office attached to the TDP's room is locked out and the party MPs are using only the main hall. Sources said the BJP wants to extend its office to this room, which would give them more space and a smooth passage in between its two rooms. The BIP's argument is that neither the TDP nor YSRCP requires such a vast space inside the complex whereas with 303 MPs, it needs that space.

STAYING AWAY

AFTER SEVERAL requests and reminders for restoring Internet connection on the campus of National Institute of Technology in Srinagar, the J&K administration finally restored partial access to Internet. This, however, may not lead to final-year students coming back soon. A large number of fourth-year students have left the institute to prepare for GATE examination and for job placements. Since, there is no WiFi access on campus even now, students who left to prepare for GATE may not come back.

MP's first non-Cong CM Kailash Chandra Joshi dies at 90

KAILASH CHANDRA Joshi, the first non-Congress chief minister of Madhya Pradesh, died at a private hospital in Bhopal after prolonged illness. He was 90. The state government has announced a three-day state mourning.

Joshi will be cremated at his native place in Hatpipliya in Dewas district on Monday.

In the elections held imme-

diately after the Emergency was lifted, the Janata Party defeated the Congress and Joshi became CM for less than seven months between June 1977 and January 1978 — he resigned on health grounds. Before being elected as the CM, he was the Leader of Opposition in the state Assembly for five years.

His long career began with a membership of the Bharatiya Jansangh. Describing him as a stalwart who contributed strongly to MP's growth, Prime Minister Narendra Modi said Joshi worked hard to strengthen



the Jana Sangh and the BJP in central India and made a mark as an effective legislator.

Chief Minister Kamal Nath said the loss was irreparable and described the BIP stalwart as soft spoken.

Besides representing Bagli in Dewas district eight times, Joshi was also the Bhopal MP between 2004 and 2014. He also represented the state in the Rajya Sabha. He was twice the state president of the BJP. His son Deepak Joshi was the school education minister in the Shivraj Singh Chouhan government. Calling him 'saintlike', Chouhan said Joshi was simple and avoided pretence.

UP Cong expels 10 over indiscipline

THREE DAYS after the Uttar Pradesh Congress Committee (UPCC) issued showcause notices to 11 state leaders for holding an "unnecessary" meeting against a decision of the All India Congress Committee, 10 of the leaders were expelled from the party for six years on Sunday.

The 11 leaders had recently held a meeting at the residence of former MP Santosh Singh in Lucknow and raised concerns over fresh appointments in the state Congress committee, including those who had recently joined the party. They had also

decided to meet Congress president Sonia Gandhi to express their concerns and to hold a convention in Western UP of state leaders who felt sidelined in the new committee.

Those expelled include veteran leader Ram Krishna Dwivedi and Satya Dev Tripathi, who served as chairman and member of the disciplinary committee, respectively, and were also state ministers. Others on the list include former MLAs Mudhar Narayan Mishra, Vinod Chaudhary, Nek Chandra Pandey, former Youth Congress president Swayam Prakash Goswami and former Gorakhpur district president Sanjeev Singh.

In show of unity, Pawar, Uddhav meet NCP MLAs

MUMBAI, NOVEMBER 24

IN AN attempt to put up a united face after the Ajit Pawar-led split in the NCP, party chief Sharad Pawar and Shiv Sena chief Uddhav Thackeray met NCP legislators together on Sunday.

During the two-hour meeting at the Renaissance hotel in Andheri (East) where the MLAs have been sequestered, both leaders told the NCP legislators that they had no reason to be worried and that the Sena-NCP alliance was sustainable and long-lasting. Legislators told *The Indian*

Express that Sharad Pawar also asked if the MLAs felt pressured or were at the hotel under duress. Many of them are said to have replied that they had been contacted by the Ajit Pawar camp.

The NCP has claimed that 48 of its 56 MLAs were present during the interaction. Sharad Pawar was the first to arrive at the hotel and he subsequently held talks with them.

"He asked whether the MLAs were fine and whether they were under any duress or pressure. Some of them said that they had been contacted by members of the Ajit Pawar camp to switch over. The MLAs, however, said that their loyalties were with Sharad Pawar and they would stay with him," an insider who was privy to the meeting said.

After Uddhav arrived, the two leaders had a detailed discussion before meeting the legislators together. The two leaders also had an extended personal chat with NCP leader Dhananjay Munde, a close associate of Ajit Pawar. It was at Munde's residence that the rebel MLAs had gathered on Saturday morning ahead of the swearingin of Devendra Fadnavis as Chief Minister and Ajit Pawar as Deputy Chief Minister.

Munde had remained incommunicado to Sharad Pawar. His phone had remained switched off after the swearingin ceremony, and no NCP leader was able to reach him until his appearance at the legislators'

meeting on Saturday evening.

Subsequently, the two leaders held a joint meeting with all the NCP legislators where Uddhav assured them that the NCP-Sena relationship was not for short term gains but was an alliance for the future. Yuva Sena chief and Worli MLA Aaditva Thackeray was also present.

"Don't think that this relationship is limited to five years. This pact is for long term. We have the majority and be rest assured that the 'Maha Vikas Aghadi' will form the government in the state," Uddhav told the MLAs.

Interestingly, the Shiv Sena as well as NCP leaders and workers kept a combined vigil around the hotel premises to ensure that any attempts to poach MLAs were stalled.

NCP MLA Jitendra Awhad complained about the presence of policemen in plainclothes on the hotel premises and accosted a few of them. "I do not understand the need for deployment of plainclothes policemen in the hotel when the political situation in the state is volatile. This is a classic case of intimidation by the government," Awhad said.

Meanwhile, Congress leaders also complained that their legislators were being approached. The 44 Congress MLAs are presently at the Marriott near the international airport.

Former CM Ashok Chavan said attempts were being made to poach Congress MLAs. "There are attempts being made to contact our MLAs. We have had instances of BJP members booking rooms in the hotel and trying to get in touch with our MLAs," he said, adding that he was sure the legislators would stay united despite all such attempts.

Meanwhile, the Congress legislators were also given a briefing on the impact of defection on membership of the Legislature Assembly. The MLAs were given a detailed briefing on how legislators in Karnataka lost their membership when they defected and how they had to approach the SC to be eligible to fight elections again. "They were also reminded of the pact between the Congress-NCP and Shiv Sena to field a combined candidate against any member who defects," a source said.



THE CONGRESS, NCP and Shiv Sena have made a pitch before the Supreme Court for conducting the floor test at the earliest instead of the November 30 deadline allowed by Maharashtra Governor Bhagat Singh Koshyari. The battle, however, will rest on two crucial aspects, which are likely to weigh on the minds of the lawyers arguing in court: the appointment of a pro-tem Speaker and who is recognised as the NCP legislature party leader.

The Governor has to convene a brief session of the Vidhan Sabha to facilitate the floor test and appoint a pro-tem Speaker. The pro-tem Speaker has a limited role of administering oath to newly elected legislators and conducting the floor test for the Chief Minister to prove majority. Subsequently, the ruling party appoints a Speaker.

Conventionally, the seniormost legislator is picked as the protem Speaker although this is not binding on the Governor. Congress's Balasaheb Thorat is said to be the senior-most legislator but since it is not mandatory for Governor Koshyari to follow the convention, the appointment could likely be another cog in the wheel for conducting the floor test.

In 2018, Karnataka Governor Vajubhai Vala appointed BJP leader K G Bopaiah as the protem speaker although Congress's R V Deshpande was the seniormost MLA. The Governor had said he picked Bopaiah from a list of names submitted to him by the secretary of the state legislative assembly. Despite pleas from the Congress, the Supreme Court did not look into the merits of Bopaiah's appointment. It, however, directed the secretary

of the legislative assembly to permit several local channels to broadcast the trust vote live.

In the 2016 trust vote, in which then Congress chief minister Harish Rawat proved his majority, the Supreme Court had directed that the registrar general of the Uttarakhand High Court would be present as an observer.

Another issue that would be key to the outcome of the floor test is who is recognised as the NCP's legislature party leader.

Although the NCP MLAs on Saturday sacked Ajit Pawar as the legislature party leader, denouncing his letter of support to the BIP and appointed Jayant Patil in his place, the Speaker would ultimately decide on who would be recognised as the party whip on the floor of the House. Since Patil's election was after Ajit Pawar extended NCP support, if the Speaker allows him to issue a whip to NCP MLAs, then the Speaker could disqualify the party's MLAs who defy the whip. NCP lawyers told the apex court that 41 MLAs were present in the meet sacking Ajit Pawar

Maharashtra BJP leader Ashish Shelar has already called the sacking of Ajit Pawar "legally invalid" since it did not have the Governor's approval.

The Congress-NCP-Sena's lawyers would be conscious of the advantage of getting the court's nod on this aspect as well.

What SC said on Gov's role in earlier rulings

THE SUPREME Court on Sunday sought the letter submitted by Devendra Fadnavis to Maharashtra Governor Bhagat Singh Koshyari claiming majority support, and the Governor's letter inviting him to form the government. A perusal of these documents will help decide whether due process was followed in inviting the BJP leader to take oath as Chief Minister.

A corollary to this is the independence of the office of the Governor, as discussed in various judgments of the top court, starting with the historic March 1994 decision in the S R Bommai case.

Discussing the scope of exercise of powers under Article 356 of the

Constitution, the Supreme Court, in the Bommai judgment, had laid down limits of the President's power in dismissing state governments, and established that the floor of the House is the only place to conclusively test majority. In their petition, the Shiv Sena,

NCP and Congress have contended that at the time of government formation, the Governor is duty bound to select a chief minister who can demonstrate that he enjoys the confidence of majority of the legislators in the House. They have cited the Supreme Court's decision, in January 2006, in the case of Rameshwar Prasad and Others Vs Union of India and Another to buttress this.

Discussing the role of Governors in government formation, a bench headed by then Chief

Justice of India Y K Sabharwal, and including then Justices K G Balakrishnan, BN Agrawal, Ashok Bhan and Arijit Pasayat, had said that a political party having prima facie support has to be permitted to form the government, and it would have to ultimately prove majority on the floor of the House.

The petitioners have said there has to be some cogent material, in the form of letters of support, to arrive at such a prima facie conclusion, and the discretion

The petition says the BJP has shown no such demonstration, either by way of letters of support or physically parading the MLAs, and the party clearly falls short of the halfway mark. The three parties have also contended that the BJP cannot achieve the numbers by breaking other parties in view of the anti-defection law.

The verdict in the Rameshwar Prasad case referred to the Bommai judgment, which was delivered by a nine-judge bench, and said the role of the Governor had come in for considerable criticism on the ground that some Governors had failed to display the quality of impartiality expected of them. The Sarkaria Commission Report, the court noted, had said that "many have traced this mainly to the fact that the Governor is appointed by, and holds office during the pleasure of the President, i.e., in effect, the Union Council of Ministers."

The Supreme Court had said the Governor's action should be to protect the Constitution and not to promote the political interests of any political party. "Undisputedly, a Governor is charged with the duty to preserve, protect and defend the Constitution and the laws, has a concomitant duty and obligation to preserve democracy and not to permit the 'canker' of political defections to tear into the vitals of the Indian democracy," it had said, adding that the courts could look into any malafide decision.

Third special hearing in top court on non-working day this year

New Delhi: The hearing on Sunday in the Supreme Court on the Shiv Sena-NCP-Congress combine plea is the third instance this year when the apex court held a special proceeding on a non-working day.

On April 20, the top court held an extraordinary hearing on Saturday after a former employee of the apex court accused then Chief Justice of India Ranjan Gogoi of sexual harassment and

Later on November 9, the apex court delivered its historic verdict, again on Saturday, in the Ram Janmabhoomi-Babri Masjid land dispute case in Ayodhya granting entire 2.77 acre of disputed land in Ayodhya to deity Ram Lalla.

This is the third instance when the apex court this year held hearing on a holiday. Last year in May 2018, the top

court had heard a matter during midnight when Congress challenged the invitation by the Governor to the BJP to form the government in Karnataka.

On July 29, 2015, the apex court had sat through midnight to consider an urgent plea to stay the scheduled execution of lone death row convict of 1993 Mumbai blasts case, Yakub Memon, at 6 am the next day.

In 1985, the apex court's doors were opened past midnight to hear the bail plea of a prominent businessman who was charged under the stringent FERA law.

Like Karnataka tussle, SC to examine again: Did Governor rely on correct material? in the early hours of May 17, 2018. EXPLAINED

IN A repeat of the legal tussle for formation of the government in Karnataka in 2018, the Supreme Court is once again called on to look into whether the Maharashtra Governor, Bhagat Singh Koshyari, relied on "correct material" to allow Devendra Fadnavis to stake claim to form the government.

In 2018, the Congress party and JD(S) knocked on then CJI Dipak Misra's doors at midnight after Governor Vajubhai Vala scheduled the swearing in of BS Yediyurappa as the Karnataka CM and appointed BJP legislator K G Bopaiah as pro-tem Speaker instead of Congress MLA R V Deshpande, who was the seniormost legislator. As per convention, the senior-most legislator is appointed as pro-tem Speaker

to conduct the floor test. As in the Karnataka case, the

Discretionary powers limited ALTHOUGH THE decisions made by the office of the

Governor enjoy immunity from judicial review, the Supreme Court has in a series of verdicts defined the contours of the discretionary powers of a Governor. The court has held that the discretionary power of a Governor is very limited and even in that limited area, the exercise of power cannot be arbitrary or fanciful and must be in good faith and bound by convention.

petitioners also alleged that the Governor overlooked a post-poll alliance and administered the oath to the BJP's chief ministerial candidate. In Karnataka, the Congress and JD(S) had announced a post-poll alliance though the Governor invited the BJP, the single largest party, to form the government.

In the Karnataka case, senior advocate Abhishek Singhvi, who appeared for Congress, hinged his

case on whether the Governor wrongly relied on Yediyurappa's letter claiming to have 111 MLAs (BJP has 104) staking claim to form the government. However, Singhvi did not produce the letter and the court did not stay the floor test that was scheduled for the next day. The court asked Yediyurappa to produce his letter to the Governor after an unprecedented three-and-a-half-hour marathon hearing that took place

The SC noted in the next

hearing, after Yediyurappa was sworn in as chief minister, that the letter only conveyed Yediyurappa's assertion of having majority to stake claim, and not numbers or signatures of the MLAs. The court then ordered a floor test the very next day, virtually setting aside the Governor's order granting the government 15 days to prove its majority on the floor of the House.

On the same lines, Singhvi, appearing for the Congress and NCP, questioned the Governor's decision to rely on Fadnavis's letter. Both Singhvi and senior advocate Kapil Sibal, who appeared for the Shiv Sena, argued that the Governor's decision was "unconstitutional".

Since Fadnavis has already been sworn in, the court agreed to look into the merits of the Governor's decision. On Sunday, the Supreme Court asked Solicitor General Tushar Mehta


to produce the letters by Governor Koshyari recommending revocation of President's rule in the state and inviting Devendra Fadnavis to form the government. The court also sought the letter Fadnavis submitted to the Governor showing he has the majority. In both cases, former Attorney

General and senior advocate Mukul Rohatgi, appearing for BJP MLAs, who he refused to name during the hearing, argued before the court that constitutionally the Governor's actions were not subject to judicial review. Citing Article 361 of the Constitution, Rohatgi argued that any act done in exercise and performance of the powers and duties of the office of the President and Governor were immune from scrutiny by courts. However, over the years, the Supreme Court has interpreted this provision liberally and examined actions of the Governor's exercise of discre-

tionary powers.

celebrate Constitution Day in an effective manner and governors will play a major role in creating about awareness the fundamental duties.

"The post of governor is the most important link in our federal system. Governors have a role in ensuring better coordination between the Centre and states," Kovind was quoted as saying in an official release.

The President also made suggestions to governors to make their Raj Bhavans more interactive and accessible to ordinary people and representatives of different organs of the state.

The conference laid emphasis on tribal welfare and issues related to water, agriculture, higher education and ease of living.

During the meeting, five groups of governors submitted their reports on these issues, and deliberated and identified actionable points in which governors can play a facilitating role.

Rajasthan: J&K students say hurt when called terrorists

With new deadline in sight, work on Rohtang tunnel picks pace

SIXTY FIVE-YEAR-OLD Jhumki Devi is lined up at a checkpost along the snow-bound Chandra river, firmly holding on to a permission slip which will allow her to travel to Manali in a bus. She is making a visit to her doctor — a trip that would have been unthinkable this time of the year if it wasn't for the partially opened

Rohtang tunnel. Most winters, heavy snowfall in the Rohtang Pass cuts off villages in Lahaul-Spiti from the rest of the country. That's set to change with the tunnel, which cuts through the mighty Pir Panjal range, providing a winter

to residents of Lahaul and Spiti but also to those living in Zanskar valley of Ladakh. At 8.8-km, it's the world's longest highway tunnel above 10.000 feet. With work on the tunnel

nearly complete, Defence Minister Rajnath Singh recently told Himachal Chief Minister Jai Ram Thakur that the tunnel would be operational by May 2020 as against the official schedule of September 2020. The new deadline has given fresh impetus to the remaining work inside the tunnel — the paving of the concrete road, among other work.

That means that the tunnel, which had been opened for civilian traffic a week ago, will again be closed from November 25 on-

Given the stealth in the swearing-in, a prompt floor test in Maharashtra is the only way to bring the light in

HERE IS HARDLY any moral high ground left in Maharashtra's political arena. But the question raised by the events of Friday night-Saturday morning is this: Is the constitutional ground also slipping rapidly? That question is, now, before the Supreme Court. On Sunday, the Court gave a notice to the respondents, after the Shiv Sena-NCP-Congress knocked on its door, and directed that two letters be produced before it on Monday morning - the letter of support presented by Devendra Fadnavis in support of his claim and the Governor's letter inviting him to form the government. Those two letters feature in the bizarre sequence of events that led to the swearing in of Fadnavis as Chief Minister of Maharashtra in the early morning hours on Saturday, after President Ram Nath Kovind revoked President's Rule at 5.47 am, in the wake of the Narendra Modi government invoking a special provision of The Government of India (Transaction of Business) Rules which gives the Prime Minister special powers to permit a departure from rules - to circumvent the need for a meeting of the Union cabinet. The court will be watched for the urgency with which it orders a floor test, the only way in which the legitimacy of a government can be tested, a principle established by its own Bommai ruling. The court, it is hoped, will not only show the way forward, but also restore a semblance of constitutional propriety, offer a restatement of constitutional presence, after a night in which the darkness drew into its fold high constitutional offices like that of president, prime minister and governor.

In Maharashtra, the political tug and pull has now been overtaken by serious questions of adherence to, rather betrayal of, constitutionalism, in letter and in spirit. But let there be no doubt that when it comes to playing with the mandate, all parties are in the dock, no side conducted itself honourably. After the break-up of the long-standing Shiv Sena-BJP pre-poll alliance, which won a majority of the votes, the jarring unlikeliness of the Congress-Sena partnership has been followed by the swearing-in of Ajit Pawar as Fadnavis's deputy. The Congress has for long decades fought the Sena and its brand of politics in Maharashtra and used that stated antagonism to bolster its own "secular" credentials. Fadnavis and the BJP have loudly and insistently targeted Ajit Pawar, for the alleged irrigation scam and the multicrore scam in the Maharashtra State Cooperative Board - the high court is scheduled to hear the irrigation case this week.

But the question before the court goes beyond the tawdriness in the air, the secretive parleys between parties, the meetings of MLAs holed up in three Mumbai hotels, the twists and turns in the Pawar family drama, playing out in real time on Twitter. Can a government be sworn in while a nation sleeps, can it be a result of pre-dawn moves and stealth in the night? The court must bear in mind that whatever it says will be read closely by a nation looking for

Rule of Rajapaksas

Sri Lanka needs a politics of national reconciliation. It looks unlikely to get it

OTABAYA RAJAPAKSA'S PRESIDENCY has started off predictably and disquietingly. There is no pretence that this time it will not be the Rajapaksa family rule.

After Ranil Wickremesinghe stepped down as Prime Minister following the Gotabaya victory, the new president lost no time in appointing Mahinda as the new prime minister of a caretaker government. Another brother, Chamal, has been appointed a minister in the government, which will hold fort until fresh parliamentary elections are held in March 2020, the earliest that the present parliament can be dissolved before the end of its five year term next August. At the height of the previous Rajapaksa rule, there were 40 family members in government. There is little doubt that Mahinda, who was barred from the presidential election because he had already held the office twice, will run the country in close coordination with his brother. At the moment, the parliamentary configuration is not such as to allow the new dispensation to do away with progressive amendments to the Constitution made by the last government to check the powers of the executive presidency, including the two-time bar. But it would surprise no one if the Rajapaksas turned the clock back on these 2015 amendments when the opportunity arises.

That moment may not be far away. President Rajapaksa is confident of winning the 2020 parliamentary election, and that self-belief may not be far off the mark. A divided opposition, engaged in a tug of war between Wickremesinghe and the unsuccessful presidential candidate, Sajith Premadasa, is unlikely to get its act together to put up a fight to the Rajapaksa purpose built political vehicle, Sri Lanka Podujana Peramuna. In any case, Sri Lankan voters have seen that cohabitation — in which the president and prime minister are from different parties — is another name for paralysis of governance. It happened in 2001, and once again in 2015, although in the second instance, it was dressed up as a "national unity government" and showed some promise before imploding because of irreconciliable differences between former President Maithripala Sirisena and Wickremesinghe.


External affairs Minister S Jaishankar is said to have communicated Delhi's desire for hastening national reconciliation in Sri Lanka. The Rajapaksas have a poor record on this front. In the post-war years, the first family oversaw an unprecedented militarisation of the Sinhala Buddhist majority community. Voters from the majority community have not forgotten that it was the brothers, Mahinda and Gotabaya, who crafted a victory over the Liberation Tigers of Tamil Eelam. This is what powered Gotabaya's majoritarian victory in these elections. Nor did Tamil voters forget what it was like in the years following the 2009 defeat of the Tigers. National reconciliation requires states manship of a tall order. It would be a pleasant surprise if Gotabaya, the newest majoritarian right wing leader to join the growing ranks of such leaders in the world, can pull it off.

The absence of compassion



On NRC, Home Minister Shah and former CJI Gogoi show a similar disregard for suffering of the vulnerable

THE COUNTRY TODAY stands at the brink of catastrophic human suffering and injustice, if the government implements, nation-wide, the National Register of Citizens (NRC), as announced by Union Home Minister Amit Shah. Combined with the Citizenship Amendment Bill — assuring citizenship to all undocumented persons except those of Muslim faith — it risks tearing the country apart, reopening the wounds of Partition, and ultimately destroying India's secular democratic Constitution.

For six years, the people of Assam were compelled to scramble for documents of land ownership, birth, schooling and voters' lists to establish that their parents and they were citizens of this country. Too much was at stake. If they failed, they ran the risk of being lodged for years in detention centres carved out of jails, separated from their families, and threatened with deportation. Impoverished people in desperation sold all their belongings to engage expensive lawyers, and weathered often hostile or corrupt officials. Some despaired and killed themselves.

When the final list was published, nearly 2 million people were excluded, but at least the rest hoped that they would at last be able to get on with their lives. But the announcement by Shah that the NRC would be reopened in Assam has reignited dread and uncertainty even among those who found their names in the NRC. Even more gravely, after the CAB, this means only Muslim residents of Assam will be subjected to this renewed interrogation of their citizenship. There is no closure to their suffering. The defence of the ruling establishment is that the NRC process was led by the Supreme Court. This, indeed, is true. The Supreme Court, most of all under Chief Justice Ranjan Gogoi, not just monitored, but energetically drove the NRC.

Justice Gogoi chose a moment, a few days before he remitted office, in a public function in Delhi, to vigorously defend the NRC in Assam. It is unusual for an incumbent Chief Justice to publicly declare his views on highly politically fraught matters. He described the NRC as "a base document for the future", which musters the facts about "illegal immigration", in order to end the "turbulence whose effects changed the course of life of not only individuals but of communities and cul-

tures across the region." He dismissed the critics of this process variously as "armchair", "careless", "irresponsible", "worsening the situation", people "playing with fire" who "thrive through their double speak", are "far removed from the citizenry", with "vile intentions". Many of these critics were litigants in his court. I was one of them.

But we combated the way it was implemented, violating constitutional guarantees and due process, extracting a huge toll of avoidable suffering. It used this to shift the burden of proof to the person who claims to be a citizen, and not the state which accuses the person of being a foreigner.

Injustices of the process mounted through the period when the judiciary directed the NRC. The Supreme Court, between 2014-2019 — a decisive part of this was under Justice Gogoi – resembled more an executive than judicial forum. A People's Tribunal including many respected retired judges and thinkers, held on September 7 and 8, observed that in the normal course of things, "administrative processes are managed by the executive, and in cases of rights violations, the remedy lies before the courts. However, when the courts themselves 'take charge' of such processes (and in executivestyle fashion, as indicated by the opacity and use of sealed covers . and by the Court's insistence on setting deadlines despite the scale of the exercise and the potential injustices that might follow), the entire system of remedies is taken away, as there can hardly be an appeal against the Supreme Court's

own devised procedures." This resulted in "huge burdens on millions of impoverished and unlettered people because the burden of proof was shifted to the resident to prove that they were citizens, based on documents such as of birth, schooling and land-ownership which impoverished and unlettered rural residents anywhere would find hard to muster. Even when residents succeeded in producing

these documents, these were often rejected for small discrepancies such as in the English-language spelling of Bengali names or in ages even though it is well-known that most rural people do not know their date of birth. Many do not have legal land records. And in the middle of the NRC process, an arbitrary category was introduced of 'indigenous' Assamese, who were treated much more leniently even when they could not produce the required documents."

I had approached the Supreme Court questioning the constitutional legality of detaining persons deemed "foreigners" by these processes indefinitely in inhuman detention centres. Detainees are housed in prisons within prisons. Families are separated, with husbands in one detention centre and wives in another, not allowed to communicate with each other. Children are often alone outside. Detainees have no work or recreation, and are denied parole. They have no hope of release, because there is no question of Bangladesh accepting them.

I was deeply dismayed by remarks made by Justice Gogoi during the hearings, reported in the press. For instance, he said to the Chief Secretary of Assam, "The existing centres are housing 900 people as against the so many who have been declared foreigners. Why are there not thousands?" This spurred further panic among Bengali-origin Assamese people, and a reported drive to detain more people.

I therefore sought the recusal of Justice Gogoi from hearing this matter. Justice Gogoi ruled that there was no question of recusal. Instead, he took the singularly unorthodox step of removing me as petitioner from my own petition. As I said to him in court, I am convinced that true justice is always tempered with compassion. And it is compassion, above all, that I found conspicuously absent in the actions of Chief Justice Gogoi.

It is this same compassion that I find mislaid in his now public remarks about the NRC, and as much in the announcement of Home Minister Shah. They seem profoundly indifferent to the intense human suffering the NRC process has left in its trail for millions of our most impoverished and vulnerable people.

Where Pink Floyd Meets Pash

"WE DON'T NEED no education" was the first thing Parnal Chirmuley wrote on the blackboard in our first class. The famous lines from the Pink Floyd song made me chuckle. "Cool teacher," I thought. But as I looked around, I realised that none of my 16 classmates in the BA(Hons) course registered the cool quotient, neither of the song nor the teacher. I rolled my eyes, happy in my bubble from a private school education and relative privilege. But three years later, as I passed out of JNU, I was aware not only of Pink Floyd, but of Pash, Brecht, Firaq Gorakhpuri and Namdeo Dhasal.

The sprawling JNU campus upended my life and all its trappings. This was the JNU of about 15 years ago. The majority of students were from small townships and rural areas. In the days before the internet exploded, and the time before the university became synonymous in the national imagination with "antinational" sentiments, JNU's popularity spread to the hinterland through sheer word of mouth. One distant cousin, one random school senior, or one small news clipping about its academic excellence sufficed to draw students from across the country, to get not just a degree but an education. This was a place where your Class 12 marks didn't matter, nobody cared which school you came from. All that mattered was if you had a mind of your own, and were not afraid to speak it. "Talkative", "hyper", "distracted", words used by teachers in school to describe me nega-

The daughter of a prominent Left leader lived next door but I was not aware of her lineage for the longest time. And on the other side resided a Sanskrit PhD scholar who spoke a dialect of Hindi I barely understood. She was from Gorakhpur, and kept to herself, but she always got mithai from home after Chhath Puja, which she distributed in the corridor. All three of us, and many more, stood in line everyday with our buckets at the geyser for hot water in the winter, and cribbed about the inter-

minable wait. Dinner time in the mess was always something to look forward to, the palak-dal notwithstanding. The rich pamphlet culture, which was thriving a decade ago, was literally food for thought. We chewed on the current political/social issues on campus, country and the world at large, as we made our peace with the aloo-variant subzi of the day. Often, the floors would be littered with pages but would be cleaned post haste, as the mess was needed for a post dinner public meeting. It is at such a public meetings that we had the opportunity to listen to voices like Prakash and Brinda Karat, Sachin Pilot and Baba

INU is often perceived as a bastion of the "elite liberal", but the students protesting on the roads of Delhi are anything but elite. They are fighting for the spirit of the university which enabled them to question, debate and discuss the status quo.
