12% of urban India relies on bottled water, 1 in 4 homes has a purifier

HARIKISHAN SHARMA NEW DELHI, NOVEMBER 28

AN ESTIMATED 12.2 per cent of urban households rely on bottled water for their drinking water needs — up from 2.7 per cent 10 years ago. The finding is part of the National Statistical Office's latest report, which comes against the backdrop of the Centre preparing to roll out the Jal Jeevan Mission, which aims to provide tap water to all rural households by 2024.

In fact, bottled water has emerged as the third principal source of drinking water in urban households — behind 'piped water into dwelling' (40.9 per cent) and 'piped water to yard/plot' (16 per cent) — during July-December 2018, when NSO's survey was conducted. The report also states that one in four urban households rely on water purifiers.

Bypoll wins: Verdict against NRC, says Mamata, even BJP rivals agree

THE RULING Trinamool Congress (TMC) on Thursday won all the three Assembly bypolls, wresting Kharagpur Sadar and Kaliaganj from the BJP and Congress respectively and retaining Karimpur. Calling it a mandate against NRC, Chief Minister Mamata Banerjee said it was a vote against the BJP's "arrogance".

The BIP emerged second in all the three constituencies, including Kharagpur Sadar which was seen as its stronghold. The seat was earlier held by state BJP president Dilip Ghosh, before he was elected to the Lok Sabha from Medinipur, which includes Kharagpur Sadar assembly segment.

In the Lok Sabha polls earlier this year, the BJP had recorded a lead of around 46.000 votes in Kharagpur Sadar assembly seg-

ment, and around 57,000 votes a margin of 20,853 votes. In 2016, in Kaliagani, which is part of the Raiganj Lok Sabha seat represented by the BJP's Debasree Chaudhuri.

In Kharagpur Sadar, TMC candidate Pradip Sarkar defeated BJP's Prem Chandra Jha by

Stranded after flat tyre, Hyderabad vet raped and murdered

SREENIVAS JANYALA HYDERABAD. NOVEMBER 28

WAITING FOR her two-wheeler to get fixed, a 27-year-old veterinarian was sexually assaulted and killed on the outskirts of Hyderabad Wednesday night.

No arrest has been made so far. According to Cyberabad Police, the woman was returning home from her clinic a little after 8 pm when she noticed a flat tyre and called her sister, who suggested that she leave her two-wheeler at the toll plaza and take a cab home. But before she could, she was approached by two men, who offered to take

The woman agreed, and as she waited for the men to return, she was ambushed and dragged into the bushes barely 50 metres from Tondupally toll plaza, behind a line of trucks that obscured visibility from the road,

her vehicle for repair, police said.

police said. According to police, after killing her, the accused took her body to an under-construction bridge a few kilometres away, and set it on fire. According to an officer, innerwear found around 100 metres from the spot has led police to believe she was sexually assaulted.

Police are yet to ascertain the number of attackers, or whether they are the same men who took her two-wheeler for repair. As part of their probe, police are also looking for truck drivers who had parked their vehicles by the roadside. The woman's family has told

ON AUGUST 6, as he was returning from a National Register of Citizens (NRC) hearing, Hanif Ali, a farmer, had an accident and died. Ali and 14 other members of his family, including an infant, had been given a day to appear for the hearing, held at a centre 450 km from their Achalpara vil-

lage in central Assam. When the final NRC list came out on August 31, the family took solace in the fact that all of them were in it.

However, last week, the state government said it was considering a fresh NRC. The ruling BJP has been raising questions over the NRC list that came out on August 31, particularly the exclusion of a

large number of Hindus from it. His despair evident, Ali's 25year-old nephew Monirul Islam, who runs a grocery store in Achalpara, says, "I was in the vehicle with my uncle. People like us put in our everything to participate in the NRC process and its multiple steps... How many times do we have to prove our Indian citizenship? Isn't it better you kill us all rather than this non-stop harassment?" A science teacher at Majortop

Government High Secondary School near Achalpara, 37-yearold Samsul Hoque was a witness to the NRC process from both sides. Hoque worked as a Field Level Officer with the NRC authorities, and later struggled to get one of his five sisters, Abida Sidiga (34), included in the list. 

founder Bal Thackeray was cremated in 2012.

Hours later, he chaired his first Cabinet meeting. While the alliance, in its Common Minimum Programme, said it would ensure "immediate" farm loan waiver, the Cabinet put off a decision for now. Instead, in a symbolic move, the first decision was to approve Rs 20 crore for conserving Raigad Fort, which was the capital of Chhatrapati Shivaji Maharaj.

Speaking to reporters after the Cabinet meeting, Thackeray said he would call for a white paper on farmers' schemes and expenditure before taking a decision. "I have asked the Chief Secretary to give us a realistic picture about the schemes implemented by the state and central governments, and the assistance provided to farmers so far. We are determined to extend assistance to farmers that will make them happy. After getting the information in a day or two, we will take a decision,' he said. "We are fortunate that the first proposal approved was to sanction the next installment of Rs 20 crore for the Raigad fort."

The project for restoration of the fort, estimated to cost Rs 605 crore, was announced by the previous BJP-led government, which had released an initial amount of Rs 20 crore.

Thackeray said the previous state government had only announced a farm loan waiver, but the funds were not credited to the farmers' accounts. "I don't want to restrict myself to making announcements. I want to give money in the hands of farmers,' he said. "This government will be of the common people. It will work towards ensuring that no resident of the state feels that he is

living under threat," he said. Thackeray is the third Sena leader — after Manohar Joshi and Narayan Rane — and the first from his family to occupy the top post.

At the oath-taking ceremony, as party workers shouted slogans and burst firecrackers, Thackeray took the blessings of his aunt Kunda, mother of Raj Thackeray.

The loudest cheers, after Thackeray, were reserved for NCP chief Sharad Pawar, who was instrumental in the bringing the three parties together after the

The CMP promises "immediate assistance to farmers suffering due to premature rains and floods" in the form of an immediate loan waiver. Unseasonal rain in early November had damaged standing crop on 93.89 lakh hectares of land, with 1.04 crore farmers suffering losses.

following revelations of Israeli spyware exploiting its vulnerabilities. The Indian Computer Emergency Team (CERT-In) "has clearly said that we want to audit your (WhatsApp's) entire system... we have told them that we want to conduct an audit and inspection of WhatsApp's security systems and processes," Prasad said.

In response to pointed questions from Congress MPs Digvijaya Singh and Jairam Ramesh whether the government bought the Pegasus software, which was allegedly used for surveillance on over 100 people in India, Prasad said that all electronic interception of communications in India followed a standard operating procedure — and did not give a categorical denial to questions whether the government or any of its agencies had bought the spyware. When Congress MP Anand Sharma pressed on the issue that whether he was aware of government-authorised surveillance, Prasad said: "To the best of my knowledge, no unau-

done." As first reported by The Indian Express on October 30, Facebook-owned WhatsApp said journalists and human rights activists in India were targets of surveillance by operators using Pegasus.

The disclosure follows a lawsuit filed in a US federal court in San Francisco in which WhatsApp alleged that the Israeli NSO Group targeted some 1,400 WhatsApp users with Pegasus.

While WhatsApp declined to reveal the identities and "exact number" of those targeted for surveillance in India, its spokesperson had told *The* Indian Express that WhatsApp

was aware of those targeted and had contacted each one of them. "Indian journalists and human rights activists have been the target of surveillance and while I cannot reveal their identities and the exact number, I can say that it is not an insignificant number," a WhatsApp spokesperson had said.

Digvijaya Singh raised the issue in the Rajya Sabha through a calling attention motion. Replying to another question in Rajya Sabha, Prasad said the government had, on November 26, issued notice to NSO Group seeking details on the malware.

On questions about privacy, the Minister invoked national security: "A terrorist has no right to privacy, a corrupt person has no right to privacy."

He said that fundamental freedoms have to be operated under "reasonable restrictions" and referred to RJD MP Manoj Iha's remark that the Government was using national security as "an elastic concept like chewing gum."

"National security has been compared to chewing gum. We just witnessed the anniversary of 26/11 two days ago. Those who die for the country, we have to think about them as well. We have to balance (that) with privacy."

According to the minister, when reports about the breach came in media, CERT-IN (Computer Emergency Response Team) on September 9 sought submissions from WhatsApp, including a need to conduct an audit and inspection of WhatsApp security system and process.

"The response from WhatsApp was received on November 18, 2019 and further clarification and technical details have been sought on November 26. "CERT-IN has also sent a notice to NSO Group on November 26, 2019 seeking details about the malware and its impact on Indian users," he said.

Prasad said: "During the high-level engagements like meeting of CEO Will Cathcart and VP Policy Nick Clegg of WhatsApp that took place with the ministry on July 26, 2019 and September 11, 2019, no mention was made by the high level WhatsApp team regarding this vulnerability." He added that the government was yet to receive names of people targeted by unnamed entities using Pegasus spyware. The minister underlined that digital players must erect appropriate security walls or be ready to face action.

"Any violation of the procedure is actionable in law. Anyone who has a problem can file and FIR or a formal complaint and the government will look into it. No unauthorised interception has been done," he said.

Prasad also added that it seemed "too much of a coincidence" that the names that had "come out in the open have a chronic hatred against Narendra Modi", a reference to the fact that a substantial number of those targeted by the WhatsApp vulnerability include activists and human rights lawyers.

"Our view is very clear. Whoever has a complaint, he can file a case, get damages of Rs 5 lakh, and send (the accused) to jail. The union government will cooperate fully in that enquiry. But government should not be involved in any fishing enquiry as it is a matter of Indian people's respect," he said.

Prasad said the global business community is welcome to do business in India but they would also have to acknowledge and understand that safety and

security of Indians is indeed of prime importance.

"You can come to India for business, but there are sensitive and hyper-sensitive data and India would claim its right over that," Prasad said, adding he would discuss this in detail once the Data Protection Law comes into force. The minister said the Bill will be introduced in Lok Sabha soon.

According to WhatsApp, the spyware was developed by NSO Group and had been used to snoop on about 1,400 users globally, including 121 users from India. Digvijaya Singh demanded

Joint Parliamentary Committee (JPC) to be set up to probe the breach. Questioning the government's role in the entire row, Singh said, "They should tell the House if people were spied upon. The government should tell us which journalists, activists were targeted in the breach. This is a violation of right of privacy...There are only three possibilities in the matter of Whatsapp hacking. First, the government legally engaged in espionage. Second, espionage happened illegally without the government's knowledge. Or the government illegally engaged in espionage."

BJP's Rakesh Sinha said that India should consider developing a parallel social media platform, parallel to WhatsApp. CPI(M)'s K K Ragesh said that those who are being snooped upon are those questioning the government.

At least two dozen academics, lawyers, Dalit activists and journalists in India were contacted and alerted by WhatsApp that their phones had been under state-of-the-art surveillance for a two-week period until May

Aman Wadud, who has been fighting cases of the excluded, points out that the previous NRC had been a court-monitored process. "I know of many cases in which the NRC process caused immense pain to poor, illiterate people. Implementing it in Assam all over again is an outrageous idea. The Supreme Court monitored the NRC process, the BJP government executed it on the ground. Then how can the state government request the Centre that the NRC be rejected?"

On the other end are people like Manoj Das, 40, a businessman dealing in automobile parts in Assam's Hojai town. His 70-yearold mother, Kamala Das, is not in the NRC. "Many of our people (Bengali Hindus) were wrongfully excluded. Even if we have to go through the NRC process again, we must do it without complaining because only then can genuine citizens like my mother be included," he says.

The Bengali Hindus (who are a large support base for the BJP in Assam) are also counting on the Centre getting the Citizenship (Amendment) Bill passed in Parliament before the new NRC. The Bill makes citizenship easier for refugees from other countries fleeing religious persecution (barring Muslims).

Mintulal Namashudra (48), of Udharbond near Silchar in Assam's Bengali-majority Barak Valley region, hopes this Bill will help his wife and him get included in the NRC — provided they can prove "religious persecution". Amrit Lal Das of Bongaigaon points to the incongruity of people who had been seeking to be included in the NRC opting for CAB. "How can genuine citizens be treated as 'refugees'?' he wonders.

method to treat drinking water. In rural areas, only 27.3 per cent of households treated water before drinking.

As per the report, Delhi tops the list of 36 states and UTs in the use of electric water purifiers -36.5 per cent of households in the capital rely on one to treat drinking water. Punjab came a close second (35.9 per cent), followed by Uttarakhand (21.8 per cent) Haryana (19 per cent) and Gujarat (16.5 per cent). In Tripura Manipur, Arunachal Pradesh Lakshadweep, Chhattisgarh, Bihar, Daman and Diu, Uttar Pradesh, Jharkhand and Madhya Pradesh, less than 5 per cent of

BIP never supports such a statement and we do not support this ideology... We have decided that she will be removed from the consultative committee on defence, and will not be allowed to participate in the parliamentary

party meetings this session." With the Opposition taking up the issue in Lok Sabha, Defence Minister Rajnath Singh said his party condemns any philosophy which describes Gandhi's killer as a patriot. WOMAN KILLED, DUMPED IN PANIPAT

20-yr-old's husband told her gun needed for safety: Police

TWO DAYS after the decomposing body of a 20-year-old woman was found in the bushes near Panipat refinery in Haryana, Delhi Police have claimed that her husband, 21-year-old businessman Sahil Chopra, "planned the murder". Chopra was arrested along with his friend Shubham and cousin Badal Tuesday night after he "confessed to killing his wife Nancy Sharma", police said.

The couple got married on March 7 and began living at Chopra's home in Janakpuri. Sharma went missing on November 11, and when her parents couldn't get through to her, Sharma's in-laws allegedly told them a mix of stories — that she was in France with Chopra or that the two had run away with jewellery and cash worth Rs 20 lakh

"During questioning, Chopra said he was fed up of fighting with her. On November 11, he allegedly told her they have to go to Panipat to collect money from someone, and it'll also be a long drive. He allegedly told her that since it's late night, they should carry a pistol for safety. During questioning, he claimed Sharma was given the

pistol by a friend and she carried it after he insisted on being safe," an officer said. Police are yet to recover the weapon.

At Sharma's Hari Nagar home, her father Sanjay Sharma (45) recalled a heated conversation he had with his daughter in January.

"I never approved of the relationship. In January, someone told me they spotted Nancy on a bike with Sahil. We ended up fighting and she said she is not a minor anymore, and I have no say in who she marries. I didn't approve of Sahil's lifestyle," said Sanjay, who also has a nine-year-old daughter and 12-year-old son.

Sharma's paternal aunt Ritu said that in January-end, she left home to live with a friend in a paying guest accommodation.

In March, Sanjay got photos of his daughter's wedding on WhatsApp from her. "The two ran away and got married and then 20 days later, Sahil's family did

wedding rituals," said her father. According to him, trouble started less than three months later — from alleged dowry demands to domestic violence – Sanjay claimed. "Once I saw a red mark on her neck and inquired how she got that... she covered it

Race for nursery admission begins today, private schools list out criteria

NEW DELHI, NOVEMBER 28

THE CAPITAL'S scramble for entry-level school admissions will begin today, with private schools across the city releasing their admission forms. The process spanning three-and-a-half months — has begun 10 days earlier than last year. The first list of selected candidates will be released on January 24. The admissions will be conducted for entrylevel classes to schools — Nursery, KG or Class I.

All recognised private schools

in Delhi are required to reserve 22% of their seats for children from economically weaker or disadvantaged groups, and 3% for children with special needs. Admission to these reserved seats will be conducted through a centralised draw-of-lots process by the Delhi government. Apart from this, schools are free to

choose their own criteria on the

basis of which applicants will be

allotted points. The primary criteria against which most schools will allot points to applicants would be distance between the child's home and the school. The weightage

Finance Assistance to a maximum of 50% of total cost of Rain Water Harvesting Structure or Rs. 50,000/-, whichever is less would be given to the consumer by DJB. Detailed guidelines in this regard are being issued separately, by the RWH Cell of DJB. In view of this scheme and to enable domestic consumers who have not installed functional Rain Water Harvesting Structure, levy of Rain Water Harvesting penalty has been deferred till 31.03.2020.

While there was some initial apprehension over whether she would be speaking, Hassan ultimately decided to address the students."We had gathered just as you have gathered now to fight for free and accessible education. In South Africa, education is expensive. People get the education they can afford, not the education they deserve... At every forefront of change, it's the

PURI CALLS BILL REVOLUTIONARY

Unauthorised colony Bill passed in Lok Sabha: 'Will end injustice of many yrs'

THE LOK Sabha Thursday unanimously passed The National Capital Territory of Delhi (Recognition of Property Rights of Residents in Unauthorised Colonies) Bill, 2019, aimed at recognising the property ownership rights of residents of more than 1,700 unauthorised colonies in the national capital.

Describing the Bill as a "revolutionary step", Union Minister of Housing and Urban Affairs Hardeep Singh Puri said it was meant to end injustice that has been going on for many years. "The maps of all 1,728 (unau-

thorised) colonies will be uploaded on a new portal, which has been created... we have already got the maps of 600 or so, and even as we speak the work is going on... After that a new portal will start from December 16, and individuals can apply for registration."

"Work which could not be done in the last 11 years, we propose to complete it well before December 31," he added.

While tabling the Bill for consideration earlier, he said attempts had been made to deal with this problem in the past too — but only half-heartedly.

AAP slams Centre, calls move an eyewash

The deed is conveyance of right of ownership of the flat after payment and documents are received from the allottee and possession is taken by him/her. It is an essential document required for purchase of property, which is signed by all parties, and is a binding contract in a court of law.

A senior DDA official said that the authority will create a web fixing geo-coordinates of plots. An applicant will be required

to upload relevant documents in DigiLocker, take a photograph of the property, log in to the DDA portal and enter required information, after which a unique application number and ID for the property shall be generated. The deed will help people get their properties registered.

AAP also asked why the maps prepared under their government were rejected, but the same maps were accepted when they came through the DDA. "Finally, the Centre took Delhi government's demand for regularisation forward... their first condition was to freshly map the unauthorised colonies after refusing to use the GSIL map that was prepared under CM's orders in 2015. But they are using the same maps," Chadha said.

Delhi Congress campaign committee chairperson Kirti Azad hit out at the Centre and Delhi government for failing to do anything for unauthorised colonies for long, and raising the issue as assembly elections



Investors' Summit puts industrial development on fast track



The economic reforms started by the UP Government have paved way for investment of Rs 2 lakh crore through more than 350 proposals. State government held Investors' Summit in Lucknow on February 21 and 22, 2018. In this summit, 1,045 investment proposals worth Rs 4.28 lakh crore were signed at the Indira Gandhi Pratishthan. Most of the investment proposals received earlier are now taking tangible shape.

Buoyed by the success of Investors' Summit, the government went a step ahead and organised two Ground Breaking Ceremonies (GBCs) to make investment proposals a reality. The first GBC was held five months after the summit, the process of materialising 81 investment proposals worth Rs 61,847 crore were initiated by Prime Minister Narendra Modi. The second GBC was held in July 2019. It was decided to make 290 proposals for investment of Rs 64,860 crore a ground reality.

Along with GBC-1, GBC-2 and other

projects, a total of Rs 2 lakh crore investment have been made in UP in last two and a half years of the Yogi Adityanath-led government. These projects will create employment opportunities for approximately 4 lakh

Leading industrial houses have joined hands with the state government to accelerate industrial growth of Uttar Pradesh. Tata Sons Chairman N Chandrasekaran, Adani Group Chairman Gautam Adani, Pepsico India Holdings CEO & President Ahmed El Sheikh, Samsung India's President and CEO H C Hong, Lulu Group Chairman Yusuff Ali MA, Torrent Group Chairman Sudhir Mehta, Medanta Chairman Dr Naresh Trehan, HCL Founder Chairman Shiv Nadar and FICCI President Sandeep Somani were among those present in the second ground breaking ceremony. Vivo Mobiles, Oppo Mobiles and Sunlight Fuel were also represented among those expressing their intent to make investments in UP.

Earlier, the Prime Minister had announced Defence industrial corridor worth Rs 20,000 crore in UP during investors' summit at Lucknow, in 2018. In recent months, the UP government took the step to quickly set up a Defence Industrial

Corridor in the state to speed up industrial development. Agra, Aligarh, Chitrakoot, Lucknow, Jhansi and Kanpur have been identified for the project. Around 5,071.19 hectare land has been proposed for all these six nodes.

Prime Minister Narendra Modi laid the foundation stone of the project in Jhansi. It has rolled out avenues for companies willing to invest and set up big defence and aerospace units under the Defence Industrial Corridor scheme. These districts have strong ancillary base to support the needs of defence manufacturing and ensure continuous supply of raw materials, labour, etc. The corridor is likely to create thousands of job opportunities in units to be set up in

The state government is also coming up with three 'defence parks' in Kanpur, Agra and Jhansi and three 'aerospace parks' at Lucknow, Agra and Kanpur of 100-150 acre each on the defence corridor. The process for acquiring land for all these six nodes of the Defence Industrial Corridor has already started. In Jhansi, 92.48 percent land has been acquired while 89.41 percent land has been acquired in Chitrakoot. In Aligarh, 100 percent land has been acquired. So far, 43 defence equipment manufacturers have shown interest in the project so far.

UP government will act as a facilitator and will provide 'plug-andplay' industrial infrastructure like manufacturing areas, testing centres, other concessions like interest reimbursements (50-60%) on loans taken by units to buy land, creating infrastructure or building common facilities for these parks. Each park will have at least five units in it.

The biggest advantage of investment,

given to the companies investing over Rs 300 crore and creating around thousands of job opportunities in the notified areas of the defence corridor, is the reimbursement of 25% of the cost of land units. The reimbursement will also be given to the 'anchor units' which can be Indian or global equipment manufacturing companies that can design and manufacture defence and aerospace platform with an investment over Rs 200 crore as well as bringing in a minimum of 10 vendor units. The vendor units are to supply a minimum 75% of its end product to the anchor unit and have to be located in the same cluster as anchor unit.

100 new buses to boost capital's cluster fleet

EXPRESS NEWS SERVICE NEW DELHI, NOVEMBER 28

THE CAPITAL'S cluster bus fleet Thursday got a boost of 100 new buses equipped with hydraulic lifts, CCTV cameras and panic

Flagged off by Chief Minister Arvind Kejriwal, the 100 standard-floor buses — along with another 229 inducted earlier form the first batch of buses to have been added to Delhi's fleet in around 10 years. "Several new buses have ar-

rived in recent months and the rest of the buses are also coming soon. I believe that with the induction of new buses, irregularity in public transportation in Delhi will be resolved. Just like transformations that have happened in the health and education sectors in Delhi, we want the public transport sector to become technologically advanced and be recognised internationally," the CM said.

The cluster bus fleet now stands at 2,008.

The acquisition of standardfloor buses had been on hold for several months after disability rights activists had petitioned against their induction in the Delhi High Court. A standard

floor bus does not align with the floor of bus stops and it is impossible for those on wheelchairs and those using crutches to get on them without help.

The proposal to equip these buses with hydraulic lifts was finally accepted, paving the way for new buses. According to Delhi govern-

ment officials, a little over 300 buses will also be added to the Delhi Transport Corporation fleet by May next year. While the cluster buses are

operated by private players, DTC buses are operated entirely by the Delhi government.

According to officials, the new buses will ply on seven routes: 10 from Mubarakpur Dabas to Old Delhi Railway Station, seven from Nilothi Village to Old Delhi Railway Station, 15 from Qutubgarh to Palika Kendra, seven from Bakoli Temple to Old Delhi Railway Station, 11 from Rohini Sector 23 to Old Delhi Railway Station.

The route between Uttam Nagar and the Delhi Airport will have 20 buses and that between Lumpur Border and Old Delhi Railway Station will have six.

SHOULD FOCUS ON WORK INSTEAD, SAYS JAJU

'Civic body councillors not in MLA ticket race'

NEW DELHI, NOVEMBER 28

COUNCILLORS OF the three municipal corporations in the capital — East, South and North will not be in the race for MLA tickets in the upcoming assembly elections, Delhi BJP in-charge and national vice-president Shyam Jaju has told The Indian Express.

According to Jaju, the councillors were conveyed this by a senior leader in a recently held meeting, where they were asked to continue good work and not focus on getting a ticket.

The meeting was also attended by Union Minister Prakash Javadekar, who is the BJP in-charge of Delhi polls. As per another senior leader, Javadekar had told councillors that the "Central leadership is not keen to field them as MLA candidates", and that they should not seek tickets from party leaders. The minister had also said that

the party decides on candidates on the basis of merit, and "survey reports and name-dropping by senior leaders would hardly be of any use".

There are 181 BJP councillors in the three civic bodies. Among those hoping to bag a ticket are North body Standing committee head Jai Prakash (Sadar), former standing committee head of South MCD Shikha Rai (Greater Kailash), former mayor of South MCD Kamaljeet Shehrawat (Dwarka), former South body

mayor Narendar Chawla (Tilak Nagar) and former North body mayor Adesh Gupta (Patel Nagar), it is learnt.

Another BJP leader said that even though some of the leaders were popular in their areas, the party is skeptical about the perception of "corruption in the MCDs"

The leader said, "Many of these councillors became mayors and standing committee leaders because the party did not field any other senior leaders in the previous MCD polls. They should focus on governance."

He added that councillors seeking tickets may face anti-incumbency as the BIP-ruled corporations have been in power for over two-and-a-half terms.

Senior BJP leaders have been vocal about the "negative perception of the three MCDs" with Delhi BJP president Manoj Tiwari and Rajya Sabha MP Vijay Goel calling the building department of the civic bodies

Four firms in race, bids for Jewar airport will be revealed today

THE FINANCIAL bids for the upcoming greenfield airport in Jewar will be revealed Friday. The four developers that met the technical requirements for the airport bid are Delhi International Airport Limited, Zurich Airport International AG, Adani Enterprises Limited and the Anchorage Infrastructure Investments Holdings Limited.

"The financial bids will be evaluated on the basis of which developer provides maximum revenue per passenger. Once the bids are opened and due discussions are held, a meeting with the state government officials will announce the chosen developer. For the first time, an international organisation has shown interest in developing the airport which will set a great

precedent," said Shailendra Bhatia, nodal officer, Noida International Airport Limited (NIAL).

The global tender for the airport was floated on May 30 by the NIAL, the nodal agency notified by UP government for managing the project. The chosen bidder will develop the Phase 1 of the Jewar Airport at an estimated cost of Rs 4,588 crore. The technical bid had opened on November 6 and the four bidders were qualified Wednesday.

Jewar airport will be the third one in NCR region after Delhi's IGI airport and Ghaziabad's Hindon airport. The airport is said to be spread over 5,000 hectare and will cost an estimated Rs 29,560 crore. According to officials, the airport will have six to eight runways. Total project area as per approved estimates will be 1,334 hectares across six villages.

Fake call centre offering discounts, cashbacks busted

BJP RAJYA SABHA MEMBER G V L NARASIMHA RAO SPEAKS TO RITIKA CHOPRA ABOUT THE ANDHRA PRADESH GOVERNMENT'S DECISION TO MAKE ALL SCHOOLS IN THE STATE ENGLISH MEDIUM.

What is the issue you raised in the Rajya Sabha?

The Andhra Pradesh government has recently directed all its schools in the state to switch over to English as the medium of teaching for Classes I to VI from the next academic year.

What are your objections to this decision?

There are two problems with this. Yes, there is an aspiration among parents to send their children to English-medium schools, but the reality is that teachers are not equipped to teach in English immediately. Nor are parents equipped to offer support at home. This would increase the chances of children dropping out of school in the early years. Learning in the mother tongue is the best form of learning in the formative years. Also, if the government projects that Telugu is not a preferred medium of learning, then you are automatically placing a premium on English...

What alternative or solution are you proposing?

I am not against the proposal per se... The government should ensure the transition happens without hurting the interest of the students. Let the government implement this on a pilot basis, show that it works and then consider the complete transformation. Ideally, the state should continue Telugu medium of teaching as an alternative for children who cannot cope with learning in English.

The state government has defended the proposal stating that the poor should have access

to the same education as the rich. The government is trying to create a class divide by saying that if children from better-off families can go to English medium schools, why should the poor not be offered the same education. The real problem here is that neither the teacher equipped to impart education in English nor are parents equipped to offer support at home.

Does this decision seem ironical considering the role the Teluguspeaking led in the language

movement? Yes, it is ironical. The entire movement for state reorganisation on a linguistic basis happened because people of Andhra region felt alienated in a state where Tamilians dominated the whole system. Telugu has a 1000-year heritage, and it is the most widely spoken classical language. This measure will hurt the language.

BJP condemns thought of calling Godse patriot: Rajnath

Oppn protests, seeks Pragya's expulsion from House, demands govt statement

DEEPTIMAN TIWARY NEW DELHI, NOVEMBER 28

AS THE Opposition targeted the government on Thursday over BJP MP Pragya Singh Thakur's remark praising Nathuram Godse, Defence Minister Rajnath Singh condemned the statement in the Lok Sabha.

"Let alone calling Nathuram Godse a patriot, our party condemns even having such a thought. As far as Mahatma Gandhi is concerned, he is our ideal. He has been our guide and will remain our guide in future. His ideology was not only relevant in the past, but remains so today and shall remain relevant in future. Irrespective of party, caste or religion, everyone considers Gandhi his/her ideal and a source of inspiration," Singh said.

As soon as Lok Sabha proceedings began on Thursday, the Opposition created a ruckus over Thakur's remark. While Congress Leader of the House Adhir Ranjan Chowdhury demanded a statement from the government, AIMIM leader Asaduddin Owaisi gave a privilege motion notice to Speaker Om Birla over the issue.

"Inside the House they say the Congress is a terrorist party. The party whose thousands of workers and leaders have sacrificed for the freedom of the country is being called terrorist party... The murderer of Mahatma Gandhi is called a patriot. Will this House remain quiet?" Chowdhury said.

"The government should state this clearly whether it follows the path of Nathuram Godse or Mahatma Gandhi. You want to appropriate Indira Gandhi, Jawaharlal Nehru and now Mahatma Gandhi. The entire country and the world is criticising them today. The government must make a statement on this. They use Gandhi politically, but help his murderers. This is an outcome of your ideology," he added.

The Speaker kept requesting the members to maintain calm and mentioned that Thakur's remarks had been removed from the records, hence there was nothing to discuss.

While Owaisi was not allowed to speak by Birla, he was heard shouting whether members would not be allowed to even speak on Gandhi. "It is immaterial that the remarks have been expunged. The entire world has heard her saying it. It has been said on the floor of the House. Are you not going to even protect the dignity of Mahatma Gandhi?" he said.

The Congress had moved an adjournment motion on the issue, but when it was not allowed, the Opposition staged a walkout shouting slogans and seeking Thakur's expulsion from the House. The Congress was joined in its protest by the Left, TMC and DMK. The party members, including Sonia Gandhi, came back to the House about 10 minutes later.

Govt seeks House nod for additional spending of over Rs 21,000 cr in current fiscal

THE GOVERNMENT'S supplementary budget on Thursday allocated more than Rs 8,000 crore to the newly formed Union Territories of Jammu and Kashmir and Ladakh and Rs 20 crore for upkeep of Ayodhya.

Based on the Supreme Court's order, the Home Ministry is working on forming a trust to build a Ram temple in Ayodhya, while a section of Muslim stakeholders in the case plans to file a review to top court's judgment granting the disputed site to the Hindu side.

The Supplementary Demand for Grants 2019-20, tabled by Finance Minister Nirmala Sitharaman in Parliament on Thursday, allocated Rs 20.40 crore for "Other Charges for upkeep of Shrines, Temples etc. Protection and upkeep of Ayodhya."

The Demand for Grants said Rs 8,820.62 as share of the 14th Finance Commission have been allocated to the UTs of I&K and Ladakh.

The government sought approval to spend an additional gross amount of Rs 21,246.16 crore in the current financial year, with net cash outgo at Rs 18,995.51 crore, with over 40 per cent of the additional gross amount sought as grants for the newly formed UTs.

The Rs 8,820.62 crore funds as grants in lieu of the erstwhile state's share of the 14th Finance Commission Award includes the share of revenue deficit grant (Rs 5892.50 crore), local body grant (Rs 725 crore) and SDRF(Rs 139.50 crore), and state share of net proceeds of taxes for November and

December (Rs 2063.62 crore). An amount of Rs 4,557 crore will be infused in IDBI Bank through recapitalisation

bonds, while Rs 2,500 crore will be used for recapitalsation of state-owned insurance companies. "Taking into account the savings available within the same section of the Grant, this will entail a cash outgo of Rs 2,500 crore for recapitalization of insurance companies," it stated.

The Finance Minister sought Rs 2,000 crore to meet additional expenditure towards payment of pay and allowance of armed forces and another Rs 666 crore for meeting expenditure of Department of Space.

Rs 3,387.46 crore has been provided in the supplementary demands for grants for meeting expenditure towards salaries and cost of ration of the police. About Rs 1,000 crore has been sought for providing additional funds under the scheme for free LPG connection to poor households.

The Union Budget presented in July for this financial year had estimated total Rs 27.86 lakh crore as government expenditure, excluding public sector company expenses.

Govt tells RS

THE "MALWARE infection" in the Kudankulam Nuclear Power Plant was confined to its administrative block and the plant is "absolutely safe", Minister of State in the Prime Minister's Office Iitendra Singh said during Question Hour in Rajya Sabha on Thursday.

To further assuage fears, Singh also informed the House that the malware detected in the administrative network had no effect on the plant control and instrumentation system as they are not connected to any external Internet or intranet. He said that after the detection of the

malware, a committee was set up comprising directors of IIT and other experts, who have made specific recommendations, and the same are being implemented. "We have now a quarterly Cyber Security

Audit System in place, which would have a future bearing regardless of whether there is a cyber threat or not. We would be doing an in-house exercise of audit for the same," Singh said.

The Nuclear Power Corporation of India (NPCIL) had last month confirmed the presence of malware in one of the computers at the Kudankulam plant. NPCIL, however, added that the "systems are not affected" by the cyberattack.

Responding to a question on undertrials languishing in jails, Law Minister Ravi Shankar Prasad said that he has appealed to Chief Justices of all High Courts to release those who have served half of their proposed sentence in jail. "Those who have completed more than 50 per cent of their status as an undertrial in jail, they must be released if they are not serious offenders in many more cases... I am making an appeal... As far as release on bail is concerned, that can be done only and only by the judiciary," Prasad said.

Parliament passes Bill proposing 3-fold hike in chit fund limits

PARLIAMENT ON Thursday passed a Bill which provides for a three-fold rise in monetary limits for chit funds and hiking commission for a foreman.

A foreman is responsible for managing the chit.

The Chit Funds (Amendment) Bill, 2019, was passed by voice vote in Rajya Sabha. It got Lok Sabha's nod on November 20.

The maximum chit amount is proposed to be raised from Rs 1 lakh to Rs 3 lakh for those managed by individuals or less than four partners, and from Rs 6 lakh to Rs 18 lakh for firms with four or more partners. The maximum commission for foreman is proposed to be raised from 5 per cent to 7

The Bill also allows the foreman a right to lien against the credit balance from subscribers.

The Chit Funds (Amendment) Bill also introduces words such as "fraternity fund", "rotating savings" and "credit institution" to make chit funds more respectable, Minister of State for Finance Anurag Thakur told the

Piloting the Bill, Thakur said chit funds are legal and one should understand that these are different from unregulated deposit schemes, or Ponzi schemes.

The Bill provides for substituting terms such as 'chit amount', 'dividend' and 'prize amount' with 'gross chit amount', 'share of discount' and 'net chit fund', respectively. It also proposes to allow subscribers to join the process of drawing chits through video-conferencing.

About members' objection to this clause, Thakur said all subscribers should be present at the time of draw of chit fund, but if some people are unable to attend, they

should have the option of video conference ing. He also said the Bill removes the limit of Rs 100 – set in 1982 – and allows state governments to specify the base amount over which provisions of the Act would apply.

Responding to issues raised by members during the debate, Thakur said chit fund subscribers can opt for insurance but the government cannot make it mandatory, as it would add to the cost. He also said the Bill provides that the chit fund operator has to have secured deposit to the size of scheme, which is a sufficient safeguard for people subscribing to the scheme.

On compensating the poor from money collected under GST (12 per cent GST on chit fund), the minister said, "Neither I nor Finance Minister Nirmala Sitaraman can do anything about it. It is in the hand of the GST Council." He added that the GST Council, represented by finance ministers of states, can take a call on this.

On Congress member Digvijaya Singh's suggestion, Thakur assured that the Union government would soon schedule a meeting of all chief secretaries of states for expediting fraud cases pending with state-level coordination committees.

Oppn to Naidu: Surprises shouldn't be sprung by bringing Bills without notice

OPPOSITION PARTIES are learnt to have told Rajya Sabha Chairman M Venkaiah Naidu on Thursday that no "surprises" should be sprung in the nature of Bills introduced without adequate notice.

Ordinarily, Bills or any discussion are taken up in the House only when the business advisory committee (BAC) has allocated time for them. That is why the Opposition members mentioned the matter to Naidu during a BAC meeting on Thursday.

Since the last session, the Opposition has alleged, several important Bills, including the one of reorganisation of Jammu and Kashmir, were tabled without adequate notice. Some others - such as the Muslim Women (Protection of Rights on Marriage) Bill, 2019, the Unlawful Activities (Prevention), National Investigation Agency (Amendment), Right to Information and National Medical Commission Bills - were passed without adequate legislative scrutiny, opposition parties maintain.

Sources said the Opposition, which has been under fire from the Chair for a walkout by some parties during Finance Minister Nirmala Sitharaman's reply to the discussion on economic crisis on Wednesday, also mentioned images and videos taken during the speech in the Upper House on Wednesday which showed several ministers dozing in the background during Sitharaman's reply.

"We told him that we at least sat through for quite some time. The quality of the speech was clear when ministers themselves slept off. The Chairman did not respond, but BJP members did ask 'who was asleep'," a source said. Naidu had pulled up Opposition leaders

on Wednesday for interrupting Sitharaman's speech. He had said that some leaders, "claiming to be speaking on behalf of the whole Opposition", met him in his chamber after the House was adjourned until 2 pm and sought more time to be given for the short-duration discussion on the state of the economy. They even assured him that if their suggestion was agreed to, they would cooperate in passage of the Chit Funds (Amendment) Bill listed for Wednesday, Naidu had pointed out.

The Chairman had said: "Keeping in view the importance of this issue relating to economy, and in view of the request of Opposition leaders and their assurance, I agreed to allow more time for discussion, though as per rule, (a) short-duration discussion is allowed only for two-and-a-half hours."

Naidu had expressed concern that after 24 members spoke on the economy for about three-and-a-half hours from 2 pm when Sitharaman started her reply around 5.30 pm, some Opposition members started questioning her and interrupting her.

The minister agreed. But Bharat's third suggestion was difficult for him to accept — the MP wanted English-medium instruction in every government school. "Hindi is our national language," the minister reminded the MP.

NO STATE ISSUES, PLEASE

THE VERBAL spat between MPs from the Trinamool Congress and the BIP have reached the winter session of Parliament, too. Trinamool MPs often get irritated at attempts by their BJP counterparts from West Bengal to raise state issue in Parliament, and have in the past complained about it. Speaker Om Birla recently called Trinamool's Lok Sabha leader Sudip Bandyopadhyay to his chamber and told him that following a letter from Bandyopadhyay and his party colleagues Mala Roy and Sougata Roy, he has told BJP MPs Locket Chatterjee, Soumitra Khan and Arjun Singh that state issues cannot be "directly raised" in the House. The TMC letter named the three MPs and taken objection to their repeated attempts at raising Bengal-related issues.

BJP retains Pithoragarh in Uttarakhand bypolls

THE RULING BIP retained the Pithoragarh Assembly seat in bypolls, with the party's candidate Chandra Pant defeating Congress's Anju Lunthi by 3,267 votes, according to the results declared on Thursday.

The victory margin was bigger than the 2017 Assembly elections, when the saffron party won the seat by 2,684

votes. Chandra Pant is the widow of three-term BJP MLA Prakash Pant, whose death earlier this year necessitated the bypoll. During the campaign, Pant had

promised voters that she will fulfil her late husband's dreams. According to the results,

Kumar Bhatt finished third with 835 votes. As per data, 844 vot-

ers preferred NOTA.

Pant secured 26,086 votes (51.57 per cent), while Lunthi received 22,819 (45.11 per cent). Samajwadi Party's Manoj

Uttarakhand Chief Minister Trivendra Singh Rawat dedicated the victory to the dreams of Prakash Pant and development of Pithoragarh.

Congress state president Pritam Singh called the result a victory of sympathy and money

Reacting to the win, Chandra Pant said, "It is the result of developmental works done by my late husband in the constituency, besides the relentless hard work of party workers... I would try to meet the expectations of the voters who showered their love and affection on me." Uttarakhand BJP president Ajay Bhatt said the Pithoragarh bypoll win was reflective of people's trust in the party. "By ensuring Chandra Pant's victory in Pithoragarh, people have reasserted their faith in the BJP. They have also put a seal of approval on the performance of the government headed by Trivendra Singh Rawat, said Bhatt, who is also an MP from Nainital.







MORE THAN 100 tribal families from Bhajna and Kutku villages of Garhwa district leave their villages each year for the upper reaches of the forest to survive during rainy season. From a distance, they see their houses washed away, and poles erected to support their homes. If the wood is not wet, they manage to prepare rice meals, and return home once the water recedes, knowing well that they will have to repeat the drill the next year.

The villagers have been compelled to leave their lands each year since 1987, when the dam

walls were constructed, as the water swells up during rains at the stalled Mandal Dam Project, also known as the North Koel Reservoir. However, they now face complete displacement.


Eight villages, including Kutku and Bhajna, will be completely submerged, affecting more than 3,000 tribals, once the project, which recently received clearances from the Union forest ministry and the state forest department, is fully functional.

The dam spanning Garhwa and Latehar districts was conceived in 1970 by the erstwhile Bihar government on Koel – a tributary of river Son — with an aim to boost irrigation in Gaya, Aurangabad and Palamu (now in Jharkhand), and to generate 24

MW electricity. Construction began in 1972 but the project was stalled in 1993 after the Bihar forest department raised concerns. After the project was revived

in 2016, it was agreed to restrict the water capacity at a level lower to reduce submergence of villages. At his first rally ahead of Assembly polls in Jharkhand, PM Narendra Modi, who laid the foundation stone for the project earlier in January, sought a mandate to continue development work under the state BIP government while the Jharkhand Mukti Morcha promised to reconsider

Far from the heated political rallies in poll-bound Jharkhand, through the circuitous route to Kutku via Daltonganj-Chainpur-Ramkanda-Bhandaria-Madhgari after crossing a river, *The Indian* Express spoke to a few villagers on their concerns over the dam.

"I am married for the last 12 years and every year we make plans to deal with it. We are not able to construct our houses fearing submergence... We somehow manage it thinking that after the rains we will still have our lands with us. But now we will be completely displaced. I have not seen any political leader coming to us to discuss our problems," said Anita Minz, a tribal Christian at

Kutku village.

Ramdhani Bhuiyan, in his mid 40s, said his house is submerged under 20 feet water every rainy season. "We build everything from scratch every year because from October to February we reap mustard oil. This sustains our family. Once the dam is constructed we will be left with nothing," he

said. While some such as Bhuiyan and Minz are sustained by the fertile land, many seek employment as daily wage labourers in the state and outside.

Pratap Tirkey, who claimed to be a local activist delivering rice, salt and kerosene under the public distribution system to these villages, said most of the families still use wood for cooking. "The government says they will give Rs 15 lakh to each family, and talks have been going on for long, but they need to be given land, a place to live and hospital facilities... Just giving money to the tribals, who have no idea of managing money, will lead to devastation," he said. Dr D S Srivastav, secretary of

the Nature Conservation Society that prepared and submitted a wildlife management plan for the project before the 43rd Standing Committee meeting of the National Board of Wildlife, said that villagers must be rehabilitated before construction begins. "Construction should not be started till the villagers are re-settled outside of Palamu Tiger Reserve area... The conflict with wildlife will be extreme because

tigers, leopards and other wildlife in the vicinity," he said.

However, Aftab Alam, the **Executive Engineer of the Water** Resources Department, overseeing the revival of the dam, said all displaced families had received compensation three decades ago under the Bihar government's rehabilitation policy.

"However, for smooth implementation, we have identified around 800 families who currently stay in the villages and will give them one-time financial package comprising Rs 117 crore," Alam said, adding that, "The dam will facilitate irrigation and various other projects like fishing, tourism will be started."

New Lanka President arrives, to meet PM Modi today

LESS THAN a fortnight of assuming office, newly elected Sri Lankan President Gotabaya Rajapaksa will meet Prime Minister Narendra Modi on Friday in his first overseas visit and discuss the future direction of the bilateral relationship between the two countries.

Rajapaksa, brother of Sri Lankan Prime Minister and ex-President Mahinda Rajapaksa, said that he was looking forward to strengthening bilateral relations with Modi and the Indian government.

As he landed here on Thursday evening, he was received by Minister of State (road transport and highways) Gen (retd) V K Singh.

On Friday, Modi and Rajapaksa are expected to discuss a host of issues, and Delhi will try to assess the newly elected Sri Lankan President's

agenda — both domestic and

On the domestic front, Delhi will want to gauge Gotabaya Rajapaksa's approach towards the ethnic Tamil minorities in the island country.

After External Affairs Minister

S Jaishankar met him in Colombo earlier this month, Delhi had once again drawn the redline on Tamil minorities in Sri Lanka, for the first time in recent years. Delhi underlined its expectation that the new government in Sri Lanka should carry forward the process of "national reconciliation" and meet the aspirations of the Tamil community. It also outlined "equality, justice, peace and dignity" as the key components of Tamil minorities.

The government has said that these expectations have been conveyed to Rajapaksa during the meeting between him and Jaishankar. This comes amid concerns in the Tamil community in

The Rajapaksa family, which

was in power before 2015, has been accused of human rights violations against Tamil minorities. Indian concerns stem from the past record of the Rajapaksas. when they were in office.

This is the first time in recent vears that Delhi has underlined these expectations so clearly, especially after five years of Sri Lankan government under President Maithripala Sirisena Wickremesinghe.

Delhi will also seek to understand the new Lankan President's attitude keeping in mind the pro-Chinese Rajapaksa brothers at the helm in Colombo. During their term last time. when Gotabaya Rajapaksa was the country's Defence Secretary from 2005 to 2015, Chinese submarines and ships had docked in Lankan ports — causing a fair bit of concern in Delhi.

Gotabaya, on his part, has said that his country will "maintain an equidistant and vet, cordial relations with all countries".

Data on Hindu Bengalis not included in NRC soon: Himanta

THE ASSAM government will soon present before the Assembly data on Hindu Bengalis who have been excluded from the final NRC, and who would be eligible to apply for citizenship once the the Citizenship (Amendment) Bill is passed in Parliament, Assam minister and senior BJP leader Himanta Biswa Sarma said on the sidelines of the first day of winter session on Thursday.

Members belonging to opposition Congress and AIUDF, whose demands for an adjournment motion to discuss the citizenship amendment Bill (CAB) and the NRC was turned down by the Speaker, staged a walkout to protest the Bill and BJP's demand for scrapping the recently completed NRC and seeking a fresh one.

Sarma told reporters in Assamese: "We want CAB in Assam. According to statistics I

have, people whose names have been excluded [from final NRC], if these people are kept on being excluded, many Assembly constituencies might go to the hands of other people. So, in the interest of Assamese people, we need CAB."

These issues, like the one relating to amendments in the citizenship law, strike at the very foundations of our Constitution. It is sheer hypocrisy on the part of

the Modi-Shah establishment to celebrate November 26 as Constitution Day while deceitfully subverting this sacred document...

"The whole of the northeast is in turmoil because of these amendments. And because the NRC project implemented in Assam, monitored by the Supreme Court, has not fulfilled the RSS-BJP expectations and propaganda, there is now clamour for a fresh NRC. The Home Minister is also speaking of unleashing an NRC in the entire country — a step that will lead to

4-yr-old 'sacrificed' for treasure in UP, 11 arrested, say police

Lucknow: A four-year-old boy was allegedly killed by a group of 12 people who used the child as "human sacrifice in search for treasure" in Pilibhit district. Police on Thursday said they arrested 11 of the accused, while one is still absconding. "All the 11 arrested

have confessed to killing the boy for finding treasure. The accused were told by two occultists — Omkar and Bhagat — that there was an ancient treasure hidden in the village. They were told that they need to sacrifice a child in order to obtain the treasure. The 12 then made a plan to abduct a child from the village," said Maniram Singh, SHO of Bisalpur.

According to police, two of the accused — Munna (35) and Sudhir

The same day, they took him to Munna's farm where they performed a "puja", along with the other accused, and later killed the child and mutilated his body, the SHO said. 

WhatsApp snooping: Govindacharya's plea listed for SC hearing on Dec 2

KARISHMA MEHROTRA NEW DELHI, NOVEMBER 28

A PETITION regarding the WhatsApp snooping case is listed for hearing on Monday in court number 1 before the bench held by the Chief Justice of India, according to the latest cause list updated on the Supreme Court

The petitioner, former RSS ideologue K N Govindacharya, is seeking an NIA probe against Facebook, WhatsApp and the NSO Group. The petition is also seeking perjury proceedings against WhatsApp for "misleading" the court about encryption and data during another case proceeding.

The petition comes almost a month after *The Indian Express* reported that WhatsApp was used to spy on Indian citizens. This was done using a spyware tool called Pegasus, which has been developed by an Israeli firm, the NSO Group. WhatsApp has sued the NSO Group in a US court for alleging targeting the phones of 1,400 users.

The petition states: "NSO has stated that its sells Pegasus only to government agencies. The fact that human rights activists, lawyers etc. have been snooped shows the gravity of the situation. Earlier, Chief Minister of Delhi has stated that the phones of judges are also being tapped."

'FAILURE' OF ANTI-MINE BOOTS

Army withholds payment of Rs 16.7 crore to firm

MANAMAN SINGH CHHINA CHANDIGARH, NOVEMBER 28

THE INDIAN Army's procurement of anti-mine boots for troops deployed on the Line of Control in Jammu and Kashmir has run into rough weather, with the Army's Northern Command finding the boots supplied to be defective and withholding payment of nearly Rs 17 crore to the supplier firm.

The Boot Anti Mine (Infantry), or BAMI in Army parlance, were procured by the Northern Command in 2018 under the Army Commanders Special Financial Power Fund. The boots were distributed to protect the troops who venture close to minefields along the border with PoK. Arbitration proceedings are

now under way at Udhampur since August.

Documents accessed by *The Indian Express* show that the Northern Command has withheld payment of nearly Rs 16.77 crore for the supply of 6,250 anti mine boots to a Batala (Punjab) based firm, Gee Kay Engineering Industries, alleging that defective shoes had been supplied which did not offer adequate protection and caused severe injuries to Army personnel following mine

The boots had been supplied to the Northern Command in July 2018 and were accepted by the Army authorities after 100 per cent inspection in September 2018. The boots had been selected after extensive blast tests and field trials by a Technical Evaluation Committee of the Northern Command. The Inspection and

The Army, however, wrote a letter to the suppliers in February 2019 pointing out that two officers had suffered grave injuries from mine blasts despite wearing the boots. The letter, written by HQs Northern Command, Udhampur (J&K), said that a Lt Colonel deployed in Naushera suffered injury due to mine blast to his right foot, with two fingers amputated and a third likely to be amputated. In another incident cited by the Army, a Major posted in Akhnoor was severely injured in mine blast and half his left foot was amputated.

"These boots have failed to provide protection to the wearer as per the qualitative requirements in the tender and have caused grave injury to the personnel wearing it. You are requested to forward reasons for failure of the boots and severe injury including loss of limb to the wearer," the letter, written by Colonel General Staff on behalf of Chief Engineer, Northern Command,

When contacted, the supplier firm rejected the allegations. Replying to a written query, an advocate for Gee Kay Engineering Industries, Guneet Chaudhary, said his clients had supplied 6,250 pairs of BAMI after successfully qualifying the Technical Evaluation Test conducted by the **Technical Evaluation Committee** headed by senior officers of Northern Command.

"The supplied BAMI were duly inspected physically by the Inspection and Acceptance Board and strongly recommended for acceptance and procurement was duly approved by the Army Commander. The operational Corps Commander had publicly declared that it is due to BAMI supplied by the client, the lives of the two officers were saved. Further, it is only yesterday, a retired Chief of Integrated Defence Staff (IDS) mentioned in social

media that the foot of one of his

battalion officers, at present recu-

perating in Northern Command

Hospital, was saved as he was

wearing BAMI. It leaves no doubt about the quality of the BAMI. The BAMI supplied are as per the International Standards," he said. Chaudhary went on to say that the Northern Command Headquarters failed to make the payment for 6282 pairs so far, whereas as per the terms and conditions of the Request for Proposal,

100 per cent payment was to be

made at 'cash on delivery'. "...The denial of payment for more than 500 days for no valid reason forced us to serve the Notice for Arbitration under Clause 18 of the Arbitration Act. The Head Quarter, Northern Command has appointed, Kartar Singh, Retired District and Session Judge as the sole arbitrator for the settlement of the dispute. The Arbitration Proceedings are going on at Udhampur and we will not be able to divulge the details of the arbitration proceedings as it will be against the confidentiality clause of the Arbitration Act," he added.

THE DEFENCE Acquisition Council (DAC), under the Defence Ministry, on Thursday approved capital procurement worth Rs 22,800 crore. The projects that were approved include thermal imaging-based night sights for assault rifles, long range anti-submarine warfare P8I aircraft and twin engine heavy helicopters and revalidated the necessity for the procurement of additional Airborne Warning and Control System (AWACS) aircraft. The DAC approved the in-

digenous design, development and manufacturing of the nights sights, which will be manufactured by Indian private companies and used by troops on the frontline. The sights will give Indian troops the capacity to execute long-range accurate engagements in dark and allweather conditions.

The P8I aircraft will be used by the Navy will enhance its capabilities for maritime coastal surveillance, Anti-Submarine Warfare (ASW) and Anti-Surface Vessel (ASV) strikes. The twin-engine heavy helicopters will be procured for the Indian Coast Guard to undertake missions to prevent maritime terrorism, infiltration of terrorists by sea routes as well as search and rescue operations.

Used for early warning, AWACS aircraft would help in achieving effective air space dominance in the least possible time and once inducted, they would also increase the extent of coverage along the borders and enhance both air defence and offensive capabilities.

Malik: Reflect upon reality rather than just entertainment

PANAJI, NOVEMBER 28

GOA GOVERNOR Satya Pal Malik on Thursday appealed to filmmakers, asking them to reflect upon reality and social anomalies rather than "just entertainment" in their movies.

Speaking at the closing ceremony of the 50th edition of the International Film Festival of India (IFFI), Malik said, "In India, what is shown is not the only reality... India still has poverty, unemployment... If you look at the cities, there are those who sling backpacks and walk around in search for work. We can't even guarantee them good jobs. The same is the case with the farmer. I have returned seeing the state of our soldiers... Sitting far from reality, I see lots of people making speeches that 'we are doing this for soldiers, we are doing that for soldiers'."

Malik called upon the filmmakers to make movies attacking the "new mahajans", referring to the nouveau riche who don't spend any money on charity.

"There are those who own big homes, those who live in 14 storeyed buildings, one floor for their dog, one for their driver... but not a penny spent by them on any soldier or their family. So I appeal to filmmakers to attack this category of society. Probably it will yield some good outcome."

He added, "Get out of the phase where you only end a movie with a girl marrying a boy. Show the anomaly, show the un-

employment... there is the struggle of the youth for jobs... our farmers are in deep distress... there are no zamindars anymore... your movies now need to show the new mahajans, the nouveauriche, maybe your movies will make them act, maybe the youth, the distressed, the unemployed, the society will benefit... I truly believe in the power of cinema."

Malik, who was previously the Governor of the state of Jammu and Kashmir, also spoke about the abrogation of Article 370. He said, "I am sorry I still am carrying the Kashmir hangover... Earlier 50 people would die in a week. There was unrest in 2010 where 50 people were killed... When the Burhan Wani unrest took place around 110 were killed... Each week there were many casualties. But after the abrogation of Article 370, not even a single bullet was fired."

Among those present in the audience during Malik's address were Brazilian actor Wagner Moura, Iranian filmmaker Maysam Makhmalbaf and Bollywood director Rohan Sippy.

Vidyalayas is 62.07 per cent." Claiming that the CM has ini-

tially given his support for the two new schools, RLSP state president (campaign) Jitendra Nath told *The Indian Express* on Thursday: "We are shocked at the volte-face of Nitish Kumar, who is perhaps afraid of our leader getting political mileage if the two KVs come up. 

HC asks Karnataka: How will you protect kids of detained illegal migrants?

EXPRESS NEWS SERVICE BENGALURU. NOVEMBER 28

THE KARNATAKA High Court on Thursday directed the state government to respond on how children of alleged illegal immigrants will be protected in the event of detention of the parents.

The court also told the state government that deportation process of a person accused of being an illegal immigrant must begin soon as an FIR is registered.

The single-judge bench of Justice K N Phaneendra posed the question on children of detainees after an advocate representing two alleged illegal immigrants from Bangladesh, arrested in September 2018, told the court that two young children of a woman, arrested by the police in Sarjapur area of rural Bengaluru, were housed at a children's home, separated from their imprisoned mother for more than a year now.

Justice Phaneendra was hearing the bail of alleged illegal Bangladeshi immigrants Babul Khan, 46, and his daughter Taniya, 20.

The judge asked, "What happens if kids are separated from parents in the process? Grownup children will be okay, but what if children are small, and what happens if their education is affected? Can the State do something?"

Justice Phaneendra observed "Children are children even if they are children of illegal immigrants. What is the international

also what can be done." Assistant Solicitor General C Shashikantha informed the court that all children will be housed with their parents once detention centres are set up in the state over the next year, starting with one facility near Bengaluru in early-2020.

The court directed the government to file its response by December 4. Justice Phaneendra also indicated that alleged illegal immigrants must be detained at detention centres established as per international convention and not in prisons.

"Once FIR is registered and the person is arrested under Foreigners Act, then the process of deportation should begin immediately. The notification says mere registration of FIR can start the process," the court said. "Once Foreigners Act is invoked by the police, the deportation process must start irrespective of outcome of the case. If secured, they (alleged illegal immigrant) should be brought to court and they should be put in detention centres."

On Tuesday, the government had told the High Court that 35 detention centres will be set up across the state to house illegal foreigners before deportation.

SC reserves order on Chidambaram's bail plea

THE SUPREME Court on Thursday reserved its order on former Union minister P Chidambaram's petition seeking bail in the INX Media money laundering case.

The Enforcement Directorate (ED) opposed the plea and argued that "sufficient evidence has come on record that" the senior Congress leader "has been indulging in destruction of evidence and influencing witnesses".

Appearing for ED, Solicitor General Tushar Mehta told a bench of Justices R Banumathi, A S Bopanna and Hrishikesh Roy that "three witnesses have given statement that the petitioner and his family members have pressurised them and asked them not to appear" before ED. One of them, who was also

part of the money laundering, had written to the agency stating that he does not want to be confronted with the accused, as the latter is a "powerful" person, Mehta said. The other two witnesses simply did not turn up.

Mehta submitted that to conceal proceeds of crime, the accused closed certain bank accounts and opened new ones.

During the probe, it was found that two bank accounts of the petitioner's son Karti Chidambaram in Metro Bank, UK, were closed, he said. As part of the cover-up operations, shareholding patterns and directors of shell companies set up to launder the ill-gotten money was changed, he contended.

The SC is hearing Chidambaram's petition against the Delhi High Court order dismissing his bail plea. The Congress leader has con-

tended that although HC observed that he is not likely to flee or tamper with evidence or influence witnesses, the court denied him bail on the ground that the the alleged offence was grave. Gravity of offence cannot be the ground for denying bail, and if HC's view was accepted then no

Countering this, Mehta said Karti had not got regular bail in the ED case. He had challenged certain provisions of the Prevention of Money Laundering Act in High Court, which, while taking it up, granted him protection from arrest. Mehta said the ED had challenged that in SC, as "the High Court order ought not to have been passed".

"Karti, too, will have to be arrested when the (HC) order is vacated, given the material the ED has found," Mehta said.

Sonia slams govt's 'vindictiveness', asks all to stand up to 'regime'

CONGRESS PRESIDENT Sonia Gandhi on Thursday lashed out at the Centre over the prolonged incarceration of PChidambaram and called it "sheer vindictiveness" of the Narendra Modi government that has kept the former Union minister in prison for 100 days.

His son and Lok Sabha MP Karti also hit out at the government and asked whether he is being kept in jail for political

Addressing a general body meeting of the Congress Parliamentary Party, Sonia asked the party to be united in standing up to the Narendra Modi and Amit Shah's "regime", which, she alleged, is intoxicated by power and does not follow rules and conventions.

Sonia's criticism came on a day the Supreme Court reserved its verdict on a plea filed by Chidambaram seeking bail in the **INX-Media case.**

Karti Chidambaram claimed the government is 'afraid' and doesn't want to face his father in Parliament. PTI

Sonia said: "Let us be united in our resolve to stand up to the Modi-Shah regime, a regime that knows or follows no rules and conventions, intoxicated by power, and wielding it to strike at every institution of our democracy, at political opponents... like our colleagues [D K] Shivakumar and Chidambaram. It is sheer vindictiveness that has

kept Chidambaram in prison for 100 days."

She said, "These are undoubtedly extraordinary times, when our fortitude and resilience are under the greatest of tests. But collectively we will turn the tide — not for our sake but for the sake of the Constitution, for the sake of a liberal and pluralistic democracy, and for the sake of our country and our people."

Karti told *The Indian Express* that it is "very unfortunate" that Chidambaram has been kept in remand for 100 days.

He said: "It is not even a trial He has not even faced trial. It is a pre-trial remand for investigation. How long will you investigate something which happened in 2007, for which you filed an FIR in 2017...Is it being done because you don't want him to speak in Parliament What is this remand for. His personal liberty, right to reputation everything is greatly damaged by this," Karti said.

UGC proposes to regulate fee charged by deemed universities

THE UNIVERSITY Grants Commission (UGC) is set to regulate the fee charged by private deemed universities for professional programmes.

The higher education regulator is working on a regulation that proposes to set up a highpowered committee to determine the "reasonableness" of the fee charged by private deemdto-be universities.

As per the UGC (Fees in professional education imparted by private-aided and unaided institutions deemed to be universities) Regulations, 2019, a deemed university can only charge fee approved by the said committee. UGC made the draft regulations public on Thursday for feedback and comments.

Most states have fee fixation committees and even laws for fee charged by state private institutions for professional programmes. However, there's no regulation of fee charged by private deemed universities which

come under the union government. Currently, out of the 127 deemed universities, 90 are private institutions.

In order to determine the "reasonableness" of the fee charged by private deemed universities, the proposed fee committee (to be set up by UGC) will look into a number of factors, including the cost of educating one student, revenue surplus generated by the institution, salary and allowances to be paid to teaching and non-teaching staff.

According to the draft, UGC's fee committee will have five members and it will be headed by a former Vice-Chancellor or former head of a regulatory body like the UGC. The other members will include an eminent educationist who had achieved the rank of a professor, a nominee of a statuary national regulatory authority, an expert from the field of account-

ancy and an officer of the UGC. The said committee will be competent to impose a fine of up to Rs 10 lakh for every violation, apart from the excess fee that the institution will be asked to refund to the students.

PIB to fact-check govt-related news

KRISHN KAUSHIK NEW DELHI, NOVEMBER 28

"RECEIVED A forward that looks too good to be true!!! or maybe came across a piece of news that you want verified !! Send it across and we will Fact Check it for you, no questions asked."

This is what the official handle of the Press Information Bureau (PIB) tweeted on Thursday. It added, "Ever wondered if a WhatsApp forward is true or just fake news? Or if a tweet/ FB (Facebook) post is real? Fret no more!"

It said the web link or a "snapshot" of that information can be shared through email. and the government would respond after checking its authenticity. It announced that PIB is now officially trying to bust fake news or false information, but the information has to be related to the government.

Kuldeep Singh Dhatwalia, Principal Director General of PIB, told The Indian Express that because of the "speed at which false information is being circulated on social media", the government will try to verify the authenticity of government-related information.

"We are starting with government-related news," Dhatwalia said. "If it is not factually correct and it comes to our notice, we will ask the concerned officer of the particular ministry to check

with the ministry and we will put out the factual position."

Dhatwalia added that PIB would be "thankful" to those who "bring something which is not genuine to our notice", and "the moment we are sure that it is fake news, we will put the official version in the public domain".

He said that PIB has to "put a new system in place", for which they are "identifying and training officers". The team will include "just a few officers who are already working on social media", he said, who will be groomed and trained. He said the initiative is restricted to information about the Union government and its ministries and departments as of now, but "we will see how far we can go" with it.
