Govt to end SPG cover for Gandhi family, Cong reacts angrily

FROM SPECIAL Protection Group (SPG) to CRPF Z-plus, the Centre has downgraded the security cover for Congress president Sonia Gandhi and her children, Rahul Gandhi and Priyanka Vadra, based on the latest threat assessment by security agencies, sources told The Indian Express.

The three were under SPG cover since the assassination of former Prime Minister Rajiv Gandhi in 1991. Two months ago, the government had similarly downgraded the security cover for Congress leader and Prime Minister Manmohan Singh.

The latest decision was slammed by Congress leaders, with the party's general secretary K C Venugopal accusing the government of "playing with the lives of Sonia, Rahul and Priyanka". Senior leader Ahmed Patel accused the ruling BJP of deploying the "ultimate personal vendetta **CONTINUED ON PAGE 2**

THE OUTCOME of one of India's most significant and sensitive litigation will be known Saturday morning when a five-judge Constitution Bench, headed by Chief Justice of India Ranjan Gogoi, rules on appeals challenging a 2010 order on the title to the disputed Ram Janmabhoomi-Babri Masjid site in Ayodhya.

The Bench, also comprising Justices S A Bobde, D Y Chandrachud, Ashok Bhushan and S A Nazeer, will meet at 10.30 am Saturday to pronounce the judgment it had reserved on October 16 after hearing CONTINUED ON PAGE 2

PM for calm: Whatever the verdict, it will not be anyone's loss or victory

AS THE nation braced for the Supreme Court ruling Saturday on the disputed Ayodhya site, Prime Minister Narendra Modi called for calm, underlining that the judgment "will not be anyone's loss or victory".

In Twitter posts Friday night, the Prime Minister said: "The Supreme Court will rule on Ayodhya tomorrow. In the last few months, there was continuous hearing on this issue and the whole country was following it with curiosity. While the hearing was on, all sections of the society made efforts to maintain a harmonious atmosphere which

THE DAY before the historic opening of the Kartarpur Corridor, linking Dera Baba Nanak in Punjab to Darbar Sahib in Pakistan, a group of Canadian Sikh pilgrims were welcomed with garlands at the Wagah immigration terminal.

The pilgrims had crossed the Attari-Wagah border to take part in the inauguration of the corri-

dor by Prime Minister Imran Khan Saturday, while Prime Minister Narendra Modi will open the link on the Indian side.

The warmth on the ground, however, failed to find an echo at the government level. As Pakistan Foreign Minister Shah Mahmood Qureshi raked up the Kashmir issue Friday, the administration took another U-turn on a commitment by PM Khan to waive the fee of \$20 per pilgrim on the opening day.

On Thursday, the Pakistan Army had overruled another commitment by Khan that Sikh

pilgrims from India would not

need to carry their passports. Speaking to reporters in Lahore, Qureshi referred to Kashmir and criticised the "communication blackout" in the Valley and what he claimed were "ceasefire violations taking place on the LoC". He claimed that even Opposition parties in India are "not buying socio-economic development claims".

Qureshi also criticised the abrogation of Article 370. Asked about talks, he said: "There cannot be a bilateral exchange at this

NCRB data on farmers' suicides is out with key omission — reasons

AFTER WITHHOLDING data on incidents of lynchings, the National Crime Records Bureau (NCRB) has released figures on farmers' suicides but with a key element from the previous edition missing this time — reasons for the suicides.

The bureau's latest Accidental Death and Suicide report for 2016 shows that while Maharashtra saw a 20 per cent dip from the previous year, in line with the national trend, the state continued to top the list with 2,550 of the 6,270 farmers'

suicides recorded nationwide. Significantly, the NCRB did

not release the data on farmers' suicides alongwith its muchdelayed crime data on October 21, the day of voting in the Maharashtra Assembly elec-

Overall, the data shows that while farmer suicides have dropped by almost 21 per cent, those by farm labourers have gone up by 10 per cent.

In its previous reports, however, the NCRB had included reasons behind farmers' suicides under categories such as farm distress, crop failure, loans, family problems, illness, etc.

Even under loans, there were sub-categories on the source, including banks, money lenders and micro-finance institutions. The reports also included data on the socio-economic status and landholding of each victim.

BJP-led govts gave PIO and OCI cards to Aatish, eased norms for single parent

TWO DIFFERENT BIP-led governments had issued the People of Indian Origin (PIO) card and the Overseas Citizen of India (OCI) card to author Aatish Taseer in January 2000 and July 2016, respectively. The revocation of his OCI card Thursday is being read by many as a response to an article he wrote this May in Time

magazine which was critical of Prime Minister Narendra Modi.

The PIO scheme was launched in 1999 under the Atal Bihari Vajpayee government, and the PIO and OCI schemes were merged and re-launched in 2015.

The fact that the government cited Taseer's "Pakistan origins" to revoke his OCI card despite him being raised by his mother sits at odds with the BJP-led government's moves towards

Moody's cites jobs, rural stress to cut ratings outlook to negative from stable

Maintains ratings, but says probability of 'entrenched slowdown' higher

SUNNY VERMA NEW DELHI, NOVEMBER 8

RATING AGENCY Moody's Investor Service Friday cut its outlook on India's ratings to negative from stable, but affirmed the investment grade Baa2 foreign-currency and local-currency long-term issuer ratings. The agency said prolonged financial stress among rural households, weak job creation, and a credit crunch among nonbank financial institutions (NBFIs), have increased the probability of a more "entrenched slowdown".

Lower nominal GDP growth would mean India will face significant constraints in lowering its fiscal deficit and debt burden, Moody's said. The ratings agency also cut its outlook for 21 large companies, including State Bank of India, Indian Oil Corporation Ltd, Infosys Ltd and NTPC Ltd to "negative" from "stable".

Lowering of the sovereign credit outlook is a potential step towards an investment rating downgrade. India is now just two notches above non-investment grade country ratings on Moody's scale. While Moody's



Can result in fund outflow

THE AGENCY'S action has the potential to result in fund outflows from the Indian markets and an increase in overseas borrowing costs for Indian companies. The negative outlook and the commentary following the action indicates an upgrade is unlikely soon since in its assessment the slowdown is likely to deepen. The government will have to aggressively pursue stake sale in PSUs to raise resources to improve its fiscal health.

As Fadnavis quits, **Uddhav: Form Govt** or will look at options

UNABLE TO stake claim for government formation jointly with Shiv Sena despite a pre-poll alliance, Maharashtra Chief Minister Devendra Fadnavis Friday submitted his resignation to Governor Bhagat Singh Koshiyari. The Governor has asked him to continue as 'caretaker CM' for the time being.

Breaking his silence over the prolonged BJP-Sena stalemate, Fadnavis blamed the Shiv Sena for dishonouring the mandate of the people. He expressed confidence BJP would form the government, but attacked the Sena for its high-handedness which, he said, put a question mark on the allies' co-existence. "In the very first press confer-

ence after poll results (on October 24), Shiv Sena president Uddhav Thackeray said all options were



open for Sena. This was a big shock especially since we were pre-poll allies. The BIP won 105 seats, Sena 56. The mandate was for the alliance," Fadnavis said at a briefing in Sahyadri, the government guest house.

PAGE 1 No Net for tests, NIT-Srinagar students want to leave

LESS THAN a month after NIT-Srinagar reopened, more than half of its final-year students are preparing to leave the campus

again. An indefinite Internet blockade in the Valley has disrupted NIT-Srinagar's placement drive, affecting students preparing for the Graduate Aptitude Test in Engineering (GATE) and Graduate Record Examinations (GRE).

So much so, that more than 200 B.Tech students in their fourth year — out of 379 — have

sought the institute's permission to leave and return next year after appearing for GATE in February. These students have also signed an undertaking that they are leaving of their own volition and will take responsibility for completing the seventh-semester syllabus on their own. The undertaking was submitted to Kowsar Majid, Dean of Academic

Affairs, this week. "A few companies have had to postpone their campus recruitment as students cannot appear for their online test. Those preparing for GATE and GRE need the Internet for accessing study material," said a fourth-year student, who has signed the undertaking. When contacted Friday, NIT-Srinagar director Rakesh Sehgal

confirmed that almost half the students in the fourth year had sought permission to leave. He did not wish to comment further.

A senior official in the institute said the director has agreed to let students leave on the condition that they do not press teachers for special classes later. "We are planning to relax the attendance requirement for these students, and also hold semester-end examinations in February for them," the senior official said.

Sources said NIT-Srinagar has, on several occasions, approached

the HRD Ministry and local administration for restoration of Internet services on campus but in vain.

The NIT reopened on October 15, more than two months after the abrogation of Article 370 forced it to shut indefinitely on August 3, when close to 1,500 stu-

dents were asked to vacate the

campus overnight. Since the institute was forced to shut down in the middle of placement season, about 70 outstation students had camped in a hostel in Ghaziabad for a month, at their own expense, to organise


their placement drive. The Indian Express reported on from Jammu and Kashmir could not be informed about this placement drive because of the blockade - about 55 students had found jobs through this drive. The fourth-year students plan to continue the drive in Ghaziabad once they are permitted to leave. About 2,100 students out of 2,892 have reported at the insti-

tute after it reopened, but a large number of PhD students haven't joined as yet because of the blockade. "What are research students going to do if they can't access journals online?" the senior official said. There are a total of 358 PhD students at NIT-Srinagar.

improves its fiscal health materially through aggressive stake sale in state-owned companies.

The ratings agency also said it does not expect the credit crunch among non-bank financial institutions to be resolved quickly. The negative outlook also in-

dicates that an upgrade is unlikely in the near term. Stock, currency and bond markets fell sharply reacting to lowering of the India outlook. Sensex at the Bombay Stock Exchange fell 330 points or 0.8% to close at 40,323.6, while the rupee lost 31 paise or 0.45% during the day to 71.28 against the US dollar. Noting concerns raised by the

agency, the finance ministry in a statement said India continues to be among the fastest growing major economies in the world, and its relative standing remains unaffected. The government said it has undertaken a series of financial sector and other reforms to strengthen the economy as a whole, and proactively taken steps in response to the global slowdown.

"These measures would lead to a positive outlook on India and would attract capital flows and stimulate investments. The fundamentals of the economy remain quite robust with inflation under check and bond yields low. India continues to offer strong prospects of growth in near and medium term," the finance ministry said.

The economy grew 5% in April-June quarter, its weakest since 2013, prompting the government to cut corporate tax rate to 22% from 30% (excluding surcharge and cess), and a number of other growth promoting measures. Moody's said while measures announced by the government will provide support to the economy, they are unlikely to restore productivity and real GDP growth to previous rates.

"India's economic growth has slowed materially, with real and nominal GDP growth falling to 5% and 8% year on year in April-June 2019, respectively. Moody's estimates that the growth slowdown is in part long-lasting. Moreover, compared with two years ago when Moody's upgraded India's rating to Baa2 from Baa3, the probability of sustained real GDP growth at or above 8% has significantly diminished," it said, adding that the prospects for economic and institutional growth promoting reforms have

Over the last seven months,

the Reserve Bank of India has also downgraded the GDP growth projection for the current financial year from 7.4% (in February 2019 policy statement) to 6.1% in its October policy statement. Revising the GDP growth ex-

pectation for FY'20 downward by 80 basis points from 6.9% in its August policy to 6.1% in October policy, the RBI in its MPC (Monetary Policy Committee) statement said while various high frequency indicators suggested that domestic demand conditions remained weak, there were indications of muted expansion in Q3.

Separately, Nomura Global Market Research said in a report Friday that India's growth will fall to 4.9% in 2019.

"With tight domestic credit conditions persisting amid weak global demand, we now expect India's recovery to be delayed and the pickup to remain below potential. We lower our GDP growth projections to 4.9% y-o-y (from 5.7%) in 2019 and to 6% (from 6.9%) in 2020," it said in the report.

Slowing growth and tax collections would put strain on the exchequer, making it difficult to reduce the country's debt burden. Moody's now expects a fiscal deficit of 3.7% of GDP by Marchend 2020, as against a government target of 3.3%.

The rating agency said multiple facets of the slowdown and structural weaknesses in the real economy and financial system point to further downside risks to its expectations that real and nominal GDP growth will rise towards 6.6% and 11%, respectively over the next year.

Farmer suicides

"Not only were the old categories retained but more sub-categorisation had been done to further diversify the data this time. But it's interesting to note that this data has not been published," said a former NCRB official who was involved in the exercise.

In another departure, farmers' suicides have not been recorded separately but included under the category 'Suicides by Profession'. The report for 2015 had a separate category 'Suicides by Persons Involved in Farming Sector' under which were six categories, including "cause-wise distribution of farmer suicides'

and "land-holding-wise distribution of farmer suicides".

The former official said the suicide data report had been compiled and submitted 18 months ago to the Home Ministry, which sought a number of clarifications. "A key question was also whether NCRB needed to collect data on farmers' suicides at all," he said.

The data shows that Maharashtra accounted for almost 40 per cent of all farmer suicides in the country in 2016. Karnataka (1,212) was second on the list but still recorded 50 per cent less farmers' suicides than Maharashtra. Compared to overall figures

of 6,270 in 2016, 8,007 farmers (including land-holders and cultivators) had committed suicide in 2015 across the country. The data shows that 5,109

farm labourers committed suicide in 2016, compared to 4,595 in 2015. Even in this category, Maharashtra topped with 1,111, followed by Karnataka (867) and Madhya Pradesh (722). In 2015, the publication of di-

verse sets of data on farmers' suicides data showed that they were being exploited by micro-finance institutions.

The data showed that 80 per cent of farmers who killed themselves because of bankruptcy or debts had taken loans from banks and registered microfinance institutions — not from money lenders.

Of over 3,000 farmers who committed suicide due to debt and bankruptcy, 2,474 had taken loans from banks or microfinance institutions.

It was for the first time that the NCRB had categorised farmers' suicides due to debt or bankruptcy based on the source of loans.

"Such data is beneficial for formulating robust policies that alleviate farm distress. By withholding such important data, the government is preventing other stakeholders in the civil society from participating in such efforts," the former official said.

On October 21, the NCRB released its latest report on crime incidents across the country, but without publishing data collected under the new sub-heads of death due to mob lynching, murder by influential people, killing ordered by khap panchayat and murder committed for religious reasons.

While there was no explanation on how and why the government suddenly rummaged through his PIO application, a Union Home Ministry spokesperson Thursday said Taseer had "concealed the fact of Pak origin of his late father" in the application. Taseer, a British passport-holder, was given an OCI card on the basis that he is a child of an Indian national. While his father Salmaan Taseer was a Pakistan national, his mother Tavleen Singh, senior journalist and columnist with The Indian Express, raised him as a single mother. The two never married were estranged, and she was Taseer's sole legal guardian. Salmaan Taseer was a prominent politician in Pakistan and was assassinated for speaking out against his country's blasphemy

law. What also is at odds with the argument about his father's nationality is that while the BJP-led government's passport rules relating to a single parent were eased, the rules to grant OCI card have remained stuck in time. In January 2018, the government decided that passports will no longer have information names of father/legal guardian, mother, spouse, and address –

printed on the last page.

Affairs had then said, "A threemember Committee comprising the officials of the Ministry of External Affairs and the Ministry of Women and Child Development was constituted to examine various issues pertain-

ing to passport applications where mother/child had insisted that the name of the father should not be mentioned in the passport and also relating to passport issued to children with single parent and to adopted children. The Report of the Committee had been accepted by the Ministry. One of the recommendations of the Committee was that the Ministry of External Affairs should explore the possibility of doing away with the printing of information contained in the Passport Booklet such as names of father/legal guardian, mother, spouse, and address contained in the last page of the passport." Aatish holds a British passport

and a Green Card in the US. He grew up in India, but was never stamped an Indian visa. Tavleen Singh, his mother, had submitted an affidavit in 1982 that she was the sole guardian. He never met his father till 2002 when he was 21, and after a few years, in 2005-06, he was estranged from his father again.

On Thursday, the MHA spokesperson said, "Taseer was given the opportunity to submit his reply/objections regarding his PIO/ OCI cards, but he failed to dispute the notice," the spokesperson said. "Thus, Aatish Ali Taseer becomes ineligible to hold an OCI card as per the Citizenship Act, 1955. He has clearly not complied with very basic requirements and hidden information," the spokesperson

The government invoked Clause 7A of the OCI card rules which states: "Provided further that no person, who or either of whose parents or grandparents or great grandparents is or had been a citizen of Pakistan, Bangladesh or such other country as the Central Government may, by notification in the Official Gazette, specify, shall be eligible for registration as an Overseas Citizen of India Cardholder under this sub-section."

and amity," he said As Modi called for calm, states went on alert across the country.

The Uttar Pradesh government said all schools, colleges, educational institutions and training centres will remain shut from November 9 to November 11. Chief Minister Yogi Adityanath said: "It is the responsibility of everyone to maintain an atmosphere of peace and harmony in the state at any cost. Do not pay attention to rumours... If anyone tries to break the law, strict action will be taken against them." Rajasthan Chief Minister

Ashok Gehlot appealed for peace and reviewed security arrangements through a videoconference with Divisional Commissioners, Police Commissioners, Inspector Generals, District Collectors and Superintendents of Police. "It is the duty of District Collectors and SPs to be on guard against any incident which might vitiate the law and order," he said.

Kerala Chief Minister Pinarayi Vijayan urged everyone to exercise self-restraint whatever the verdict. He recalled that even during the demolition of the Babri Masjid, Kerala had reacted in an "exemplary manner". People, he said, should accept the verdict peacefully. Chhattisgarh Chief Minister



On his part, Shiv Sena chief Uddhav Thackeray said his party stopped talks with the BJP after it painted him as liar. "That's how we decided on the line 'equal sharing of power and responsibilities'," he said. But Fadnavis had a different take. "From Day 1, they were speaking to Congress-NCP leaders thrice a day. But Uddhav Thackeray refused to even take my phone call," he said. Questioning Sena's claim that BJP committed to 50:50 power sharing including rotation the CM's post, he said, "During an informal talks with media, I had indicated no such decision was taken in my presence. If at all any decision was taken it would be known to Uddhav Thackeray and BJP President Amit Shah. 

Security upped, Sisodia asks pvt schools to remain shut

AHEAD OF the Supreme Court's verdict in the Ram Janmabhoomi-Babri Masjid dispute, Delhi Police has increased security across the national capital and asked its top officers to identify sensitive areas for deployment of additional force. The Supreme Court is scheduled to pronounce its verdict at 10.30 am Saturday.

In a tweet, Deputy CM Manish Sisodia said: "There are potential security concerns with the SC Ayodhya verdict tomorrow morning. All government schools and many private schools are

closed tomorrow, as it is a second Saturday. We are advising all private schools to also remain closed tomorrow." All educational institutions in Ghaziabad and Gautam Budh Nagar will also remain shut till Monday, as per official orders.

"Delhi Police has made elaborate security arrangements and coordinated with the 'aman (peace) committee', requesting them to be present in communally sensitive areas as well as around religious places. All precautionary measures will be taken in light of the situation," said a senior police officer.

The officer said that following Delhi Police Chief Amulya Patnaik's directions, DCPs of all 15 districts had called meetings with

their SHOs Friday and discussed arrangements for sensitive areas.

"All DCPs and SHOs have been directed to increase police visibility and patrolling in such places," the officer said, adding that personnel have been told to coordinate with hospitals and the fire department to prepare for any possible fallout of the judgment.

Police personnel also met the shahi imam and imams of other mosques, requesting them to urge people to exercise restraint and demonstrate faith in the judiciary.

According to a police advisory, sufficient forces are being mobilised and the department will also requisition extra Central Armed Police Forces companies





SAYS LAW TO REGULARISE COLONIES WILL BE PASSED IN WINTER SESSION

PM enters Delhi poll mix, meets RWA heads, unauthorised colony residents

ABHINAV RAJPUT NEW DELHI, NOVEMBER 8

THE BJP top brass made its most significant foray so far into the Delhi Assembly poll battle, with Prime Minister Narendra Modi Friday meeting a delegation of over 200 people at his residence, including RWA heads and people living in unauthorised colonies.

Calling it the 'PM Uday Yojna', Modi told the delegation that a law will be passed in the upcoming Winter Session of Parliament to give ownership rights to people living in the capital's illegal colonies. The PM's remark comes after the Union Cabinet last month approved a proposal to grant ownership rights to people living in 1,797 unauthorised colonies — a move that is esti-

mated to benefit 40 lakh people in the city.

Union Minister Hardeep Puri said he has held talks with the DDA vice-chairperson and the L-G, and that the registration process will begin in two weeks.

Modi stressed that essence of

the law will be based on principles of 'sabka saath, sabka vikas', and also compared the uncertainty behind the illegal status of colonies to the uncertainty behind removal of Article 370 and

Triple Talaq.

"The soul of the policy will be

based on *sabka saath*, *sabka* vikaas. It's not that one religion will get benefited, another will not; one colony that supports BJP will get the benefit and other will not. This policy will cover all people; even areas that would not have voted for BJP in the past several years," he said.

He said a similar uncertainty used to exist in the minds of Muslim mothers and sisters over Triple Talaq, as they feared there was a sword hanging over their heads — that they could be evicted from home for something as simple as adding more salt in food.

"Similarly, people living in these colonies feared whether MCD officials will demolish their homes some day; their son feared what will happen if they build an additional floor. Ending all such uncertainty, the decision has been taken," the PM said.

Delhi BJP's media relations head Neelkant Bakshi said the delegation that called on the PM included Lok Sabha MPs Manoj Tiwari, Ramesh Bidhuri, Hans Raj Hans, Rajya Sabha MP Vijay Goel and other senior party leaders. He said activists who have been demanding and fighting for regularisation of unauthorised colonies were also part of the team. "They had all gone to thank the PM for the decision," he said. Regularisation of unautho-

rised colonies has remained a major poll issue in Delhi for decades. The BJP and the AAP have been vying to take credit for giving ownership rights to the people living in these settlements, ahead of Assembly polls next year.

Start registration, people fear it won't happen: CM

GOING BEYOND "announcements", the Union government should roll out the registration process for people in unauthorised colonies, "who are under the impression that it will not happen", Chief Minister Arvind Kejriwal said Friday, taking a swipe at Prime Minister Narendra Modi's outreach to people residing in such colonies.

Since the Union Cabinet cleared the proposal to regularise these 1,797 colonies, housing a population of over 40 lakh, the CM has maintained that the Centre's announcement will remain meaningless unless the registration process, the most crucial step in conferring ownership rights, begins.

While stating that the AAP was not in the race to claim credit, the CM reminded people that it is the Delhi government

which made the first move by clearing the proposal in its Cabinet way back in November 2015, "which has now been accepted by the Centre".

"It's a good thing that registration is being opened. The Delhi Cabinet had sent the proposal to regularise to the Centre in 2015. The Centre took around five years to clear the proposal. They tried to stop our CCTV project, mohalla

tion process and we got this done as well. I wish work begins as soon as possible... I have come to know that people in unauthorised colonies think regularisation won't eventually happen as similar announcements have been made in the past. They should do it, that is more important," the CM told a press conference. Revenue Minister Kailash Gahlot said the Delhi government is prepared to start the registration process.

The revenue department has been directed to work out details based on the final arrangement between the Indian and Pakistani governments," he said. In line with the arrangement

in place in case of the other routes, Kejriwal said the Delhi government will bear expenses of the pilgrims in case of Kartarpur Sahib as well, including facilitation fees charged by India or Pakistan.

"On the occasion of the 550th Prakash Parv of Shri Guru Nanak Dev ji, the Delhi government has taken the historic decision of including Kartarpur Corridor in the Mukhyamantri Teerth Yatra scheme," he later tweeted.

Under the scheme, senior citizens are allowed to take one family member with them. Apart from MLAs, Delhi government ministers and the chairman of the Tirth Yatra Vikas Samiti are authorised to issue certificates to applicants.

So far, around 17,000 pilgrims, which include attendants, have undertaken visits funded by the government.

THE DELHI Commissioner for Persons with Disabilities has issued an order recommending that cab aggregator Uber compensate a person with 80% locomotor disability after two cab drivers refused to ferry him and board his wheelchair, leading to him missing a flight.

In a first-of-its-kind order against a private cab aggregator, the commission observed that Uber was discriminatory persons

On November 5, the com-

missioner issued a series of recommendations — including one to the Ministry of Heavy Industries and Ministry of Road Transport and Highways — to "take the initiative to frame a policy to manufacture disabled friendly cars and vehicles...keeping in view the needs of persons with disabilities".

The commissioner also recommended that Uber must have agreements with drivers to compensate for non-compliance.

In the latest case, disability rights activist Arman Ali, also Director of the National Centre Persons with Disabilities, had booked an Uber in Chennai to go to the airport in June. While the first driver can-

celled the ride, the second driver reached him and refused to fit his wheelchair in the front or rear seat. The driver eventually cancelled the ride. "My entire luggage had to be

removed and the driver left me there. For a person with disability, it is agonising to be discriminated for basic services," Ali told The Indian Express. He missed his flight and subsequent meetings in Bengaluru, and paid Rs 14,000 for a fresh ticket.

24. It observed that Uber paid only Rs 45 compensation, as cancellation charge, to Ali and recommended that it offer compensation for the additional cost he incurred in booking another flight. After missing two hearings,

Joyjyoti Misra from Uber India Systems Pvt Ltd, in her response, submitted that it had issued a warning to the driver and sensitised him against discrimination.

sioner recommended that Uber train its drivers on disability rights policy, apart from drawing agreements of penalty if a driver violates the policy.

An Uber India spokesperson said the commissioner's directions are a recommendation, and that the company has three months to respond to it.





Days after arrest for 'theft', ex-Armyman dead in Tihar Jail

NEW DELHI, NOVEMBER 8

A 64-YEAR-OLD former Indian Army captain, arrested by the Delhi Police over accusations of stealing "secret" Indian Army books, allegedly committed suicide inside Tihar Jail Thursday.

Mukesh Chopra was arrested by a team of Delhi Police officers after being briefly detained at the Manekshaw Centre at Delhi Cantonment on November 2. The administration department of the centre told police that he had allegedly stolen nine books, including an in-house magazine. Police had also claimed to have recovered four mobile phones from his possession. He was booked under sections of theft at the Delhi Cantonment police station.

Amid suspicion by security agencies of a spying angle to the alleged incident, Chopra was sent to three-day police custody and jointly questioned by police, the Intelligence Bureau and other investigating agencies. The court of duty magistrate Priya Aggarwal had then sent him to judicial custody on November 6. According to Tihar officials,

Chopra fell off the first floor of jail number 8-9 where he was lodged. He was taken to two hospitals, where doctors tried to revive him, but he succumbed to his injuries by Thursday evening.

Tihar jail officials told *The Indian Express* that Chopra was supposed to be counselled after he arrived in jail, as per the standard operating procedure under Project Samarthan, a mental health programme. However, he allegedly jumped to his death before the session.

"The inmate jumped from the first floor of the control room in his jail. He was supposed to be counselled. We tried our best to revive him, and later shifted him to two hospi-

His family and lawyer, meanwhile, raised questions on his death. His lawyer Deepak Tyagi told The Indian Express, "What business did he have going to the control room? If they accused him of spying for the Chinese government, then he should have been kept in a secure ward. We have found that he was also not given proper medical care while being taken to the hospital.'

His brother Rangnesh Chopra alleged: "While in police custody, my brother was subjected to interrogation which lasted for more than 15 hours every day. He would only sleep for five hours before they would wake him again. He was a former Indian Army officer and he was branded a spy by incompetent police officers."

A magisterial enquiry has been ordered and the family has appealed for a special board of doctors to conduct the postmortem. Tihar Jail officials said they will take further action as per the findings of the enquiry, and maintained there was no foul play in his death.

served as a Captain with the 5th Battalion parachute regiment from 1970 onwards. His family said he was a part of an expedition team cooperating with a team from Spain. "He was made the liaison officer, but the Spanish team accused him of professional misconduct and complained to the Defence Ministry. He was never the same after that. But he still had love for his country," Rangnesh said.

Chopra shifted to Canada with his wife and daughter in 1983, where they obtained Canadian citizenship. He worked as a business consultant. His daughter, a Harvard University graduate, is placed in a private company in Germany. He recently came to India from Hong Kong, and was supposed to attend a wedding in Noida.

As per court records, police recovered nine books, most of them on India-China relations, strategy and a book on the transformation of the Chinese People's Liberation Army. His counsel said all the books are available online. His family claimed he was a card-holding member of the Manekshaw Centre, but forgot to carry his card that day.

At event to celebrate teachers, less education and more politics

AN EVENT hosted by the official association of Delhi government school teachers Thursday took a political colour as many of those who spoke on stage took aim at the Delhi government.

Among them were the convenor of the Delhi BJP's 'intellectual cell'; national president of an outfit called the Bharat Mata Parivar; and organising secretary of the Bharat Vikas Parishad.

The event, hosted by the Government School Teachers' Association, was organised to "honour teachers" and "discuss issues related to education in Delhi", and saw over 500 Delhi government school teachers in attendance.

Delhi BJP chief Manoj Tiwari was supposed to be the chief guest, but he did not turn up.

Targeting the AAP government over its education inter-

ventions, general secretary of the association Ajay Veer Yadav claimed the government has "progressively undermined the respect of teachers by empowering school management committees (SMC)".

An SMC includes parent representatives, a social worker and a representative of the local MLA.

Murari Sharan Shukla, national president of outfit Bharat Mata Parivar, called Chief Minister Arvind Kejriwal "a Maoist", while Amit Kharkhari, convenor of Delhi BIP's 'intellectual cell', claimed that "under this government, teachers can't meet the minister and senior officials".

The key speaker, Suresh Jain, organising secretary of Bharat Vikas Parishad, said: "Many problems are plaguing society... Why is that the case? Students should be taught sanskaar... they are becoming individualistic. which is causing them to commit crimes in society..."

Equipment shortage: Lok Nayak Hospital to shut OT

ASTHA SAXENA NEW DELHI, NOVEMBER 8

FACING AN acute shortage of equipment required in operation theatres, the Delhi governmentrun Lok Nayak Hospital has decided to shut OT services in general surgery department from December 1. An order to this effect was issued by the department on November 6.

The order cites shortage of essentials such as laparoscopic sets; OT tables; patient transfer trolleys; post-operative ICU beds; OT ceiling lights; and a C-arm, and has been marked to top administrative officials. The OT caters to around 15-20 patients daily.

The order, issued by head of department Dr P Lal, said they have sent numerous demands to the hospital procurement section but to no avail.

"The undersigned has managed to procure expensive laparoscopic equipment on a loan basis... for 18 months from various companies so that patient care is unaffected... and training of resident doctors remains unaffected. This was done in the hope that the hospital would eventually be able to procure these items. But the same have not been processed or put on the burner/shelved," wrote the HOD.

Health Secretary Sanjeev Khirwar told *The Indian Express*: "We are aware of the problems and immediate steps are being taken to fill the gap. Services wil not be shut and purchases will be made before December 1."

According to sources, the orthopaedics department also faced a similar problem. Senior doctors said that on November 1, the department's OT services were delayed due to shortage of nursing orderlies. "Ideally we operate around 15 cases, but on that day, services started at 12 pm and only four cases were operated. Not a single nursing orderly was available for the four OTs," claimed a senior doctor.

While Vice-President M Venkaiah Naidu and Prime Minister Narendra Modi called on Advani to wish him as he turned 92, President Ram Nath Kovind and former president Pranab Mukherjee were learnt to have wished him over phone. Other prominent leaders who visited the nonagenarian leader included BJP president Amit Shah, working president J P Nadda, general secretary (organisation) B L Santhosh, Union minister Ravi Shankar Prasad and Haryana Chief Minister Manohar Lal Khattar. From the Sangh Parivar, joint general secretary Krishna Gopal and RSS leader Ramlal visited Advani while RSS general secretary Bhaiyyaji Joshi was learnt to have wished him over phone.

COURT CALL

THE CONGRESS has protested, rather forcefully, the central government's decision to withdraw the SPG cover to Gandhi family members Sonia, Rahul and Priyanka. The party is also considering mounting a legal challenge apart from the political attack. Those in the know said that challenging the decision in a court of law cannot be ruled out, and the party is looking at the pros and cons. It is too early but the possibility cannot be ruled out, a senior leader said. To put up a legal challenge, they would have to dissect the decision in an unemotional and merit-based manner, the leader said.

THE RIGHT BLEND

THE PROJECT to make a university building for the country's first rail university, called National Rail and Transportation Institute, in Vadodara is going on in full swing. Last heard, Railways was likely to bring in architect Hafeez Contractor for the design. The building will be established in the campus of the National Academy of Indian Railways, and care is apparently being taken so that it represents modernity while blending in the heritage of Pratap Vilas Palace, where the academy is situated.

SC to hear Karnataka MLAs' fresh plea to postpone bypolls on Nov 13

THE SUPREME Court on Friday agreed to hear on November 13 a fresh plea by disqualified Karnataka MLAs, seeking a direction to Election Commission to again postpone the Assembly bypolls for 15 seats, scheduled to be held on December 5.

for the petitioners seeking urgent listing of the Interlocutory Application for directions, the registry is directed to list the said application on Wednesday, November 13, 2019, subject to curing of defects by the petitioner. AMID MAHARASHTRA CRISIS, MILIND DEORA SUGGESTS

'NCP-Cong could form govt with outside support from other parties'

MANOJCG NEW DELHI, NOVEMBER 8

AMID THE prolonged BIP-Sena stalemate over government formation in Maharashtra, senior Congress leader Milind Deora on Friday suggested that the NCP and Congress should now stake claim to form the government with outside support from other parties (read Shiv Sena) and independent legislators.

This is the first time a senior Congress leader has openly suggested that the NCP and Congress should try to have a shot at power and think about some sort of indirect association with the Sena. The Congress had so far maintained that the people's mandate for the alliance was to sit in the Opposition and it would respect that.

"It is very unfortunate that in a very important state, the second biggest state in the country, we still don't have a government. A pre-poll alliance was formed by the BJP and Shiv Sena. That alliance received the people's mandate but because of internal politics, both parties are not interested in forming the government. This is absurd and unprecedented. The Congress and NCP were very clearly voted to sit in the Opposition, but now the NCP and Congress must explore options because India's commercial capital cannot be left without a government," Deora told The Indian Express.

Asked whether the options include a tie-up with the Sena, the former Union minister said, "One option could be that the NCP-Congress form the government and other parties and independents are free to support from outside. The Congress should not compromise on its ideology and value system."

Asked if the Congress would be willing to talk to the Sena, Deora said, "The Congress must be careful not to compromise on its ideology. We should also be careful not to repeat the experiments of Delhi and Bihar. I don't know what Shiv Sena's plans are. They will have to come clean on whether they want to stay with BJP at the Centre and in various municipalities. It is for them to decide whether they want to break their alliance."

While the Congress had let AAP form the government with its outside support in 2013, in Bihar Nitish Kumar became the **Chief Minister with Congress** and RJD support. Deora hinted that it should be the other way around in Maharashtra.

Since the BIP and Sena are not able to form the government, Deora said, the Governor would have to invite the next party or alliance. "In the latter's case, it is Maha Aghadi - NCP and Congress. I personally believe that BIP-Shiv Sena have left Mumbai and Maharashtra hanging by a thread by rejecting the peoples' mandate and not forming the government."

However, he said, "No conversation can happen with parties if they are still part of the NDA."

"You can't be in two different marriages at the same time... So all parties will have to decide what is their ideology and motivation. Then I think one option could be for the NCP and Congress to take the initiative to form the government. We are together as an alliance and we have more numbers than anyone else, including the Sena individually," Deora said.

"Maybe other parties can consider supporting us from outside. We should be able to bring in like-minded parties supporting us from outside and inside in order to provide stable governance for five years. After the Governor invites us, it is for others to decide. When the UPA government was formed, parties that were not part of the pre-poll alliance wanted to support us."

Asked whether the Sena would agree to this formulation, he said, "They will have to choose between a rock and a hard place."

Rs 25-50 cr being offered to MLAs to switch: Cong

AMID NO breakthrough in the stalemate between BJP and Shiv Sena over government formation, Congress leader Vijay Wadettiwar on Friday claimed that sums of "Rs 25 crore to Rs 50 crore" were being offered by the BIP to party MLAs to switch sides in Maharashtra.

"Some of our MLAs have been approached by BJP. We have asked our MLAs to record these calls as evidence. I am sure that none of our MLAs will switch over because if anyone does, we will put up a combined Opposition candidate against that person and ensure that he never wins an election," Wadettiwar said.

He went on to name Congress's Igatpuri MLA Hiraman Hoskar as one of those who had received such a call.

When contacted, Khoskar claimed that he had not received a call from any political leader but from intermediaries. "I have not received any call. However, I was approached by certain intermediaries who are known to me... they asked me to come to Mumbai, claiming that they wanted to discuss the polticial situation in the state. I found it suspicious and declined to do so. I have informed my party leaders about this."

WITH THE deterioration in the relationship between the BJP and Shiv Sena, NCP chief Sharad Pawar has become the rallying force with leaders from across political lines lining up to meet him.

The entire top brass of the Maharashtra state Congress met Pawar at his residence in south Mumbai on Friday. Shiv Sena leader Sanjay Raut too met Pawar twice in the day — once early in the morning and later in the evening after Chief Minister Devendra Fadnavis submitted his resignation and criticised the Shiv Sena for its reluctance to

hold talks with the BJP. The NCP has finished third in the elections, but it was largely due to Pawar's assertive leadership that the party managed to improve its winning tally from 41 seats in 2014 to 54 this year. Pawar's power moves over the past week has consolidated his position as one of the leaders who could trip the BIP in Maharashtra with his political

Manjhi walks out of alliance, cites Tejashwi's 'ineffective' leadership

FORMER CHIEF minister litan Ram Manjhi's Hindustani Awam Morcha (Secular) walked out of the RJD-led Grand Alliance in the state on Friday, citing the "ineffective leadership" of Tejashwi Yadav.

On the other hand, the CPI and CPI(M) agreed to participate in a protest rally of alliance partner Rashtriya Lok Samata Party (RLSP) later this month, signalling the possible entry of the Left into the opposition alliance.

HAM (S) has not been on good terms with the RID after its candidate in the recent Assembly bypolls from Nathnagar lost to the JD (U) by a slender margin. The RID had blamed the loss for HAM (S) fielding its candidate. "We had been under pressure from workers to chart our own course," Manjhi had said.

Confirming the exit, HAM(S) spokesperson Danish Rizwan told The Indian Express: "Leader of Opposition Tejashwi Yadav has been invisible as the main Opposition voice. His leadership

is ineffective. He has not been able to take along his alliance partners."

Rizwan hinted at a fresh tieup for HAM (S), but ruled out chances of going back to the ruling NDA.

After winning just one seat in the Assembly elections in 2015, the party had tied-up with RJD for the Lok Sabha polls in 2019. The alliance however, failed to make an impact. But Manihi remains an influential leader in the Magadh belts of Gaya and Jehanabad and areas of Purnia

While the absence of RJD leader Tejashwi Yadav at the press meet triggered speculation, IMM leader Hemant Soren said in reply to a question, "We have been discussing with RJD. Tejashwi ji is aware of the nature of alliance. He has some questions which will be dealt on time."

Asked if the Left parties are out of the alliance, he said, "Please wait and watch." Seats may be later given to Left parties at a later stage from the Congress, JMM or RID share, he said.

It was announced that the RJD will contest Deoghar, Godda, Koderma, Chatra, Barkata, Chhatarpur and Hussainabad seats. For Congress and JMM, seat distribution for only the first phase was announced.

Thirteen seats are set to go to

polls in the first phase. Out of them, Gumla, Bishunpur, Lohardaga and Manika are reserved for Scheduled Tribes (ST) and Chatra, Latehar, Chhatarpur are reserved for Scheduled Castes (SC). The remaining six are Panki Bishrampur, Daltonganj, Hussainabad, Garhwa and Bhawanathpur. Out of these, the Congress will contest Lohardaga, Manika, Panki, Daltonganj, Bishrampur and Bhawanathpui and IMM will be fielding candidates at Gumla, Bishunpur, Latehar and Garhwa. RJD will contest Hussainabad, Chatra and Chattarpur.

Sources in the Opposition said feedback from the people had indicated that an alliance would put up a better fight against the BJP. But leaders of both Congress and JMM agree that the conversion of votes in favour of alliance candidates would be a challenge.

WITHDRAWAL OF SPG COVER

Cong slams govt: 'Playing with lives of Gandhis'

CONGRESS LEADERS and chief ministers on Friday hit out at the Central government over its decision to withdraw the Special Protection Group (SPG) cover given to Congress president Sonia Gandhi and her children Rahul and Priyanka.

"The BJP has descended to the ultimate personal vendetta mechanism, compromising the lives of family members of two former Prime Ministers to acts of terror and violence," senior Congress leader Ahmed Patel said. His party colleague Anand Sharma said the decision was "shocking and vindictive".

The party asked the government to explain the basis of the decision. "It makes the family vulnerable. Don't forget that two members of the family — Prime Ministers Indira Gandhi and Rajiv Gandhi — were assassinated. The state has a duty to protect and SPG cover was not a favour. The UPA government never withdrew Atalji's cover," Sharma said.

The Congress released a letter that four senior leaders — former Prime Minister Manmohan Singh, A K Antony, Ahmed Patel and M Veerappa Moily — had written to the Cabinet Secretary on November 5 asking the government to treat security matters of the three in a non-partisan manner. They had argued that "any change in the status of their security prejudicial to the three protectees... shall be malafide and... shall be an ill-advised act of commission on the part of which, government which would place their lives in danger and under direct threat."

Addressing a press conference, Congress communication department head Randeep Surjewala said the SPG had written to Rahul four times on the threat perception. "On August 6,

2018, November 6, 2018, June 06, 2019 and August 29, 2019, the same SPG, on a review of the security protectee Rahul Gandhi in tandem with Intelligence Bureau, Research and Analysis Wing, wrote to him saying there is a threat perception to his life from Islamic terrorist group, from Khalistani terror group, from ultras and Naxalite groups active from Chhattisgarh up to

Govt may invite Brazil President as chief guest for 2020 R-Day

THE GOVERNMENT is considering inviting Brazil President Jair Bolsonaro as chief guest for the Republic Day celebrations in 2020, sources have told *The Indian Express.* They said the proposal is being explored and may take final shape.

Prime Minister Narendra Modi is set to meet Bolsonaro next week when he visits Brasilia for the annual BRICS summit on November 13 and 14.

Bolsonaro, widely seen as a far-right firebrand and a political outsider, was sworn in as the 38th president of Latin America's largest democracy early this year. If he is invited, this will be the third time a Brazilian

President will be chief guest at the Republic Day celebrations, after Fernando Henrique Cardoso in 1996 and Luiz Inacio Lula da Silva in 2004.

During his visit to Brazil, the Prime Minister will also hold a bilateral meeting with Bolsonaro. This will be the Prime

Minister's second visit to Brazil. New Delhi has been weaving strategy with hospitality to decide its chief guests for the Republic Day. The choice of chief guest every year is dictated by a number of reasons — strategic and diplomatic, business interests and geopolitics.

This year, after the invitation to US President Donald Trump did not work out, South Africa's President Cyril Ramaphosa was invited as the chief guest. Ten leaders from ASEAN countries were invited in 2018.

Prior to that, then US president Barack Obama attended it in 2015, French President Francois Hollande in 2016 and Crown Prince of Abu Dhabi Sheikh Mohamed bin Zayed Al Nahyan in 2017.

Modi and Bolsonaro have met

a few times this year, including on the sidelines of the G-20 summit and the recently-concluded Future Investment Initiative business forum in Riyadh.

Bolsonaro had congratulated Prime Minister Narendra Modi on the latter's re-election in May 2019. When they met on the sidelines of the G20 Summit in Osaka on 29 June 2019, key issues of bilateral importance were discussed during the meetings.

Man held as **Uttarakhand MLA** alleges he tried to set him on fire

Protect human rights of illegal immigrants in detention: HC to Karnataka govt

EXPRESS NEWS SERVICE BENGALURU. NOVEMBER 8

THE HUMAN rights of all illegal immigrants detained by police in Karnataka must not be violated and they should be provided all basic necessities until they are deported to their home country, the Karnataka High Court told the state home de-

partment on Friday. A single judge bench of Justice KNPhaneendra was hearing the bail plea of two alleged illegal Bangladeshi immigrants, Babul Khan and Tania, who were arrested last year.

The directive comes in the wake of the detention of 60 illegal Bangladeshi immigrants, including nearly 40 women and children, by Bengaluru Police in a special drive on October 25 at the prodding of the new BJP government in Karnataka. Karnataka Additional Chief

In an affidavit, Goel said that a detention centre meant to house illegal immigrants is still in the process of being set up and would be ready only in early 2020. Goel told the court that illegal immigrants in the state would be kept in properties leased by the state until the detention centre is operational.

The court said that once someone is found to be an illegal immigrant, "it is an offence if they are found to be out in the open". "The court should not be

Appearing on behalf of the Union Home Ministry, the additional solicitor general said the new detention centre in Bengaluru will provide facilities to the detained immigrants as per a manual brought out by the ministry.

Karnataka Additional Chief Secretary (Home) Rajneesh Goel told the court that once a detention centre is set up, it would be the responsibility of the MHA's foreigners registration regional office to look after the welfare and deportation of the illegal immigrants.

The case was adjourned to November 18 to enable the state government to provide all details of facilities that will be provided to illegal immigrants at temporary homes and the rules for such detention.

The alleged presence of a large number of illegal Bangladeshis in Bengaluru has become a political issue and source of confusion since the BJP came to power in Iuly, with Home Minister Basavaraj Bommai saying a National Register of Citizens will be introduced to check illegal residents and police commissioner Bhaskar Rao warning against sheltering suspected immigrants.

In the Karnataka High Court this week, state authorities, however, indicated that official records show the presence of only 373 illegal residents from Bangladesh in the state with 127 released on bail after their detention.

Prone to misuse, will damage media freedoms: Editors Guild to Andhra govt

Urges state govt to withdraw order, minister says govt only wants media to have proof

EXPRESS NEWS SERVICE HYDERABAD. NOVEMBER 8

THE EDITORS Guild of India on Friday issued a statement expressing concerns over Andhra Pradesh government's decision to delegate powers to the secretaries of different departments to initiate action against the media over any news item they consider defamatory.

On October 30, the Andhra Pradesh government had issued GO 2430, granting permission to secretaries of all departments to issue rejoinders or file defamation cases over any news item in print, electronic and social media if "baseless and defamatory news with malafide interest"

against the government is published. "The Guild believes that such

blanket powers to top civil servants in each of the departments will be prone to misuse and their rampant application will do grievous damage to the freedoms of the media. The Guild has always upheld the principles of free, fair and responsible journalism. But such powers, earlier exercised only by the information commissioner, are now delegated to all secretaries and this will seriously undermine the functioning of the media," the statement said.

"The Guild urges the Andhra Pradesh government to withdraw this order. Criminal defamation is bad enough by itself, in the hands of individuals. If the state were to employ it with its own limitless resources, it will amount to censorship by another name," read the statement signed by Guild president Shekhar Gupta, general secretary AK Bhattacharya and treasurer Sheela Bhatt.

The Press Council of India had also taken suo motu cognizance of the order on November 2. PCI Chairman Justice Chandramauli Kumar Prasad had expressed grave concern over the government's order. "The chairman is of the view that the threat to prosecute media personnel in general shall demoralise the journalists in large which shall have a severe bearing on the freedom of press. Not

only this, the problems which the order in question seeks to redress can very well be remedied by the Council itself," a PCI statement said.

However, state Minister for Information and Public Relations Perni Venkataramaiah defended the order, stating that if any section of the press makes baseless statements against a department, the department head has to send a factual rejoinder. The newspaper or the TV channel has to disclose the rejoinder to the people, the minister said. "If the newspaper or the TV channel does not disclose the rejoinder, the government would issue a legal notice and go to court... This was the crux matter of the GO. What is wrong in this and where was the government muzzling the freedom of the press? What the government wants is that the media should have proof when it is making allegations and they should not be baseless," he said.

"Earlier, the Commissioner of Information and Public Relations had the authority to go to court, on behalf of the respective departments. Now, the GO has been modified and the special powers have been given to the top officials of the respective departments with Cabinet approval. Any person, company, or government can go to court in case of any injustice,' said Andhra Pradesh Public Policy Adviser K Ramachandra Murthy.

Soldier killed in Pak firing as Army foils infiltration bid

A SOLDIER was killed on Friday in crossborder firing from Pakistan as the Army tried to stop an infiltration attempt at the Krishna Ghati sector in Poonch district of Jammu and Kashmir, an Army spokesperson said.

Identifying the dead soldier as Sepoy Rahul Bhairu Sulagekar, 21, from Karnataka's Belagavi district, Defence Ministry spokesperson Lt Colonel Devender Anand said, "On the intervening night of November 7-8, Pakistan Army violated the ceasefire. This was accompanied by suspicious movement of terrorists, abetted by the Pakistan Army, in the Krishna Ghati Sector."

"Observing suspicious movement, effective engagement of terrorists and Pakistani posts was carried out by own alert troops," he said, adding that in the following exchange of fire, Sepoy Sulagekar sustained gunshot wounds and was evacuated to the nearest medical aid centre. However, he succumbed to his injuries. He is survived by his mother.

The body has been handed over to his family, officials said.

J&K yet to decide on allowing congregation at Hazratbal on Prophet's birth anniversary

AS PEOPLE across Kashmir Valley prepare to commemorate the birth anniversary of Prophet Muhammad on Sunday, the police and civil administration are in a fix. Every year, thousands assemble at

Srinagar's Hazratbal shrine for a glimpse of a strand of the Prophet's hair on his birth anniversary.

Given the situation in the region, the government is vet to decide on whether to allow such a large congregation or to impose restrictions — both situations have the potential to stir up tensions. "It is a huge challenge for us," a senior police officer told The Indian Express. "The

situation is tricky both ways. On the one hand, we can't afford such a huge assembly of people, and on the other hand, it is almost impossible to stop people from visiting Hazratbal shrine that day." The Prophet's birth anniversary is celebrated on the 12th day of the third month

of the Islamic calendar — November 10 this year. While thousands stay awake through the night and offer prayers at Hazratbal, huge gatherings are organised at several shrines and mosques across the Valley. Last week, the government prevented

people from offering prayers at the shrine of Naqshband Sahib in Srinagar's old city, resulting in clashes and stone-pelting. The government's decision had triggered outrage in the Valley. Sunday's congregation at Hazratbal

SC to hear CBI plea against relief to Jaising NGO on November 14

THE SUPREME Court on Friday said that it will hear on November 14 the CBI's appeal challenging the Bombay HC order restraining the agency from taking coercive steps against senior advocate Indira Jaising's NGO Lawyers Collective in an alleged Foreign Contribution (Regulation) Act violations case.

A bench headed by Chief Justice of India Ranjan Gogoi said there was another PIL seeking action in the matter and both will be heard together.

The HC had granted the relief to the NGO while hearing a plea seeking quashing of an FIR registered by the CBI against it. Challenging this, the agency said that the HC order effectively "is an order granting anticipatory bail to the accused/Respondents as contemplated under Section 438 CrPC; that too without satisfying the mandatory condi-

The CBI pointed out that the apex court in a 2017 case "had unequivocally held that it is impermissible in law for the Courts to pass interim orders directing the investigating agency to take 'no coercive steps' against the accused while exercising 482 CrPC or Article 226 jurisdiction as the same amounts to an order granting anticipatory bail under Section 438 CrPC, passed without satisfaction of the conditions of the said provision, and as such, any order of such nature is completely unsustainable and bad in law".

The HC could only have stayed the investigation after coming to a definite finding that the FIR is unsustainable and bad in law, it added.

The HC had passed the interim "order on a completely untenable reason that the FIR is based solely and entirely on the inspection of Report of 2016", the CBI's appeal said.



Ramakant Gundecha died on Friday. The younger of the two brothers was on a train to Pune when he suffered a heart attack.

"It's shocking, and I find it difficult to believe he is no longer with us. We started learning to-

gether in Bhopal. He relentlessly worked for the cause of dhrupad in India and worldwide. This is an irreparable loss for the world of dhrupad and Hindustani music," said dhrupad exponent Uday Bhawalkar, whose association with the Gundecha Bandhu goes back to 1974, to Ujjain, where they first met and understood the basic concepts

ing a raga under a rigid composi-

of music.

tion and rhythm structure, and is sung or played on a rudra veena with a pakhawai and tanpura. *Dhrupad* is a more rigid form than *khayal* or *thumri*, in which the rhythm can vary. It isn't folk and erotic like a thumri. and does not have taans and sargams like a khayal. The meditative, leisurely pace of the music had in the last few years reduced the takers of the dhrupad, but the Gundechas along with the Dagar family have been at the helm of a revival of the genre, which originated in the 12th century and is said to be the oldest surviving form of classical music in India.

Unfortunately, the most dedicated audience for the art form is not in India but cities in Europe, where *dhrupad* concerts are regular. However, the very vocal Ramakant always aimed at the revival of dhrupad and attempted to do it with his brother by making their performances less academic and more lucid and melodic. The two brothers were awarded the Padma Shri in 2012.

"They created the muchneeded new compositions in dhrupad. It's devastating news. The world of *dhrupad* will never be the same again," said dhrupad vocalist and Ramakant's gurub-

hai Pt Nirmalya Dey. Madhya Pradesh Chief Minister Kamal Nath expressed his condolences. "Padma Shri Ramakant Gundecha made his mark in *dhrupad* singing across the world. He won many prizes for his talent. The entire art fraternity is in shock by his death," he said.

It could, therefore, be efficient to couple efforts to reduce anaemia among men with existing efforts that target anaemia among women and children," said Oliver Didzun, lead author of the study.

In 2018, India launched Anemia Mukt Bharat, which aimed to reach children, pregnant women, women of reproductive age and male and female adolescents. "Given the inexpensive treatment of many common forms of anaemia and the condition's effect on economic productivity, policy makers in India might want to consider extending some components of the Anemia Mukt Bharat programme to men..." researchers said in the study.


It needs to hound and victimise a writer to feel strong and decisive

T SHOULD BE deeply embarrassing to the Ministry of Home Affairs in India to be shown up as a petty-minded witch-hunter like this. (It should be deeply troubling to the rest of the country if the MHA isn't embarrassed). The ministry has put out, officially, that the Overseas Citizenship of India (OCI) card of British-born journalist and writer Aatish Taseer is being cancelled because he concealed the fact that his late father was of Pakistani origin, and because Taseer had failed to dispute the notice sent to him which asked him to explain this "lapse" in information. To counter the second claim, Taseer has tweeted out a picture of an email exchange between himself and the Consul General where he objected to the ministry's claim — the full 21 days to reply were not given to him, he pointed out, only 24 hours. And on the first charge, surely the mandarins of MHA need to read more, or at least, be better informed about what is being written and read. Aatish Taseer has written about his father, Salmaan Taseer, governor of Pakistan's Punjab who was assassinated in January 2011, extensively, including in his 2007 book, Stranger to History: A Son's Journey through Islamic Lands. As he wrote in a later essay: "The line that had gone through Punjab affected me directly. No nostalgia, no bittersweet ironies for me: I had a parent on one side and a parent on the other".

But then, the powers-that-be in the MHA do read. By all accounts, they have read Taseer's profile of Prime Minister Narendra Modi in *Time* magazine earlier this year, in May, during his re-election bid, titled "India's Divider in Chief". They have read it enough to be provoked by it to show Taseer the border. They are provoked by it enough to lose sight of how small and insecure they are making themselves look by drawing a line to keep out a writer who writes about his hybrid identity and about the idea of India in affectionate and generous ways. In doing so, they make India, the country he spent formative years in, look more like the Pakistan he travelled to, and discovered, only later in life — the home of the idea of a utopia "animated far more by the wish to purge than to build". Of course, Taseer also found it in himself, and in Pakistan, to revise that view. To widen his lens in order to see the country through its more complicated realities and its people, beyond the "endless contradictions" that are also "self-wounding" as they seek to kill off a shared past with India.

As it tries to cut Taseer off from a country he calls his own, a country that is therefore his, the Indian government only attracts unflattering attention to itself. The controversy about Taseer's citizenship is not about the obscure and antiquated law, the Citizenship Act of 1955. It is about the mighty Indian state that apparently needs to hound and victimise a writer to feel strong and decisive.

AS I SIT down to write this, I still find it hard to believe that a prime minister whom I have openly supported for more than five years has allowed his government to exile my son. When the notice arrived from the home ministry, three months ago, asking Aatish to explain why his status as an Overseas Citizen of India (OCI) should not be revoked on the grounds that he had not revealed that his father was Pakistani, my first reaction was to call the home minister.

I thought there was some misunderstanding and wanted to clear it up. I wanted to show him a document in my possession that shows that when I brought Aatish to live in India in 1982 as his sole legal guardian, he was given permission till the age of 18. His father's name is on the affidavit I signed. When he turned 18, I tried to apply for another indefinite visa and was advised by the officials to get a PIO card instead. This I did and nobody asked me if his father was Pakistani. In any case, this was irrelevant since neither Aatish nor I were in touch with his father. I thought if I explained all this to the home minister, he would be supportive.

My calls to the home minister were ignored. So I then tried to call Hiren Joshi who, as the prime minister's man in charge of the media, has an obligation to at least return the calls of a journalist. He refused to come on the phone. I wrote him several e-mails. They were also ignored. It was then that I realised that somebody very high up wanted revenge on Aatish. This had been a niggling fear at the back of my mind ever since he wrote that article in *Time* magazine that appeared on the cover with a distorted sketch of Narendra Modi and the words, "Divider in Chief".

I remember telling Aatish, then, that the

article was inaccurate and ill-timed because this was in the last week of the Lok Sabha campaign and there were clear indications to me that Modi would be winning a second term. The title of the piece was offensive but the content should have offended Rahul Gandhi more than Modi because in it the then Congress President was described as "an unteachable mediocrity". In any case, it was only after this article appeared that the plot to exile my son began to unfold. Modi's troll army on Twitter went ballistic and it was not long before Aatish was being described not just as a Pakistani but as an ISI agent and a jihadist. The inevitable happened yesterday

when Twitter was used to inform Aatish that he was no longer entitled to an OCI card because he had "lied" about his father's nationality. The truth is that neither he nor I have ever lied about it. Salmaan Taseer's mother was English and as far as I know, Salmaan had a British passport since as a Pakistani he is allowed dual nationality. Aatish was born in London in 1980 and British law at the time allowed him to become a full British citizen. We got him a British passport because of the hope that it would make it easier for him to go between India and Pakistan. My relationship with Salmaan ended badly soon after and I brought Aatish back to India. He did not meet his father till he was an adult.

Bringing him home to India as a baby made my family less disapproving of my "mistake". Financially, the only support I had was the job that MJ Akbar gave me in *The* Telegraph as soon as I returned home and told him I needed work. What I earned was not enough to live on. My mother helped by paying the rent of my barsati in Golf Links. And, my sister and my friend, Vasundhara Raje, helped financially whenever I was too broke to get through the month. Luckily, my sister's twins are only two years older than Aatish, so there was a regular supply of clothes. And, as I wrote in my book, Durbar, the only really nice clothes Aatish had as a child came from Sonia Gandhi. We were friends then and she helped, as did my other friends, in whatever way they could. But grateful as I am to all those who helped me through those difficult years, I have to say that I would not advise any woman to become a single mother.

To return, though, to the exile that Aatish now faces, I have to say that I am truly horrified that this was done without my even being given a hearing. Of course, as the BJP's Twitter trolls tell me gleefully, I could go to court. But, I am not sure that I can afford to spend the next 10 years fighting a legal battle against the mighty Indian state. Even as I write these words, my heart goes out to those people whom the home minister calls "termites" who may actually be Indian "termites" but will probably spend the rest of their lives in detention centres because if I cannot afford a legal battle, how can they.

Let me say as clearly as possible that I believe what has happened to Aatish is not just wrong but evil, just as what is happening to the desperately poor people who are running around trying to prove their Indian citizenship is evil and wrong. The damage done to India's image as the world's largest democracy is incalculable.

NOT CRICKET

Players involved in fixing are only most visible part of a malaise that spreads far beyond, must be urgently addressed

HE SKELETONS KEEP tumbling out of the Karnataka Premier League with players and coaches being regularly picked up by the police on charges of matchfixing. CM Gautam is the latest player caught in the police net and indications are that it may be just the tip of the iceberg. No one should be surprised, except, of course, the Indian cricket board which has been silent witness to corruption in officially sanctioned state leagues over the years. This is the board that puts several hurdles in the way of Indian cricketers taking part in county cricket for genuine skill-building experience and stops them from playing in overseas leagues, but has continued to be a silent watcher as its own state association sanctioned leagues are infested with corruption. The players and support staff that form the core of these leagues are the ones who end up in the IPL, from where paths lead to the Indian team — and yet, the Indian board continues to push things under the carpet.

Take the KPL, for instance. It was even stopped for three years when Anil Kumble was the president of Karnataka State Cricket Association. When he stopped it in 2009 because he wasn't happy with the private ownership of the franchise model, Kumble had said: "What is the KPL about? What is the point of it? In its current form, it would allow backdoor entry into KSCA for people not passionate about cricket." And here we are, the backdoor smashed by the gate crashers.

It's easy to criticise the players who have been involved in fixing, but the malaise spreads far beyond them. Karnataka cricket is full of stories about how the system is rigged from the top, a fact borne out by the police who have unearthed dubious owners and those who influence them. The situation has been dire for some time now. There have been cases of captains announcing final playing elevens after the team takes to the field, because they have been suspicious of their own team mates. Some have been spooked by the presence of travelling "fans" from across the country to remote places in the state where the games were held. Even as the police continue to investigate the KPL, the Tamil Nadu state association whose TNPL, too, was hit by the fixing controversy, has given a clean chit after an internal investigation. The pattern seems to be clear: Unless and until the police get into the act, the board or the associations won't do any serious spring cleaning on their own.

LET MONA LISA BE

She continues to trigger conversation, and disagreement, five centuries later

HIS TIME IT isn't the enigmatic smile that has got people talking about Mona Lisa, but a claim that the Musee du Louvre in Paris is worse off for being the home of Leonardo Da Vinci's masterpiece. Millions of visitors troop in to the Louvre, in itself an architectural marvel and heritage structure, just to view the oil-on-wood painting Da Vinci is believed to have completed in 1507. Since the French Revolution, this Renaissance masterpiece has been housed here except for a brief period when it was stolen.

It is being held against Mona Lisa that she overshadows all the other masterpieces in the Louvre, and the magnificent museum itself. True, the glory of Mona Lisa is such that visitors tend to ignore the many great specimens of Renaissance art, Egyptian antiquities and Greek sculptures. The Rembrandts and Raphaels, Rubens and Vermeer, Michelangelo and even the other Da Vinci works fade into the background as the gaze is focussed on Mona Lisa. Yet, many visitors, drawn in by the aura around the painting, leave unimpressed by this relatively small-sized oil-on-wood work. For the informed museum-goer, however, it signifies a moment in art history that can't be ignored. If the great Flemish art in the hall that houses Mona Lisa is largely ignored as a consequence, so be it.

If it is just hype that draws people to her, the crowd will disperse, later if not sooner. There is, however, no reason to force the crowd to exit. Or to take down Mona Lisa from that Louvre wall. Cut out the noise, and the smile will continue to reach out to you. Stay or leave, but let her be on the wall surrounded by many masters.

LONG MARCH THAT WASN'T

Fazlur Rehman's movement seems impressive, but only on the surface

THE PLAN TO hold a "long march" to topple Prime Minister Imran Khan from power was called the "azadi march", a name Khan had chosen for his own agitation against then Prime Minister Nawaz Sharif in 2014. But, in 2019, a long march has not been easy to organise.

The main opposition parties, Pakistan

Muslim League-Nawaz (PMLN) and Pakistan People's Party (PPP), were doing badly after the 2018 election, won by Khan's Pakistan Tehreek-e-Insaf (PTI). PMLN leader Sharif had been convicted of corruption and money-laundering, or not being "sadiq" (truthful) and "ameen" (trustworthy), under the constitution, and sentenced to seven years in jail. The leader of the PPP, Asif Ali Zardari, was picked up for corruption by the National Accountability Bureau (NAB) once again and was facing trial. Both mainstream party leaders were severely, if not terminally, ill: Zardari has already spent 11 years in a NAB jail in the past. But it was neither the PMLN nor the PPP who thought of the "long march" against Khan, knowing that the army — called the "idara" or "institution" stood squarely behind him.

PMLN was divided between the incarcerated Nawaz, who wanted anti-government agitation, and his younger brother head of the party, Shehbaz Sharif — who preferred to wait for the right winds to blow from the GHQ. A letter from prison from Nawaz to the party, however, forced his hand. On the other hand, Zardari, pragmatic to a fault, thought he could marginally support the "long march" and see where it went in the long run.

But the long march was owned by neither party. It was organised and run by Maulana Fazlur Rehman of Jamiat Ulemae-Islam-Fazl (JUIF), a religious party no one thought could ever undertake a protest march with little following among the masses (Fazlur Rehman actually had lost his seat in parliament in the 2018 election). Additionally, the maulana was supposed to be a man of realism, ever staying on the right side of the army which he knew stood behind PM Khan. The kind of mobilisation he finally managed, though, on the outskirts of Islamabad on the first of November, surprised all observers.

The disciplined crowd from the party's religious seminaries or madrasas was estimated at a couple of hundred thousand. Still, even more astounding was the amount of money he could spend — estimated at a billion rupees — on the transport of his votaries. No one, not even expert observers, could have predicted the kind of show in Islamabad where the PMLN's Shehbaz Sharif and PPP's Bilawal Bhutto-Zardari looked like "marginal" politicians seeking the limelight.

Bilawal was upfront with his "selected" accusation — that the 2018 polls were rigged by the army to bring Khan to power, kicking polling agents out of the process while soldiers oversaw the vote-count. Fazlur Rehman was not less emphatic in sarcastically pointing to the support of the army behind Khan who, he said, was totally incompetent as prime minister. He was, no doubt responding to Khan's own uncivilised language about him in the recent past. And, when he threw at Khan the deadline of "two days" - in which Khan was to bow out of power or face "arrest" at the hands of his madrasa followers – everyone knew that the maulana was taking on the "idara" in extremis, which neither of the two parties would be able to do.

However, Shehbaz Sharif let off some accumulated steam accusing Khan of relying on magic rather than Islam: Tangentially referring to Khan's ascetically inclined wife, who is rumoured to be in possession of djinns, making Khan win through supernatural means. Predictably, the army spoke through its Inter-Services Public Relations (ISPR) warning all and sundry that the army would not tolerate the sort of disturbance the "long march" was threatening.

What Pakistan has achieved in its 72 years of existence is the culture of insult. It is a nuclear power where the leaders, and their followers, speak a language unheard of in past civilisations. Some fulmination comes from religion, but not all. And it come equally from the mouths of men and women. For instance, the prime minister's adviser on information, Firdaus Ahiq Awan (the name means paradise) — a heavily powdered volcano emitting fire and brimstone on television. She easily eclipses the PTI rank-andfile vulgarising democracy in Pakistan daily through their harangues.

IOC STRIKE OFF INDIAN OIL WORKERS suspended their 14day-old agitation which had seriously disrupted national economy and hampered drought relief and rabi sowing. The decision was taken by representatives of nine unions and leaders of the Petroleum Workers' Federation in response to the Petroleum and Chemical Minister's appeal. General secretary of the Petroleum Workers' Federation, Y D Sharma, announced that the nine concerned unions all over the country had been advised to suspend the protest action. Though workers are expected to resume work by tomorrow, it will take another week or 10 days before normalcy in the IOC operations is restored.

JANATA LOCAL TIES JAGJIVAN RAM CONFIRMED that the Janata Party would have local adjustments in the

four southern states and Maharashtra and West Bengal, and that it would put up "roughly 400" candidates in the coming elections. Talking to newsmen, he said, "I do not think we will contest all the 542 Lok Sabha seats." He did not think there would be any difficulty in selection of candidates even for the seats not held by the Janata Party in the distorted Lok Sabha. "We have learnt the art of selecting candidates. We have done this for years," he added. Replying to questions, Ram confirmed that the party president, Chandra Shekhar, had left the final selection of candidates for

the seats on which there were sharp differences to him.

US Hostage Crisis

THE MUSLIM PROTESTERS holding some 60 American hostages in the US embassy in Teheran rejected a mediation offer from the Palestine Liberation Organisation, Teheran radio reported. The announcement appeared to dash one of the best hopes for a quick end to the embassy siege, AP reports. As if to underline their determination, an Iranian student set himself afire outside the embassy today, Iran's Pars news agency said. He was hospitalised with serious burns and was given little chance of survival.
