After a heated debate, RS clears Citizenship Bill

The Rajya Sabha on Wednesday passed the contentious Citizenship (Amendment) Bill (CAB), 2019, with 125 votes in favour and 99 The current strength of the Upper House is 240.

The Bill amends the Citizenship Act, 1955, and for the first time, will grant citizenship on the basis of religion to non-Muslim communities from Afghanistan, Bangladesh and Pakistan, who entered India on or before December 31, 2014. It was passed by the Lok Sabha on Monday.

The debate saw fiery exchanges, with Opposition members accusing the government of violating the provisions of the Constitution. The Opposition also added that the legislation could be challenged on legal grounds. Several members also flagged the violent protests against the Bill in Assam and Tripura.

Replying to the debate, Union Home Minister Amit Shah said, "The Bill has no provision to snatch citizenship from anyone but to grant citizenship to the refugees. There is no need for Indian Muslims to live in fear. India has given respect to its Muslim population. This Bill not discriminate against them. India will never be Muslim mukt (free)."

Army deployed in Assam, Tripura as violence spreads

The Army was deployed in Guwahati, Tinsukia and Dibrugarh in Assam and in Kanchanpur and Manu areas of Tripura on Wednesday as protests against the Citizenship (Amendment) Bill, 2019, continued for the second day.

Another column, requisitioned in western Assam's Bongaigaon district, has been put on standby and the paramilitary Assam Rifles have been deployed in the Ananda Bazar area of Kanchanpur, where the situation remained tense following Tuesday's protests.

Army PRO Lt. Col. P. Khongsai said two Army columns have been deployed in Guwahati city and are carrying out flag marches.

As the debate on the Bill commenced in the Rajya Sabha, a relatively quiet morning was shattered by violent clashes across Assam's Brahmaputra Valley, including capital Guwahati.

Railway stations set afire A railway station in Dibrugarh's Chabua, the hometown of Chief Minister Sarbananda Sonowal, was set on fire by protesters late at night. The Panitola railway

station in Tinsukia district was also torched, a Northeast Frontier Railway spokesperson said. The house of Union Minister Rameswar Teli in Duliajan was attacked by protesters and properties damaged.

Curfew imposed

The State government imposed curfew in Guwahati from 6 p.m. "till further notice". Mobile Internet and data services were suspended for 24 hours in 10 districts of the Valley, including Kamrup (Metro), Dibrugarh, and Tinsukia. Internet services were already suspended across Tripura for 48 hours from 2 p.m. on Tuesday.

Though no party or student body had called a shutdown, protesters, a majority of them students, fought pitched battles with security forces at several places, including near the secretariat.

Unlike Tuesday, when people responded to a shutdown called by the North East Students' Organisation, hundreds of people poured onto the streets across the State, protesting against the CAB. The protests soon went out of control as vehicles and public structures were vandalised or set on fire. Police resorted to baton charges and firing of teargas.

2002 riots: Modi gets clean chit from Nanavati-Mehta panel

Report tabled in Gujarat Assembly five years after submission

The Nanavati-Mehta Commission on Wednesday gave a clean chit to Prime Minister Narendra Modi in the 2002 Gujarat riots, in which more than 1,000 people were massacred across the State after a train compartment was torched by a mob, killing 59 pilgrims returning from Avodhva.

The Commission's report was tabled in the Legislative Assembly by Minister of State for Home Pradeepsinh Iadeia, five years after it was submitted to the then government.

The Commission also absolved the State administration, Ministers and police officers of any complicity, direct or in direct, and also ruled out any conspiracy to organise the large-scale riots. It refused to call the

riots a result of any "preplanned conspiracy" or "orchestrated violence"

"There is no evidence to show that these attacks were either inspired or instigated or abated by any Minister of the State," the Commission said in its report, which runs to over 1,500 pages and is

compiled in nine volumes. However, the panel, comprising former Supreme Court judge Justice G.T. Na-

High Court Judge Justice Akshay Mehta, observed in the report that police at some places were "ineffective in controlling the mob because of their inadequate numbers or because they were not properly armed."

On the riots in Ahmedabad city, where a former parliamentarian was among those killed by the rioters, it held that "The police had not shown their competence and eagerness which was necessary" to control the mob violence.

It said, "On an overall consideration of the entire material, the commission finds that the communal riots which followed the Godhra incident were really by way of an aftermath of those incidents." The panel blamed the Godhara train-burning as the trigger for the riots.

Chief Justice wants CRPF security for courts in wake of threats

Jammu & Kashmir High Court Chief Justice Gita Mittal and Judge Rajesh Bindal on Wednesday sought upgradation of security on all court premises in the Union Territories (UTs) of J&K and Ladakh, including district courts, in the wake of threats from militants and strike calls by lawyers.

The judges also asserted that "the J&K police were unable to control the situation and need to be replaced by the Central Reserve Police Force".

Centre claims agreement to end JNU stand-off; no deal yet: students

HRD Ministry says hostel hikes remain, BPL students to get 50% concession

The Centre claimed to have brokered a deal between the administration and the students of the Jawaharlal Nehru University on Wednesday night to end the ongoing stand-off regarding a hike in hostel fees.

However, the JNU Students' Union said there is no agreement as vet. It also asked students not to be affected by rumours of an agreement and said the movement would continue until their demands were

The Ministry of Human Resource Development (MHRD) has been holding talks with the students for the last two days in a bid to end the dispute which has led to mass street protests, police action and a threatened boycott of examinations which are due to begin on Thursday. On Wednesday night, the Ministry circulated a document recording the discussions, stating that agreements have been reached to ensure that normality returns to the campus.

Utility charges

The document stated that the monthly room rent hikes -₹10 to ₹300 for a shared room and ₹20 to ₹600 for a single room – will remain. The students from below poverty line families will get a 50% concession. However, the newly imposed service and utility charges of approximately ₹2,000 per month will be rolled back with the costs to be borne by the University Grants Commission. This fee structure change will be ratified in an inter-hostel admi-

nistration meeting, the document read.

It also said students will call off the agitation while the administration will take a "lenient view" of incidents that have occurred since the protest began almost two months ago. An earlier compromise formula from MHRD on Saturday had proposed that the JNU administration would withdraw all cases against the students. In order to compensate for the lost academic period, the Academic Council will be requested to consider and give relaxation upto two weeks, said the MHRD document. It added that the Delhi High Court orders regarding notification of JNUSU would be followed. "Not only shall the campus return to normalcy immediately but a foolproof system shall be put in

such issues in future," said the document.

A senior official said while JNUSU representatives had agreed to all the decisions in the document, it had still to be passed by the union's general body. The JNUSU said refuted that it had agreed to the "draft" being circulated.

The union said while it was meeting the MHRD and having a dialogue, after patiently putting forward the demands, the administration was doing its best to disrupt peacefultalks. It alleged that some students who were in support of the administration have started attacking those who were against the fee hike. "As this movement has shown, the JNU students will continue to resist in the most democratic manner, in spite of all provocations and acts of violence," the JNUSU said.

High Court directs police to provide security to university V-C, Registrar

JNU seeks contempt action against students, police

The Delhi High Court on Wednesday asked the police to provide security and assistance to Jawaharlal Nehru University's administrative staff, including the Vice-Chancellor and the Registrar, to enable them to enter the main office building, access to which has been

blocked by protesters. Justice Pratibha M. Singh passed the order after the court was informed that the Registrar has been unable to enter the administrative block due to the protest by the students. The court was informed about the situation while hearing a sexual harassment case involving two professors.

Central government Standing Counsel Monika Arora told the court that there was a High Court or-

der of August 2017 directing the students to protest 100 metres away from the administrative block.

The students were also told not to block access to the building. Ms. Arora said as per the order, the police could intervene if the students did not comply with

Delhi government Standing Counsel (Criminal) Rahul Mehra, who appeared for the police, said the agency would comply with the court orders and suggested that the university talk to the students to resolve the

Violated court's order

In a separate application, the JNU has moved the High Court seeking contempt action against its students and the police for allegedly violating the court order bar-

ring protests within 100 metres of the administrative block.

The university said the students violated the court's

August 9, 2017, order. Also, it alleged that dayto-day working has been disrupted since October 28.

It has also claimed that the police also violated the order by refusing and failing to take action to maintain law and order in the university and remove the blockade around the administrative block. The petition has contended that repeated efforts made by JNU officials to enter the administrative block to perform their duties failed as the agitating students turned violent.

The Delhi Congress on Wednesday organised a protest march outside the BJP headquarters on DDU Marg against the Citizenship (Amendment) Bill, demanding its withdrawal. It termed the Bill a "gross violation Constitution".

Delhi Congress chief Subhash Chopra said the Citizenship (Amendment) Bill passed in the Lok Sabha was a direct attack on the Constitution.

"The power-drunk BJP was insulting the Constitution which will create division and an explosive-like situation in the country. This Bill has set a wrong precedent and raised a question mark on the standing of the country before the world," Mr. Chopra said, adding that those who are endorsing the Bill are trying to weaken the secular and democratic fabric of the country.

"This Bill was totally unconstitutional and this is why the Congress workers have come to oppose it," he said. AICC general secretary in-charge of Delhi P.C.Chacko appealed to the workers to be prepared for a sustained fight on this issue.

Congress, Left parties oppose electoral bonds, say it distorts political scenario

'New rules under RTI Amendment Act will dilute RTI Act'

While warning that electoral bonds encourage crony capitalism and distort the political playing field, the Congress and both major Left parties vowed to continue opposing the scheme during a Jan Manch or people's gathering organised by the National Campaign for People's Right Information Wednesday.

Congress MP Rajeev Gowda pointed out that while the BIP had claimed that donors would remain anonymous under the scheme, information accessed by RTI activists showed that the government can track details through SBI (the state-owned issuing bank) and the serial number on the bonds. It's not surpris-

ing that the BJP has been the biggest beneficiary, with 90% of known donations, he said, demanding that the scheme be scrapped and the names of all donors released into the public domain.

Yechury files plea in SC

The electoral bonds scheme encourage crony capitalism, said Communist Party of India (Marxist) leader Sitaram Yechury, noting that he has filed a petition in the Supreme Court seeking abolition of the scheme. Communist Party of India leader D. Raja said that schemes like the electoral bonds were completely skewing the political scenario, adding that the challenge ahead is to fight

money power in politics. Free and fair elections cannot be ensured without ensuring a level playing field amongst parties in terms of resources and funding, he said. The political leaders also opposed the new rules under the recently enacted RTI Amendment Act, saying that it would dilute the RTI Act. Delhi residents at the Jan Manch spoke about how the government put them through hardships during demonetisation in the name of fighting corruption even while pushing electoral bonds which is an instrument for money laundering. When the government wants citizens to account for their income and switch to digital payments, why are political parties not disclosing details of who is funding them, asked a resident.

Fearing action, owners of illegal units shifting at night

Move comes after verification drive begins at Anaj Mandi

Days after a massive fire ripped through a four-storey building housing illegal manufacturing units at Anaj Mandi, owners of the illegal manufacturing units in the area are moving out at midnight fearing action from civic agencies. The fire had claimed 43 lives.

A police officer said that owners of illegal units operating from residential premises have started moving out after a joint team of MCD, BSES, police and district administration kicked off a verification drive in the

"We have arrested Suhail, brother-in-law of the building owner Rehan. Suhail also owns two units in the building. A total of 18 manufacturing units were operating from the building. Imran, brother of Rehan is absconding. He will be arrested soon," said the officer.

During investigation, it was found that a total of seven commercial electricity meters were installed in the building. The top two floors of the building were constructed illegally.

"We have recovered hard disks of CCTVs installed in each floor of the building for investigation. Except for one hard disk, all other disks got

damaged in the fire. It has been sent to forensic science laboratory to retrieve data," the officer added.

Sealing drive

Meanwhile, the North Delhi Municipal Corporation (NDMC) on Wednesday wrote a letter to the Delhi police seeking security assistance while carrying out sealing drive in Sadar Bazar and Paharganj area.

On Wednesday, a team from the North body surveyed Sadar Bazar and Paharganj areas and ordered shutdown of 45 units operating illegally. "We have closed 45 units, four units were sealed and show cause notices were issued to 23 units operating in the area. The team faced resistance in Karol Bagh but managed with

the help of police. North bo-

dy will conduct similar drives in other areas falling under its jurisdiction," said a senior officer with North

A team of senior officers from BSES also surveyed the building in Anaj Mandi where the fire broke out on Sunday. "We have cut off power supply to two buildings for violating norms. A major drive has been ordered across the city to stop misuse of power connection," added the officer.

The police officer said that the accused Rehan and his manager Furkan allegedly told the police that to operate from the building, they reached out to all the authorities concerned, including police, through a local man. Every manufacturing unit operating in the area does the same thing, they said.

Air quality back to 'severe' category

Level of PM2.5 is four times more than safe limit as per Indian standards: CPCB

The air quality of Delhi was back in the "severe" category on Wednesday and is likely to improve by Thursday and further on Friday, according to government-run monitoring agency, System of Air Quality and Weather Forecasting and Research (SAFAR).

On Wednesday, the average level of PM 2.5 - deadly respirable particles - was (265.5 ug/m3) more than four times the safe limit (60ug/m3) as per Indian standards in Delhi and NCR at 9 p.m., according to the Central Pollution Control Board (CPCB). On November 3, the PM2.5 level in Delhi and NCR had hit 625 ug/ m3 - more than 10 times the safe limit. But the level is more than 10 times the safe limit (25 ug/m3) set by the World Health Organisation (WHO).

People are advised to avoid all outdoor physical activities, give morning walk a miss and close windows of rooms. "Stop any A metro train crosses the Yamuna river on a cold and smoggy Wednesday. •R.V. MOORTHY activity if you experience any unusual coughing, chest discomfort, wheezing, breathing difficulty or fatigue and consult a doctor," SAFAR said.

Delhi's Air Quality Index (AQI) on Wednesday was 408, up from Tuesday's 369, according to the 4 p.m. bulletin by the CPCB, which is the average of the last 24 hours.

Nod for revision in metro phase IV funding

Now, Centre and Delhi government to share cost of land in 50:50 ratio

The Union Cabinet on Wednesday approved the revision in the funding pattern of Delhi Metro Phase-IV which will lead to the Delhi government and the Centre sharing the land cost in a 50:50 ratio.

The approval pertains to the three priority corridors which got the Centre's nod earlier this year including the Aerocity-Tughlakabad, Ashram-Janakpuri West and Mulundpur-Maujpur corridors.

The decision was taken at a Cabinet meeting chaired by Prime Minister Narendra Modi.

Currently, the Centre and the Delhi government share the cost of Delhi Metro projects on a 50:50 ratio and with Wednesday's approval, the land cost will also be shared in a similar

A statement issued by the government said that the move was in compliance with a September 6 Supreme Court order and in pursuance of the amendments to the Metro Rail Policy 2017, applicable only for

"The total cost of the project which is ₹24,948.65 crore remains unchanged. The contribution from GOI increases from the existing ₹4154.20 crore to ₹4643.63 crore resulting in a net increase of ₹489.43 crore," the statement read.

Police can use simple Urdu, Persian words while registering FIR: court

HC clarifies it while disposing of a plea challenging police circular

The Delhi High Court on Wednesday clarified that it had, in a previous order, directed that FIRs should be registered in simple language, and archaic Urdu and Persian words could be avoided.

A Bench of Chief Justice D.N. Patel and Justice C. Hari Shankar also clarified that police could use simple Urdu and Persian words while registering complaints.

The Bench made the clarification while disposing of a petition challenging a police circular to its stations to stop the use of 383 Urdu or Persian words while registering

The petitioner, Naima Pasha, claimed that the circular was issued "purportedly" on the High Court's August 7 direction to use simple words while lodging complaints, as some Urdu and Persian words of general use also fi-

gured in the list of 383 terms. "Archaic Urdu and Persian words ought not to be utilised [while lodging FIRs] and that is what we intended to convey by our order of August 7 in a separate pending PIL before us. Urdu and Persian words of general use can

be used," the court said. In a separate petition, the court had on November 25

called for 100 FIR copies to ascertain whether the circular of November 20 was being adhered to. The police on Wednesday submitted the FIR copies before the court which noted that the words prohibited in the circular were still being used while registering complaints.

The court noted that police was taking steps to avoid usage of archaic Urdu and Persian words as it has issued a circular and the FIRs also indicate decrease in use of such terms. The court also asked the police to put up on its website the list of Urdu and Persian words, whose use has been prohibited.

Security guard shoots self accidentally

A 40-year-old security guard, identified as Madan Lal, allegedly shot himself accidentally while cleaning his service pistol in south West Delhi's Kishangarh on Tuesday night, the police said on Wednesday. Delay in setting up fast-track courts: DCW writes letter

The Delhi Commission for Women (DCW) on Wednesday wrote to the Central and the Delhi governments over the delay in setting up of fast-track courts in the national capital.

"The Commission has learnt that there is an acute shortage of fast-track courts in Delhi and as per the latest assessment, an additional 45 fast track courts are required. This is a very serious matter as currently, the fast-track courts suffer from severe pendencies leading to judicial delays having unimaginable consequences on the life and liberty of lakhs of sexual assault survi-

vors," read the letter. The women's commission, in its letter to the Central and State governments, also sought details of fast-track courts that have been sanctioned by the government but not operationalised, number of courts sanctioned and reasons for non-operation alisation of the same.

Additionally, the panel also sought information pertaining to whether or not assessments of any kind on the required number of fast-track courts have been conducted.

Authorities have been asked to provide the information by December 13.

'Register new vehicle when owner shows proof of disposal of old one'

Parliamentary panel makes recommendation in report tabled on Wednesday

Registration of a new vehicle should be done only when the owner produces proof of disposal of the old vehicle and availability of parking space, parliamentary panel on Home Affairs headed by Congress leader Anand Sharma has recommended in its report 'The Management of Worsening Traffic Situation in Delhi' which was tabled in Parliament on Wednesday.

Taking a grim view of the traffic situation in Delhi, the panel has made 107 recommendations based on their consultations with Union Ministries of Home Affairs, Road Transport and Highways and Housing and Urban Affairs and representatives of the Delhi government, four urban local bodies, DDA, Delhi Police and other agencies.

The number of vehicles registered each day in Delhi is growing. The population of Delhi has grown from 4 lakh in 1901 to over 192 lakh now and projected to rise to 225 lakh by 2025. There is 112 lakh vehicles in Delhi accounting for 12.50% of total vehicles in the country. And over 1,700 vehicles are registered each day here, stated

"Registration of new vehicles should be allowed only if the old vehicle is either scrapped or disposed of and if the occupant of a house has parking space," the panel has noted. It also recommended that insurance premium for the vehicles should be connected directly to traffic rule

Expressing concern over old and unfit vehicles plying on Delhi roads, the committee recommended strict action to ensure compliance with the order of National Green Tribunal on phasing out diesel and petrol vehicles of 10 and 15 years vintage respectively.

The panel flagged that public transport falls woefully short. There has been no addition to the bus fleet in the last ten years, the panel said. It has strongly recommended the Delhi government to ensure addition of 6,000 more buses at the earliest. Taking note of poor response to some tenders in this regard, the committee said that there is a need to revise the norms

to invite adequate response. The panel also pulled up Delhi Police, asking them to focus on rule enforcement not only at traffic lights but also to ensure on-road disci-

Acknowledging the positive impact of the Delhi Metro and noting that it has, however, not made much different to the number of vehicles on Delhi roads for want of lastmile connectivity, the panel urged DMRC to undertake multi-modal integration at all the stations besides increasing the fleet strength and frequency, rationalisation of fares and expansion to the unconnected areas.

There should be separate lanes for the VIP traffic, the committee has suggested. 'The Ministry of Home Affairs should coordinate with all concerned to ensure free and safe movement of important persons without inconveniencing the commuters," the report said.

The panel also recommended exploration of dedicated lanes for emergency vehicles like ambulances and fire engines to save precious lives and for two-wheelers as well in view of their substantial number using Delhi

The panel expressed an guish over non-introduction of computer-based Area Traffic Control Systems which is operational in South East Asian countries for 30 years.

In a first, 66 fire officials from city to take part in service games

2nd edition of Indian Fire Services Games will be held in Lucknow

DFS Director Atul Garg confirmed the development and said that the 66 firemen and fire officers will be participating in the games organised by Fire Services Games Association of India, a non-profit organization. The event is scheduled for December 20-22 in Lucknow's Mahanagar.

"There are two purposes for us to send our firemen. One is that our firemen will go, win medals and make Delhi proud. They would also then participate internationally and make the country proud. Secondly and importantly, they will meet firemen from other States and share ideas," Mr. Garg said.

The Director said that the event provides the firemen an opportunity to communicate with their counterparts in other States and

Eatery owner beaten to death by customer for refusing to play cards

Accused has been arrested, murder case registered: police

A 60-year-old eatery owner was beaten to death allegedly by a 24-year-old customer after the victim refused to play cards with the latter in north Delhi's Kashmere Gate, the police said on Wednesday. The accused has been arrested, they said. A senior police officer

said that the accused has been identified as Govind alias Golu, a resident of Kashmere Gate, who allegedly killed Chandra Shekhar Kashyap who owned an eatery in the area. The incident was reported on Sunday and the accused was arrested on the same day, the police said.

The officer said that the victim lived in Kashmere Gate earlier and had later shifted to Karawal Nagar but continued to run the eatery known as 'Shekhar ka dhaba'. The accused would




come to the eatery often and play cards with Kashyap, complainant Mohammed Shahid who used to work at the eatery told the police.

Mr. Shahid told the police that on the day of the incident, Mr. Govind had come to the eatery around 5 p.m. and asked Kashyap to play cards with him. After the victim refused to play, an argument broke out between the two. The argument turned violent and both of them hit each other, Mr. Shahid also said. The complainant and a few others intervened and tried to stop the fight. However, during the fight Kashyap had abused Mr. Govind after which he started punching the victim. Mr. Govind hit Kashyap a few times on his head after which the victim lost consciousness. The accused then fled the

The complainant and another employee rushed Kashyap to Aruna Asif Ali Government Hospital where he was declared brought dead. The police were then informed about the incident.

The police then registered a case under Section 302 of the Indian Penal Code and a probe by a team comprising Inspector U. Balashankaram and Sub-Inspector Satender Singh was conducted. The accused was subsequently arrested on Sunday night, they said.

Nirbhaya case: convict's father seeks FIR against eyewitness

'He charged money to appear in interviews on TV channels'

NEW DELHI The father of one of the convicts in the 2012 Nirbhava case on Wednesday moved a Delhi court seeking an FIR against the only evewitness for allegedly giving interviews to news channels after charging money, claiming it affected the case by "resulting into a media

The eyewitness, a friend of the victim, was accompanying her on the bus when the incident took place. The complaint filed by Heera Lal Gupta, father of Pawan Kumar Gupta, cited some recent media reports which that witness charged money to appear for interviews, said advocate A.P. Singh.

'Independent probe'

"This calls for an independent investigation into the perjury that appears to have been committed by him [witness], being the sole witness, his testimony has strongly influenced the outcome of the case which led to the imposition of death penalty of the accused," the complaint said.

Citing the reports, the advocate added: "On the basis of said facts and circumstances, it is clear that the conduct of him clearly shows that his testimony was false and fabricated... This goes to the root of his testimony and if established would show that the testimony in fact false."

The complaint said based on witness' "false" testimony the accused in the Nirbhaya gang rape case were convicted and given capital punishment. The lawyer told the court that a complaint was filed with the police to lodge an FIR in this regard, however, no action was taken. A Delhi court had recently directed Tihar Jail authorities to produce the four convicts before it on December 13 so that they can apprise the court about the status of their petitions.

Execution of convicts

The court was hearing a plea by the victim's parents who have sought a direction to the jail authorities to expedite the execution of the convicts.

The victim's parents had approached the court saying the convicts have exhausted all legal remedies. In December last year,

Nirbhaya's parents had approached the court to fasttrack the procedure to hang all four convicts in the case. The Supreme Court on

December 12, 2018, had dismissed a PIL seeking direction to the Centre to execute the death penalty awarded to the four convicts in the Nirbhaya gang rape and murder case.

A 23-year-old woman in December 2012 was gangraped and brutalised in a moving bus in south Delhi by six persons.

The woman had boarded the bus in Munirka in south Delhi along with her male friend on her way back home on December 16 that year. After raping and brutalising the woman and beating her friend, the assailants had thrown them out of the bus.

After receiving initial treatment in New Delhi for a few days, she was transferred to Mount Elizabeth Hospital in Singapore, where she succumbed to injuries on December 29,

Delhi govt.'s free pilgrimage scheme suspended temporarily

AAP has blamed BJP for the cancellation of trains

Mr. Sisodia said that he has asked time to meet the Union Railway Minister to discuss the issue and would try to resolve it soon. AAP blamed the BJP for

the cancellation of trains and termed it as "dirty politics", adding that the BJP is "scared of losing the upcoming Assembly election in

Maheish Giri termed the allegations as "cheap politics" and said that it has became a habit of the Delhi government to announce new schemes and hide their failures by blaming the Central government when it [Delhi government] is not able to complete them [Centre]. "The Central government made trains available for the 'Mukhyamantri Tirth Yatra Yojana' during the elections in Karnataka and Jharkhand for troop movements and Mr. Kejriwal is trying to get political mileage from this issue," he said.

A district consumer disputes redressal forum here has directed Air India to compensate MP Devji Patel by paying ₹50,000 for cancelling a ticket booked for travelling from Delhi to Ahmedabad despite the complainant having reached the airport on time.

Directing the airline to pay the settlement amount to Mr. Patel, the consumer Bench said, "It is observed that the mental pain, agony and suffering due to loss of his reputation has to be commensurate with the amount claimed, accordingly the settlement amount of ₹50,000 is totally justified even on merit of the case, inclusive of the mental agony and harassment to the

complainant." The Bench has also directed the airline to pay an additional amount of ₹10,000 as litigation

charges. The directions came when the consumer forum was hearing a plea moved by Mr. Patel, alleging that on reaching the airport an hour before the flight departure, he was informed



that the ticket had been allotted to another passenger.

"The complainant had to attend some important election meeting in Ahmedabad on November 28, 2012 and hence booked an air ticket from the [airline] at the Parliament Ticket Counter. Its departure time was 18:40. The complainant entered the airport at 17:40 where he was informed that his tickets were cancelled by officials of the airline," the Bench observed while noting the allegations.

The airline had, however, contended that the complainant had failed to reach the check-in-counter on time.

FIR filed against 520 AMU students

An FIR has been filed against 20 named and 500 unnamed students of Aligarh Muslim University (AMU) in connection with their protest against the Citizenship (Amendment) Bill on Tuesday night.

Superintendent of Police (City) Abhishek said the students did not seek permission from the city administration. "Some of the student leaders misbehaved with the officers and heckled some constables. An FIR was registered under Sections 188 and 353 of the IPC," he said.

Those named in the FIR include outgoing students' union president Salman Imtiaz and former AMUSU president Faizul Hasan. "It is our democratic right to protest against the violation of the Constitution," Mr. Imtiaz said.

The troops are from the Central Reserve Police Force, the Border Security Force and the Sashastra Seema Bal.

'BJP still hopeful of alliance with Sena'

Chandrakant Patil rubbishes reports of disaffected Eknath Khadse and Pankaja Munde quitting party

With the Maharashtra Vikas Aghadi government of the Shiv Sena, the Nationalist Congress Party (NCP), and the Congress yet to decide on the portfolio allocation, Bharatiya Janata Party (BJP) State president Chandrakant Patil on Wednesday said he is still hopeful of a BJP-Sena alliance in the near future given that the two saffron parties are "natural allies".

'The two parties are natural allies. The Hindutva ideology courses through their veins. We [the BJP and the Sena] have had an alliance for the last 30 years and I am still hopeful of one in the future," Mr. Patil, who is an MLA from Pune's Kothrud, said.

Mr. Patil was reacting to former chief minister and senior Sena leader Manohar Joshi's statement on Tuesday that both estranged parties could come together in the near future and that Sena chief Uddhav Thackeray would take a decision on this at the right time.

"Ideally, both the BJP and the Sena ought to have come together and formed a government after the Assembly poll results were out as we had the mandate," said Mr. Patil, adding the doors for discussion were always open to the Sena and that the BJP had no pride or arrogance in this matter.

The BJP leader quelled suggestions that disaffected OBC leaders within the party Eknath Khadse and Pankaja Munde will be exiting the BJP. "They [Mr. Khadse and Ms. Mundel are not any freshly inducted leaders into the BJP fold but senior and experienced leaders. Mr. Khadse and Ms. Munde had some issues and were upset about certain things which they have confided in me. But this does not mean that they are going to leave the

ideals have been imbibed by Ms. Munde since her childhood, and alleged that rumours of Ms. Munde's alleged disenchantment with the BIP is a mere figment of the media's imagination. "Likewise, Mr. Khadse has been instrumental in building the BJP in Maharashtra along with the late Gopinath Munde. There is no way that he will quit the party."

Eyeing 2024, Shetti announces major organisational overhaul

Party aims to send more legislators to Assembly and one MP

In a major overhaul, Swabhimani Paksha chief Raju Shetti on Wednesday dissolved his party's working committee to rebuild the organisation before the 2024 parliamentary and Assembly polls. Mr. Shetti announced his decision at a meeting of party leaders and workers in Solapur.

The farmers' leader said fresh internal elections will be conducted over the next two months at the zilla and State levels. "The two-year tenure of most of the members in the organisation had come to an end. So, this move to dissolve the present leadership has been taken to build the organisation anew. By January 11 next year, we will have established a new leadership at the village level and by February 11, we will see a leadership at the State level." Mr. Shetti said the revamp will also see the establishment of a disciplinary committee at the divisional level.

The former two-time MP from Hatkanangale in Kolhapur district said the exercise will also factor in the alloca-

tion of responsibilities to new entrants and fresh tasks to experienced leaders.

Mr. Shetti, formerly a constituent of the Bharatiya Janata Party (BJP)-led NDA government, had severed ties with the BIP in 2017 while turning into a bitter critic of the Narendra Modi government at the Centre and the erstwhile Devendra Fadnavis-led government in the

While Mr. Shetti supported the NCP and the Congress in the Lok Sabha polls, the alliance proved costly for him as he was defeated by the Shiv Sena's Dhairyasheel Mane. Mr. Shetti recouped somewhat with his party winning a single seat in the recent Assembly polls. The

Swabhimani Paksha's lone MLA Devendra Bhuyar had emerged as a 'giant killer' to defeat BJP leader and State Agriculture Minister Anil Bonde from Morshi segment in Amravati.

"The organisational overhaul is being carried out with the aim to form a new. young leadership drawn from the youthful ranks. We are hoping to send more legislators to the Assembly and an MP to the Lok Sabha at the time of the 2024 polls," said Swabhimani Paksha leader Anil Pawar.

Meanwhile, Mr. Shetti said his party will support the Sena- Congress-NCP's Maharashtra Vikas Aghadi government, but he will not himself seek the key agriculture ministry portfolio. "We will accept it [agriculture portfolio] only in the event my party is respectfully offered it without any conditions attached," he reiterated. Speculation has recently arisen over the agriculture ministry portfolio being offered to Mr. Shetti, who had denied that a concrete offer in this regard was yet to come from the three big

Discontent among MVA allies delays allocation of portfolios?

As per reports, NCP stalwart Ajit Pawar is in reckoning for the post of deputy chief minister. Ajit, nephew of NCP chief Sharad Pawar, had broken ranks with his party and joined hands with the BJP on November 23 to form a government under Devendra Fadnavis, which lasted just 80 hours. Ajit had recently said that party workers wanted him to be the deputy CM.

Alongside CM Thackeray, Eknath Shinde and Subhash Desai of the Sena, Jayant Patil and Chhagan Bhuibal of the NCP, and Nitin Raut and Balasaheb Thorat of the Congress had taken oath as ministers on November 28. The cabinet expansion will take place after conclusion of the winter session of the State legislature on Decem-

Popular competition prohibits 'sensitive' subjects

The organisers of 'Firodiya Karandak', a popular intercollegiate drama competition, have decided not to allow plays dealing with "sensitive" subjects such as Babri Masjid, Article 370, Hindu-Muslim relations or caste dynamics.

The annual competition, which began over four decades ago and always draws a full house, will be held in the first week of February. Rules for the event were released on Wednesday. "To maintain social har-

mony and law and order, the organisers, from this year, have decided not to permit entries with sensitive subjects like Hindu-Muslim (sic), Jammu & Kashmir, Article 370, India-Pakistan, Ram Mandir and Babri Masjid or subjects that comment on any caste or religion," said a rule. If a group presents a play on any such subject, it would be disqualified, the rules warned.

Chief organiser of the competition, Ajinkya Kulkarni, said, "Being too young and amateur, participants do not have the knowledge and the depth required to handle such sensitive issues. Students are unaware of consequences if something unwar-

ranted is said on this platform, which has a certain legacy, and as organisers, the responsibility lies with us.'

The rules do not say that a play should not mention a particular religion, but it must not create ill-feelings against any religion, he said. Firodiya Karandak is a platform for showcasing artistic talent and not political leanings, Mr. Kulkarni said.

"In the past three or four years, we saw that participants came with subjects which have been done do death, commenting on religious and caste lines," he said. Generally, students favour subjects related to current issues in the country,

"My question to students is, are farmer suicides, drought, economy, unemployment, quality of education not current issues? Why do only subjects with comment on religion and caste interest them?" Virgin Group founder Sir Richard Branson will meet Chief Minister Uddhav Thackeray on Thursday to brief him about the Virgin Hyperloop One project that will connect Pune to Mumbai.

In Mumbai to promote his Virgin Atlantic airline, Mr. Branson said it would be a courtesy call to clear "misunderstandings" and to gauge the new administration's interest in the hyperloop project.

A.P. Cabinet clears Disha Bill to ensure rape verdicts in 21 days

The Andhra Pradesh Cabinet on Wednesday cleared the A.P. Disha Bill, 2019 (A.P. Criminal Law (Amendment) Bill, 2019) paving the way for awarding the death penalty for the offences of rape and gang-rape and expediting the verdict in trials of such cases to 21 days. The legislation is to be tabled in the ongoing session of the Assemb-

The Cabinet also gave its nod for introduction of the A.P. Special Court for Specified Offences against Women and Children Bill, 2019, for dealing with offences against women and children, including rape and gang-rape, acid attacks, stalking, voyeurism, sexual harassment and cases under the Protection of Children from Sexual Offences (POCSO) Act.

anonymity. The proposed laws seek to amend relevant provisions in the Indian Penal Code. 1860, and the Code of Criminal Procedure, 1973, and to introduce Sections 354-E and 354-F in the IPC for dealing with harassment of women through social media and sexual assault of children respectively.

'Strong message'

Under Section 354-E (harassment of women through social media, digital mode or any other form), it has been proposed to sentence the guilty to imprisonment for up to two years on first conviction and four years on subsequent convictions.

Under Section 354-F (molestation / sexual assault), imprisonment is sought to be increased to a minimum of five years and maximum seven vears.

Chief Minister Y.S. Jagan Mohan Reddy told the Assembly on December 9 that he was for speedy trial of rape cases to send the message that the A.P. government was in no mood to tolerate crimes against women and children.

NEW DELHI Chief Justice of India (CJI) Sharad A. Bobde on Wednesday informed petitioners advocates G.S. Mani and Mukesh Kumar Sharma, and the Telangana government who sought an investigation into the extra-judicial killing of four men accused of the gang-rape and murder of a veterinarian in Hyderabad that the court had tapped, Justice (retired) P.V. Reddi to take up the assignment, but he had declined.

Chief Justice Bobde said the court would approach another retired Supreme Court judge for the job.

Plea for CBI inquiry

Mr. Mani's petition had sought a CBI or a special investigation team probe against Cyberbad Police Commissioner V.C. Sajjanar, who is a respondent in the petition. He said the encounter was a red herring, deliberately done to turn public attention away from the police's inability to prevent such crimes against women.

The petitions were filed last week on a day the CJI and the second most senior judge of the court Justice N.V. Ramana both voiced their apprehension over the tendency to seek "instant justice" and "revenge".

"Justice can never be instant and should not take the form of revenge," the CJI said in a speech at the inauguration of a new building of the Rajasthan High Court in Jodhpur on December 7.

The petitions urged the court to call for police records of the case and further order an inquiry into the "killings" in accordance with the Supreme Court's 16 guidelines. As per the police, all the four accused - Mohammed Arif, Chintakunta Chennakeshavulu, Iollu Shiva and Jollu Naveen – were taken to the scene of the crime around 60 km from Hyderabad in the early hours of December 6 for a reconstruction of the crime scene.

The accused then allegedly grabbed the weapons of the police team and opened fire. In the retaliatory fire, the accused died, the police

Stream near Sabarimala foothills hit by pollution

Study detects high coliform content

Faking a dip in the Valiyathodu, a stream that runs through Erumeli, is part of the tradition of the temple town, which hosts lakhs of Sabarimala pilgrims every

However, bathing in the waterbody could expose people to faecal coliform, which is several times over the permissible level (500 units). The issue, attributed to the discharge of partially treated sewage from the toilet complexes here, has triggered concerns of a health crisis in the region.

As per a water analysis report prepared by the Kerala State Pollution Control Board (PCB), the faecal coliform bacteria count in the bathing ghat at Valivathodu was 5,000 units as on November 23.

This volume, according

to officials, has now increased manifold over the last two weeks with the con tinuing discharge of waste.

The PCB has submitted a report to its member-secretary and the Kottayam District Collector proposing action, including environment compensation cost, against the Travancore Devaswom Board.

"Under-treated waste from the STPs run by the TDB is being discharged into the Valiyathodu, a tributary of the Manimala river. Besides posing health risk to those bathing in it, it also serves as a drinking water source for people in Kottayam, Pathanamthitta and Alappuzha districts," said a

senior PCB official. District Collector P.K. Sudheer Babu said a show cause notice had been issued to the TDB based on the PCB report.

Stage set for maiden survey of butterflies in A.P. national park

50 experts from Kerala, northeastern States to participate

The Andhra Pradesh Forest Department and experts from Kerala and northeastern States will begin the first survey of butterfly species in the Papikonda National Park (PNP) on Thursday. The PNP spreads over 1012.86 sq.km. in East and West Godavari

districts. The experts, led by Kerala-based environmental forum Warblers and Waders, will carry out the survey with an aim to record all butterfly species, and also conduct a study on migratory species in the national park in the Papikonda hill range in the Eastern Ghats. Divisional Forest Officer (Rajah-

mundry-Wildlife) Anant Shankar told The Hindu, "The four-day survey, from December 12 to 15, is the maiden survey during which the entire national park will be explored, documenting the butterfly species."

"A total of 50 experts, including ornithologists, have been roped in for the scientific survey. The findings and report will be presented at the 'Conference of the Parties to the Convention on the Conservation of Migratory Species' to be held in Gandhinagar in February 2020," Mr. Shankar said. The exercise will offer a

picture of the existing biodiversity of the park. The diversity of butterfly species would be considered as a health indicator of the park. Declared as a national park in 2018, preliminary studies have recorded over 80 species of butterflies. Forest Department officials say that the park is home to 121 butterfly species as per their internal studies.

'Unsecured wells pose threat to leopards in Karnataka' Study records 27 incidents of other wildlife species falling into open wells in the State

The elusive leopards, which have been deprived of attention in conservation circles, are facing an unconventional threat in Karnataka: unse-

A new paper highlights the high number of incidents of the spotted big cats falling into them.

The paper "Big cat in well: An unconventional threat to leopards in southern India" has been published in the scientific journal Oryx by wildlife researcher and conservationist Sanjay Gubbi of the Nature Conservation Foundation and his team.

As many as 70 incidents between 2008 and 2017 have been recorded by the team. According to the authors of the study, the incidents



were reported from 10 districts and the highest was reported from Udupi district (36) followed by Tumakuru (9), Ramanagaram (8) and Uttara Kannada (8).

The highest number of falls occurred during the

pre-monsoon and monsoon (53%) possibly as a result of lower visibility, especially in high rainfall areas like Udupi and Uttara Kannada, said the study.

The falls in districts like Tumakuru and Ramanaga-

ram were into dry wells, ac-

cording to the study. In most cases, the Forest department rescued them. Twenty-nine (41%) leopards were translocated after medical inspection and treatment, 28 (40%) were released at the same site or were assisted to escape on their own, eight (11%) died as a result of the fall and five (7%) were sent to zoos, with serious injuries.

"These falls can lead to stress, injury, and death of the leopard, and also pose a risk to people if the leopard manages to escape from the well. With leopards being increasingly documented in human-settled areas, any open wells will need to be securely covered to prevent any increase in this emerging threat," says Mr. Gubbi, the lead author.

The other authors are Aparna Kolekar, Pallabi Chakraborthi from the Nature Conservation Foundation and Vijaya Kumara of the Kuvempu University, Shimogga. The researchers also re-


corded 27 incidents of other wildlife species falling into open wells during the same period, including sloth bear, elephant, gaur, sambar chital, muntjac, blackbuck, Bengal fox, mugger and small Indian civet. These incidents resulted in 11 mortalities.

This emerging threat assumes greater importance in the background that the leopard has been recently uplisted from the Near Threatened to Vulnerable by the IUCN Red List.

Heavy metals contaminating India's rivers

Samples from 65% of testing sites unsafe: survey

Samples taken from twothirds of the water quality stations spanning India's major rivers showed contamination by one or more heavy metals, exceeding safe limits set by the Bureau of Indian Standards.

The findings are part of a report, which is the third edition of an exercise conducted by the Central Water Commission (CWC) from May 2014 to April 2018.

Samples from only onethird of water quality stations were safe. The rest, or 287 (65%) of the 442 sampled, were polluted by heavy metals. The other major contaminants found in the samples were lead, nickel, chromium, cadmium and copper. The study spanned 67 rivers in 20 river basins. Lead, cadmium, nickel, chromium and copper contamination were more common in nonmonsoon periods while iron, lead, chromium and copper

Strength in numbers

A flawed collegium system is no reason to hold back appointments to the judiciary

The list of alarming numbers and figures relating to the depleting numbers in India's higher judiciary has a new addition. On December 10, the Supreme Court of India said that 213 names recommended for appointment to various High Courts are pending with the government. Data show that 38% of all sanctioned posts for High Court judges are lying vacant as of December 1, with the High Courts of some States including Andhra Pradesh and Rajasthan functioning at below half their actual capacity. The court has fixed a time period of six months to appoint as judges at least those whose names the Supreme Court collegium, the High Courts and the Government have agreed upon. At each level of the appointment process of judges to the higher judiciary, prior to the names reaching the Prime Minister and President for final approval, there are time periods specified. The Memorandum of Procedure states that appointments should be initiated at least six months before a vacancy arises and six weeks of time is then specified for the State to send the recommendation to the Union Law Minister, after which the brief is to be sent to the Supreme Court collegium in four weeks. Once the collegium clears the names, the Law Ministry has to put up the recommendation to the Prime Minister in three weeks who will in turn advise the President. Thereafter no time limit is prescribed and the process, seemingly, comes to a standstill.

The Supreme Court's recommendation now of a time limit to these appointments is welcome. It is no secret perhaps, that the equation between the court and the Union Government has been strained by the former's decision to strike down as unconstitutional in 2015 the move to set up a National Judicial Appointments Commission which would have been responsible for appointments and transfers to the higher judiciary in place of the Supreme Court collegium. Since then, reports of delays in appointments have become increasingly commonplace, with both sides testy over procedure. Last week, the same Bench of the Supreme Court chastised the government for not acting on another set of nominations on which the government had sent back objections. If the collegium reiterates the names, the court said, the government has no option but to appoint the judges. Such standoffs are now inevitable. As grievous as it is for the government to disrupt the process through delays, it is for the court to take an increasingly firm hand to ensure that the collegium system that it fought so hard to protect, despite flaws, actually functions effectively. Doing so would be in its best interests. Vacancies in the higher judiciary threaten every aspect of the justice delivery system and it is the courts, and very seldom the government, that always take the blame for any shortfall in justice.

Staggering spread

Governments must do more to increase public awareness of vaccine importance

ven as reported measles cases globally during → 2000 to 2018 decreased by 59%, there has been a ✓ spike since 2016. Compared with over 1,32,000 reported cases in 2016, the numbers shot up to over 3,53,000 in 2018. While the numbers in 2018 were more than double the previous year, the numbers in 2019 have already surpassed those of 2018. By mid-November 2019, over 4,00,000 cases were reported globally. Since measles surveillance is generally weak, WHO and the Centers for Disease Control and Prevention resorted to estimating the number of measles cases and deaths. Based on an updated estimation model, there have been nearly 10 million cases and over 1,42,000 measles deaths in 2018. Last year, the Democratic Republic of the Congo, Liberia, Madagascar, Somalia, and Ukraine accounted for 45% of all reported cases. The situation worsened in Congo by November, with a nearly four-fold increase in cases (from 65,000 in 2018 to 2.50,000 in 2019) and over 5,100 deaths. The situation in Ukraine is grim. After a 50% drop in the number of cases in 2018 compared with 2017, the trend has now reversed – 58,000 cases by mid-November this year, which is 4,000 more than in 2018. There has been a decline in the other three countries mentioned that reported the most number of cases last year.

Vaccine hesitancy has been highlighted for the staggering spread in cases globally. In DR Congo, there is low institutional trust, misinformation, vaccine shortage and even attacks on health-care centres and workers leading to the spread of both measles and Ebola. The Philippines and the small Pacific island of Samoa serve as a textbook case of the sudden emergence of vaccine hesitancy. Mass immunisation using a newly approved dengue vaccine in Philippines, before the risks associated with the vaccine were reported by the manufacturer, shattered public trust in vaccines; so low vaccine coverage led to measles and polio outbreaks. In Samoa, an error in preparing the measles, mumps, and rubella (MMR) injection led to the death of two infants. Fear-mongering led to a fall in vaccine uptake, leading to an outbreak of measles. But in many European countries and the U.S., vaccine hesitancy has been on religious grounds and primarily due to anti-vaccination campaigns spreading fake news about vaccine safety. To counter rising hesitancy, about a dozen European countries have already introduced laws making vaccination mandatory. New York City too introduced such a law when the U.S. nearly lost its measles elimination status. Such laws may prove counterproductive in the long run, and the only way to increase vaccine uptake is by educating the public. With 2.3 million children not vaccinated against measles last year, India has much to do to protect its young citizens.

The 'Delhi dogma' fallacy of the right

Minister Jaishankar's rendition of foreign policy is self-congratulatory, critiquing history from the luxury of the present

The 4th Ramnath Goenka Lecture by India's External Affairs Minister S. Jaishankar on November 14 was a much-needed master account of India's foreign policy, told in phases, lucid, analytical and comprehensive. Mr. Jaishankar's speech, which reflects a practitioner's hands-on knowledge of India's foreign policy, has, unfortunately, not yet received the critical treatment it deserves. In his speech, the Minister makes a strong pitch to practitioners and analysts to think beyond the "Delhi dogma" that has traditionally defined, and constrained, according to him, the pursuit of India's foreign policy. Though thought-provoking, Mr. Jaishankar's speech is riddled with several empirical and conceptual issues.

Of, and for the right

To begin with, the speech is a product of a certain messianic presentism of the Indian right that Mr. Jaishankar is a part of. The speech has a heavy self-congratulatory tone aimed at establishing a moral superiority over past governments, as if history began in 2014. To that extent, this is an ideological attempt masquerading as an objective stocktaking of India's foreign policy

The speech makes the cardinal mistake of critiquing history from the luxury of the present, removed from the temporal constraints that forced the decisions of the past: this is a methodological error. When you fuse a methodological mistake with an ideological attempt at

superiority, you get a flawed analysis of the past. While the speech falls short of telling us what the new big ideas of the Narendra Modi government are, it is big on what today's regime thinks went wrong in the past.

One direct result of presentism is the tendency to judge the merit of one's past policies based on current capabilities. To state, for instance, that taking the Kashmir issue to the UN was a mistake assumes that India could have forcibly liberated the princely state of Jammu and Kashmir (J&K) from the Pakistani invasion during 1947-48. At a point of time when the Indian (and Pakistani) Army was still commanded by British officers, it might not have been possible for India to forcibly get back the rest of J&K. The next best option at the time was indeed to go to the United Nations, which it did.

Need for non-alignment

In the early decades of its existence, India was a militarily weak, recently-decolonised state with an array of domestic political and security challenges, with limited resources, and as a result, attempts at carrying out major military campaigns would have been disastrous. And when faced with the whirlwind of the Cold War, it also, and rightly so, decided to be nonaligned. The policy of non-alignment was hardly woolly-headed; it was largely an exercise in realism. Not only that accommodation by a weak power is not weakness, India also benefitted from both the camps. Would becoming a camp follower have helped India against China in 1962? The answer might lie in the Pakistani experience in 1965 and 1971 despite being an alliance partner of the U.S.

Unwilling to appreciate this complex early journey of a weak power is being ahistorical.

Cut to the present. The Minister



dwells at length on India's new appetite for risk-taking, and global positioning. He states that "not all risks are necessarily dramatic; many just require the confident calculations and determined follow up of day-to-day management but their aggregate impact can result in a quantum jump in global positioning. To a certain degree, we see that happening today." Does it mean that India's pre-2014 foreign policy lent it no global standing? Does it also mean that India's global standing, materially and reputationally, has dramatically increased post-2014 especially in the wake of the rather aggressive policies in Kashmir?

Handling China More so, what has been the track record of the much-fabled strongwilled foreign policy of the Modi regime in dealing with China, easily India's biggest strategic challenge today? Mr. Jaishankar's speech seems unsure on how to deal with it even as he offers a strong critique of the Nehru government's handling of China over six decades ago. Does his government have a China policy "today"? Is avoiding the tactical pressure from China (which can have electoral implications) via informal summits and slow peddling the Quad helpful in addressing the long-term China challenge? If indeed our past failures in dealing with China have reached us where we are today, how can being fixated with past mistakes help us frame a better China policy?

The Minister's speech often lacks clarity about what it seeks to advocate. He rightly states, in the context of India not joining the Regional Comprehensive Economic Partnership (RCEP), that "economic autarky and import substitution" are old dogmas, then goes on to argue, that "embracing the new dogma of globalization without a cost-benefit analysis is equally dangerous". This is just smart phrasing, and one is unsure why India was unable to get a deal from the other partners especially China (despite the Chennai connect) and where India stands on the RCEP now and what are the longterm implications for the Indian economy of not joining it.

Foreign policy of any regime, past or present, should be judged on the basis of concrete outcomes. Even as Mr. Jaishankar offers a spirited critique of the foreign policies of previous governments, his speech points towards very little concrete outcomes achieved by the Bharatiya Janata Party-led governments. He argues that "the balance sheet for India's foreign policy after seven decades presents a mixed picture". Notwithstanding the fact that the history of any country's foreign policy performance "presents a mixed picture", it would have been more useful if the incumbent External Affairs Minister were to clearly articulate the foreign and security policy successes of his government. 'Howdy Modi', 'Chennai Connect' and 'JAI' (Japan-America-India) are hardly spectacular outcomes.

I am in agreement when he argues that dogmas can be problematic because "dogma treats every new approach as an unjustified deviation". However, are we to assume that broad themes and consistency in foreign and security policy are necessarily bad ideas? More so, how would the bold claims of a strong foreign and security policy sit well with strategic ambiguity, and tactical and reactive posturing?

Or is it that there is another foreign policy dogma in the making today - the so-called Modi doctrine? If so, is undoing past dogma seen as a first step towards promoting the new doctrine? Is that what Mr. Modi's External Affairs Minister has in mind when he says, "The world that awaits us not only calls for fresh thinking, but eventually, a new consensus at home as well. Putting dogmas behind us is a starting point for that journey"?

Kashmir and Pakistan

The biggest disappointment yet is Mr. Jaishankar's articulation of the Modi government's policy towards Kashmir, and Pakistan. He argues that the concerns of critics' about the internationalisation of Kashmir and hyphenation with Pakistan "is thinking from the past, reflecting neither the strength of India, the mood of the nation nor the determination of the Government". Put differently, he seems to argue that the Government's Kashmir policy is brilliant because India can militarily contain the situation in Kashmir, there is domestic widespread support for a militarised solution to Kashmir, and the government does not bother what the international community thinks about it. Not only does this assessment reek of foreign policy arrogance, it hardly sits well with a government that is acutely conscious of promoting the country's glory the world over. Let alone the fact that its Kashmir policy is proving to be a disaster.

The not-so bright idea of selling the family silver

The Government may not be striking pay dirt in privatising public sector undertakings, especially the profitable BPCL

Then we examine the proposed stake sale of profitmaking public sector undertakings (PSUs), a few strategic issues of national importance need to be considered. The first is an ideological one – that Government must get out of business. The second is the need to bring the fiscal deficit down. The third is a long-term financial one: which option, public- or privately-owned, is better for the Government treasury? A fourth is about national security and self reliance: can India be under pressure if we do not have full control over petroleum? Why do the United States, China and other superpowers have control over their petroleum reserves?

Number crunching

Let us look at the long-term financial issue. The Burmah Shell (Acquisition of Undertakings in India) Act 1976 enabled the Government of India to take ownership by paying ₹27.75 crore. One estimate of that amount in today's terms is to use the inflation factor, which is about 22.42 (between the year

1976 and now). This means that the Government would have paid ₹622.06 crore today. The current market value of Bharat Petroleum Corporation Limited (BPCL) varies between ₹85,000 crore and ₹115,000 crore. The government's share at present is about 53.3% (which it is contemplating selling), that is worth between ₹45,000 crore and ₹61,500 crore. We got the company for a song.

How much has the Government earned meanwhile? Since 2011, the total dividend it has earned is about ₹15,000 crore, which is several times the present value of the investment of ₹622 crore. Let us estimate the present value of all future incomes that the Government would earn. One way is to use inflation and calculate what the value of all future flows would be, based on the present value of all future incomes. The average inflation in the last three years has been 4.5%, 3.6% and 3.48% in 2016, 2017 and 2018, respectively, or an average of 3.86%. If the Government sells its entire stake, it would forego future income of about ₹78,589 crore. In addition the BPCL has also paid taxes of about ₹25,000 crore to the Government since 2011. No doubt the Government will continue to get taxes from the private sector as well. However, the effective tax rate on profits before tax for the BPCL is about 34%, whereas for



the private sector player it is between 25% and 28%. So there will be a loss in tax revenue for the Government after any privatisation.

In summary, financially, we as a nation are worse off by selling such a profitable venture. As the case of the BPCL and several other PSU 'Navratnas' show, they have given super normal returns to the public exchequer. Instead of selling such high performing PSUs, should we not be selling the lossmaking ones?

Issue of fiscal deficit target Another issue underlying the disinvestment is the fiscal deficit target of 3.4%, now reduced to 3.3%. There are many ideological debates among economists about the importance of reducing the fiscal deficit, but we leave that to the experts. Given that revenue collections are not enough, the Government is perhaps planning the sale of well-running PSUs to meet the fiscal deficit target. If the Government does meet its fiscal deficit target by the stake sale of various PSUs including the BPCL this year, how would it meet that target next

year? Note that in spite of the huge one-time dividend from the Reserve Bank of India, we are far from meeting the deficit target. Nothing much will change in terms of the expenditure or revenues in the coming years. These strategic sales and dividends cannot be repeated every year. We will be back to the same levels of fiscal deficit. The real way of meeting this target is to cut out wasteful Government expenditure, most of which is on salaries and pensions, and ensuring that the bureaucracy delivers. Unfortunately, the cuts will be in

On national security

The ideological issue of Government versus private ownership is related to the strategic issue about national security. Natural resources, especially oil, are a strategic national resource. The United States maintains such an underground crude oil reserve to mitigate any supply disruptions. Some comparative figures for such reserves are: the U.S. over 600 billion barrels, China 400, South Korea 146, Spain 120 and India 39.1. India does have a target to substantially increase its reserves. At today's prices to reach Chinese levels of reserves we will need nearly ₹2 lakh crore, which is 10% of the Central Budget. Even if we spread this out over several years, it is still a lot of money. There are two (state-owned) Chinese companies in the top five oil companies; in fact Sinopec is the world's second largest, just behind Aramco. While China sticks to state-owned national resources, we are moving in the opposite direction. National security also depends on the economic power that a Government has. We do have plans to build perhaps the world's largest refinery in India, with the help of Saudi Arabia, but ownership and control will be in foreign hands. Meanwhile with the strategic disinvestments, we will lose Government control over both crude and refining. Nothing prevents China or any other country for that matter from buying up refining capacity in India.

Is this strategic disinvestment akin to killing the goose that lays the golden eggs? Financially we are worse off, and strategically the nation finds itself in a vulnerable situation. We need to see through the ideological narrative coming from the developed nations. They embraced free trade when it suited them and are now trying to embrace protectionism. China adopted a market system but does not allow this to cloud its thinking when it comes to strategic national issues: the control then remains with the Government. India too needs to re-think its strategy.
