Are fears over the CAA misplaced?

To reassure Indian Muslims, the PM needs to state that the govt. will not conduct an exercise like NRC

A day after asserting at an election rally that those "creating a storm" against the Citizenship Amendment Act (CAA) can be "identified by their clothes itself", Prime Minister Narendra Modi tweeted that "no Indian has anything to worry regarding this Act". It is unfair to dismiss without careful consideration the government's claim that Indians have nothing to fear from the CAA. Not even its critics can deny that all that the CAA does is to offer a benefit: citizenship. It does not take away anything from anyone. And, it offers the benefits of citizenship to persecuted religious minorities from Afghanistan, Pakistan and Bangladesh.

True, it doesn't offer this benefit to persecuted Ahmadiyyas or Shias from these countries. It is discriminatory towards persecuted non-Indians who are Muslims. But what has that got to do with Indians, or Indian Muslims, for that matter? As has been pointed out umpteen times by Home Minister Amit Shah, the CAA doesn't even refer to Muslims. So why is it being said that this law targets Indian Muslims?

No CAA without NRIC

For an answer, we don't need to look beyond the Home Minister's own statements. Mr. Shah has repeatedly underscored two things: one, he will implement the National Register of Indian Citizens (NRIC), extending the NRC exercise conducted in Assam to the rest of India; and two, the sequence is all-important: he will implement the CAA first, and only after that, the NRIC.

Put simply, the CAA is a safety net that will ensure, and insure, the citizenship of all Hindus, Sikhs, Christians, Buddhists, Jains and Paris not just the lakhs of Hindus classed as "illegal migrants" by the Assam NRC, but also others all over India who might be categorised as "foreigners" when the NRIC is implemented. The citizenship of all of them will first be secured through the CAA, and only then, after all non-

citizenship-related documentation, will the all-India NRC or NRIC be implemented. If there is no NRIC, there would be no need for the CAA either. The NRIC's objective is to divide the people domiciled in India into two categories: citizens and "illegal migrants". The CAA's objective is to preemptively rescue, prior to the NRIC exercise, the citizenship of all Indians except those whose religion finds no mention in the CAA.

Threat of omission

It's simple arithmetic: add all the religious groups under threat of exclusion by the NRIC (Hindus, Buddhists, Muslims, Sikhs, Jains, Christians, Parsis). Subtract from this set all the religious groups secured by the CAA (Hindus, Buddhists, Sikhs, Jains, Christians, Parsis). We are left only with Muslims as the remainder. They will be the only community excluded Muslims are protected with requisite from the 'legislative benevolence' of the Indian state as incarnated in the CAA. Ready to be scooped up, like so many gasping fish, by the NRIC net.

Every Indian who is puzzled by the intensity of the anti-CAA protests sweeping the country needs to answer a few simple questions: What happens when, after Hindu, Sikh, Buddhist, Jain, Parsi and Christian residents of India who are excluded by the NRIC are granted citizenship, thanks to the CAA, only Muslim "non-citizens" remain? Will these stateless people be sent to detention camps? Or will they be accorded an inferior status in a hierarchy of citizenship where non-Muslims occupy a higher position?

Even if the government were to announce that it won't implement the CAA, the very existence of this legislation is a danger to the social fabric of the country, for it is a tremendous enabler of hate speech. The world's foremost experts on Genocide Prevention consider hate speech the prime harbinger of genocide. "The Holocaust did not start with the gas chambers. It started long before with hate speech," observed Adama Dieng, the UN Secretary General's Special Adviser on Prevention of Hate Speech, on Prevent Genocide Day this month. As a political tool, the CAB-NRIC combo has the potential to encourage hate speech, especially at election time. As an administrative tool, it weakens constitutional safeguards against genocidal machinations, which could prove deadly in the unlikely event of the world's largest democracy mutating into a majoritarian state sympathetic to such machinations.

Exclusionary precedents

There is ample historical precedent for exclusionary citizenship laws and the ends they served. The Reich Citizenship Law of 1935 stripped German Jews of their citizenship, and everyone knows what came after. Closer home, the 1982 Citizenship Law in Myanmar rendered Rohingya Muslims stateless, despite the fact that they were indigenous to the Arakan region. Myanmar is currently facing charges of genocide at the International Court of Justice.

Assurances by the government that "no Indian will lose citizenship" are to be welcomed. But anti-CAA protesters are convinced that under the CAA-NRIC regime, sections of Muslims will cease to be "Indians" anyway. Once they lose their citizenship, the government can still claim that no "Indian" has lost citizenship, for it is the government which decides who is an Indian and who isn't.

If it is indeed the case that all fears about the CAA are misplaced, and it is only "vested interests" that are misleading the nation, then it is easy for the Prime Minister to dispel such misapprehensions. Instead of blandly insisting that "not a single Indian will lose citizenship", he only needs to declare categorically that the government will never, ever conduct anything like the NRIC. And he must repeat this assurance in every election rally, tweet it out, and reiterate it in his radio address. Can he do so? If he cannot, or will not, then what does that say of the intent behind the

Calling the U.S.'s bluff in 1971

Bold power play by India and Russia held off Pakistan's benefactors in those crucial days in December 1971

As we remember the liberation of Bangla desh this week more than four decades ago, it is worth recalling the geopolitics that made it possible. By 1969, Prime Minister Indira Gandhi and her advisers were aware that the U.S.'s feelers to China could potentially come at a cost to India's security. The Sino-Soviet split meant that Moscow had looked at geopolitical developments with a similar perspective. By July 1971, the veil had been lifted. Pakistan had served as a middleman in the U.S.-China detente. By December 1971, it was crunch time as the fate of their ally hung in the balance. The U.S. aircraft carrier 'Enterprise' was despatched to the Indian Ocean as a gambit to raise Pakistan's morale.

At a meeting chaired by Mrs. Gandhi to assess the implications of the Seventh Fleet's presence in the Bay of Bengal, her adviser D.P. Dhar urged India to leverage the special understanding that had been formalised in August, "What is the point of India having signed the Indo-Soviet treaty of Peace, Friendship and Cooperation, if India cannot call this bluff?" Then, on December 14, Mrs. Gandhi's confidant P.N. Haksar cabled Dhar in Moscow saying it was necessary "to make a public announcement carrying the seal of the highest authorities in the Soviet Union that involvement or interference by third countries... cannot but aggravate the situation". Shortly thereafter, the Soviets "sent a top-secret message to Nixon" warning the U.S. "against involvement or interference".

Entry of Soviet naval vessels

Naval units from the Soviet Pacific Fleet had already been dispatched. The U.S. was aware that the Soviet Navy had entered the Indian Ocean on December 5 and by December 7 was "approximately 500 nautical miles east of Ceylon (Sri Lanka)." On December 8, U.S. National Security Adviser Henry Kissinger admitted that given the Russia factor, "I must warn you, Mr. President, if our bluff is called, we'll be in trouble... we'll lose." On December 11, Kissinger briefed President Richard Nixon, "16 Soviet naval units are now in the Indian Ocean area, including three space support ships. Communications intelligence indicates that most of the ships are near Ceylon and Socotra." The vessels were armed with anti-ship cruise missiles capable of destroying U.S. warships and escorted by nuclear submarines. There was no longer any

ambiguity about what the Indo-Soviet Treaty meant in the unfolding situation.

The White House had also been hoping for some sort of a Chinese move to complicate India's military operations. On the same day, Nixon told Kissinger, "a movement of even some Chinese toward that border could scare those goddamn Indians to death."

China doesn't take the bait

On December 10, in a secret meeting in New York, Kissinger told Huang Hua, China's official at the UN, that the U.S. was "moving a number of naval ships in the West Pacific toward the Indian Ocean: an aircraft carrier accompanied by four destroyers and a tanker, and a helicopter carrier and two destroyers." Kissinger also offered to provide "tactical intelligence" on "the disposition of Soviet forces" on China's borders, and added, if the Chinese"were to consider the situation on the Indian subcontinent a threat to its security, and if it took measures to protect its security, the U.S. would oppose the efforts of others to interfere with the People's Republic."

The move was aimed to kill several birds with a single stone. But China didn't bite. Beijing feared that even limited coercive actions against India would invite immediate reprisals from Moscow. In the light of Russia's dramatic military escalation to Chinese provocations in their 1969 border crisis, Chairman Mao Zedong was not going to take a chance again. Indeed, a few months earlier, Soviet Defence Minister Andrei Grechko had plainly told Dhar, "the Chinese were aware of the superiority of Soviet forces on the Eastern borders and this 'had downed their tail'." For China to "invite a conflict" after the conclusion of the Indo-Soviet Treaty would be tantamount to "courting a disaster". Later, during the Nixon-Mao summit in 1972, Zhou Enlai told Kissinger that the U.S. bluff had been called by the Soviets. On December 13, the Soviet Ambassador to India, Nikolai Pegov, reassured New Delhi that Moscow would counteract any moves by the U.S. or China. And, if Beijing decided to intervene in Ladakh, Moscow "would open a diversionary action in Xinjiang." Three days later, the Pakistan Army surrendered.

Looking back, we can see that Indian policymakers achieved something remarkable in managing the geopolitical contradictions. They crafted a partnership with the Soviets to offset what was a formidable U.S.-Pakistan-China front. The nuggets also reveal how seriously China and the U.S. took Indian countermeasures and Moscow's resolve to ensure that its ally emerged victorious.

The rhetoric and reality of capital punishment

It provides neither justice nor deterrence

Following the Supreme Court's dismissal of review petitions by all four convicts in the Nirbhaya rape and murder case, the four have moved one step closer to the gallows. In the light of this, and the repeated demands to punish all rape convicts with the death penalty, it becomes important to examine empirical evidence on the topic.

If the experience of the past century is taken as a guide, it is clear that death penalty as a measure to end sexual violence has completely failed. In 1965, only 23 nations had abolished the death penalty. But, subsequently, criminal justice systems across the world lost confidence in this mode of punishment. Today, over two-thirds of countries have given up on capital punishment either in law or in practice. The standards by which nations conduct themselves have evolved. But,

in India, we continue to go against the tide.

Against natural justice

In the system of criminal justice worldwide, including in India, underpinning the element of sen-

tencing is the 'Theory of Punishment'. This is classical law, proved so by having stood the test of time for centuries. It stipulates that there should be four elements of a systematic punishment imposed by the state: the protection of society; the deterrence of criminality; the rehabilitation and reform of the criminal; and the retributive effect for the victims and society. Capital punishment, in its very essence, goes against the spirit of the 'Theory of Punishment', and by extension, natural justice.

The first element, 'protection of society,' is not served by imposing the death sentence any better than by incarceration. This has been proven time and again as inmates have spent decades on death row, harming no one, but being brutalised by the inhuman punishment meted out to them. Second, there are several factors which effect criminal activity and deterrence is only one of them. In a UN survey, it was concluded that

'capital punishment deters murder to a marginally greater extent than the threat of life imprisonment." The report of the Justice J.S. Verma Committee said that capital punishment is a regressive step and may not provide deterrence. The committee recommended the life sentence for the most grievous of crimes.

It is not just statistics that prove the case against deterrence, so does logic. A reasonable man is deterred not by the gravity of the sentence but by the detectability of the crime.

Third, the facet of 'reform and rehabilitation of the criminal' is immediately nullified by the prospect of capital punishment, ad oculos. This leaves only the final element

'the retributive effect'. Killing should never be carried out based on the primal and emotive desire among human beings for revenge. Revenge is a personalised and emotional form of retribution, which of-

ten loses sight of proportionality.

A comparative study of death row conflicts shows that the jurisprudence in this regard is skewed against the weak-

er sections. Justice P.N. Bhagwati, said that "death penalty in its actual operation is discriminatory for it strikes mostly against the poor and deprived". The reasons include lack of adequate legal assistance to the marginalised. The Death Penalty Project has conclusively shown the manner in which wrongful capital sentencing is carried out. In the United States alone, over 350 people have reportedly been wrongfully sentenced in the last century.

Hence, in the light of the recent incidents of heinous violence perpetrated against women, it becomes imperative for the judiciary not give in to the public clamour for making capital punishment mandatory for rape convicts. Public angst and emotions cannot be an alternative to reason and logic. There needs to be better enforcement of law in response to valid questions on justice but death penalty holds no answers.



Jharkhand voters keep parties guessing

No clear signal from the ground for BJP and Congress-led Opposition alliance as campaign ends

As the campaign for the Iharkhand Assembly election came to an end on Wednesday, the unpredictable voter mood is keeping both the BJP and the Opposition alliance, comprising the Jharkhand Mukti Morcha and the Congress, on tenterhooks.

The two major opponents have channelled all energies into getting the major chunk of 16 seats in Santhal Pargana in the final phase on December 20, with no clear pattern emerging from the previous four phases.

From the BJP's preference for a five-phase election in a small State, it became evident that the saffron party wanted to use all resources at its disposal and its strong cadre base to negate the antiincumbency factor. The party began its campaign on the plank of development including industrialisation, benefits of central schemes and

job creation. However, the issues did not resonate enough with voters leaving the electoral battlefield wide

Ties with AJSU The woes of the BJP worsened as some of the candidates who had joined the party just before the election were found short of expectations. In at least 15 Assembly segments where the Kurmi community has a sizeable population, the BJP's prospects are said to have taken a hit following the break-up with its former alliance partner, the All Jharkhand Students' Union (AJSU). The regional party has a good support base among Kurmis.

Moreover, the image of Raghubar Das, the first Chief Minister to complete the full five-year term in Jharkhand, reportedly did not augur well for the saffron party.

"Since its formation Jhark-

hand had always seen a tribal leader assuming CM's charge till Mr. Das's ascent to the top post. He was seen as an outsider. Many did not like the way Mr. Das conducted himself in public. His straight talking and treating subordinates with disdain

sent a wrong signal to voters," said Professor V.P. Sharan, a political analyst.

Rebellion against CM

The Chief Minister faced rebellion in his home turf with his former Cabinet colleague Saryu Rai challenging him in the East Jamshedpur seat. Party insiders said the third and fourth phase had not gone well for the party. The alliance of the JMM,

Congress and RJD took time to recover from the crushing defeat it received in the Lok Sabha election. If there was a silver lining, it was the coming together of the JMM and the Congress who had fought the 2014 Assembly election separately. Unlike in the last Parliament election, the JMM and the Congress coalition appeared to have worked more cohesively this time. JMM executive president Hemant Soren, who had been holding an average six meetings a day, said he was hopeful of outperforming the BJP.

HC agrees to hear 2 PILs on Jamia violence

The Delhi High Court on Wednesday agreed to hear two public interest litigation (PILs) petitions moved on the recent violence at Jamia Millia Islamia University here during protests against the Citizenship (Amendment) Act (CAA).

Both the petitions were mentioned before a Bench of Chief Justice D.N. Patel and Justice Rekha Palli which allowed them to be listed for hearing on Thursday.

Meanwhile, the High Court refused to grant interim protection from coercive action to two women students of Jamia Millia Islamia University in relation to the violence during the protests against the CAA.

The hearing witnessed heated exchange of words between the Delhi government standing counsel and the top law officers of the country.

Centre cautious on framing CAA rules

Intelligence Bureau monitoring and compiling details of all agitations

A committee to frame rules for the implementation of the Citizenship (Amendment) Act, 2019 is yet to be formalised and it will include the Secretaries of the Ministries of Home and Law and Justice, a senior government official said.

Amid strong across the country after the CAA was passed last week by Parliament, the government has decided to act cautiously while framing the rules.

The Intelligence Bureau is monitoring and compiling the details of all the protests related to the CAA. It apprised the government on Wednesday of eight major protests in Assam, Tripura, Manipur, Arunachal Pradesh and Delhi.



'NRC places an intolerable burden on the poor and vulnerable sections'

Government is trying to divert attention from economic woes through the Citizenship Amendment Act and the National Register of Citizens, says Congress leader

SOBHANA K. NAIR

Congress leader Jairam Ramesh speaks about the Citizenship Amendment Act and the National Register of Citizens while discussing his latest book A Chequered Brilliance: The many lives of V.K. Krishna Menon.

The Citizenship Amendment Act has been in the making for the past four years. Isn't the Congress too late to begin the protests now?

■ It's not quite true. A few months ago, Congress president Sonia Gandhi understood the gravity of the situation; she set up a group. I was a member of that group. We visited the northeastern States and submitted a report. It's true that the first time the legislation came up in the Lok Sabha, we walked out. I think the walkout was largely because we were unsure. We had not formulated a unified position till then. Because, even within the Assam Congress, there were divisions. This time, we didn't walk out. We actually voted against the Bill, in both Houses of Parliament.

What was the feedback from your party in the Northeast specifically on the issue of

■ There was a historical background for the NRC in

The current NRC was launched in 2005 after a tripartite meeting between Dr. Manmohan Singh, Tarun Gogoi and the AASU. But we have seen the dislocation the NRC causes and we've also seen the bogey of the BJP demolished. completely They were claiming 40 lakh illegal migrants. The NRC finally comes up with a figure of something like 19 lakh of which a substantial number are non-Muslims. Now they are trying to discredit the NRC process in Assam because their propaganda was debunked.

But what was the feedback?

■ Let me tell you. In Tripura it's very interesting in the tribal areas. The tribal leaders want the NRC and it's the non-tribal leaders who are deeply sceptical because they will know they don't have the papers. The Chief Minister of Tripura himself was on record as having said that if the NRC is implemented in Tripura, he would not be part of it. So there were different views on the NRC. All the States unanimously opposed the Citizenship Amendment Act (CAA) but on the NRC it was a nuanced view... we must have an NRC. Who can be opposed to documenting illegal migrants, nobody. The Congress party is certainly not opposed to the documentation of the illegal migrants. The problem is the way you do it.

So what is the Congress's final stand on a nationwide

■ Given the Assam expe-



rience, where we saw, the NRC places an intolerable burden on the poor and vulnerable sections of society, the Congress party's position is that we need a far greater homework on the administrative modalities of the NRC. We need to create a proper environment in which the NRC has to be implemented. The Citizenship Amendment

■ We had a rally planned ear-

And finally, a very successful rally was held, but by that time, the economic slowdown had been overtaken by the issues of the Citizenship Amendment Act and the NRC. But the economic issue is not going to go away. It's now very clear that the economic malaise is not cyclical it's structural. It's also very clear now that we have the monster of inflation coming up. We thought that inflationary expectations had been con-

trolled but that's clearly not.

And this is inflation, not driven by oil prices as it was during the UPA regime, but this is inflation being driven by rising food prices. So this is a dangerous combination.

Chequered Brilliance: The many lives of V.K. Krishna *Menon* you bring out the many contradictions of a very controversial character. You write in your book that many believed that he would succeed Nehru. Could it have been the reality had the 1962 India-China War not happened?

■ I think he was a consequential personality and a compelling personality, but he was also a contradictory and controversial personality. Like all great men he had monumental achievements, both before 1947, and after 1947. But like all great men, he made gigantic mistakes. When I started writing this book it was not to make him into a hero or a villain, but

try to understand this 'pheno-Menon'. He was the arch priest of the Left. But ultimately, would he have been Prime Minister, I am doubt-

You make startling claims in

vour book that General K.S.

Thimayya, then Army chief, openly aired his frustrations about Krishna Menon in his conversations with Nehru and with U.K. High Commissioner Malcolm MacDonald! How did the Indian intelligence not know about it?

■ If this sort of thing happened today the General would have been sacked! It's unacceptable. I was aghast when I read the records. He had gone to the extent of telling MacDonald that Krishna Menon wanted to make himself the master of the armed forces so that he might one day have their support to achieve his political ambition to take Nehru's place either after or even before Nehru's withdrawal from public life.

Rajbongshis oppose CAA, but back NRC

The Rajbongshis are all set to shut down parts of north Bengal from January in protest against the Citizenship (Amendment) Act.

With a population of 3.5 million in 2001 that is estimated to have swelled to about 5 million, the Rajbongshis constitute the largest SC group in West Bengal. A few more millions are estimated to reside in western Assam and parts of east Bihar.

Two political outfits representing the Rajbongshis – the Kamtapur People's Party (KPP) and the Greater Cooch Behar People's Association (GCPA) – plan to take to the streets in at least two districts of north Bengal, Cooch Behar and

Jalpaiguri, in January. KPP president Atul Roy, who had earlier backed a separate democratic homeland movement, said the new law posed a threat to the community. "Bangladeshi Hindus have taken over our land in north Bengal," said Mr. Rov.

Bangshi Badan Barman, the general secretary of the GCPA, said: "CAA should be revoked and National Register of Citizens (NRC) be implemented in north Bengal."

The two groups were ready to accept March 25, 1971, as the cut-off date for the NRC, he added.

Police arrest PFI State unit president for 'inciting violence'

Offices of the Assam government wore a deserted look on Wednesday as members of the Sadou Asom Karmachari Parishad, the apex employees' organisation, ceased work in protest against the Citizenship Amendment Act (CAA).

Central government offices, banks and other establishments functioned norwhile schools remained closed and mobile Internet services suspended for the eighth day.

Officials said educational institutions were likely to open on December 23.

With people unable to access social media, protesters used walls in urban areas for anti-CAA graffiti as hundreds gathered at Guwahati's Latasil Field on the third and final day of the "mass satyagraha" organised by the All Assam Students' Union (AA-SU). The protesters chanted anti-CAA slogans besides slamming the Narendra Modi government for "planning to dump Bangladeshis in Assam".

The police arrested Aminul Haque, State unit president of the Popular Front of India (PFI), for allegedly inciting the violence and arson that claimed six lives last week. The police also raided

the PFI office in Guwahati and seized laptops and other materials Assam Finance and Health Minister Himanta Biswa Sarma on Tuesday said the government had video evidence of PFI and Congress members orchestrating the violence.

Cong. complaint to DGP A Congress delegation on

Wednesday met State DGP Bhaskar Jyoti Mahanta and complained that the Sarbananda Sonowal government was selectively targeting party workers.

"The injured being treated at the Guwahati Medical College Hospital belong to different communities but this government is singling out one community besides selectively arresting our party workers," said Congress MP Gauray Gogoi, a member of the delegation.

Meanwhile, after popular Assamese artistes, a major cog in the anti-CAA wheel, called for a demonstration at Guwahati's Chandmari Field on Thursday, the BJP-led State government announced a grant of ₹50,000 each to 2,000 artistes and technicians. The government also said 55,000 vacant posts would be filled up. The AASU welcomed the move but said the sops would not mute the voices of protest in the State.

Assam govt. employees 'CAA violates international convention'

Citizenship law will affect ties with friendly neighbours, says Congress

The Congress on Wednesday claimed that the Citizenship (Amendment) Act not only "violates" provisions of the Constitution but also falls afoul of an international convention to which India is a signatory.

Addressing a press conference, Congress MP and lawyer Abhishek Manu Singhvi said India was a signatory to the international convention on torture that talks about "providing shelter to people who face torture in another



country". "India is bound by the principle of jus cogens that ensures human rights to those who are tortured and persecuted," Mr. Singhvi told

He also pointed out that this law would have serious implications in terms of international relations, especially with friendly neighbours such as Bangladesh.

The Congress leader also reiterated the party's contention that the new law violated regional agreements like the Assam Accord and the one signed with the former rebels in Tripura.

Mr. Singhvi also clarified that the petitions filed by Congress leaders never sought a "stay" from the Supreme Court but only asked

that a "show cause" notice be issued to the Union government. Interestingly, former As-

sam Chief Minister Tarun Gogoi, a trained lawyer, also donned his lawyer's robe after three-and-a-half decades to assist senior counsel and party colleague, P. Chidambaram in the top court.

Protests can lead to an anti-BJP front, says Pawar

'There have been no talks yet between the parties'

The protest by political parties, coupled with demonstrations against the Citizenship (Amendment) Act by citizens and students across the country has the potential for a national front against the BJP, said Nationalist Congress Party (NCP) president Sharad Pawar in Nagpur on Wednesday.

"All political parties have met the President against the Act. Some States have already clarified they will not implement the Act. The meeting with the President was an indication that the process of all political parties coming together has begun. Though there have not been any talks between the parties, everything points towards this," said Mr. Pawar in an interaction with mediapersons.

"The Centre did not expect the protests that erupted across the country. There have been protests not only in the States which would be impacted but also in regions which may be largely unaffected. In addition, the support is coming from all communities. This shows that the movement has the potential to build into an anti-BJP movement," he said. "The BJP may have won the Parlia-

Act indifferent to Sri Lankan Tamils: DMK

The Dravida Munnetra Kazhagam (DMK), the main Opposition party in Tamil Nadu, has moved the Supreme Court against the Citizenship (Amendment) Act, saying it is a deliberate ploy to "demonise and marginalise" Muslims and distract public attention from the "extreme administrative incompetence" of the government.

The writ petition, among the 59 the top court agreed to hear, said the Act is indifferent to Tamils who had fled Sri Lanka and have been staying in India for decades. "There was no reason to keep them out of the benefits derived from the Act," it contended.

"The Act is a classic example of spewing venom against one section of the human race by targeting the Muslim community and letting down Tamils who have come from a neighbouring country as refugees," the petition said.

House set to vote to impeach Trump

President says he did nothing wrong, denounces the probe as an 'attempted coup'

The House of Representatives began debate on Wednesday ahead of a historic vote on two articles of impeachment against President Donald Trump charging him with abusing his office and obstructing Congress that would make him the third U.S. President to impeached.

The vote in the Democratic-controlled House is expected to fall almost entirely along party lines, underscoring the deep divide in Congress over Mr. Trump's con-- and the larger political schism within the nation itself.

Mr. Trump would become only the third American President to be impeached, an extraordinary check on presidential power spelled out in the U.S. Constitution for executives who commit "high crimes and misdemeanours." No President has ever been removed from office under its terms.

The vote would result in a trial next month in the U.S. Senate, in which House members would act as prosecutors. That chamber is controlled by Mr. Trump's fellow Republicans, who have shown little interest in removing him from office.

House Democrats accuse Mr. Trump of abusing his power by asking Ukraine to investigate Joe Biden, a former U.S. Vice-President and leading Democratic contender in the 2020 election. Mr. Trump is also accused of obstructing the congressional investigation into the matter.

Republicans signalled as soon as the day began that they intend to do everything possible to stall the proceedings. Representative Andy Biggs, a Republican member of the Judiciary Committee, journ immediately after the morning prayer and pledge of allegiance, leading to a

Mr. Trump has called the impeachment process "a total sham," and on Tuesday sent House Speaker Nancy Pelosi a lengthy letter, in which he accused her of engaging in a "perversion of justice".

The President has denounced the probe as an "attempted coup" and has argued Democrats are trying to undo the results of the 2016 election. "Can you believe that I will be impeached today by the Radical Left, Do Nothing Democrats, AND I DID NOTHING WRONG! A terrible thing," Mr. Trump tweeted early on Wednesday morning. "Say a prayer!"

With Mr. Trump seeking a second term next year, impeachment has cleaved the public, with most Democratic voters supporting it and most Republicans opposed.

Republicans contend that a "yea" vote on impeachment could cost some moderate House Democrats their seats in next year's congressional elections. Still, several Democrats who represent districts that backed Mr. Trump in 2016 have said in recent days they will vote to impeach him.

Sri Lanka Supreme Court rules against custodial death

It orders police and state to pay LKR 2 mn in compensation

Sri Lanka's Supreme Court on Tuesday ruled against a case of custodial death, ordering seven police personnel and the state to pay a total compensation of LKR 2 million (about ₹8 lakh) to the victim's family.

"It is the State's responsibility to protect every citizen of this country. In the instant case, I find that the State has failed its responsibility and has violated the Fundamental Rights of the deceased," Justice S. Thurairaja ruled, with the other two judges on the bench - L.T.B. Dehideniya and Murdu N.B. Fernando - agreeing.

The order pertains to a fundamental rights petition filed by a resident of Embilipitiva town in Sri Lanka's southern Sabaragamuwa Province that her husband had been arrested and "killed" by the police who thereafter "fabricated a ver sion to justify the killing".

Almost a decade ago, in September 2010, police arrested the petitioner's husband over his suspected involvement in a murder in the area. Days after the suspect's arrest, the family was informed that he "was shot

and taken to the Embilipitiya Hospital", where he was declared dead.

Counsels representing the police officers, named as respondents in the case, had submitted that the suspect was taken out of the police station at night "to recover a weapon" hidden in his plantain grove. On the way, the man "had struggled" with a policeman "to snatch his rifle and he was killed as a result of a single shot that went off", they claimed.

Police failure

In a strongly-worded ruling, the Supreme Court judge observed that if the deceased were a person involved in grave crimes, as claimed by the police, then the police should have been more careful in handling him. Adding that the police side failed to "satisfactorily explain" why the man was taken out at night without handcuffs with only three officers and the driver, close to a police officer with a readily loaded and unprotected (unlocked) weapon, in a faulty van without a door. "In these circumstances, I find the respondents' submissions to be highly untenable," Justice Thurairaja noted.

The judge cited a 1974 U.S. Supreme Court judgment, that said: "[A] prisoner is not wholly stripped of constitutional protections when he is imprisoned for crime. There is no iron curtain drawn between the Constitution and the prisons..."

Commending on Monday's ruling, Saliya Peiris, a President's Counsel who appeared for the petitioner, told The Hindu: "This judgment is welcome. It was a classic case of a death in police custody. It sends out a strong message to the police that even in cases where a suspect is allegedly involved in a heinous crime, the suspect's fundamental rights must be protected."

The judgment is especially significant since such police action against suspects is sometimes popular among the public, depending on the crime, he added.

Germany bans gay 'conversion therapy'

The German government on Wednesday signed off on a new law banning "conversion therapies" designed to force heterosexuality on homosexuals. The legislation, set to be

introduced next year, would see the practice made punishable with up to a year in

prison and fines of up to €30,000 (\$33,000). "Homosexuality is not an illness, so the word 'therapy' is misleading," said Health Minister Jens Spahn, the architect of the law.

Once it is approved, Germany would be only the second European country passed similar legislation in 2016. Mr. Spahn said that he wanted the ban to be as farreaching as possible, adding that the so-called therapies often caused "severe physical and psychological damage"





removal," said Mr. Bhure.

"Thus, the NCLAT decision to declare removal of Mr. Mistry as illegal and consequentially restoring him to the position of executive chairman of Tata Sons Ltd. has to clear the litmus test before the apex court. In all likelihood, the said direction will be stayed by the apex court pending the appeal. Equally, the other direction to reinstate Mr. Mistry as director of the three Tata companies forthwith would be unsustainable as he himself resigned from other group companies," he added.

FADA moves SC on sale, registry of BS-IV vehicles

Seeks modification of deadline order

The Federation of Automobile Dealers Associations (FADA), on Wednesday, said it had approached the Supreme Court for sale and registry of unsold BS-IV vehicles beyond the current

deadline of April 1, 2020. In a statement, FADA said that on behalf of its members, it has filed an Impleadment Application in the Supreme Court along with an application seeking modification in the apex court's order October 24, 2018, order directing that "...no motor vehicle conforming to emission standard Bharat Stage -IV shall be sold or registered in the entire country 01.04.2020."

FADA president Ashish Harsharaj Kale said that with the current timeline of all India BS-VI fuel availability of April 1, 2020, most manufacturers would shift to 100% BS-VI vehicle production only by end February, 2020 or first week of March,

2020. "Looking at this timeline of BS-VI production and the current fluctuating demand situation, despite putting in the best of efforts, there is a possibility that many of our members are not able to ensure 100% liquidation of BS-IV inventory purchased by them in the course of business before the deadline of April 1, 2020," Mr. Kale

Infosys to settle visa violation case in California for \$800,000

Tech major Infosys will pay California a sum of \$800,000 to settle visa related allegations.

Attorney General, State of California Department of Justice, Xavier Becerra said an \$800,000 settlement was announced against Infosys and its BPM (business process management) subsidiary. Some 500 Infosys employees were working in the state on Infosys-sponsored B-1 visas rather than H-1B visas between 2006 and 2017,

as per an official post available on the website of State of California.

'Bank mergers may pose cybersecurity risks'

The boisterous Mr Haldane

Samanth Subramanian's latest biography, A Dominant Character, captures the British-Indian scientist's thoughts on how science and politics play off each other

When British-Indian scientist John Burdon Sanderson (JBS) Haldane moved to India with his wife, Helen, he had carried along with him a dozen jars of live fish in the cabin hold. The fluctuating temperature in the baggage hold would kill them, he had explained to an ISI official, also assuring him that "they will be sealed up and will not smell."

In many ways, this was typical of the British-Indian scientist best known for his work in physiology, genetics, evolutionary biology and statistics - he bent the rules and defied authority consistently.

"He had a lack of tolerance for idiots," agrees journalist and writer Samanth Subramanian, whose latest book, a biography of Haldane, titled A Dominant Character: The Radical Science and Restless Politics of JBS Haldane, is peppered with incidents such as this one.

Written in evocative prose that makes a reader cringe, laugh out loud, and get emotionally invested in the life of this layered, complex man, the book focusses on what Haldane "thought about science and politics and how they would play off each other."

A dominant character

"I knew him first as a British biologist who moved to India, and that in itself was intriguing," says Subramanian. "There were all these little witty things that would come up in my



The title of the book – A Dominant Character – is both a nod to Haldane's personality and the science he loved (dominant and recessive inheritance patterns are essential to Mendelian genetics).

Haldane was indeed a Renaissance man, a polymath of vast and

Haldane's life – lived not in an ivory tower of scientific research, but in

varied interests. He wrote cutting the real world - had all the elements of a great story.

He fought in the First World War and Spanish Civil War. His first wife was a much-married woman, his second he met when he was still married to his first. Then there was the tragic irony of never being able to have children, despite being obsessed with genes. And the moral dilemma of the Lysenko affair, which pitted his politics and science against each other.

"That was his one misstep," says Subramanian. A deviation, almost, from all the values he had espoused; he was against imperialism, rampant capitalism, racism or eugenics.

Throw in his personal evolution. A diary, written when he was ten, for instance, may have echoed his mother's conservative, empirelauding politics. But he left Britain for India, at 65, because he thought that the country's involvement in the Suez Affair made it a "criminal state". And add a dash of acerbic wit. "One of my reasons for settling in India was to avoid wearing socks."

This is Subramanian's first stab at a biography; his previous two books, Following Fish and This Divided Island: Stories from the Sri Lankan War, were a travelogue and a narrative history of postwar Sri Lanka respectively.

One of his most significant sources of information was Haldane's own writing - detailed and illustrative if a trifle illegible. ("His handwriting resembled ants somersaulting through snow"). Thankfully, his writing was mostly typed up by his secretary.

"Haldane was 100% engaged with the world. That isn't common now," says Subramanian. In the age of genetic manipulation and designer babies, questions raised around these things aren't just scientific; they are political and ethical, he says. "It is important for scientists to resume that role of a public intellectual.'

The East's own gin

Roku, a two-year-old Japanese premium gin, has just been launched in India



The spotlight on gin in India hasn't yet stopped shining. On Tuesday, Beam Suntory, the global spirits brand launched their parent Japanese brand House of Suntory's premium 'craft' gin into the country. Called Roku, the gin was launched at the Trident in Gurugram, along with three whiskies: Beam Suntory's Oaksmith, as well as The House of Suntory's Yamazaki and Hibiki.

Master blender Shinji Fukuyo, who creates these whiskies and then ages them in American oak barrels, was present at the launch, as was George Kumekawa, from the House of Suntory.

Kumekawa has been overseeing the growth of Roku since its launch in 2017 in Japan and select countries in South East Asia and Europe. Roku has top notes of Yuzu, a Japanese citrus fruit and a sweet aroma courtesy cherry blossom and green tea. The complex flavours leave you with a hint of spice in the end, given the presence of the Japanese Sansho pepper.

Ahead of the India launch, he talks about why he's excited for Indian bartenders to work with Roku, and why the brand considers this a craft gin. Edited excerpts:

You're using six botanicals for Roku...

Yes, roku means six — we are using six Japanese botanicals, all of which are sourced from different areas in Japan, through different seasons. The Sakura tea and Sakura flower are only harvested in spring; the Sencha tea and Gyokuro tea are sourced in



different places and through different seasons; and we also have the Sansho pepper and Yuzu peel that come from different areas in the country. We then distil immediately to extract the best flavours. This requires a lot of time and effort, which is why we call it a ___ craft gin. There's no definition of this, but it's more about how much we care about and invest in the process, and the fact that we source everything locally.

Outside of these six, we also use eight traditional botanicals

including juniper berries. These are sourced outside of Japan. But to differentiate ourselves, we distillate the juniper berry twice. The reason is that the berry is sometimes too strong and we don't want that — we want it to match perfectly with the six Japanese botanicals.

The world has been focusing on gin now for a while. How do you see your presence in the Indian context now, at the end of 2019?

In addition to this [gin trend], I think that the education level of the bartenders here is growing rapidly. The way they serve and create their cocktails is getting better some Indian bartenders are getting popular outside of India too. For instance, in Hong Kong, the 8 1/2 Otto E Mezzo Bombana is a premium Italian place with a good bar. A bartender called Devender Kumar has been running it for a couple of years now, and he has elevated the bar. It's been placed in the Asia's 50 Best Bars consistently. The level of the industry [in India] is growing now too. We want to place Roku in India in the mid- to high-end category. I think it's the right time that we started the gin here, along with the

Do you plan to produce outside of Japan too, given the rapid expansion in the past few years?

launch of the House of Suntory whiskies.

Roku is produced in Osaka, in one of Suntory's oldest production plants. We don't have plans for sure to produce outside of this.

The confusing caller aliti

The crow family, called Corvids, is often seen as a harbinger of bad luck. Perhaps it is because they are the most intelligent birds studied, with skills possessed only by humans and a few other higher order mammals. For instance, they have strong organisation and community building traits (partner and group bonds), which keeps them in groups and helps them join mixed hunting parties of birds.

A part of the family is the Rufous Treepie (Dendrocitta vagabunda) that proudly displays its slate-grey hood, red-brown mantle, and long black-tipped silver-grey tail as it sits on trees. When it takes off, with a jerky, flapping motion that soon turns into a glide, you'll see its dull orange to light brown underparts and pale grey and black wings.

The Corvids – crows, ravens, rooks, jackdaws, magpies, treepies, choughs and nutcrackers - are the largest passerine birds (with three toes pointing forward and one

backward, helping the bird to perch). They're spread out across Southeast Asia, though surprisingly haven't been sighted in Sri Lanka.

Rufous Treepies are strongly arboreal in nature (mostly found on trees) but they do not shy away from occasionally coming to the ground to feed. Although they have adapted well to urbanisation, they are fewer in number compared to crows that dominate several parts of the city with their superior adaptation skills. They are natural omnivores and you may see the stout hooked silver-black beak pecking on invertebrates, fruits, sometimes the nectar of the Semal (red cotton)

tree, juveniles of birds, small reptiles and rodents (they're natural pest controllers). Like crows, they are also hoarders of food.

In cities, they often resort to scavenging. These birds are often found feeding on scraps disposed by humans (such as bread, chapaati, unwanted meat leftovers, cooked food). The increasing reliance on humans for food and the abundance of such food is alarming

and could adversely affect the populations of smaller birds in the vicinity.

Rufous Treepies are aggressive and territorial when it comes to breeding and protecting their territory from other creatures. They have a wide variety of calls: metallic fluty (ko-ki-la), meowing notes (a long-drawn mee-aao is said to be associated to breeding), often mixed with rattling cries to ward these



Sun-soaked South Africa

When Christmas arrives in South Africa, they say, one can feel it in the air. The streets of Cape Town are infused with the aroma of braai, a barbecue with yellow rice, raisins and vegetables, the local traditional Christmas meal. Follow it up with malva pudding, a South African dessert.





T20 is often perceived as a batsman's game but come Thursday, the pacers are set to have a field day during the Player Auction for the Indian Premier League (IPL)'s 13th

There's no doubt that the likes of Glenn Maxwell, Shimron Hetmeyer and Alex Carey will attract the highest bids during the miniauction with 338 players going under the hammer for a maximum of 73 slots. However, the pace bowlers could match the big-hitters in the price

Six players – Vinay Kumar, Ashoke Dinda, Mathew Wade, Saniay Yadav, Robin Bisht and Jake Weatherald – were added the auction list on Wednesday.

Need of the hour

One of the main reasons for the emphasis on speedsters is the fact that at least six of the eight franchises are in need of at least one reliable fast bowler. The Australian duo of Pat Cummins and Josh Hazlewood will be on the radar of many.

Similarly, England's Chris Woakes and the West Indies pair of Kesrick Williams and Sheldon Cottrell are expected to sign a big cheque along with Jaydev Unadkat, who will be hoping to emerge as the highest earning Indian cricketer for the third consecutive time.

Possible tussle Many franchises could also go for Dale Steyn, Mohit Sharma and Tim Southee along with

promising domestic pacers Ishan Porel of Bengal, Mumbai's Tushar Deshpande and Kartik

Tyagi of Uttar Pradesh. Despite it being a miniauction, Thursday will give a glimpse into the mindset of the rejigged support staff of five franchises. Barring Mumbai Indians, Chennai Super Kings and Delhi Capitals, all the others have a new head coach.

It will be interesting to see how the new support staff approach the auction. The task will be made even more difficult considering the uncertainties surrounding the 2021 IPL.

The league could see the addition of one team next year, effectively meaning that the dynamics of a full auction could become even more complicated.

Besides the big-ticket overseas players, focus will be on the interest the Indian players generate. While the under-19 trio of Yashasvi Jaiswal, Priyam Garg and Ravi Bishnoi may find many takers, it will be curious to see the response for Robin Uthappa and Piyush Chawla, formerly with KKR.

Abhishek Raman's century frustrates Kerala

THIRUVANANTHAPURAM A defiant century by opener Abhishek Raman (110) brought Bengal on the threshold of taking the first innings lead against Kerala at the end of the second day in the Ranji Trophy Elite Group A & B match at the KCA-St. Xavier's College ground here on Wednesday.

Bengal, in reply to Kerala's first innings total of 239, was 236 for six at stumps with Shahbaz Ahmed (25 batting) and Arnab Nandi (seven batting) negotiating a difficult half-an-hour's play in the final session.

Abhishek grafted his way to a well-deserved century after showing loads of patience and technique on a dicey surface which was still helping the spinners.

Early blows Kerala delt early blows, re-

ducing Bengal to 25 for two but Abhishek found an ideal ally in former captain Manoj Tiwary (51) to rebuild the innings with a 99-run thirdwicket stand.

Tiwary, who was dropped by Robin Uthappa in the slips off Monish on eight, made Kerala pay dearly. He targeted Jalaj Saxena and played forceful shots against the offspinner.

Abhishek, on the other hand, punished the loose deliveries as the partnership prospered. However, Tiwary's impetuousity cost him his wicket. The batsman, after lifting Jalaj for a six over extra cover, repeated the stroke and was caught at the fence by Uthappa.

Leg-spinner S. Midhun, who was surprisingly introduced late, scalped Sudip Chatterjee in his first over as Kerala enjoyed a rare success in the second session.

But Abhishek figured in two partnerships – 48 for the fifth wicket with Shreevats Goswami (24) and 41 for the sixth wicket with Shahbaz that brought his team closer to Kerala's total. At the fag end of the day, Basil Thampi ended Abhishek's vigil when the batsman feathered a catch to Monish at first slip.

Earlier, the Bengal medium pacers needed just 1.2 overs to wrap up the Kerala innings. It added just four runs to its overnight total before being dismissed for 239. The impressive Ishan Porel finished with three wickets.

DDCA drama continues

Two senior selectors and entire junior selection team sacked

The Delhi and District Cricket Association (DDCA) added another messy chapter to its administrative history when it sacked two senior selectors and the entire junior selection committee on Wednesday.

The decision was taken by the hurriedly-formed Cricket Advisory Committee (CAC). The two members who took the decision were Robin Singh (Jr) and Parwinder Awana, who, incidentally,

had served as coaches in the junior category this season. The third member, Sumit Narwal, who held a unique position of Observer, Cricket Operations, did not attend the meeting, which was convened by Sanjay Bhardwaj.

The selectors who lost their positions were Atul Wassan and Vineet Jain, the former because he was hardly available and the latter because he was an outsider. Their replacements will be Bantu Singh, who was not considered initially because he did not meet the qualification norms, having served five years as selector in the past, and Chetnya Nanda, who is also a former selector.

The junior selection committee will consist of Ashu Dani, Pradeep Chawla and Karan Dubey, the last named an outsider going by the

Apex Council argument. The DDCA Ombudsman Justice (Retd) Badar Durrez Ahmed had ruled recently that no selector should be changed until the season was over. Considering the developments at the DDCA, Government Nominee Rajan Tewari shot off a protest letter to highlight the "anarchy" in Delhi cricket and the 'illegal" acts by the mem bers of the Apex Council.

"I have sought immediate intervention by the Ombudsman since the Apex Council has decided to defy him," said Tewari.

Flamengo beats Al Hilal the hard way

Flamengo's run to FIFA Club World Cup final was not as easy as its canter to the Brazilian Serie A title, which it won by a 16-point margin the highest in recent times. The South American side had to overcome a first-half deficit to inflict a 3-1 loss on Asian champion Al Hilal.

Former Benfica coach Jorge Jesus with the help of a string of veteran Brazilians with European experience has tried creating a modern team – valuing the ethos of pressing football – unlike the pragmatic approach of coaches like Luiz Felipe Scolari and Dunga, which has long been prevalent in Brazilian club football.

While the new methods have offered grand success at home, Flamengo has found it hard to deal with teams from outside the country as was evident during its laborious Copa Libertadores final win over Argentina's River Plate.

Here, too, the Brazilians started listlessly with too many mispasses in the middle as Al Hilal looked happy to concede possession and hit its more illustrious opponent on the counter, using the pace of Salem Aldawsari,

who played on the left of a midfield three, and his fellow Saudi Arabian international Mohammed Alburayk, operating as a right-wing back.

Former Italian international Sebastian Giovinco, too, orchestrated some fine move with his guile and turn, exploiting the space opened up by the burly forward Bafetimbi Gomis, who did well to hold the ball and draw defenders his way.

The Saudi side, cheered on by pockets of faithfuls, took the lead in the 18th miwhen Aldawsari sneaked inside the box to connect a strong right-footer past a diving Diego Alves left flat-footed following a deflection off Pablo Mari – after Alburayk had run into space on the right before playing a teasing ground pass towards his team-mate.

Asserting dominance

Flamengo had to wait till the break to assert its dominance and almost immediately after the restart Giorgian De Arrascaeta equalised with an easy tap-in.

With the Asian side showing signs of fatigue, Flamengo took control of the game and found the lead when Bruno Henrique, running into the box, was left unmarked and placed his header on the back of the net after a curling cross from the right by De Arrascaeta in the 78th minute.

More misfortunes were to come Al Hilal's way as Ali Al-Bulayhi conceded an own goal four minutes later as a shot from Henrique caused panic near the goalmouth. The Brazilian champion's ploy to exert more pressure

in the second half on its tiring opponent finally bore fruit, offering the team a way out from a difficult situation.

Summing up the contrasting nature of the two halves, Henrique said: "In the first half we were not playing that bad. "However, we knew that

they (Al Hilal) did not have the physical strength to play with the same intensity for 90 minutes and we were able to create more opportunities in the second session, playing as a team."

With a chance now to collect the world title, manager Jesus called the final to be the "most important match of his career' "I am always impressed

with European football. I know Liverpool is favourite, but it has to win the next match. We have reached the final and it will be one of the most important match of my professional career. Winning this trophy will be a great honour," he said.
