# Two die in police firing in Mangaluru as anti-CAA protests rock the country

Marchers take to the streets, defy prohibitory orders in many places and brave police crackdowns

SPECIAL CORRESPONDENT

Two persons were killed in police firing in Mangaluru on Thursday as protesters across the country took to the streets against the Citizenship (Amendment) Act (CAA) and the proposed National Register of Citizens (NRC), which in combination could potentially introduce a religious test for citizenship in India.

Police in the coastal city of Mangaluru lathi-charged and later opened fire at protesters they claimed were trying to set fire to a police station and had targeted police personnel in Bunder area.

The police said the exact cause of death of Nausin, 23, and Jalil Kudroli, 49, would be known only after postmortem examination. The two, who were injured in the violence, died in hospi-

Mobile Internet data service has been suspended in the entire Dakshina Kannada district for two days "to prevent misuse of social media platform", police said. Curfew has been clamped in the Mangaluru City Police Commissionerate area till December 22 midnight, and all educational institutions will remain shut.

More than two dozen vehicles, including a State bus, TV broadcast vans and police vehicles, were torched at different locations as parts of old Lucknow witnessed chaotic scenes.

Thousands gathered at Mumbai's August Kranti Maidan and raised slogans, displayed placards, sported painted faces, sang songs and played music. There were repeated announcements throughout the rally to keep things peaceful. Former IAS officer Kannan Gopinathan and actor Sushant Singh took part in the Mumbai protest.

Kolkata witnessed five rallies, of which the one held without the support of political parties drew no less than 20,000 people. Chief Minister Mamata Banerjee has dared the Modi government to go for a UN-monitored referendum on the contentious issue.

#### **Internet blocked**

In the national capital, the police – which is under the Union Home Ministry – detained people from various locations and thwarted a demonstration. Mobile phone and Internet services were cut in parts of the city and 19 stations of the Metro Rail in central Delhi were shut but hundreds managed to assemble at Jantar Mantar, an earshot from the parliament building. Around 700 flights were delayed and 20 were cancelled in Delhi.

## Over 1,200 protesters held, later released

The Delhi police on Thursday detained more than 1,200 protesters, including politicians D. Raja, Sitaram Yechury, Nilotpal Basu, Brinda Karat, Ajay Maken, Sandeep Dikshit and activists Yogendra Yadav, Umar Khalid, from central Delhi during anti-Citizenship (Amendment) Act protests in the national capital.

"Around 800 protesters, detained from near the Red Fort, Mandi House and other areas in central Delhi, were let off after a warning. Nearly 300 of them were taken to Surajmal Stadium in Nangloi, around 100 to Rajiv Gandhi Stadium in Bawana and another 50 to Keshavpuram. They were all released by evening," said Delhi police spokesperson M.S. Randhawa.

Donald Trump on Wednesday became the third U.S. President to be impeached as the House of Representatives formally charged him with abuse of power and obstruction of Congress in a historic step that will inflame partisan tensions across a deeply divided America.

The Democratic-led House's passage of two articles of impeachment on a mostly party-line vote sets the stage for a trial next month in the Republican-controlled Senate on whether or not to convict and remove him from office.

No President in the 243year history of the U.S. has been removed from office by impeachment. That would require a two-thirds majority in the 100-member Senate, meaning at least 20 Republicans would have to join the Democrats in voting against Mr. Trump – and none has indicated they will.

## 'No chance'

The Senate's top Republican, Mitch McConnell, has predicted that there is "no chance" his chamber will re-

House Speaker Nancy Pelosi said after the vote that she would wait to name the House managers, or prosecutors, until she knew more about the procedures for the Senate trial. She did not specify when she would send the articles to the Senate.

Mr. Trump, 73, is accused of abusing his power by pressuring Ukraine to investigate political rival Joe Biden, a leading contender for the 2020 Democratic presidential nomination, as well as a discredited theory that Democrats conspired with Ukraine to meddle in the 2016 election.

# Amid Net shutdown, CM opens free Wi-Fi hotspot

'Centre must focus on jobs, not CAA'

NEW DELHI On a day when Delhi saw suspension of mobile services, including Internet, for the first time, Chief Minister Arvind Kejriwal presided over the inauguration of free Wi-Fi hotspot installation at the ITO bus stop here as part of the Aam Aadmi Party government's flagship project aimed at providing free public access to Internet across the Capital.

The irony of the situation was not lost on the CM, who said, "It is ironic that Internet services are down today [Thursday] because the police have asked for them to be shut on the day when we are launching this project...We hope that the situation normalises soon and the services resume."

#### 109 hotspots installed

According to the Delhi government, 109 free Wi-Fi hotspots were installed in Delhi to mark the launch of the scheme. Deputy CM Manish Sisodia marked the launch of the project at Vishwavidyalaya metro station.

Internet services were shut down at several locations, including ITO, on a request by the Delhi police,

# Students, locals walk for kms over restrictions

Red Fort remained off limits for protesters and tourists

As Delhi Police barricaded the area around Red Fort, students of nearby schools, tourists, locals and shopkeepers faced issues due to blocked roads. Munza, a Class XII stu-

dent of a convent school near Red Fort, walked past the monument holding her younger sister's hand with their mother walking ahead. "When I went to school in the morning, it was all okay. I had taken a rickshaw. But later in school, we were informed about the protest and our parents were called to take us home. No student was allowed without parents," she said, adding that she had to now walk nearly

2 km carrying a heavy bag. Another worried mother who identified herself as Shikha Jain was on her way to work when she realised that roads were blocked and her two sons aged five and seven studying in two private schools nearby won't be able to come back home in their usual rickshaw. "They should have given an alternative route. Now, I will

have to miss half day's work to make sure my children reach home safe," she said.

Daleep Kumar was on his way to school to bring his son when he was stopped by the police who asked him to show his son's school identity card. He reasoned with them that the identity card is with his son but the official didn't let him go for nearly 20 minutes till he managed to convince him.

Senior citizens - Anoop Kumar (73) and Satish Bhatiya (64) - who run a shop in Chandni Chowk and had their vehicles parked at Shanti Van were also

stopped and asked to take a longer route but were later allowed after the situation started to get tense.

Several tourists, including foreigners, also left disappointed as the entry to Red Fort was closed for the

Shops in the adjoining Chandni Chowk area mostly remained open and business remained marginally affected. "People who had come for shopping are being troubled because of the blockade. But it hasn't affected business," said Rehman Malik, who runs a speakers' shop.

Hundreds of protesters were pushed inside buses parked right outside the Red Fort. Barricades began a km ahead of the main entry point of the Red Fort. People trying to reach the place were stopped at every barricaded point and were asked questions.

"They asked us if we had gone there to take part in the protest or for some other purpose. Before we could answer, we were told that if we had gone to protest, we should either go back or get

# Capital locked as DMRC closes 19 of its stations over protest

Major transit points like Central Secretariat, Rajiv Chowk closed for hours

As protests rock the Capital over the amended Citizenship Act (CAA), the Delhi Metro Rail Corporation (DMRC) on Thursday closed as many as 19 metro stations across the network. Several commuters were left stranded especially at key interchange stations with their plans for the day going for a

"How long can they keep metro stations shut? People have to go on with their lives," said Zanab Khan, who was stuck at Rajiv Chowk, attempting to make her way to the demonstration at Jantar Mantar.

The first few stations to be closed were Jamia Millia Islamia, Iasola Vihar Shaheen Bagh and Munirka on the Magenta Line; Lal Quila and Jama Masjid on the Violent Line and Chandni Chowk and Vishwavidyalaya on the Yellow Line. Subse-

quently, the DMRC closed entry and exit gates of Patel Chowk, Lok Kalyan Marg and Udyog Bhawan on the Yellow Line; Pragati Maidan and Barakhamba Road on the Blue Line and ITO, Khan Market and Mandi House on the Violent Line.

DMRC officials said that the stations were closed following directions from Delhi Police in view of the protest marches that took place in Red Fort, Mandi House and Jantar Mantar. Major transit points like the Central Secretariat and Rajiv Chowk were also closed for nearly six hours and two hours respectively. However, the interchange facility was available to commuters during

this period, officials said. Janaki Fernandes, also part of the protests, said

that the shutting down of metro stations was "dictatorial and terrifying". Terming the move "draconian", she asked "Is the government showing that it is afraid by curbing all this?"

Others, however, argued that the government was well within its rights to take security precautions. Ram Anand, who had been waiting at the Rajiv Chowk Metro Station for about half an hour, said that the move caused inconvenience to the public but it is the government's wish, they can do whatever they want to control the situation.

Meanwhile, DMRC officials said: "As a precautionary measure amid protests, Delhi Metro had to close the gates of a few metro stations. The safety of our passengers and security of metro property is paramount to us and we have to ensure the same as per the advice given by authorities.'

## Remove objectionable content: police to social media

Details of accounts sent to companies

The Delhi police cyber cell has asked social networking companies to shut down 50 accounts for spreading rumours during the protest against amended Citizenship Act (CAA) in the Capital, said a police officer on Thursday.

The officer added that they have identified 70 accounts on social media, which were spreading rumours regarding the Act and posting various deepfake videos. Fifty such accounts were kept under the scanner for the last two days.

The details of these 50 accounts have been sent to the social networking companies and they have been asked to shut these accounts with immediate effect, he

"The accounts were operating from outside Delhi. We have also blocked more than 20 websites for posting inflammatory material. We are also keeping an eye on Pakistani twitter handles engaging with twitter accounts in India," the officer added.

Meanwhile, the intelligence wing of the Delhi police has issued a fresh advisory and instructed police to immediately hold a meeting with Imams of all mosques in the city and asked them to request people to maintain peace.

#### **Meeting with Imams**

"We held a meeting with U.P. and Haryana Police to stop the mass movement of protesters to Delhi. We are meeting with Imams of various mosques and requesting them to stop any kind of protest after Friday's prayer meeting," the officer added.

He added that they have requested the people to reach out to local police or any other senior officers in case if they have any doubt over the CAA or if they want to share any information with the police.

"We are requesting teenagers to maintain peace and not to circulate any unverified videos or any other inflammatory material on social media. Do not be part of rumour-mongering," he ad-

# Delhi, Gurugram face bottlenecks over anti-CAA stir

Several arterial roads and major parts of central Delhi witnessed heavy congestion on Thursday due to barricades put up by the police to prevent people from reaching the protest venue.

Traffic snarls were common across the city with the situation on the border areas turning worse as the Delhi police barricaded roads and imposed traffic restrictions to clampdown on planned protests against the CAA.



Thousands of protesters opposing the amended Citizenship Act, who were stopped by the police from taking out rallies from Mandi House and Red Fort, and the ones who were detained during the day, made their way to Jantar Mantar to hold demonstrations denouncing the Act on Thursday.

"After today's protests, this day will go down in history," said Yogendra Yadav, addressing a crowd at Jantar Mantar on Thursday evening. He was detained form Red Fort here earlier in the day.

Permission for Left parties' protest march from Mandi House to Jantar Mantar had been denied shortly before it was scheduled to begin. "The police were detaining people left, right and centre and tried to scatter us." said Srinjoyee Dutta (27), an ad hoc professor at Indraprastha College for Women.

"I saw the police taking away at least four bus loads of people from Mandi House." said Shuddhabrata Sengupta, an alumnus of Jamia Milia Islamia. If the government wants to divide the protesters, the city will witness more protests," he added.

Capital's air quality enters 'very poor' category; light rainfall likely tomorrow

The minimum temperature in the Capital dropped to 5.2 degrees Celsius on Thursday, the lowest this season, according to Regional Meteorological Center, New Del-

On Thursday, the air quality of the city deteriorated to the upper level of 'very poor' category and is expected to be 'severe' in some parts of the city on Friday, chiefly owing to slower winds, according to government-run monitoring agency System of Air Quality and Weather Forecasting and Research (SAFAR). The minimum temperature on Thursday was three notches lower than the season's normal, while the maximum settled at 15 degrees Celsius, 7 degrees colder than the season's normal, said India Meteorological Department.



## 'Students boycotting exams ineligible to register for next'

Schedule will be posted on JNU website

Jawaharlal Nehru University (JNU) has warned its students who are boycotting exams that they will not be eligible to register in the next semester if they fall short of the academic requirements of institution.

In JNU, evaluation of students is conducted in different modes - home assignquizzes, term papers, presentations, sessional examinations etc., it

Since bona fide students are prevented from writing the end-semester examinations by some protesting students, the Deans of Schools and Chairpersons of Special Centres have decided to give 'take-home exams' to the students, the university said.

"Those who refuse to write the exams on their own will, in spite of the fact that the university is making every effort to conduct the examinations, will not be eligible to register in the next semester if they do not fulfil the academic requirements as per university ordinances," the university administration said.

Willing students will have the opportunity to write the exams, it added.

"Protecting the academic interests of bona fide students is the top priority. Deans of Schools and Chairpersons of Special Centres will prepare the schedule and post on the JNU website," the university said.

Stone-pelting on police in Khandwa

Protests against the new citizenship law and the proposed NRC swept through a dozen districts of Madhya Pradesh as the Congressruled State joined the nation-wide agitation against the Centre's twin controversial measures.

The protests were held against the National Register of Citizens (NRC) and the Citizenship (Amendment) Act (CAA) in 12 districts - Bhopal, Shajapur, Khandwa, Khargone, Seoni, Gwalior, Betul, Ratlam, Barwani, Sagar, Ujjain and Panna, a police officer said.

Prohibitory orders under CrPC section 144, banning assembly of people, were clamped in 43 of the 52 districts in the State, he said.

The protesters included members from various sections of the society.

#### 'No untoward incident'

MP Police State Situation Room Inspector Harman Lakra said the protests were peaceful and no untoward incident has been reported from any of these 12 districts.

Prohibitory orders have not been imposed in nine districts - Guna, Shivpuri, Alirajpur, Dhar, Betul, Dindori, Hoshangabad, Tikamgarh and Niwari districts, he added.

In some districts, the CrPC section 144 was clamped on Wednesday and in others on Thursday

morning, he added. In Khandwa, protesters returning from the site of an anti-CAA agitation pelted stones at police, resulting in tension in the communally sensitive town, officials said.

Police wielded batons to disperse the stone-pelting crowd which damaged a car, they said.

#### Section 144 defied

Defying prohibitory orders imposed in the town, a large number of people gathered in the Idgah area to protest against the CAA and the proposed nation-wide implementation of the NRC.

After the end of the 'Save the Constitution' protest, agitators were returning from the site in form of a rally when the police intervened, an official said.

The police asked the protesters, who were raising slogans, not to take out the rally, he said.

This angered the marchers who pelted stones at police personnel in Imlipura and Bada Bam areas, causing tension in the communally sensitive town, the official said.

Police baton-charged the stone-pelters, who damaged a car and a few other properties, he said.

Stating that the amended Citizenship Act was against the Constitution, the demonstrators demanded that the new law should be withdrawn without delay.

The leaders observed

that granting citizenship to foreigners on the basis of their religion and exclusion of Muslims from its purview amounted to sacrificing secularism and ethos of the Constitution.

The parties which took part in the demonstration include CPI(M), CPI, Forward Block and CPI(M-L). Many senior leaders of these parties in the State took part in the protest.

CPI(M) Odisha State Committee secretary Ali Kishor Patnaik also criticised Chief Minister Naveen Patnaik for supporting the Act. The BJD's support to the CAA and opposition to the National Register of Citizens was mischievous, he said.

A separate demonstration was also organised by the CPI(M-L) Red Star where the demonstrators burnt the effigies of the Prime Minister, the Union Home Minister and Chief Minister.

# Policemen injured as protest turns violent in Ahmedabad

Protesters pelt stones after police lob tear gas shells to disperse crowd

A protest against the Citizenship Amendment Act (CAA) and the National Register of Citizens (NRC) in the Shah-E-Alam area here turned violent on Thursday, with at least five policemen injured in stone pelting. The police lobbed teargas shells to disperse the mob of around 2,000 in the Muslim-dominated area.

Protesters shouted slogans and held placards saying, "No CAB No NRC." When the police tried to disperse them, the crowd started throwing stones and brick pieces.

A video clip aired by a local news channel showed agitators hurling stones at polvehicles. policemen at the site can be seen taking cover behind moving police vehicles from the stones coming from both sides of the road.

Another video showed some people thrashing a policeman who fell from a moving police bus.

# CAA-NRC cast shadow on Goa arts festival, 4 artworks sealed

Stand by each piece of work, says curator Sudarshan Shetty

The citizenship law over which protests have erupted across the country has cast a shadow on the Serendipity Arts Festival here with an exhibition featuring artworks related to the newly enacted Citizenship Amendment Act (CAA) as well as the National Register of Citizens (NRC) "temporarily sealed" on Wednesday.

On being reopened a few hours later, three of the 27 artworks in the exhibition, 'Look Outside This House', curated by leading artist Sudarshan Shetty as part of the visual arts segment of the festival, were found to be either removed, non-functional or shut.

#### 'Troubled, pained'

While the Serendipity Arts Foundation that organises the annual multi-disciplinary festival cited a "technical glitch" as the reason, Mr. Shetty said he felt "troubled and pained at the situation we have come to," and that he stood by "each piece of work in the show."

One of the videos is that of 'Miyah poets' of Assam, which talks of violence and discrimination and the alleged threat of statelessness due to the country's changing socio-political climate. The second one invited viewers to write on wallsized canvases with ink created out of carbon in the air and featured some anti-CAA/NRC scribbles three

days into the festival. The third video, which was supposed to showcase sensor-fitted goggles for the blind, carried the caption, "Due to the ongoing protests against the Citizenship Amendment Bill in the Northeast, we could not procure the goggles for the blind in time for this show."

A statement quoted Mr. Shetty as asking such a caption should be a problem. "Or why a few by chance scribbles on a white wall about the [CAA/NRC] by exhibition visitors ... or two poems of lament about the

NRC and politics about immigration by poor men who have lost their family members to violence, should have upset/ disturbed/ frightened people is difficult to accept," he said.

The foundation was not available for comment.

#### **Band members held**

Meanwhile, four members of the band Dastaan, which performed at the festival on Tuesday, were arrested by the Goa Police on Wednesday for allegedly hurting religious sentiments. Band members Sumant Balakrishnan, Anirban Ghosh, Shiva Pathak and Nirmala Ravindera, were arrested under Section 295-A of the Indian Penal Code.

A complaint by Venkat Krishna Kunduru alleged the band insulted the Hindu religion by mixing chants of 'Om' and abusive language. All four were released on bail bonds of ₹20,000 each, a senior police officer said.

The festival will continue till Sunday.

# FTII hunger strike against high fees enters fourth day

Management firm on hike, students want Ministry to intervene

The indefinite hunger strike called by students of the Film and Television Institute of India (FTII) to protest steep annual fee hikes as well as the allegedly prohibitive cost of the FTII entrance exam entered the fourth day on Thursday, with the administration refusing to yield to the students' demands.

A total of 11 students – six from the FTII and five from the Kolkata-based Satyajit Ray Film and Television Institute (SRFTI) – are now on relay hunger strikes in Pune and Kolkata.

As many as 400 FTII alumni, several eminent film personalities among them, have signed a petition condemning the joint entrance fee hike and urging the Information and Broadcasting (I & B) Ministry to give urgent attention to the issue of the students' hunger strike.

A statement issued by the FTII Students' Association (FTIISA) said that since "the [FTII and SRFTI] authorities are turning a blind eye to the situation the students request the immediate intervention of I&B Minister Prakash Javadekar in the

"Even as the health of the students deteriorates on the fourth day of our strike, the administration is not heeding our concerns...While four students had initially gone on strike on December 16, two more from the 2018 batch have joined the protest," said Rajashri Majumdar, general secretary of the students' association.

the admission fee are a huge burden for current and future students, many of including my whom. daughter, have taken bank loans and other education loans to pursue their studies. Keeping in mind the deteriorating health of the students, I would request higher authorities to urgently address this issue," said Anuradha Ghosh, a parent of one of the students sitting on strike.

The students' association maintained that the joint entrance test (JET) fee to the FTII and the SRFTI ranged from ₹4,000 to ₹10,000, a sum clearly beyond students from the middle and

lower middle class sections. "While premier postgraduate institutes like the FTII and SRFTI should stand for affordable education for all sections of society, the present entrance exam fee and the overall tuition fees are excessive and prove that the government is bent on making education unavailable for the financially underprivileged sections by turning institutes like these into profit-making machines," read the FTIISA statement.

The FTII administration has convened a special governing council meeting on December 27 in Delhi to address the crisis. However, the students'

association accused the administration and the I & B Ministry of "ignoring the fact that the lives of the striking students are at grave risk" by convening the governing council meeting eight days hence, instead of trying to resolve the issue as quickly as possible.

"The Chairman of FTII is refusing to prepone the date of the governing council meeting and despite repeated attempts, the Ministry is not responding to our calls or emails," claimed the students' association, adding that the hunger strike would continue till their demands

# Pune NGO develops 'cheaper, more reliable' meter to measure strength of concrete

Research foundation claims its 'maturity meter' reduces margin of error and is priced lower than foreign meters, which are currently in use

The Pune Construction Engineering Research Foun-(PCERF) developed what it claims is the country's first indigenous Concrete Maturity Meter that determines the strength of concrete used in construction. PCERF is a a non-profit organisation that works to new cost-effective technologies in the sector.

The device can help in significantly reducing the margin of error in estimating the

strength of a structure while cutting project costs as well. "This diminutive device, which we have dubbed as the 'Intelligent Concrete Maturity Meter', is affordable and easy to use. It will be available at 30% to 40% of the cost of the foreign maturity meter that is in use in the market," said Vishwas Lokare, president, PCERF.

Despite the importance of concrete in infrastructure construction, its in-place strength is often erroneously estimated by using the cumbersome and time-consuming 'standard cube' or cylindrical tests, said Dr. Hemant Dhonde, an executive member of PCERF, who developed the instrument along with another structural engineer, Dr. Rajesh Ghongade.

**Improving accuracy** "These methods are destructive and less accurate, which leads to many glitches in the development of the structure. To counter that, the Maturity Method, which is a 30year old proven Non-Destructive Testing method, is

used to estimate the real-

time and realistic strength development of in-place concrete." Dr. explained.

Considered as more reliable, the method is based on the principle that concrete strength is directly related to its hydration (temperature) and age (time). However, it is mostly used in major infrastructure enterprises in foreign countries and seldom in major Indian construction projects. A foreign-produced maturity meter was also used in the construction of the Bandra-Worli Sea Link in Mumbai.

"The Indian maturity meter will be able to measure the strength of concrete accurately at a lower cost, to the advantage of the construction sector. The equipment has been tested and is ready for commercial use," said Mr. Lokare

The device, which can be directly connected to mobile phones, has been specifically developed to suit the techniques and skills of end users in India.

"By using this maturity meter, one can have savings of around 10% to 12% of the overall project," said Mr. Lo-

The foreign-made maturi-

ty meter kit is available in the range of ₹3 lakh to ₹5 lakh, while the India-produced maturity meter kit is priced between ₹50,000 and ₹5 lakh, he said. He said PCERF had recent-

ly filed a patent for the meter. The device will be presented at the 16th edition of an International Expo called 'Constro 2020' organised by PCERF, to be held next month.

# Centre's crackdown autocratic: Pinarayi

Anti-CAA protests continue in Kerala

Kerala Chief Minister Pinarayi Vijayan on Thursday lent his support to the growing protests against the Centre's alleged move to stifle public expression of resistance to the "anti-Muslim" bias in the recently enacted Citizenship Amendment Act (CAA), 2019.

In a social media post, Mr. Vijayan condemned the arrests of CPI(M) general secretary Sitaram Yechury, Polit Bureau member Vrinda Karat and CPI general secretary D. Raja in New Delhi and historian Ramachandra Guha in Bengaluru. CPI(M) State secretary Kodiyeri Balakrishnan joined him in censuring the Centre.

Mr. Vijayan said that by arresting protesters, incarcerating their leaders, and robbing citizens of the freedom of movement and speech, the BJP-led NDA alliance at the Centre had displayed an authoritarian character not witnessed in the country even during the dark days of Emergency.

The "repressive character" of the Centre was evident in its decision to disallow the Left parties and the students of Jamia Millia Islamia their constitutional right to dissent.

The Centre had shut down Internet and mobile phone networks in parts of New Delhi to choke freedom of expression and prevent citizens from mustering themselves in defiance against the law, he wrote.

He said the Centre could not force the entire nation into silent submission. He wanted the law to be revoked. Kerala has cobbled together a united political front against the Act, he said and pointed out the State was in the forefront of the growing protests against the Centre's "illiberal actions."

Demonstrations resounded across the State for the second consecutive day on Thursday. In Thiruvananthapuram, the police fired water jets to disperse a group of DYFI activists who attempted to storm the Raj Bhavan. SFI activists held protest in Kollam. CPI State secretary Kanam Rajendran led protest in Kochi. The Jamat-e-Islami and the Muslim Youth League staged protest rallies in Malappuram.

# Kin of accused in Disha case move SC

They seek compensation of ₹50 lakh

The relatives of the four accused in the Disha rape and murder case, who were killed in a shootout with the police, moved the Supreme Court on Thursday, seeking a CBI probe into the deaths.

The relatives also sought compensation of ₹50 lakh each for the families of the accused.

The petition asked the court to call for all the police records prior to and after the "encounter" that occurred in the early hours of December 6. The petition also wanted the CBI investigation to cover the conduct of Cyberabad Police Commissioner V.C. Sajjanar.

On December 12, the court set up an inquiry commission, led by Justice V.S. Sirpurkar (retired), to probe the circumstances of the "encounter" deaths.

The Commission, which includes Justice Rekha Bal-

dota (retired) of the Bombay High Court and retired CBI Director Karthikeyan, was given six months to complete its investigation. Advocate K. Parameshwar was appointed counsel for the Commission.

The court also stayed the proceedings in the Telangana High Court and the National Human Rights Commission into the incident.

The accused – Mohammed Arif, Chintakunta Chennakeshavulu, Jollu Shiva and Jollu Naveen – were taken to the scene of the crime around 60 km from Hyderabad in the early hours of December 6 for a reconstruction of the crime

According to the police, the accused surprised their escorts, grabbed their guns and tried to kill them in a bid to escape. The members of the team then retaliated and the accused were killed in the crossfire.

# Land belonging to Kalki group attached

Nearly 907 acres of land belonging to the Kalki group, owned by self-styled godman Kalki Bhagwan has been provisionally attached under the provisions of the Benami Transactions (Prohibition) Act, sources said in Chennai on Thursday.

About 400 acres is located at Satyavedu in Andhra Pradesh and other parcels are in Arani, Udhagamandalam, on the outskirts of Coimbatore, near Madurai and in Belgaum.

Sources said the Initiating Officer of Benami Prohibi-

tion Unit (BPU) under the Income Tax Department, Chennai, had issued attachment orders under Section 24(3) of the Act, and sent them to the respective Sub-Registrars. The provisional attachment is for 90 days.

In October, the I-T Department conducted searches on the group and said preliminary estimate of unaccounted cash receipts was ₹409 crore from the financial year 2014-15 onwards. About 90 kg of gold, and over 1,000 carats of diamonds and ₹150 crore of unaccounted cash were also unearthed, sources said.

# <sup>+</sup> Unlike Bengal, Kerala may update Population Register

It may be updated between April 15 and May 29 next year

Kerala may update the National Population Register (NPR) though the West Bengal government, which also opposes the Citizenship (Amendment) Act (CAA), has stalled it.

Early this week, the West Bengal government withdrew all activities related to the NPR. The Census Cell of the Home and Hill Affairs Department had communicated to the officials concerned that all activities regarding

preparation/updating of the NPR have been suspended. No activity regarding the NPR may be taken up without the prior clearance from the State government, it informed the officials.

The anti-NPR campaigners had criticised the register as the first step towards the preparation of the National Register of Citizens.

NPR is scheduled between April 15 and May 29 next year. The register will be updated along with house listing and housing census to be carried out in the State.

Slum areas

The details of slum areas in each municipality will have to be obtained in connection with the first phase of the census and the updating of the NPR, said a communication issued by the Director of Census Operations, Kerala.

The objective of the NPR, according to the website of the Office of the Registrar General and Census Commissioner, India, is to "create a comprehensive identity database of every usual resident in the country. The database will contain demographic as well as

biometric particulars.' In Kerala, updating of the It is "mandatory for every usual resident of India to register in the NPR."

The website defines a usual resident "as a person who has resided in a local area for the past six months or more or a person who intends to reside in that area for the next six months or more," it said.

Issued before row

In Kerala, the notifications regarding the updating of the NPR were issued before the controversy over the CAA surfaced.

There has not been any directive from the State government regarding stoppage of the NPR, said senior officials.

A senior functionary with the directorate maintained that he was unaware of any order for stopping the

# + Onion imports yet to bring price relief to customers

Bulbs likely to reach Delhi, A.P. retail markets over weekend

the Central government in a bid to counter domestic shortages and tame soaring prices are set to enter the retail market – mostly in Delhi and Andhra Pradesh - by Saturday, according to officials from the Consumer Affairs Ministry.

On Thursday, the Ministry announced that public trading agency Metals and Minerals Trading Corporation (MMTC) has contracted to buy an additional 12.500 tonnes of onions from Turkey, taking the total contracted imports to 42,500

However, customers suffering under a prolonged price surge are yet to see any of these imported onions.

According to Ministry officials, just over 1,000 tonnes of imported onions have arrived in the country so far. That initial shipment arrived at the Mumbai port last Sun-

day, but due to procedures to fumigate and clean the onions, their arrival in the retail market has been delayed. The initial buyers are state-run National Agricultural Cooperative Marketing Federation of India (NAFED), which has been supplying subsidised onions in the National Capital Region, and the Andhra Pradesh State government, said a Ministry official.

Retail prices in Delhi have not dropped below the ₹100 per kg mark for the last two weeks (since December 5). In fact, they peaked at ₹145 per kg on Wednesday, according to data from the National Horticulture Board.

The situation is particularly severe in southern India, with onions selling for ₹160 per kg in Chennai on Thursday, and ₹120 per kg in Hyderabad and Bengaluru.

## Protest and order

Authorities should facilitate expression of views, not suppress rights

The duty of the state to preserve public order should never extend to the suppression of political views contrary to those of the government. It is quite unedifying for the state to use its power to regulate public protests to negate the people's right to assemble peacefully. The State-wide clamping of prohibitory orders under Section 144 of the Code of Criminal Procedure in Uttar Pradesh and Karnataka are stark examples of the misuse of regulatory power to suppress the lawful exercise of constitutional rights. As protests against the Citizenship (Amendment) Act escalate in several cities and towns, the invocation of Section 144 in a whole State does not seem to be in conformity to the general rule that such a restriction on fundamental freedoms should be "reasonable, least invasive and bona fide". On top of it, Internet and mobile phone services were suspended and some Metro Rail stations shut down in Delhi. Restrictions wider than necessary tend to suppress rather than regulate. Were all these steps justified, especially in the light of judicial pronouncements that draw the limits of the power to regulate assemblies? The apex court has often said an order under Section 144 has to be reasonable and be "minimal". It meant that the order should be limited to specific localities, and in response to a particular situation. "Such restraint should not be allowed to exceed the constraints of the particular situation, either in nature or in duration," it observed.

A widespread protest may indeed regress into violence, but "the perception of threat to public peace and tranquility should be real and not imaginary or a mere likely possibility," the court observed, while examining the lawfulness of the police action on a gathering of peaceful protesters at Delhi's Ramlila Maidan in 2011. In this backdrop, the action of the police in Bengaluru and Delhi in preventing protesters from gathering, and the denial of permission to hold any protests in several other places, was excessive. An orderly assembly armed with a permission that contains limits on duration and number is normally not likely to degenerate into violence. It is somewhat satisfying that in most cities, the protesters gathered peacefully or courted arrest. However, the incidents of disturbances from a few cities, including the police firing in Mangaluru, underscore the burden cast upon the state in protecting the constitutional guarantees of peaceful dissent on the one hand, and public order on the other. On the political side, India's leadership will have to respond to the widespread public fears over the implementation of the new naturalisation norms. On the administrative side, however, the authorities should aim to facilitate the exercise of the people's rights, rather than suppress them.

## Not unimpeachable

Trump is unlikely to be removed as President, but the rebuke will hurt

Tnited States President Donald Trump made history, albeit not in the way he would have dreamed, when he became only the third incumbent to get impeached by the House of Representatives. On Wednesday, the House impeached him on two articles, one each for abuse of power and obstruction of Congress. The first article relates to Mr. Trump withholding \$391 million in military aid and a White House meeting unless Ukraine President Volodymyr Zelensky agreed to investigate the business dealings of the family of Democratic presidential frontrunner Joe Biden – in other words, a bid to discredit domestic rivals through foreign influence. This article, which identifies a violation of the oath of office and a breach of national security, passed by 230 votes to 197, with the entire Republican membership opposing it. The second article relates to the charge that Mr. Trump obstructed the Congressional probe into abuse-of-power allegations by urging witnesses not to cooperate and asking federal government agencies to disregard subpoenas. This passed by 229 votes to 198. Now, the matter passes into the hands of the Senate. Given that a two-thirds majority, or 67 Senators, is required to convict and to remove Mr. Trump from office, and the chamber is split between 53 Republicans, 45 Democrats and two independents who caucus with the Democrats, an acquittal is expected.

Yet, two things are certain: first, no matter Mr. Trump's popularity with his constituents and the current global mood leaning towards nativist populism, the impeachment is a stain on his reputation and a historic rebuke that will never fade in the annals of infamy. Second, and more worrying for prospects of harmony within the American union, the impeachment will drive a deeper wedge between the two opposing political discourses of a polarised electorate. Already, the Democrats led by House Speaker Nancy Pelosi have indicated that they might withhold articles of impeachment from the Senate for some time, effectively delaying the trial in the Upper House until there is more clarity around the rules that the latter will set for the trial. If this becomes a protracted and hostile engagement across the two chambers, it could muddy the waters during the upcoming election year and make the campaign even more vicious than that of 2016. Going beyond the impeachment, however, it might be possible to bridge the chasm between Mr. Trump's detractors and supporters only if a conversation is initiated to retrieve the spirit of bipartisanship on issues such as immigration, trade, climate change, gun control, racism and minority rights. The alternative route may well lead directly to a political purgatory for one of the world's oldest democracies, and that is likely to hurt.

# In thrall to its own violence

In its second innings, the Modi government has turned its back on conciliation, with dire consequences for the polity

s to why the Narendra Modi regime has succeeded in pushing the country into a needless, but harmful, instability, a clue is available in Union Home Minister Amit Shah's opening remarks when he piloted the Citizenship Amendment Bill in the Rajya Sabha. The Minister cockily argued that his government was perfectly aware that the proposed amendment would be a controversial law, but he was prepared to be disagreeable. The Minister's refrain was that if there was a 'problem', it had to be 'solved', because, unlike the earlier ruling arrangements, the new regime was not given to procrastination.

That is perhaps the rub. After the 2019 Lok Sabha mandate, the composition and character of the Modi government stand changed. The new team has gone out of its way to convey a new sense of urgency to take up the old priorities. This clear-headedness has turned out to be a mixed blessing.

#### Breaking with Vajpayee era

There is no one in the inner councils of the decision-making who has had any kind of familiarity with the Atal Bihari Vajpayee-L.K. Advani era's working and how it tried to govern this complex land; it was a regime that successfully managed to fight a war with Pakistan, exploded 'the bomb', and steered the economy out of the Washington-led sanctions against India – and much more, without creating new, debilitating fault

lines at home. The tone and temper of the Vajpayee regime was defined by a prudent impulse. With the passing away of Sushma Swaraj and Arun Jaitley in recent months, the 2019 government has apparently settled into a new working idiom, with a dangerous imbalance at the core of the Indian state. The Prime Minister stands very tall, much taller than all his ministerial colleagues; with the possible exception of the Home Minister, no Cabinet colleague has the stature or the prestige to introduce a note of caution in the face of any proposed policy recklessness or political waywardness.

There is no one like a Lord Peter Carrington, who as Foreign Secretary could tell an overbearing Margaret Thatcher "that she was being impossible" in her treatment of colleagues or in insisting on a policy extremism. Arguably, the Modi government suffers from a lack of equilibrium in its collective working; and, inevitably, the entire ruling cabal ends up feeding the Prime Minister's ingrained confrontationist instincts. This itch for confrontation has produced an unhappy consequence for statecraft and political management: the option of conciliation invariably stands spurned. There is a new fascination for aggression, a new appetite for skirmishes and combats. And, this belligerence is deemed to be politically satisfying and electorally rewarding.

It needs to be recalled that the Vajpayee-Advani government subscribed, during most of its six years in power, to a wise policy prescription: it was inclined to believe that while it was possible for a political party like the Bharatiya Janata Party (BJP) to win a Lok Sabha majority without the Muslim vote, it would be unhelpful to try to govern the country without the



cooperation and support of the largest minority. Political wisdom demanded that a group numbering over a hundred million people not be allowed to sulk in its corner. In a democracy, the leaders engage in dialogue and seek conciliation, and, as Albert Camus put it in The Rebel, it is only "tyrants [who] conduct monologues above a million solitudes."

#### No appetite for compromise

In the Modi-Shah era, this preference for accommodation and partnership stands virtually abandoned. The tweaked proposition is: not only can the BIP win a majority without the Muslims' vote, it can also govern without their support and can live without their trust or confidence or affection. Admittedly, from time to time, the ruling party comes up with catchy slogans, paying politically correct lip service to the idea of inclusiveness; but, in day-to-day governance. the accent is on catering to the Hindu majority's sensibilities, and if the minorities take offence. so be it. There is a calculated confidence that any group, however unhappy or large, can be tamed. The post-Article 370 Jammu and Kashmir is cited as a satisfying and successful application of this nononsense, no-weakness, no-accommodation approach.

Every citizen, every group, and every community subscribes to its own notion of justness and fair play. This may differ from the neighbour's idea of justice; but the task of every ruler is to reconcile differing notions of justness, without gratuitously making any group feel that it has been permanently dealt a raw hand. During the first Modi govern-

ment, there was an eager promotion of violence in words; verbal aggression was encouraged not iust on social media or in television studios, but it was approvingly looked upon as a sine qua non to tell the whole world that the ancien regime had truly been put in its place. In the process, a certain debasement of democratic decencies was inevitable, but was celebrated as a much needed jettisoning of the old 'dogma.'

Now, with 300-plus Lok Sabha seats under its belt, the ruling party has developed a fascination for authoritative violence. Coercion and violence are deemed as a curative instrument of state policy and political control. This gathering belief in the usefulness of state violence has led to an indifference to international criticism or disapproval of the civil society at home. Each act of criticism, in fact, is pugnaciously depicted as a challenge to our nation, its security and its nationhood. The notion of 'police brutality' stands, almost, beautified.

On the other hand, any protest or resistance in the streets against the government's policies or politics is branded as inspired by vested interests, or worse, instigated by Pakistan or by 'urban naxals.' Any resistance is seized upon as an excuse for further state violence.

The ruling clique finds itself emboldened and confirmed in its confrontationist impulses, partly because a very sizable chunk of the media has reoriented itself to being the government's mouthpiece, and also partly because the judiciary is no longer available as a forum of relief to any aggrieved citizen. No government could ask more than a sitting Chief Justice of India batting publicly, outside the court, for the flawed National Register of Citizens (NRC).

Mismanagement of economy

This fascination for violence, aggression, bullying and intimidation has had a particularly telling effect on the government's management of the national economy. Even otherwise, its paucity of talent, its weakness for mediocrity has already been felt; but, now, the danda approach has compounded the situation. Corporate India senses a fear in the air but is not permitted to voice its apprehensions. No \$3 trillion economy is amenable to coercion or slogans or to prime ministerial fiats.

Yet, the regime remains enamoured of its own intransigence, without comprehending that so early in its second innings, the government's trust stands considerably eroded. The Prime Minister allows himself to deploy extremely divisive vocabulary when out on the election trail in Jharkhand but, back in New Delhi, he feels he is entitled to respect and trust of all citizens and pretends to be baffled that large number of citizens are apprehensive about the CAA.

A regime that has developed a taste for coercion, however legitimate or legal, and a passion for aggression, ends up squandering the citizens' trust. The Modi regime has ordered its own custom-made Achilles heel.

# Inaccurate diagnosis, draconian remedy

India's black money problem was misdiagnosed; unverified, exaggerated numbers went into enactment of harsh laws

ndia's fight against foreign black money has returned a whimper. The government's intent cannot be faulted, but since the obiem usen was misdiagnosed, the ensuing legislative measures have been bereft of constitutional and economic common sense. They relied too little on persuasion, and far too much on browbeating. The economic results are nothing to rave about.

High on populism, low on constitutional wisdom, the Black Monev Act was a draconian law that was bound to fail. At minimum tax rate of 60%, it gave marginal incentive for the hoarders to come clean. Lawmakers overestimated the writ of international laws and made no economically persuasive case. Resultantly, as of May 2019, the total untaxed foreign assets mined was ₹12,500 crore. Wholly recovered, this wouldn't even pay Prasar Bharati's bills for four years. Even this recovery was aided greatly by international exposes such as the Panama Papers in which the government's legislation had no role to play. In comparison, Indonesia recovered about ₹25 lakh crore under similar schemes. The government's initial obsession with browbeating had an ominous start. But, instead of

doing course correction, it passed an even more confiscatory law, the Fugitive Economic Offenders Act.

#### **Existing laws**

The intent of both the laws could have been achieved by a few tweaks in the existing laws. The Income Tax Act has, since 1989, provided for up to three times penalty on escaped tax. Similarly, wilful attempts to evade taxes have, since 1975, been punishable with impr sonment of up to seven years. A protocol for automatic exchange tax information, under which India is now receiving data from Switzerland, was signed in 2011, as was the amendment requiring all citizens to disclose foreign assets with their domestic tax returns.

Post-May 2014, tax control policv is different only in three aspects, all constitutionally suspect. The first relates to retrospective application of tax and penal laws that are so confiscatory and brazenly discriminatory that they walk all over a citizen's right to life. carry on business and own property. The second is about shifting the burden of proof onto the citizen to establish that he is not an offender. Lastly, and this is what makes this new policy rather wicked, citizens can be subjected to criminal trial, without the taxman first proving that there has been tax evasion. The results of giving such unbridled powers to agencies have been disastrous.

The Enforcement Directorate, India's money laundering watchdog, secured conviction in less



than 1% of case but attached assets worth ₹29,468 crore. In contrast, the agency's equivalents in the U.S. and the U.K. secured conviction in about 50% cases. The Income Tax Department's records were not inspiring either, hovering at near 2% conviction rates in Financial Year (FY) 2016-2017. A Comptroller and Auditor General report showed that in FY 2016-2017 - the demonetisation year the number of raids more than doubled, as compared to FY 2013-2014, the last year of UPA-II; but in the same period, the undisclosed income detected was less than one-fourth the amount during the latter period. In medical sciences, intrusive

methods of treatment are generally resorted to when diagnosis shows evidence that less risky methods may not be restorative. But, India's fiscal policy seems to be driven by the opposite logic: intrusion first, diagnosis later.

No clear estimate of black money owned by Indians and stashed abroad is available. Between 2008 and 2012, various reports quoted

anywhere between \$500 billion and \$1.5 trillion, some relying on estimates of a Swiss Bankers Association (SBA) report. These turned out to be false. James Nason, an officer of the SBA, has said that the SBA had never published any such report. In March 2019, National Institute of Financial Management reported to the Lok Sabha Standing Committee on Finance, that the estimate is about \$216 billionthe estimate quoted ahead of the 2014 elections. In essence, India's foreign black money problem was misdiagnosed and unverified, exaggerated numbers went into satisfying Parliament that draconian financial laws are justified.

#### **Taking cognisance**

For the judiciary, one question that arises is: if the conventional wisdom on black money was based on disinformation, should it take cognisance of it? If yes, how? For example, should the Supreme Court take a relook at its verdict in Ram Jethmalani's case against black money, especially to guide lower courts in their examination

of financial crime allegations? A democratic state cannot unjustly enrich itself by making citizens pay for what is not rightly owed. The belief that the government will act on principles of honour and good faith is an invaluable but fragile national asset, Nani Palkhivala wrote in an article in 1993. He said that fiscal system must have not just legality but also legitimacy. It is denuded of all legitimacy when there is a breach of faith on the part of the government in its dealings with the taxpayer

International media called demonetisation, among the government's purported measures to fight the black money menace, as a 'massive theft of people's property'. Similarly, the announcement that ₹15 lakh will be deposited in each citizen's account was found to de nothing more than a politica bait. In civil cases if a trustee breaches faith this way, trust laws provide recourse. As do penal laws in similar circumstances against agents, servants and even against wives. There is, however, no punitive recourse against political skulduggery. The doctrine of promissory estoppel deserves to be tried in political jurisprudence also.

The government should give up the belief that being an intrusive, browbeating confiscator enriches Indians. It doesn't. This approach is reminiscent of India's imperialistic past and, in its current form, is impoverishing us into an economic depression. The draconian fiscal laws must at once be repealed. Increased international cooperation, technological advances and banking penetration implodes black money more than any law or sermon on patriotism. India's war on black money can only be won through democratic, persuasive and economicallysound means.

# Should the government exit navratna companies?

**PARLEY** 

Disinvesting partial stakes is more fruitful than outright asset sales of PSUs

Last month, the Cabinet approved sale of the government's stake in Bharat Petroleum Corporation Limited, a navratna public sector company with oil refining and marketing operations. BPCL's stake alone is expected to raise about ₹60,000 crore for the exchequer this year, and given the fiscal pressures the government is facing on the tax revenue front, such largescale disinvestment will help. In a conversation moderated by Vikas **Dhoot,** T.T. Ram Mohan and C.P. Chandrasekhar discuss the implications of BPCL's stake sale. Edited excerpts:

If we look at India's approach to disinvestment since liberalisation, the focus in the Narasimha Rao government and the UPA years was on offloading minority stakes and listing them on the stock exchange. During the time of the Atal Bihari Vajpayee government, we saw some bold moves on strategic sales with many large, loss-making PSUs like Balco, Modern Foods and Hindustan Zinc being sold off. In September 2014, Prime Minister Narendra Modi had said that the government has no business to be in business. In the last six years, we saw a slightly cautious approach until now. For the first time, we are looking at a profitable public sector undertaking (PSU) like BPCL being put up for sale in an import-dependent sector like petroleum. Would you say that this signals a turning point?

Is it about improving efficiency? Is it about broadening the capital market? The fact that they're not talking of something similar in the case of public sector banks suggests that this may not be as much of an ideological shift as a matter of expediency.

Mr. Chandrasekhar, what do vou think?

**C.P. Chandrasekhar:** We have to recognise that this is a culmination of a tendency we've observed over a significant period of time, particularly starting with the Vajpayee government. The original understanding was that you go in for partial disinvestment to public sector equity with two purposes, among many. One was it would allow you to mobilise a certain amount of resources which can be put into some kind of a fund which could be used to modernise, renovate or make viable public sector firms which still have the possibility of being profitable despite being loss-making. This could also be used to put money into firms that were so loss-making that it is best to shut them down, by paying off retrenchment funds to workers and cleaning the books. The other was that having private equity holding in public firms brings in a certain degree of monitoring and discipline of managers in the public sector that comes from outside the government. We have clearly shifted from both of these.

It's now clear that even partial disinvestment or even a strategic sale is clearly to mobilise resources to finance the Budget, which is problematic at multiple levels.

The CEA recently argued that the private sector does a far better job of taking savings in the economy and making sure that they are ploughed back productively. One of the longstanding problems of India's public sector has been about bureaucratic and political interference and rent-seeking. So, one could argue that this kind of a sale will free up entities like BPCL to scale bigger heights under private management.



**CPC:** You just have to look at the civil aviation sector where we brought in the private sector in a big way. You have to look at what "competition" has done in the telecom sector. And we know that survival in these sectors for a number of firms was essentially because they were bankrolled by public sector banks.

TTR: It is not borne out empirically that the private sector is more efficient. Even in post-liberalisation India, a number of studies show a trend towards convergence in performance between PSUs and private enterprises. Even in banking, until about 2011 when the NPA crisis started, we saw a similar trend. One of the reasons people tend to believe that the private sector is more efficient is because there's something called a survivorship bias in the data. When a public sector enterprise makes losses, it continues to exist. Whereas, if a private sector enterprise makes losses for a long time, it sort of exits the database. So, people will look at public and private sector banks and say private sector banks are doing much better, but they will ignore the many private sector banks that failed and had to be merged with other entities. The problem in comparing the two is that only the survivors of the private sector are left standing and you say they are doing marvellously.

If improving efficiency is the argument, then it logically follows that the focus of disinvestment or privatisation should be on loss-making or underperforming entities. It is not clear why you should take a highly competitive and profitable company such as Concor or BPCL and opt to privatise it first unless, of The question one should ask is, if basic engineering and managerial skills are there, then how do we ensure that the enterprise

course, your basic motivation is to raise revenue in quick time.

continues to perform well?

One of the arguments being made about BPCL is that if the government sells it now when it is doing well, then it stands to realise a very good price. But if and when private competition comes into distribution of oil, then BPCL surely will not do well and the government wouldn't realise the same price. That is just pessimistic thinking because you presume that every public enterprise is doomed to fail. The question one should ask is, if basic engineering and managerial skills are there, then how do we ensure that the enterprise continues to perform well? How do you address governance issues so that these public assets are managed well? Instead of asking that, we start off with the presumption that whatever is public cannot do well and should be

Of course, one can make the argument that within the oil sector, even if you sell BPCL, there will still be public sector dominance. There is HPCL merged with ONGC and there is IOC which is much bigger than BPCL. So selling BPCL will fetch the government revenue without necessarily undermining government dominance in the oil sector. But that's a limited argument to make and one should be careful not to stretch it too far and extend it to PSUs in general.

In Parliament, when asked about its disinvestment policy, the government said this month that it is not driven by profit or loss but decided on the basis of 'national security, sovereign functions, market imperfections and public purpose.' How would you interpret this differently than the earlier focus of retaining PSUs in strategic sectors?

**CPC:** The phrases used in the response to the Parliament question is just to obfuscate... The essential purpose of this exercise is to get money for the Budget and getting money in this manner is neither rational nor, in an accounting sense, meaningful because the government will lose hugely in the process and, therefore, the people who are essentially one step removed from the owners of these assets would also lose.

TTR: Valuation is the trickiest part in privatisation. Privatisation leads to superior efficiency provided certain conditions are fulfilled - how you privatise is very crucial to the success. One of the most important conditions to be met is that the valuation must be right. There's no point in giving assets away on the cheap, because then it is very easy for the private sector buyer to make supernormal returns on undervalued assets. So getting the valuation right is a tall order and that is where controversies arise. Even in Air India's case, if it is seen to be sold on the cheap, there's bound to be a severe backlash. In general, if you go for strategic sales, where you sell a 100% or majority stake in one go, then the chances of getting the valuation right is lower as there is no price discovery process. Later on, you realise the price was perhaps not right. Whereas with disinvestment, where you unload in tranches, there's a better chance of price discovery over time - the first tranche may be undervalued, but once it is listed and performance improves, the government can realise better valuations in subsequent tranches. This is why contrary to popular perception in the country, a vast majority of privatisation sales the world over have happened through share issue privatisations (disinvesting partial stakes) as opposed to asset sales (what we call

strategic sales). In the literature, there is examination of the virtues of share issue privatisation versus asset sales and it is seen that the former is preferred worldwide. Asset sales typically happen under distress conditions, where governments are under severe fiscal stress and they want to raise revenue quickly. And I would sincerely hope that we do not go down that route except in a few cases.

If you look at some of the earlier strategic sales like **Hindustan Zinc or Paradeep** Phosphates, where the government retained a minority stake, the firms have turned around from chronic losses to become quite profitable. And the government got this upside because it retained a stake. Is that an approach we could look at?

CPC: If there is incremental disinvestment even from profitable PSUs, to generate resources to restructure the rest of the public sector, that is something we can dis-

TTR: Yes, you need to have a framework for carrying out disinvestment or privatisation... Is it for strengthening the public sector or is it for dismantling the public sector? The Disinvestment Commission under G.V. Ramakrishna was very clear that privatisation should be for strengthening the public sector. So they ruled out privatisation of core industries and highly profitable PSUs, and they also said the proceeds should be used for restructuring other PSUs or spending on rural infrastructure. The receipts should not be used for the government's revenue expenditure. So I think it would make more sense if the government were to articulate a philosophy under which the privatisation is to be carried out so it will be easier to carry Parliament and the public with you.

Strategic sales are very difficult to pull off due to valuation issues. And we have seen that already in Air India. The government will also have to take into account what happens to employees and their benefits. Although the objective is to quickly sell off assets to bridge the tax shortfall, I think it's going to be very difficult for the government to pull it off.



## A tale of two demands

Dr. Singh and the CPI(M) demanded citizenship for Bangla refugees, but not on the basis of their religion

During the debate on the Citizenship Amendment Bill (CAB), 2019, BJP Rajya Sabha MP, J.P. Nadda, alluded to comments by former Prime Minister Manmohan Singh in 2003 asking for grant of citizenship to minorities who have faced persecution in Bangladesh. He said the government was only implementing this demand. Is the government's assertion that the Citizenship Amendment Act (CAA) is only in line with what Dr. Singh had asked for, valid?

In 2003, during a debate over the CAB 2003, Dr. Singh addressed Deputy Prime Minister L.K. Advani: "After the partition of our country, the minorities in countries like Bangladesh have faced persecution, and it is our moral obligation that if circumstances force... unfortunate people to seek refuge in our country, our approach to granting citizenship to [them] should be more liberal. I... hope that the Hon. Deputy Prime Minister will bear this in mind in charting out the future course of action with regard to the Citizenship Act."

A similar demand was registered by the CPI (M) in a resolution in its 2012 Party Congress to "sympathetically consider the legitimate demand of the large number of Bengali refugees to recognise them as citizens of India. They had fled their country, erstwhile East Pakistan and then Bangladesh... At the time of the Parliament discussion on the Citizenship Amendment Act, 2003, all political parties from across the spectrum had supported an amendment to protect these citizens who are victims of historical circumstances. Yet even after so many years the law considers them illegal migrants....[the CPI(M)] demands a suitable amendment in Clause 2 (i)(b) of the said Citizenship Act in relation to the Bangladesh minority community refugees. This must be done while protecting the Assam Accord...".

As economist Prasenjit Bose wrote in *The Hindu* online edition (http://bit.ly/prasenCAA), "Over 5.21 million persons [from East Pakistan] had registered themselves in Indian check posts as "refugees" by 1970... srinivasan.vr@thehindu.co.in

Another 9.89 million had crossed over in 1971, according to figures provided by the Indian government to the United Nations... While most of the 1971 refugees returned to Bangladesh after the end of the hostilities, a few thousands did not... Although a large majority of the Bengali refugees are Hindus, the post-Partition refugees also include a section of Bengali Muslims, given the specific nature of the 1971 conflict in Bangladesh, which was fought over language and not religion... Since none of these refugees had entered India with valid passports or travel documents, they have become 'illegal migrants'... after the passage of the Citizenship Amendment Act, 2003. Moreover, the 2003 amendment has made it impossible for children born in refugee families to become Indian citizens by birth, if either of their parents is deemed to be an 'illegal migrant'."

**Qualitatively different** 

Both Dr. Singh and the CPI(M) demanded exemption for Bangladeshi refugees already in India from being declared as illegal migrants, and to be granted citizenship, not on the grounds of religion, but because they faced persecution. This is qualitatively different from what the CAA 2019 argues for. It chooses to provide citizenship only to non-Muslims from three Muslim-majority nations – Pakistan, Bangladesh and Afghanistan. It avoids the term "persecuted" but its statement of objects says "many persons belonging to Hindu, Sikh, Buddhist, Jain, Parsi and Christian communities have faced persecution on grounds of religions" in these three countries and renders only these communities to be eligible for beneficial effects of the Act. This classification could fail the test of constitutionality because of the exclusion of some countries and communities on the basis of religion. The provisions of the Act omit persecuted Muslim sects from the three Muslim-majority nations. Besides, it does not consider other neighbours - Myanmar, Sri Lanka, for e.g., – which have a record of minority persecution.

Journalists must stay in the sidelines while covering protests

When tear gas first hits you, it is hard to follow the standard operating procedure journalists are given when they go out to cover protests. I was 22, in Srinagar, when I first smelt that now-familiar burning scent of chilli (capsica) mixed with CR/CS/CN chemical gas, which the police dilute according to the strength of the protest. "Don't rub your eyes", "cover your nose and mouth with a wet cloth", "run far from the firing" and "always carry a bottle of water" are all great bits of advice, but not easy to do if you are a journalist carrying tripods and other equipment and trying to get photographs, record visuals, and note down comments of protesters and the police all at once. I was caught off guard the first time, but I learnt quickly to avoid the stinging sensation, streaming eyes, breathlessness

One trick is to stay on the sidelines of a protest, not at its centre. Journalists often interview protesters right in the middle of the marching crowds, but that isn't the best idea. Others try to get as close to police barricades, even stand on top of them to get a better shot, which can be dangerous if protesters decide to knock them down or the police decide to lathicharge the protesters. In fact, conflict trainers will tell you that the best place to be is at a slight height away from the protest you can get a view, but not become part of the melee. Also, journalists must take pains not to be identified with either the security forces or the protesters. One way to do that is to not wear khaki or green or camouflage clothes, preferably nothing that resembles a uniform, and avoid tshirts with political messages. Also, journalists should

always have their press IDs displayed prominently.

There's more in journalism manuals about what to

do when protests get out of hand or the police decide to get tough. The first sign of that is when police cordons get tight or the street lights go out. Another confusing sign is when authorities start clearing barricades, which could mean they are bringing in fire trucks to use water cannons on the crowds, or buses to arrest them en masse. Either way, this is another clear cue for journalists to step to the side of the protests and get to a vantage point. This is also a good time to change the tape or memory card in your camera, especially as the police often detain journalists and confiscate videos that may show excessive force or a human rights violation by forces. It also makes good sense to steer clear of those in the protest who might

purposely push journalists

in harm's way to ensure favourable coverage.

Much of what journalists learn about covering protests is on the job. In the 1990s, I covered a protest on Delhi's Parliament Street where a photographer was grievously injured because he tried to climb a fire truck for a good view and it suddenly backed away. During the 2010 student protests in Kashmir, when pellet guns were widely used by the forces, I learned to keep away from police lines, to avoid the sharp stones pelted at them. During the Nirbhaya protests in Delhi, I learned that wearing several layers of clothes helps to avoid "water burns" from the sheer force of water cannons. During the protests against President Mohamed Morsi in 2013 in Egypt, I learned how quickly a protesting crowd can morph into one for regime change, and the story one is covering itself changes.

EMS on status of Governors

Mr. E.M.S. Nambudiripad has expressed the view that "a serious review" of the status of the Governors had assumed "immediate importance" in the context of the split in the Central leadership of the Congress and the consequent political conditions in the country, which were "reminiscent of the last days of the Mughal Empire" with the States tending to take more and more independent positions vis-a-vis an increasingly weakening Centre. Commenting on the President's address to the recent Governors' Conference, Mr. Nambudiripad, in a signed editorial in the Marxist party organ, Desabhimani, has said that though the homilies of the President were "pleasant to hear" they were bound to remain mere paper declarations when viewed against the practical, political realities in the country. ## Two killed in police firing in Mangaluru

The CAA, passed by Parliament recently, offers a route to citizenship for non-Muslim refugees from Pakistan, Bangladesh and Afghanistan, while the NRC, according to Home Minister Amit Shah, will identify and remove "infiltrators".

An unsigned note circulated by a Central government functionary around noon said when the NRC is rolled out, people will be able to use existing documents to establish citizenship. However, there was no formal announcement from the government regarding concerns raised in the rallies across the country that the hand of the new citizenship regime will be heavy on Muslims and poor people who are unlikely to possess

In Mumbai, actor Sushant Singh, who was removed by television show Savdhan India for his position on the CAA-NRC, said, "I must thank the students of this country for letting us know that India's blood hasn't cooled yet."

Historian Ramachandra Guha was among the people detained in Bengaluru.

Smaller cities in Karnataka, particularly Kalaburagi in North Karnataka, witnessed huge turnout for several protests.

In Lucknow Chief Minister Yogi Adityanath said protesters who damaged public property will be forced to pay for it.

"No protest can take place without permission," he told news agency ANI.

#### Policemen injured

Several policemen including an Assistant Commissioner of Police (ACP) were injured in heavy stone pelting when a march turned violent in Shah-e-Alam area Ahmedabad.

Expressing solidarity with the nation-wide protests, students and various organisations took to the streets across Kerala, even as Chief Minister Pinarayi Vijayan warned the Centre against using force to crush democratic and peaceful means of protest.

# Don't add fuel to the fire: Centre

Message says NRC merely a normal process to register name in citizens' register

NEW DELHI

As protests against the Citizenship (Amendment) Act (CAA) and the National Register of Citizens (NRC) raged across the country, Minister of State for Home G Kishan Reddy said a countrywide NRC had not been notified so far and no one should fear.

Mr. Reddy told *The Hindu* that "political parties and intellectuals should not put petrol in fire, instead they should douse the flames".

The Minister asked students to read the CAA before protesting. "It is not against students, any region or people belonging to any religion... no one is being sent to detention centres. Political parties should behave responsibly. Cine actors also participating in protests, why are they doing so?" he

#### Ads in newspapers

The government published an advertisement in Hindi newspapers to dispel the myths around the CAA and the NRC.

It said that "the NRC has not been announced yet and

if it is done so in future, then rules and regulations should be such that no Indian citizen is troubled."

Mr. Reddy said, "Violence was reported only in some rural areas of Lucknow. In Delhi, demonstrations were peaceful. The Northeast is also normal. Political parties and intellectuals should not instigate people on the lines of religion. Students do not know that the CAA is not against them."

No discussion has been held vet on whether those excluded from Assam's NRC would benefit from the CAA, he said. Around 19 lakh people in the State were excluded from the final register published on August 31, an exercise conducted to segregate Indian citizens living in Assam from those who had illegally entered the State from Bangladesh after March 24, 1971 on the basis of the Assam Accord signed by the Government of India in 1985.

#### WhatsApp note

A fact-check of the NRC released unofficially by the government and circulated on WhatsApp said that the proprocess to register your name in the Citizens' register." "Just like we present our identity cards or any other document for registering our names in the voter list or getting Aadhaar card made, similar documents shall need to be provided for NRC, as and when it is carried out," the unsigned note said.

"Citizenship can proved by submitting any documents related to date and place of birth. However, a decision is yet to be taken on such acceptable documents. It is likely to include voter cards, passports, Aadhaar, licences, insurance papers, birth certificates, school-leaving certificates, documents relating to land or home or other similar documents issued by the government," the note said.

To a question on what will happen to those who are homeless, poor, uneducated and do not have documents, the note said, "Such people vote on some basis and they also get the benefit of the welfare schemes of the government. Their identity will be established on the basis

## It's similar to Emergency resistance, says Yechury

'Outpouring of student frustrations'

The protests against the Citizenship (Amendment) Act (CAA) are similar to the resistance that students and political parties had mounted against the Emergency, CPI(M) general secretary Sitaram Yechury said on Thursday.

A joint protest, which five Left parties organised at Mandi House, was broken up by the Delhi police within 10 minutes of the agitators having assembled there. The police argued that Section 144 was in force, so an assembly of more than four persons would not be allowed. All prominent leaders of these parties, including CPI general secretary D. Raja and Mr. Yechury, were detained.

Breaking with the norm of taking detained leaders to the nearest police station, the police carted them off to north Delhi, many kilometres away, and dropped them at an undisclosed loca-

The leaders and those who escaped arrest at Man-



di House and the Red Fort came to Jantar Mantar to continue protest. "This is more like resistance to Emergency. Look at this generation, they are the inheritors of India. They are agitated over the change in India's constitutional status," Mr. Yechury said. "The protests were an outpouring of frustrations of students and others with the government's lackadaisical approach to the economy. The students are asking what is the government's job. It is to address livelihood concerns. The economy is in recession, unemployment rates are the highest we have ever seen, our farmers are committing suicides."

# Centre 'muzzling' dissent, says Congress

Party general secretary

Priyanka Gandhi Vadra said there would be a greater fightback by citizens if the government tried to "si-

lence" them. "Every time force is applied to dominate and rule, every time you beat and suppress, every time you push people to the wall, they will rise up stronger, their resolve will strengthen and their voice will grow louder," Ms. Vadra tweeted in Hindi.

"Our freedom movement was proof of this, our Constitution is the guarantor of it and our people are the soul of it," she added.

In a series of tweets, former Finance Minister P. Chidambaram condemned the police for preventing citizens including historian Ramachandra Guha from peacefully protesting in Bengaluru.

#### 'Liberty at stake'

"What are at stake - liberty, equality, constitutional morality – are so important that we must seize the moment and push back the authoritarian regime," Mr. Chidambaram tweeted. "Ram Guha was not violating any law when he was arrested. He was alone! Sec 144 'prohibition' was not attracted. It is the four policemen who surrounded him who made the solitary peaceful citizen into an 'unlawful assembly'!".

## Jaishankar briefs U.S. Senate panel on CAA

External Affairs Minister S. Jaishankar had shared India's perspective on Citizenship (Amendment) Act (CAA), 2019, with the Senate Foreign Relations Committee on the sidelines of Wednesday's India-U.S. "2+2" ministerial meeting in the United States, the spokesperson of the Ministry of External Affairs said here.

India has been maintaining that the developments regarding the new citizenship code is an internal matter. This, however, did not prevent important legislative outfits in the U.S. from commenting on the new law with the USCIRF calling for sanctions on Home Minister Amit Shah. The issue, however, did not figure in the official discussion between the visiting Indian dignitaries, Defence Minister Rajnath Singh and Dr. Jaishantheir and counterparts.

In a joint statement issued on Thursday, both India and the U.S. agreed to uphold the "international rules-based order." The statement called upon Pakistan to deny resources to cross-border terror groups.

The document also contained American acknowledgement of Indian support for the recovery of remains of those U.S. soldiers and aviators who were lost in air crashes in the mountains of Arunachal Pradesh during the Second World War.."

## Hindu, Sikh refugees support Act

#### People need reassurance: **Assam MLAs**

A group of 20 Bharatiya Janata Party MLAs on Thursday met Assam Chief Minister Sarbananda Sonowal and sought creation of an atmosphere where the legislators can face the people for removing misconceptions about the Citizenship (Amendment)

The legislators said they had to virtually go underground to avoid public ire and steps must be taken to assure the people that their culture, language and existence were not under threat from any piece of legislation.

"I have had to go into hiding [after the anti-CAA protests that left six people dead] and was forced to leave home town Dibrugarh. We cannot let such a situation continue," BJP MLA Prasanta Phukan said.

The Sootea MLA, Padma Hazarika, said the government must hasten implemention of Clause 6 of the Assam Accord, 1985, that guarantees constitutional safeguards for the indige-

nous Assamese people. Mr. Hazarika said some protesters had been spreading misinformation on the tea estates of eastern Assam that the CAA would make the Adivasis or "tea tribes" lose their plantation jobs to "truckloads of Bangladeshi labourers".

Tea industry captains have corroborated the "fear psychosis" that has seen plantation workers stay away from work across many estates in eastern Assam, leading to a fall in production.



Urges govts. to ensure their protection

"Our democracy and other institutions in the country are well equipped to deal with any differences of opinion in a peaceful manner. I do not think any external agency has any locus standi to comment on a matter which is completely internal to India," he said in response to a comment by UN-ICEF's Executive Director Henrietta Fore, who had noted that struggle for equality all over the world was leading to the loss of

# 'CAA paves the way for foreign aggression'

Plea in SC says the Centre failed to protect the country from internal disturbance

A petition filed in the Supreme Court on Thursday raised a novel argument against the Citizenship Amendment Act (CAA) of 2019 of opening the nation to foreign aggression and internal disturbances.

It said the Centre, through this Act, had failed in its constitutional duty to protect the country from external aggression and internal disturbance.

The court will hear the CAA challenge on January



22. Under Article 355 of the Constitution, the Centre has a duty to protect the States from external aggression and internal disturbance.

However, the petition filed by Anis Educational

advocate Ejaz Maqbool, said the new law allowed massive influx of illegal migrants into the country.

## 2005 verdict

The Supreme Court had held that massive influx of illegal migrants from neighbouring countries amounts to "external aggression and internal disturbance" in a 2005 judgment in Sarbananda Sonowal versus Union of India.

"By virtue of this Act, the Union has not only violated the constitutional mandate

and Welfare Trust through but has in fact devised a procedure to grant citizenship to these illegal migrants, that too in a fast track manner," the petition said. The Act facilitates the in-

flux of illegal migrants into India and in fact, retrospectively legitimises illegal entry into the nation by enabling them to apply for Indian citizenship.

The Centre, through this Act, has virtually granted citizenship to illegal migrants in failure of its constitutional obligation under Article 355, the petition said.

# Mamata to take back remark

On a day when West Bengal Chief Minister Mamata Banerjee dared the Centre to carry out a referendum on the Citizenship (Amendment) Act across the country, Governor Jagdeep Dhankar urged her to with-

draw her comment. Addressing her fourth anti-CAA rally in a row in Kolkata on Thursday, Ms. Banerjee said, "We would like to know how many [people] are for CAA and how many are against it. If majority does not agree to it, will you [the Prime Minister] resign?" The referendum could be carried out by independent bodies like the United Nations or any impartial international organisation, she said.

"I appeal to CM Mamata Bannerjee to please withdraw her reported statement," the Governor said

on social media. Earlier in the day, the Governor, while pointing out that the Supreme Court had not granted any stay on the Citizenship (Amendment) Act, urged "all to give up agitational path in the interest of peace so that normalcy returns and the sufferings of people are contained."

Kolkata witnessed five rallies during the day, of which the rally held without the support of political parties drew no less than 20,000 people. The rally, organised by civil society representatives, students and activists, demanded the scrapping of the CAA and the non-implementation of the National Register of Citizens (NRC).

'Persons from 24 countries nabbed

Union Home Minister Amit Shah on Thursday said some forces inimical to India were using the borders of friendly countries like Nepal and Bhutan to push "infiltrators."

Addressing the troops and officers of the Sashastra Seema Bal (SSB) on its 56th Raising Day celebrations, he said that in the last one year "54 infiltrators, including two Pakistanis," have been nabbed at the Nepal border. These infiltrators were from 24 countries, apart from Pakistan. The SSB is tasked with guarding the 1,751-km long frontier with Nepal and Bhutan. It was raised in the aftermath of the 1962 Chinese aggression.

Mr. Shah said India enjoyed very "cordial and friendly" relations with Nepal and Bhutan and the border force had ensured that people from these nations were treated with "respect" at these fronts. The country's 130 crore people were sleeping peacefully because all the border guarding forces like the SSB were protect-



ing the nation and serving in where temperatures range from -46°C to 47°C.

Mr. Shah promised to the troops that the government would make sure that within one to one and a half years the jawans of all border guarding forces got to spend at least 100 days with their children, families and

"This is a difficult job but as the Modi government has accomplished other difficult targets, this will be done too," he said at an SSB camp in south Delhi. He added that the force would get an additional manpower of 12,055 personnel by the end of next year.
