

# Sengar gets life for Unnao rape

Former BJP MLA fined ₹25 lakh

SPECIAL CORRESPONDENT NEW DELHI

A Delhi court on Friday sentenced former BJP MLA Kuldeep Singh Sengar to life imprisonment for raping a minor girl in Uttar Pradesh's Unnao in 2017.

"The convict Kuldeep Singh Sengar is hereby sentenced to undergo imprisonment for life, which shall mean imprisonment for the remainder of his natural biological life in terms of Section 376 (2) Indian Penal Code," said the court order.

The court also imposed a fine of ₹25 lakh, awarding an additional compensation of ₹10 lakh over and above the ₹25 lakh given as ex gratia to the mother. The amount will be deposited in the victim's bank account as soon as the fine is realised.

From the fine amount of

realisation, ₹15 lakh will be paid to the State government to meet the prosecution and trial expenses.

As directed by the court, the victim and her family members will continue to live for a year in a rented accommodation arranged by the Delhi Commission for

# Seven killed as protests against citizenship law turn violent in U.P.

Home Ministry says there will be no discrimination against Muslims and undocumented people

SPECIAL CORRESPONDENT NEW DELHI

At least seven people were killed in Uttar Pradesh as the protests against the controversial Citizenship (Amendment) Act (CAA) turned violent in many parts of the State on Friday.

As protests against the CAA and the proposed National Register of Citizens (NRC) continued across the country, the Home Ministry said there would be no discrimination against Muslims and undocumented people as feared.

A spokesperson said any document relating to date of birth or place of birth or both would be sufficient to establish citizenship.

#### No firing, says DGP

Uttar Pradesh Director General of Police O.P. Singh said the police did not fire at protesters, while PTI quoted unnamed State officials as saying that the protesters had fired at the police at various plac-

Two people were killed in Bijnor and one each in Meerut, Sambhal, Firozabad, Kanpur, according to PTI.

Police tried to disperse crowds with teargas shells followed by rubber bullets. Mr. Singh said over 50 policemen were seriously injured.

The Hindu's U.P. correspondent Omar Rashid was detained in Lucknow for over three hours, despite identifying himself, and released on the intervention of the Chief Minister's Office.

# Death for four in Jaipur serial bomb blasts case

The explosions in 2008 killed 71 people; 200 were injured

Four persons convicted of the serial blasts that killed 71 people and left 200 injured in the Walled City of Jaipur in May 2008 were sentenced to death by a special court here on Friday. The four were held guilty of planting the bombs and carrying out explosions, while one of the accused, charged with sending an e-mail claiming responsibility for the blasts, was acquitted.

Special judge Ajay Kumar Sharma awarded the death penalty to Mohammed Saif, 34, Mohammed Sarwar Azmi, 36, Saifur Rehman, 36, and Mohammed Salman, 34, after convicting them on Wednesday under various sections of the Indian Penal Code, the Unlawful Activities (Prevention) Act, and the Explosives Act, in eight cases filed by the Anti-Terrorism Squad of the police.

Lucknow resident Shahbaz Ahmed, 43, was acquitted in all the cases for want of evidence.

The ATS had claimed that he had sent an e-mail to media houses on behalf of the Indian Mujahideen two days after the blasts.

The IPC provisions under which the four convicts were awarded capital punishment, life imprisonment, sentences of various terms and fine included Sections 302 (murder), 307 (attempt to murder), 121-A (conspira-



cy for waging war against government), 124-A (sedition), 153-A (promoting enmity between groups) and 120-B (criminal conspiracy).

The court held that Saif was involved in the blast at the Manak Chowk Police Station, while Sarwar carried out the blast at the Chandpol Hanuman temple. Saifur Rehman was convicted of planting bombs at five different locations and Salman was held guilty of the blast at the Sanganeri Gate Hanuman temple. All of them hail from Uttar Pradesh.

### 'Will file appeal'

Defence lawyer Paker Farooq said he would file an appeal against the judgment in the High Court when the case goes there on Monday next for confirmation of the death verdict. "We will challenge the sentence. This verdict is based on conjectures and surmises... There was no direct evidence and the circumstantial evidence was not trustworthy."

**Gehlot welcomes verdict** Rajasthan Chief Minister Ashok Gehlot said the judgment should be welcomed. "Those who believe in violence should be taught a lesson... whoever they are," he told reporters on the side-

lines of a function.

During the arguments on the sentence, the prosecution demanded the death penalty for the convicts on Thursday, while defence counsel sought leniency, contending that the convicts had already spent 11 years in jail and belonged to decent families with no history of crime. Counsel also claimed that Salman was a juvenile at the time of the offence.

# 40 detained as protest turns violent

Over 20 injured in lathi-charge; police claim antisocial elements disrupted peaceful march

Stones, footwear and bloodstains on streets were the remnants of a protest against the Citizenship (Amendment) Act, which began peacefully at Jama Masjid but ended with arson two kilometres away near the Daryaganj police station on Friday.

At least 40 people were detained and 21 injured after Delhi police used lathis and water cannon to disperse the protesters who hurled stones at security personnel. Some people, who the police said were "outsiders", set ablaze a car outside the police station near Delhi Gate. The fire was immediately doused with water and fire extinguishers.

Many among those who were detained were heard pleading that they were protesters but not involved in the violence, and had merely

Police officers use drones to monitor situation at the venue

As Friday prayers ended around 12.50 p.m. at Jama Masiid, thousands stood on the steps of the mosque and raised Tricolours while shouting slogans against the Citizenship (Amendment) Act. The peaceful protest continued till late in the evening as the police stood on the sidelines.

#### Slogans raised

Bhim Army chief Chandrashekhar Azad was at the protest and held up a copy of the Constitution. He, however, disappeared after a few minutes.

Following this, thousands of protesters continued shouting slogans outside the mosque's gate no. 1. Members of the Bhim Army claimed that Mr. Azad had been detained by the police but later managed to escape. Spokesperson of the Delhi Police, however, said Mr. Azad was never in their custody.

Jama Masjid Imam Syed Ahmed Bukhari, who was absent from the protest, is said to have refrained from speaking about the amended Citizenship Act during his Friday sermon.

Nisha, a protester from Seelampur, said: "From what I know, the government is asking for proof of birthplace or else they will enlist me as a refugee. I have proof but my parents do not, but they were also born here. Why should we live like refugees in our own country? I am an Indian. It is so disheartening that I have to keep saying it."

During the agitation, policemen in anti-riot gear stood to the sides and used drones to monitor the situation. "Yes. Come. Take my picture. I was here," said a protester looking at the drone.

Another protester received a loud cheer from the crowd because of his placard which read: "Jahan

Supreme Court lawyer Mahmood Paracha, who was also protesting at the site, encouraged members of the Bhim Army to continue the agitation. "We will not leave until Azad comes back," said a member. The initial plan was to march from Jama Masjid to Jantar Mantar but the crowd was denied permission. A minor argument also broke out between Mr. Paracha and a group that wanted to march to Jantar Mantar but it was later pacified by the lawyer.

Around 4 p.m., when the evening prayers had just begun, Azad reappeared and the crowd broke out into a loud cheer. Again holding up a copy of the Constitution, he asked the protesters to sit on the road. Within minutes, the protesters were asked to begin their prayers and they, including Azad, went inside the mosque.

The protest stopped for around 20 minutes and resumed only after the prayers. It went on till late evening.

Shops in and around the area were all shut. Some of the shopkeepers stood outside their shops while others joined the protest. "Puri zindagi pachtaane se accha to kuch paison ka nuksaan hi hai," said Gulam Hassan Sarkar, owner of an eatery -Kashmiri Restaurant – just opposite the mosque.

The Capital on Friday witnessed a wave of fresh protests and demonstrations against the amended Citizenship Act as thousands took to the streets shouting anti-government slogans.

Protests were witnessed in Jamia Millia Islamia, Seemapuri, India Gate and north-east Seelampur.

"There were large gather ings in Seelampur, Shastri Park, Jamia Nagar and Shaheen Bagh. Senior officers, with the help of 'respectables' of respective areas, talked to the protesters and they dispersed peacefully," said Delhi Police spokesperson M.S. Randhawa.

Incidents of stone-pelting were reported from Seemapuri where an additional deputy commissioner of police as some other personnel sustained minor injuries, said Mr. Randhawa.

In view of the protests and prohibitory orders, large parts of the city witnessed massive traffic jams

for the second consecutive day on Friday.

Prohibitory orders were imposed in 12 police station areas of northeast Delhi, officials said, adding that drones were used to keep a tab on the law and order situation. In the morning, police carried out a flag march in Seelampur, which had seen violent protests on Tuesday, in the wake of intelligence inputs about the security situation.

Delhi Mahila Congress chief and former president Mukherjee's Pranab daughter Sharmistha and some other members of the outfit were detained near Home Minister Amit Shah's residence during a protest against the new legislation. They were detained at Mandir Marg police station and released after a few hours.

In addition to officers and personnel of the district police, 58 companies were deployed on Friday to bolster strength of the local police, said Mr. Randhawa.

# NHRC team visits Jamia Millia Islamia

Team inquired into claims of human rights violations at the university

The National Human Rights Commission (NHRC) deputed a fact-finding team to inspect the Jamia Millia Islamia (JMI) premises on Friday to inquire into claims of human rights violations during the recent police crackdown university.

The NHRC is said to have received multiple complaints alleging illegal detention of students by the police and denial of legal and medical access to the injured students. A team led by Special Superintendent of Police Manzil Saini conducted a spot inquiry to find out "whether incidents in JMI involved violation of Human Rights", the NHRC said in a statement.

Following clashes between the police and protesters opposing the amended Citizenship Act last Sunday, the police barged into the university reportedly chasing certain miscreants who had perpetrated violence. Videos from the incident showed tear gas shells being fired into closed rooms,

while students also alleged police brutality. The incident received widespread condemnation with students, staff and alumni of multiple university in the country and abroad issuing statements in solidarity with JMI.

The team visited all the buildings in the university where damage had taken place including the reading room, toilets and other areas, a university official said, adding that the team only conducted spot inspections and did not speak to any of the students involved in the incident.

Officials were informed that the team would visit the university again.

'Preserve footage'

University officials have also been asked to preserve all CCTV footage with them for the purposes of an enquiry if issued by the NHRC.

'The fact-finding team will submit its report, which will be analysed and placed before the Commission for appropriate recommendations in the matter," the NHRC said

Security of stage to be taken over by Special Protection Group

Prime Minister Narendra Modi's "thanksgiving rally" will be held at Ramlila Maidan, located at the crossroads between Lutyens' Delhi and the old Walled City, on Sunday under heavy police deployment after intelligence inputs suggesting a "threat" to his safety during the event in addition to the ongoing protests against the amended Citizenship Act in the Capital.

Party sources claimed the Prime Minister's Office (PMO) had been apprised of an estimated two lakh attendees from across north Indian States converging at the venue aboard 3,000 buses to be a part of the 'Dhanyawad Rally' on Sunday.

While the ostensible objective of the event was intended to express gratitude to Mr. Modi for the BJP-led Centre's decision to confer ownership rights on an estimated 40 lakh residents of unauthorised colonies, the massive footfall, according to party insiders, will also be utilised for "soft messaging" about the CAA.

14 'Digital Raths' flagged off in BJP headquarters

Delhi BJP chief Manoj Tiwari on Friday flagged off 14 'Digital Raths' from the party's State headquarters here. It will illustrate to the residents of illegal colonies the "struggle behind regularisation of such colonies" through video screening. The vans are part of the party's campaign for the upcoming Assembly elections.

While party sources chose "not to speculate" about the contents of the Prime Minister's speech, an insider said, however, he was expected to broach the CAA, given the multiple protests against it across the



The Bench gave a last chance to the Delhi government to notify the action plan.

### Finalise draft regulations within a month, NGT tells pollution board

STAFF REPORTER

Following a plea seeking enforcement of environmental norms by hotels and banquet halls, the National Green Tribunal on Friday directed the Central Pollution Control Board (CPCB) to finalise the draft regulations within one month.

A Bench headed by NGT chairperson Justice Adarsh Kumar Goel directed the Delhi Pollution Control Committee (DPCC) to ensure compliance of environmental norms by marriage halls, restaurants, motels, hotels and banquets.

The civic bodies were also directed to issue a certificate pertaining to the adequacy of parking in the areas before the grant of "consent to establish".

"Stringent norms need to be worked out for controlling and regulating parking of vehicles used by the organisers and guests in functions as well as parking of vehicles on roads and public places adding to the pollution. This includes regulation of pick and drop facilities," the Bench said.

The green panel also directed all the States and Union Territories to similarly enforce implementation of the norms and furnish a compliance report to the CPCB within three months.

"The transport departments of all the States and UTs may assess the available parking capacities...in case the number of vehicles exceeds the capacity, there should be action plans for providing adequate additional parking space. If it is not possible, the number of vehicles to be registered must be curtailed," the Bench directed.

"The investors Summit will provide an opportunity to allay fears and apprehensions from the minds of outside business community about investment in J&K. It will present immense opportunities to develop contacts between the local and outside business community and will provide not only

primary employment but also generate secondary and ancillary employment opportunities for youth," said J&K Chief Secretary B.V.R Subrahmanyam, who chaired the first meeting of the apex committee on Thursday.

#### **Showcasing potential**

The summit, which was earlier scheduled in October but could not take place due to uncertain situation on the ground, will provide J&K a platform to showcase its strengths, strategies and potential in the investment sector. "Participating trade and industry organisations will have an opportunity to know first hand about the business friendly policies of the government and identify business opportunities in Jammu and Kashmir," said Mr. Subrahmanyam.

The J&K administration has described the summit as a mega event. ""It will see strategic sectoral sessions, round table deliberations, technical presentations, partnerships, one-to-one business meetings and signing of memorandum of understanding," the Chief Secretary said.

Officials said the Confederation of Indian Industry has been selected as the national while Earnest partner, Pricewaterhouse-Coopers and Expro have been selected as knowledge,

Around 15,000 kanals of land have been identified so far and it will be open for outside investors soon.

An official said Lieutenant Governor Girish Chandar Murmu will be presiding over various pre-event functions in coming weeks.

# Ensure foolproof security in all district courts, HC tells U.P. govt.

'If State government can't, we will ask for Central forces'

Amid recurrent incidents of violence in various court premises in Uttar Pradesh, the Allahabad High Court on Friday ordered the State government to ensure a foolproof security in all district courts, complete with the deployment of special security force and installation of CCTV

camera there. A Bench of Justices Sudhir Agarwal and Sunit Kumar gave the direction to the government with the State's Home Secretary and Inspector General of Police (law and order) attending the hearing in response to summons to the State police chief and Additional Home Secretary.

The Bench asked the go vernment to make security arrangements in all district

courts by December 31.

It also directed government to get boundary walls built around all district court premises, besides installing CCTV cameras and deploying special police force there by January 15 next year.

After issuing directions, the Bench fixed January 2 as the next date to hear the matter further.

#### **Bijnor court shooting**

The Bench issued directions while adjudicating an incident of violence in a Bijnor courtroom that the High Court had taken suo motu cognisance of on Wednesday. One murder accused was killed and three others were injured in the December 17 attack.

"It seems there is complete failure of law and order

inside court premises in the State. The most incompetent police professionals are deployed for security of court premises in the State. Is the government serious about court security? Are top officials even aware about these incidents which happened in recent past in different courts of Uttar Pradesh?" the Bench had asked on Wednesday.

The Bench had told the Additional Advocate General that strengthening court security in the State was an issue pending with it since 2008 but nothing much seems to have been done.

If the State government cannot provide adequate security in court premises, we will ask Central government to deploy central forces for it. the Bench had said.

# 'Oppose CAA through posts, memorandums'

### Kerala takes to the skies

With the commissioning of the Kannur international airport in December 2018, Kerala achieved the distinction of having four worldclass international airports.

The Kannur airport – the gateway to Malabar and the largest airport in Kerala – has given a fillip to the development of the northern districts. The airport, operated by the Kannur International Airport Ltd., has catered to the needs of around 1.35 million flyers, helping to increase the tourist footfall and create a brand equity. KIAL managing director Va-

sudevan Thulasidas said 50% of the flyers from Kannur were domestic passengers. "We could have done better if foreign carriers were allowed to operate," he said.

The quest of Kerala for bettter air connectivity has not ended with the Kannur airport. The demand for airstrips in tourist destinations and in far-flung areas is on the rise, with the State supporting all the initiatives.

The ground work for an airport in Kottayam, closer to the hill shrine of Sabarimala, has commenced.

# Uneasy calm prevails in curfew-bound Mangaluru

No untoward incident; 7 held for Thursday's violence

An uneasy calm prevailed in curfew-bound Mangaluru on Friday, a day after two persons were killed in firing by police on a group protesting against the Citizenship (Amendment) Act.

City Police Commissioner P.S. Harsha said the day passed off without any untoward incident and seven persons had been arrested for Thursday's violent incidents.

Bodies of Nushin, 23, and Jalil Kudroli, 49, who were killed in police firing were buried in their respective Jamats in the evening, after post-mortem was conducted at the Government Wenlock District Hospital. The police are yet to announce the exact cause of death, but the relatives of the victims and other eye-witnesses said they were killed by the police bullets.

Talking to reporters in Mangaluru, Dr. Harsha said that curfew imposed on the entire Commissionerate limits till Sunday midnight would continue and any decision to relax it to allow people to buy daily essentials would be taken depending upon the situation on Satur-

Curfew was relaxed for two hours to allow people to offer their Friday prayers, he

As many as 33 police personnel were injured, including some critically, during the violence while five civilians were undergoing treatment for their injuries in hospitals, he said.

# Warning of 'Godhra-like' situation leads to furore

A Minister warning of a "Godhra-like situation" if the majority "loses patience", while talking about the violence in Mangaluru, drew sharp criticism not just on social media platforms but also from Karnataka Chief Minister B.S. Yediyurappa himself.

Responding to a statement made on December 17 by Congress MLA U.T. Khader that "Karnataka will burn if the Citizenship (Amendment) Act is implemented," Minister for Kannada and Culture C.T. Ravi drew a reference to Godhra riots of 2002. Recalling the burning of a train coach in Godhra and the violence that followed, he said, "I think Mr. Khader knows what happens if there is a reaction. He has seen what happened

when people responded to

Godhra." He went on to say that "the majority community's patience" was being tested. "Our patience is not weakness," he said.

The statement close on the heels of the BJP, led by national general secretary (organisation) B.L. Santhosh, blaming the Congress and Mr. Khader for the violence in Mangaluru.

Mr. Khader, meanwhile. clarified that his statement had been taken out of context and "misrepresented deliberately" by the BJP to escape responsibility for the violent turn of incidents. "The State will burn" is a figure of speech in Kannada and not meant to be taken literally, he argued.

Mr. Yediyurappa is learnt to have reprimanded Mr. Ravi for his statement, and directed all Ministers and MLAs to be careful of their

### 'Police burst tear gas shells inside hospital'

# for assault on student

They were booked under POCSO Act

The Bengaluru police have arrested the principal and two teachers of a school in Koramangala in connection with the assault on a 13-yearold student, attempting to bribe his parents so that they wouldn't approach the police and threatening his sister with sexual assault.

Based on a complaint by his mother, Koramangala police, on Wednesday, registered a case against the principal and the staff charging them under various sections of the Juvenile Justice (Care and Protection of Children) Act, Protection of Children from Sexual Offences (POCSO) Act, and for criminal intimidation.

Later, they arrested principal Shaji Sebastian, maths teacher Reshma and the class teacher Mathew.

The mother told the police that her 13-year-old son, who was physically assaulted, and her 15-year-old daughter are enrolled in the

school. "On December 16, while she was at work, she received a call from the PT teacher informing that her son had a minor accident. She went to the school and met the principal and her son, who was in her office," said the police.

The principal claimed that he had fallen in PT class and sustained a head wound. "However, her son accused the math teacher of hitting him with a duster," the police added.

On December 17, the principal and another senior school official called on the family and requested the mother not to file a police complaint.

They allegedly offered to waive the remaining school fees, and also offered her

# Irrigation scam: Ajit Pawar gets all clear

ACB says 'no criminal liability' has been found in its affidavit before Bombay HC

The Maharashtra Anti-Corruption Bureau has filed an affidavit before the Bombay High Court stating that "no criminal liability has been disclosed" on the part of Nationalist Congress Party leader Aiit Pawar in its investigations into 12 irrigation projects in Vidarbha during his tenure.

The affidavit, filed before the Nagpur bench of the High Court on Thursday, was signed by ACB Director-General Param Bir Singh and is in response to a demand by Atul Jagtap, whose petition before the HC led to a Special Investigation Team being formed to probe the alleged irregularities.

Mr. Jagtap had demanded that the probe be transferred to the Central Bureau of Investigation, as the ACB investigation was very slow. The ACB's affidavit details the investigation conducted so far as well as its results, on the various tenders awarded by the Vidarbha Irrigation Development Corporation (VIDC).

#### 24 FIRs filed

"Investigations have been completed into 102 tenders



by the Nagpur SIT and 57 tenders by the Amravati SIT so far. Some of those tenders are of high value. Where cognisable offences are disclosed, FIRs have been registered. So far, we have registered 24 FIRs and referred 14 matters to the Water Resources Department for permission for registration of FIR as required under the Prevention of Corruption Act. Open inquiries into 45 tenders have been closed," the affidavit said.

The affidavit also submitted that detailed questionnaires were provided to Mr. Pawar in connection with the 12 projects for which he was under the scanner, and his responses, along with the other evidence, had been examined.

"The ACB has also recommended departmental action against the concerned officials where procedural and administrative lapses are noticed. As regards the role of Respondent No. 7 (Mr. Pawar), no criminal liability is disclosed during the course of enquiry/investigation by the Special Investigation Team," the affidavit said.

#### Delay in probe

The document further refuted allegations of a delay in the probe, citing the time it takes for careful examination of various documents, statements of witnesses and legal aspects pertaining to the projects.

The development comes less than a month after the ACB ruled out Mr. Pawar's involvement in nine other applications seeking an inquiry against him during his tenure as Irrigation Minister as well as the Chairman of the

### Will form Ayodhya trust soon: Centre

The Union Home Ministry has said it is working on the modalities for setting up a trust for the construction of a Ram temple in Ayodhya, as mandated by the Supreme Court.

In its November 9 verdict, the court asked the Centre to set up a trust within three months. As per the judgment in the Ram Janmabhoomi-Babri Masjid case, the Centre must formulate a scheme with provisions for the setting up of a trust with a board of trustees or any other appropriate body, the functioning of the trust, the powers of the trustees, land transfer to the trust and all incidental and supplemental matters.

"A trust will be set up within the stipulated time," a senior official said.

CBI court convicts rape

A special CBI court in Ranchi on Friday convicted 23year-old Rahul Raj for rape and murder, on the fourth anniversary of the Nirbhaya case, in a swift trial that was completed in a little over a month, officials said.

Special CBI judge A.K. Mishra found Raj guilty of raping and then murdering the victim, who was an engineering student at a college in Ranchi.

The quantum of punishment will be pronounced on Saturday, a CBI spokesperson said.

The body of the victim was found on December 16, 2016, in her house in the Booty Basti area, where she lived alone, said CBI offi-

The agency took over the case after over a year, when

the Central government issued a notification on January 25, 2018.

The case had triggered huge student protests in Ranchi and the victim had been named "Ranchi's Nirbhaya."

### Villagers skip public hearing on JSW project

# Army to sign deal for six Apache attack helicopters

#### 22 of them are being inducted by the Air Force

The deal for six AH-64E Apache attack helicopters for the Indian Army, estimated to cost around \$930 million, is likely to be signed early next year. Army sources said on Friday. These are in addition to 22 Apaches being inducted by the Indian Air Force (IAF).

"It is in advanced stage and the file is now with the Cabinet Committee on Security . We expect the deal to be signed early next year," an Army source said. The helicopters should start coming in by 2022, the source added.

In August 2017, the Defence Acquisition Council, chaired by the then Defence

Minister Arun Jaitley, approved the purchase of six Apache attack helicopters from the U.S. for the Army.

For this, India is exercising the optional clause in the original deal for 22 Apaches, that has a provision for 11 helicopters. The Army had made a pitch for all of them, but the government had limited it to six.

The IAF has recently inducted the first batch of eight Apaches based in Pathankot. All the 22 Apaches are expected to be delivered by 2020 and will replace the ageing Russian Mi-35 attack helicopters in service.

Currently, the Army Aviation Corps operates only smaller Cheetah and ALH (Advance Light Helicopters) that weigh less than five

All the bigger helicopters, including the Mi-35s and fixed wing aircraft are operated by the IAF.

## Whither Amaravati?

There was a time for the idea for three capitals in Andhra Pradesh, but it is long past

ometimes ideas can sound good, but when it comes to implementation they need to be tested for feasibility and, importantly, timing. Andhra Pradesh Chief Minister Y.S. Jagan Mohan Reddy hinted on Tuesday that the South African model of three capitals was best suited in his State and that his government would work towards this. In South Africa, the administrative capital is in Pretoria, its national legislature in Cape Town and its judicial capital in Bloemfontein. Mr. Reddy's idea seems to stem from the reasoning that a distribution of executive, legislative and judicial governance across Visakhapatnam, Amaravati (the current capital) and Kurnool would allow for "a decentralised development of the State". The location choices are in the upper, central and lower geographical regions. Such an arrangement follows the recommendations of the expert committee appointed by the Home Affairs Ministry in 2014 to study alternatives for a new capital. Chaired by K.C. Sivaramakrishnan, the panel had argued against the need for a greenfield capital city and to instead focus on distributing locations of governance beyond the Vijayawada-Guntur-Tenali-Mangalagiri urban area, while utilising the time period of 10 years to continue functions from Hyderabad after bifurcation. The Chief Minister's idea has got support from the government-appointed G.N. Rao committee; it has recommended that the Assembly's location be retained at Amaravati, with the Secretariat and High Court moved to Visakhapatnam and Kurnool, respectively.

Despite the expert committee's recommendations, the A.P. government led by the Telugu Desam Party had decided to build a grand capital in Amaravati, and had acquired large parcels of land from farmers. The Secretariat and Legislative Assembly were shifted to Amaravati in 2016, while the High Court began functioning in the beginning of 2019. Amaravati, which still requires significant development, has become a functioning State capital for all purposes now. But it is no surprise that many farmers, who had agreed to give up fertile land for the expansion of the capital as part of a land pooling scheme and were to have received residential and commercial plots among other forms of compensation, have protested the decision to decentralise capital functions. If the government limits Amaravati to hosting only the Assembly, it must take into account the concerns of affected farmers. That said, the fact that considerable work has been completed in Amaravati to utilise the fledgling city as a functioning capital must be taken into account before embarking upon the "decentralisation" idea, which was best served before the works in Amaravati began. Abandoning the plan that is already in place will render the grand city an unviable one. As in politics, in governance, timing is everything.

## Net loss

Disruption of connectivity should be resorted to only in the face of specific threats

The shutting down of the Internet in Delhi and several States as a response to growing protests against the Citizenship (Amendment) Act (CAA), 2019, is unsophisticated and deeply damaging to social life and the economy. Meghalaya, Tripura and Arunachal Pradesh were entirely cut off, and parts of Assam, West Bengal, Karnataka and Uttar Pradesh were deprived of Internet access, in clumsy attempts to quell demonstrations. Such ham-handed interventions have won for India a place at the head of the table among intolerant countries that routinely shut down the Internet to block criticism of the government. Jammu and Kashmir is now acknowledged globally as a dark spot on the Internet, with service there blocked since August 4. After protests against the CAA began, other States are also experiencing shutdowns, and the fate of connectivity is being decided by officers empowered by the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017 under the Indian Telegraph Act, 1885, or Section 144 of the Code of Criminal Procedure. A disruption is an extreme measure, and should be countenanced only for a specific threat, and as an interim measure as official communications fill the information vacuum. A case in point is the spreading of rumours on child lifters on social media, which resulted in several lynchings. The net blackout of the kind being witnessed now, however, has little to do with rumours, and is clearly aimed at muzzling the protests.

The Prime Minister, who has fashioned himself as a digital first leader, issued a Twitter appeal to people in Assam on the CAA, but they did not get it as they had no net. The NDA government should also be aware that the connectivity chokehold applied on J&K is proving lethal to entrepreneurship, crippling a new generation running start-ups and promoting women's employment. A disrupted Internet is dealing a blow to digital financial transactions across several States, to e-governance initiatives, and economic productivity. It affects education and skill-building, as the Kerala High Court affirmed in an order holding access to the net a fundamental right that could not be denied arbitrarily. The court pointed out that the apprehension of a gadget being misused is not a legitimate ground for denial of service, and the government should act on specific complaints. Yet, since 2015, shutdowns have been rising - 134 in 2018 - and the NDA seems unwilling to change course. It seems to matter little that blunt interventions make the ambitious goal of growing into a \$5trillion economy even more unrealistic, or that India is losing face as a democracy because it chooses to sit with authoritarian regimes. That is the wrong road to take. Reform and progress vitally need the net.

# The virtual effacement of civil liberty

The judiciary needs to determine whether the executive has provided a reasoned order when it directs an Internet ban

study of India's civil liberties record will only desiccate its status as a republican democracy. Even given that narrative, the ongoing repression of freedom in the Kashmir Valley is extraordinary. Not since August 4, 2019, have most residents in the region had access to the Internet. On that fateful day, in the lead up to India's unilateral decision to revoke its compact with the State of Jammu and Kashmir, a total communication and information blockade was placed on the region. The exercise was so clinically executed that even the orders imposing the restrictions were kept under wraps.

#### The import of a ruling

On the ensuing day, the Indian government went about dramatically altering its relationship with Jammu and Kashmir. Article 370 of the Constitution, which granted the State elements of administrative autonomy, was, for all practical purposes, severed. But with a complete curfew placed on movement in the region, Kashmiris were deprived even of any means of finding out what was actually transpiring. Remarkably, this state of affairs has scarcely changed since. While certain limited channels of communication have been opened up, access to the web remains elusive. By many accounts, this might well be one of the longest bans imposed on the Internet an ostensibly democratic government.

It is these facts - and the devastating consequences that they

have had on daily life in the region – that form the backbone of Anuradha Bhasin and Ghulam Nabi Azad's challenges in the Supreme Court of India. A three-judge Bench, which has heard oral arguments in the case, will sometime during the course of the coming weeks pronounce its verdict. Although, in answering the constitutional questions raised, the judges will heed to their past decisions, the case presents the court with its first real opportunity to rule decisively on the purport and reach of the right to access the Internet. The ultimate ruling, therefore, is likely to serve as a precedent of some value. And given the growing ubiquity of the Internet, and the state's increasingly whimsical use across India of blockades on the web, how the judgment goes will also doubtless have a bearing on the endurance of the constitutional promises of liberty and equality.

#### Ms. Bhasin's arguments rest on a simple premise: that the blackout of the Internet impinges on her

right to freedom of expression. In her case, the force of the communications ban was almost instantly felt. The Kashmir Times, a daily newspaper which she edits, which has been in regular circulation for more than five decades, went altogether unpublished between August 6 and October 10. Today, despite the partial lifting of some restrictions, with journalists hamstrung by the absence of the Internet, only a pruned version of the newspaper is published. These facts, Ms. Bhasin argues, evince how a denial of access to the web poses a direct threat on the liber-

ties of the press.

Opposition in the Rajya Sabha, highlights, there are also other deleterious results that have emanated out of the measure. These include a denial of the right to health care caused by people's inability, among other things, to access government schemes such as Ayushman Bharat, and a withdrawal of education to students at different levels, occasioned by the seemingly interminable closure of institutions. What is more, the shutdown has inflicted startling economic damage on the region. Even conservative estimations released by the Kashmir Chamber of Commerce and Industry show that the State economy has suffered a loss of no less than ₹15,000 crore since the dilution of Article 370.

#### Government's stand

In its defence, the government makes two primary arguments: first, it claims, that there is no obligation on it to disclose the orders through which the restrictions have been imposed; and, second, it contends that judges must grant the state substantial leeway in matters of national security; that once the executive believes on the basis of "some material" that freedom ought to be restricted, the court must not review the validity of such measures, even when those actions involve a wholesale blocking of the Internet

On any reasonable examination, however, the state's argu-

ments fail. Its order imposing the Internet ban, we now know, was made under the Temporary Suspension of Telecom Services (Public Emergency or Public Safety) Rules, 2017. This law requires the executive, among other things, to provide a reasoned order when it directs the withdrawal of the Internet. That such a direction exists, in and of itself, must make it clear that access to the web cannot be shut out through the issuance of furtive instructions. In a democracy, orders are made to be published.

#### **Issue of rights**

There is here, of course, an even greater principle at stake: the promise of free speech preserved in Article 19(1)(a) of the Constitution. As the Supreme Court has held, this guarantee contains both an inherent and an instrumental value. The first because it is important to respect every individual's equal right to personal autonomy and dignity, and the last because of the consequences of promoting free speech, that is that better dialogue stimulates a more informed polity. It was the instrumental value of speech that prompted the court, in Sakal Papers (1961), to hold that no policy of the state can so much as regulate the circulation of a newspaper, as any such programme will directly impinge on the right to freedom of expression.

Today, publishing a newspaper without access to the Internet is almost a Sisyphean task. Hence, much like the restrictions that were struck down in Sakal Papers, a blanket ban placed on the web will also transgress the guarantee of free speech. And in this case, the human costs go even further. For instance, a report in *The Hindu* ('Ground Zero' page, "In a land without Internet", December 7, 2019) shows that, with jobs already hard to come by, there has been

a staggering 80% loss of employment among start-ups in Kashmir that rely on the Internet.

Now none of this means that there can be no restrictions ever placed on the web, or that terrorism does not require counteractive actions. But what the law demands is this: that any measure taken by the state in restricting a fundamental right is necessary and proportionate to the goal that it seeks to achieve. To determine whether the limitations imposed in Kashmir meet this test, the court need not, as the state warns, perform the role of a super-executive. It merely needs to scrutinise whether a wide-ranging ban on the Internet on an entire populace is justifiable, when, even according to the government, it is only a 'minuscule minority" who are

likely to commit violence. Indeed, the state has, in the past, segregated people possessed of a potential to terrorise from others, based on their registered mobile phone numbers. In these circumstances, to permit a blanket closure of the Internet, given its impact not only on free speech. but also on other rights, including on people's rights to livelihood and health, would amount to a virtual effacement of civil liberty.

Stifling the mere hint of dissent through bans on the Internet will only send us racing towards a bottomless pit. Already, as a recent report in Live Mint underscores, 67% of the documented cases of web shutdowns around the world last year took place in India. Should these bans be upheld, we will be entering an abyss from which there can be no return. When that happens, our Constitution, and the hallowed promises it enshrines, will be found withering by the wayside.

# A premature denouncement of the Citizenship Act

Its critics must appreciate the need to bring closure to the consequence of religious theocracy in India's neighbourhood

inarayi Vijayan, senior leader of the Communist Party of India (Marxist) and the Chief Minister of Kerala has written in The Hindu (Editorial page, "Time to defend India's secularism", December 18, 2019) on why he opposes the recently enacted Citizenship (Amendment) Act [CAA], 2019. He gives three reasons for his opposition to the legislation.

In order to take up and rebut these reasons, the aims and obiects of this legislation passed by both Houses of Parliament by a large majority, and the historic context for the legislation need first to be made clear.

### RESPONSE

The Citizenship (Amendment) Bill was introduced in 2019 after long deliberation by the Joint Select Committee of Members of Parliament. A Report of the Committee was adopted by a majority of Members of Parliament and placed on the table of both Houses in 2016. But Lok Sabha elections intervened and so the Bill had to be re-introduced in December

**Ground realities** 

The need for this Bill arose partly because the Islamic theocratic na-

tions of Pakistan, Bangladesh, and Afghanistan have brutally persecuted non-Muslim minorities since 1947. This has led to a sharp fall in ♀ the proportion of the non-Muslim minorities in the total population of these countries.

Those who survived forcible conversion escaped and illegally entered India. They were Hindus, Sikhs, Jains, Buddhists, Christians, and Parsis and they were categorised as illegal migrants. As of December 31, 2014, they numbered 31,313: Hindus (25,447), Sikhs (5807), Buddhists (2), Christians (55), and Parsis (2). Those belonging to two religions were not in this list: Muslims and Jews. A small number of Jews migrated to Israel. No Muslims or Jews came to India over the last 70 years on grounds of religious persecution.

### Political concern

Over the past 70 years, many leaders of different parties expressed concern over the appalling conditions of living of this category of illegal immigrants. Not having citizenship or passports or Aadhar cards, they could not avail themselves of any proper employment and so lived in conditions of poverty and squalor.

The first authority to express concern over this state of affairs was the Working Committee of the united Congress Party. The Committee adopted a resolution on November 25, 1947 urging citizenship and "full protection to all those non-Muslims from Pakistan who have come over to India or may do so to save their life and honour". An affirmation of this view came



from Dr. Manmohan Singh, the then Leader of the Opposition in Raiva Sabha, on December 18 2003 (a video clip is available in the Parliament Library). Dr. Singh said then: "After the Partition of our country, minorities in countries like Bangladesh have faced persecution, and it is our moral obligation that if circumstances force people – these unfortunate people – to seek refuge in our country, our approach for granting citizenship to these unfortunate persons should be more liberal." The same view was expressed in writing in 2014 to Prime Minister Narendra Modi by the then Chief Minister of Assam, Tarun Gogoi.

Chief Minister Vijayan thus seems not to have appreciated the historical context of the CAA and the need to bring to closure the sad consequence of religious theocracy in our neighbouring nations. Instead he advances three reasons to denounce the CAA: First, that it is *ultra vires* the Constitution of India, especially Articles 5 to 11 and also 14. Second. that it is divisive, and violative of human rights because it discriminates against Muslims. Third, that the Bharatiya Janata Party's aim is to establish a Hindu nation and that aim underlies the CAA.

The first reason is baseless. Articles 5 to 10 have nothing to do with the CAA. Article 11 in fact empowers Parliament to bring such an amendment as the CAA. As for the CAA violating Article 14, we need to look at the letter of Article 14 but also at judgments galore of the Supreme Court of India on the interpretation of this Article.

A simple example to contradict Ar Vijavan's contention is of a Brahmin claiming reservation in education and schools on a par with Scheduled Castes because of Article 14 guaranteeing "equality before law". The Supreme Court has repeatedly made it clear that equality before law is only for those equally placed. Here on religious persecution, the Muslims of Pakistan etc., are not similarly placed.

Mr. Vijayan further adds that "Article 14 applies not only to citizens but all persons within the territory of India." Do we know of a single example of a Muslim citizen of Afghanistan, Pakistan or Bangladesh who entered India due to religious persecution and can be identified as an illegal migrant by the official agencies to qualify for citizenship under the CAA? The Union Home Ministry, in the list prepared of this category of illegal migrants, did not discover a single such Muslim from these three

It should be made clear that there are five ways a foreigner can become a citizen of India under the Citizenship Act, 1955, namely, by birth, descent, registration,

naturalisation, and incorporation of territory. The CAA, 2019 adds a country-specific exception to the naturalisation section. However, any Muslim can become an Indian citizen under the naturalisation

### **Hindutva and Constitution**

Mr. Vijayan makes a "final point" that "the agenda of Hindutva and the ultimate goal of establishing a "Hindu Nation" underlie the Citizen (Amendment) Act". Unfortunately, the present Indian Constitution cannot be amended beyond the Basic Structure of the Constitution as defined by the Supreme Court of India. So there is no need for anyone to unduly worry about

For persons like myself, who are committed to teaching Hindutva to our divided Hindu society (on a caste, language, and regional basis), Hindutva is already incorporated in large measure in the present Constitution. For example, the use of Sanskrit vocabulary [Article 351], official promotion of the Devanagari Script and its modified numerals [Article 343], the ban of cow slaughter [Article 48], the uniform civil code [Article 44], and faith as part of the unamendable basic structure. This is enough to usher in a Hindu Nation, because Hinduism is the only religion that formally accepts that all religions lead to God (Sarva Dharma Sama Bhava). Hence Hindutva is not contradictory to secularism.
