Toll touches 16 in U.P. as protests continue

Fresh incidents of violence in Kanpur, Rampur; police claim they did not open fire at protesters

Protests against the contentious Citizenship (Amendment) Act (CAA) continued in many parts of the country on Saturday, as the death toll from widespread violence in Uttar Pradesh rose to 16.

Fresh incidents of violence were reported from towns in Uttar Pradesh, while a bandh called by the Opposition Rashtriya Janata Dal in Bihar affected road and rail traffic.

Protests in West Bengal, Assam, Meghalaya, Maharashtra and the national capital were peaceful. Chennai continued to witness protests, with activists from several students' organisations, including the Students Federation of India (SFI) and the Untouchablity Eradication Front, clashing with the police at the Dr. Puratchi Thalaivar MGR Central Railway Station.

A 25-year-old youth died and several people were injured in clashes between protesters and the police in Rampur, Uttar Pradesh, officials said. Many persons were injured in Kanpur, after protesters set the Yatimkhana police post on fire and threw stones at the police. Over 260 policemen were also injured, of whom 57 received gunshot wounds, IG (Law and Order) Praveen Kumar told PTI.

The Uttar Pradesh police maintained that it did not open fire at protesters anywhere on Friday or Saturday, and firing came from agitators. "All the deaths that took place have been in crossfire, and this will become clear in the post-mortem examination," DGP O.P. Singh told reporters. "Women and children were used as shields by the protesters,"

he alleged. "If anyone died in our fire, we will conduct a judicial inquiry and take action. But nothing happened from our side," he said.

Internet services remain suspended in many parts of Uttar Pradesh. In Patna and several other towns of Bihar, Rashtriya Janata Dal (RJD) supporters picketed rail and bus stations and blocked

While the BJP has announced a nationwide campaign to drum up support for the law, the Congress vowed to keep up the momentum of protests and announced a silent dharna at Rajghat for Monday.

As the BJP signalled that it would brazen out the protests, its ally, Shiromani Akali Dal (SAD), called for bringing Muslims under the purview of the CAA and put a lid on the controversy. Party president and former Punjab Deputy Chief Minister Sukhbir Singh Badal said, We strongly feel that the Muslim community should

be included in it [the CAA]." The law fast-tracks citizenship for followers of six religions if they have fled from persecution in Pakistan, Afghanistan and Bangladesh, and excludes Muslims.

India, China to seek fair border solution

NEW DELHI India and China will intensify the quest for the settlement of the boundary question.

A statement from the Mi-

nistry of External Affairs (MEA) issued after the 22nd round of the Sino-India boundary talks, held here on Saturday under the framework of Special Representatives' dialogue, said the officials resolved to respect each other's sensitivities for the sake of better ties. "The Special Representatives resolved to intensify their efforts to achieve a fair, reasonable and mutually acceptable solution to the India-China boundary question in accordance with the directives provided by Prime Minister Narendra Modi and

A statement issued by the Chinese embassy on the talks said the two countries are planning 70 events to celebrate the 70th anniversary of diplomatic ties next year. The statement added that the two sides would "actively advance boundary negotiations in line with the Agreement on the Political Parameters and Guiding Principles for the



Ajit Doval and Chinese team agreed to intensify efforts to resolve the border issue.

Settlement of the India-China Boundary Question".

The 22nd round was led by National Security Adviser Ajit Doval and Chinese State Councillor and Minister of Foreign Affairs Wang Yi.

The MEA statement said the officials underlined the importance of approaching the question from the "strategic perspective of India-China relations". The Indian and Chinese leaders last met at the Mamallapuram infor-

mal summit in October. Saturday's border-related meeting was specially significant as China has been critical of India's August 5 decision to end the special status of Jammu and Kashmir and bifurcation of the region into two Union Territories of Jammu and Kashmir, and Ladakh. India had retorted by reiterating Delhi's claims over the Pakistan Occupied Kashmir by urging China to stop its activities in that region.

'Protesters say they were held after Friday prayers'

All 15 sent to two-day judicial custody; family of one claims he is a minor

NEW DELHI The 15 persons arrested in connection with Daryaganj violence on Friday have been sent to two-day judicial custody, senior advocate Rebecca John said.

The lawyer, who appeared before the court for all the 15 arrested persons on Saturday, said the police did not produce them till 4.30 p.m. after which the matter went to a duty magistrate. The matter is now scheduled for Monday, she added.

When asked about the profile of the accused, Ms. John said they are all from humble background, with one being a carpenter. "Most of them say they were picked up by the police when they were returning after Friday prayers," she said



One of the 15 arrested pera Delhi court sent 11 persons, arrested in connection with sons may be a minor, said the

senior advocate. "The boy's family said he was 15 years old but the police said they are verifying his age," she said. Deputy Commissioner of Police (Central) Mandeep Singh Randhawa remained unavailable for comment. In a parallel development,

the violence in Seemapuri on Friday, to 14-day judicial custody. Metropolitan Magistrate Mayank Mittal sent them to jail as the police did not seek their custodial interrogation, said advocate Nitya Ramakrishnan, who represented the accused.

The counsel submitted before the court that three of the accused had serious injuries and no prima facie case was made out against any of them. She further said the police had not placed on record any MLC (medicolegal case) to show the nature of injuries suffered by its personnel and sought to know the basis on which Section 307 (attempt to murder) of the Indian Penal Code was applied against the accused. The police said the arrest-

ed persons damaged public property and hurled stones at the police. Some of the police personnel received serious injuries and, therefore, Section 307 was slapped against them, the police said. (With inputs from PTI)

DDA issues notification to change land use of plot near South Block to 'residential' Block to its north, Dara Shi-

Govt. moves on plan for new Parliament House

NEW DELHI A 9.5-acre plot opposite the existing Parliament House is likely to be used for the construction of a new Parliament building, with the government on Saturday moving to change the land use of the plot currently designated for recreational use to "Parliament House" in the Master Plan-2021 of Delhi.

In a notification by the Delhi Development Authority, the government sought objections and suggestions for a period of 30 days on its proposal to change the land use of the plot, after which the land-use change will be finalised.

The plot is opposite Parliament House, with Red Cross Road to its north, Raisina Road to its south and



Minister Hardeep Singh Puri.

Parliament to its west, and is currently demarcated for recreational use in the form of a district park, according to the notification.

Changes aplenty Making way for a residential

space near the seat of power, a 15-acre plot located "North of Dalhousie Road, near South Block", with South

koh Road to its south, part of South Block to the east and Rashtrapati Bhavan to its west, was proposed to be used for "residential" use instead of the existing "government office" and "recreational (neighbourhood play area)", according to the notification. This comes at a time the

Union Housing and Urban Affairs Ministry, under which the DDA operates, is preparing for a revamp of Parliament, the Central Vista and government offices in the area. While the Ministry is yet to publicly share the exact plan, sources have said the Prime Minister's residence could be shifted closer to the PMO at South Block.

Also in the notification, the DDA proposed changing the land use of a 15-acre plot on Church Road near the Central Secretariat bus terminal from transportation (bus terminal and parking) and recreational (neighbourhood play area) to "govt. of-The land use of a 7.7-acre plot to the south of Dr. Rajen-

dra Prasad Road that houses the National Archives was proposed to be changed from public and semi-public facilities to "govt. office" for 5.88 acres and recreational (district park) for 1.88 acres.

Another plot on "South of Dr. Rajendra Prasad Road and East of Janpath", spread over 24.7 acres, was proposed to be changed from public and semi-public facilities to government office on 22.82 acres and recreational (district park) on 1.88 acres.
