'Counter-cyclical steps, structural reforms needed to tackle slowdown'

We are watchful of the evolving food inflation situation — at this point it looks transient. But we need some time to confirm that, says RBI Governor

As he steps into his second year as Reserve Bank of India Governor, Shaktikanta Das says the inflation targeting process is working well, and stresses that his priority will be to boost growth and resolve financial sector issues.

It is over three years now since the Monetary Policy Committee (MPC) was first constituted. The term of the present committee will end in 2021. How has been the experience with it?

On the whole, the inflation targeting has worked well, in many senses. Number one, it is a committee-based approach, so more minds are going into decision-making. There are three external experts which bring in outside perspective. This definitely improves the quality of decision-making and the outcome or final decision itself.

Since the time the MPC has been in place, by and large, inflation has remained within the target. Of course, one can argue that headline inflation is impacted by so many factors to which RBI has no influence. But at the end of the day, inflation has remained around 4% over the last three years so that the targets have been maintained. Without a target, we had a situation about five or six years ago when CPI [consumer price index] inflation was 10%.

Also the minutes of the MPC meeting are also published which brings in a greater transparency to the process of decision-making. The minutes also reflect the thinking of each member. That brings in lot of transparency. So looking back, I think the inflation targeting framework has worked well.

But has inflation targeting turned out to be detrimental for growth?

■ The provision in the RBI Act is very clear. It is to maintain price stability, keeping in mind the objective of growth. Therefore, the prime target is inflation. You have to suitably factor in the growth aspect also. Therefore, there is scope to give due weightage to growth

Do you think the target should be core inflation rather than the headline CPI

■ We are still about little less than two years away from the five year of current inflation targeting regime. I think it is too early to comment on that. The present scheme is going very well. As we go closer to the date, the government will take a view on the inflation target for next five years. Of course, the RBI will be suitably consulted by the government. So far it looks to have worked quite

What matters more for the common man of our country is the food inflation. There-

fore, you cannot keep it away; the weightage of which is 47-48% in the overall CPI basket. The headline inflation is something that everybody understands. If you say, core inflation, that is excluding food and fuel, you are entering into complications which will not have the kind of clarity and the straightforwardness of the headline number.

Are you concerned where inflation is going currently, in the immediate short term, especially food inflation?

■ Broadly, we have articulated that it is a matter which needs to be closely monitored, that is, the food inflation. We have to be watchful of the evolving situation and evolving numbers. But at this point in time, it also looks transient. And going forward, it should come down. But we need some time to watch that it is indeed transient.

Despite all that the RBI has done, monetary transmission has been unsatisfactory. What are the options before you now?

■ First thing is transmission does take time. Two, the system liquidity which was in deficit till the end of May, is in surplus from June 1 onwards and hugely surplus. Every day, we are absorbing [₹] two-and-a-half lakh crore. So we have kept the system in comfortable and surplus liquidity. The third thing is that the external benchmark



[for loan pricing] which we had introduced from October 1. Going forward, the impact of external benchmark will be felt more and more.

Do you think there are structural issues also behind the growth slowdown?

■ We have said in our annual report that it would appear that the slowdown is cyclical. However, there are structural factors also. Without getting into categorisation of the current slowdown, the focus should be on what steps need to be taken by the fiscal and monetary authorities. There has to be some countercyclical steps. There will have to be structural reforms which have been undertaken and the process needs to be continued.

Along with that, we have said we will also have a college of supervision to provide better skill to our officers. We are creating a separate cadre for supervision officers. We are also going to use technology, data analytics, in a big way. Plus we are also internally setting up a research and analysis wing within the department of supervision which will collate and correlate all the data, see the interconnectedness and will be able to

comprehensively look at the banking structure.

What is the road ahead for PMC Bank? Is RBI open for merging it with another

■ There is a forensic audit which is under way. We will get the report may be in another fortnight. PMC Bank, with the help of outside valuers, they are assessing the realisable value of the assets which are securitised by the borrower group. The other assets, including land assets, the realisable value of that asset is also been assessed. So with the permission of the court, the effort is to monetise those assets and put that money into the bank.

For that we have formed a coordination mechanism consisting of senior officer from Economic Offences Wing, the Enforcement Directorate, RBI and the administrator of the PMC Bank to quicken the process of the monetisation. So only when we have clarity with regard to the actual realisable value of all these assets which I have referred to, we will be able to decide on a next step.

What are the regulatory changes proposed for the regulation of cooperative

One aspect is changes to regulation which are within RBI, which we are going ahead and doing it. The other is making legislative changes to the law. There we have given our suggestions to the government which is under consideration. We have tried to strengthen the regulation.

What will be your immediate priority as you enter the second year?

■ For a central bank, it is a constantly evolving situation. At this point in time our priority would be growth and financial sector issues financial sector issues like the NPA resolution in the banks, and our expectation is that the resolution process become even faster. That is one; second is the NBFC sector which we are monitoring. Third is carrying out necessary changes in the regulation of urban cooperative

In the recent past, couple of times, the RBI has had to publicly state that the health of the banking system is fine post the PMC Bank crisis. Do you find a case to revisit the deposit insurance limit?

■ We issued those statements because of unnecessarv rumours floating in the market, various names were floating saying this bank is in problem. It was creating unnecessary, unjustified uncertainties in the market. So as the regulator of banks, we thought it was necessary that we give a clear message that the banking system is safe.

Deposit insurance is a matter which the Deposit Insurance and Credit Guarantee Corporation will decide. The matter is under review in DICGC.

Trinamool team detained at U.P. airport

Police surrounded the aircraft on the tarmac and took them to an undisclosed location in the terminal

In high drama at the Lucknow airport on Sunday, a Trinamool delegation, led by former Union Minister Dinesh Trivedi, was whisked away from the aircraft and detained for hours at an undisclosed location at the airport. The team had to return by an 8.30 p.m. flight without fulfilling its plan to visit the families of those killed in the protests against the Citizenship (Amendment) Act in Uttar Pradesh.

Mr. Trivedi drew parallels with the treatment of Indians during British rule. He said the team was detained without any provocation. The delegation included Rajya Sabha members Nadimul Haque and Abir Ranjan Biswas and Lok Sabha member Pratima Mondal.

The Uttar Pradesh police were waiting on the tarmac

for the IndiGo flight carrying the delegation. It surrounded the aircraft the moment it landed around 2 p.m. Mr. Trivedi said the policemen got on the aircraft to detain the four leaders. When they resisted and forced their way to the passenger bus, the police off-loaded the other passengers. The bus carrying the leaders and policemen then drove off to an undisclosed location within the

They were confined there without even being allowed to step into the terminal building.

"Are we in 1947 or is it 2019? The BJP government led by Yogi Adityanath is

scared of democracy. The IIP administration has taken lessons from the pages of the British Raj. I am ashamed that our own policemen are behaving in this manner with public representatives," Mr. Trivedi told *The Hindu* over phone from

the airport. He said that Sunday's incident reminded him of his visit with the rest of the Opposition team on August 24 to Srinagar where they were detained at the airport and asked to return immediately. He said the Trinamool

leaders were not in Lucknow to create a law and order situation.

The wav we were manhandled and off-loaded from the aircraft the rest of the passengers would be thinking that we are terrorists," he added. The delegation has not been told under what law or rule they have been detained.

"All the government has to do is to read the Constituent Assembly debate about what Sarvepalli Radhakrishnan said on the citizenship issue. And forget about the Constitution, this kind of behaviour is against the spirit of Hinduism which is an inclusive religion," Mr. Trivedi added.

He denies police hand in killings

Uttar Pradesh Director-General of Police O.P. Singh has said that no one was killed in police firing and the deaths were due to gunshot injuries fired by non-prohibited weapons which are not used by the police.

Mr. Singh said the death toll so far in the State was 15.

Mr. Singh told *The Hindu* that the entire agitation in the State became "spontaneous and leaderless" and was "infiltrated by outsiders and anti-social elements".

He said violence was reported from only "onefourth of the State comprising 16 or 17 districts".

He said that despite the Internet clampdown and prohibitory orders, a huge mobilisation was seen as people used offline mobilebased applications.

Fifteen people were killed in Uttar Pradesh in the past three days, the highest in the country so far, in clashes with the police as many people came out in protest against the Citizenship Amendment Act (CAA) and the proposed National Register of Citizens (NRC).

Post-mortem report

"All these deaths took place due to gunshot injuries from non-prohibited weapons. The police do not use them. The post-mortem report shows that injuries were not inflicted by police weapons but show that countrymade pistols were used. It is not like that these agitators were without any weapons, they had illegal weapons and that is how we recovered 647 empty cartridges from these areas," Mr. Singh said, adding that 62 police personnel also received bullet wounds.

He said children as young as 12 and a large number of women joined the agitation despite prohibitory orders.

"Despite our instructions and advisory these people assembled and resorted to violence. We did not show any forcible action on our part, we only wanted to chase them away...there



group and I myself moved some women to a safer zone," he said.

Asked whether the police brutality as alleged by locals and visible on various video clips where policemen were seen firing would be investigated, Mr. Singh said, "In such a situation if there are lapses on the part of the police, we will certainly enquire but keep in mind we also sacrificed with injury to our men. They braved violent agitation, they faced violent mob with stone pelters but stuck to the ground. I compliment my policemen that they showed such restraint."

He said the violence was supported by certain political parties and NGOs and they have evidence against them.

Alleges conspiracy

"The whole show was captured by people who did not believe in the democratic values. They wanted to create problems for the State and the administration; for them violence was important and it smacks of a conspiracy. It was given support by political parties, NGOs we have evidence. They played a prominent role. We are collecting evidence. We have definite information that Popular Front of India [PFI] was involved, we arrested few of their office- bearers," he

While defending the police action in Aligarh Muslim University (AMU) on December 15, Mr. Singh said they entered the campus as they were called in by the university authorities.

Songs, slogans and speeches mark anti-CAA stir

Protesters in Chennai accuse BJP-led Centre of drafting laws that would 'destroy' minorities

Fiery speeches, Bharathiyar songs and rap and folk music by the band Casteless Collective marked the protests held in the city on Sunday by different groups against the controversial Citizenship (Amendment) Act (CAA) and the National Register of Citi-

The first protest of the day was by Muslims from 30 mosques in Triplicane and members of a few temples. Chants of Hindustan Zindabad, Sare Jahan Se Accha, Inquilab Zindabad and Allahu Akbar resonated through the air, as more than 500 protesters carrying Indian flags gathered at Chepauk.

Unmindful of the heat, the young, the old, the visuallychallenged, women and even children took part in the protest, which started at 11 a.m. They occupied one side of Wallajah Road leading to the beach, while the other side was open to traffic. Three MTC buses were kept on stand-by to ferry the prot-

esters, in case of arrests.

"This is a protest to condemn the CAA and ask the government to scrap it. Instead of introducing welfare schemes or improving the economy, the ruling BJP government [at the Centre] has been enacting laws to destroy Muslims, Dalits and other minorities," said M.H. Peer Mohammed, a protester.

Accusing the AIADMK government in Tamil Nadu of not treating the Muslim community properly, he said, "When many other States

have refused to implement the Act, it is sad that the Tamil Nadu government is maintaining silence on the issue. Even now, they can withdraw it. The Prime Minister should address the public and give some clarity re-Many of the protesters ar-

It is not right to treat us like this," said Anwar Basha, a protester. Around noon, more

youngsters, including non-Muslims, started pouring into the protest venue, holding placards with messages like 'Hindu-Muslim Bhai Bhai' (Hindus and Muslims are brothers) and 'We Tamils reject CAA-NRC'. Some took aim at Prime Minister Narendra Modi, Home Minister Amit Shah and the Tamil Nadu government.

They staged individual protests on the same stretch. with some squatting on the road. The organisers kept requesting the participants to protest peacefully and not cause any inconvenience to the public or the police. The agitation drew to a close at 1

The second protest – a march by the Sunnath Jamath Federation and a few members of non-Muslim communities – started from the Big Mosque on Triplicane High Road. "We walked till Chepauk, holding placards and shouting slogans against CAA and NRC. It was a peaceful protest," said Syed Riaz Ahmed, a protester.

Meanwhile, hundreds participated in a protest organised by the Citizens against CAA near the Besant Nagar bus terminus. People from different walks of life took part in the peaceful agitation.

Vehicle restriction

As a precautionary measure, the police initially prevented vehicles from entering the Besant Nagar promenade. However, the restriction was later relaxed, considering the number of people likely to visit the beach on a Sunday. Protesters carried witty

posters with messages like "It is so bad that even the crow stopped CAA-CAA" and "The cow ate my documents". The protest began with a rendition of the song 'We shall Overcome' and the 'Tamizh Thai Vazhthu'.

After that, there was a two-minute silence for those who had been killed during the ongoing protests.

Ghani set for second term in Afghanistan Kim discusses bolstering

Incumbent President wins 50.64% of the votes against 39.52% by rival Abdullah, after preliminary results

Afghanistan's President Ashraf Ghani appeared to have secured a second term, preliminary polling results showed on Sunday, but his main rival immediately vowed to challenge the tally.

After months of political limbo and allegations of fraud and corruption in the September 28 poll, Afghanistan's Independent Election Commission (IEC) said Mr. Ghani won 50.64% of the

If it holds, the result is enough for Mr. Ghani to avoid a run-off. He easily beat his top challenger, Chief Executive Abdullah Abdullah, who scored 39.52%.

In a televised address, a jubilant Mr. Ghani said the election results were a "victory" for all of Afghanistan. "A government worthy of this great nation will be built," Mr. Ghani said.

Candidates now have three days to file any complaints before final results are announced, probably within weeks. Mr. Abdullah said he would contest the

N. Korea has sought U.S. concessions by end of December

North Korean leader Kim Jong-un discussed strengthening his country's military capability with top military officials, state media reported on Sunday, with Pyongyang's end-of-year deadline for the U.S. to offer concessions approaching.

The North promised an ominous "Christmas gift" earlier this month if Washington does not give ground by the end of December. The denuclearisation process has been largely deadlocked since the collapse of a summit in Hanoi at the start of the year.

Pyongyang has carried out a series of static tests at its Sohae rocket facility this month, after a number of weapons launches in recent weeks - some of them described as ballistic missiles by Japan and others. North Korea is banned from carrying out such tests under UN sanctions.

Mr. Kim held an enlarged meeting of the ruling Workers' Party's Central Military

Hong Kong protesters rally for Uighurs

According to UN, at least 1 million Muslims have been detained in Chinese camps

HONG KONG

Hong Kong riot police pepper sprayed protesters to disperse crowds in the heart of the city's financial district on Sunday after a largely peaceful rally in support of China's ethnic Uighurs turned chaotic.

Dozens of police marched across a public square overlooking Hong Kong's harbour to face off with protesters who hurled glass bottles and rocks at them.

Earlier in the afternoon more than 1,000 people had rallied calmly, waving Uighur flags and posters, as they took part in the latest demonstration in over six months of unrest.

A mixed crowd of young

and elderly people, dressed in black and wearing masks to shield their identities, held up signs reading "Free Uyghur, Free Hong Kong" and "Fake 'autonomy' in China results in genocide".

The protest comes after footballer Mesut Ozil caused a furore in China after he criticised the country's policies toward the Muslim ethnic minority in the northwestern region of Xinjiang.

"I think basic freedom and independence should exist for all people, not just for Hong Kong," said a 41year-old woman surnamed Wong who attended the protest with her husband.

UN experts and activists say at least 1 million Uighurs and members of other largely Muslim minority groups have been detained in camps in Xinjiang since 2017 under a campaign that has been condemned by the United States and other countries.

FATF puts 150 questions to Pak.

PRESS TRUST OF INDIA ISLAMABAD

A global watchdog for terror financing has sought more clarifications and data from Pakistan on actions taken by it against madrasas belonging to the banned outfits, weeks after Islamabad submitted a report to the Parisbased body detailing steps taken by the country to curb terrorism and money laundering.

The Financial Action Task Force (FATF), which kept Pa-

kistan on the Grey List for an extended period till February 2020, had warned in October that Islamabad would be put on the Black List if it did not comply with the remaining 22 points in a list of 27 questions. Pakistan submitted a report comprising answers to 22 questions to

the FATF on December 6. In response to the report, the FATF's Joint Group has sent 150 questions to Pakistan, seeking some clarifications, updates and actions

taken against the madrasas belonging to the proscribed outfits. "We did receive a response from the FATF on our compliance report through an email in which they raised a set of 150 questions. Some of them are seeking more data, some clarifications, and most importantly questions related to madrasas and actions taken against them having affiliation with proscribed outfits," The News quoted a top official source as saying.

Thousands protest in Iraq

Thousands took to the streets in Iraq's capital and across the south Sunday to protest against Iran's kingmaking influence as the latest deadline for choosing a new Prime Minister loomed.

Anti-government rallies have rocked Baghdad and the Shiite-majority south since October 1, with demonstrators calling for a complete overhaul of a regime they deem corrupt, inefficient and overly beholden to Tehran.

"The revolution continues!" shouted one demonstrator at a protest encampment in central Diwaniyah

Sunday marks the latest deadline - already pushed back twice by President Barham Saleh – for Parliament to choose a new premier to replace Adel Abdel Mahdi, who tendered his administration's resignation last month.


Parliament speaker Mo-

hammed al-Halbussi on Sunday travelled to Arbil, capital of the Kurdish autonomous region in northern Iraq, to discuss who could become the next premier, the presidency there said.

Officials say Iran wants to install Qusay al-Suhail, who served as Higher Education Minister in the government of Mr. Abdel Mahdi.

"This is exactly what we oppose – Iranian control over our country," said 24year-old student Houeida.

Value of surrender

While the monkeys are reluctant to admit Vibhishana into their camp, Rama is determined to accept Vibhishana's surrender. He justifies His decision by narrating a story about two pigeons, said Kidambi Narayanan, in a discourse.

The two birds, a male and its partner, were sitting on a tree. The female bird fell off and was caught in a hunter's net. The hunter spent the night under a tree in the forest, after praying to the devata of the tree to protect him. The female suggested that the male bird help the hunter, who was hungry. Not knowing what to offer him as food, the male bird jumped into the fire, so that he could cook it and eat it. The male bird's reasoning was that the hunter had appealed to the tree for protection, so it was its duty to help the hunter. The hunter had not asked the bird to help him. He had only asked the devata of the tree for protection, and the pigeon was not the devata of the tree.

Moreover, the hunter had caused it sorrow, by trapping its partner in a net. Death to the female bird was certain. And yet the male pigeon helped the hunter, by offering its own life. This is the ultimate sacrifice anyone can make, and a mere bird had done this. If a pigeon should help a man, which had snared its partner, should Rama not admit Vibhishana, who had surrendered to Him? Thus goes Rama's argument. Rama further says that in case Vibhishana had only been pretending to be a friend, He would still welcome him. In case Vibhishana's words of friendship had been lies, still Rama would accept him. If Vibhishana had not spoken but had only offered anjali, still Rama would have accepted him as a friend. Sastras say that if a person surrenders, even if he has in some way harmed us, we should not turn him away, but offer him our protection.

Q. I have invested money in an insurancecum-savings scheme. The payout will be in five years' time. I will be getting a lump sum amount of ₹30 lakh.

This money is tax-free, which means that I don't need to pay any tax when I get this money. I am concerned about where to invest it once I get the lump sum.

Can it be put in an annuity scheme? Will the income from the same be taxed? Please suggest what else to do with the lump sum and how to save tax on it.

VANDANA SAHAY

A. Your age and whether you need income regularly are the two key inputs we need to know to suggest investment avenues. If you need regular income, you may invest the money in an immediate annuity plan. This will basically provide you deduction of up to ₹1.5 lakh under Section 80CCC (limit clubbed with Section 80C deduction) in the year of

However, the pension/annuity you receive will be fully taxable in your hands in your income slab rate. If you are in the high-tax bracket, this will leave less on the table for you. The returns too are lower than FD

If you will be above the age of 60 when you receive this money, then your first option should be the Post Office Senior Citizens' Scheme. This will provide you with a deduction of up to ₹1.5 lakh under Section 80C in the year of investment. The annual interest income (along with all other bank interest income) will be allowed as deduction up to ₹50,000 per annum. The rest of it will all be taxable in your slab rate. But this is the best and safest.

If you are not a senior citizen, then go with a simple Post Office Time Deposit and some bank deposits. Here again, the ₹50,000 per annum deduction for interest income, mentioned earlier, will kick in.

The other option would be for you to go with liquid/short-tenure quality debt funds. If earning income is not a priority and you can let at least a part of the money remain untouched for another five years, then consider investing 20-30% in consistent equity funds and the remaining in the debt options we mentioned above.

Whichever way you look at it, income from an investment will be taxed. It is more efficient in a mutual fund route and less so in a regular deposit route. Do not consider the insurance route simply to avoid tax. Safety, returns (if you are investing for long term) and liquidity should receive priority in investment decisions.

Q. Both my parents are retiring next year from government service and they will be getting about ₹50 lakh (together). Please throw light on some investment plans for a regular monthly income of ₹15,000.

A. The first option for your parents would be the Post Office Senior Citizens' scheme. Together, they can invest up to ₹30 lakh in this option. This will fetch them a comfortable 8.6% per annum.

This will be a quarterly payout, but they can withdraw from the post savings any time after the first quarterly payout. If they are less than 60 years (and more than 55 years), please ensure they invest their retirement proceeds within a month by opening this

Such a restriction does not exist if they are 60 years or above. Let them keep around ₹10 lakh in short-term FDs and some amount in savings banks account of large public or private sector banks to meet their emergency

The balance can be invested in LIC's Pradhan Mantri Vaya Vandana Yojana, a pension policy with 8% interest paid out monthly, quarterly, half yearly or annually. (The author is co-founder, Primeinvestor.in)

Navigating the National Pension System

Do the choices that the NPS offers sound Greek & Latin? With a little help, the system's menu can be used to your advantage

The popularity of the National Pension System (NPS), the market-linked vehicle, has been soaring with investors desperately seeking retirement options. But for a newbie investor, investing in NPS can be very much like visiting a Starbucks outlet for the first time. The scheme offers so many choices that one is unsure where to start. With a little help though, you can use NPS's large menu to your advantage.

Tier I and Tier II

One of the first choices you'll need to make while opening an NPS account is whether you need just a Tier I account or want to add on a Tier II account as well. If retirement savings is your goal, a Tier I account should suffice.

The Tier II account is a voluntary investment vehicle where you can put in and withdraw money at any time. It is only under the Tier I account that your contributions earn tax breaks of up to ₹1.5 lakh a year under section 80C and the additional exemption of ₹50,000 a year under section 80CCD (1B). Tier II contributions do not earn any tax

breaks. While the NPS Tier II does offer advantages such as flexibility and low fees, there are alternative products such as mutual funds that you can consider too, for such voluntary in-

Which fund manager The NPS lets you choose who

will manage your money. The scheme currently has 7 pension fund managers (PFMs)

on its menu - Birla Sun Life Pension Management, HDFC Pension Management Company, ICICI Prudential Pension Management Company, Kotak Mahindra Pension Fund, LIC Pension Fund, SBI Pension Funds and UTI Retirement Solutions. Given that the NPS is market-

ble shows performance separately for equities, corporate bonds and government securities. However, as you can

only a single PFM, it is best to go for one with a reasonable performance across all three.

In market-linked products, the true performance of a fund manager can be gauged only over a complete market cycle. Of the seven PFMs, only four have a 10-year track record. UTI Retirement Solutions, ICICI Pru Pension and SBI Pension have a good 10year record.

The NPS allocates your accumulated contributions into four asset classes - Equity (E), Corporate bonds (C), Government Bonds (G) and Alternative Investment Funds such as private equity funds, REITs, Invits (A). Your allocation among these is critical to your final returns.

These assets carry varying risk profiles. Equities can get you to a double-digit return in the long run with a significant risk of capital losses.

The Auto choice may certainly look appealing for folks to whom finance is Greek and Latin. But the flip side is that your returns at retirement may be sub-optimal. The Auto choice's propensity to cut back on your equity exposures right from the age of 35 can leave you with a very bond-heavy portfolio in your 40s and 50s, when your earnings are likely to be at their peak.

To maximise the retirement corpus you accumulate, it is desirable to opt for the Active choice. Peg your equity allocations at 60-75% to begin with, park 15% in corporate bonds and the rest in government bonds. You can sit tight on this allocation until you turn 55. That will be a good time to shift allocations to government bonds in order to reduce risks in the home run to retirement.

Finally, one of the most investor-friendly features of NPS is that it allows you to change vour choice of PFMs and asset allocations once a year, without any costs or tax implications. Review the performance of your PFM at least twice a year and exercise the switch option if there's a big lag.

RIGHT SIZING: TERM PLAN COVER

One size does not fit all in life insurance

Ideally, sum assured should be 12-15 times of your dependent family's annual expenses

When Sunil Thakur - a 28-yearold Bengaluru-based IT professional - bought a term insurance cover of ₹1 crore in 2016, he was single and had no dependents.

Now married and father of a one-year-old girl, Sunil strongly feels that his ₹1-crore term plan may not be sufficient to sustain his family's needs and cover his life goals 15-20 years down the

He believes that his professional and personal lives were only beginning and both his income and expenses will rise significantly in the next couple of years. And to cover the loss that may include Sunil's sudden death, perhaps a cover with higher sum assured might be required. The sad part is that people who think and calculate like Sunil are very few. To most policyholders, the ₹1 crore amount seems huge. They believe the cover is sufficient to take care of all their financial needs in case something unfortunate happens to them.

With the ₹1 crore cover being a popular term, most people seem to be mentally comforta-

How most people come to the conclusion that ₹1 crore cover is enough, is by calculating that if the family deposits ₹1 crore in a bank account that earns 7% interest, it will fetch them a monthly income of ₹58,333. To them, the amount is enough to sustain the expenses of an average middleclass Indian household.

Though this calculation may seem 'legit' on paper, it won't work when you take into consideration many factors such as

> No doubt, despite the demand for pure protection term plans having increased considerably in the last few years, the disparity in life protection in India is still as high as 92%. Attributing low awareness around adequate coverage for this massive disparity would not be wrong.

Technically, an individual's life cover should be strictly based on his/her stage of life.

What the calculations say is that an earning individual up to the age of 40 must consider

purchasing a term plan with a life cover of up to 15-20 times of the annual income. An individual in his/her 40s must consider buying a cover up to 10-20 times of the annual income, while an individual in his/her 50s should opt for a life cover 5-10 times of the annual income.

The average salary considered here is ₹10 lakh per

Apart from income, the expected expenses can also form the basis of an individual's sum assured estimation. Ideally, the sum assured of your term insurance plan should be 12-15 times your dependent family's annual expenses.

At the same time, it is important to learn that the financial situation of every individual is distinct and unique, and the one-size-fits-all approach is never recommended when choosing life insurance cover.

Also, your life insurance cover should be linked only to your needs, requirements and expenses and not to a figure like ₹1 crore. Though the emotional stress cannot be compensated for in case of sudden death of the life assured, adequate sum assured can certainly ensure that dependents do not have to

For the first five years, the death benefit remains at the same level. The sum assured then starts to rise by 5-10% for the next 15 years or till end of policy term, whichever is earlier.

All such plans let you increase your term cover by using the increasing sum assured option with the same insurer, thus taking care of the increasing expenses of your family.

Thanks to social media, artists and musicians are playing a big role in the resistance today

Rachita Taneja sees her popular comic strip, Sanitary Panels, as just "one of the tools in my toolkit to mobilise people."

With over 33,000 followers on Instagram and a column with Forbes magazine, Sanitary Panels - which began during Rachita's years as a Greenpeace campaigner - has been scathingly vocal about social and environmental causes.


Now, as protests against the Citizenship Amendment Act (CAA) and National Register of Citizens (NRC) have taken hold of the country, it is more active than ever. The images have been been taken out of phone screens into real life. Rachita's identifiable stick figures – as well as sketches she made from converting powerful press photographs - are among the most common visuals seen on protests posters in city after city. For she is among a host of cartoonists to have made their work open and available for the cause.

Another such artist is Kruttika Susarla, who has not only put up a Google drive of some of her work for the public. but also had posters translated into Tamil and Marathi for good measure.

But it is not just about posters – artists with followers as large as these women have, also take their role as influenseriously. Information dissemination is an important part of what Rachita does, be it pie charts of Internet shutdowns or social media posts dispelling rumours. She was also one of the leading people behind the Net Neutrality movement in 2015. "I always try to add some more text for explanation, along with my Sanitary Panels posts," she says.

This is something Bengaluru-based artist and social worker Shilo Shiv Suleman has been doing for about seven years now. Her work We Belong Here has been going viral since the protests picked up, though her influence is not restricted to India alone. Her The Fearless Collective, started during the Nirbhaya protests, used to be centred around art, but "has evolved into a more detailed organisation creating monuments around social issues: we work with sex workers in Pakistan, Syrian refugees and undocumented migrants in Beirut, and indigenous communities in Brazil, among others," she says.

These women are not alone... a number of artists and creative minds are using their talent to spread awareness,



mobilise, and lend the protests some colour. One of the images going viral is that of a tricolour whose saffron strip has grown larger than the other two colours, with a man struggling under its weight. Titled Weighing Us Down, the work is by an anonymous artist who goes by the Instagram handle Smish Designs. "I haven't really made it available, but people have made their own renditions of the piece to carry to the ongoing protests across the country," says the designer.

New York-based Anjali Chandrashekar, meanwhile, is seeing her work reflected not only at protests in New York, but also back home in Bengaluru, Delhi and Chennai. The Bengaluru-born, Chennai-raised artist has been based in the US for nearly a decade now. "I wanted to do my bit, not being able to participate in local protests [in India]," she says, "So I got in touch with Creatives Against CAA, who are crowdsourcing content and art and facilitating conversations."

Creatives Against CAA is essentially an Instagram page run by Kadak Collective, a group of South Asian women working in the field of graphic storytell-



ing. The group is curating work from various artists and putting them up to be shared by campaigners, protesters or even vocal Instagrammers.

Anthems galore

While 'Azadi' is the chant of choice for protesters across cities, independent singer-songwriters have also come up with pieces that seem to resonate.

'Bol Kyon', by Kolkata-based Assamese independent filmmaker Ronny Sen, garnered over 9,000 views within a day of it being uploaded on Instagram TV. Delhi-based B Tech student Shahroz Ahmad's 'Kabool Kro' reached almost 50,000 people in three days.


Shahroz, who identifies himself as Rapper Shaz, is all of 18 years old and credits his mother back home in Bihar for his love of writing. "She is a poet, I get my talent from her," he says, "I wrote the lyrics to 'Kabool Kro' in an hour, after a friend and I stayed up all night disturbed by the videos of violence in Jamia [Millia Islamia University]. My friend Akhilesh Saurabh put together the video in four hours."

'Kabool Kro', which translates to "admit it", is set against a visual mishmash of news clippings, protest visuals and videos. "I was scared that I would get hate for it, but all I got were requests to sing this at protests. I will, as soon as my exams get done," says Shahroz.

Power of the pen

And then there is the translation project initiated by Delhi-based singer-songwriter Ilina Acharya. nacular language, and get it published in vernacular press.

"Speaking from a musician's point of view, it's our job to speak up," Ilina stresses. She adds, "The power of the stage we are given, I don't think we realise the magnitude of it. No one is saying naara lagao (chant slogans), but at least use the stage creatively and respond to what is happening."

For Ilina, the project came out of a need to engage productively... "A way out of the echo chamber that is our social media. People don't really know the nitty gritties of law, but we need the facts to turn the narrative." She concludes, unwittingly echoing Shahroz's lyrics, "If they have their guns, we have our pens.'



DOWN MEMORY LANE

70 years ago on Christmas Eve

Little has changed in Agra's bustee of Padritola, except that new characters have emerged where the old are no more

Christmas Eve 1949 was as cold as ever. The manger had been set up in the Agra Catholic Cathedral aisle and in the neighbouring Christian bustee of Padritola the spirit of Christmas was at its peak. The scene is worth replicating: Jajja Bua sat in front of her house watching the fun as the tipplers were up to their antics. Cyprian had put on a petticoat and went about kneeling in front of everybody saying. "Bua mauf karna" (pardon me sister). Master Sahib had discarded his kameez-pyjama for a serge suit in which he strode up and down with the energy that only a few pegs can impart.

Fog had descended early on the *bustee*, set up by the early missionaries in the 18th century, some say even earlier, when the Apostolic See extended right up to Tibet from Agra during the Mughul period. The residents were Indian Christians but the names Latin. Pachipico, Verencio, Bitus, Linus, Lucas, Bibiana, Veronica, Valentiana, Sanfroza, Fidelis, Fosca, Filgensia, Bonavantura - and any others that you can think of. If a Roman had visited the place he would have hardly believed that he was thousands of miles away from home. They all knew Latin, at least enough to follow the Mass and give the appropriate responses to the priest, including the Gregorian chant. In such a setting the carols were in Latin too. They sang Adeste Fidelis, and other Christ Nativity hymns, each trying to outdo the other with the correct emphasis and as resounding a voice as possible.

That evening at the brickkiln near the *bustee* gate sat a group of singers rehearsing for the Mass. In between gulps of rum they rendered each line with the proper stress, applauding those who excelled. Jargi played the harmonium, Stanislaus the *dholak* and Yonnus the gypsy drum while Lazarus, Seraphine, Francis and Yakoub formed the choir. In a little room near by Lucas, a blind member of the Third Order of clerics, put on his habit and silver crucifix while humming a sacred rhyme in keeping with the occasion.

But unaffected by all the tamasha around, a young girl Virginia rehearsed the part of the Virgin for the Nativity play the next day. She had the face of the Madonna and the natural piety that made her look the right choice for the coveted role.

In another quarter the old priest Father Daniel had been prevailed upon to sample the amber stuff in preference to the "tharra" or country brew he had to make do with in his rural Mathura parish of Chandu-ka-Nagla, some 70 kilometres away from the city. Reluctantly he drank for he never wanted to doze off during Mass and give offence to the Archbishop. "Remember", he said, "the story of the priest who slept during Christmas service. The poor man has to still attend all the midnight Masses down the centuries for the one lapse."

"But Father you are different," they all cooed and Padri Daniel beamed in appreciation. Thus in every house and lane people were in a merry mood until the church bells an-

nounced that Midnight Mass was to start in half an hour. That changed the whole scene. Everybody tried to hurry. Cyprian discarded the petticoat. Jarji left the harmonium to rush to the church where he was supposed to be the sacristan, Jajja Bua put on her new skirt and jacket, Master Sahib brushed up his hair and suit, Father Daniel used his walking stick -which was more like a lathi - to good effect to reach the sacristy on time, and the girl who was supposed to play the Virgin Mary changed her clothes and make-

up to look like Christ's mother. At the stroke of midnight when the venerable Italian Archbishop Vanni raised his voice in the Gloria hymn, there was a loud report as a cracker burst and joy bells rang out to convey the news of the birth of the Saviour. A priest placed the image of the Holy Infant in the manger and the choir took up the "Glory to God" refrain.

Mass over, people wished each other despite the misty night and bitter cold. The following day was spent in merriment and the evening saw the Nativity play being enacted, with Virginia playing her part well. But there was a big commotion after the play ended. Virginia was nowhere to be found. She had slipped away with her lover.

The bustee was in turmoil for several months until the two returned, but Virginia was never allowed to play the coveted role of Mary again.

Virginia is no more – and so also many of those who enlivened that evening. But the Yuletide scene at Padritola is much the same though the actors are different and a boy with a cherub's face rings the bells at midnight to proclaim the birth of Christ in Bethlehem when Caesar Augustus ruled half the world and Agra was a part of the Braj Mandal of Lord Krishna. He too like Jesus, was born at midnight a thousand or more years before him to Devaki and Vasudeva during the reign of the tyrant Kansa.

Opening up language

Satti Khanna talks of the art of translation and his latest work


For Satti Khanna, translation is a passion, and he says his style is to "translate fairly closely to the literal movement of the original." He is an associate professor at Duke University, United States, where he teaches Indian Cinema and Modern Hindi Literature. Vinod Kumar Shukla, a poet and novelist from Chhattisgarh, is Khanna's favourite. Having translated four of his works, the fifth and latest is A Window Lived In The Wall (originally published in 1997 and titled Deewar Mein Ek Khidki Rehti Hai) which won the Sahitya Academy Award in 1999.

The text that explores a marriage, talks of "poor people who manage to be neighbourly or generous in drab circumstances," says the author. It centres on peoples' daily lives, with humour and lyricism. The window in the title forms the point between the sparse interiors of the couple's home and the vast world outside. It is the story of people flourishing despite hardships.

Khanna's family, displaced from Pakistan in 1947, found refuge in north Bihar and he later studied at St. Stephen's, Delhi, and won a scholarship to Harvard. In Delhi, after visiting Shukla in Raipur, he shared his views on his work:

What are the skills you have honed to be a translator?

A lot in my life has been to get on the bus, and then it takes me somewhere. I haven't really planned the journey, but I stay awake. I started translating out of love of the text and a desire to inhabit its space. By now I've translated say 10 books [Mohan Rakesh, Phanishwar Nath `Renu' and a few more] and not all by the same author. The greatest skill I've learned is to leave the work as open as it is in the origin. The sweetest thing about my work is its music. The next is the possibilities that hover around what is said.

What kind of research is involved in your translations?

Because I'm an amateur, I don't have a reliable method. I don't read the book, unless I have leisure to admire it and savour it. And so the relationship of pleasure in the work is the thread that goes from the original to what I'm calling the estrangement to the music that's possible in the new language. In the course of reading a book, there are allusions, references to other works, and obviously I have to understand them. I ask some specialists to respond. So the words I'm usually translating are poetic, they create their own coherence.

Do you agree that translators

don't get their due? I agree. There are two kinds of translators. One that seeks to be seriously faithful to the surface of the work we are translating. Then

the perfect one, a translator for the United Nations. They are an even smaller niche than those of us who translate text. They deserve equal notice with the original writer because they've taken it upon themselves to engender energy, rather than to relate to a world whose glimpses a translation might give us. So they feel bound to the power that's possible to human words. And may they receive, and some of them do in Europe receive, that kind of acknowledgement.


Have you ever thought of writing a book of your own?

If I wrote a book it would be about my childhood. Being displaced and being treated with people in a place of such kindness (north Bihar), such support of strangers that you can't repeat.

HYPE OR HAPPENING?

Jaggery, the lung cleanser

It may not have the thorough documentation that say blueberries have, but we in India accept that jaggery has benefits. As the purest form of unrefined sugar extracted from sugarcane juice and sometimes from the palm and coconut, it is a store house of iron, vitamins, minerals, antioxidants, potassium and sodium. Most homes have it readily available in their kitchen jars as an

effective remedy for throat infections and for general wellness A small piece

of jaggery to suck on, or a spoon of jaggery powder dissolved in warm water to drink, or a piece of jaggery, ginger and tulsi leaf to chew on – in any which way mothers hand it out when you get a bout of bad cough or feel fatigued. It's also the reason why industrial workers in dusty environments like cement factories, thermal plants and coal mines are given a fixed quota of jaggery to eat. We have simply believed, albeit without much research, that it is a protective agent in polluted conditions.

With a doctorate in pharma analysis, Raghu Khimani says in his research paper on jaggery that it helps to 'pull out' dust and unwanted particles from the body and gives relief to the respiratory tract, the lungs, food pipes, stomach and intestines. However, Dr Valsala Varrier, Chief Medical Officer with the Coimbatore branch of Arva Vaidya Sala-Kottakkal, says jaggery is effective not as a stand-

alone remedy, but always in combination - say with pepper, tulsi or dry ginger. Ayurvedic doctors recommend a daily dose of jaggery (not more than 4 gm or little less than a teaspoon) to fight toxins in the body and strengthen one's immunity.

However, if you already have a respiratory disorder like bronchitis, asthma, or wheezing, allopathic doctors clarify that only medication and treatment will heal. "Jaggery cannot

replace or substitute the treatment of indoor- or outdoor-pollution-related diseases," says Dr Anantha

Subramanian, Consultant Pulmonologist at Chennai's Kauvery Hospital. There is no scientific evidence to suggest jaggery is a broncho-dilator, a substance that relaxes bronchial muscles in people who find it difficult to breathe to increase the airflow to the lungs. Neither does it have the power to provide immediate relief to someone gasping for breath. In that context, jaggery as medicinal sugar that de-smogs the lungs is

Madurai-based certified naturopath Dr S Harishankar, says natural remedies do not match the pace and intensity of allopathy treatment. At best, this iron-rich, anti-allergic source of energy improves the haemoglobin levels that increases the oxygen-carrying capacity of the blood and thereby strengthens the body's defence mechanism.

The quick guide to naughty or nice parenting

Your child may not be keeping score, but parents often doubt themselves and their parenting abilities

Parenting is hard, because nothing can prepare you for it. If you're questioning your parenting abilities, know you're not alone. We asked parents what their trickiest troubles were, and got the experts in to

help. Thenndral S, child counsellor, and founder-CEO of Eros Psycoun Services, Chennai and V Shreya Mythrei, a clinical psychologist and psychotherapist at Aarohi Centre for Mental Health, Coimbatore answer tough questions parents

ask themselves.

Should I reward my children for good marks?

Encouraging children for their work is good, but psychologists warn against materialistic rewards. "If a child is constantly being given gifts, they will always expect something materialistic in return for their actions," says Thenndral. If you feel that your child has worked hard, gift them experiences. "This could be taking them to a park, going out for dinner or giving them a monthly subscription to their favourite comic," she says.



What should I do when my child throws a tantrum in the store: grin and bear it or throw one myself?

Acceptance is the first step. Understand that children can get overwhelmed in public spaces. "Usually, the problem arises when parents become conscious and place the onus on what others may think of them. Avoid succumbing to the tantrum. Instead, reassure them and avoid shouting or threatening," says Shreya. Prep children before you go to the store. "Tell them what they are allowed



I suspect that my child is hiding a social media handle. Is it okay to snoop?

No, but it is okay to let your child know that you feel your number 1 priority is his safety. Says Thenndral, "Understand that your child also has a personal life. Reflect on why your child was reluctant to share this information with you and then have a conversation. Explain the pros and cons of using social media and also share your concerns with them. Do also listen to your child." Explain the non-negotiables: for instance, online bullying or accessing social media that may

I think my child prefers my husband because he plays the good cop and I am always the bad cop. How do I become the favoured one?

The idea of one parent being favoured is inappropriate. What is ideal for a child is to look at both parents with equal respect. "Parents should bring a balance here and it can be done by making decisions together. For example, when a child approaches the father for permission to go on a school trip, tell him that it is important for him to discuss it first with the mother. This helps the child understand that opinions of both the parents are equally important and eliminates the situation of being the good or bad cop," says Thenndral.

My child dresses outrageously in tiny shorts. What are my options: keep quiet or bring it up?

Asserting themselves is a part of a teen's developing identity. Conversations are important. "Have a discussion with your child and listen to them. State why you feel it is inappropriate. Explain to them the importance of dressing to the context and reach a middle ground. For example, a parent might say that they can wear short shorts when they go on a picnic but not when they go to the local market," says Shreya. Relationships are not built overnight, so spend time with your child, always giving her your full attention when you do – which means get off the phone, chat, laugh, and listen.

I used to smoke. Now I tell my kids not to. Should I confess?

Yes. "Tell them how it affected your health and the reasons you quit. If they come to know about this from anyone else, your child could lose trust in you and may not be interested in listening to you at all, even on other matters," says Thenndral.



BE PREPARED: Expect the unexpected

Question of adaptability

A backup plan on being prepared for any twists and



I am sitting in a small apartment in a West

European town and in the past half hour have seen the sky go from grey to cloudy blue to rainy to rainbow-sunny. So, I've gone from packing and unpacking, alternatively, a scarf, gloves, hat, and umbrella. I don't want my bag to get too heavy but I do want to be prepared for what seems like a temperamental day.

Have the mindset

One of the key skills in what is touted as the "21st century toolkit" is adaptability. It's a word that can mean flexibility, open-mindedness, resilience, or responsiveness. It is of course all those things and more. It is broadly, the ability to work with and within changing circumstances in a manner that makes best use of both individual and contextual resources. It's a level of preparation (carry that umbrella, layer your clothing, pack some food, make sure your phone is fully charged) and it is a mindset that anticipates and accepts that things may not turn as you expect.

It's almost a cliché to say that we live in a world that is rapidly changing, where we are faced with circumstances that are unprecedented and require innovative responses for which history does not offer too many lessons. That's at the macro level – issues of climate change, automation, resource depletion, and so on – for which much of what goes into adaptability happens at a systemic level (policies, frameworks, plans). But at the micro, or individual level too, we need to think about how we can build an attitude and practice adaptability.

This is a discussion that can span many pages, but for now, let me focus just on how we might cultivate adaptability on those two levels I mentioned above – preparation and mindset. The example I began with, about being prepared for variable weather, can be applied to many other situations. Think about the many possible variations or disruptions that could occur in a given situation and what you would need to quickly be ready to handle it.

Essentially, adaptability is all about backup; equipping yourself with the material resources you need for a range of possibilities and being mentally prepared to deal with the unexpected.

I was on a plane from Delhi to Bengaluru getting ready for take-off. A few people were having trouble adjusting their luggage in the overhead cabin. A gentleman came along, helped a few people with a smiling face and made space for everybody. "It's a matter of common sense," he said with a smile. More space showed up in no time, his own baggage was tucked in, and the people waiting in the aisle got going in a matter of minutes.

And all it took was common sense? A little event like this gets you thinking: is common sense commonly available? If it were, why did the people have trouble finding space for their luggage in the first place? Anyone who travels frequently on short-haul flights between Indian cities knows that the common sense required to adjust luggage in a high spaceyielding way is anything but common. For me, what that gentleman did in such a short time, and with such good humour, was a rare constellation

Not common

Indeed, such common sense is the right mix of spatial, bodily kinaesthetic, and interpersonal skills, and I suspect even the aircrew needs some training to grow them. The man found the best pattern to fit the luggage in the overhead compartment; common sense, too, is a form of pattern-recognition in the spatial, bodily, and emotional dimensions. He was also correct in describing this essential skill as common sense as the term is

generally used. At the same time, his use revealed the basic flaw in the general currency of the term. Common sense is not common. But we have been

trained to think of it as lowly. It

is common not in the sense of

ubiquitous - but common in

the sense of petty or trivial. It

merely brings out the biased na-

ture of our daily values and the language that codes them.

Educationist and cognitive psychologist, Howard Gardner makes it clear why. Common sense is praised - and its lack mourned - he says, almost wholly with respect to three kinds of aptitudes - 'intelligences.' in Gardner's formulation: the interpersonal, the spatial and the bodily kinaesthetic. The expression 'common sense' is never used to describe other kinds of intelligences Gardner describes, such as musical, logical-mathematical, or linguistic intelligences. These appear to be the 'higher'

intelligences. It is, among other things, based on the hierarchy between mind and body that we have inherited as part of modern consciousness - that mental faculties are somehow superior to physical ones. As a part-mechanical, part-social skill required in everyday life, it sits on a pecking order much lower than those that form the foundation of established aca-

demic or artistic fields. The curious case of common sense brings to the surface the hidden biases with which society evaluates different human abilities. Our language codes these very biases. In her book Pedigree: How Elite Students Get Elite Jobs, Lauren A Rivera shows that a similar play of power and prejudice is at work in society's conception of 'merit'. The conception of merit reflects the dominant value-system in a given society, and usually, the biases of dominant social groups. Rivera talks about the infamous prejudice about head size in 19th century

European thought – the notion that non-white races had smaller skulls than Europeans which was used to propagate a kind of scientific racism.

Likewise, the sociologist Jerome Karabel has shown that before 1920, admission criteria to Harvard, Yale and Princeton were primarily intellectual, centring on disciplinary excellence as evident in subject tests. As Jewish enrolments grew, so did anti-Semitism, and the definition of merit shifted so that Jewish students could be excluded more effectively from admission to these colleges, and white Anglo-Saxon applicants given easier passage. Admission criteria moved from being primarily intellectual to a focus on 'character', as evident through the candidate's involvement in sports and extracurricular activities, and even a perceived sense of 'manliness'.

The fact that these criteria persist to this day indicate the lasting trajectory of this shift. It

Kohli, Rahul and Rohit propel India to a memorable series win

Chasing a target of 316, the three provide the impetus before Jadeja and Thakur take the Men in Blue past the finish line; Pooran and Pollard's knocks go in vain

Virat Kohli proved yet again that he was the master of the chase as he joined hands with Ravindra Jadeja to help India chase down a daunting target of 316 with eight balls to spare in the third and final ODI against the West Indies at the Barabati Stadium here on Sunday. Though the captain – quite uncharacteristically - wasn't there till the end, Jadeja took the Men in Blue past the finish line in the company of Shardul Thakur.

The thrilling victory took India to a 2-1 come-from-behind series win, its 10th successive one against the West Indies. Kohli's men had lost the opening ODI in Chennai before bouncing back at Visakhapatnam.

Openers on the prowl

The Indian openers' success story in 2019 continued with Rohit Sharma and K.L. Rahul forging a 122-run partnership and laying a strong foundation for the big pursuit.

Rohit, elegant as usual, made a 63-ball 63 with eight fours and a six - a hit that soared over midwicket - before being caught behind off Jason Holder. It was the Hitman's sixth half-century of the year.

Rahul oozed class, his cut shots and delicate whips on the leg-side bringing him a lot of runs. His 89-ball 77 was his third fifty in 2019. The wristy Karnataka batsman, who added 45 with skipper Kohli, flicked Alzarri Joseph for a magnificent six over

deep-square leg before gloving the same bowler down the leg-side to the wicketkeeper an over later.

Rahul's departure brought Windies back into the game and India lost three more wickets between the 33rd and 39th overs. With Keemo Paul striking off consecutive overs, the visitors sensed an opportunity

However, a determined Kohli worked the ball around effortlessly and played his signature strokes - cover drive and pull – to take the team forward and keep the asking rate at an achievable range

Kohli (85, 81b, 9x4) found an partner in allrounder Ravindra Jadeja (39 not out, 31b, 4x4), their 58-run association reversing the trend of the visitors striking at regular intervals to put the kids on the chase.

Just when it looked like he would take the team home yet again, Kohli played on to Paul with India needing 30 off 23 balls. But a calm Jadeja and an aggressive Shadul

Thakur who blasted 17 off just six deliveries with two fours and a six ensured that there were no more hiccups.

Earlier, asked to take first strike, West Indies' openers Evin Lewis and Shai Hope, who relied on timing and placement during his 50-ball 42, batted with restraint to put on 57.

Breaking through Jadeja provided the breakthrough, having

caught at long-off.

Mohammed Shami castled

Hope with a beauty, the batsman missing the line and seeing his middle-stump knocked back.

Roston Chase, who was yet to score when wicketkeeper Pant dropped him off Kuldeep Yadav, and Shimron Hetmyer repaired the innings with a 62-run stand.

The left-handed Hetmyer, who made 37 off 33 balls, had some close shaves and was eventually dismissed when he pulled debutant Navdeep Saini straight to fine-leg fielder Kuldeep.

Saini rattled Chase's stumps with a yorker in the next over, leaving West Indies at 144 for four in the 32nd over.

Toe-crusher

Nicholas Pooran and Kieron Pollard. who needed attention after being hit by a Saini toe-crusher, took the attack to the opposition with a 135run partnership off just 98 deliveries.

Pooran, who cut, pulled drove clubbed Saini for three fours in an over before completing his fifth half-century (89 off 64) of the year. The Trinidadian, who was dropped on 52 and 72 by Pant, was caught at deep extra-cover off Thakur.

Pollard was at his brutal best during his undefeated 51-ball 74.

His knock contained three hits to the fence and seven mighty sixes as the Caribbeans plundered 77 off the final five overs. Though West Indies finished with an impressive total of 315, it proved inadequate.





Ganguly-Tendulkar faced better bowlers than Rohit-Kohli: Chappell

Former spent opening together against some of the best fast-bowling combinations


Virat Kohli and Rohit Sharma have stacked up astonishing numbers while batting as a pair but when it comes to facing quality fast bowlers, the celebrated opening duo of Sachin Tendulkar and Sourav Ganguly had a far tougher job.

"An argument could be mounted that Kohli and Rohit are India's best ever oneday batsmen. The obvious challengers would be the feted combination of Sachin Tendulkar and Sourav Ganguly, who tormented international bowlers for 15 years," Ian Chappell wrote in his column for ESPNcricinfo.

Chappell then gave an example of how during the Ganguly-Tendulkar era, each international team had two quality fast bowlers.

Test of skill

"They (Tendulkar-Ganguly) spent bulk of that time opening together against some of the best fast-bowling combinations. Facing Wasim Akram and Waqar Younis from Pakistan: Curtly Ambrose and Courtney Walsh of West Indies; Glenn McGrath and Brett Lee of Australia: Allan Donald and Shaun Pollock for South Africa; Lasith Malinga and Chaminda Vaas of



opposition, Ganguly and Tendulkar had a tough job to do.

Sri Lanka was a serious test of a batsman's skill."

Quoting a comment of Pakistani pace great Imran Khan that "you judge a man by his opponents", Chappell said, "on the basis of the quality of the opposition, you'd have to lean towards Tendulkar and Ganguly.

"However, if you extrapolate their current figures to give Kohli the same number of innings as Tendulkar, and Rohit the equal of Ganguly, the current pair finish well in front," he added.

Chappell acknowledged

that the one indisputable argument was that Kohli and Rohit are the best ever whiteball combination.

Their combined ODI and T20I records are excellent, with Kohli – averaging over 50 in both formats – at the unbelievable level. To be fair, Tendulkar played very little T20I cricket and Ganguly's career was finished by the time the format blossomed," he wrote.

He said even though Tendulkar led the way in being the first batsman to score an ODI double-century, Rohit

has fine-tuned the art by scoring three doubles, with his monumental 264 against Sri Lanka sending the fans at Eden Gardens into a frenzy.

"Indian fans have been extremely fortunate to witness, close up, four of the best short-form batsmen of all time," Chappell wrote.

All-round mastery

"With Tendulkar it was his all-round mastery of the art but he never ceased to amaze with his back-foot forcing shots on bouncy pitches for a man short in stature. W

"When he was going there was no better off-side player than Ganguly; his drives, so effortlessly played, would pierce even the most crowded cover field."

About Kohli and Rohit, he said: "It's not so much the huge scores that stamp Kohli's class but the regularity of his success. He punishes bowlers all round the wicket by keeping the ball on the ground the bulk of the time. Thanks to him eliminating a lot of the risk in batting, his scores are consistently high but still amassed at a good

"Rohit, on the other hand, tends to play risk-free cricket early on, but once he gets motoring, it's a case of 'watch out in the stands'.

Elaborating on the decisions taken on Sunday, Chauhan said, "Since the affiliates are yet to receive the minutes of the meeting in Chennai even after eight days, the house unanimously decided on matters before it."

Asked about the elections scheduled by Raja in Chennai on February 10, Chauhan said, "the subject was not part of the agenda and the president 'suo moto' announced the date. Secondly, the Central Council also dismissed the decision taken in Chennai to form a four-member committee that includes me, to help the president conduct the elections. "To avoid further conflict, the house decided not to consider Chennai or New Delhi and chose Ahmedabad as a neutral venue to hold election in the presence of a Supreme

close the matter of a showcause notice issued to him by the president. In a longawaited move, the meeting decided to re-register all players whose ratings were taken away in 2009. Gurpreet Pal Singh, a Rail-
